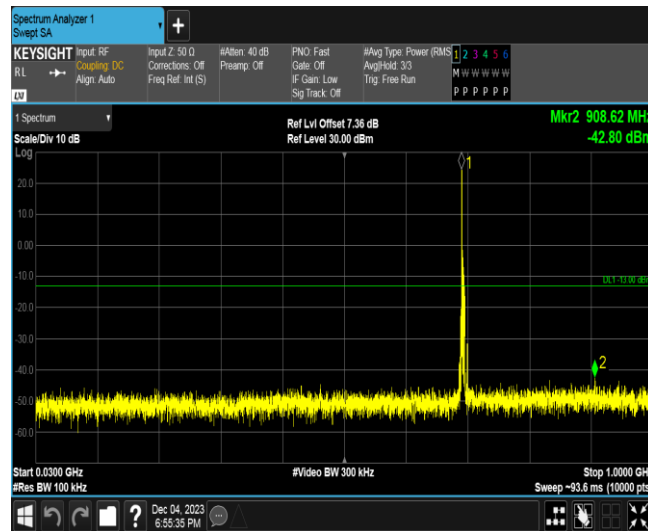


Band12-3MHz-16QAM-23165-1RB#0-Range2:1000~10000MHz

Band12-10MHz-QPSK-23060-1RB#0-Range2:1000~10000MHz

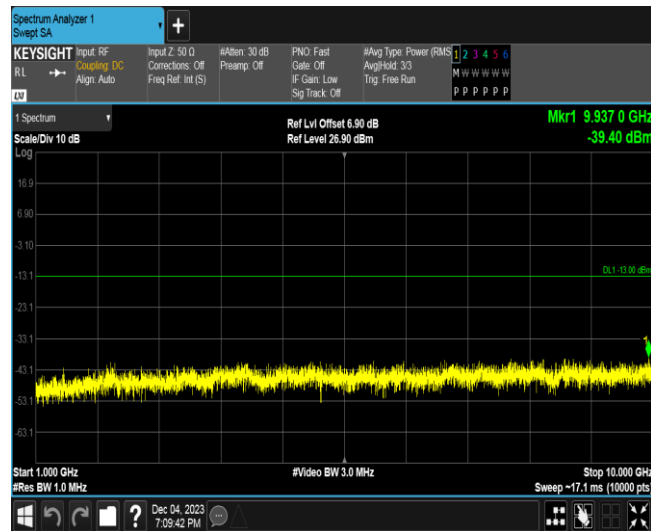

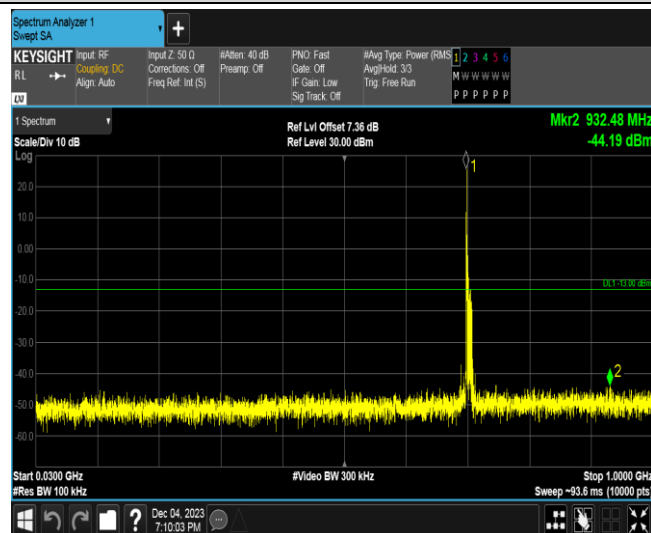
