



2.4GHz WLAN (DTS) operation is possible in 20MHz, and 40MHz channel bandwidths. 



 4. At all times when the EUT is transmitting, it shall be transmitting at its maximum power control level.
 5. The integration period of the power meter exceeds the repetition period of the transmitted signal by at least a factor of five.
 6. Determine according to the duty cycle of the equipment: when it is less than 98%, follow the steps below.
 7. Measure the average power of the transmitter. This measurement is an average over both the ON and OFF periods of the transmitter.
 8. Adjust the measurement in dBm by adding $[10 \log (1 / D)]$, where D is the duty cycle {e.g., $[10 \log (1 / 0.25)]$, if the duty cycle is 25%}.
 9. Record the test results in the report.







Test_Graph_802.11b_ANT1_2412_1Mbps_OBW







9. Power Spectral Density Measurement

9.1 Provisions Applicable

The transmitter power spectral density conducted from the transmitter to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

5. Set the Span $\geq [1.5 \times \text{DTS bandwidth}]$.
6. Sweep time=Auto couple.
7. Detector function=Peak.
8. Trace Mode=Max hold.
9. When the measurement bandwidth of Maximum PSD is specified in 3 kHz, add a constant factor $10 \times \log(3\text{kHz}/20\text{kHz}) = -8.23 \text{ dB}$ to the measured result.
10. Allow trace to stabilize. Use the marker-to-peak function to set the marker to the peak of the emission.
11. The indicated level is the peak output power, after any corrections for external attenuators and cables.

For Average power spectral density test:

1. The testing follows the ANSI C63.10 Section 11.10.5 Method AVPSD.
2. Connect EUT RF output port to the Spectrum Analyzer through an RF attenuator.
3. Set Span to at least 1.5 times the OBW.
4. Set RBW to: $3 \text{ kHz} \leq \text{RBW} \leq 100 \text{ kHz}$.
5. Set VBW $\geq [3 \times \text{RBW}]$.
6. Sweep Time=Auto couple.
7. Detector function=RMS (i.e., power averaging).
8. Trace average at least 100 traces in power averaging (rms) mode.
9. When the measurement bandwidth of Maximum PSD is specified in 3 kHz, add a constant factor $10 \times \log(3\text{kHz}/20\text{kHz}) = -8.23 \text{ dB}$ to the measured result.
10. Determine according to the duty cycle of the equipment: when it is less than 98%, follow the steps below.
11. Add $[10 \log (1 / D)]$, where D is the duty cycle, to the measured power to compute the average power during the actual transmission times (because the measurement represents an average over both the ON and OFF times of the transmission). For example, add $[10 \log (1/0.25)] = 6 \text{ dB}$ if the duty cycle is 25%.
12. Record the test results in the report.






Test Graphs of Conducted Output Power Spectral Density





10. Conducted Band Edge and Out-of-Band Emissions

10.1 Provisions Applicable

In any 100kHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power.





Test Graphs of Spurious Emissions in Non-Restricted Frequency Bands



Test_Graph_802.11b_ANT1_2412_1Mbps_Lower Band Edge Emissions





11.2 Measurement Procedure

1. The EUT was placed on the top of the turntable 0.8 or 1.5 meter above ground. The phase center of the receiving antenna mounted on the top of a height-variable antenna tower was placed 3 meters far away from the turntable.
2. Power on the EUT and all the supporting units. The turntable was rotated by 360 degrees to determine the position of the highest radiation.
3. The height of the broadband receiving antenna was varied between one meter and four meters above ground to find the maximum emissions field strength of both horizontal and vertical polarization.
4. For each suspected emission, the antenna tower was scan (from 1 M to 4 M) and then the turntable was rotated (from 0 degree to 360 degrees) to find the maximum reading.
5. Set the test-receiver system to Peak or CISPR quasi-peak Detect Function with specified bandwidth under Maximum Hold Mode.
6. For emissions above 1GHz, use 1MHz RBW and 3MHz VBW for peak reading. Place the measurement antenna away from each area of the EUT determined to be a source of emissions at the specified measurement distance, while keeping the measurement antenna aimed at the source of emissions at each frequency of significant emissions, with polarization oriented for maximum response. The measurement antenna may have to be higher or lower than the EUT, depending on the radiation pattern of the emission and staying aimed at the emission source for receiving the maximum signal. The final measurement antenna elevation shall be that which maximizes the emissions. The measurement antenna elevation for maximum emissions shall be restricted to a range of heights of from 1 m to 4 m above the ground or reference ground plane.
7. When the radiated emissions limits are expressed in terms of the average value of the emissions, and pulsed operation is employed, the measurement field strength shall be determined by averaging over one complete pulse train, including blanking intervals, as long as the pulse train does not exceed 0.1 seconds.

8. If the emissions level of the EUT in peak mode was 3 dB lower than the average limit specified, then testing will be stopped and peak values of EUT will be reported, otherwise, the emissions which do not have 3 dB margin will be repeated one by one using the quasi-peak method for below 1GHz.
9. For testing above 1GHz, the emissions level of the EUT in peak mode was lower than average limit (that means the emissions level in peak mode also complies with the limit in average mode), then testing will be stopped and peak values of EUT will be reported, otherwise, the emissions will be measured in average mode again and reported.
10. In case the emission is lower than 30MHz, loop antenna has to be used for measurement and the recorded data should be QP measured by receiver. High - Low scan is not required in this case.





11.3 Measurement Setup (Block Diagram of Configuration)


Radiated Emission Test Setup 9kHz-30MHz
























