The antenna is a **PCB Antenna** which permanently attached, and the best case gain of the antenna is **3.42 dBi** . It complies with the standard requirement.



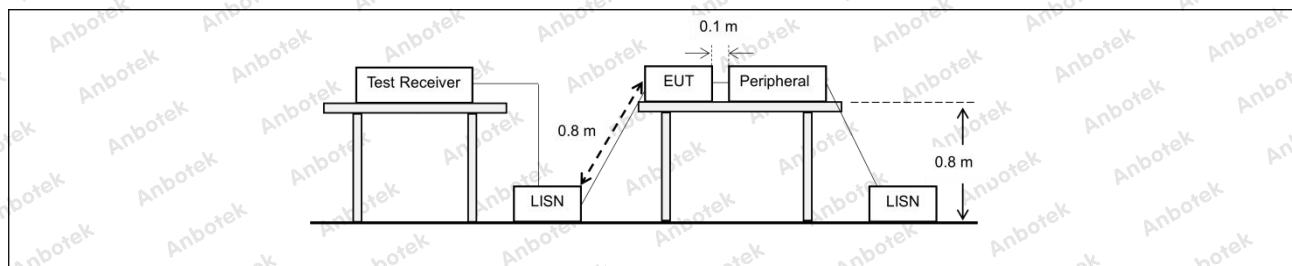

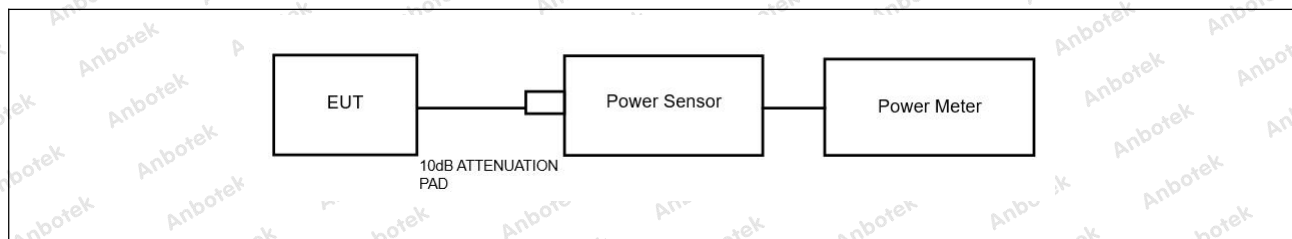
5. Maximum Conducted Output Power
