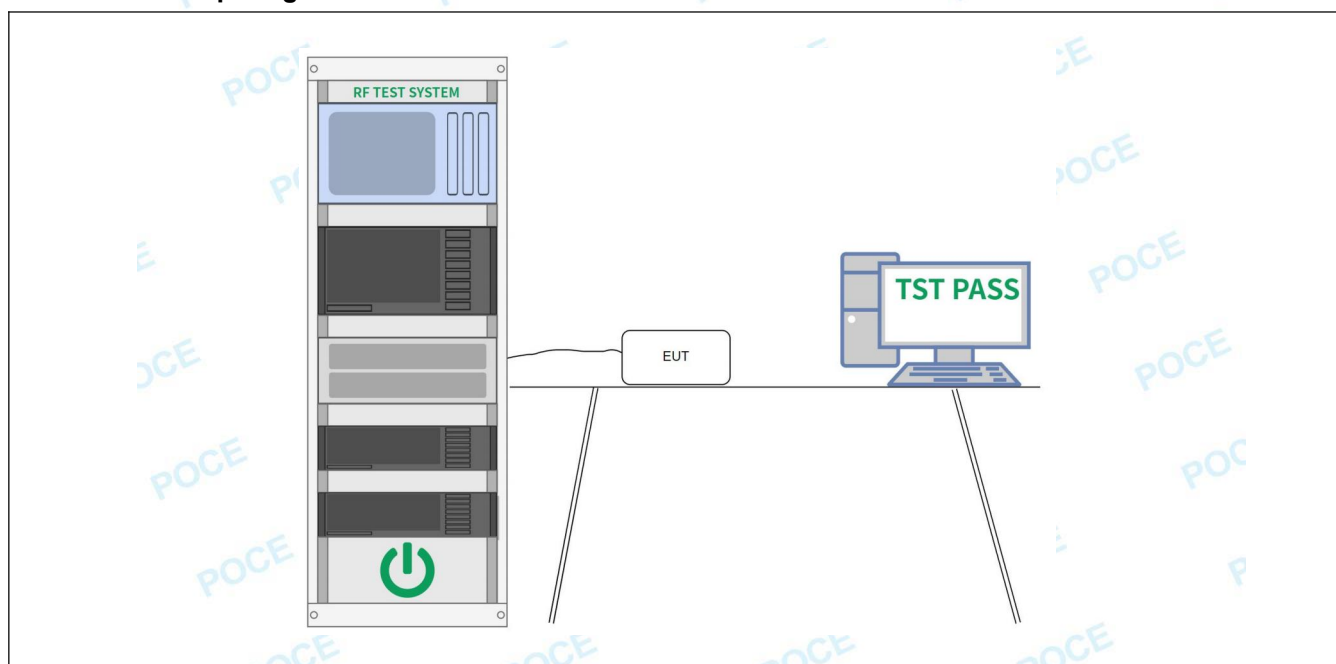

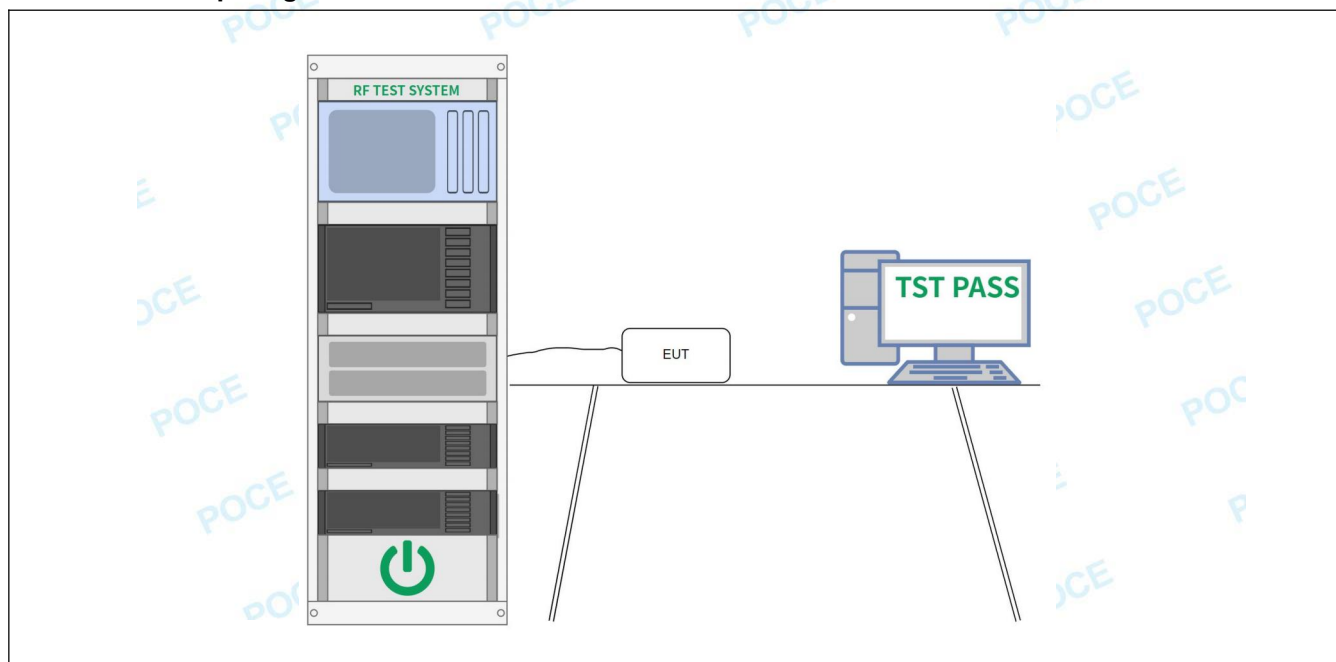

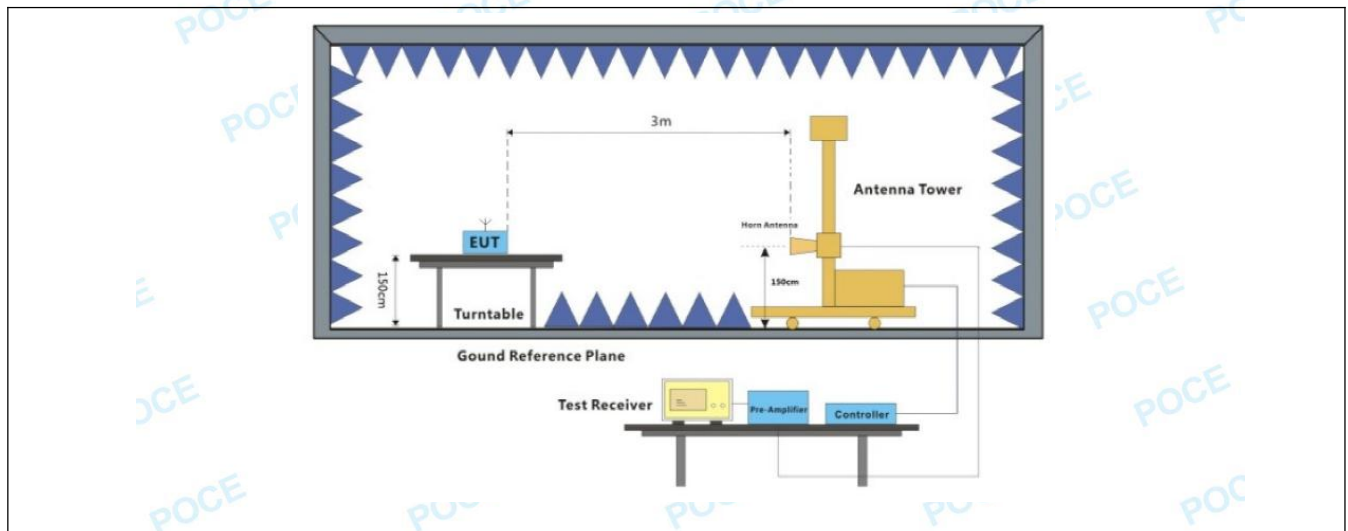

4.8.2 Test Setup Diagram:



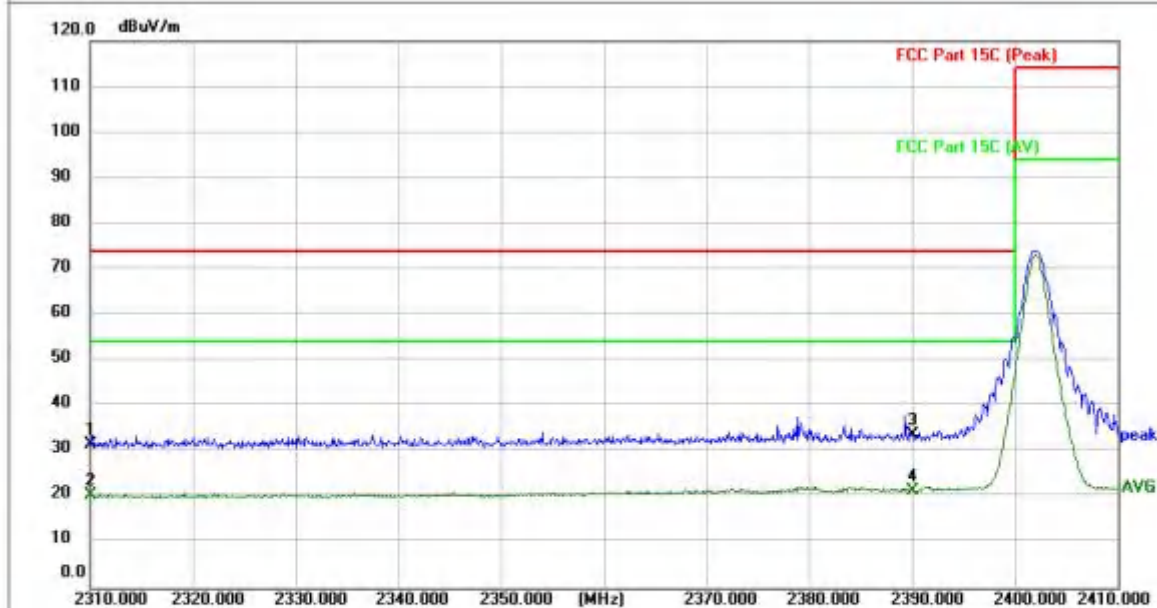

Emissions in frequency bands (below 1GHz)

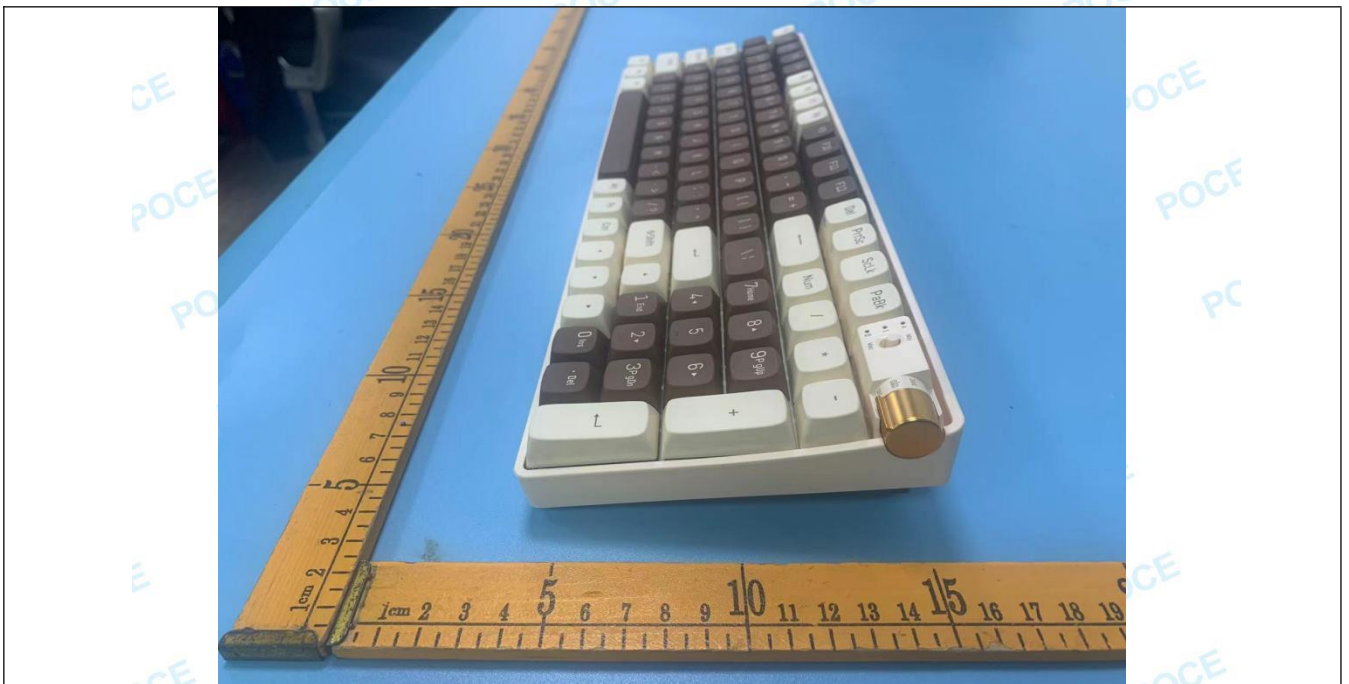


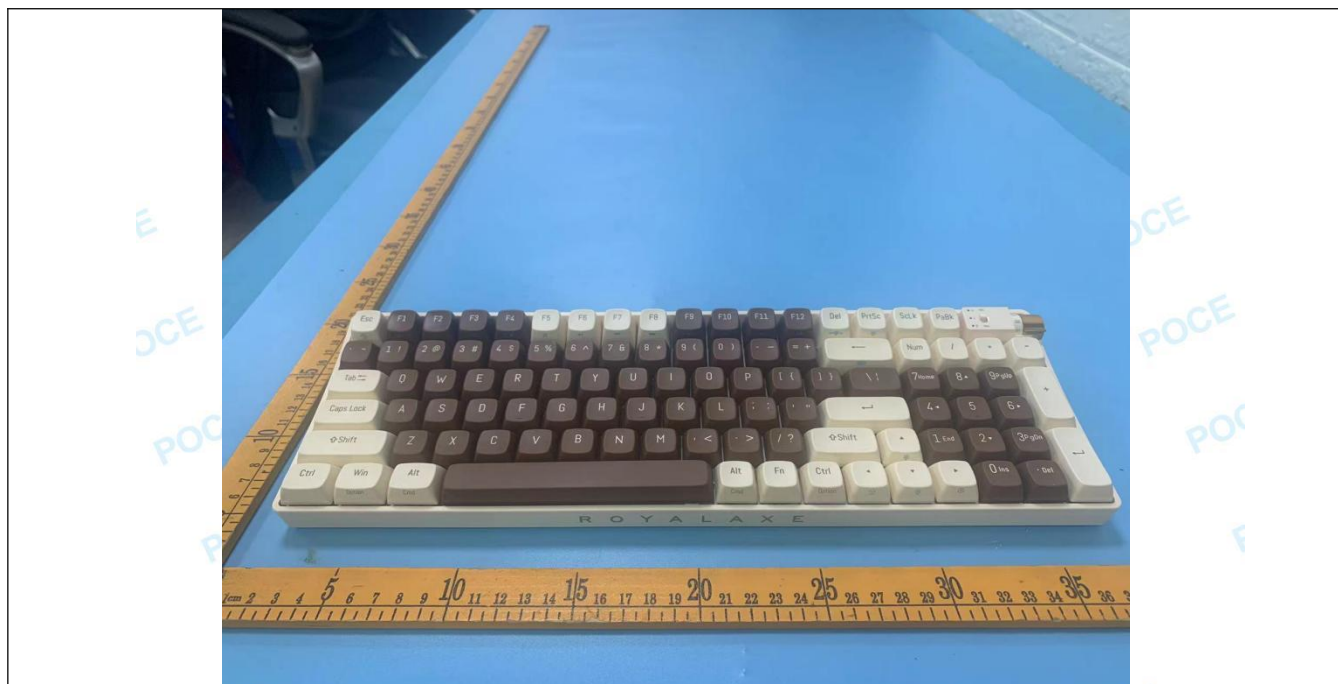

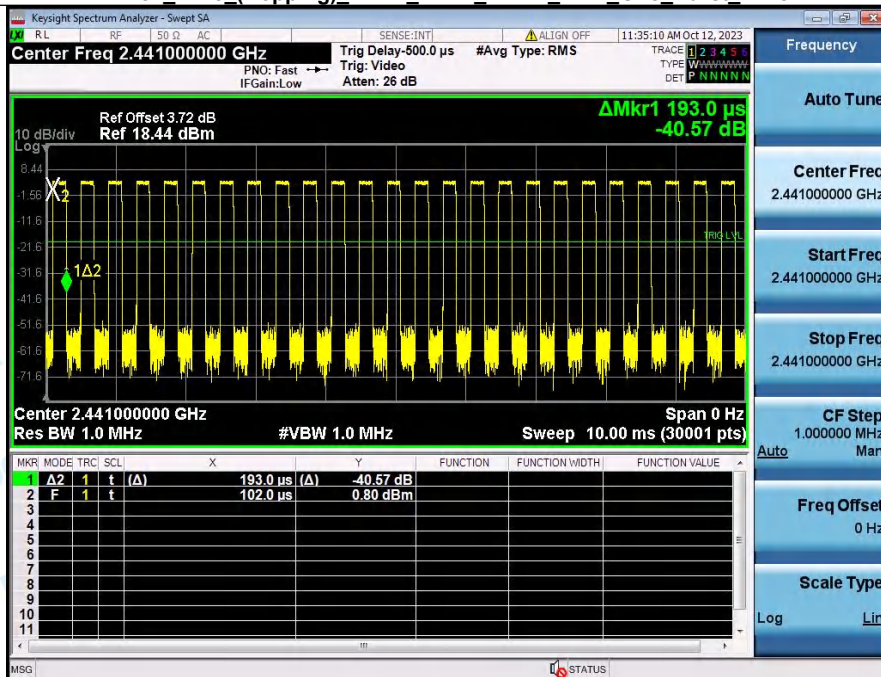
Dwell Time (Hopping) NVNT ANT1 1-DH5 2441 One Burst Time



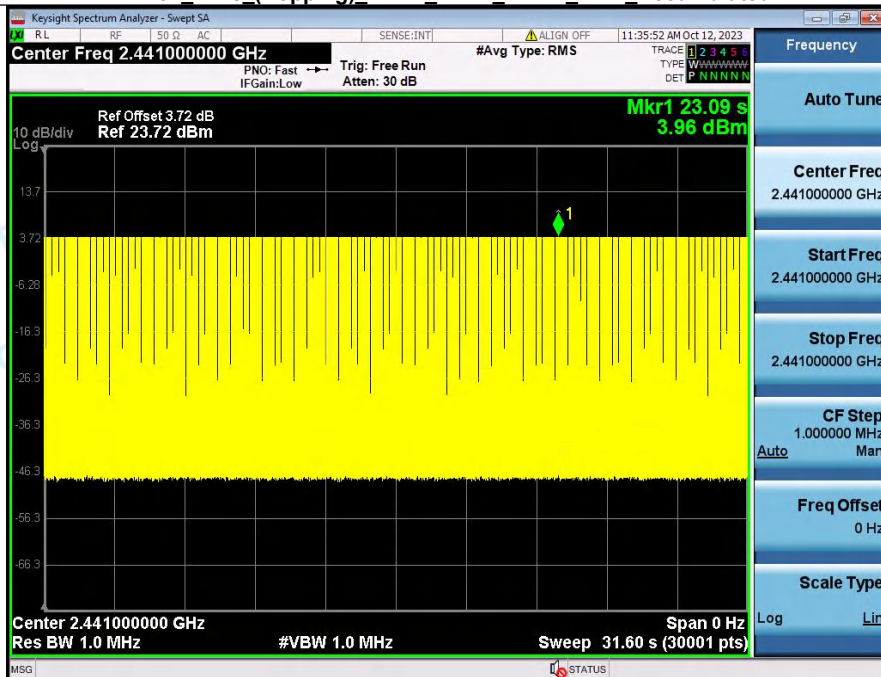
Dwell Time (Hopping) NVNT ANT1 1-DH5 2441 Accumulated

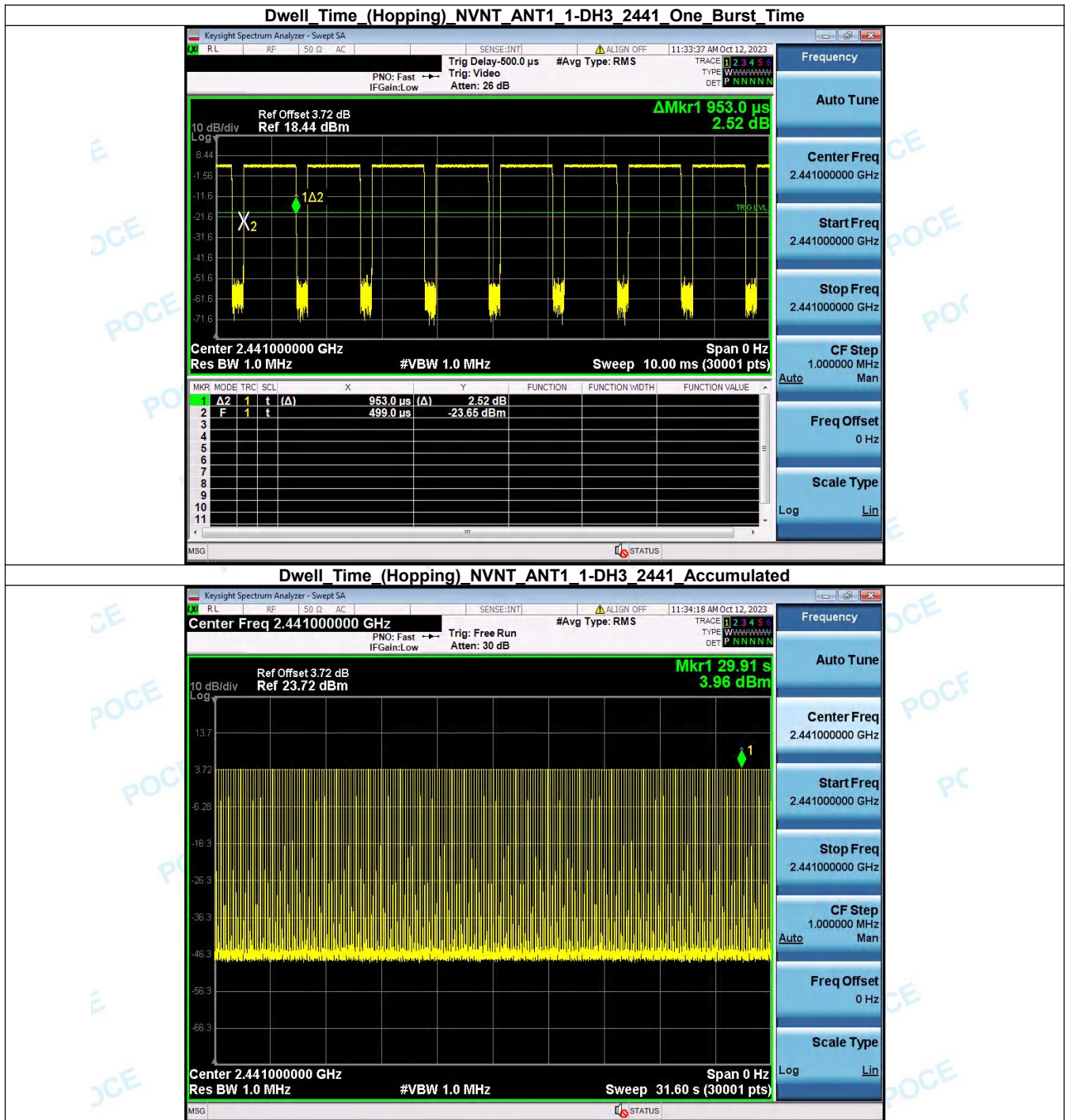


Dwell Time (Hopping)_NVNT_ANT1_1-DH1_2441_One Burst Time
