4 Add device

A.Quickly way

Open "Smart Life" APP. Turn on the Bluetooth on your mobile phone, and grant the corresponding permission to the "Smart Life" APP. Click the "Add" button.

If the dialog box does not pop up,you can click the "+" icon or "Add Device" button on the home page, and the camera will be searched, then click the "Add".

Enter Wi-Fi name and password, then click the "Next".

Wait for the camera to automatically complete network configuration.

B.QR code way

Open "Smart Life" APP, click "+" on the top right corner of the page "HOME", then select "Smart Camera (Wi-Fi)".

Make sure the indicator is flashing or a prompt tone is heard, then press "Next"

Enter wifi name and password, then press "Next"

Scan the QR Code on your phone with camera. Heard a prompt tone, then press "I Heard a Prompt".

Frequently Asked Questions

1 Can I share with family and friends?

Yes, you can share your cameras with family and friends who will have access to view the camera and control your bulbs, plugs, and other devices. In the app, press the Profile button and click on the "Home Management" button, and you will be able to give or revoke sharing permissions. In order to share, the other user should already have downloaded the app and registered a new account.

2 What's the Wireless Range?

The range of your home Wi-Fi is heavily dependent on your home router and the conditions of the room. Check with your router specifications for exact range data.

3 How many cameras can I control?

Smart Life app can control an unlimited amount of devices in an unlimited amount of locations. Your router may have a limit of how many devices can be connected to one router.

4 My device can't be connected to network with App

- Make sure the device is under the config status (Indicator light is flashing quickly)
- Make sure the Wi-Fi is available and not too far away from router
- Make sure the Wi-Fi password you input is correct

5 My device shows offline in my App

- Make sure the device is powered on
- Make sure the network is stable and the Wi-Fi name and password not modified. If not, add device again.
- If the network is normal, but it's still offline. Check if there are too many Wi-Fi connections. You can restart your router to check the status of the device.
