4.1.2 Test Procedure

- a. The RF exposure test was performed in anechoic chamber.
- b. Perform H-field measurements for each edge/top surface of the host/client pair at every 2 cm, starting from as close as possible out to 20 cm.
- c. The highest emission level was recorded and compared with limit.
- d. The EUT was measured according to the dictates of TCB


