In accordance with 47CFR 15.212 Modular Transmitters and KDB 996369 D01 'Module Certification Guide v04'. FCC ID 2BKVU-TXW-BTM01 has been examined against the following requirements.

Physical components and tuning capacitor(s) may be located external to the shield, but must be on the module assembly	Yes, the products have a shield, Physical components and tuning capacitor(s) are assembly to the module and located internal to the shield.
2. The module must have buffered modulation/data inputs to ensure that the device will comply with Part 15 requirements with any type of input signal	Yes, The module has buffered modulation/data inputs.
3. The module must contain power supply regulation on the module	Yes, The modular transmitter has its own power supply regulation.
4. The module must contain a permanently attached antenna, or contain a unique antenna connector, and be marketed and operated only with specific antenna(s), per Sections 15.203, 15.204(b), 15.204(c), 15.212(a), 2.929(b)	Yes, The module contains a permanently attached PCB Antenna.
5. The module must demonstrate compliance in a stand-alone configuration	Yes, The module compliance in a stand-alone configuration.
6. The module must be labelled with its permanently affixed FCC ID label, or use an electronic display (See KDB Publication 784748 about labelling requirements)	Yes. The module has its permanently affixed FCC ID label and the FCC ID label is laser engraved on the shield.
7. The module must comply with all specific rules applicable to the transmitter including all the conditions provided in the integration instructions by the grantee	The module complies with all specific rules applicable to the transmitter.
8. The module must comply with RF exposure requirements	Yes. We provided an MPE report to show the module comply with RF exposure requirements.

Items to be covered by Split modular transmitters.

Requirement per 15.212 and KDB 996369 D01 'Modular Certification Guide v04'	Explanation from Grantee (do not write yes/no, but explain why product complies/how it is achieved)
9. Split modular transmitters must meet all the requirements of a single modular in above item1 and 5 for single modular approval requirements.	
10. Only the radio front end must be shielded. The physical crystal and tuning capacitors may be located external to the shielded radio elements. The interface between the split sections of the modular system must be digital with a minimum signaling amplitude of 150 mV peak-to-peak.	
11. Control information and other data may be exchanged between the transmitter control elements and radio front end.	
12. The sections of a split modular transmitter must be tested installed in a host device(s) similar to that which is representative of the platform(s) intended for use.	
13. Manufacturers must ensure that only transmitter control elements and radio front end components that have been approved together are capable of operating together. The transmitter module must not operate unless it has verified that the installed transmitter control elements and radio front end have been authorized together. Manufacturers may use means including, but not limited to, coding in hardware and electronic signatures in software to meet these requirements, and must describe the methods in their application for equipment authorization.	

**Alimited modular approval (LMA) may be granted for single or split modular transmitters that comply partially with requirements above.**
