RF Exposure Evaluation

- 1. The corresponding SAR Exclusion Threshold condition, listed below:
- 1) The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤50 mm are determined by:

[(max. power of channel, including tune-up tolerance, mW)/(min. test separation distance, mm)] .[Vf(GHz)]≤3.0 for 1-g SAR and≤7.5 for 10-g extremity SAR,16 where

- > f(GHz) is the RF channel transmit frequency in GHz
- > Power and distance are rounded to the nearest mW and mm before calculation
- > The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is≤50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion.

- 2) At 100 MHz to 6 GHz and for test separation distances > 50 mm, the SAR test exclusion threshold is determined according to the following:
- a) [Threshold at 50 mm in step 1) + (test separation distance 50 mm):(f(MHz)/1 50)] mW, at 100MHz to 1 500 MHz
- b) [Threshold at 50 mm in step 1) + (test separation distance 50 mm)-10] mW at > 1500 MHz and≤ 6 GHz
- 3) At frequencies below 100 MHz, the following may be considered for SAR test exclusion.
- a) The threshold at the corresponding test separation distance at 100 MHz in step 2) is multiplied by [1+log(100/f(MHz))] for test separation distances > 50 mm and < 200 mm.
- b) The threshold determined by the equation in a) for 50 mm and 100 MHz is multiplied by /2 for test separation distances≤50 mm.
- c) SAR measurement procedures are not established below 100 MHz. When SAR test exclusion cannot be applied, a KDB inquiry is required to determine SAR evaluation requirements for any test results to be acceptable.

Remark:

- 1. Output power including tune up tolerance;
- 2. When the minimum test separation distance is < 5 mm, a distance of 5 mm according to f) in section 4.1 is applied to determine SAR test exclusion.

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

[(max. power of channel, including tune-up tolerance, mW)/(min. test separation distance,mm)] · [√f(GHz)]

The test Result is less than 3.0 for 1-g SAR and ≤ 7.5 for 10-g extremity SAR.

Conclusion

Therefore this device complies with FCC's RF radiation exposure limits for general population without SAR evaluation.
