F= Frequency in MHz Friis Formula

Friis transmission formula: $P_d = (P_{out} \cdot G) / (4 \cdot \pi \cdot R^2)$ Where

P_d = power density in mW/cm²

P_{out} = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

Pd is the limit of MPE . If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

2.2 EUT RF EXPOSURE EVALUATION

WIFI ANT : 3.0dBi

1. Antenna Gain: The maximum Gain measured in fully anechoic chamber is 1.0 in linear scale.
2. EUT RF module is more than 20cm away from the human body.

Remark: $P_d = (P_{out} * G) / (4 * \pi * R^2) = (79.433 * 1.9953) / (4 * 3.1416 * 20 * 20) = 0.03153$, $G = 10^{gain/10} = 1.9953$

The sum of the ratios(2.4GWIFI) is less than the limit value of 1.0, so there is no sar requirement.
