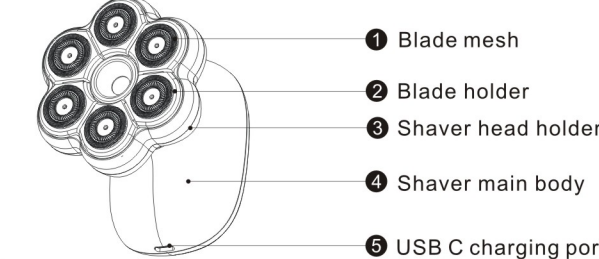


One: Safety Instructions

- Warning:
1. Keep this product out of reach of children; it is not to be used as a toy.
  2. Individuals with physical disabilities, mental impairments, or lacking relevant experience and knowledge should use this product under supervision and guidance of a guardian.
  3. Do not disassemble the body to replace the battery; do not modify or repair this product without authorization.
  4. Before charging, ensure that the voltage marked on the product matches the voltage of the charging source.
  5. Do not charge the product unattended, and do not exceed a charging duration of 24 hours.
  6. When not in operation, this product can be washed under a tap; ensure it is dry after cleaning.
  7. Charge, store, and use the product within a temperature range of 5 to 35 degrees Celsius.
  8. This product contains a built-in rechargeable battery; do not throw it into fire or charge, use, or store it at high temperatures.

Two: Product Introduction



- Caution:
1. This product is suitable for cleaning head and facial hair; do not press too hard while using.
  2. If the charging cable of this product is damaged or the device is not functioning properly, stop using it and replace the charging cable.
  3. Please use a charger that is purchased through official channels and certified by 3C, with a specification of 5V 1A/2A.
  4. Mild skin irritation may occur during shaving. It is recommended to use the shaver regularly.

Four: How to Use

1. Button function description: A short press turns the device on at speed level one, another short press switches to speed level two, and a further short press turns the device off.
2. Camera function description: A short press to turn on the device will automatically activate WIFI and the camera light; When short press to the off state, the camera and WIFI will be turned off.

Five: Connecting to Product WiFi

1. Scan the QR code or search for "hndvisual" in the app store, download the APP, and install the software
2. Once installed, the following icon will appear: HND
3. Long press the power button on the main unit for 3 seconds to turn it on
4. Tap on the icon to search for WiFi.
5. Tap on the Wireless Local Area Network settings.
6. Connect to WiFi "KSA-XXX"

2 APP Fault Analysis and Troubleshooting

Fault	Solutions
No response when powering on	Please try several more times according to the correct operating instructions. Charge using the provided charging cable
Camera light is not on	Turn the shaver off and then back on again
APP crashes	Uninstall the current APP, re-download and install it for use
Abnormal image display	Disconnect the phone from the device's WiFi, restart the product, and reconnect
Unstable connection between the shaver and the APP	Restart the product and try to connect to the APP again
If the problem cannot be resolved by following the above steps, please contact customer service. We will provide you with further feasible solutions!	

Seven: LED Display

- 
1. Motor speed
  2. Battery Level
  3. WIFI status and battery
  4. Cleaning reminder
1. Powering On/Off: A short press turns the device on at level one, another short press switches it to level two, and a further press turns the device off.
  2. Battery Display: The battery level is shown as a percentage. When the battery is below 10%, a battery indicator light will appear to remind you to charge; when the battery is above 20%, the charge reminder icon will not be displayed.
  3. WIFI: When not connected to WIFI, the WIFI icon blinks; when connected, the icon remains steadily lit.
  4. Cleaning function reminder display: After the device is used for 20 minutes, start the rinse function reminder (automatically turn off the rinse reminder function after 2 minutes of shutdown) to remind the user to clean and maintain the product.

Eight: Charging

1. Before the first use, please charge the battery to 100%
2. 15. When the power is less than 20%, the battery percentage flashes.
3. When charging, connect the Type-C end of the data cable to the shaver, and connect the other end to the power adapter; At this time, 15. the battery percentage is blinking are blinking for charging; When fully charged, the screen displays 100%.
4. Please do not put the product into the box when charging.

Cleaning the Shaver

- Turn off the shaver before cleaning.
1. To maintain optimal performance, regularly clean the shaver.
  2. For cleaning, detach the shaver head (illustration provided) and use a brush or rinse with water.
  3. Within 12 months from the day after you receive the product, if the product exhibits performance failures listed in "this manual," and such issues are confirmed by our after-sales service center, you may enjoy free repair services.

Symptoms	Causes	Solutions
Shaving performance is not satisfactory	Blade wear or damage	Please replace with a dedicated shaving head
	Stubble clogging the shaver	Please clean the shaver
	Low battery power	Please charge the shaver
Long press of the power button not functioning	Travel lock is activated	Press and hold the button for 5-7 seconds to unlock
	Circuit malfunction	Return for after-sales service and repair
The sterilization light is not on	Not activate	Press and hold the button for 3 seconds to activate
	Circuit malfunction	Return for after-sales service and repair

Nine: Troubleshooting Two

Symptoms	Causes	Solutions
Charging indicator light not on	No power supply connected	Connect the power cord for charging
	Indicator light damaged	Return for after-sales service and repair
	Circuit malfunction	Return for after-sales service and repair
Excessive charging time	Battery reached the end of its life	Return for after-sales service and repair
	Circuit malfunction	Return for after-sales service and repair
Skin irritation after shaving	Skin needs time to adapt to the shaver	Skin irritation disappeared after using for 2-3 weeks

Instructions for Multi-functional Shaver

M40 Series

A. Brush Cleaning: Use a brush to separately clean the stubble on the blade assembly and the rotating axis of the shaver body.

B. Rinse with Clean Water: Place the blade assembly and the rotating axis of the shaver body under a faucet separately and rinse them. After cleaning the stubble, make sure to remove any remaining water to keep the shaver dry. To maintain good shaving performance, it is recommended to replace the blade assembly every six months.
