5.1.1. Antenna Requirement

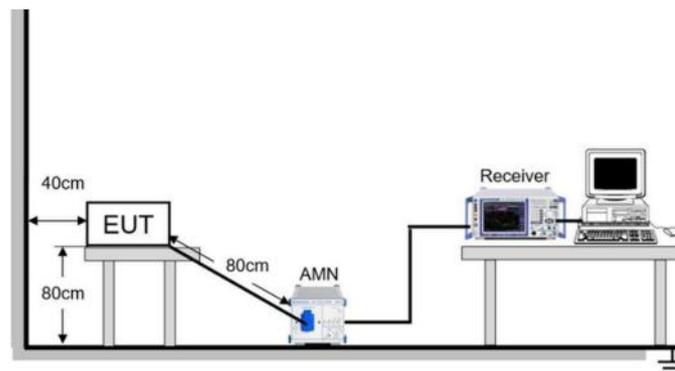

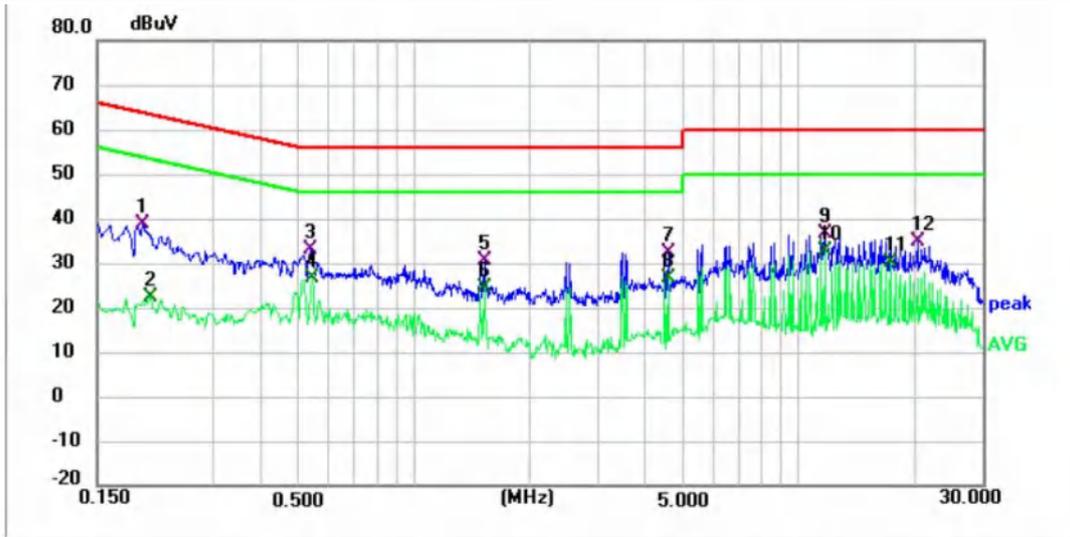

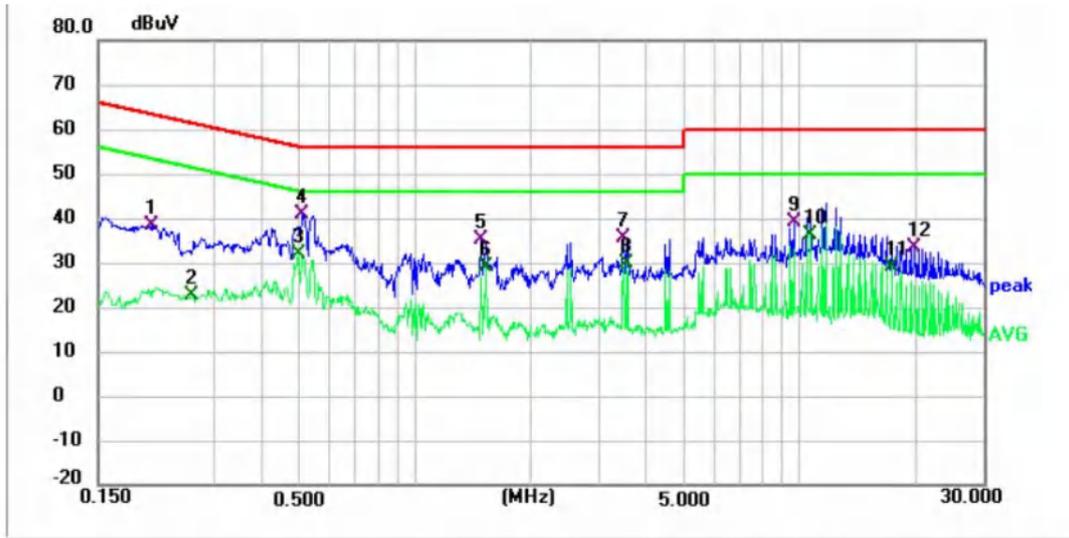

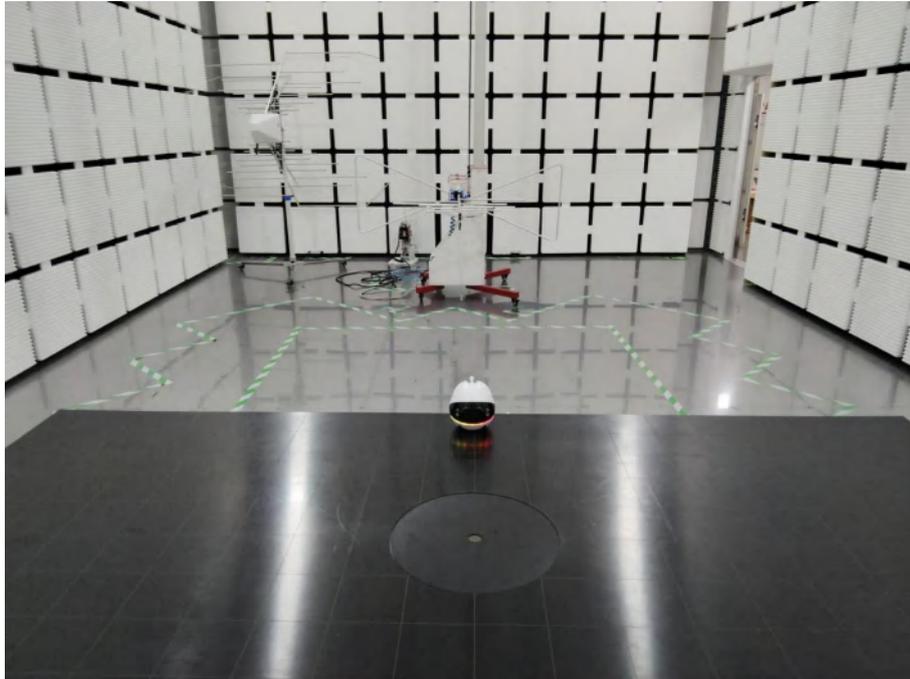

Radiated Spurious Emission (Above 1GHz)



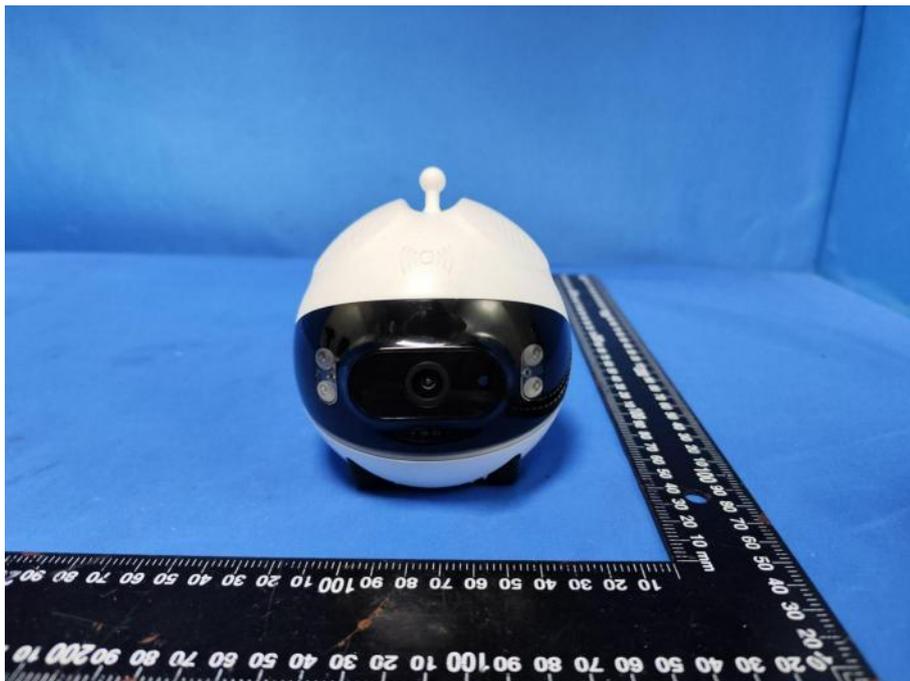
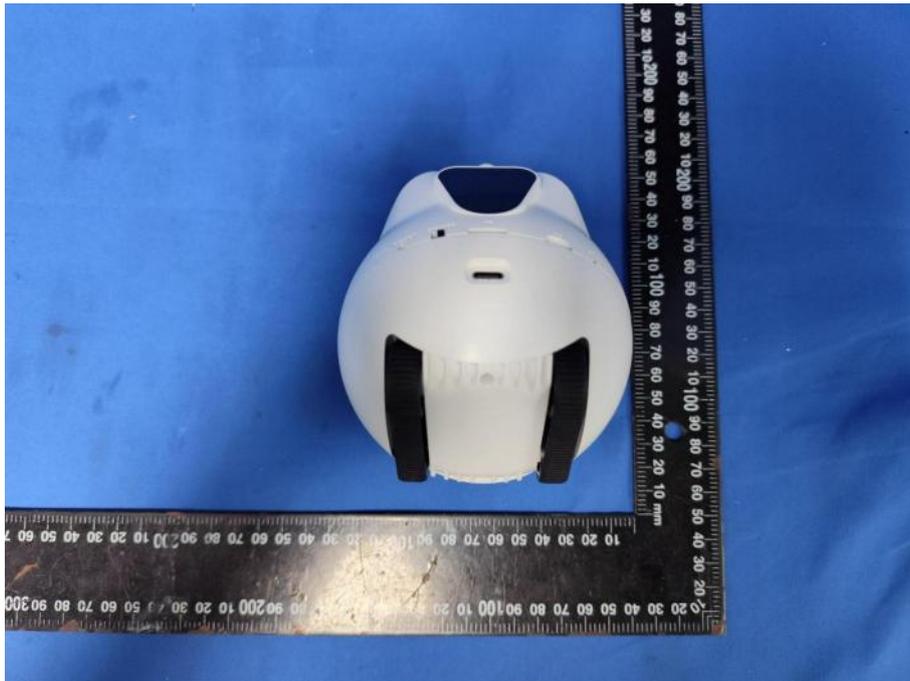
Radiated Spurious Emission (below 1GHz)
