

4.2 Test Procedure

a) The EUT was configured for testing in a typical fashion (as a customer would normally use it). The EUT has been programmed to continuously transmit during test. This operating condition was tested and used to collect the included data.

b) The following is the setting of the receiver

c) The EUT was placed 0.8 meters from the horizontal ground plane with EUT being connected to the power mains through a line impedance stabilization network (LISN). 





7. Maximum Conducted Output Power

7.1 Standard and Limit

According to 15.247(b)(3). For systems using digital modulation in the 902–928 MHz, 2400–2483.5 MHz, and 5725–5850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Test Setup Block Diagram



10. Band-edge Emission(Conducted)

10.1 Standard and Limit

- 4) Measure the highest amplitude appearing on spectral display and set it as a reference level.
- 5) Set a convenient frequency span including 100 kHz bandwidth from band edge.
- 6) Measure the emission and marking the edge frequency.
- 7) Repeat above procedures until all frequencies measured were complete.



- 5) Measure the spurious emissions with frequency range from 9kHz to 26.5GHz.
- 6) Repeat above procedures until all measured frequencies were complete.








