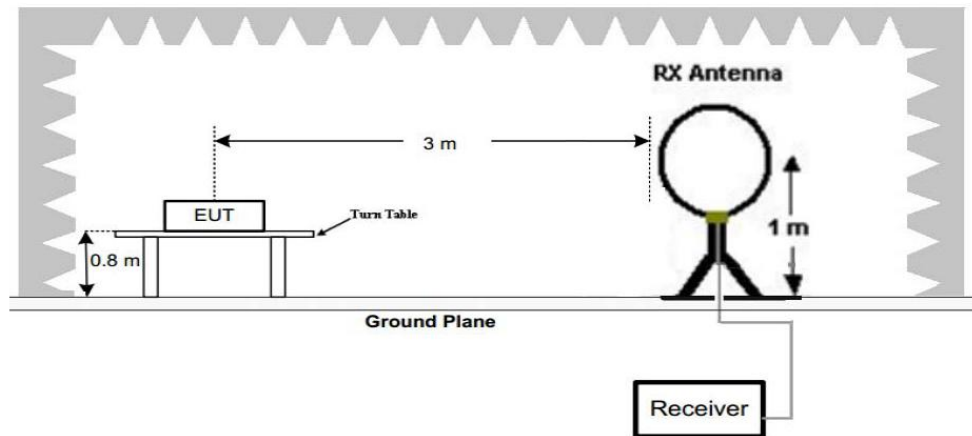


Figure 1. Below 30MHz

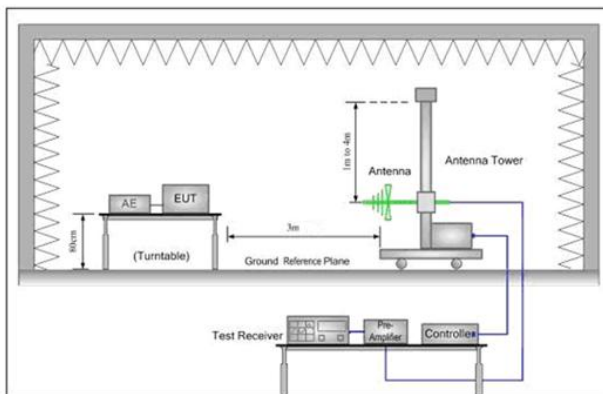


Figure 2. 30MHz to 1GHz

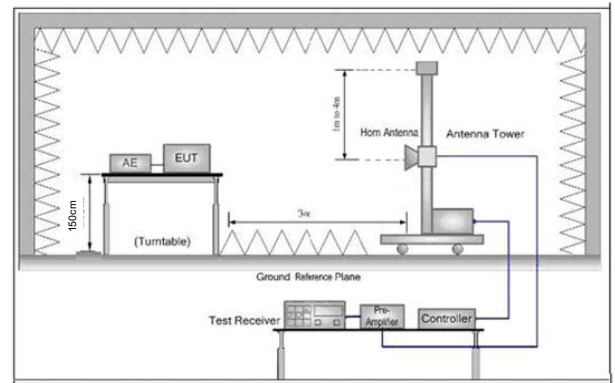


Figure 3. Above 1 GHz

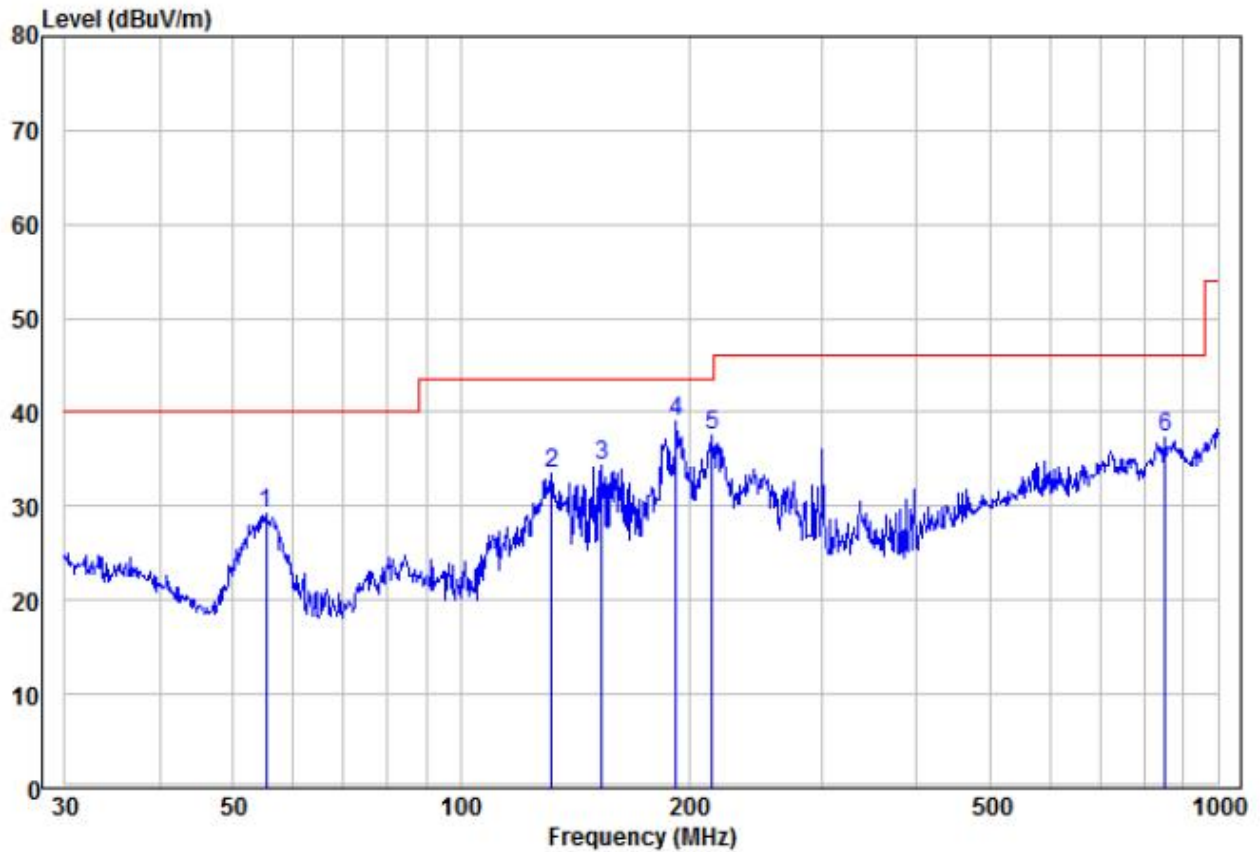
- a. 1) Below 1G: The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.  
2) Above 1G: The EUT was placed on the top of a rotating table 1.5 meters above the ground at a 3 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.  
Note: For the radiated emission test above 1GHz:

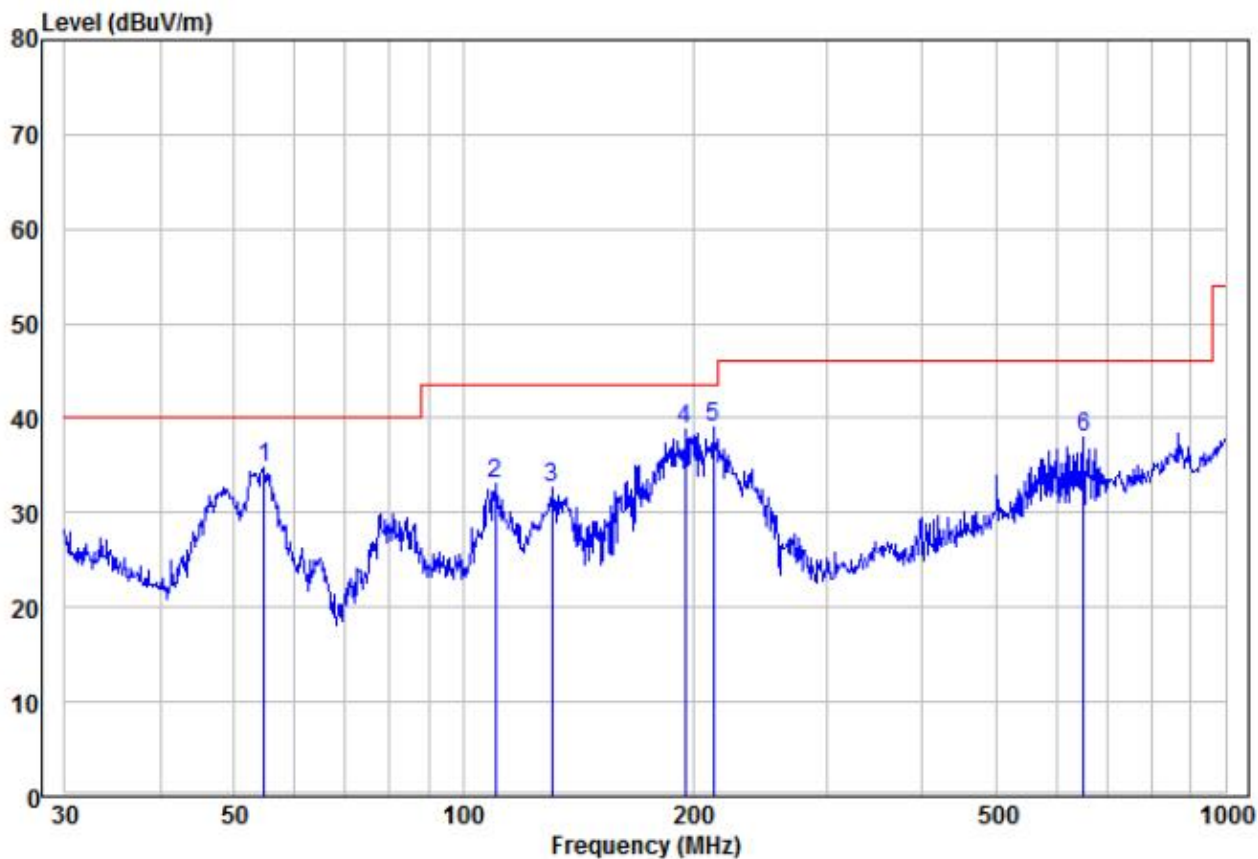

Final Test Level = Receiver Reading + Antenna Factor + Cable Factor – Preamplifier Factor
- Scan from 9kHz to 25GHz, the disturbance above 10GHz and below 30MHz was very low. As shown in this section, for frequencies above 1GHz, the field strength limits are based on average limits. 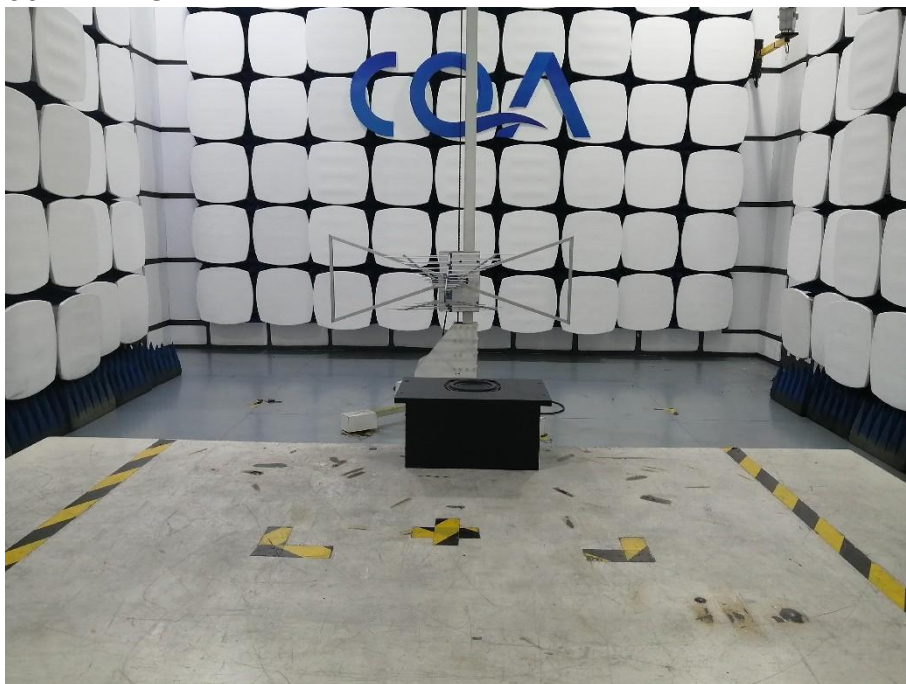

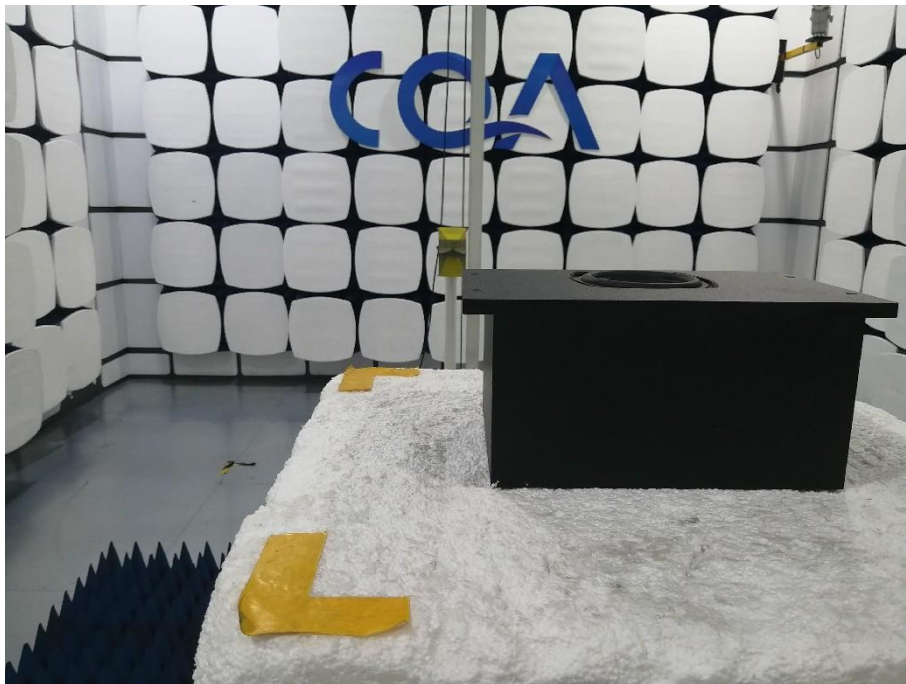

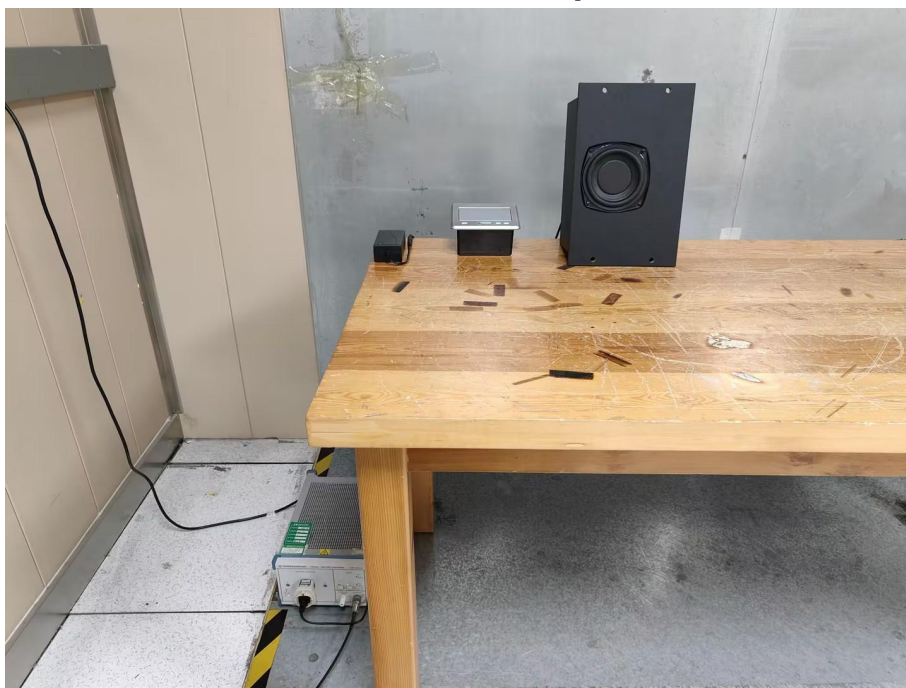
