1.8.4 Frequency Stability:

According to description of ANSI C63.4-1992 sec.13.1.5 and sec.13.1.6, the frequency stability measurements were carried out. 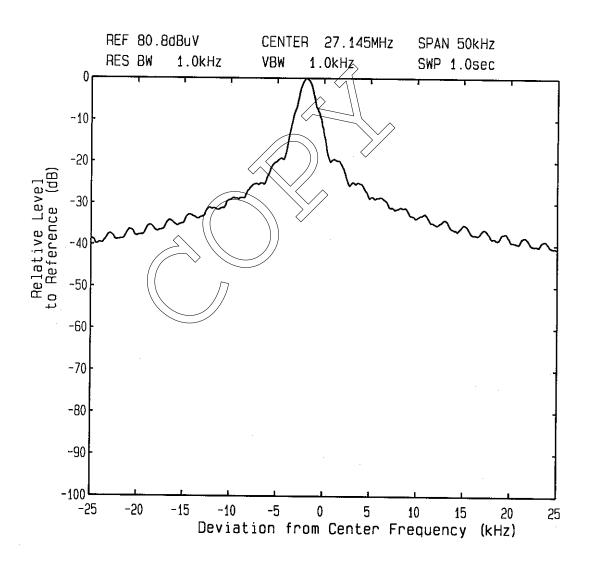

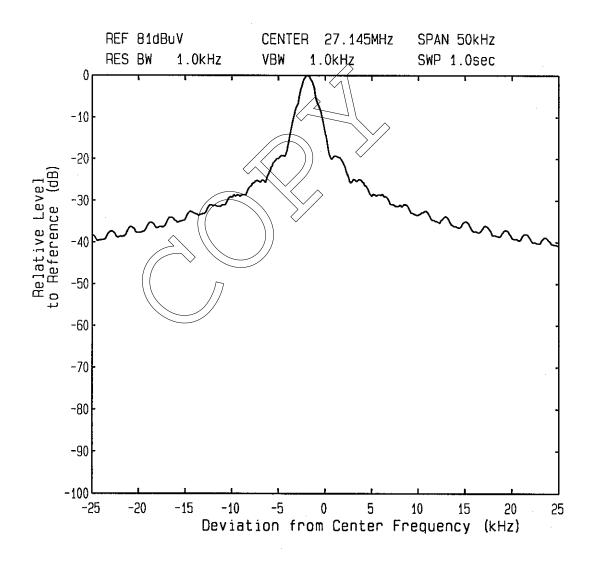

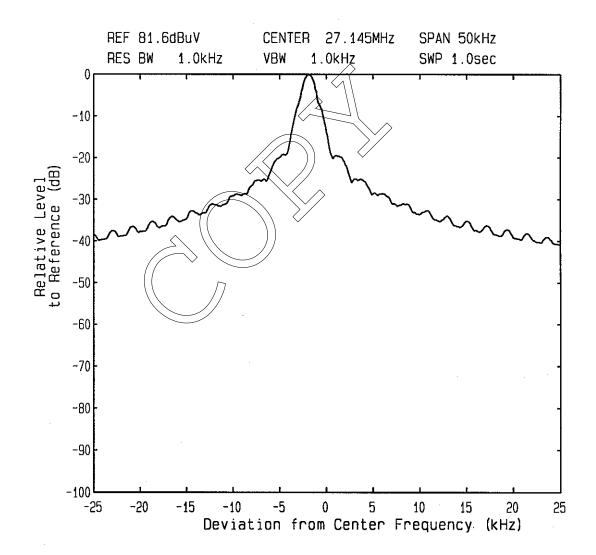

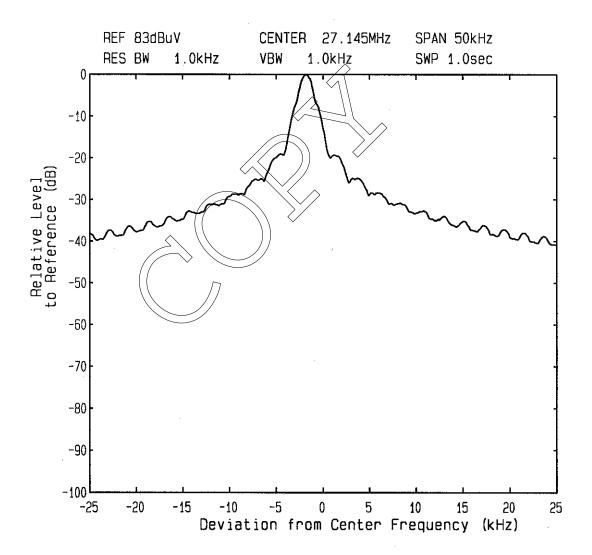
