R4) The antenna specifications have been attached as a separate exhibit [Antenna Specs](#). Included is data for both the HKAD4001A 1/4-wave antenna (pages 1-2, refer to model

number QW220) and the HKAD4002A 5/8-wave antenna (pages 3-5, refer to model number B2003).

Q5) Users manual pg 100 lists only 1/4 wave antenna, MPE report shows 5/8 wave antenna - please clarify and/or submit correct users manual.

R5) The corrected Users Manual attached as a separate exhibit [Corrected Users Manual](#) now includes both the 1/4-wave and 5/8-wave antennas. This information is on page 94 of the manual.
