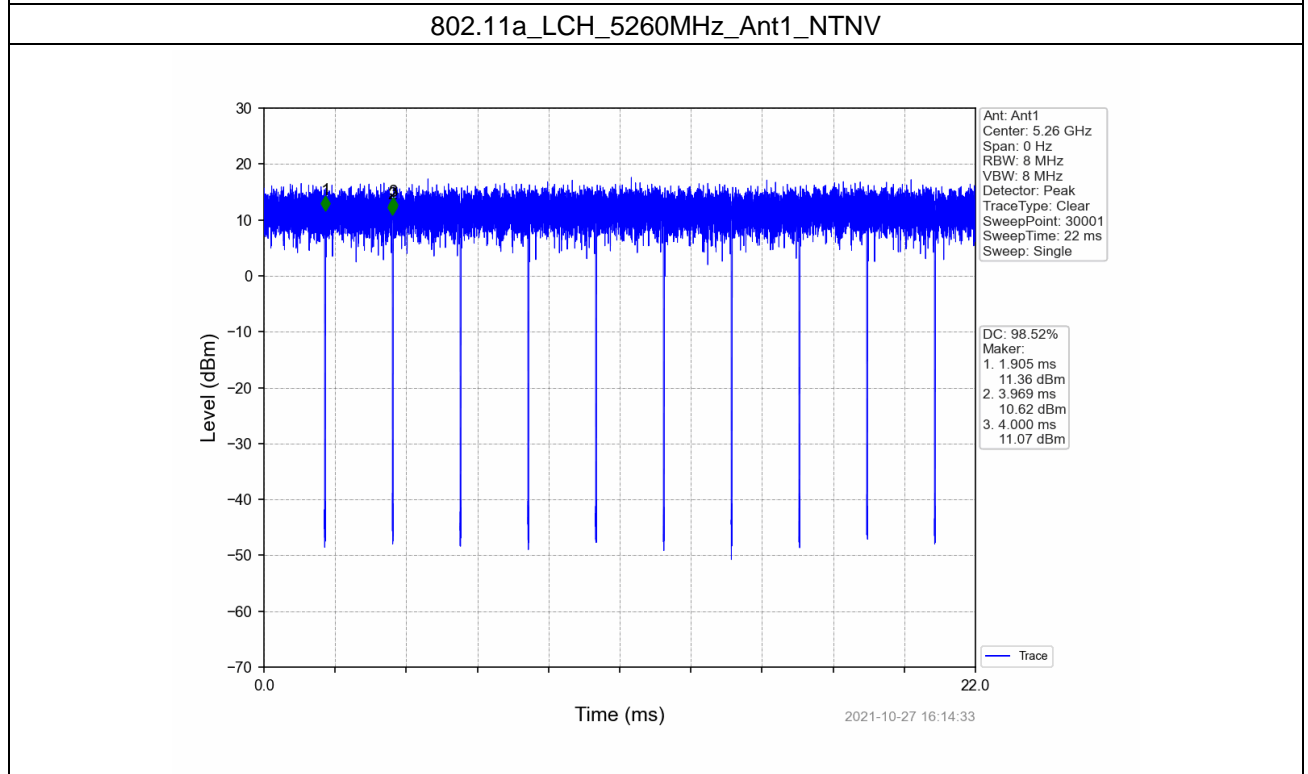
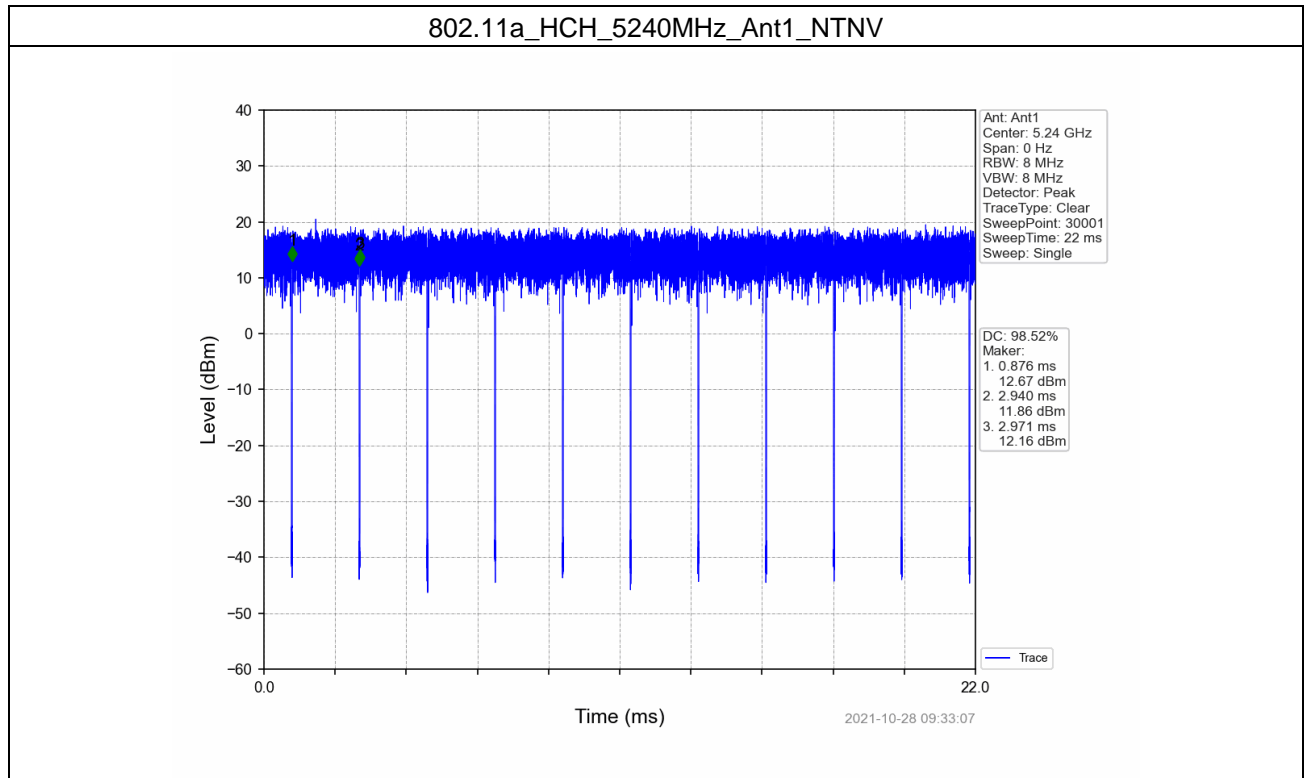
### 1.1.2 Test Graph

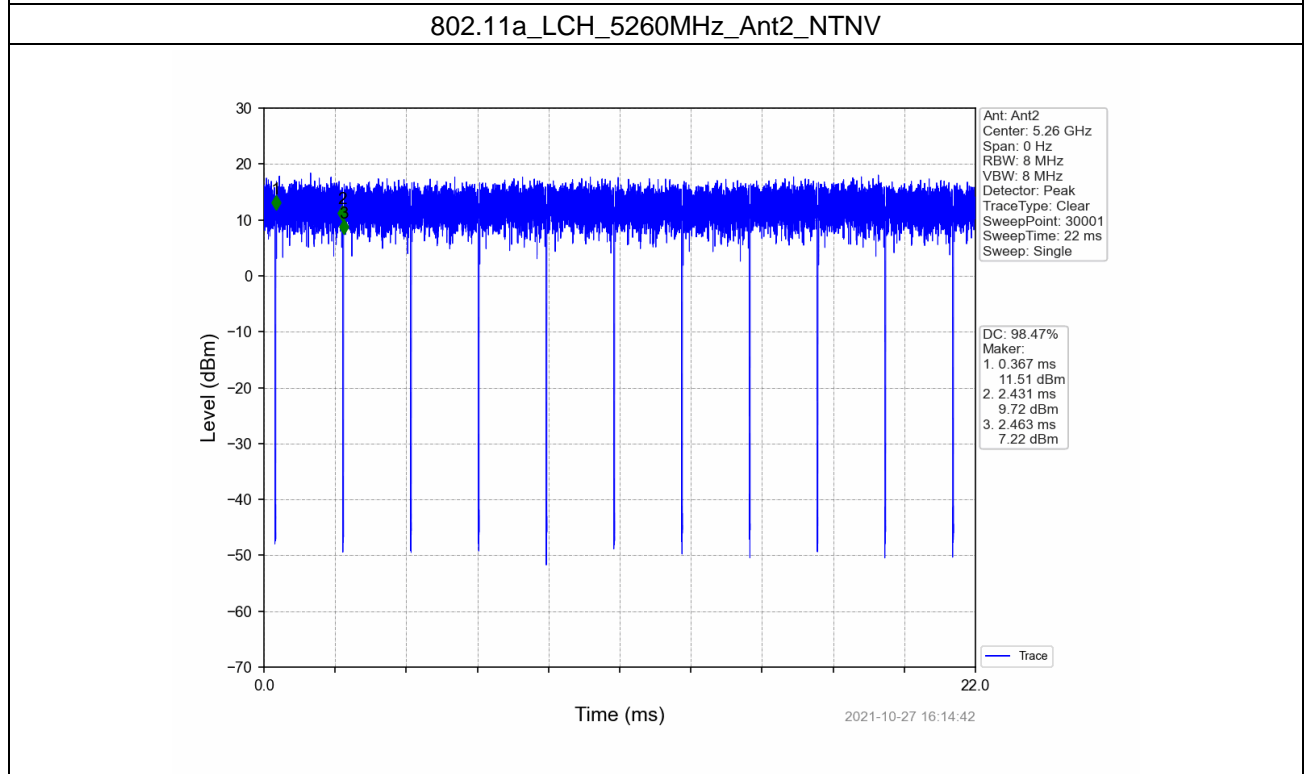
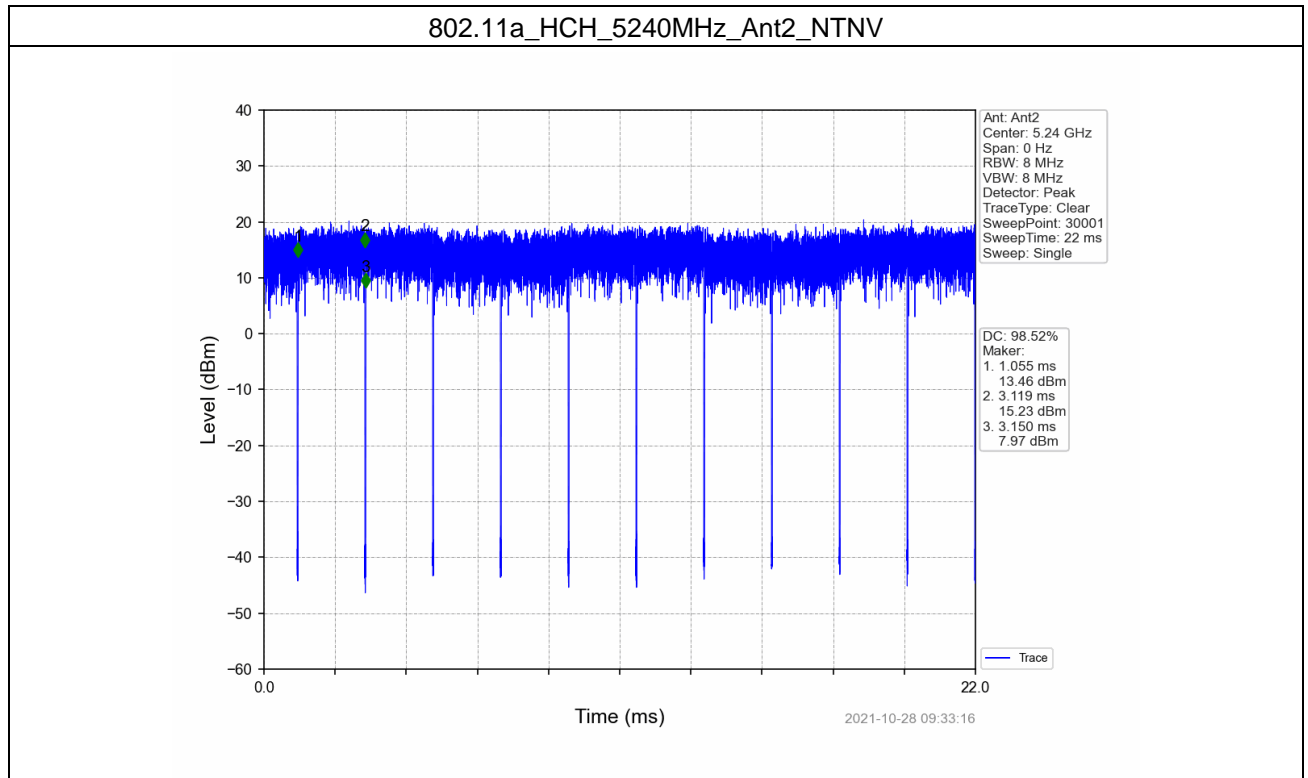
### 1.2.2 Test Graph
