

Photograph of the tissue simulant fluid liquid depth (Head)












Fig.3 EUT Back side to flat phantom






Fig.6 EUT Right side to flat phantom



Fig.10 Antenna position of EUT (Tablet mode)




Fig.11 Antenna position of EUT (Laptop mode)
