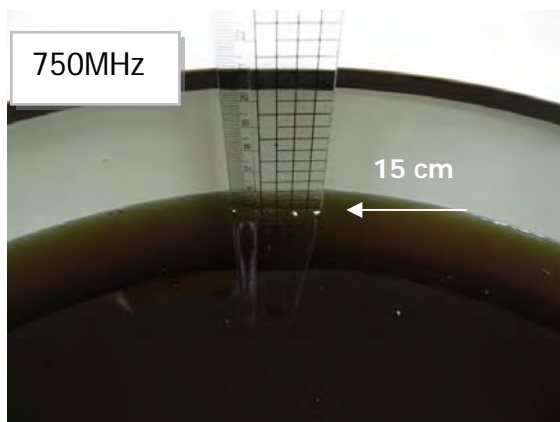

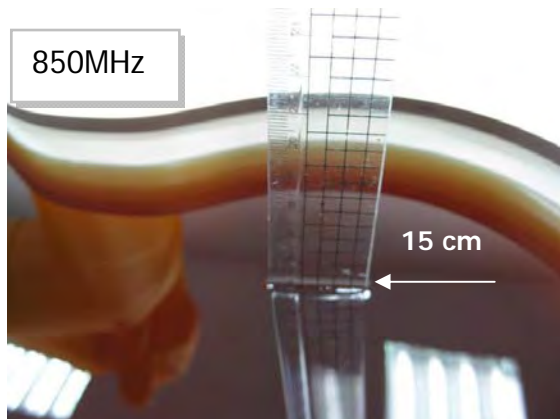

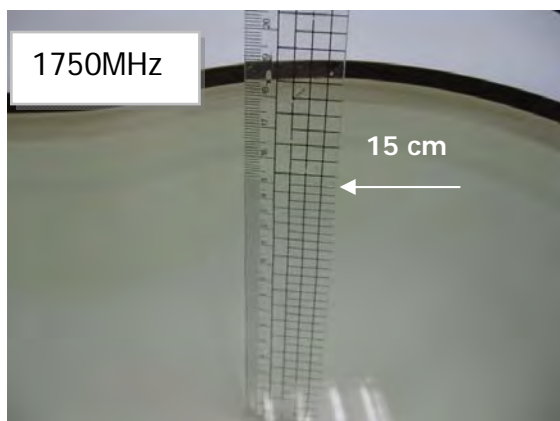

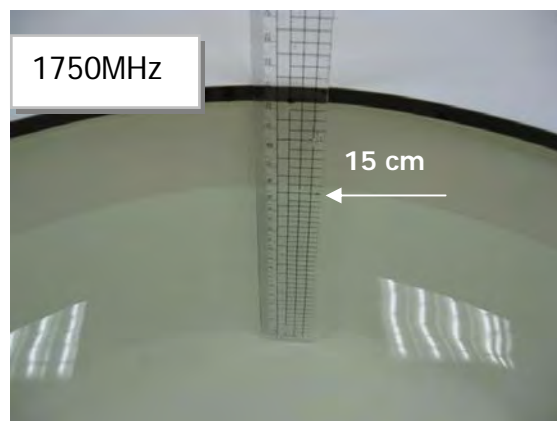

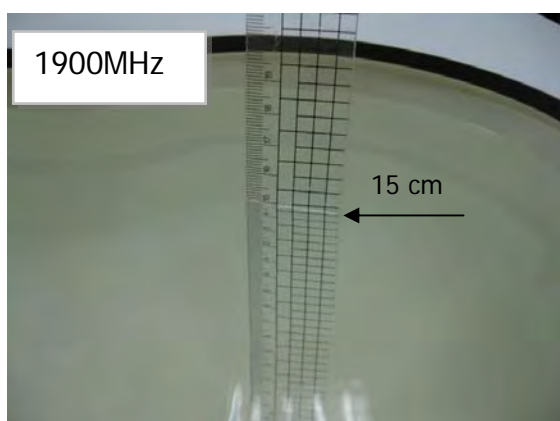

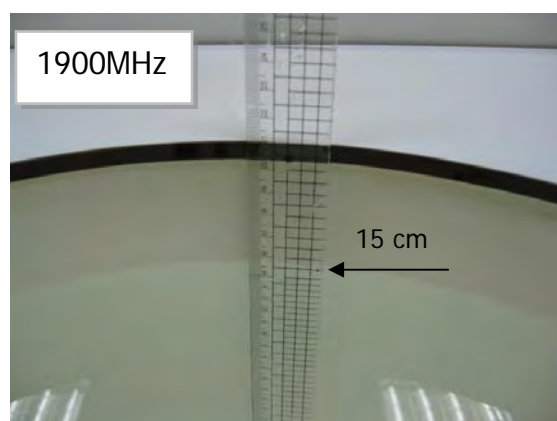

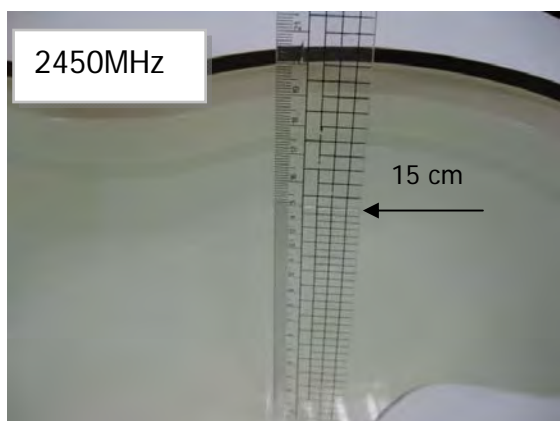

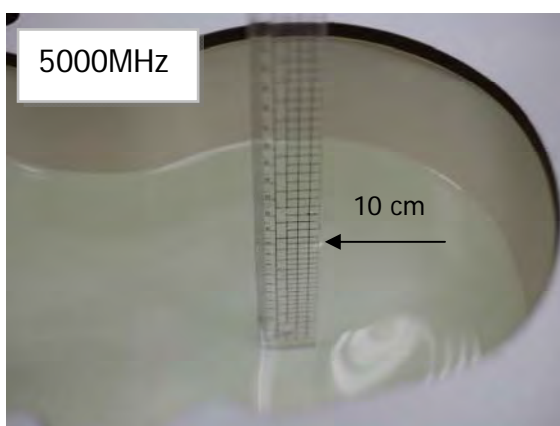

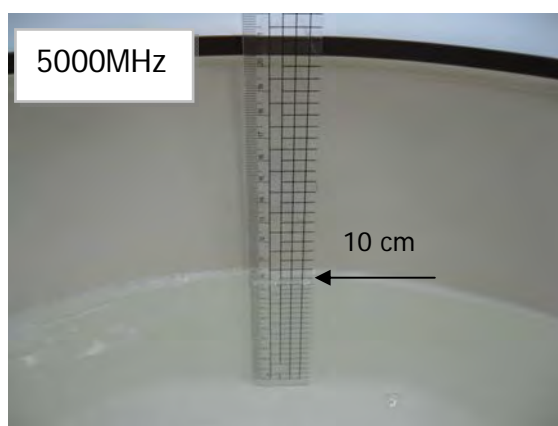

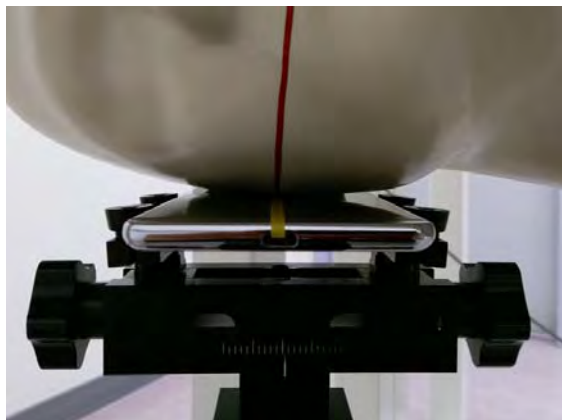


Fig.4 Right Head Section / Cheek-Touch Position

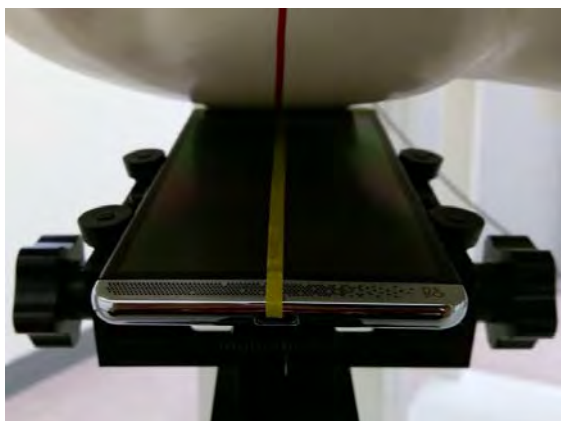
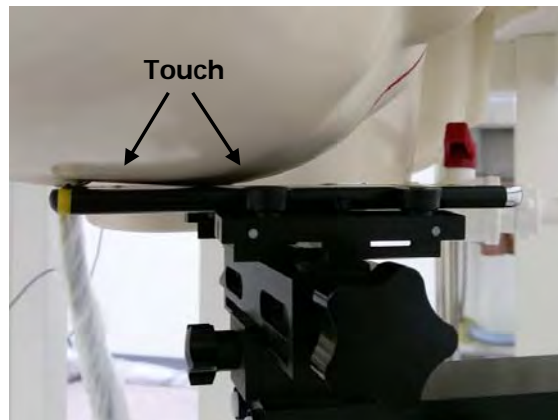


Fig.5 Right Head Section / Ear-Tilt Position(15°)

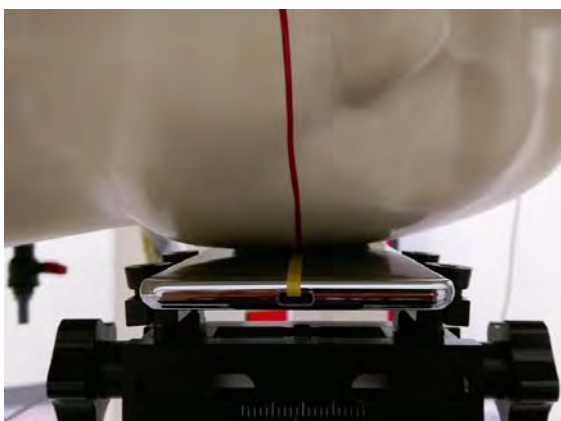
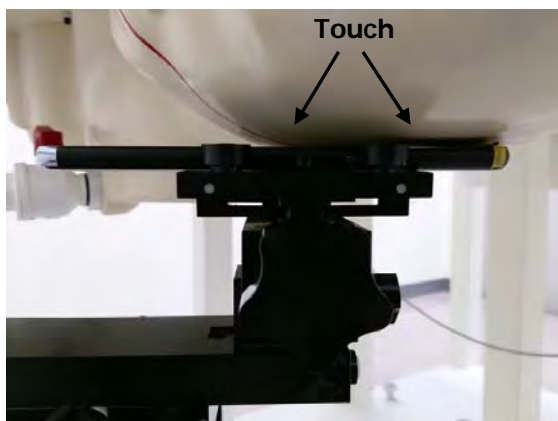


Fig.6 Left Head Section / Cheek-Touch Position

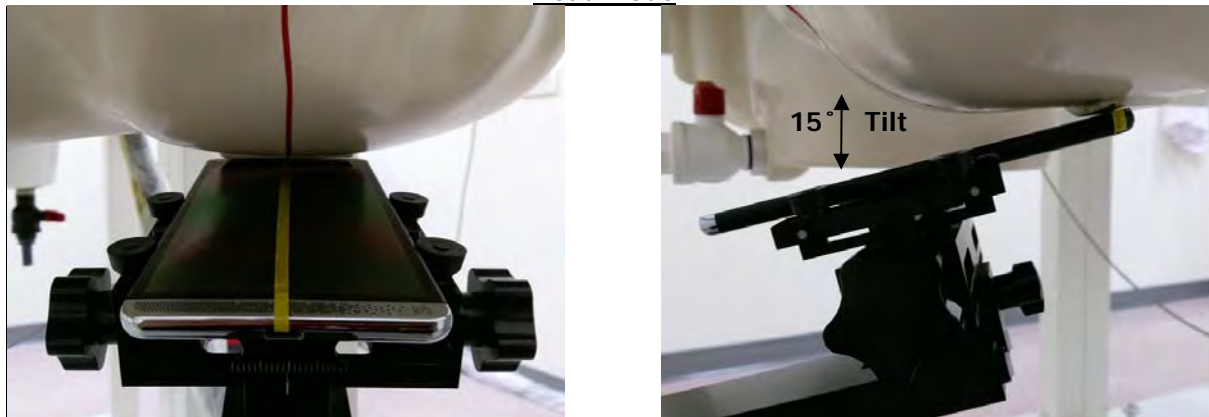

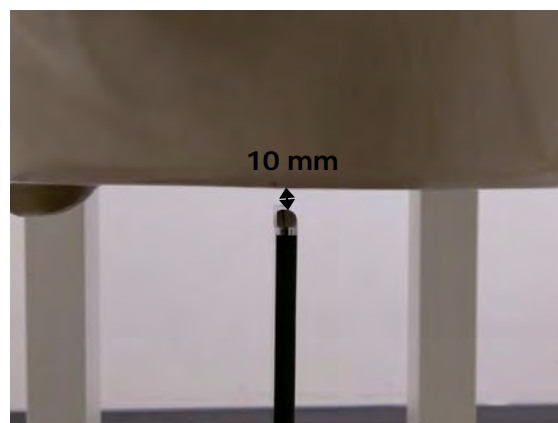
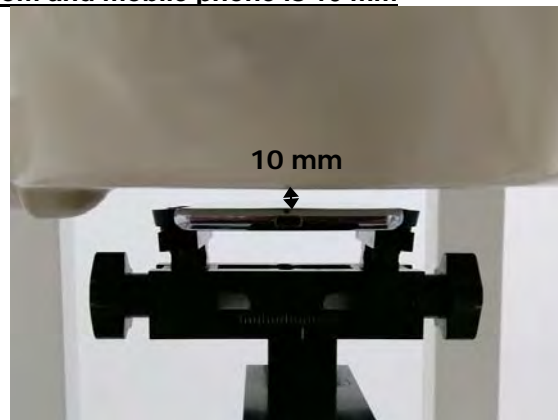

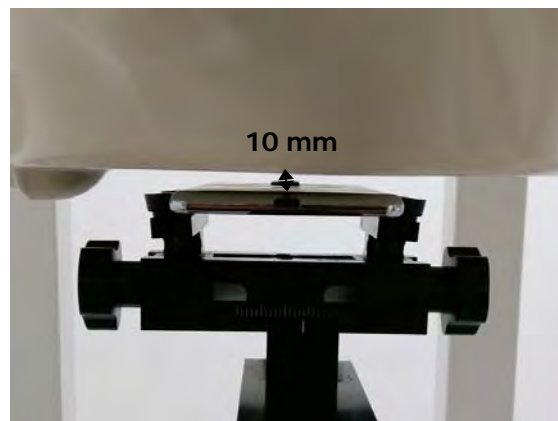

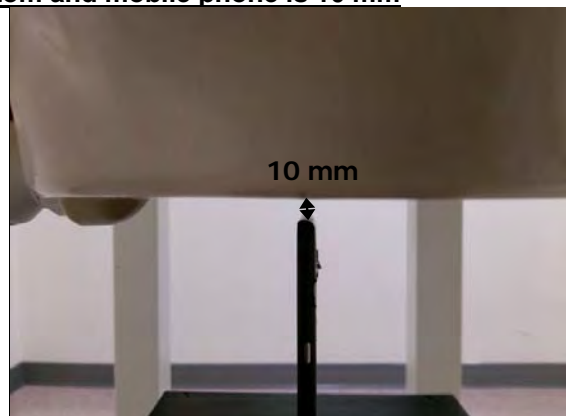

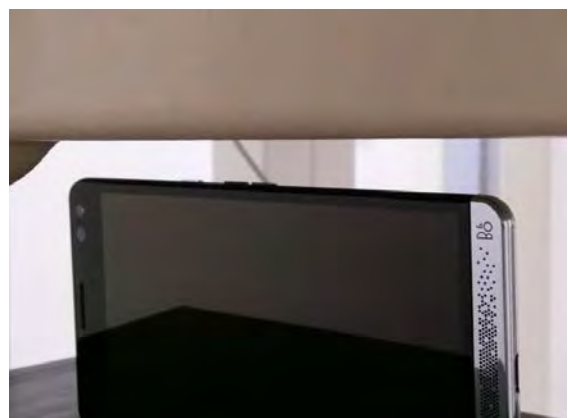
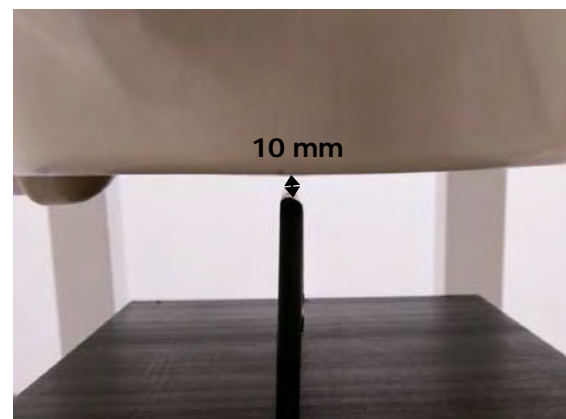

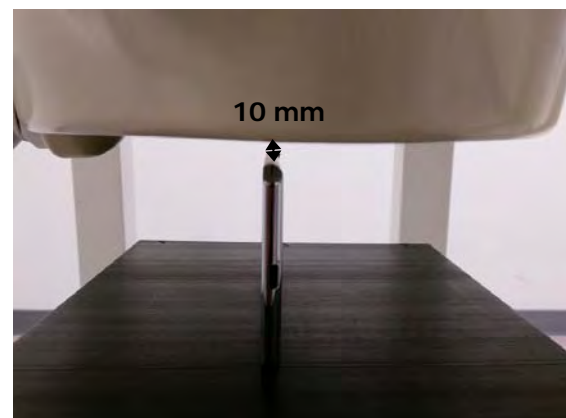
**Fig.11 EUT Top side to flat phantom**

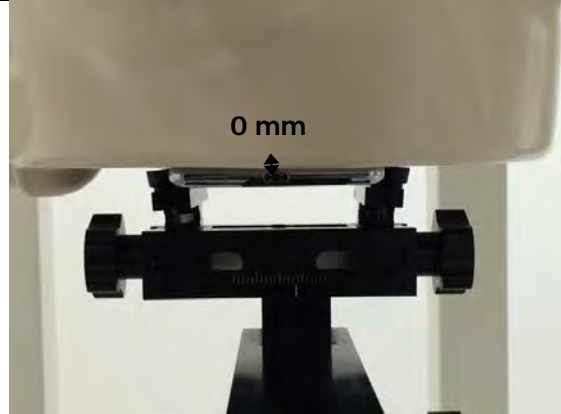

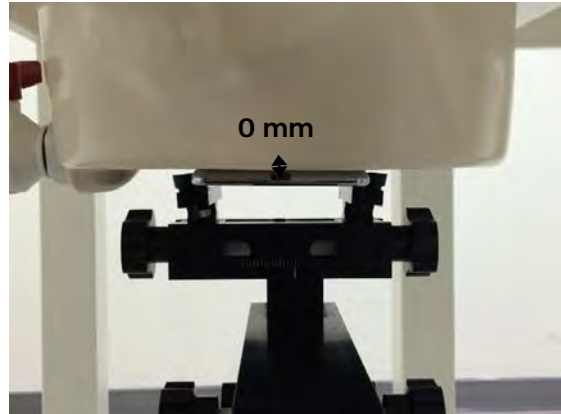

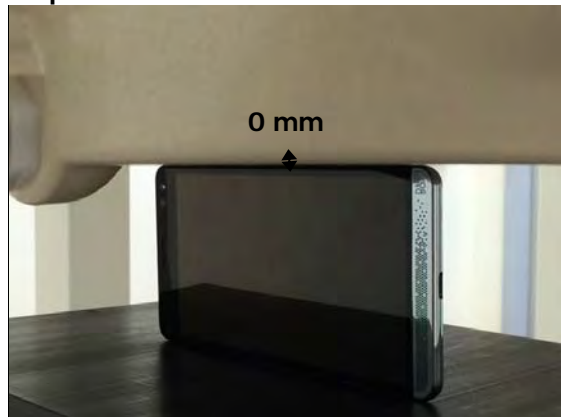
**Fig.14 EUT front to flat phantom**

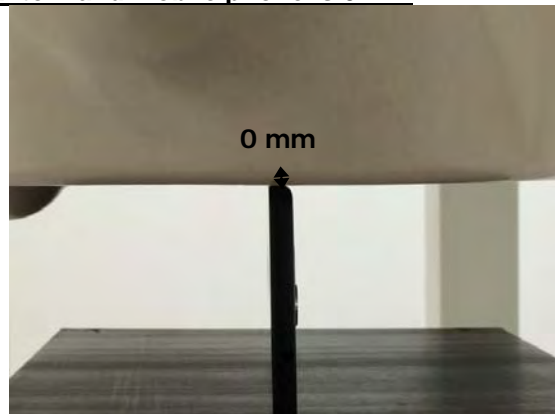

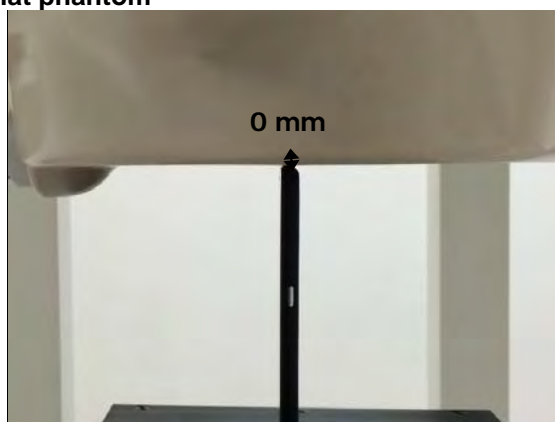
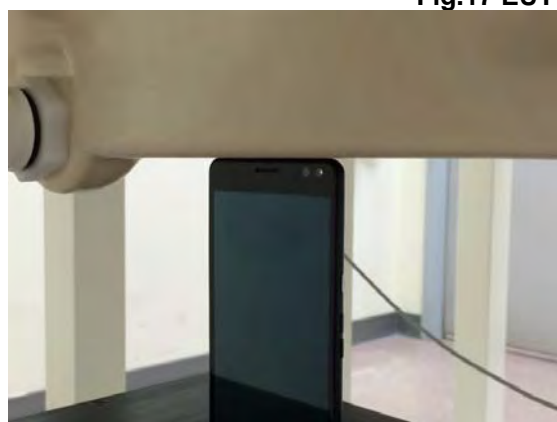

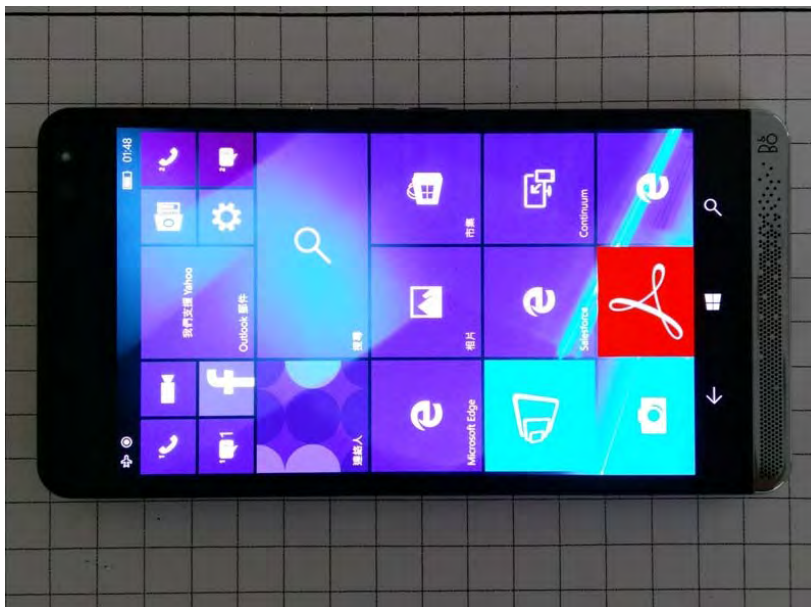


Fig.19 Front view of EUT

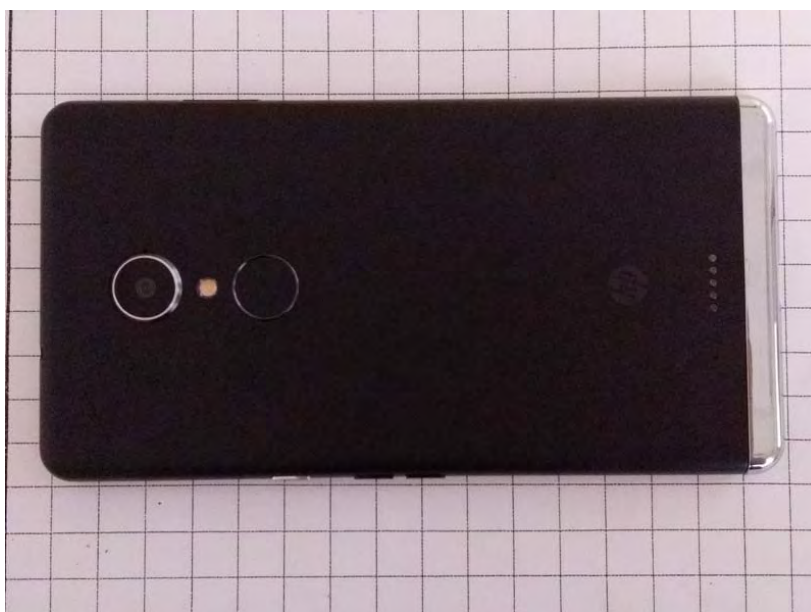


Fig.20 Back view of EUT

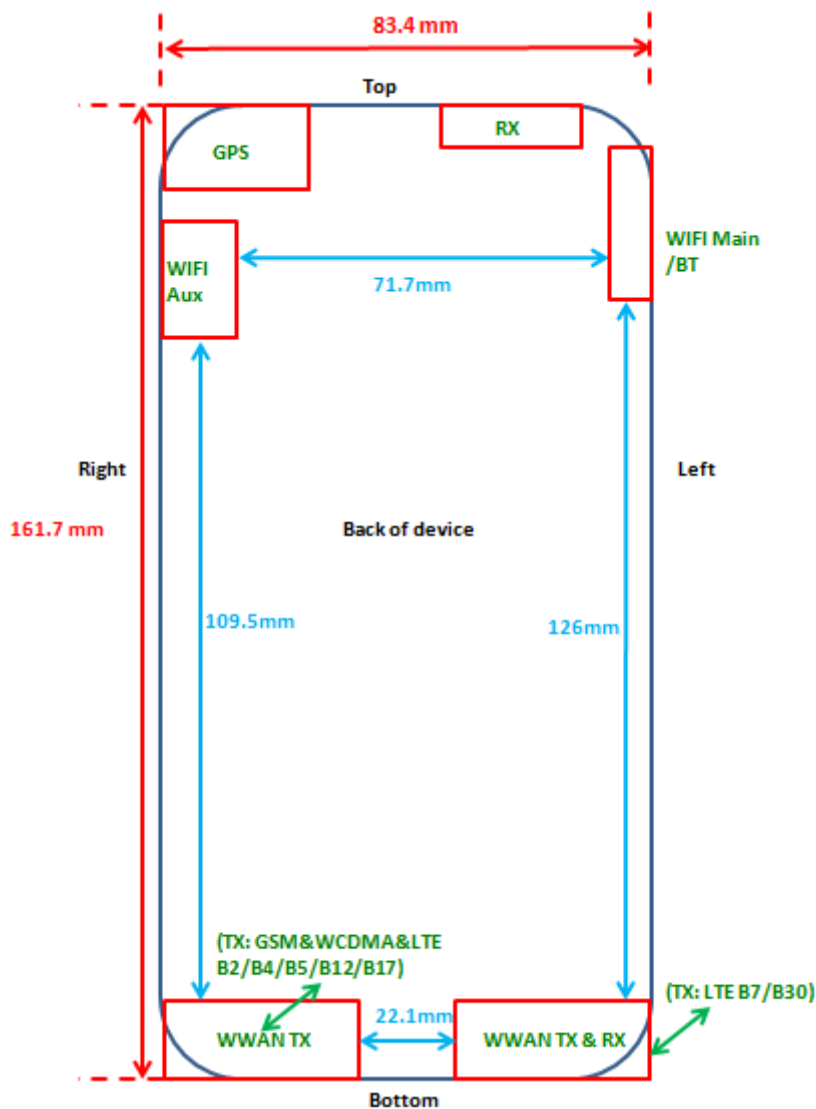


Fig.21 Antenna position of EUT
