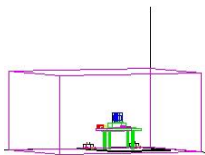

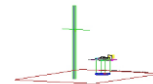

1.0 INTRODUCTION

1.1 Scope

Measurement and determination of electromagnetic emissions (EMC) of radio frequency devices including intentional and/or unintentional radiators for compliance with the technical rules and regulations of the Federal Communications Commission.

1.2 Element Materials Technology Test Location

These measurement tests were conducted at the Element Materials Technology facility located at 18855 Adams Court, Morgan Hill, CA 95037. The measurement facility is compliant with the test site requirements specified in ANSI C63.4-2014 and KDB 414788 D01 v01r01.

2.0 PRODUCT INFORMATION

2.1 Equipment Description

The Equipment Under Test (EUT) is the **Apple Wireless Right Earbud FCC ID: BCG-A3063**. The test data contained in this report pertains only to the emissions due to the EUT's Narrowband UNII transmitter.

- This Narrowband UNII module has been tested by manufacturer and the following were confirmed:
 - A) The hopping sequence is pseudorandom
 - B) The receiver input bandwidth equals the transmit bandwidth
 - C) The receiver hops in sequence with the transmit signal
 - D) Narrowband UNII can only hop within the same UNII band and cannot hop between bands

The maximum achievable duty cycles for all modes were determined based on measurements performed on a spectrum analyzer in zero-span mode with RBW = 8MHz, VBW = 50MHz, and detector = peak per the guidance of Section B)2)b) of KDB 789033 D02 v02r01 and ANSI C63.10-2020. The RBW and VBW were both greater than 50/T, where T is the minimum transmission duration, and the number of sweep points across T was greater than 100. The duty cycles are as follows:

2.5 Test Configuration

The EUT was tested per the guidance of ANSI C63.10-2020 and KDB 789033 D02 v02r01. ANSI C63.10-2020 was used to reference the appropriate EUT setup for radiated spurious emissions testing and AC line conducted testing. See Sections 3.2 for AC line conducted emissions test setups, 3.3 for radiated emissions test setups, and 7.27.2, 7.3, 7.4, and 7.5 for antenna port conducted emissions test setups.

The EUT was investigated with and without charging case. The worst case configuration found was used for all testing.

For emissions from 1GHz – 18GHz, low, mid, and high channels were tested with highest power and worst case configuration. The emissions below 1GHz and above 18GHz were tested with the highest transmitting power and the worst case channel.

The EUT was manipulated through three orthogonal planes of X-orientation (flatbed), Y-orientation (landscape), and Z-orientation (portrait) during the testing. Only the worst case emissions were reported in this test report.

For AC line conducted and radiated test below 1GHz, following configurations were investigated and EUT powered by AC/DC adaptor was the worst case.


- EUT charged by charging case and powered by AC/DC adaptor with USB-C cable
- EUT charged by charging case and powered by host PC with USB-C cable

2.6 Software and Firmware

The test was conducted with firmware version 8A357 installed on the EUT.

3.0 DESCRIPTION OF TESTS

3.1 Evaluation Procedure

The measurement procedures described in the American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices (ANSI C63.10-2020) and the guidance provided in KDB 789033 D02 v02r01 were used in the measurement of the EUT.

3.2 AC Line Conducted Emissions

The line-conducted facility is located inside a 7m x 3.66m x 2.7m shielded enclosure. The shielded enclosure is manufactured by AP Americas. The shielding effectiveness of the shielded room is in accordance with MIL-Std-285 or NSA 65-6. A 1m x 1.5m wooden table 80cm high is placed 40cm away from the vertical wall and 80cm away from the sidewall of the shielded room. Two 10kHz-30MHz, 50Ω/50μH Line-Impedance Stabilization Networks (LISNs) are bonded to the shielded room floor. Power to the LISNs is filtered by external high-current high-insertion loss power line filters. The external power line filter is EPCOS 2X60A Power Line Filter (100dB Attenuation, 14kHz-18GHz) and the two EPCOs 2X48A filters (100dB Minimum Insertion Loss, 14kHz - 10GHz). These filters attenuate ambient signal noise from entering the measurement lines. These filters are also bonded to the shielded enclosure.

The EUT is powered from one LISN and the support equipment is powered from the second LISN. If the EUT is a DC-powered device, power will be derived from the source power supply it normally will be powered from and this supply line(s) will be connected to the second LISN. All interconnecting cables more than 1 meter were shortened to a 1 meter length by non-inductive bundling (serpentine fashion) and draped over the back edge of the test table. All cables were at least 40cm above the horizontal reference ground plane. Power cables for support equipment were routed down to the second LISN while ensuring that that cables were not draped over the second LISN.

Sufficient time for the EUT, support equipment, and test equipment was allowed in order for them to warm up to their normal operating condition. The RF output of the LISN was connected to the spectrum analyzer and exploratory measurements were made to determine the frequencies producing the maximum emission from the EUT. The spectrum was scanned from 150kHz to 30MHz with a spectrum analyzer. The detector function was set to peak mode for exploratory measurements while the bandwidth of the analyzer was set to 10kHz. The EUT, support equipment, and interconnecting cables were arranged and manipulated to maximize each emission. Once the worst case emissions have been identified, the one EUT cable configuration/arrangement and mode of operation that produced these emissions is used for final measurements on the same test site. The analyzer is set to CISPR quasi-peak and average detectors with a 9kHz resolution bandwidth for final measurements.

Line conducted emissions test results are shown in Section 7.8. Automated test software was used to perform the AC line conducted emissions testing. Automated measurement software utilized is Rohde & Schwarz EMC32, Version 10.50.40.

3.3 Radiated Emissions

The radiated test facilities consisted of an indoor 3 meter semi-anechoic chamber used for final measurements and exploratory measurements, when necessary. The measurement area is contained within the semi-anechoic chamber which is shielded from any ambient interference. The test site inside the chamber is a 6m x 5.2m elliptical, obstruction-free area in accordance with Figure 5.7 of Clause 5 in ANSI C63.4-2014. Absorbers are arranged on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections for measurements above 1GHz. An 80cm tall test table made of Styrodur is placed on top of the turn table. For measurements above 1GHz, an additional Styrodur pedestal is placed on top of the test table to bring the total table height to 1.5m.

Per KDB 414788 D01 v01r01, radiated emission test sites other than open-field test sites (e.g., shielded anechoic chambers), may be employed for emission measurements below 30MHz if characterized so that the measurements correspond to those obtained at an open-field test site. To determine test site equivalency, a reference sample transmitting at 149kHz was measured on an open field test site (asphalt with no ground plane) and then measured in the 3m semi-anechoic chamber. A calibrated 60cm loop antenna was used while the reference device was rotated through the X, Y and Z axis in order to capture the worst case level. A maximum deviation of 2.77dB at 149kHz was measured when comparing the 3 meter semi-anechoic chamber to the open field site.

For all measurements, the spectrum was scanned through all EUT azimuths and from 1 to 4 meter receive antenna height using a broadband antenna from 30MHz up to the upper frequency shown in 15.33 depending on the highest frequency generated or used in the device or on which the device operates or tunes. For frequencies above 1GHz, linearly polarized double ridge horn antennas were used. For frequencies below 30MHz, a calibrated loop antenna was used. When exploratory measurements were necessary, they were performed at 1 meter test distance inside the semi-anechoic chamber using broadband antennas, broadband amplifiers, and spectrum analyzers to determine the frequencies and modes producing the maximum emissions. Sufficient time for the EUT, support equipment, and test equipment was allowed in order for them to warm up to their normal operating condition. The test set-up was placed on top of the 1 x 1.5 meter table. The EUT, support equipment, and interconnecting cables were arranged and manipulated to maximize each emission. Appropriate precaution was taken to ensure that all emissions from the EUT were maximized and investigated. The system configuration, mode of operation, turntable azimuth, and receive antenna height was noted for each frequency found.

Final measurements were made in the semi-anechoic chamber using calibrated, linearly polarized broadband and horn antennas. The test setup was configured to the setup that produced the worst case emissions. The spectrum analyzer was set to investigate all frequencies required for testing to compare the highest radiated disturbances with respect to the specified limits. The turntable containing the EUT was rotated through 360 degrees and the height of the receive antenna was varied 1 to 4 meters and stopped at the azimuth and height producing the maximum emission. Each emission was maximized by changing the orientation of the EUT through three orthogonal planes and changing the polarity of the receive antenna, whichever produced the worst-case emissions.

3.4 Environmental Conditions

The temperature is controlled within range of 15°C to 35°C. The relative humidity is controlled within range of 10% to 75%. The atmospheric pressure is monitored within the range 86-106kPa (860-1060mbar).

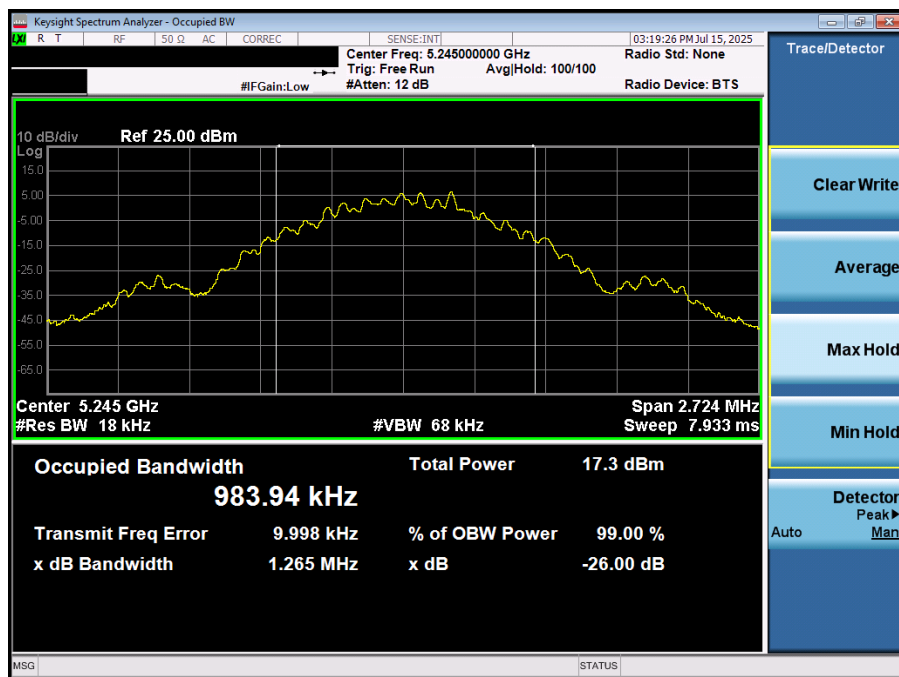


Plot 7-1. 26dB BW & 99% OBW (NB UNII BDR – 5157MHz)

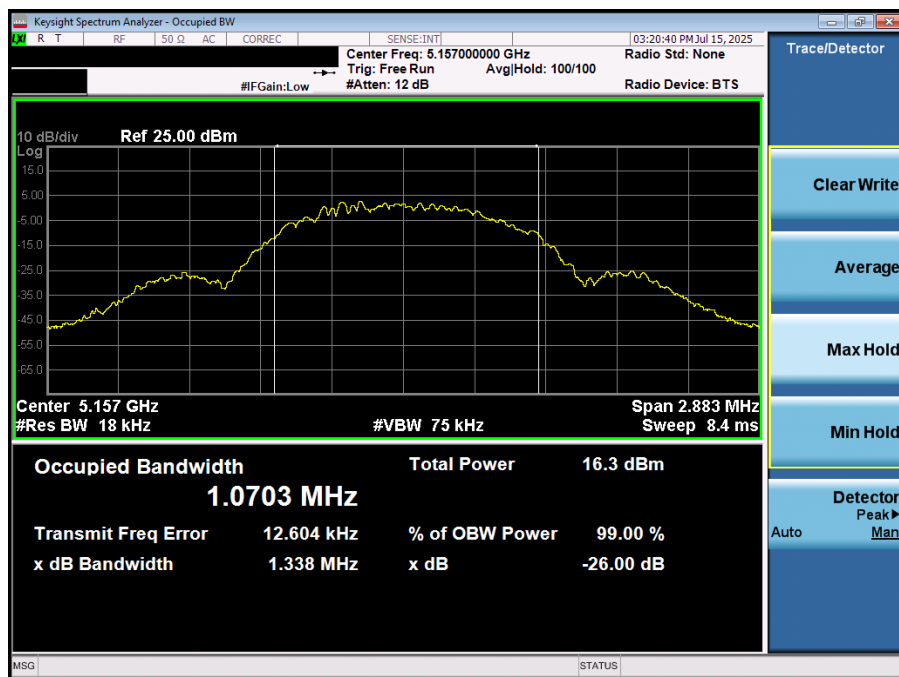


Plot 7-2. 26dB BW & 99% OBW (NB UNII BDR– 5200MHz)

Plot 7-5. 26dB BW & 99% OBW (NB UNII LE1M – 5200MHz)

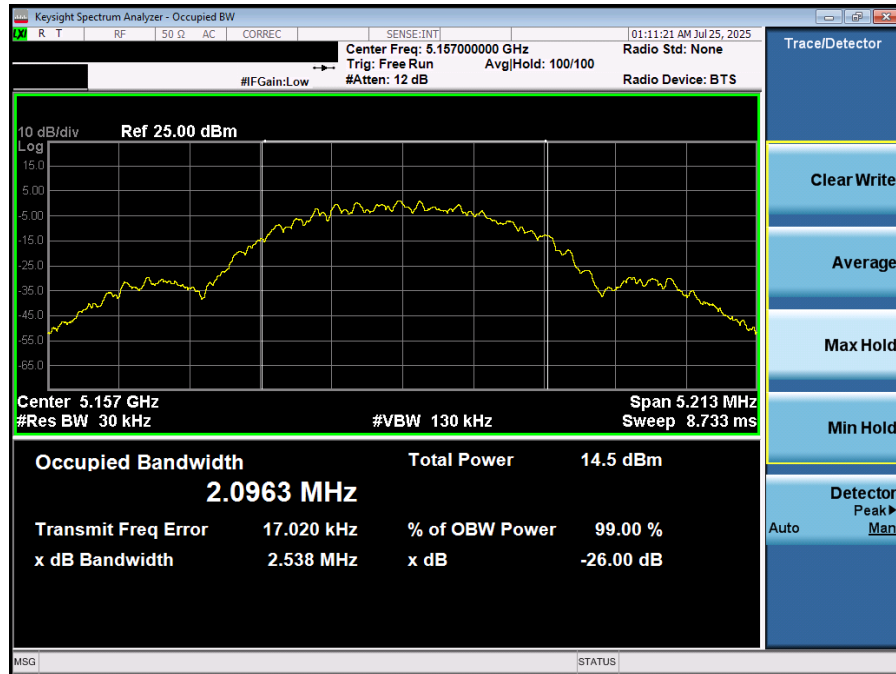


Plot 7-6. 26dB BW & 99% OBW (NB UNII LE1M – 5245MHz)

Plot 7-7. 26dB BW & 99% OBW (NB UNII LE2M – 5157MHz)

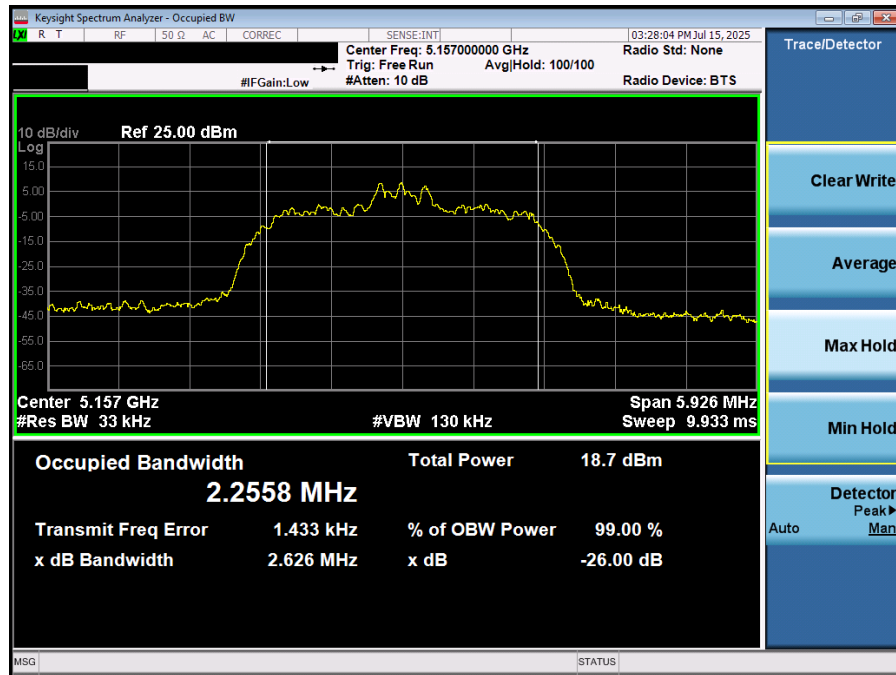


Plot 7-8. 26dB BW & 99% OBW (NB UNII LE2M – 5200MHz)

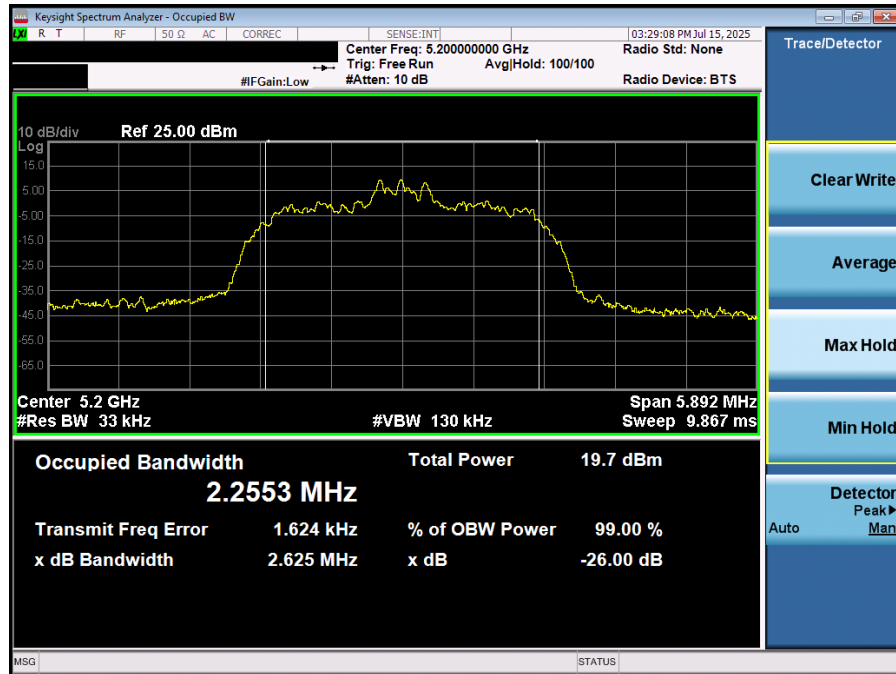


Plot 7-9. 26dB BW & 99% OBW (NB UNII LE2M – 5245MHz)

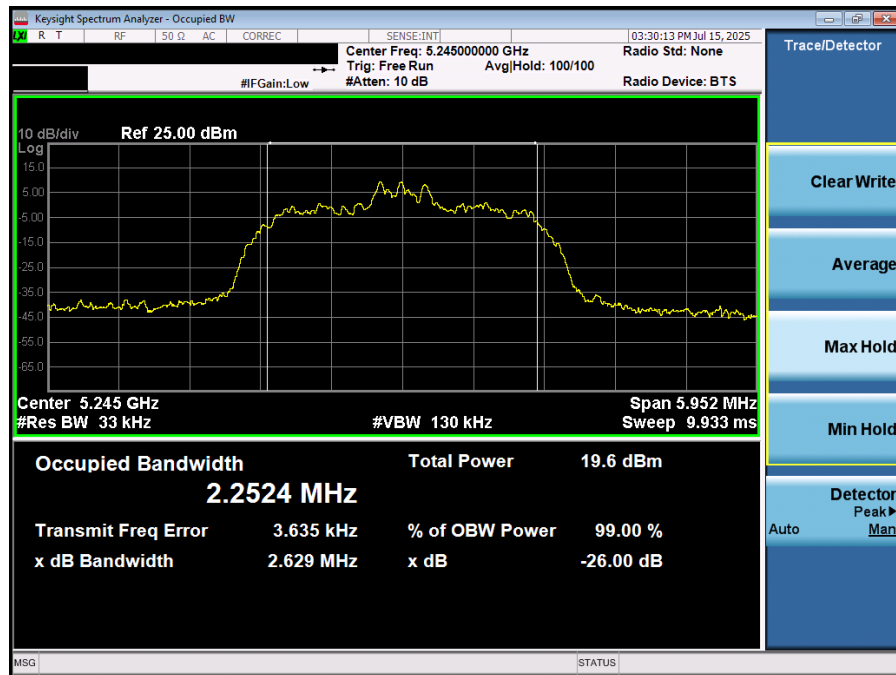


Plot 7-10. 26dB BW & 99% OBW (NB UNII HDR4– 5157MHz)

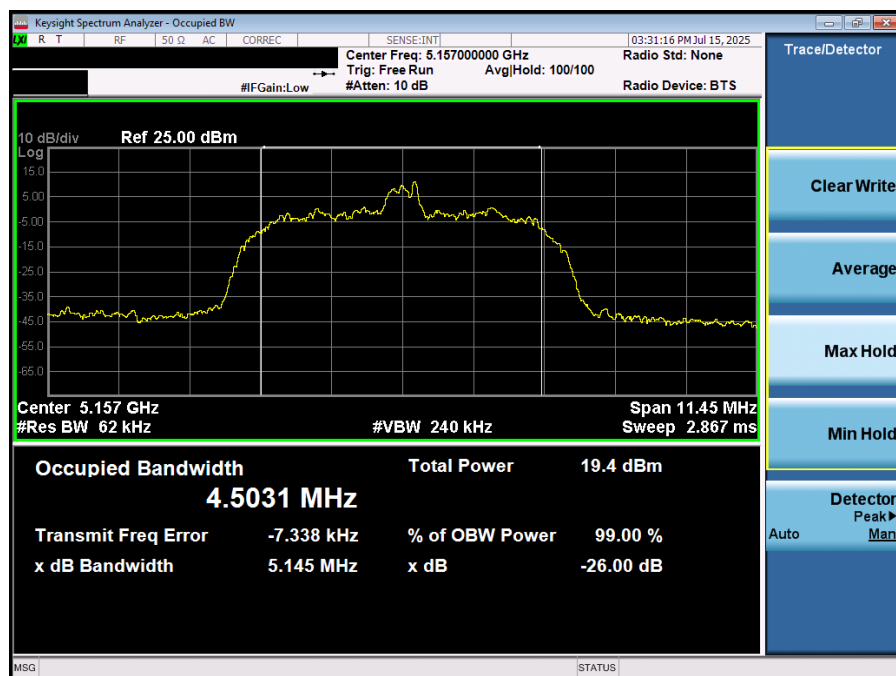


Plot 7-11. 26dB BW & 99% OBW (NB UNII HDR4– 5200MHz)

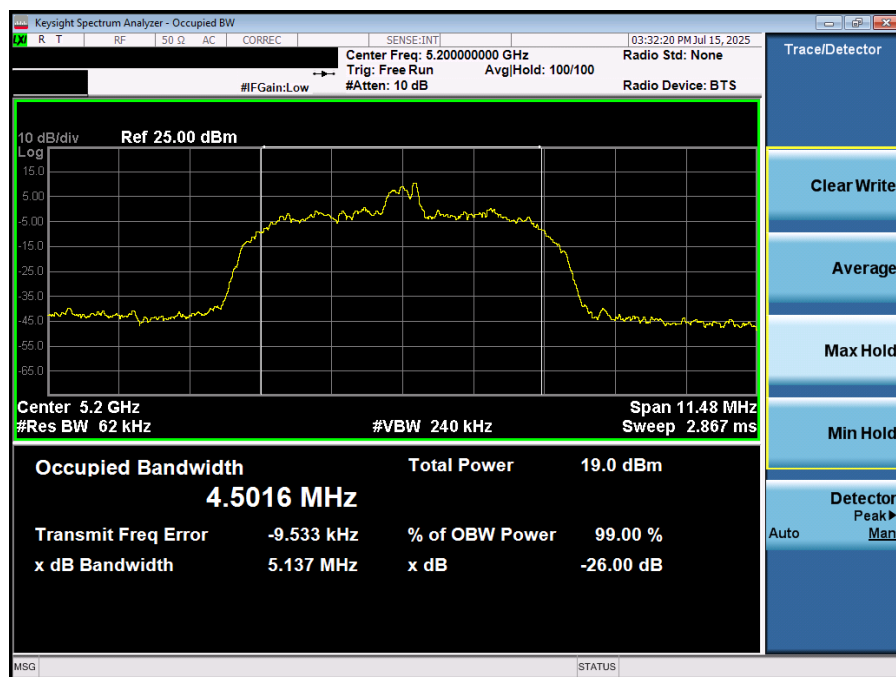


Plot 7-12. 26dB BW & 99% OBW (NB UNII HDR4– 5245MHz)

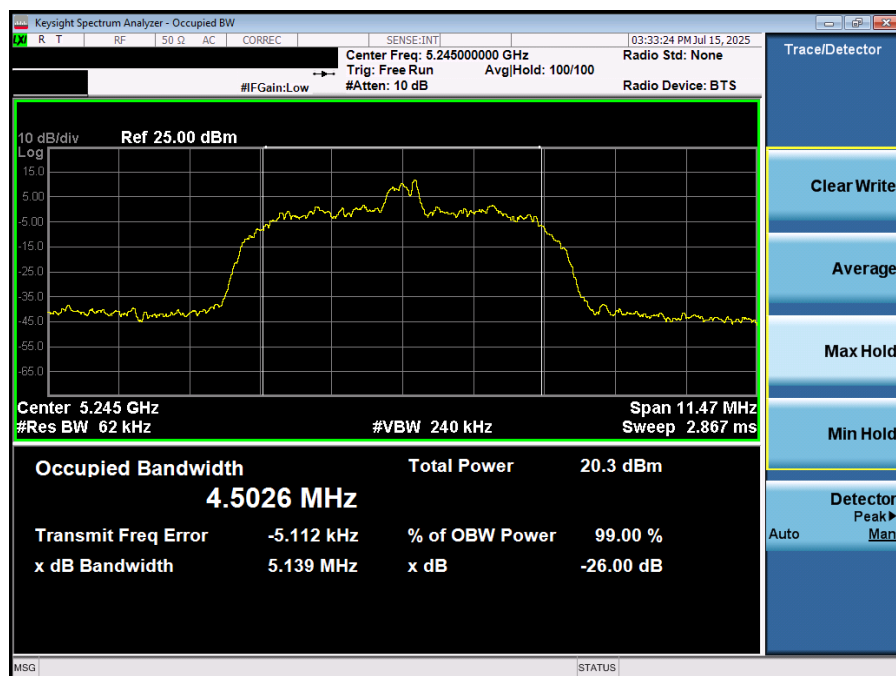


Plot 7-13. 26dB BW & 99% OBW (NB UNII HDR8- 5157MHz)

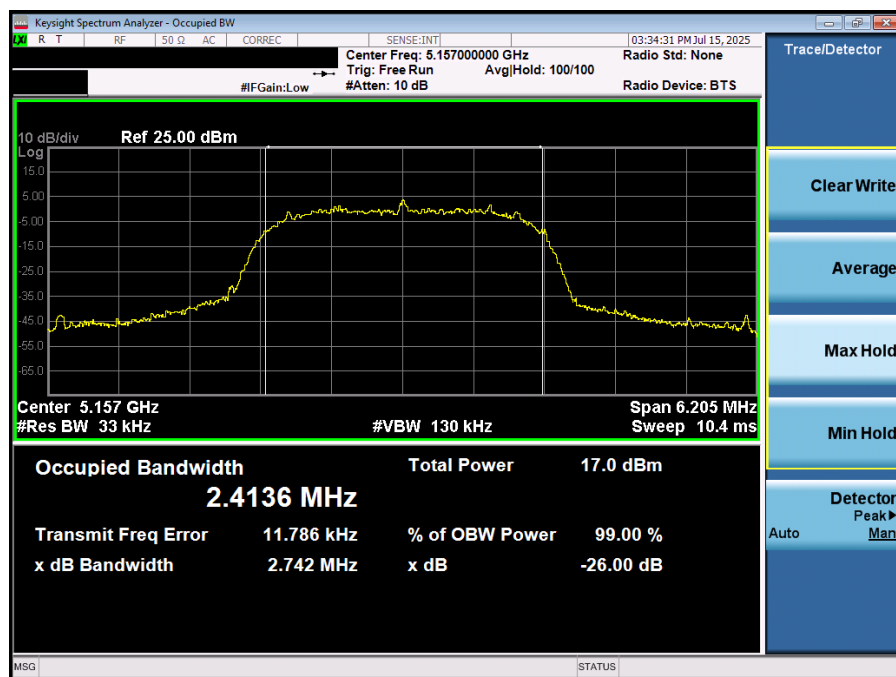


Plot 7-14. 26dB BW & 99% OBW (NB UNII HDR8- 5200MHz)

Plot 7-15. 26dB BW & 99% OBW (NB UNII HDR8– 5245MHz)

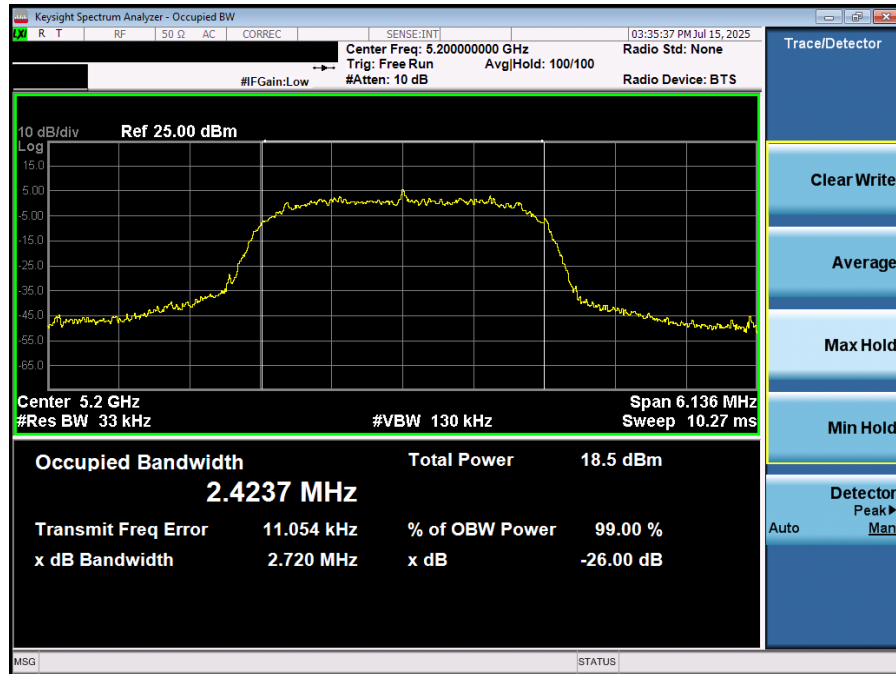


Plot 7-16. 26dB BW & 99% OBW (NB UNII HDRp4– 5157MHz)

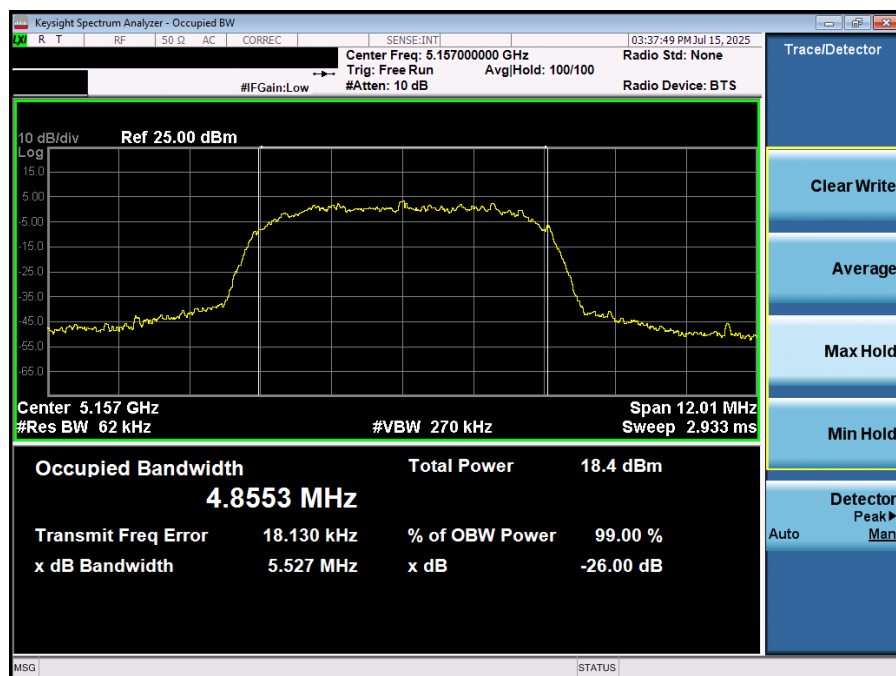


Plot 7-17. 26dB BW & 99% OBW (NB UNII HDRp4– 5200MHz)

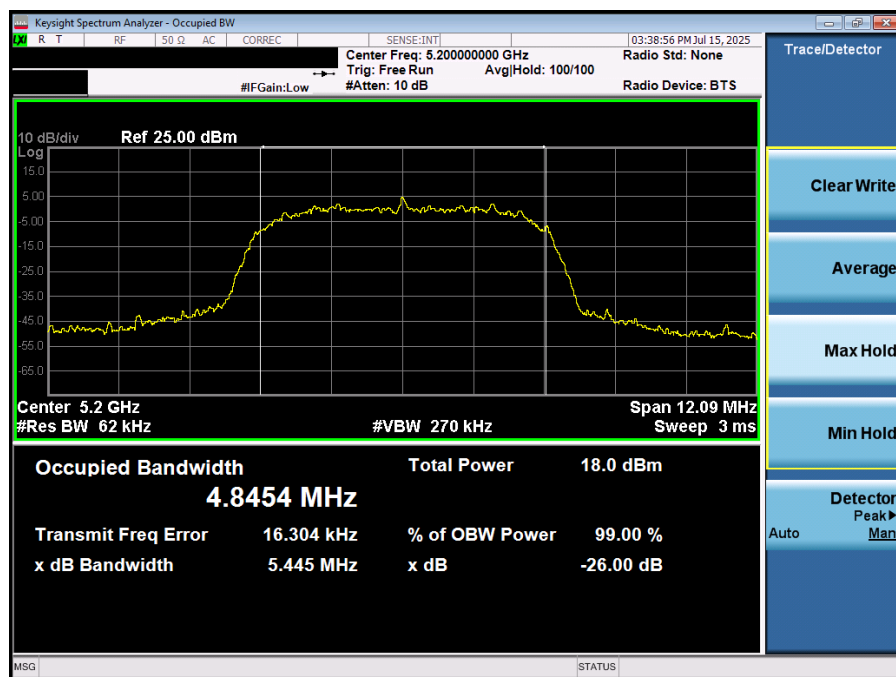


Plot 7-18. 26dB BW & 99% OBW (NB UNII HDRp4– 5245MHz)

Plot 7-19. 26dB BW & 99% OBW (NB UNII HDRp8– 5157MHz)

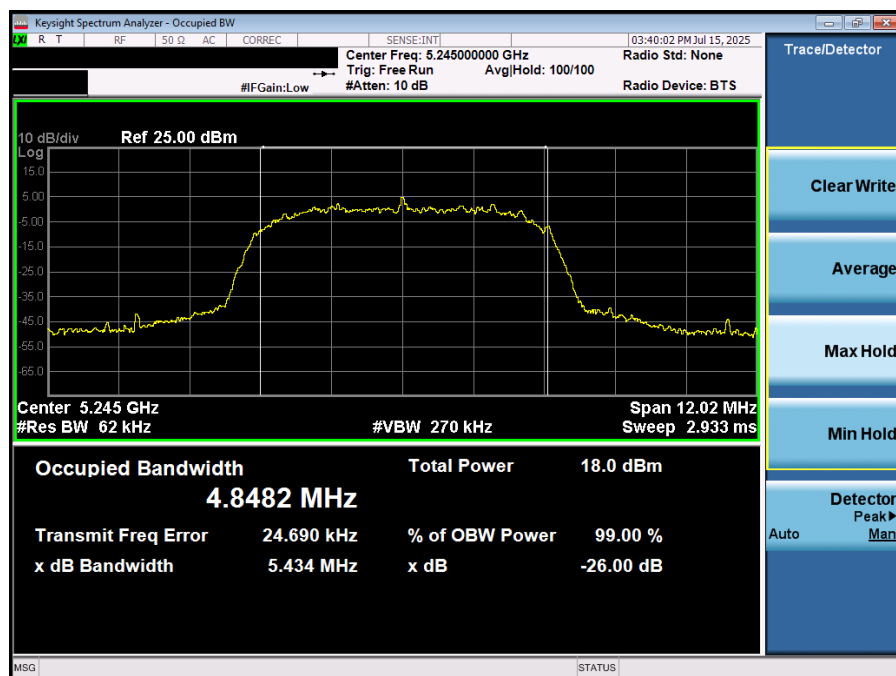


Plot 7-20. 26dB BW & 99% OBW (NB UNII HDRp8– 5200MHz)

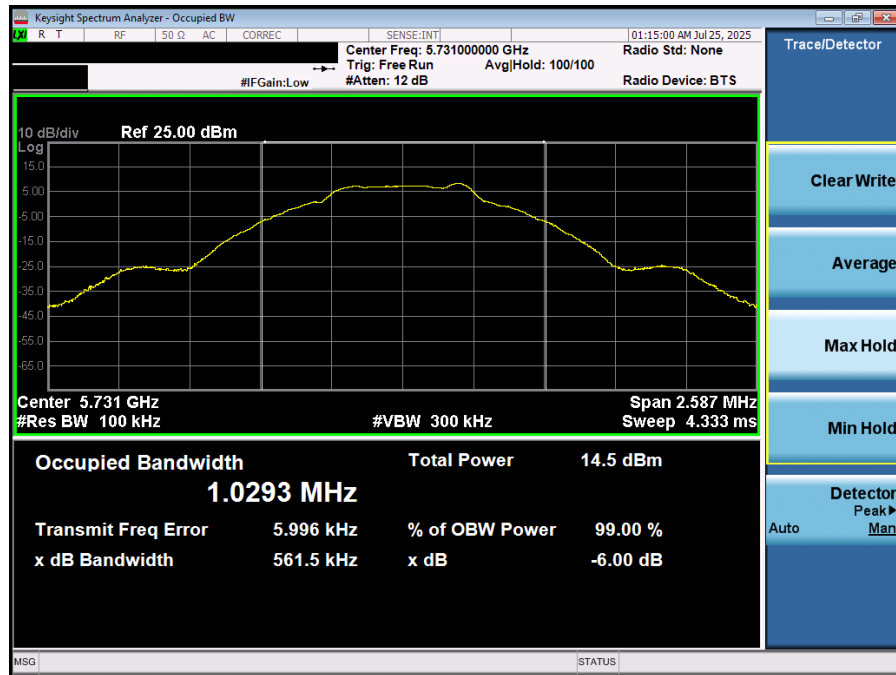

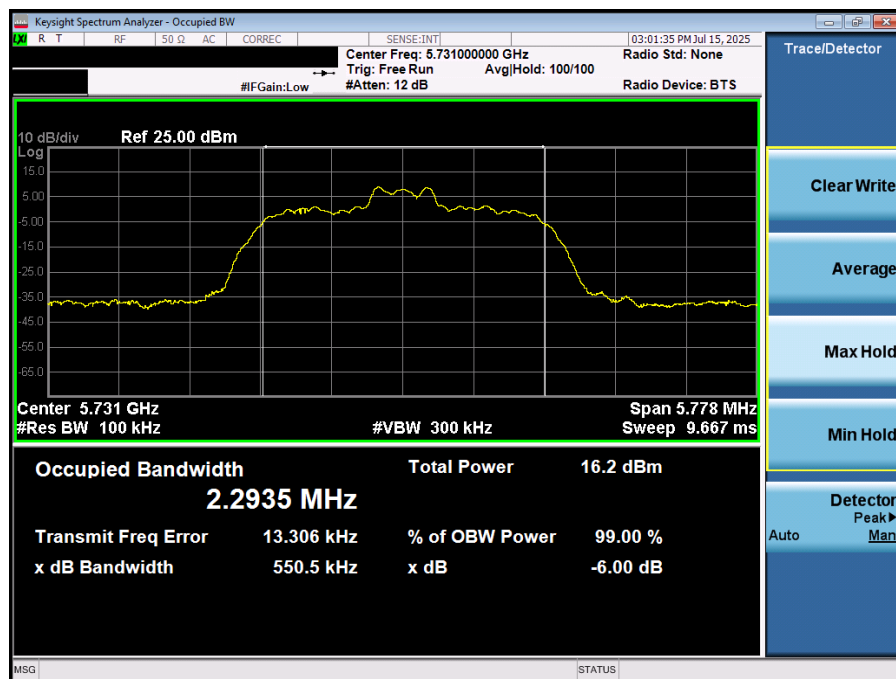


Plot 7-29. 6dB BW & 99% OBW (NB UNII LE2M – 5788MHz)

Plot 7-30. 6dB BW & 99% OBW (NB UNII LE2M – 5844MHz)

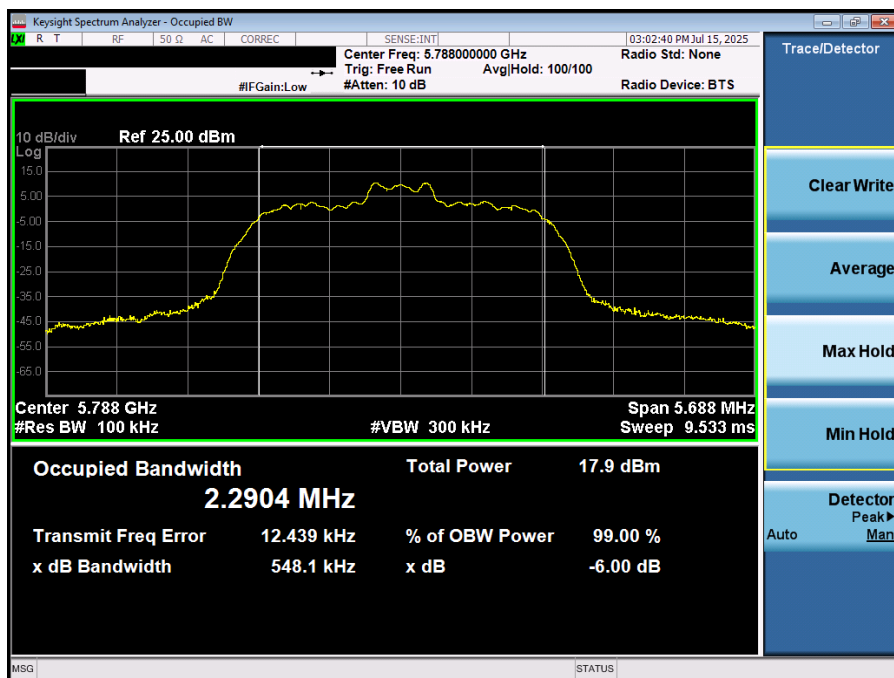


Plot 7-31. 6dB BW & 99% OBW (NB UNII HDR4 – 5731MHz)

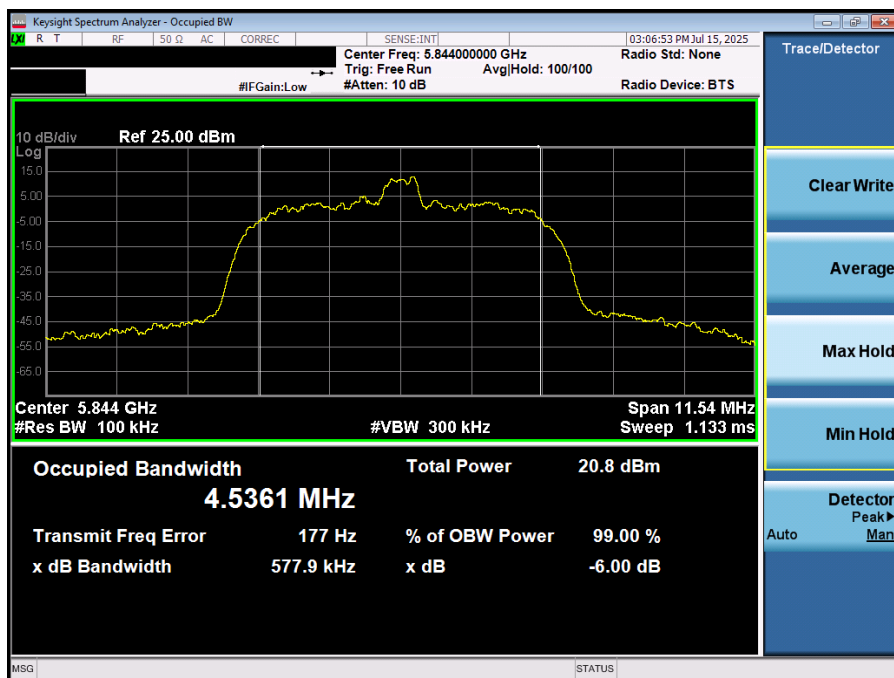


Plot 7-34. 6dB BW & 99% OBW (NB UNII HDR8 – 5731MHz)

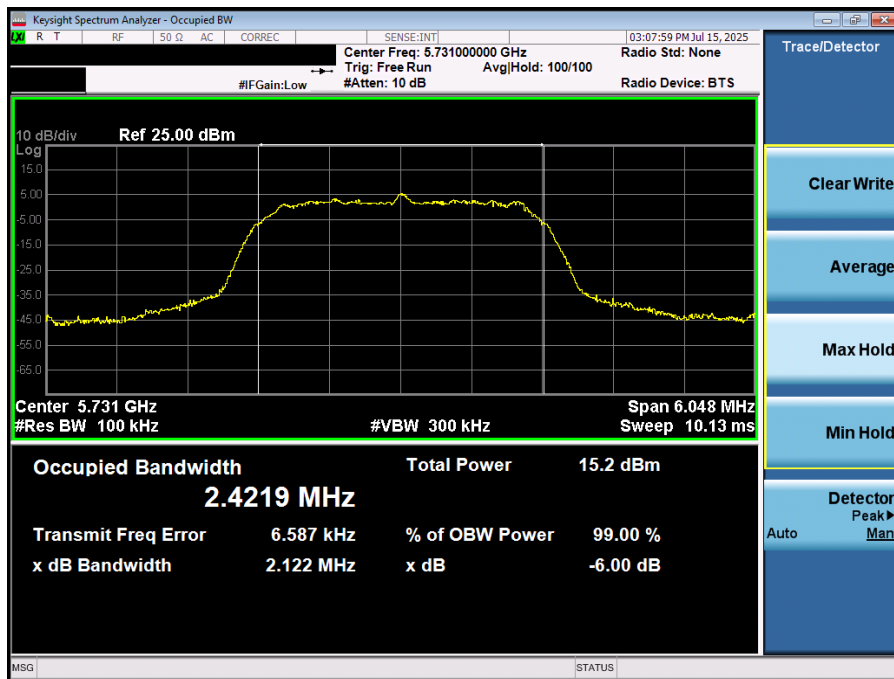


Plot 7-35. 6dB BW & 99% OBW (NB UNII HDR8 – 5788MHz)

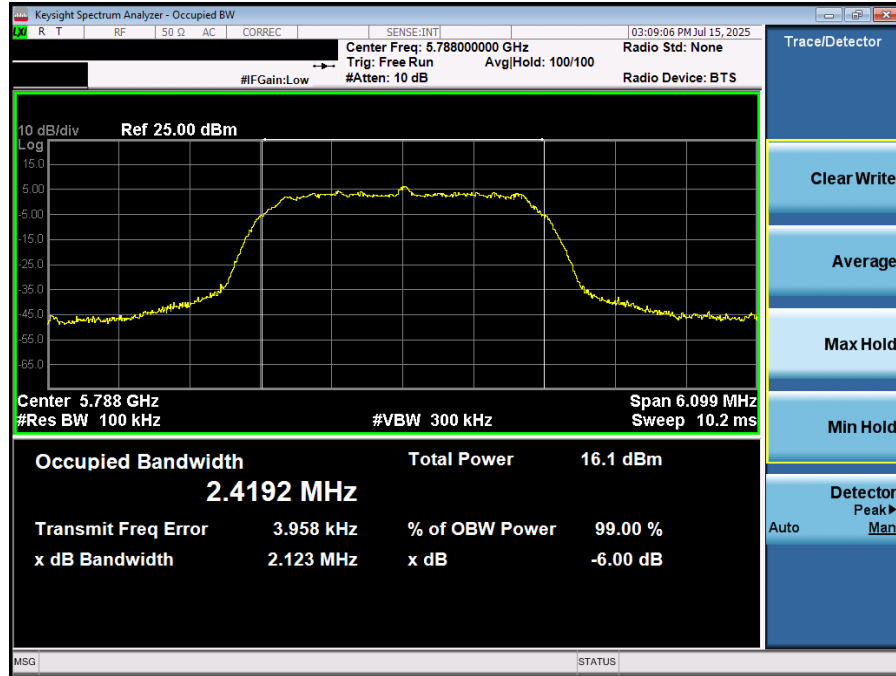


Plot 7-36. 6dB BW & 99% OBW (NB UNII HDR8 – 5844MHz)

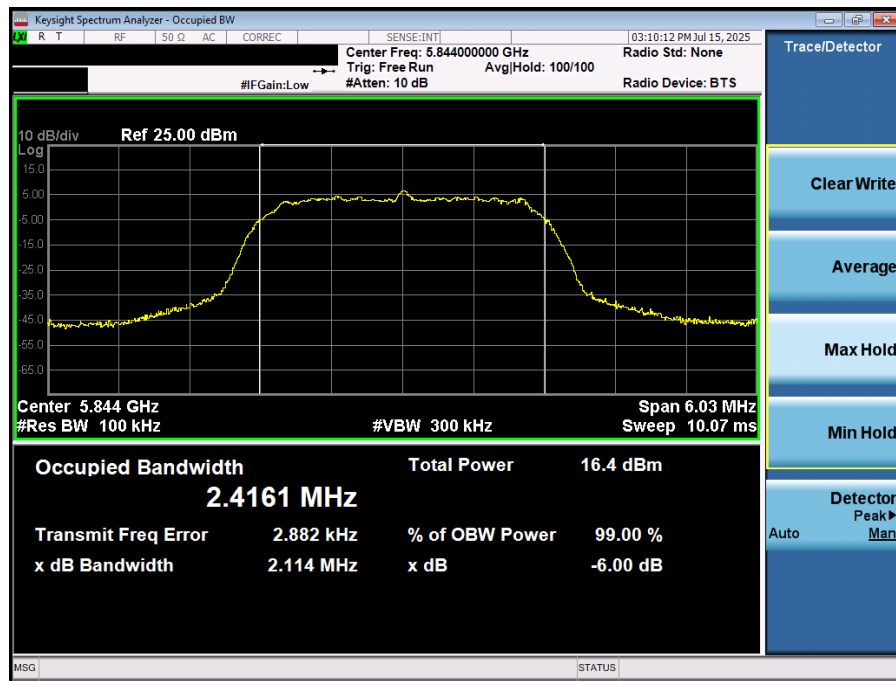


Plot 7-37. 6dB BW & 99% OBW (NB UNII HDRp4 – 5731MHz)

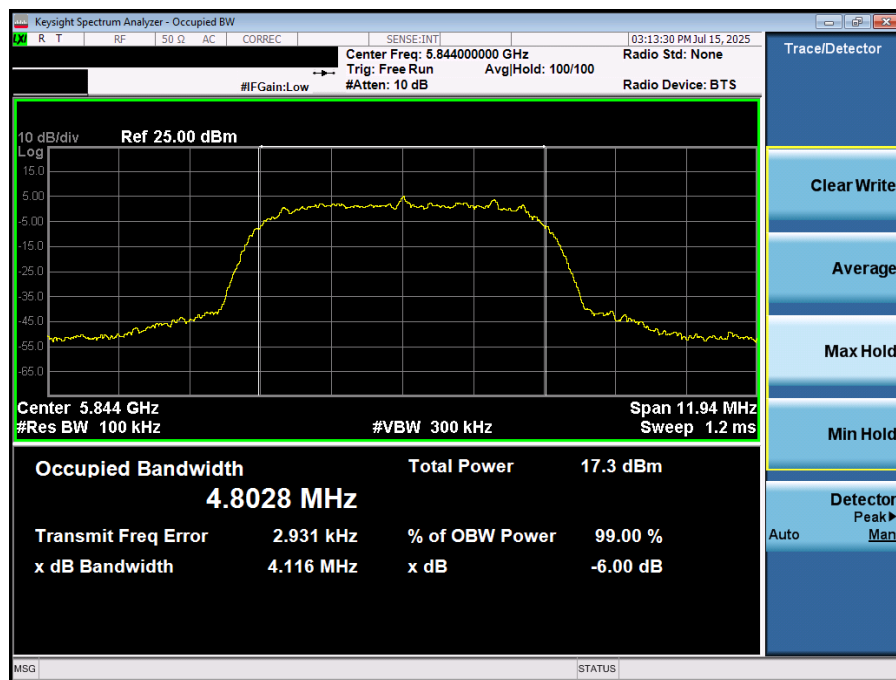


Plot 7-40. 6dB BW & 99% OBW (NB UNII HDRp8 – 5731MHz)

The spectrum analyzer was connected to the antenna terminal while the EUT was operating at its maximum duty cycle, at its maximum power control level, as defined in ANSI C63.10-2020 and KDB 789033 D02 v02r01, and at the appropriate frequencies. 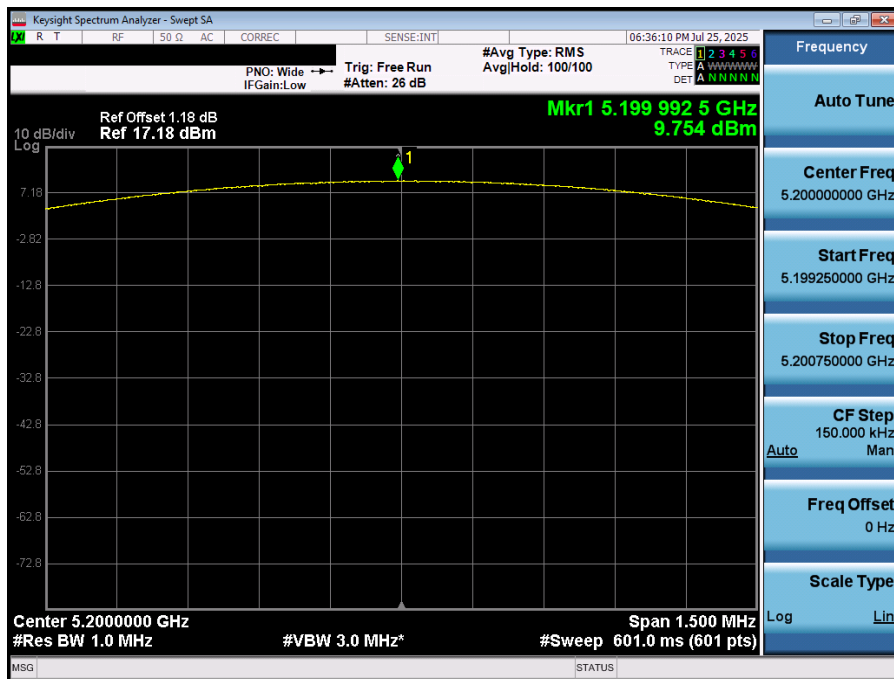

Plot 7-43. PSD (NB UNII BDR – 5157MHz)

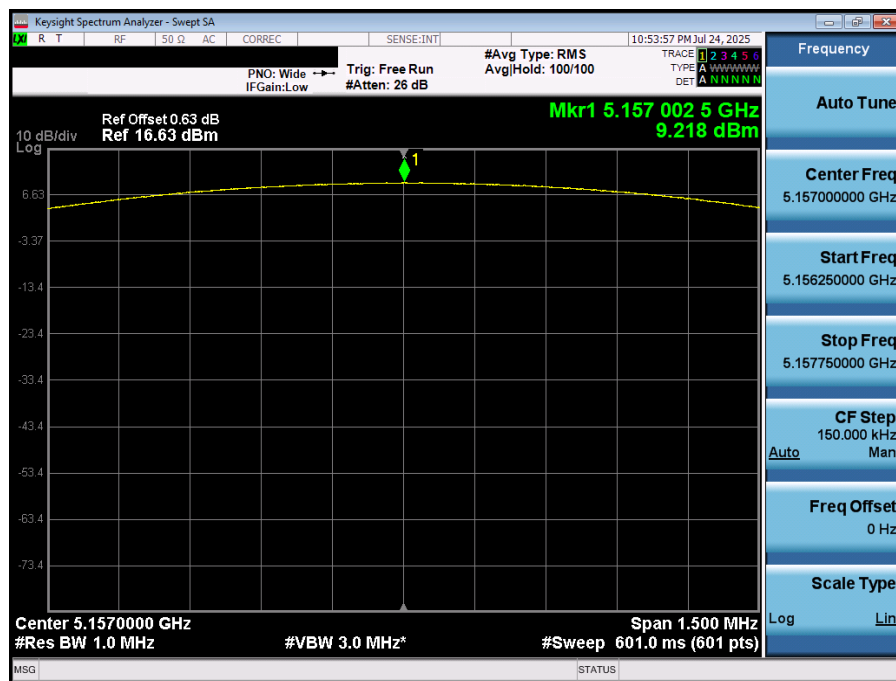


Plot 7-44. PSD (NB UNII BDR – 5200MHz)

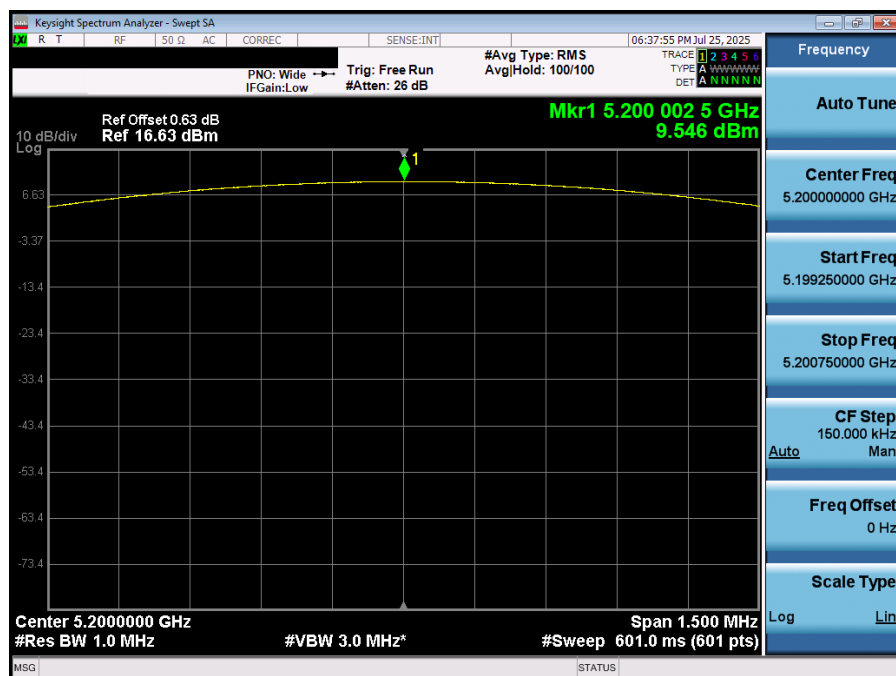


Plot 7-45. PSD (NB UNII BDR – 5245MHz)

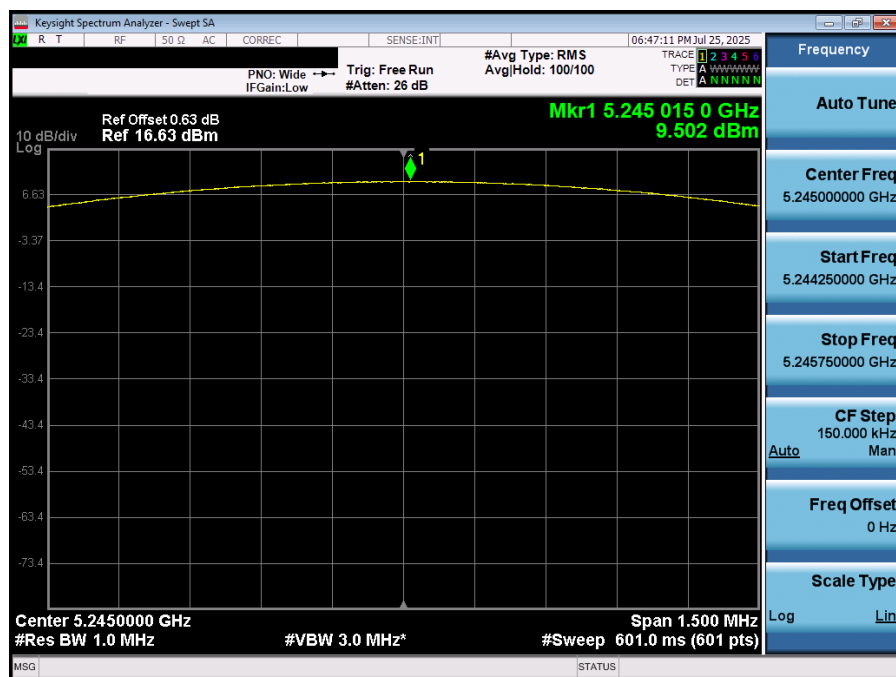


Plot 7-46. PSD (NB UNII LE1M – 5157MHz)

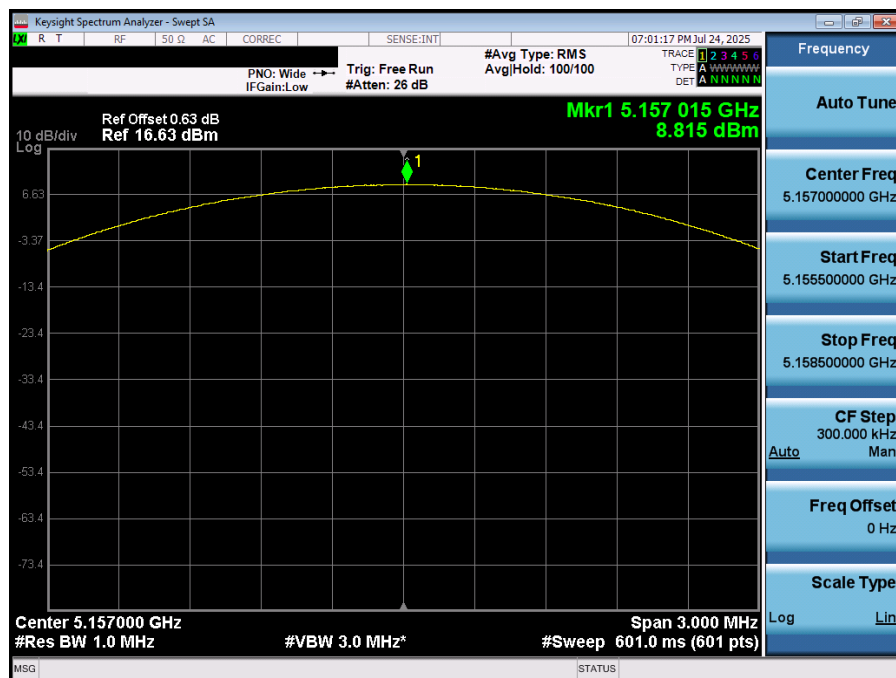


Plot 7-47. PSD (NB UNII LE1M – 5200MHz)

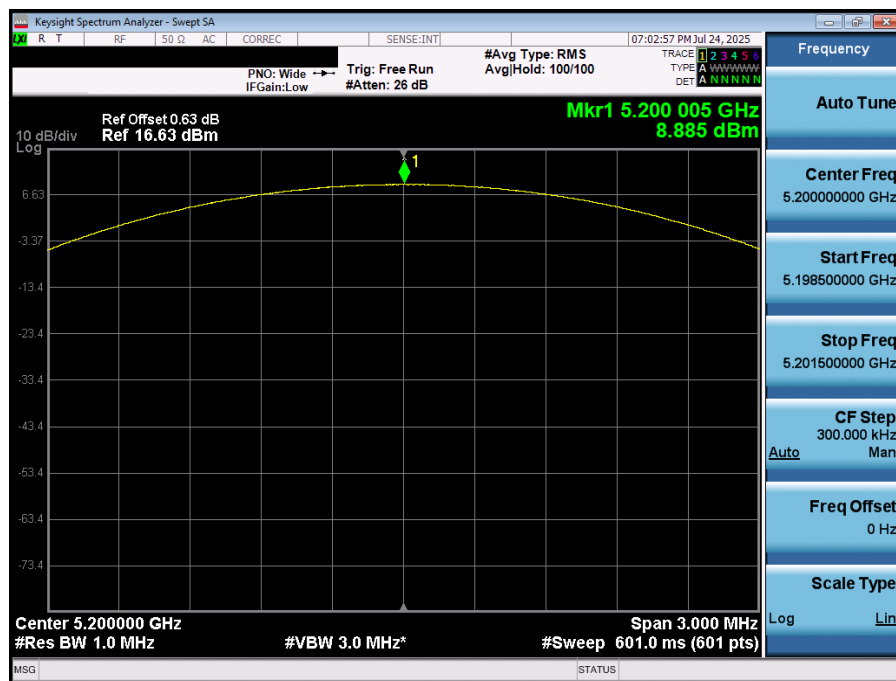


Plot 7-48. PSD (NB UNII LE1M – 5245MHz)

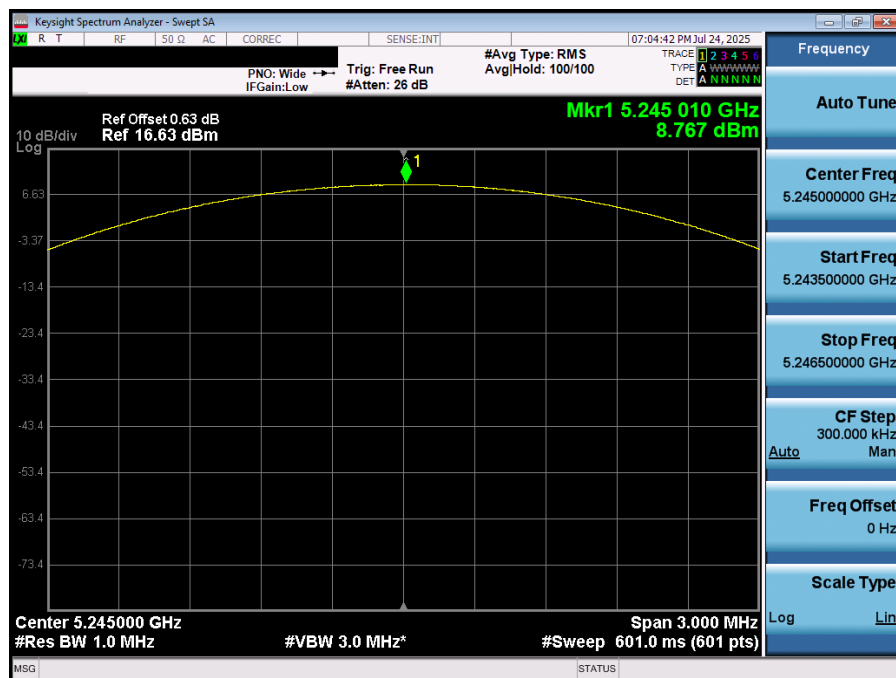


Plot 7-49. PSD (NB UNII LE2M - 5157MHz)

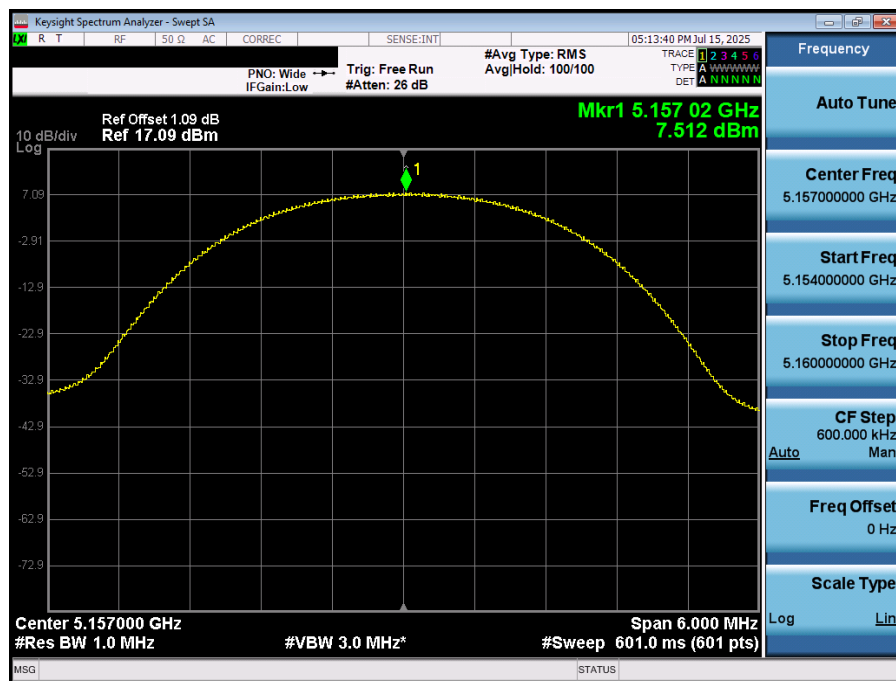


Plot 7-50. PSD (NB UNII LE2M - 5200MHz)

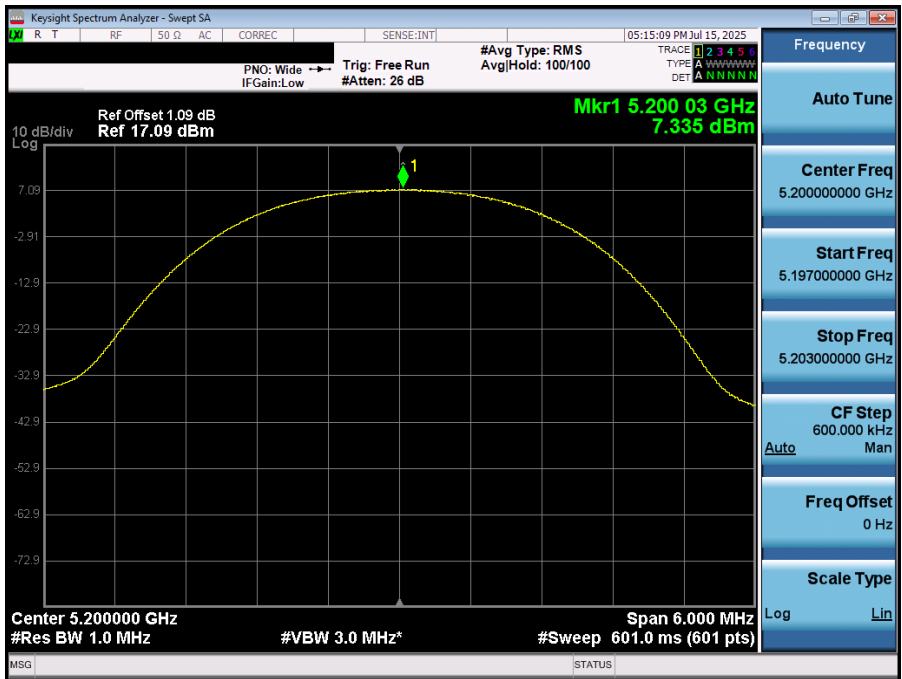


Plot 7-51. PSD (NB UNII LE2M – 5245MHz)

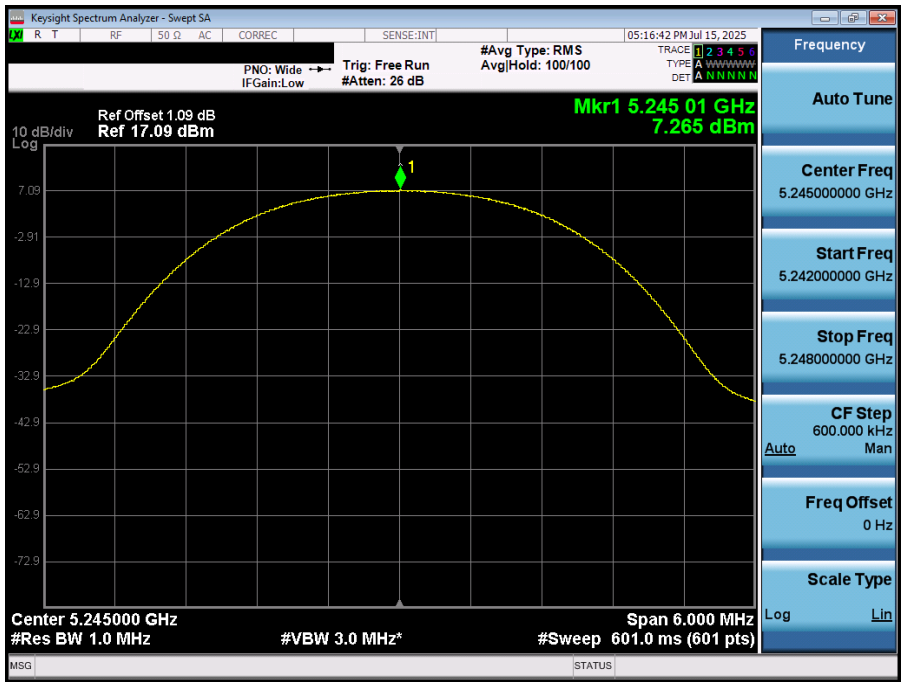


Plot 7-52. PSD (NB UNII HDR4 – 5157MHz)

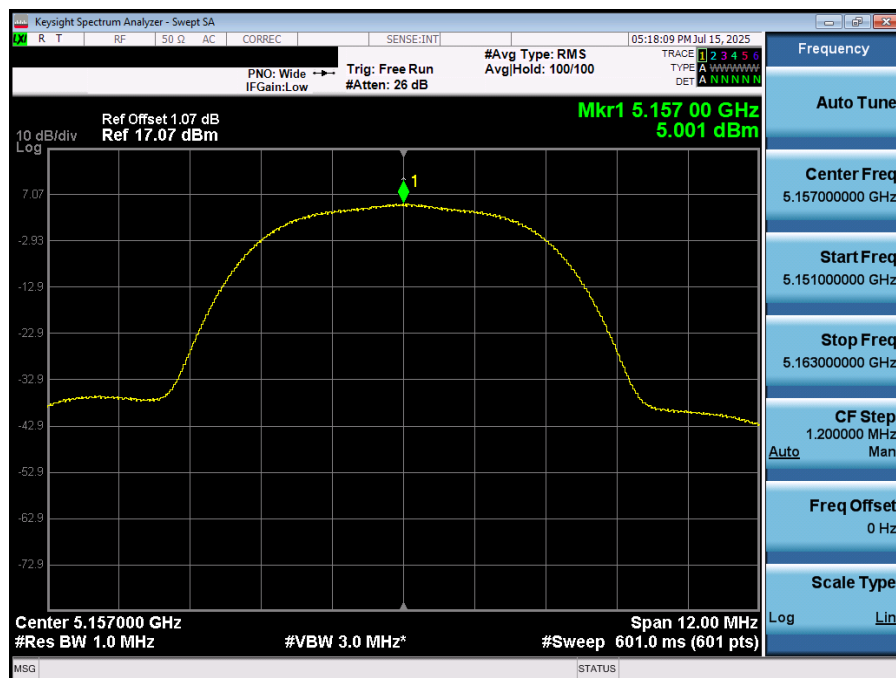


Plot 7-53. PSD (NB UNII HDR4 – 5200MHz)

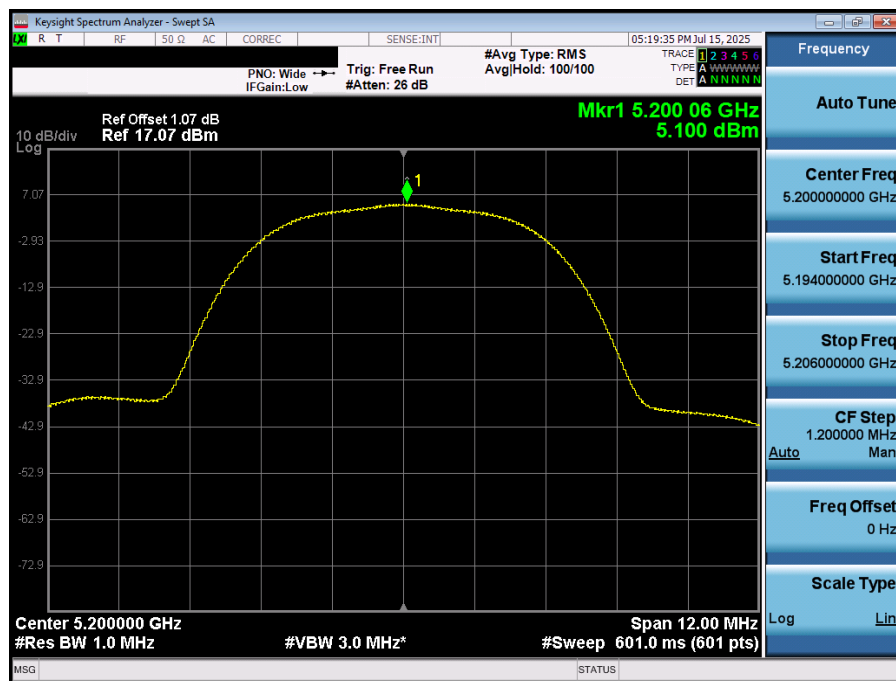


Plot 7-54. PSD (NB UNII HDR4 – 5245MHz)

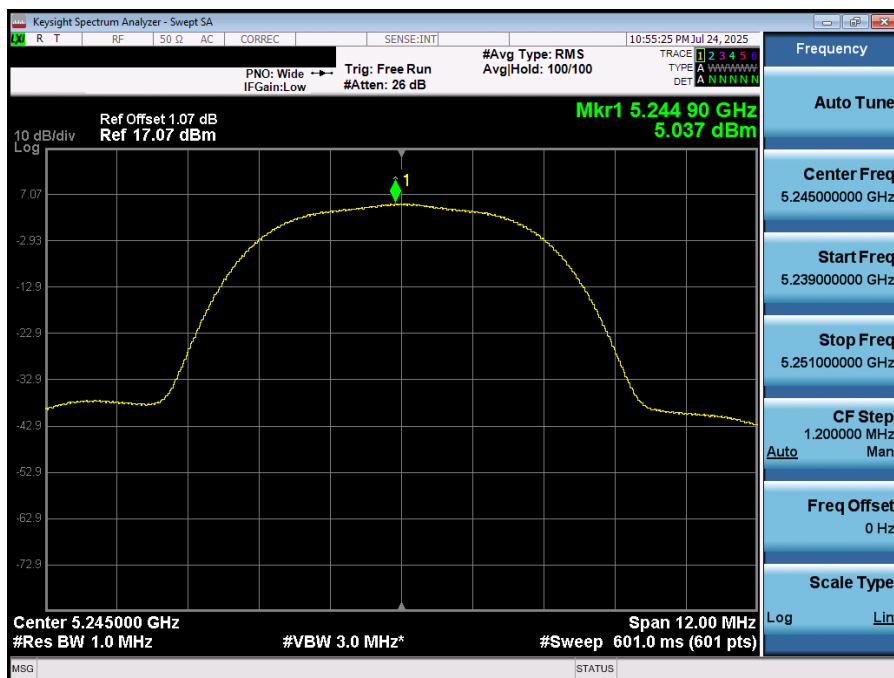


Plot 7-55. PSD (NB UNII HDR8 – 5157MHz)

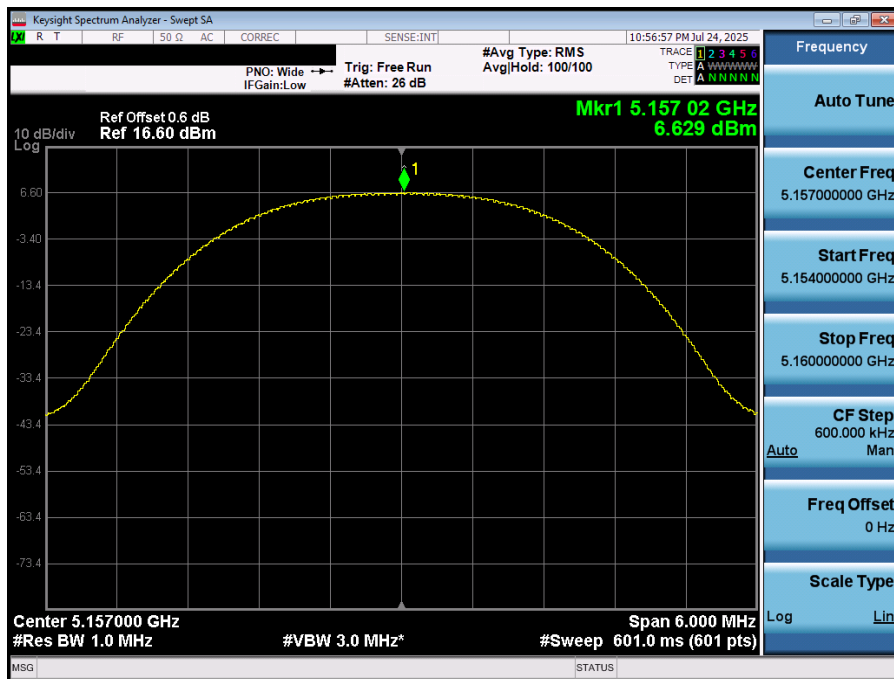


Plot 7-56. PSD (NB UNII HDR8 – 5200MHz)

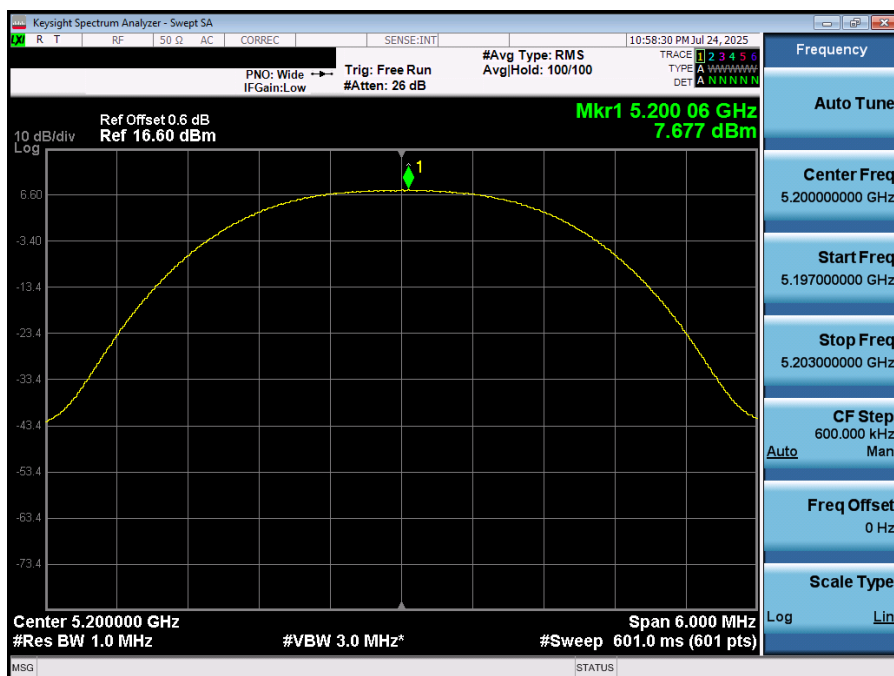


Plot 7-57. PSD (NB UNII HDR8 – 5245MHz)

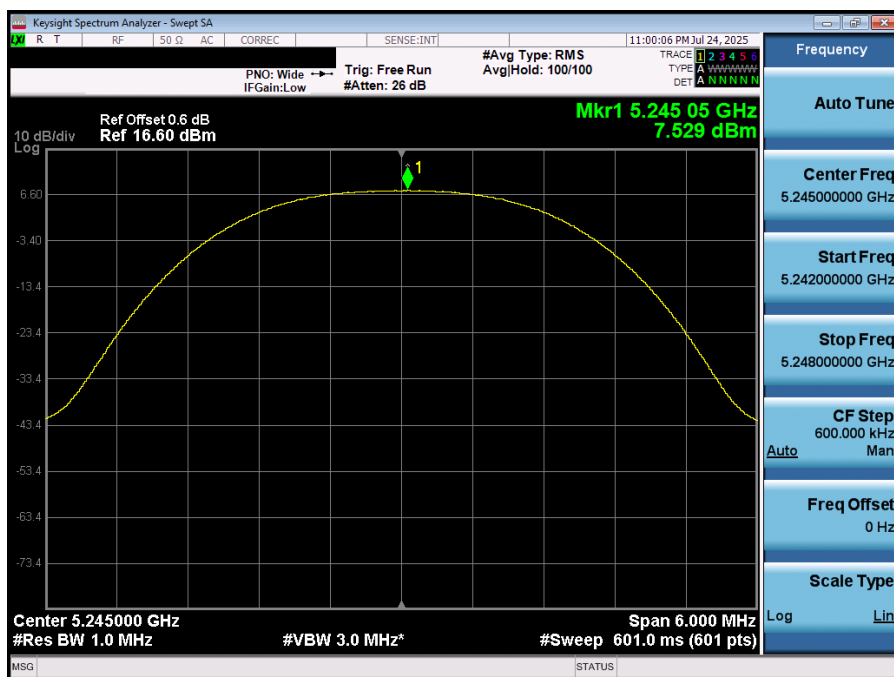


Plot 7-58. PSD (NB UNII HDRp4 – 5157MHz)

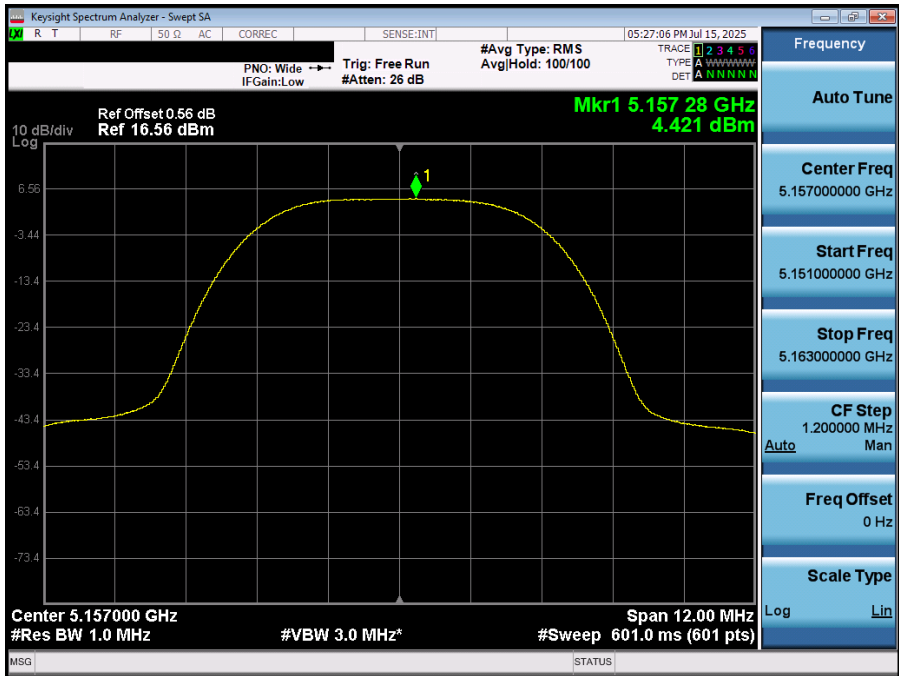


Plot 7-59. PSD (NB UNII HDRp4 – 5200MHz)

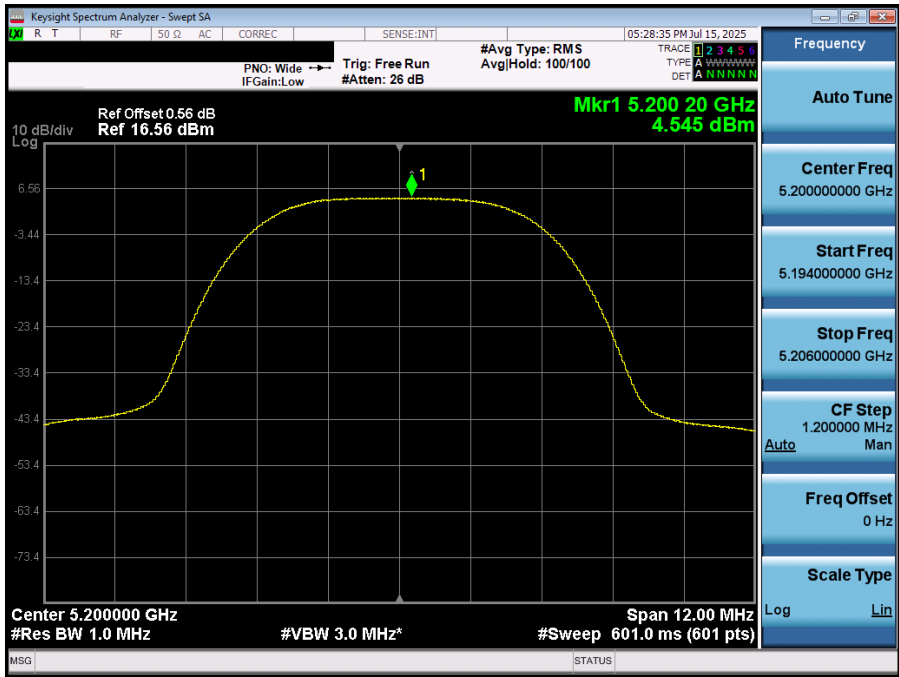


Plot 7-60. PSD (NB UNII HDRp4 – 5245MHz)

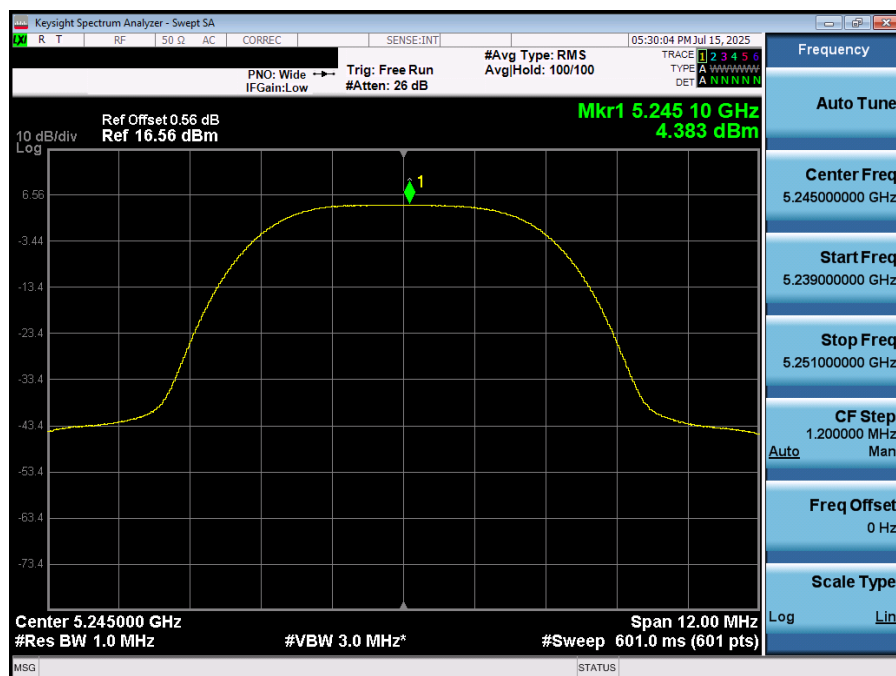


Plot 7-61. PSD (NB UNII HDRp8 – 5157MHz)

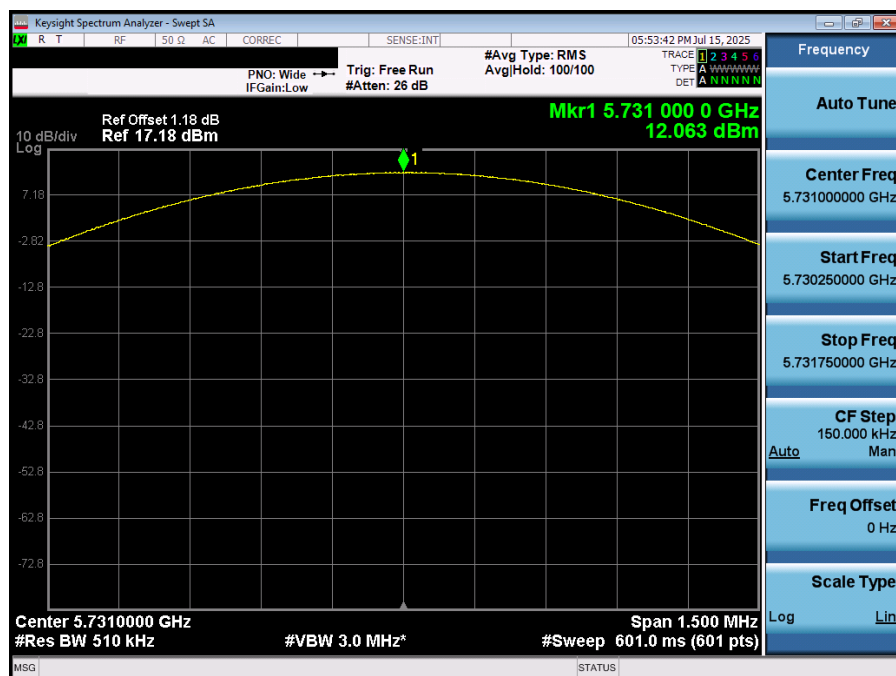

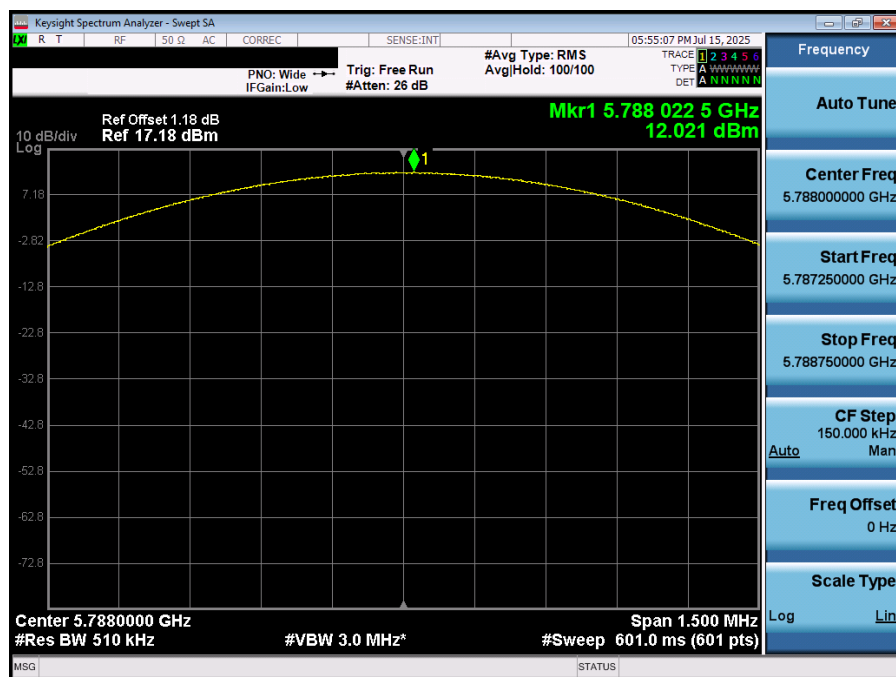

Plot 7-64. PSD (NB UNII BDR – 5731MHz)

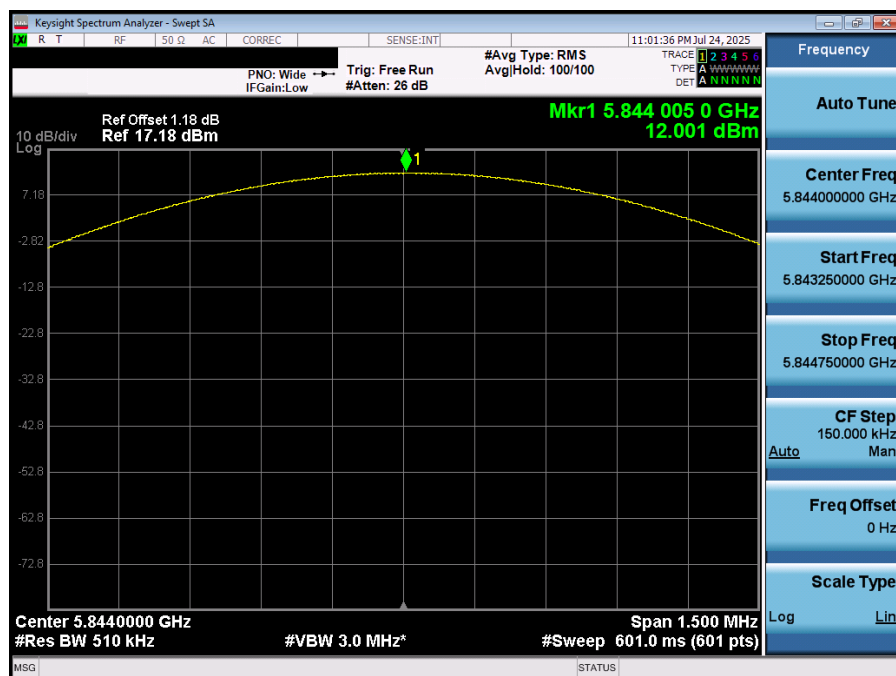


Plot 7-65. PSD (NB UNII BDR – 5788MHz)

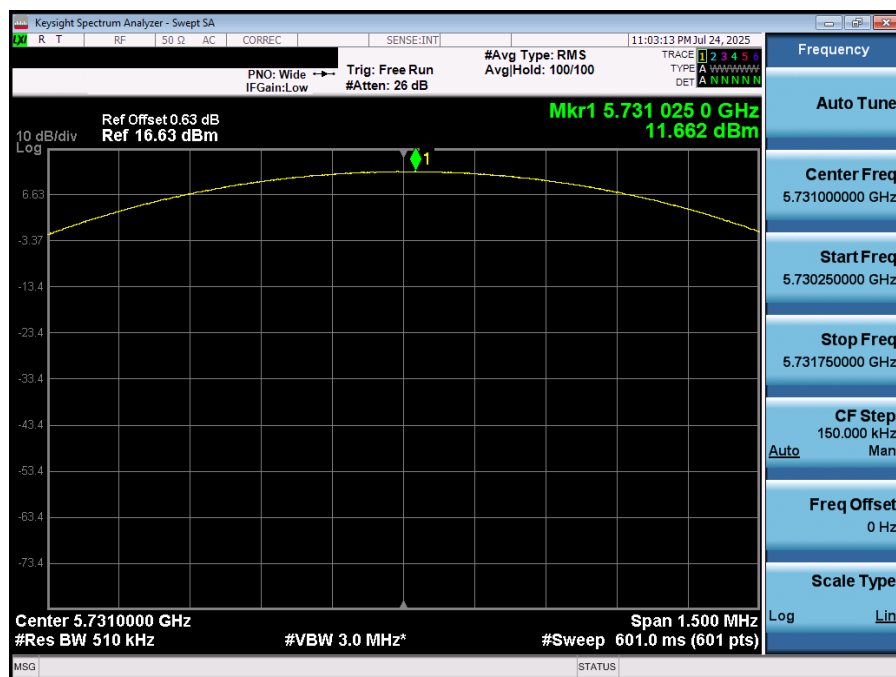

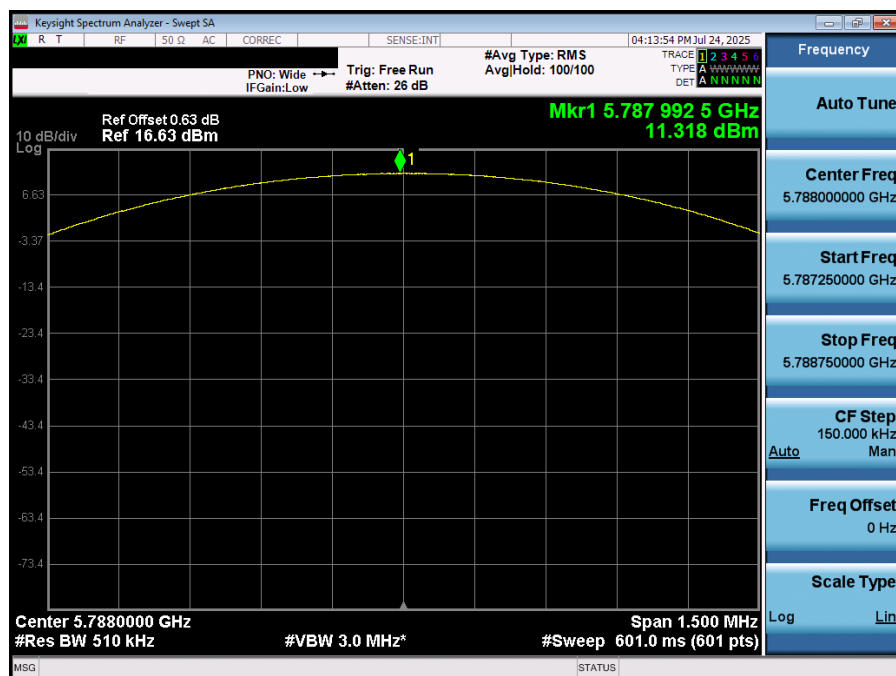


Plot 7-66. PSD (NB UNII BDR – 5844MHz)

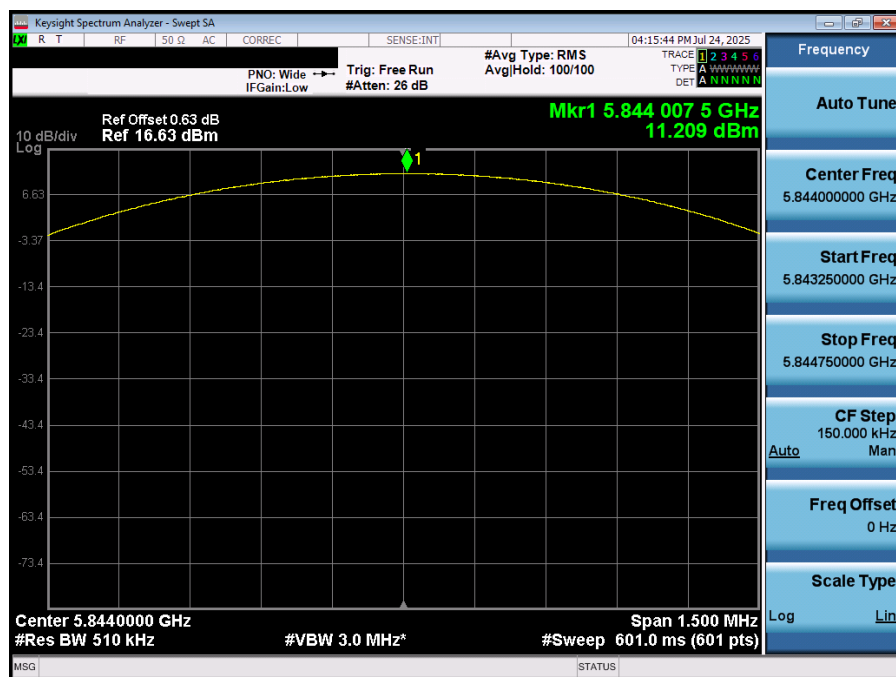


Plot 7-67. PSD (NB UNII LE1M – 5731MHz)

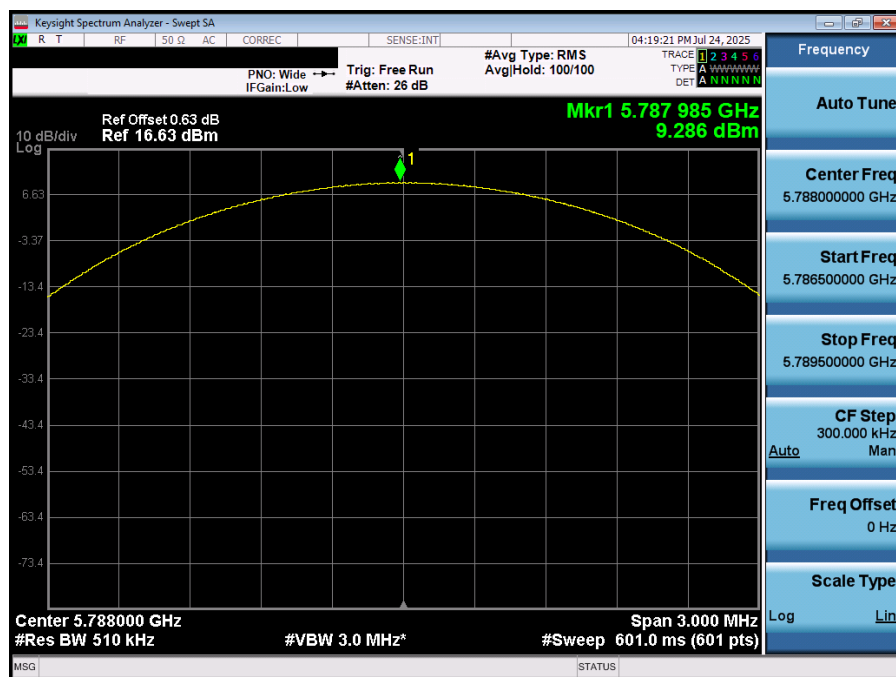
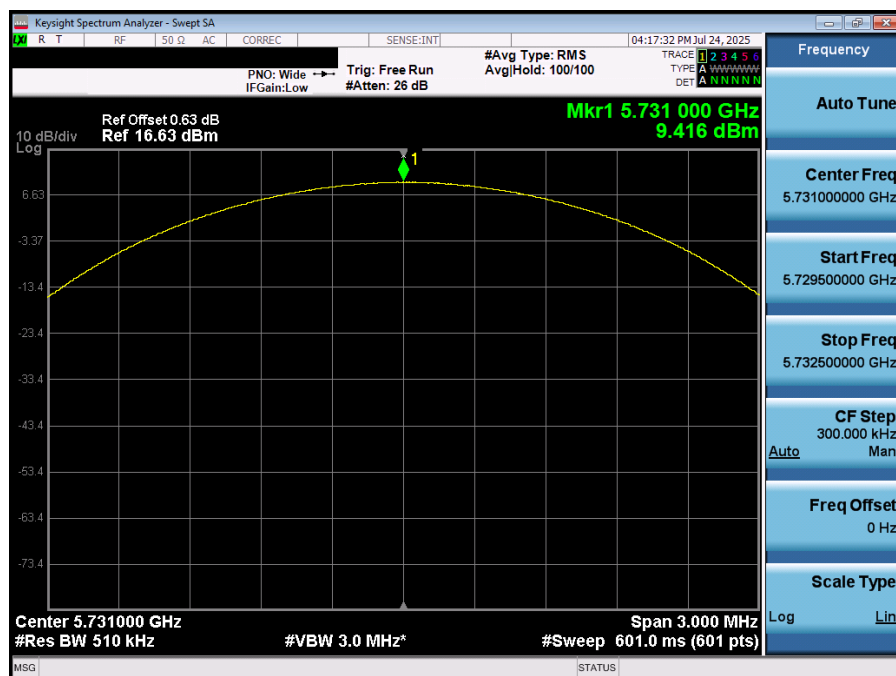



Plot 7-68. PSD (NB UNII LE1M – 5788MHz)

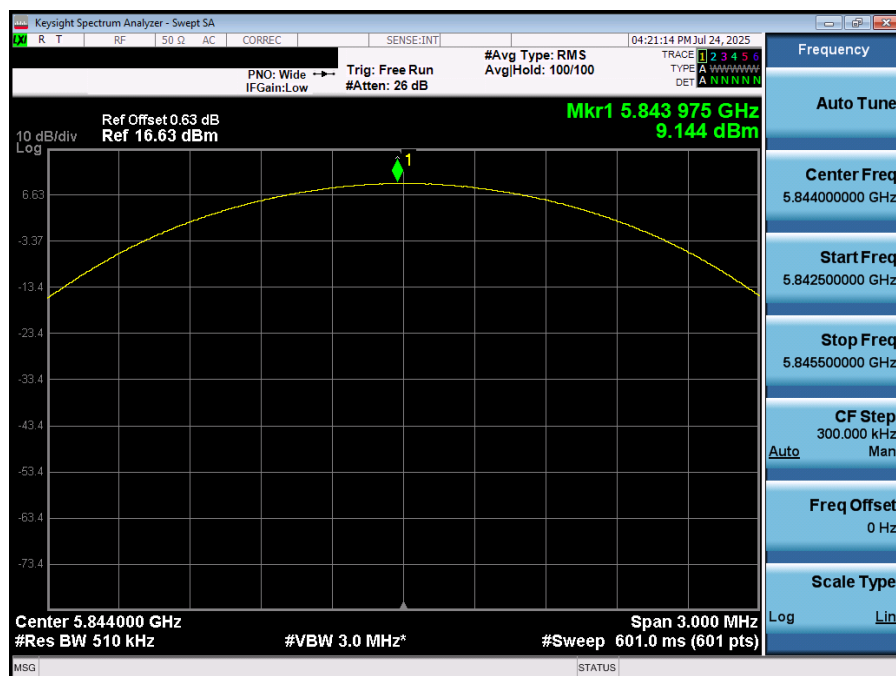


Plot 7-69. PSD (NB UNII LE1M – 5844MHz)

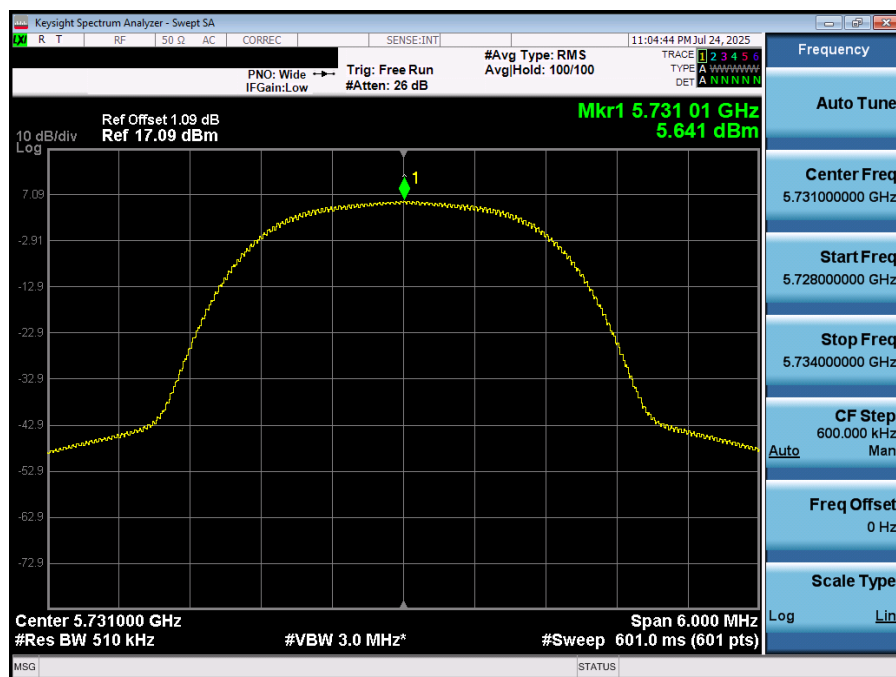

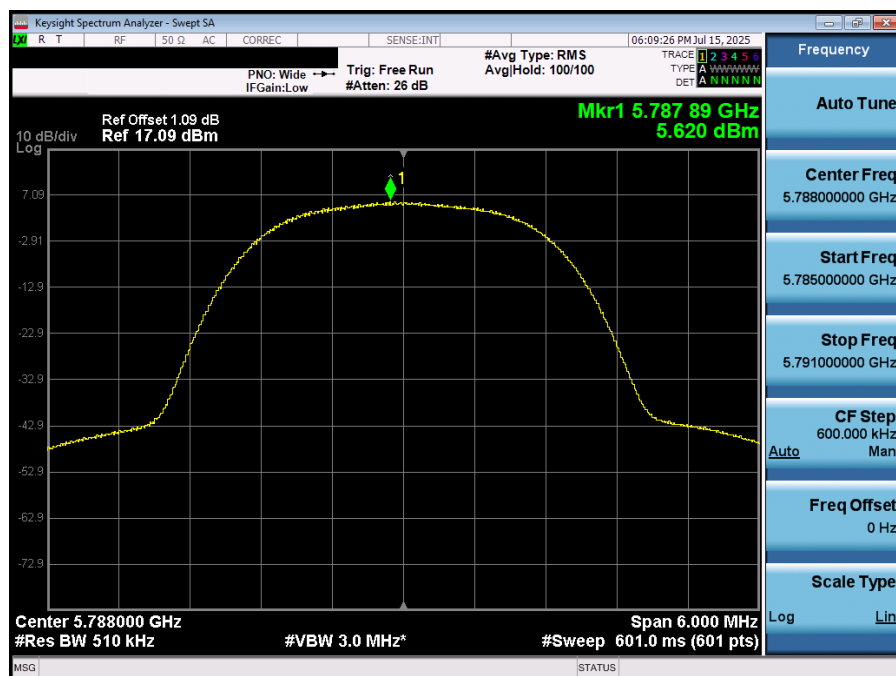


Plot 7-72. PSD (NB UNII LE2M – 5844MHz)

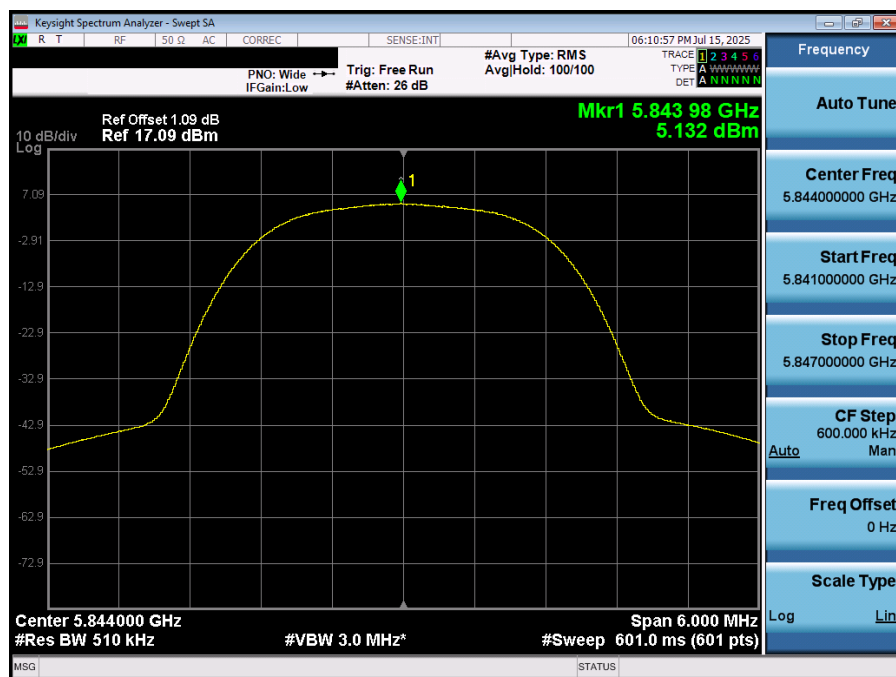


Plot 7-73. PSD (NB UNII HDR4 – 5731MHz)

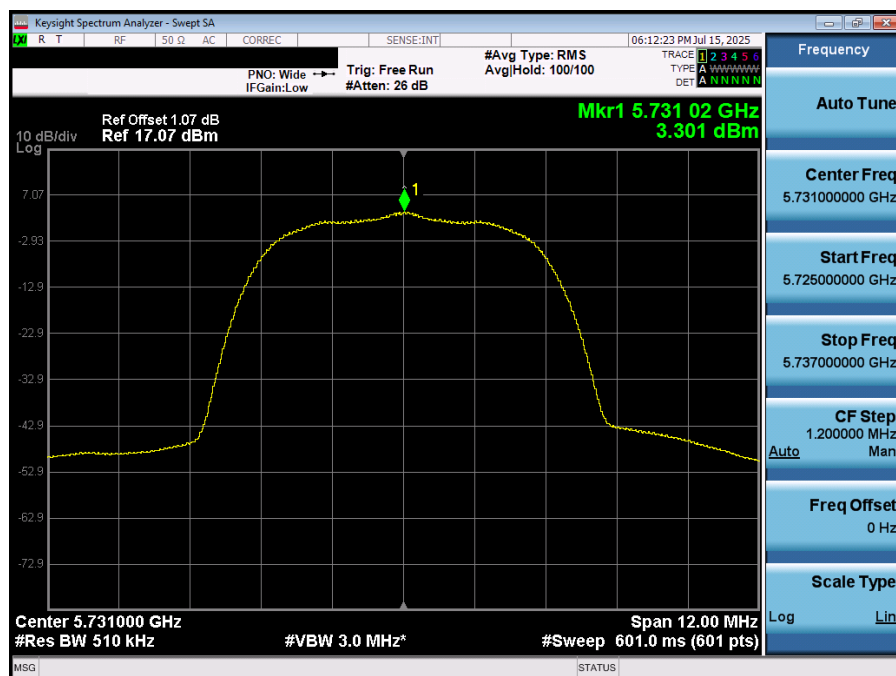


Plot 7-74. PSD (NB UNII HDR4 – 5788MHz)

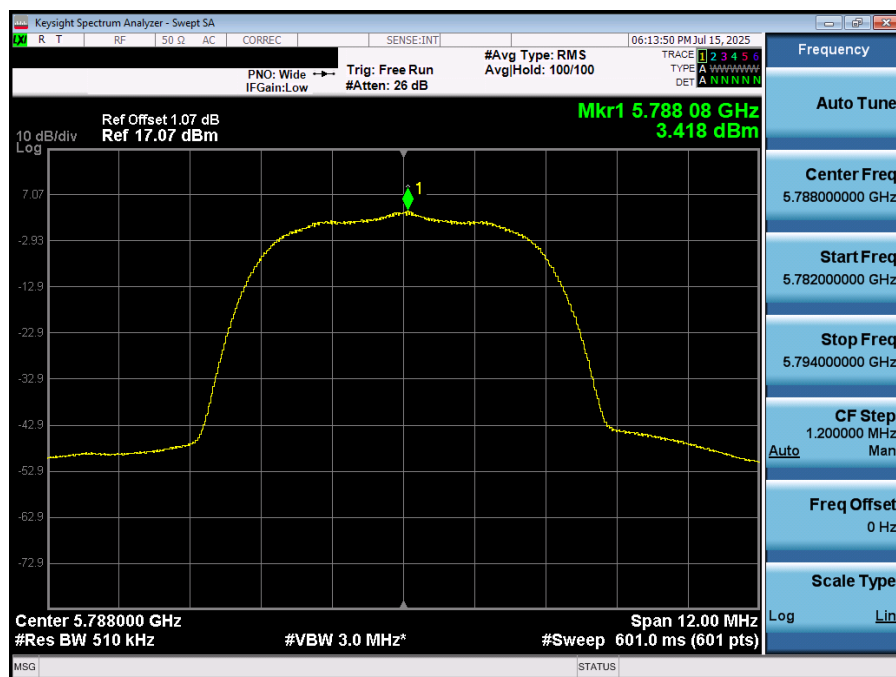


Plot 7-75. PSD (NB UNII HDR4 – 5844MHz)

Plot 7-76. PSD (NB UNII HDR8 – 5731MHz)

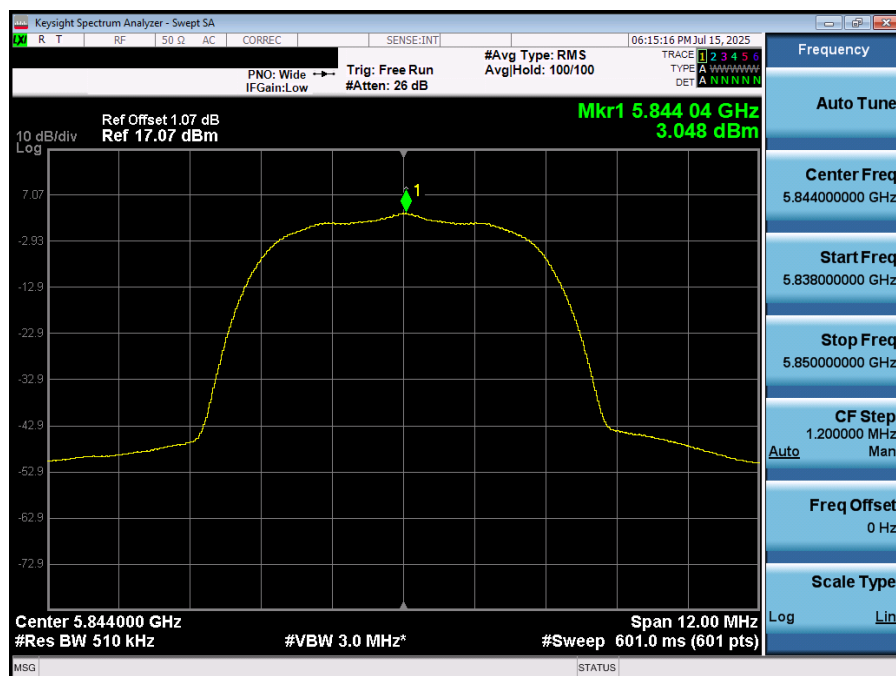


Plot 7-77. PSD (NB UNII HDR8 – 5788MHz)

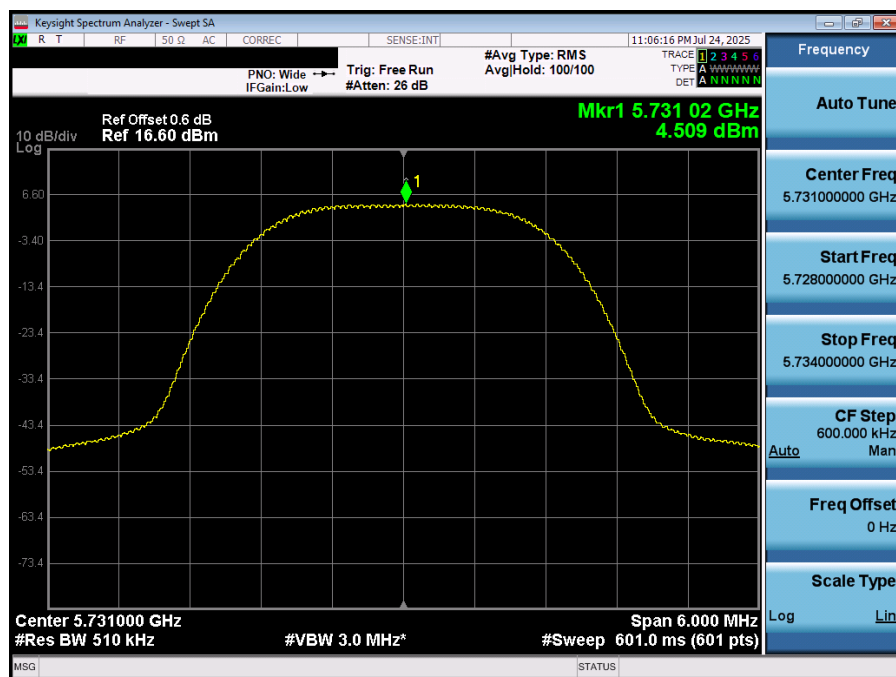

Plot 7-78. PSD (NB UNII HDR8 – 5844MHz)

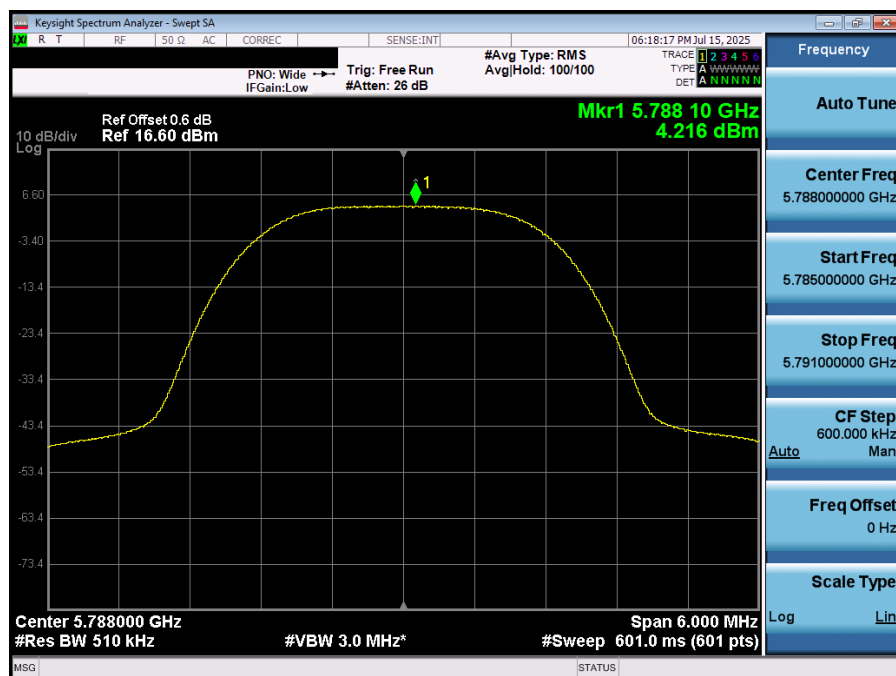


Plot 7-79. PSD (NB UNII HDRp4 – 5731MHz)

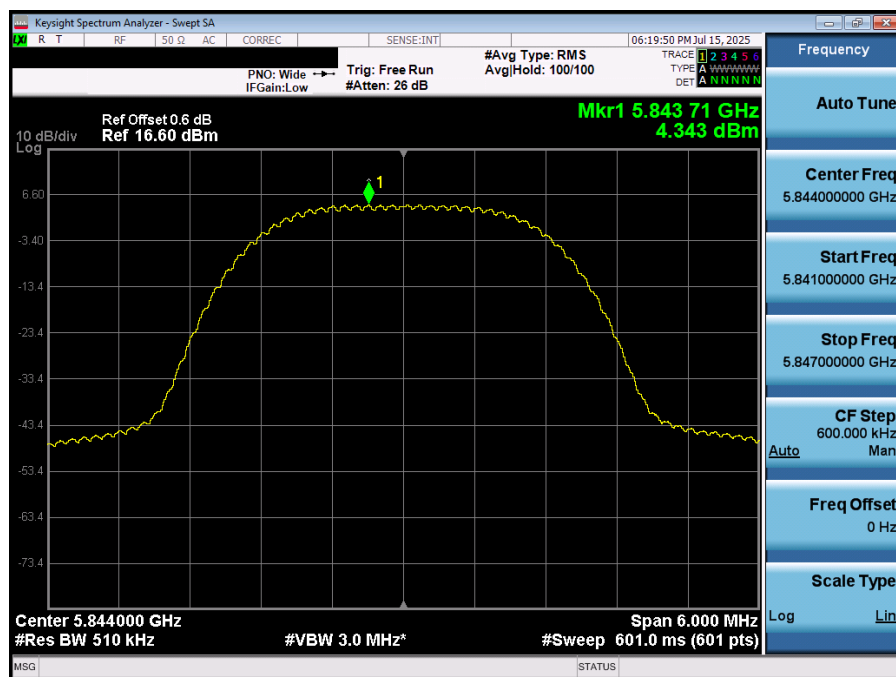

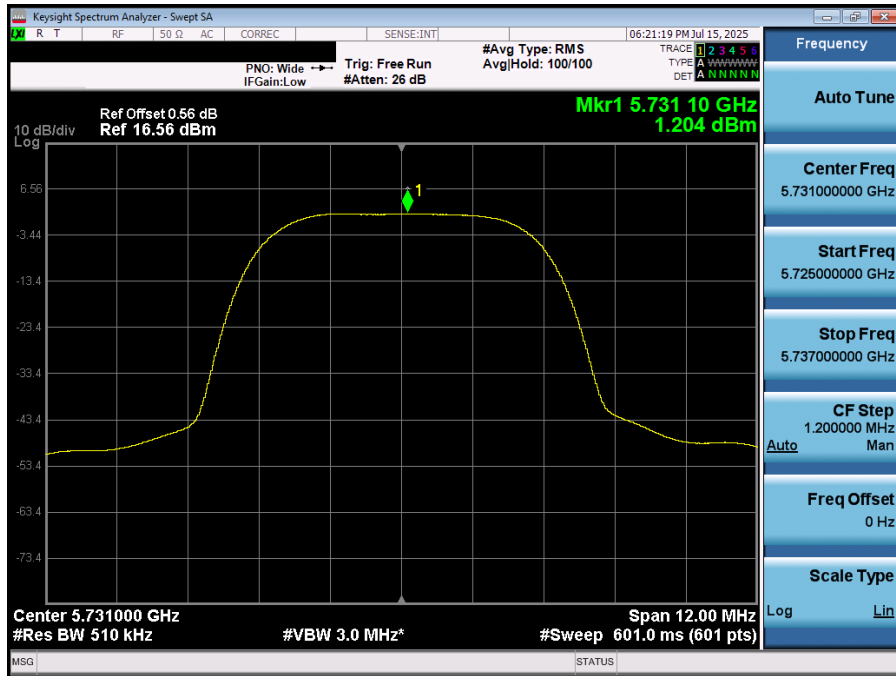


Plot 7-80. PSD (NB UNII HDRp4 – 5788MHz)

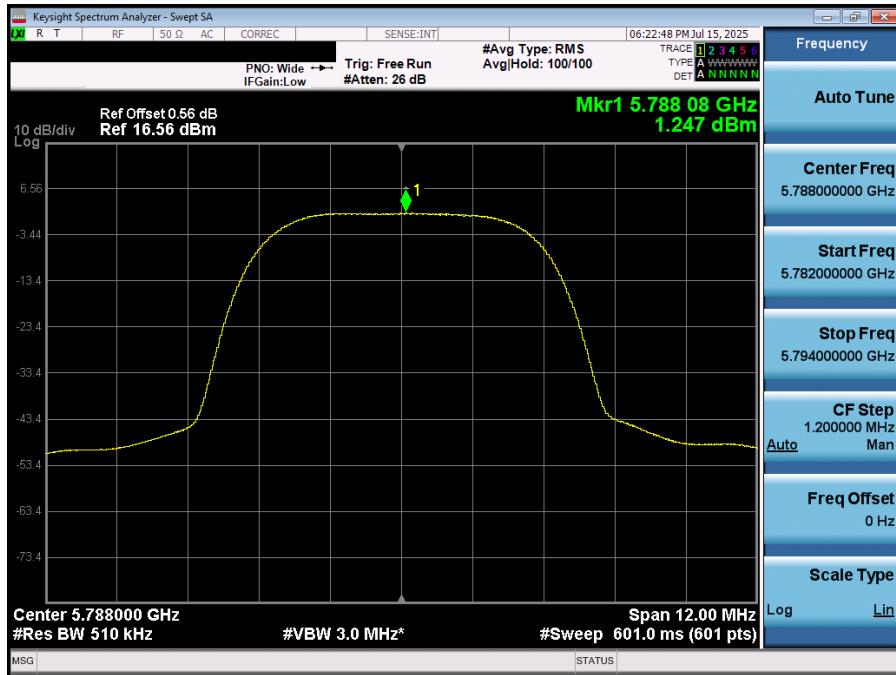


Plot 7-81. PSD (NB UNII HDRp4 – 5844MHz)

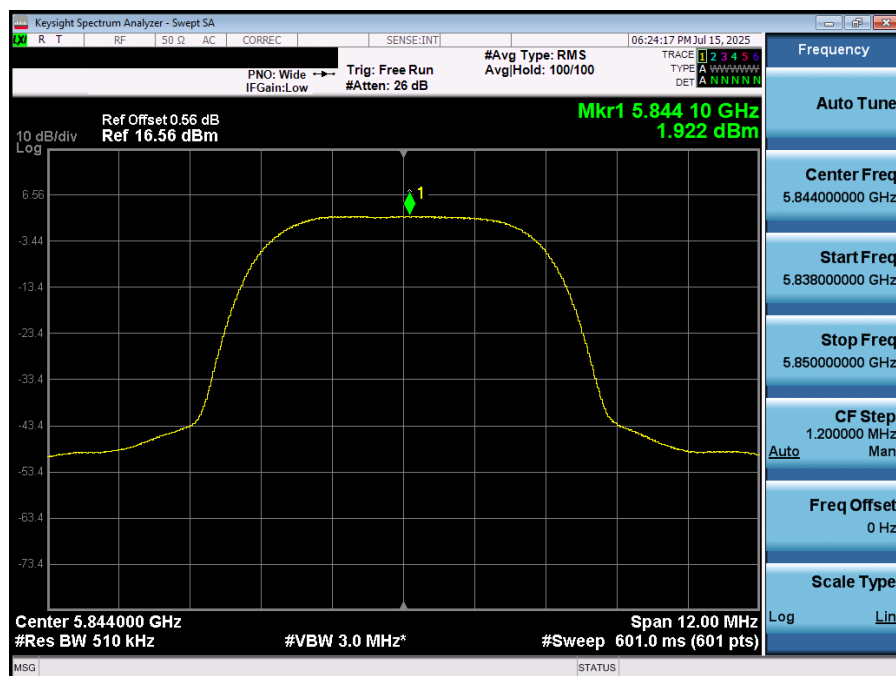


Plot 7-82. PSD (NB UNII HDRp8 – 5731MHz)

All out of band radiated spurious emissions are measured with a spectrum analyzer connected to a receive antenna while the EUT is operating at its maximum duty cycle, at its maximum power control level, as defined in ANSI C63.10-2020 and KDB 789033 D02 v02r01, and at the appropriate frequencies. All channels were investigated among all UNII bands. Only the radiated emissions of the configuration that produced the worst case emissions are reported in this section.

For transmitters operating in the 5.15-5.25 GHz band: All emissions outside of the 5.15-5.25 GHz band shall not exceed an EIRP of -27 dBm/MHz.

For transmitters operating in the 5.725 – 5.85 GHz band: All emissions shall be limited to a level of -27 dBm/MHz at 75 MHz or more above or below the band edge increasing linearly to 10 dBm/MHz at 25 MHz above or below the band edge, and from 25 MHz above or below the band edge increasing linearly to a level of 15.6 dBm/MHz at 5 MHz above or below the band edge, and from 5 MHz above or below the band edge increasing linearly to a level of 27 dBm/MHz at the band edge.

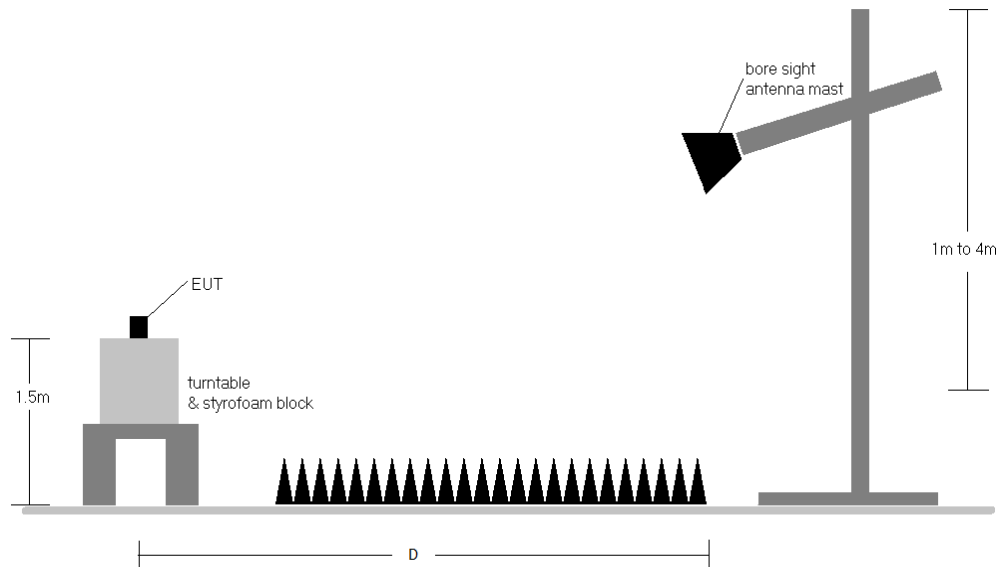


Figure 7-5. Test Instrument & Measurement Setup

Test Notes

1. All emissions that lie in the restricted bands (denoted by a * next to the frequency) specified in §15.205 are below the limit shown in Table 7-7.
2. All spurious emissions lying in restricted bands specified in §15.205 is below the limit shown in Table 7-7. All spurious emissions that do not lie in a restricted band are subject to a peak limit of -27dBm/MHz. At a distance of 3 meters, the field strength limit in dB μ V/m can be determined by adding a “conversion” factor of 95.2dB to the EIRP limit of -27dBm/MHz to obtain the limit for out of band spurious emissions of 68.2dB μ V/m.
3. The antenna is manipulated through typical positions, polarity and length during the tests. The EUT is manipulated through three orthogonal planes.
4. This unit was tested with its standard battery.

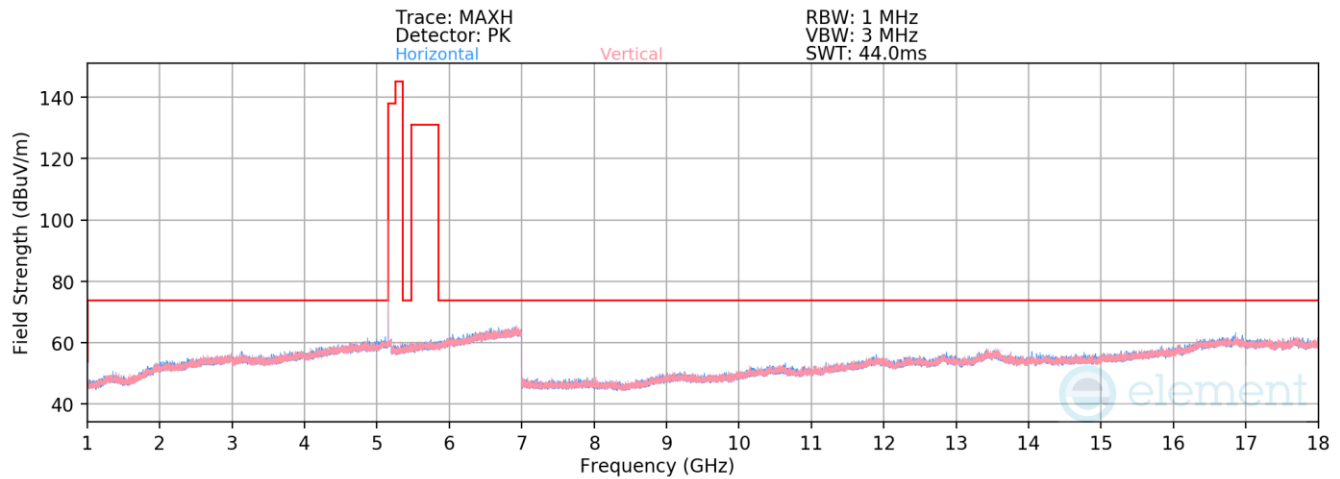

Plot 7-85. Radiated Spurious Emissions 1-18GHz (BDR GFSK – 5157MHz)

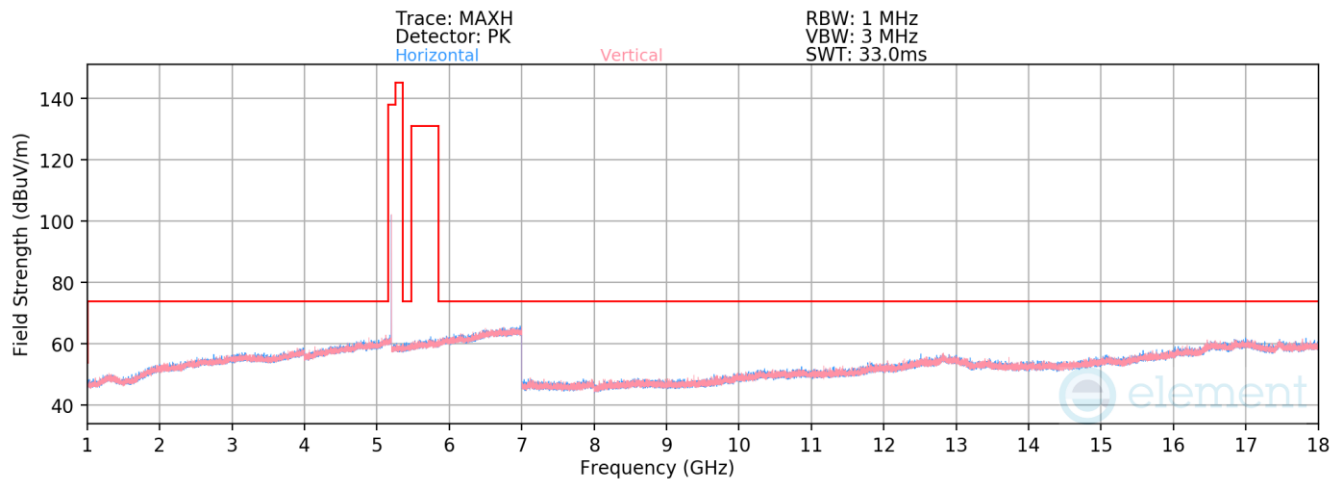

Plot 7-86. Radiated Spurious Emissions 1-18GHz (BDR GFSK – 5200MHz)

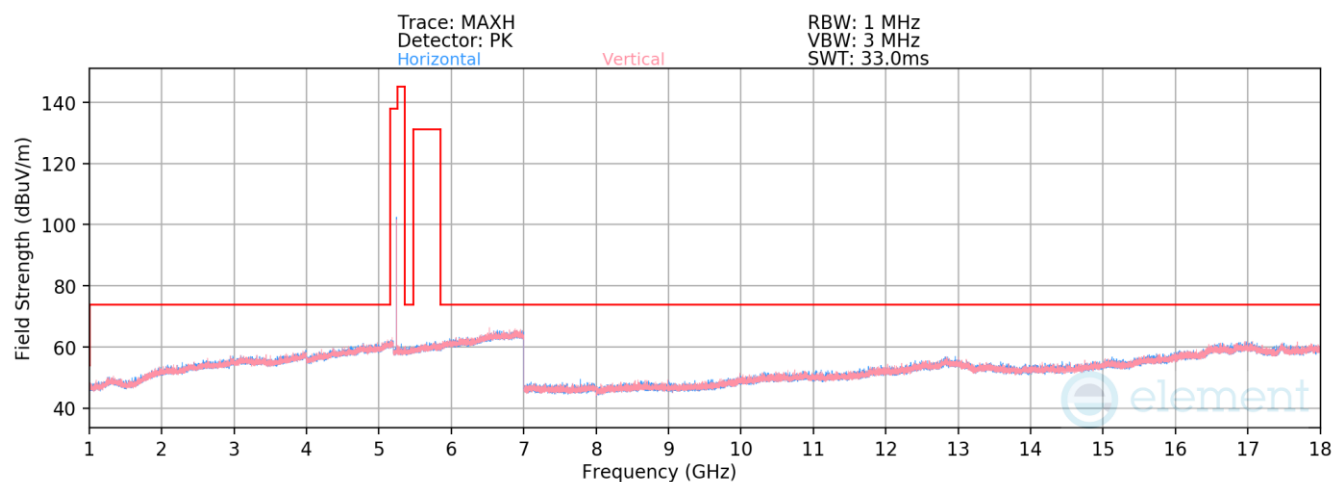

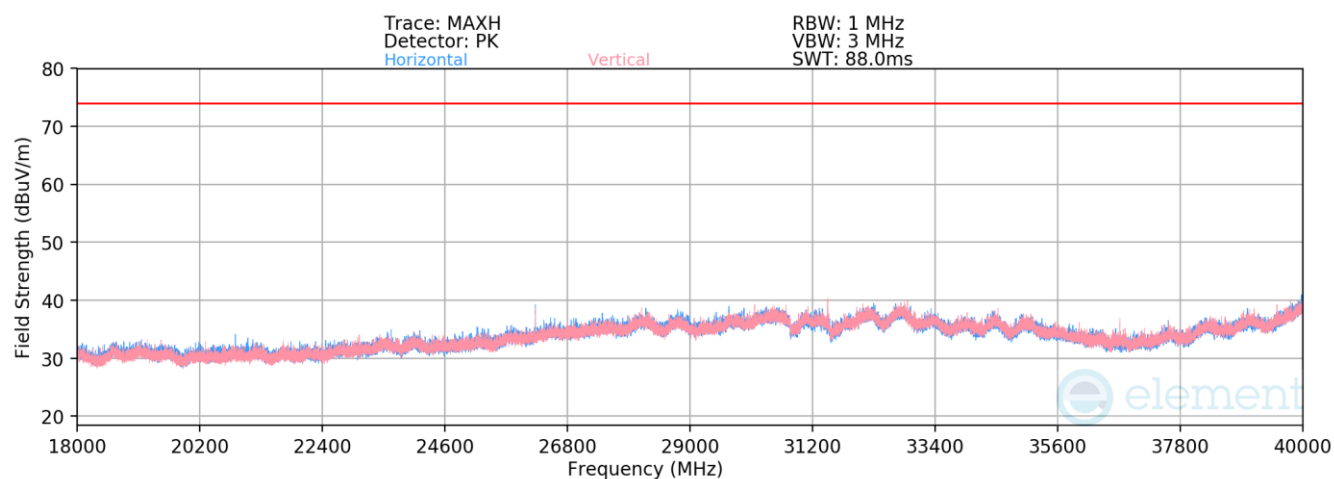

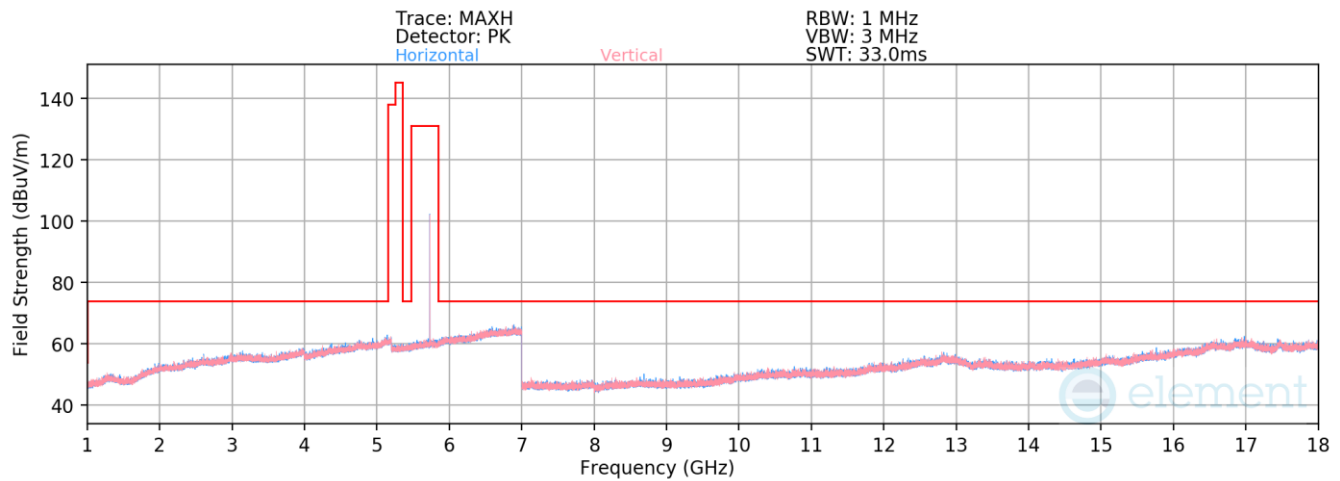

Plot 7-89. Radiated Spurious Emissions 1-18GHz (BDR GFSK – 5731MHz)

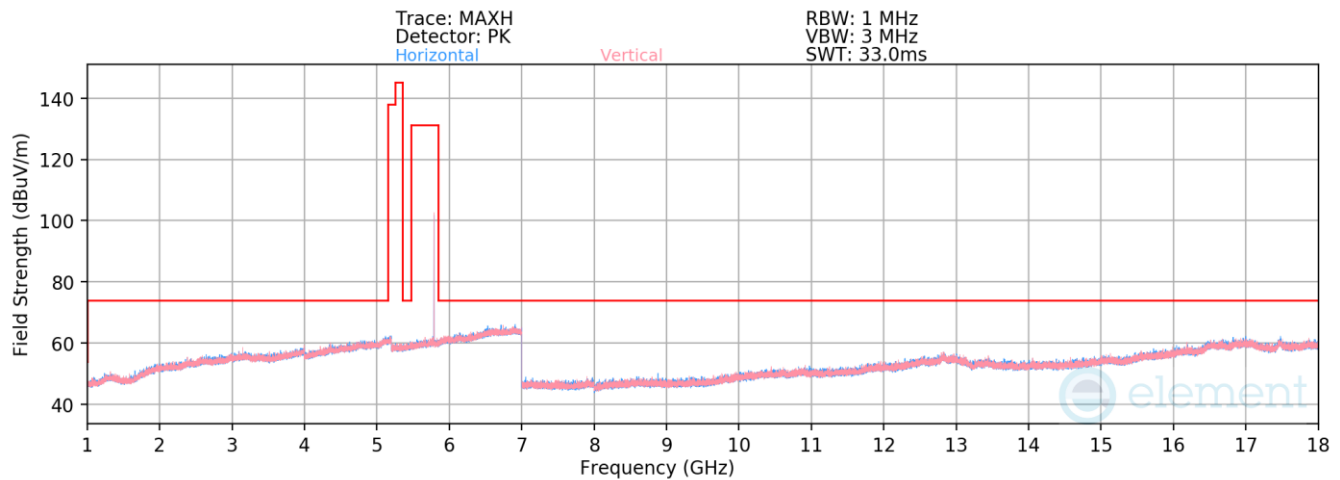

Plot 7-90. Radiated Spurious Emissions 1-18GHz (BDR GFSK – 5788MHz)

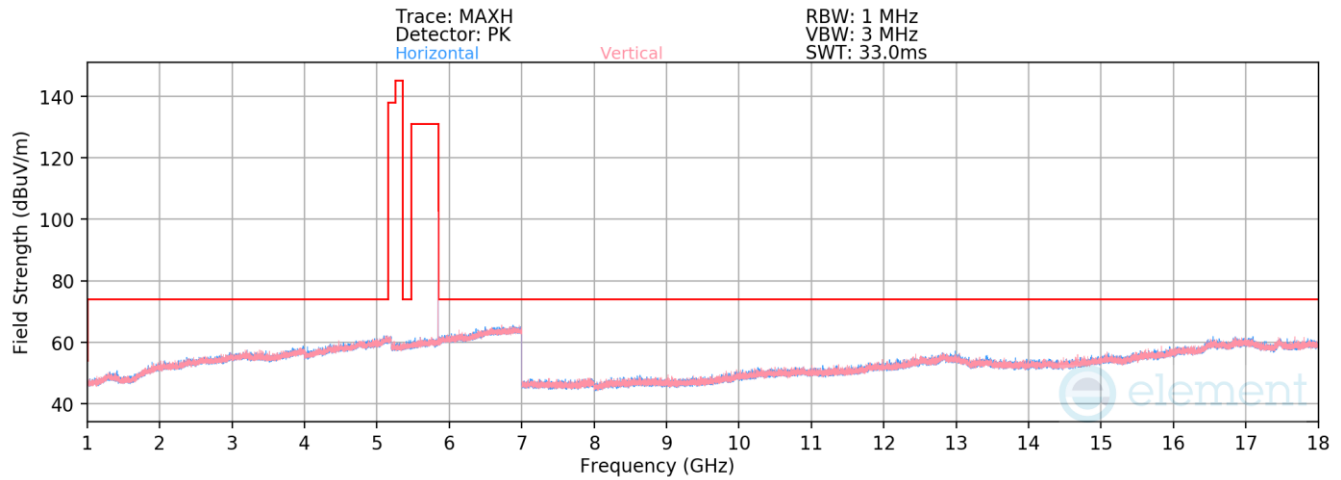

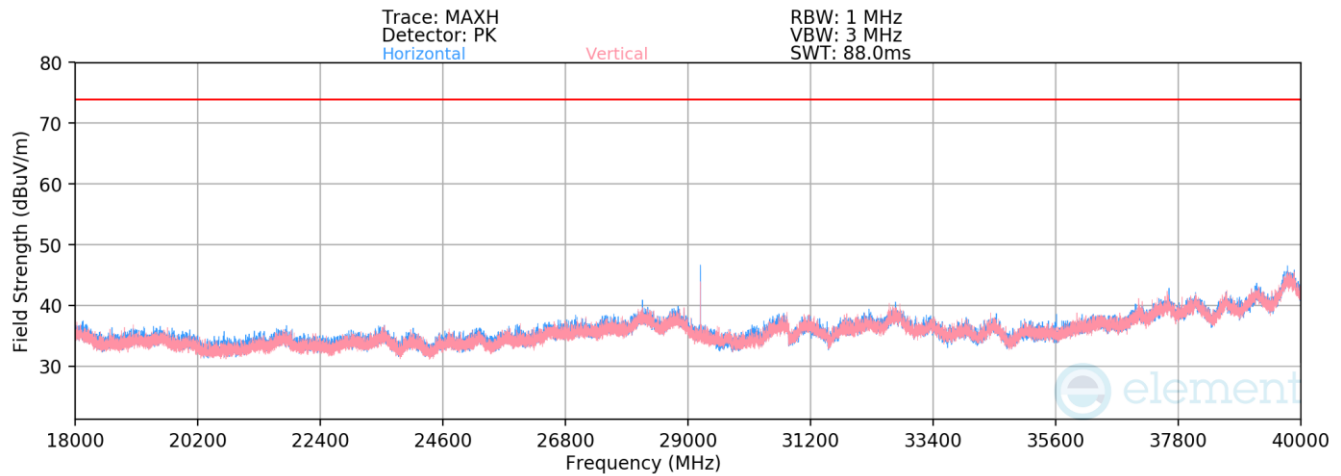

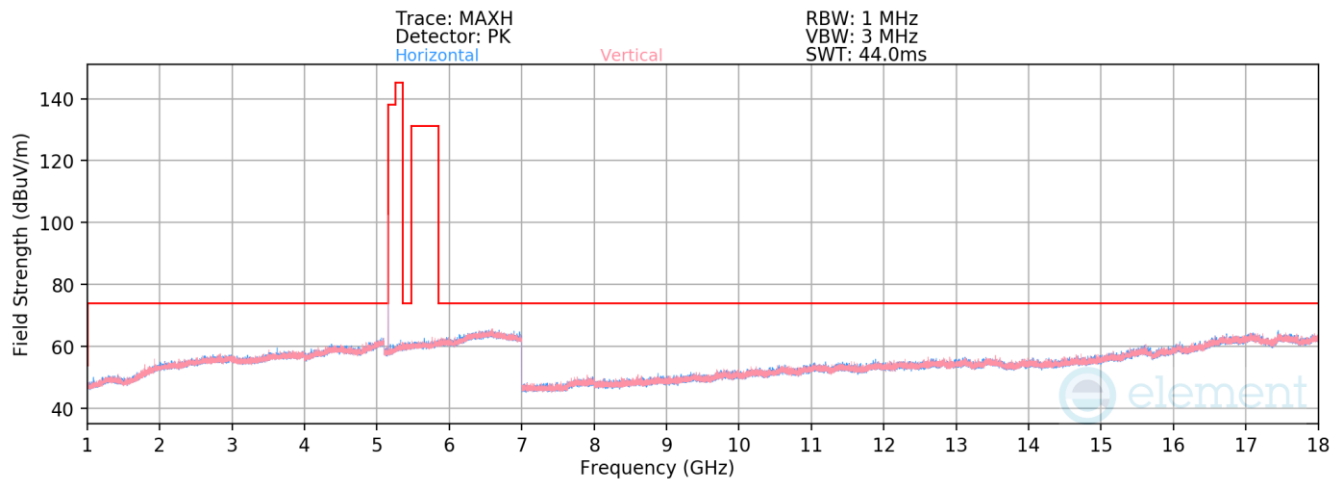
