4. CALIBRATION AND UNCERTAINTY

4.1. MEASURING INSTRUMENT CALIBRATION

The measuring equipment utilized to perform the tests documented in this report has been calibrated in accordance with the manufacturer's recommendations, and is traceable to recognized national standards.

4.2. SAMPLE CALCULATION

Where relevant, the following sample calculation is provided:

Field Strength (dBuV/m) = Measured Voltage (dBuV) + Antenna Factor (dB/m) + Cable Loss (dB) – Preamp Gain (dB)

36.5 dBuV + 18.7 dB/m + 0.6 dB – 26.9 dB = 28.9 dBuV/m

5. EQUIPMENT UNDER TEST

5.1. DESCRIPTION OF EUT

The EUT, model number A1671, A1821 is a tablet with multimedia functions (music, application support, and video), Cellular GSM/GPRS/EGPRS/CDMA2000 1xRTT/1x Advanced/EVDO Rev.A/WCDMA /HSPA+/DC- HSDPA/LTE FDD & Carrier Aggregation/TDD/TD-SCDMA radio, IEEE 802.11a/b/g/n/ac radio, and Bluetooth radio. The rechargeable battery is not user accessible.

5.2. DESCRIPTION OF MODELS DIFFERENCES

Both Model A1671 and A1821 have identical PCB layout, design and functionality, except that A1671 supports second electronic-UICC based SIM or “soft SIM” (called eSIM) beside the regular UICC based SIM and A1821 will come with eSIM removed. RF and electromagnetic characteristic are independent of the eSIM element. Both Models have exactly same technology and band support. Model A1671 is used for EMC/RSE Testing and that data will be used for both Models

5.3. MAXIMUM OUTPUT POWER

EIRP/ERP TEST PROCEDURE

ANSI C63.26:2015/ TIA / EIA 603-D Clause 2.2.17
KDB 971168 Section 5.6

$$\text{ERP/EIRP} = \text{PMeas} + \text{GT} - \text{LC}$$

where: ERP/EIRP = effective or equivalent radiated power, respectively (expressed in the same units as PMeas, typically dBW or dBm);

PMeas = measured transmitter output power or PSD, in dBm or dBW;

GT = gain of the transmitting antenna, in dBd (ERP) or dBi (EIRP);

LC = signal attenuation in the connecting cable between the transmitter and antenna, in dB.

For devices utilizing multiple antennas, KDB 662911 provides guidance for determining the effective array transmit antenna gain term to be used in the above equation.

5.5. SOFTWARE AND FIRMWARE

The EUT software installed during testing was 14E32020u and firmware was 1.54.09.

5.6. WORST-CASE CONFIGURATION AND MODE

The worst-case is EUT on the highest power. Based on Peak Power measurement investigations, the following modes should be considered as worst-case scenario for all other measurements.

Worst-case modes:

- GSM GPRS
- GSM EGPRS
- CDMA 2000 1xRTT
- CDMA 2000 EVDO REV. A
- UMTS REL 99
- UMTS HSDPA

The EUT was investigated in three orthogonal orientations X/Y/Z. It was determined that X (Flatbed) orientation was worst-case orientation for cell band, secondary band, AWS band and PCS band without AC/DC adapter and headset.

Radiated spurious emissions were investigated below 30 MHz, from 30 MHz – 1 GHz, and above 1 GHz. There were no emissions found on below 30 MHz and 30 MHz - 1GHz.

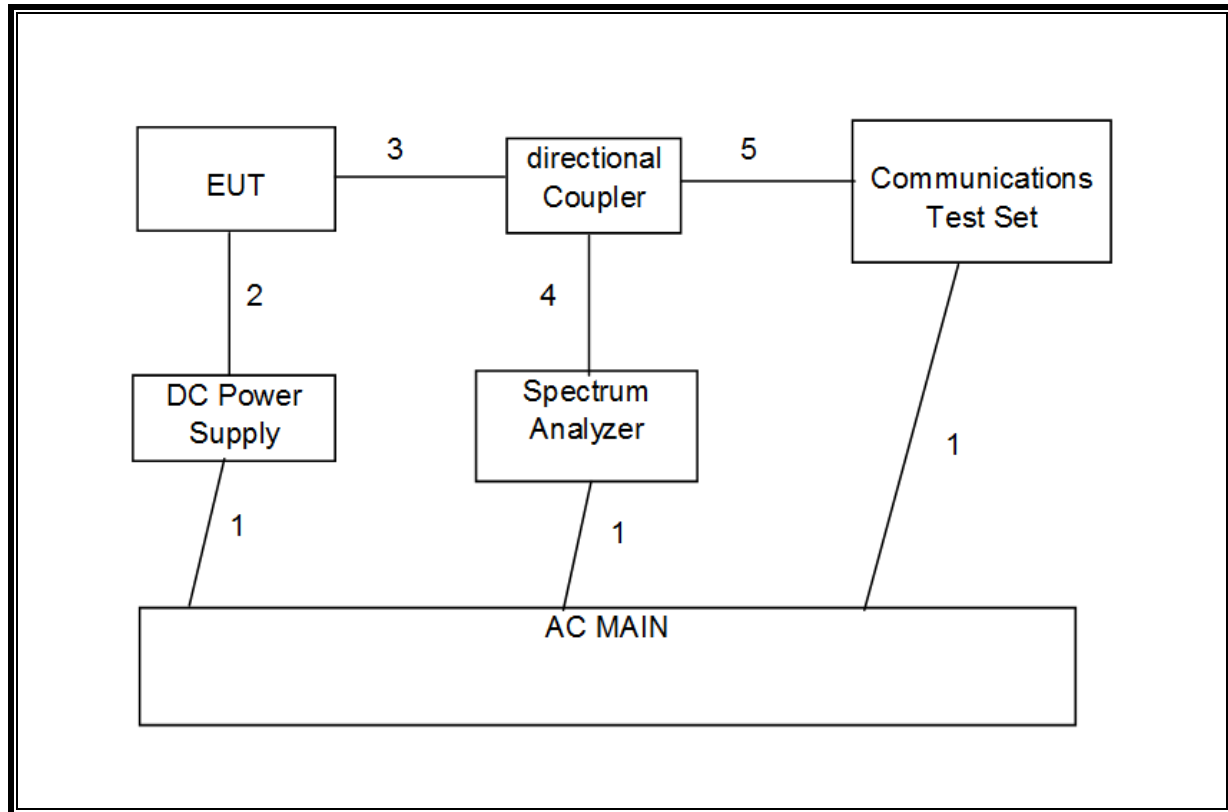

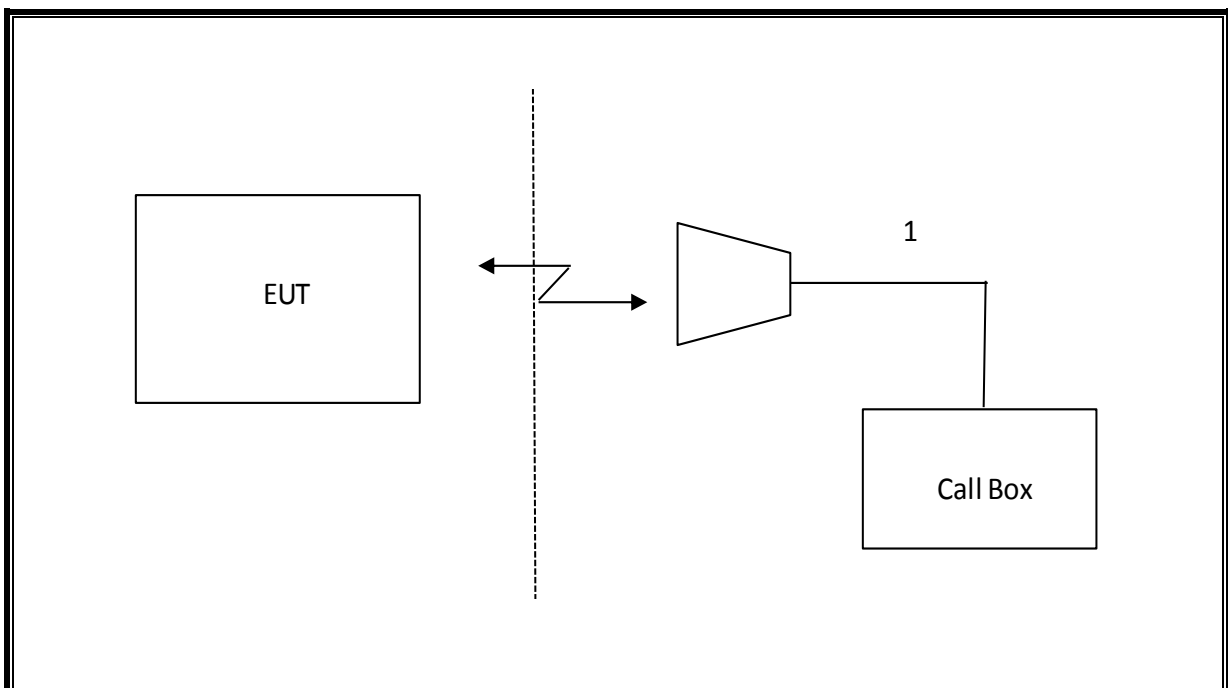

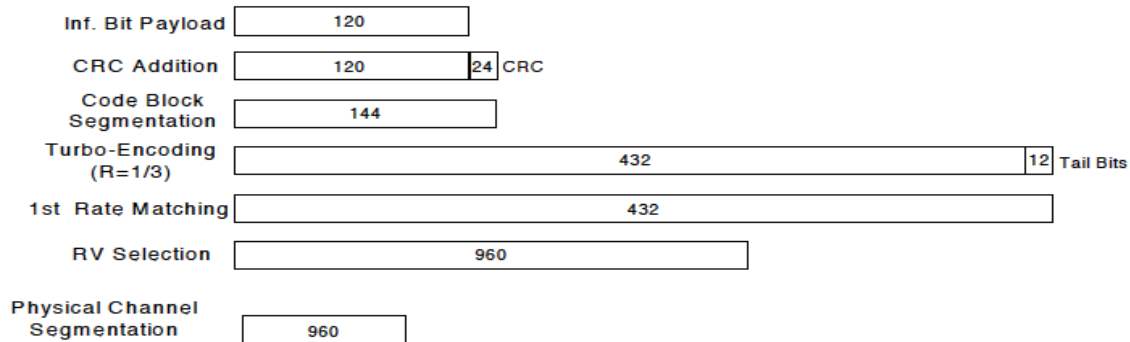


Figure C.8.19: Coding rate for Fixed reference Channel H-Set 12 (QPSK)

The temperature is increased by 10 degrees, allowed to stabilize and soak, and then the measurement is repeated. This is repeated until +50°C is reached.

Frequency Stability vs Voltage:

The peak frequency error is recorded (worst-case).

§22.917 (e) and §24.238 (a): Out of band emissions. The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least $43 + 10 \log (P)$ dB.

§27.53 (h) For operations in the 1710–1755 MHz and 2110–2155 MHz bands, the power of any emission outside a licensee's frequency block shall be attenuated below the transmitter power (P) by at least $43 + 10 \log_{10}(P)$ dB

§90.691 Emission mask requirements for EA-based systems.

(a) Out-of-band emission requirement shall apply only to the “outer” channels included in an EA license and to spectrum adjacent to interior channels used by incumbent licensees. The emission limits are as follows:

(1) For any frequency removed from the EA licensee's frequency block by up to and including 37.5 kHz, the power of any emission shall be attenuated below the transmitter power (P) in watts by at least $116 \log_{10} (f/6.1)$ decibels or $50 + 10 \log_{10} (P)$ decibels or 80 decibels, whichever is the lesser attenuation, where f is the frequency removed from the center of the outer channel in the block in kilohertz and where f is greater than 12.5 kHz.

(b) When an emission outside of the authorized bandwidth causes harmful interference, the Commission may, at its discretion, require greater attenuation than specified in this section.

RSS132§5.5

Mobile and base station equipment shall comply with the limits in (i) and (ii) below.

In the first 1.0 MHz band immediately outside and adjacent to each of the sub-bands specified in Section 5.1, the power of emissions per any 1% of the occupied bandwidth shall be attenuated (in dB) below the transmitter output power P (dBW) by at least $43 + 10 \log_{10} p$ (watts).

After the first 1.0 MHz immediately outside and adjacent to each of the sub-bands, the power of emissions in any 100 kHz bandwidth shall be attenuated (in dB) below the transmitter output power P (dBW) by at least $43 + 10 \log_{10} p$ (watts). If the measurement is performed using 1% of the occupied bandwidth, power integration over 100 kHz is required.

RSS133§6.5

Equipment shall comply with the limits in (i) and (ii) below.

(i) In the 1.0 MHz bands immediately outside and adjacent to the equipment's operating frequency block, the emission power per any 1% of the emission bandwidth shall be attenuated (in dB) below the transmitter output power P (dBW) by at least $43 + 10 \log_{10} p(\text{watts})$.

(ii) After the first 1.0 MHz, the emission power in any 1 MHz bandwidth shall be attenuated (in dB) below the transmitter output power P (dBW) by at least $43 + 10 \log_{10} p(\text{watts})$. If the measurement is performed using 1% of the emission bandwidth, power integration over 1.0 MHz is required.

RSS139§6.6

(i) In the first 1.0 MHz bands immediately outside and adjacent to the equipment's smallest operating frequency block, Footnote 2 which can contain the equipment's occupied bandwidth, the emission power per any 1% of the emission bandwidth shall be attenuated below the transmitter output power P (in dBW) by at least $43 + 10 \log_{10} p(\text{watts})$ dB.

(ii) After the first 1.0 MHz outside the equipment's smallest operating frequency block, which can contain the equipment's occupied bandwidth, the emission power in any 1 MHz bandwidth shall be attenuated below the transmitter output power P (in dBW) by at least $43 + 10 \log_{10} p(\text{watts})$ dB.

TEST PROCEDURE

For Cellular equipment - Compliance with these rules is based on the use of measurement instrumentation employing a resolution bandwidth of 100 kHz or greater. In the 1 MHz bands immediately outside and adjacent to the frequency block a resolution bandwidth of at least one percent of the emission bandwidth of the fundamental emission of the transmitter may be employed. A narrower resolution bandwidth is permitted in all cases to improve measurement accuracy provided the measured power is integrated over the full required measurement bandwidth (i.e. 100 kHz or 1 percent of emission bandwidth, as specified). The emission bandwidth is defined as the width of the signal between two points, one below the carrier center frequency and one above the carrier center frequency, outside of which all emissions are attenuated at least 26 dB below the transmitter power.

For PCS equipment - Compliance with these rules is based on the use of measurement instrumentation employing a resolution bandwidth of 1 MHz or greater. However, in the 1 MHz bands immediately outside and adjacent to the frequency block a resolution bandwidth of at least one percent of the emission bandwidth of the fundamental emission of the transmitter may be employed. A narrower resolution bandwidth is permitted in all cases to improve measurement accuracy provided the measured power is integrated over the full required measurement bandwidth (i.e. 1 MHz or 1 percent of emission bandwidth, as specified). The emission bandwidth is defined as the width of the signal between two points, one below the carrier center frequency and one above the carrier center frequency, outside of which all emissions are attenuated at least 26 dB below the transmitter power.
