1.0 INTRODUCTION

1.1 Scope

Measurement and determination of electromagnetic emissions (EMC) of radio frequency devices including intentional and/or unintentional radiators for compliance with the technical rules and regulations of the Federal Communications Commission and the Innovation, Science and Economic Development Canada.

1.2 PCTEST Test Location

These measurement tests were conducted at the PCTEST Engineering Laboratory, Inc. facility located at 18855 Adams Court, Morgan Hill, CA 95037. The measurement facility is compliant with the test site requirements specified in ANSI C63.4-2014 and KDB 414788 D01 v01.

2.5 Test Configuration

The EUT was tested per the guidance of KDB 789033 D02 v01r04. ANSI C63.10-2013 was used to reference the appropriate EUT setup for radiated spurious emissions testing and AC line conducted testing. See Sections 3.2 for AC line conducted emissions test setups, 3.3 for radiated emissions test setups, and 7.2, 7.3, 7.4, and 7.5 for antenna port conducted emissions test setups.

The emissions below 1GHz and above 18GHz were tested with the highest transmitting power channel and the worst case configuration.

The EUT was manipulated through three orthogonal planes of X-orientation (flatbed), Y-orientation (landscape), and Z-orientation (portrait) during the testing. Only the worst case emissions were reported in this test report. The worst orientation was found to be Y-orientation (landscape).

For AC line conducted and radiated test below 1GHz, following configuration were investigated and EUT powered by AC/DC was the worst case.

- EUT powered by AC/DC adaptor via USB cable with wire charger
- EUT powered by host PC via USB cable with wire charger

802.11n HT20/40 and acVHT80 2TX CDD mode test data provided in this report covers 802.11n HT20/40 and 802.11acVHT80 2TX STBC mode

802.11n HT20/40 and acVHT80 2TX CDD test data provided in this report covers 802.11n HT20/40 and 802.11acVHT80 2TX SDM. Refer to Table 7-14 for conducted powers for channels where conducted powers were measured with SDM mode instead of worst-case CDD mode.

802.11ac VHT20 and VHT40 mode are different from 802.11n HT20 and HT40 only in control messages and have the same power settings.

2.6 Software and Firmware

The test was conducted with firmware version 15E61570I installed on the EUT.

For conducted spurious emissions, automated test software was used to measure emissions and capture the corresponding plots necessary to show compliance. The measurement software utilized is PCTEST "UNII Automation," Version 3.4.

2.7 EMI Suppression Device(s)/Modifications

No EMI suppression device(s) were added and/or no modifications were made during testing.

3.0 DESCRIPTION OF TESTS

3.1 Evaluation Procedure

The measurement procedures described in the American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices (ANSI C63.10-2013) and the guidance provided in KDB 789033 D02 v01r04 were used in the measurement of the EUT.

3.2 AC Line Conducted Emissions

The line-conducted facility is located inside a 7m x 3.66m x 2.7m shielded enclosure. The shielded enclosure is manufactured by AP Americas. The shielding effectiveness of the shielded room is in accordance with MIL-Std-285 or NSA 65-5. A 1m x 1.5m wooden table 80cm high is placed 40cm away from the vertical wall and 80cm away from the sidewall of the shielded room. Two 10kHz-30MHz, 50Ω/50µH Line-Impedance Stabilization Networks (LISNs) are bonded to the shielded room floor. Power to the LISNs is filtered by external high-current high-insertion loss power line filters. The external power line filter is an ETS Lindgren Model LPRX-4X30 (100dB Attenuation, 14kHz-18GHz) and the two EMI/RFI filters are ETS Lindgren Model LRW-2030-S1 (100dB Minimum Insertion Loss, 14kHz – 10GHz). These filters attenuate ambient signal noise from entering the measurement lines. These filters are also bonded to the shielded enclosure.

The EUT is powered from one LISN and the support equipment is powered from the second LISN. If the EUT is a DC-powered device, power will be derived from the source power supply it normally will be powered from and this supply line(s) will be connected to the second LISN. All interconnecting cables more than 1 meter were shortened to a 1 meter length by non-inductive bundling (serpentine fashion) and draped over the back edge of the test table. All cables were at least 40cm above the horizontal reference groundplane. Power cables for support equipment were routed down to the second LISN while ensuring that that cables were not draped over the second LISN.

Sufficient time for the EUT, support equipment, and test equipment was allowed in order for them to warm up to their normal operating condition. The RF output of the LISN was connected to the spectrum analyzer and exploratory measurements were made to determine the frequencies producing the maximum emission from the EUT. The spectrum was scanned from 150kHz to 30MHz with a spectrum analyzer. The detector function was set to peak mode for exploratory measurements while the bandwidth of the analyzer was set to 10kHz. The EUT, support equipment, and interconnecting cables were arranged and manipulated to maximize each emission. Once the worst case emissions have been identified, the one EUT cable configuration/arrangement and mode of operation that produced these emissions is used for final measurements on the same test site. The analyzer is set to CISPR quasi-peak and average detectors with a 9kHz resolution bandwidth for final measurements.

Line conducted emissions test results are shown in Section 7.8. Automated measurement software utilized is Rohde & Schwarz EMC32, Version 10.20.01.

3.3 Radiated Emissions

The radiated test facilities consisted of an indoor 3 meter semi-anechoic chamber used for final measurements and exploratory measurements, when necessary. The measurement area is contained within the semi-anechoic chamber which is shielded from any ambient interference. The test site inside the chamber is a 6m x 5.2m elliptical, obstruction-free area in accordance with Figure 5.7 of Clause 5 in ANSI C63.4-2014. Absorbers are arranged on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections for measurements above 1GHz. An 80cm tall test table made of Styrodur is placed on top of the turn table. For measurements above 1GHz, an additional Styrodur pedestal is placed on top of the test table to bring the total table height to 1.5m.

For all measurements, the spectrum was scanned through all EUT azimuths and from 1 to 4 meter receive antenna height using a broadband antenna from 30MHz up to the upper frequency shown in 15.33(b)(1) depending on the highest frequency generated or used in the device or on which the device operates or tunes. For frequencies above 1GHz, linearly polarized double ridge horn antennas were used. For frequencies below 30MHz, a calibrated loop antenna was used. When exploratory measurements were necessary, they were performed at 1 meter test distance inside the semi-anechoic chamber using broadband antennas, broadband amplifiers, and spectrum analyzers to determine the frequencies and modes producing the maximum emissions. Sufficient time for the EUT, support equipment, and test equipment was allowed in order for them to warm up to their normal operating condition. The test set-up was placed on top of the 1 x 1.5 meter table. The EUT, support equipment, and interconnecting cables were arranged and manipulated to maximize each emission. Appropriate precaution was taken to ensure that all emissions from the EUT were maximized and investigated. The system configuration, mode of operation, turntable azimuth, and receive antenna height was noted for each frequency found.

Final measurements were made in the semi-anechoic chamber using calibrated, linearly polarized broadband and horn antennas. The test setup was configured to the setup that produced the worst case emissions. The spectrum analyzer was set to investigate all frequencies required for testing to compare the highest radiated disturbances with respect to the specified limits. The turntable containing the EUT was rotated through 360 degrees and the height of the receive antenna was varied 1 to 4 meters and stopped at the azimuth and height producing the maximum emission. Each emission was maximized by changing the orientation of the EUT through three orthogonal planes and changing the polarity of the receive antenna, whichever produced the worst-case emissions.

3.4 Environmental Conditions

The temperature is controlled within range of 15°C to 35°C. The relative humidity is controlled within range of 10% to 75%. The atmospheric pressure is monitored within the range 86-106kPa (860-1060mbar).

The bandwidth at 26dB down from the highest in-band spectral density is measured with a spectrum analyzer connected to the antenna terminal while the EUT is operating at its maximum duty cycle, at its maximum power control level, as defined in ANSI C63.10-2013 and KDB 789033 D02 v01r04, and at the appropriate frequencies. The spectrum analyzer's bandwidth measurement function is configured to measure the 26dB bandwidth.

The 26dB bandwidth is used to determine the conducted power limits.




Plot 7-1. 26dB Bandwidth Plot SISO ANT1 (802.11a (UNII Band 1) – Ch. 36)




Plot 7-3. 26dB Bandwidth Plot SISO ANT1 (802.11a (UNII Band 1) – Ch. 48)




Plot 7-4. 26dB Bandwidth Plot SISO ANT1 (20MHz BW 802.11n (UNII Band 1) – Ch. 36)




Plot 7-5. 26dB Bandwidth Plot SISO ANT1 (20MHz BW 802.11n (UNII Band 1) – Ch. 40)




Plot 7-6. 26dB Bandwidth Plot SISO ANT1 (20MHz BW 802.11n (UNII Band 1) – Ch. 48)




Plot 7-7. 26dB Bandwidth Plot SISO ANT1 (40MHz BW 802.11n (UNII Band 1) – Ch. 38)




Plot 7-9. 26dB Bandwidth Plot SISO ANT1 (80MHz BW 802.11ac (UNII Band 1) – Ch. 42)




Plot 7-10. 26dB Bandwidth Plot SISO ANT1 (802.11a (UNII Band 2A) – Ch. 52)

Plot 7-13. 26dB Bandwidth Plot SISO ANT1 (20MHz BW 802.11n (UNII Band 2A) – Ch. 52)




Plot 7-14. 26dB Bandwidth Plot SISO ANT1 (20MHz BW 802.11n (UNII Band 2A) – Ch. 56)




Plot 7-15. 26dB Bandwidth Plot SISO ANT1 (20MHz BW 802.11n (UNII Band 2A) – Ch. 64)




Plot 7-16. 26dB Bandwidth Plot SISO ANT1 (40MHz BW 802.11n (UNII Band 2A) – Ch. 54)

Plot 7-17. 26dB Bandwidth Plot SISO ANT1 (40MHz BW 802.11n (UNII Band 2A) – Ch. 62)






Plot 7-19. 26dB Bandwidth Plot SISO ANT1 (802.11a (UNII Band 2C) – Ch. 100)




Plot 7-20. 26dB Bandwidth Plot SISO ANT1 (802.11a (UNII Band 2C) – Ch. 116)




Plot 7-21. 26dB Bandwidth Plot SISO ANT1 (802.11a (UNII Band 2C) – Ch. 144)




Plot 7-22. 26dB Bandwidth Plot SISO ANT1 (20MHz BW 802.11n (UNII Band 2C) – Ch. 100)




Plot 7-23. 26dB Bandwidth Plot SISO ANT1 (20MHz BW 802.11n (UNII Band 2C) – Ch. 116)




Plot 7-24. 26dB Bandwidth Plot SISO ANT1 (20MHz BW 802.11n (UNII Band 2C) – Ch. 144)




Plot 7-25. 26dB Bandwidth Plot SISO ANT1 (40MHz BW 802.11n (UNII Band 2C) – Ch. 102)




Plot 7-26. 26dB Bandwidth Plot SISO ANT1 (40MHz BW 802.11n (UNII Band 2C) – Ch. 110)




Plot 7-27. 26dB Bandwidth Plot SISO ANT1 (40MHz BW 802.11n (UNII Band 2C) – Ch. 142)

Plot 7-30. 26dB Bandwidth Plot SISO ANT2 (802.11a (UNII Band 1) – Ch. 36)




Plot 7-31. 26dB Bandwidth Plot SISO ANT2 (802.11a (UNII Band 1) – Ch. 40)




Plot 7-32. 26dB Bandwidth Plot SISO ANT2 (802.11a (UNII Band 1) – Ch. 48)




Plot 7-34. 26dB Bandwidth Plot SISO ANT2 (20MHz BW 802.11n (UNII Band 1) – Ch. 40)




Plot 7-35. 26dB Bandwidth Plot SISO ANT2 (20MHz BW 802.11n (UNII Band 1) – Ch. 48)




Plot 7-36. 26dB Bandwidth Plot SISO ANT2 (40MHz BW 802.11n (UNII Band 1) – Ch. 38)




Plot 7-38. 26dB Bandwidth Plot SISO ANT2 (80MHz BW 802.11ac (UNII Band 1) – Ch. 42)




Plot 7-40. 26dB Bandwidth Plot SISO ANT2 (802.11a (UNII Band 2A) – Ch. 56)




Plot 7-42. 26dB Bandwidth Plot SISO ANT2 (20MHz BW 802.11n (UNII Band 2A) – Ch. 52)




Plot 7-43. 26dB Bandwidth Plot SISO ANT2 (20MHz BW 802.11n (UNII Band 2A) – Ch. 56)




Plot 7-44. 26dB Bandwidth Plot SISO ANT2 (20MHz BW 802.11n (UNII Band 2A) – Ch. 64)




Plot 7-46. 26dB Bandwidth Plot SISO ANT2 (40MHz BW 802.11n (UNII Band 2A) – Ch. 62)






Plot 7-48. 26dB Bandwidth Plot SISO ANT2 (802.11a (UNII Band 2C) – Ch. 100)




Plot 7-50. 26dB Bandwidth Plot SISO ANT2 (802.11a (UNII Band 2C) – Ch. 144)




Plot 7-51. 26dB Bandwidth Plot SISO ANT2 (20MHz BW 802.11n (UNII Band 2C) – Ch. 100)




Plot 7-52. 26dB Bandwidth Plot SISO ANT2 (20MHz BW 802.11n (UNII Band 2C) – Ch. 116)




Plot 7-53. 26dB Bandwidth Plot SISO ANT2 (20MHz BW 802.11n (UNII Band 2C) – Ch. 144)




Plot 7-54. 26dB Bandwidth Plot SISO ANT2 (40MHz BW 802.11n (UNII Band 2C) – Ch. 102)




Plot 7-55. 26dB Bandwidth Plot SISO ANT2 (40MHz BW 802.11n (UNII Band 2C) – Ch. 110)




Plot 7-56. 26dB Bandwidth Plot SISO ANT2 (40MHz BW 802.11n (UNII Band 2C) – Ch. 142)








Plot 7-59. 26dB Bandwidth Plot MIMO ANT1 (20MHz BW 802.11n (UNII Band 1) – Ch. 36)




Plot 7-60. 26dB Bandwidth Plot MIMO ANT2 (20MHz BW 802.11n (UNII Band 1) – Ch. 36)




Plot 7-61. 26dB Bandwidth Plot MIMO ANT1 (20MHz BW 802.11n (UNII Band 1) – Ch. 40)




Plot 7-62. 26dB Bandwidth Plot MIMO ANT2 (20MHz BW 802.11n (UNII Band 1) – Ch. 40)




Plot 7-63. 26dB Bandwidth Plot MIMO ANT1 (20MHz BW 802.11n (UNII Band 1) – Ch. 48)




Plot 7-64. 26dB Bandwidth Plot MIMO ANT2 (20MHz BW 802.11n (UNII Band 1) – Ch. 48)




Plot 7-65. 26dB Bandwidth Plot MIMO ANT1 (40MHz BW 802.11n (UNII Band 1) – Ch. 38)




Plot 7-66. 26dB Bandwidth Plot MIMO ANT2 (40MHz BW 802.11n (UNII Band 1) – Ch. 38)




Plot 7-67. 26dB Bandwidth Plot MIMO ANT1 (40MHz BW 802.11n (UNII Band 1) – Ch. 46)




Plot 7-68. 26dB Bandwidth Plot MIMO ANT2 (40MHz BW 802.11n (UNII Band 1) – Ch. 46)























































Test Overview and Limit

The bandwidth at 6dB down from the highest in-band spectral density is measured with a spectrum analyzer connected to the antenna terminal while the EUT is operating at its maximum duty cycle, at its maximum power control level, as defined in ANSI C63.10-2013 and KDB 789033 D02 v01r04, and at the appropriate frequencies. The spectrum analyzer's bandwidth measurement function is configured to measure the 6dB bandwidth.

In the 5.725 – 5.850GHz band, the 6dB bandwidth must be \geq 500 kHz.

Test Procedure Used

ANSI C63.10-2013 – Section 6.9.2
 KDB 789033 D02 v01r04 – Section C

Test Settings

1. The signal analyzers' automatic bandwidth measurement capability was used to perform the 6dB bandwidth measurement. The "X" dB bandwidth parameter was set to X = 6. The automatic bandwidth measurement function also has the capability of simultaneously measuring the 99% occupied bandwidth. 




Plot 7-99. 6dB Bandwidth Plot SISO ANT1 (802.11a (UNII Band 3) – Ch. 149)




Plot 7-100. 6dB Bandwidth Plot SISO ANT1 (802.11a (UNII Band 3) – Ch. 157)




Plot 7-102. 6dB Bandwidth Plot SISO ANT1 (20MHz BW 802.11n (UNII Band 3) – Ch. 149)




Plot 7-103. 6dB Bandwidth Plot SISO ANT1 (20MHz BW 802.11n (UNII Band 3) – Ch. 157)




Plot 7-104. 6dB Bandwidth Plot SISO ANT1 (20MHz BW 802.11n (UNII Band 3) – Ch. 165)




Plot 7-105. 6dB Bandwidth Plot SISO ANT1 (40MHz BW 802.11n (UNII Band 3) – Ch. 151)

Plot 7-106. 6dB Bandwidth Plot SISO ANT1 (40MHz BW 802.11n (UNII Band 3) – Ch. 159)




Plot 7-107. 6dB Bandwidth Plot SISO ANT1 (80MHz BW 802.11ac (UNII Band 3) – Ch. 155)






Plot 7-109. 6dB Bandwidth Plot SISO ANT2 (802.11a (UNII Band 3) – Ch. 157)




Plot 7-111. 6dB Bandwidth Plot SISO ANT2 (20MHz BW 802.11n (UNII Band 3) – Ch. 149)




Plot 7-113. 6dB Bandwidth Plot SISO ANT2 (20MHz BW 802.11n (UNII Band 3) – Ch. 165)




Plot 7-114. 6dB Bandwidth Plot SISO ANT2 (40MHz BW 802.11n (UNII Band 3) – Ch. 151)
