



SISO Core 1 Conducted Emissions at the Band Edge




Plot 7-87. Band Edge SISO CORE 1 (802.11ax OFDMA – RU26 Index 0 – Ch. 1)




Plot 7-88. Band Edge SISO CORE 1 (802.11ax OFDMA – RU26 Index 0 – Ch. 2)




Plot 7-89. Band Edge SISO CORE 1 (802.11ax OFDMA – RU26 Index 8 – Ch. 9)




Plot 7-90. Band Edge SISO CORE 1 (802.11ax OFDMA – RU26 Index 8 – Ch. 10)




Plot 7-91. Band Edge SISO CORE 1 (802.11ax OFDMA – RU26 Index 8 – Ch. 11)




Plot 7-92. Band Edge SISO CORE 1 (802.11ax OFDMA – RU26 Index 8 – Ch. 12)




Plot 7-93. Band Edge SISO CORE 1 (802.11ax OFDMA – RU242 – Ch. 1)




Plot 7-94. Band Edge SISO CORE 1 (802.11ax OFDMA – RU242 – Ch. 2)




Plot 7-95. Band Edge SISO CORE 1 (802.11ax OFDMA – RU242 – Ch. 9)




Plot 7-96. Band Edge SISO CORE 1 (802.11ax OFDMA – RU242 – Ch. 10)

7.6 Conducted Spurious Emissions

§15.247(d); RSS-247 [5.5]

Test Overview and Limit

All out of band emissions are measured with a spectrum analyzer connected to the antenna terminal of the EUT while the EUT is operating at its maximum duty cycle, at maximum power, and at the appropriate frequencies. All data rates, RU configurations, and RU indices were investigated to determine the worst case configuration. For the following out of band conducted emissions plots, the EUT was set to a data rate of MCS0 in 802.11ax mode as this setting produced the worst-case emissions.

The limit for out-of-band spurious emissions at the band edge is 20dB below the fundamental emission level, as determined from the in-band power measurement of the DTS channel performed in a 100kHz bandwidth per the procedure in Section 11.1 of ANSI C63.10-2013 and KDB 558074 D01 v05r01.

Test Settings

1. Start frequency was set to 30MHz and stop frequency was set to 25GHz (separated into two plots per channel)
2. RBW = 1MHz
3. VBW = 3MHz
4. Detector = Peak
5. Trace mode = max hold
6. Sweep time = auto couple
7. The trace was allowed to stabilize

Figure 7-5. Test Instrument & Measurement Setup



Test Notes


1. RBW was set to 1MHz rather than 100kHz in order to increase the measurement speed.
2. The display line shown in the following plots denotes the limit at 20dB below the fundamental emission level measured in a 100kHz bandwidth. However, since the traces in the following plots are measured with a 1MHz RBW, the display line may not necessarily appear to be 20dB below the level of the fundamental in a 1MHz bandwidth.
3. For plots showing conducted spurious emissions near the limit, the frequencies were investigated with a reduced RBW to ensure that no emissions were present.
4. The conducted spurious emissions were measured to relative limits. Therefore, in accordance with ANSI C63.10-2013 and KDB 662911 D01 v02r01 Section E)3)b), it was unnecessary to show compliance through the summation of test results of the individual outputs.
5. All antenna configs were investigated and only the worst case is reported.




Plot 7-99. Conducted Spurious Plot SISO CORE 0 (802.11ax OFDMA – RU26 – Ch. 1)




Plot 7-100. Conducted Spurious Plot SISO CORE 0 (802.11ax OFDMA – RU26 – Ch. 1)




Plot 7-101. Conducted Spurious Plot SISO CORE 0 (802.11ax OFDMA – RU26 – Ch. 6)




Plot 7-102. Conducted Spurious Plot SISO CORE 0 (802.11ax OFDMA – RU26 – Ch. 6)




Plot 7-103. Conducted Spurious Plot SISO CORE 0 (802.11ax OFDMA – RU26 – Ch. 11)




Plot 7-104. Conducted Spurious Plot SISO CORE 0 (802.11ax OFDMA – RU26 – Ch. 11)




Plot 7-105. Conducted Spurious Plot SISO CORE 0 (802.11ax OFDMA – RU242 – Ch. 1)




Plot 7-106. Conducted Spurious Plot SISO CORE 0 (802.11ax OFDMA – RU242 – Ch. 1)




Plot 7-107. Conducted Spurious Plot SISO CORE 0 (802.11ax OFDMA – RU242 – Ch. 6)




Plot 7-108. Conducted Spurious Plot SISO CORE 0 (802.11ax OFDMA – RU242 – Ch. 6)


Plot 7-109. Conducted Spurious Plot SISO CORE 0 (802.11ax OFDMA – RU242 – Ch. 11)





SISO Core 1 Conducted Spurious Emissions




Plot 7-111. Conducted Spurious Plot SISO CORE 1 (802.11ax OFDMA – RU26 – Ch. 1)




Plot 7-113. Conducted Spurious Plot SISO CORE 1 (802.11ax OFDMA – RU26 – Ch. 6)




Plot 7-114. Conducted Spurious Plot SISO CORE 1 (802.11ax OFDMA – RU26 – Ch. 6)




Plot 7-115. Conducted Spurious Plot SISO CORE 1 (802.11ax OFDMA – RU26 – Ch. 11)




Plot 7-116. Conducted Spurious Plot SISO CORE 1 (802.11ax OFDMA – RU26 – Ch. 11)




Plot 7-117. Conducted Spurious Plot SISO CORE 1 (802.11ax OFDMA – RU242 – Ch. 1)




Plot 7-118. Conducted Spurious Plot SISO CORE 1 (802.11ax OFDMA – RU242 – Ch. 1)




Plot 7-119. Conducted Spurious Plot SISO CORE 1 (802.11ax OFDMA – RU242 – Ch. 6)




Plot 7-120. Conducted Spurious Plot SISO CORE 1 (802.11ax OFDMA – RU242 – Ch. 6)

All data rates and modes were investigated for radiated spurious emissions. Only the radiated emissions of the configuration that produced the worst case emissions are reported in this section.

All out of band emissions appearing in a restricted band as specified in Section 15.205 of the Title 47 CFR and Table 7 of RSS-Gen (8.10) must not exceed the limits shown in Table 7-19 per Section 15.209 and RSS-Gen (8.9).




Figure 7-6. Test Instrument & Measurement Setup

Test Notes

1. The optional test procedures for antenna port conducted measurements of unwanted emissions per the guidance of KDB 558074 D01 v05r01 were not used to evaluate this device for compliance to radiated limits. All radiated spurious emissions levels were measured in a radiated test setup.
2. All emissions lying in restricted bands specified in Section 15.205 and Section 8.10 of RSS-Gen are below the limit shown in Table 7-19.
3. The antenna is manipulated through typical positions, polarity and length during the tests. The EUT is manipulated through three orthogonal planes.
4. This unit was tested with its standard battery.
5. The spectrum is measured from 9kHz to the 10th harmonic of the fundamental frequency of the transmitter using CISPR quasi peak detector below 1GHz. Above 1 GHz, average and peak measurements were taken using linearly polarized horn antennas. The worst-case emissions are reported however emissions whose levels were not within 20dB of the respective limits were not reported.
6. Emissions below 18GHz were measured at a 3 meter test distance while emissions above 18GHz were measured at a 1 meter test distance with the application of a distance correction factor.
7. The wide spectrum spurious emissions plots shown on the following pages are used only for the purpose of emission identification. Any emissions found to be within 20dB of the limit are fully investigated and the results are shown in this section.
8. The "-" shown in the following RSE tables are used to denote a noise floor measurement.







Plot 7-123. Radiated Spurious Plot above 1GHz SISO CORE 0 (802.11ax OFDMA – RU26 – Ch. 1)




Plot 7-124. Radiated Spurious Plot above 1GHz SISO CORE 0 (802.11ax OFDMA – RU26 – Ch. 6)




Plot 7-125. Radiated Spurious Plot above 1GHz SISO CORE 0 (802.11ax OFDMA – RU26 – Ch. 11)









Plot 7-129. Radiated Spurious Plot above 1GHz SISO CORE 1 (802.11ax OFDMA – RU26 – Ch. 1)




Plot 7-130. Radiated Spurious Plot above 1GHz SISO CORE 1 (802.11ax OFDMA – RU26 – Ch. 6)




Plot 7-131. Radiated Spurious Plot above 1GHz SISO CORE 1 (802.11ax OFDMA – RU26 – Ch. 11)









Plot 7-135. Radiated Spurious Plot above 1GHz CDD (802.11ax OFDMA – RU26 – Ch. 1)




Plot 7-136. Radiated Spurious Plot above 1GHz CDD (802.11ax OFDMA – RU26 – Ch. 6)




Plot 7-137. Radiated Spurious Plot above 1GHz CDD (802.11ax OFDMA – RU26 – Ch. 11)



Plot 7-139. Radiated Spurious Plot above 1GHz CDD (802.11ax OFDMA – RU242 – Ch. 6)




Plot 7-140. Radiated Spurious Plot above 1GHz CDD (802.11ax OFDMA – RU242 – Ch. 11)






Plot 7-141. Radiated Spurious Plot above 18GHz CDD (802.11ax OFDMA – RU26, Pol. H)




Plot 7-142. Radiated Spurious Plot above 18GHz CDD (802.11ax OFDMA – RU26, Pol. V)





Plot 7-145. Radiated Restricted Lower Band Edge Measurement SISO CORE 0 (Peak & Average – RU26)



Plot 7-146. Radiated Restricted Lower Band Edge Measurement SISO CORE 0 (Peak & Average – RU26)



Plot 7-147. Radiated Restricted Lower Band Edge Measurement SISO CORE 0 (Peak & Average – RU26)



Plot 7-148. Radiated Restricted Upper Band Edge Measurement SISO CORE 0 (Peak & Average – RU26)



Plot 7-149. Radiated Restricted Upper Band Edge Measurement SISO CORE 0 (Peak & Average – RU26)



Plot 7-150. Radiated Restricted Upper Band Edge Measurement SISO CORE 0 (Peak & Average – RU26)



Plot 7-151. Radiated Restricted Upper Band Edge Measurement SISO CORE 0 (Peak & Average – RU26)



Plot 7-152. Radiated Restricted Lower Band Edge Measurement SISO CORE 0 (Peak & Average – RU242)


