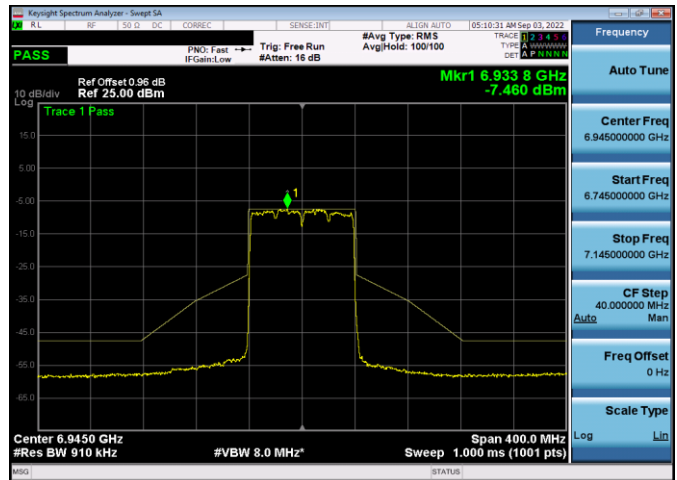

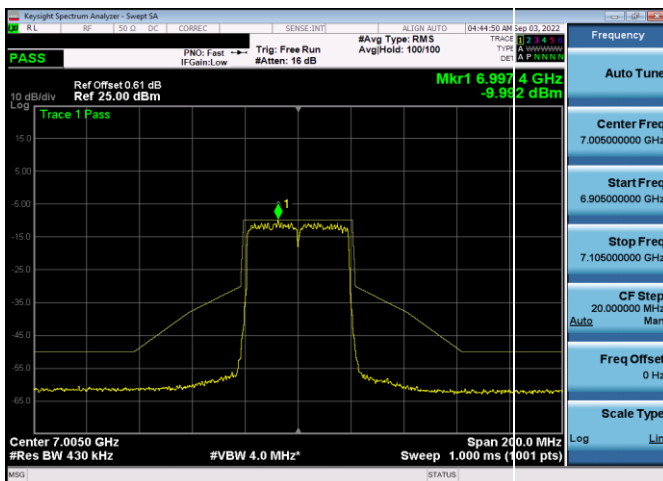

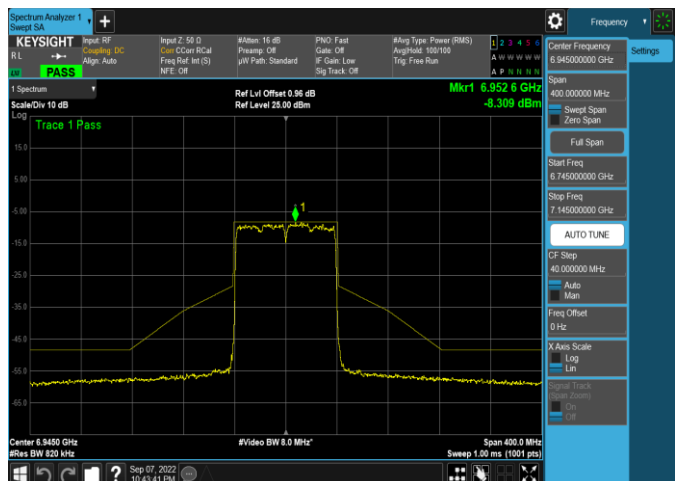

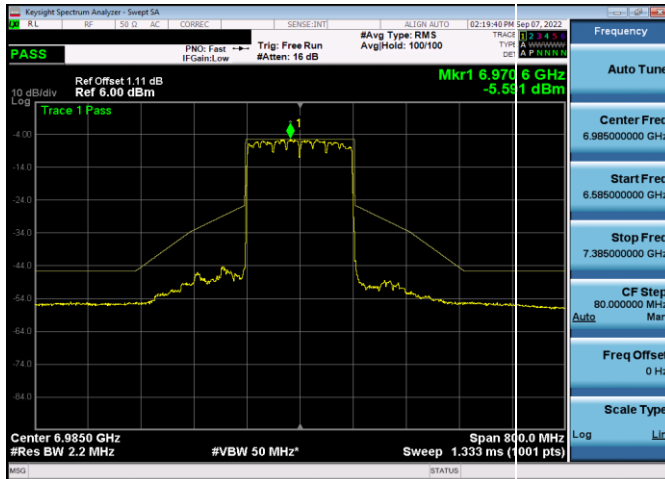

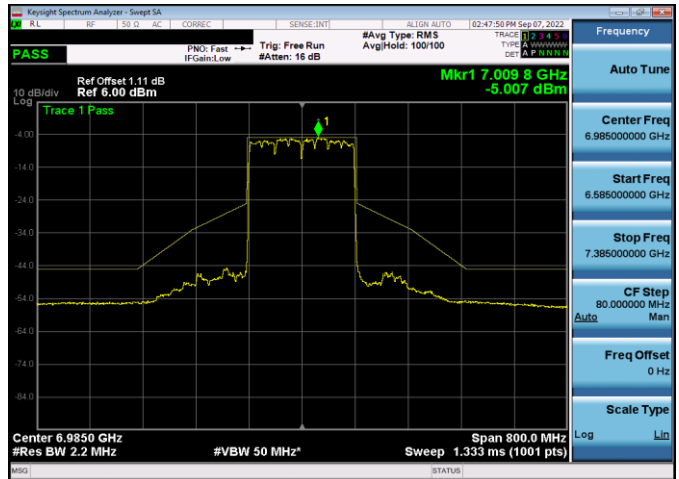

7.6 Contention Based Protocol – 802.11a/ax(SU)

§15.407(d)(6), RSS-248 [4.8]

Test Overview and Limit

Indoor access points, subordinate devices and client devices operating in the 5.925-7.125 GHz band (herein referred to as unlicensed devices) are required to use technologies that include a contention-based protocol to avoid co-channel interference with incumbent devices sharing the band. To ensure incumbent co-channel operations are detected in a technology-agnostic manner, unlicensed devices are required to detect co-channel radio frequency energy (energy detect) and avoid simultaneous transmission.

Unlicensed indoor low-power devices must detect co-channel radio frequency power that is at least -62 dBm or lower. Upon detection of energy in the band, unlicensed low power indoor devices must vacate the channel and stay off the channel as long as detected radio frequency power is equal to or greater than the threshold (-62 dBm). The -62 dBm (or lower) threshold is referenced to a 0 dBi antenna gain.

To ensure incumbent operations are reliably detected in the band, low power indoor devices must detect RF energy throughout their intended operating channel.

Test Procedure Used

ANSI C63.10-2013 – Section 12.3.2.2
KDB 987594 D02 v01r01

Test Settings

1. Configure the EUT to transmit with a constant duty cycle.
2. Set the operating parameters of the EUT including power level, operating frequency, modulation and bandwidth
3. Set the signal analyzer center frequency to the nominal EUT channel center frequency. The span range of the signal analyzer shall be between two times and five times the OBW of the EUT.
4. Connect the output port of the EUT to the signal analyzer 2, as shown in Figure 2. Ensure that the attenuator 2 provides enough attenuation to not overload the signal analyzer 2 receiver.
5. Monitoring the signal analyzer 2, verify the EUT is operating and transmitting with the parameters set at step two.
6. Using an AWGN signal source, generate (but do not transmit, i.e., RF OFF) a 10 MHz-wide AWGN signal. Use Table 1 to determine the center frequency of the 10 MHz AWGN signal relative to the EUT's channel bandwidth and center frequency.
7. Set the AWGN signal power to an extremely low level (more than 20 dB below the -62 dBm threshold). Connect the AWGN signal source, via a 3-dB splitter, to the signal analyzer 1 and the EUT as shown in Figure 2.
8. Transmit the AWGN signal (RF ON) and verify its characteristics on the signal analyzer 1.
9. Monitor the signal analyzer 2 to verify if the AWGN signal has been detected and the EUT has ceased transmission. If the EUT continues to transmit, then incrementally increase the AWGN signal power level until the EUT stops transmitting.
10. Including all losses in the RF paths) Determine and record the AWGN signal power level (at the EUT's antenna port) at which the EUT ceased transmission. Repeat the procedure at least 10 times to verify the EUT can detect an AWGN signal with 90% (or better) level of certainty.
11. Refer to Table 1 to determine number of times the detection threshold testing needs to be repeated. If testing is required more than once, then go back to step 5, choose a different center frequency for the AWGN signal and repeat the process.

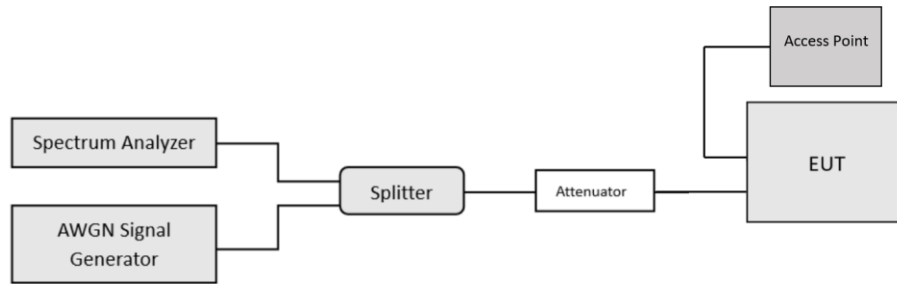


Figure 7-5. Contention-based protocol test setup, conducted method

Test Notes

1. Per guidance from KDB 987594 D02 v01r01, contention-based protocol was tested using an AWGN signal with a bandwidth of 10MHz. The amplitude of the signal was increased until detected by the EUT, signaled by the ceasing of transmission, marker indicates the point at which the AWGN signal is introduced.
2. Per KDB 987594 D04 v01, contention-based protocol was tested with receiver with the lowest antenna gain.
3. 15 trials were ran in order to assure that at least 90% of certainty was met.

Detection Level = Injected AWGN Power (dBm) – Antenna Gain (dBi) + Path Loss (dB)

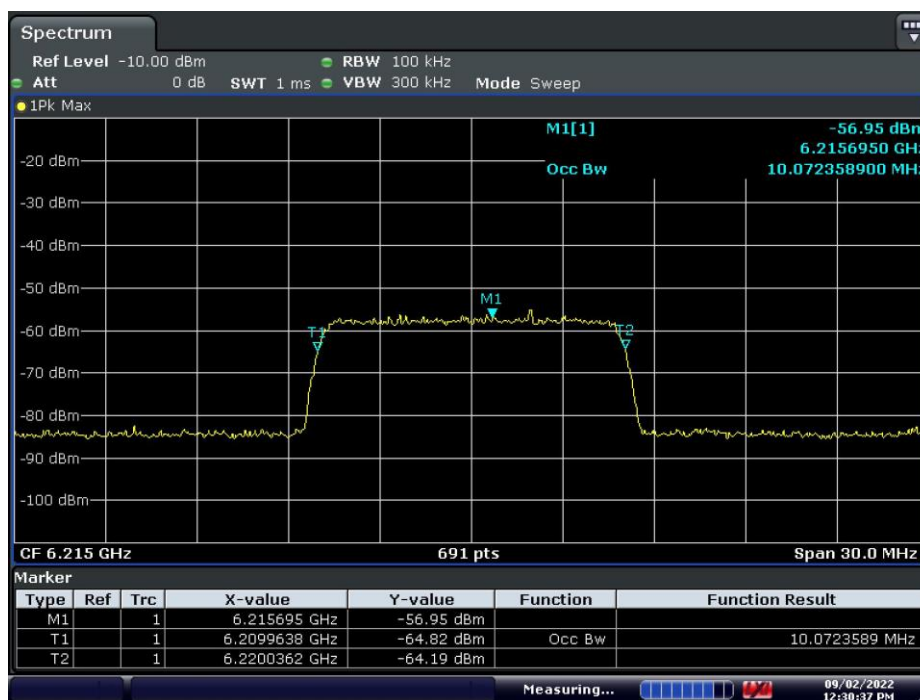

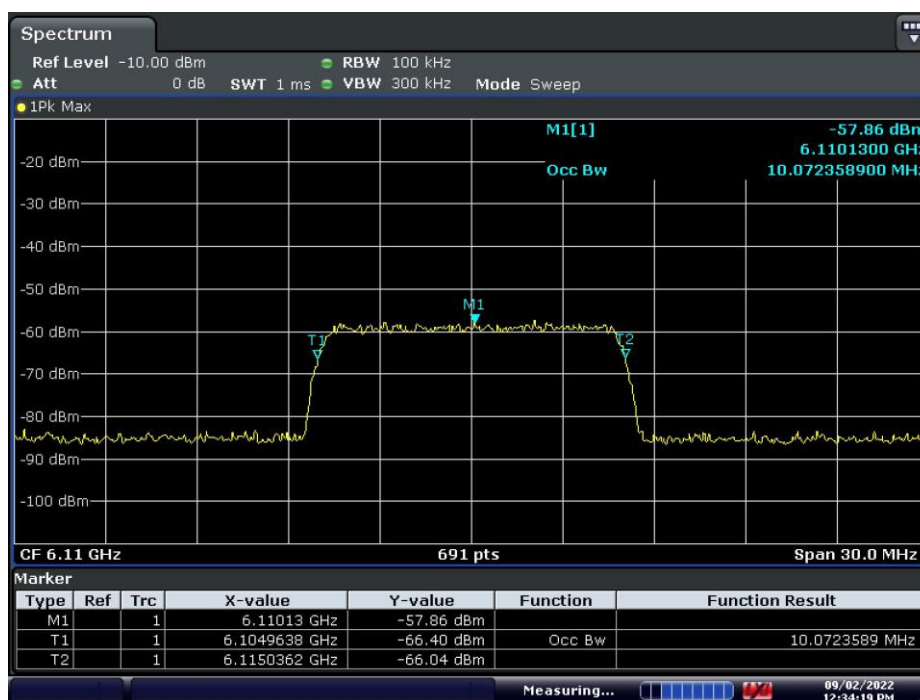

Plot 7-553. AWGN Signal – UNII 5 – 20MHz

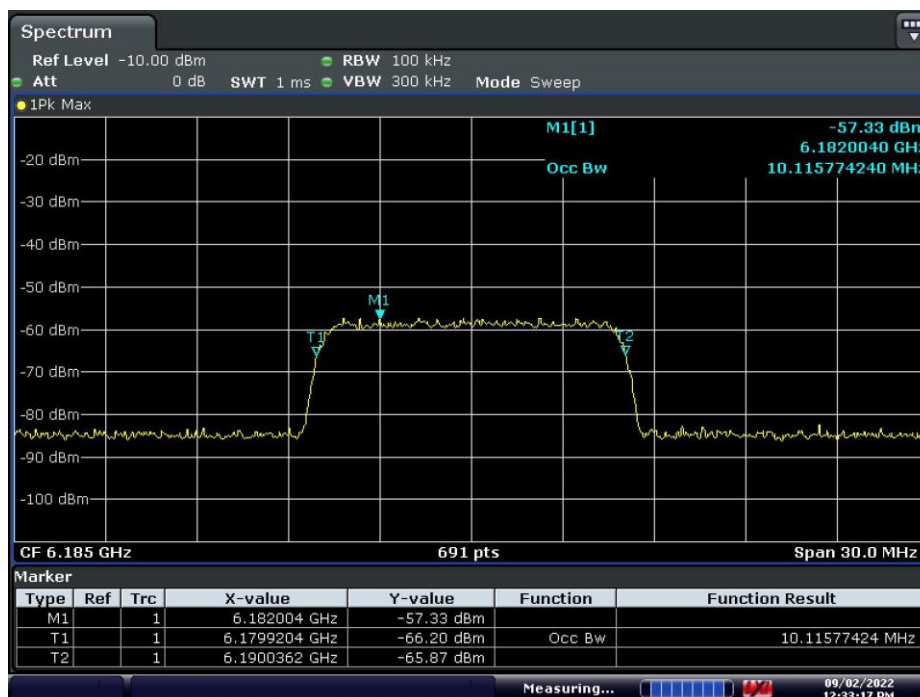


Plot 7-554. AWGN Signal – UNII 5 – 160MHz - Low

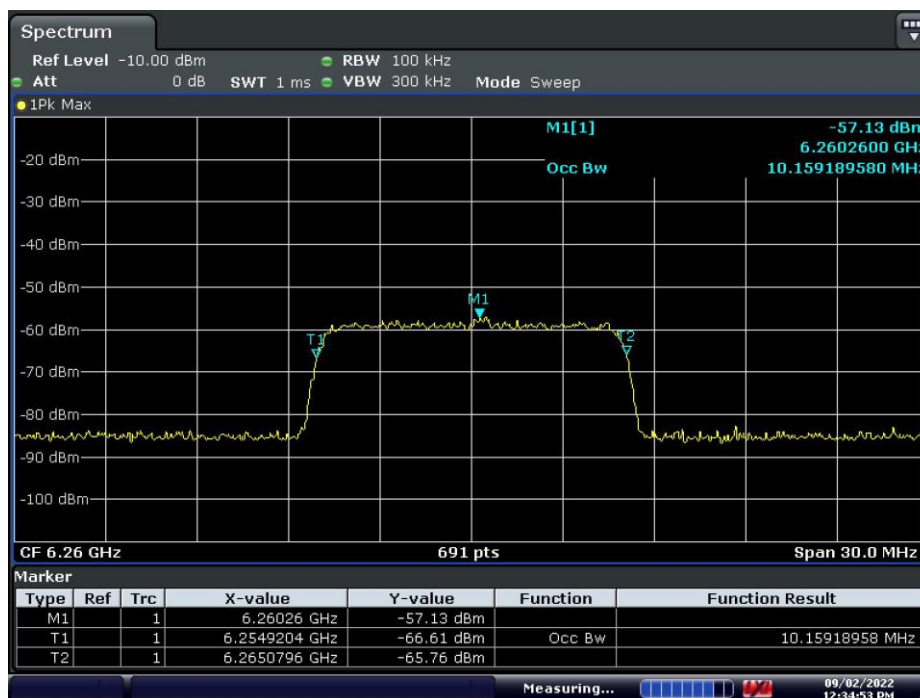

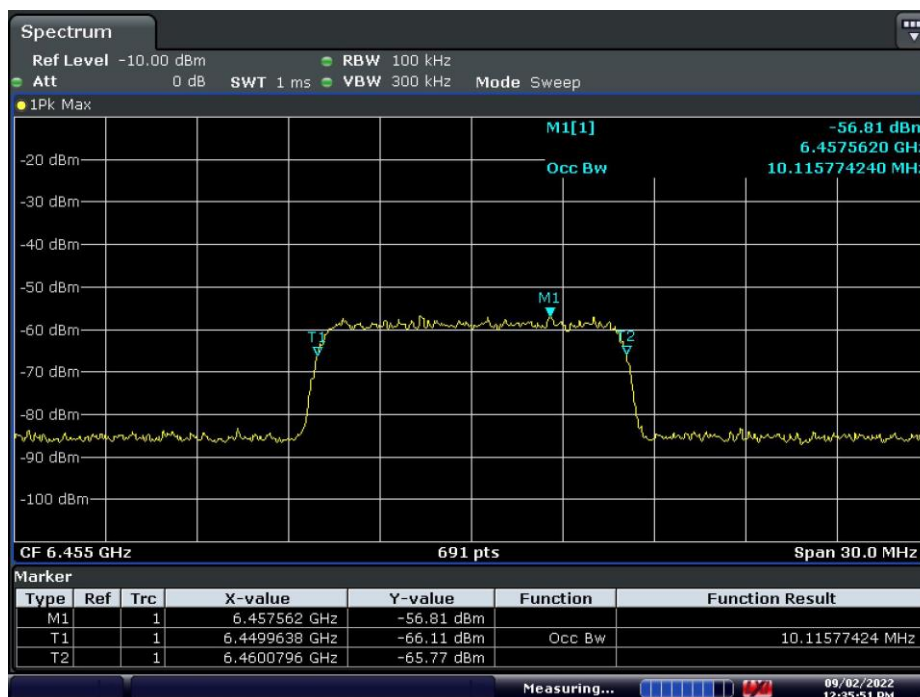
Plot 7-555. AWGN Signal – UNII 5 – 160MHz – Mid



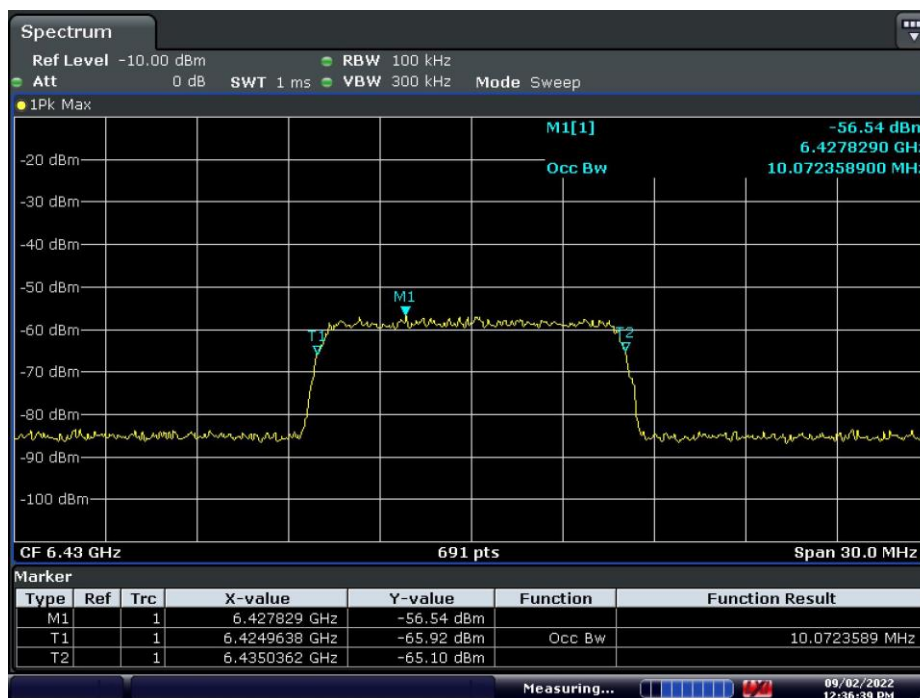
Plot 7-556. AWGN Signal – UNII 5 – 160MHz - High

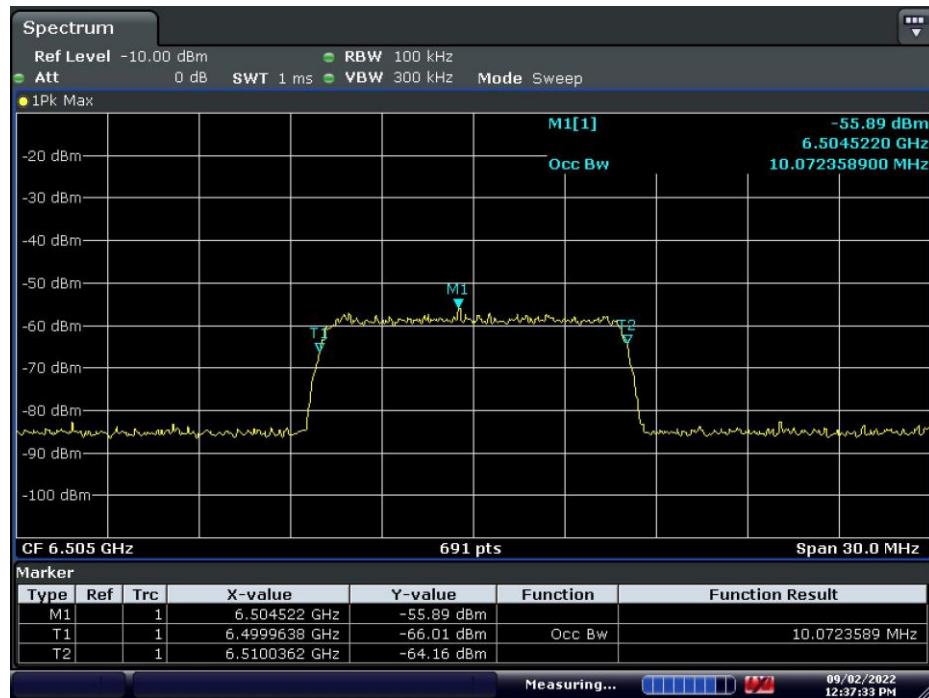
Plot 7-557. AWGN Signal – UNII 6 – 20MHz



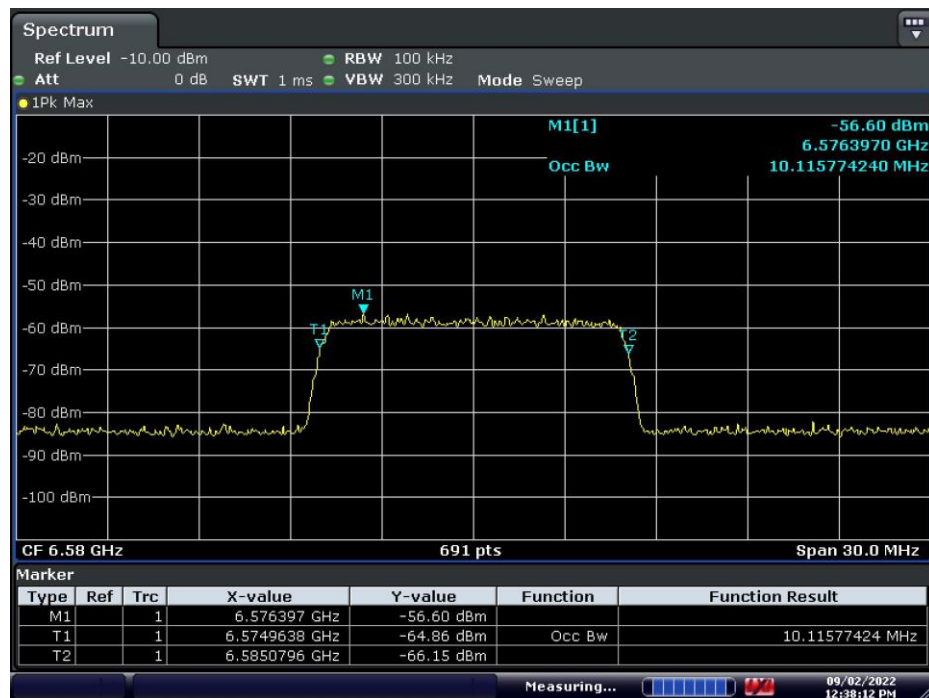
Plot 7-558. AWGN Signal – UNII 6 – 160MHz - Low

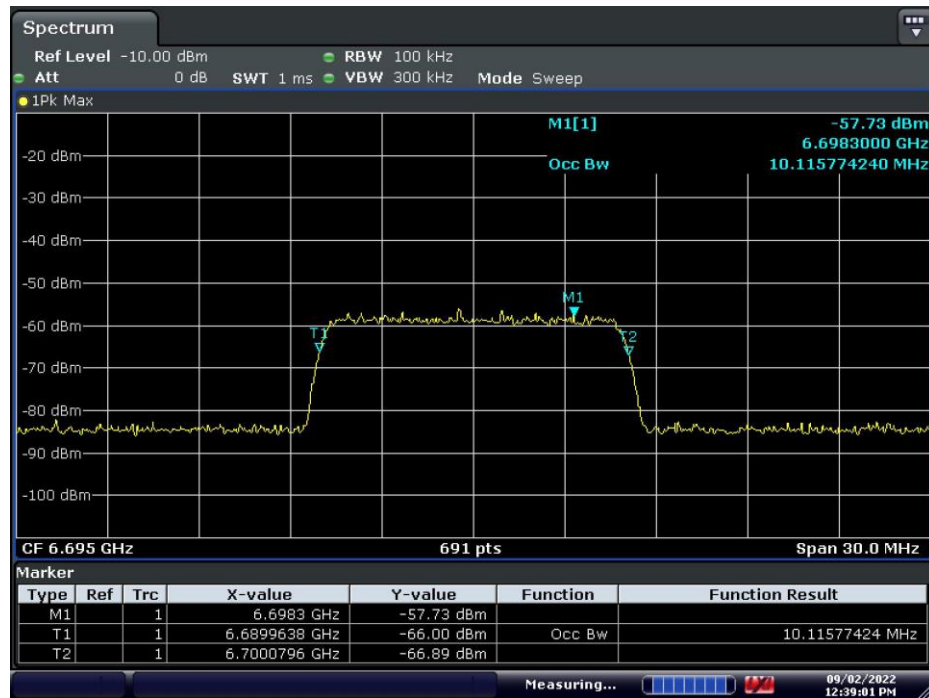
Plot 7-559. AWGN Signal – UNII 6 – 160MHz – Mid



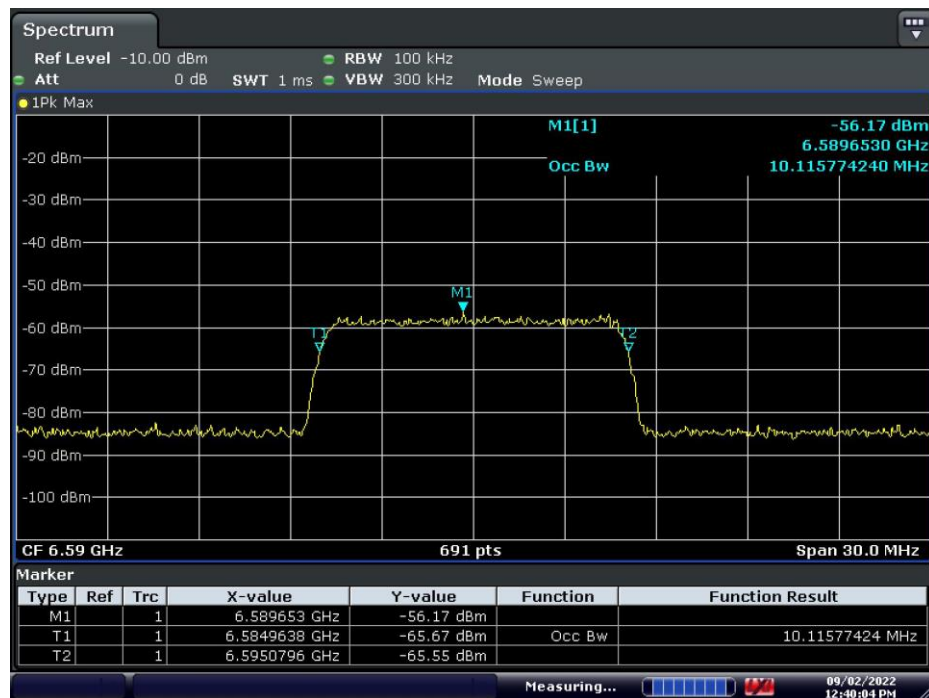
Plot 7-560. AWGN Signal – UNII 6 – 160MHz - High

Plot 7-561. AWGN Signal – UNII 7 – 20MHz

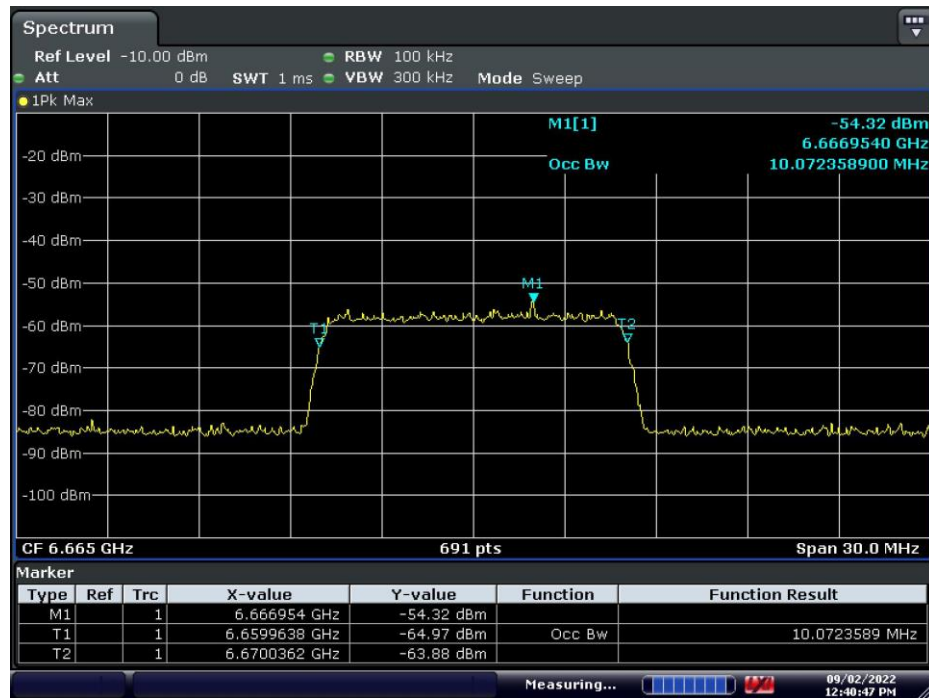


Plot 7-562. AWGN Signal – UNII 7 – 160MHz - Low

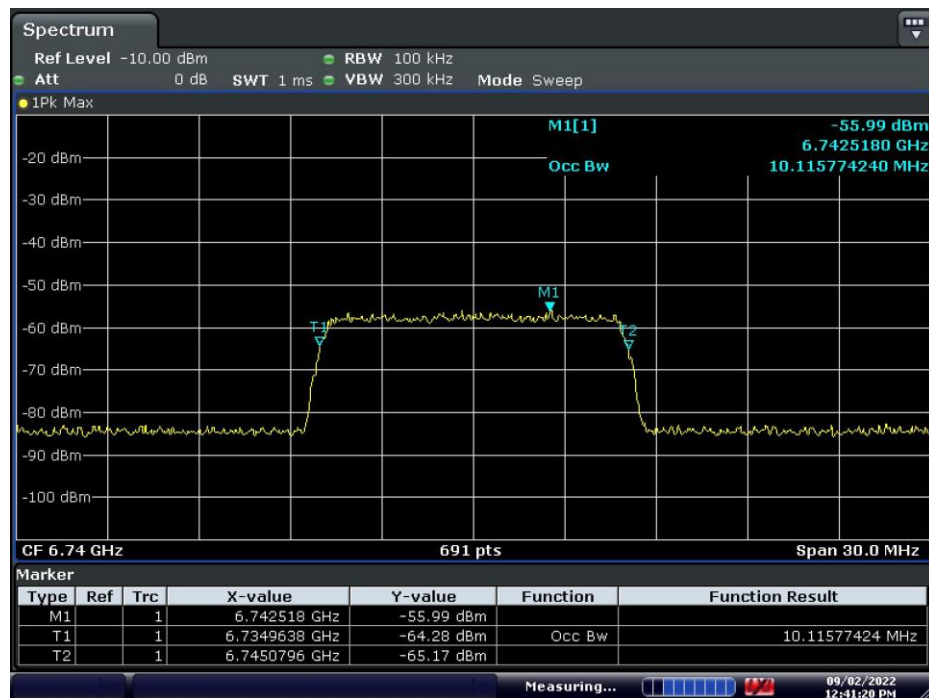

Plot 7-563. AWGN Signal – UNII 7 – 160MHz – Mid

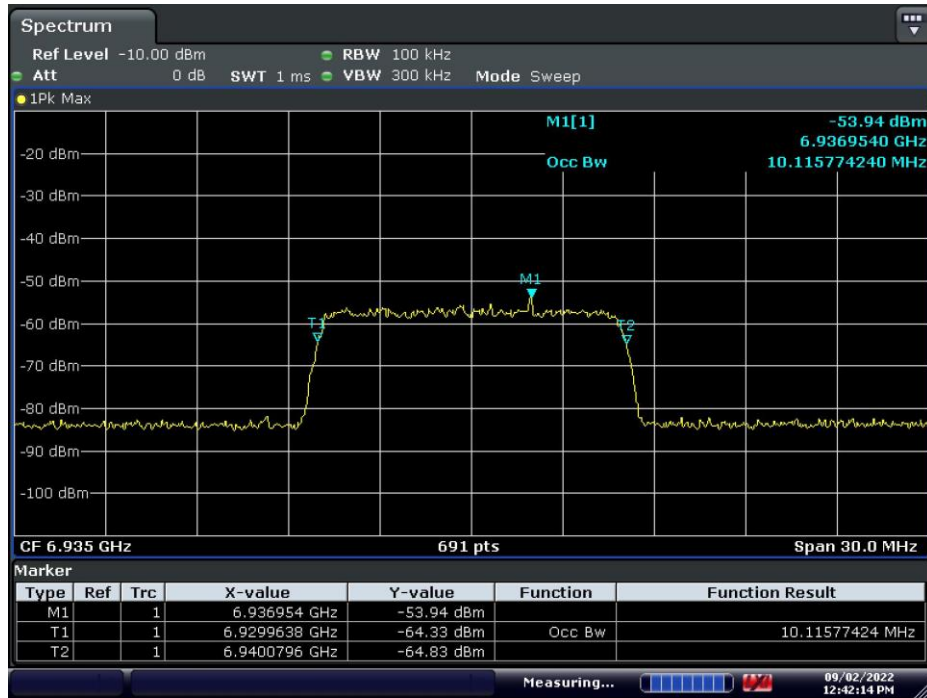


Plot 7-564. AWGN Signal – UNII 7 – 160MHz - High

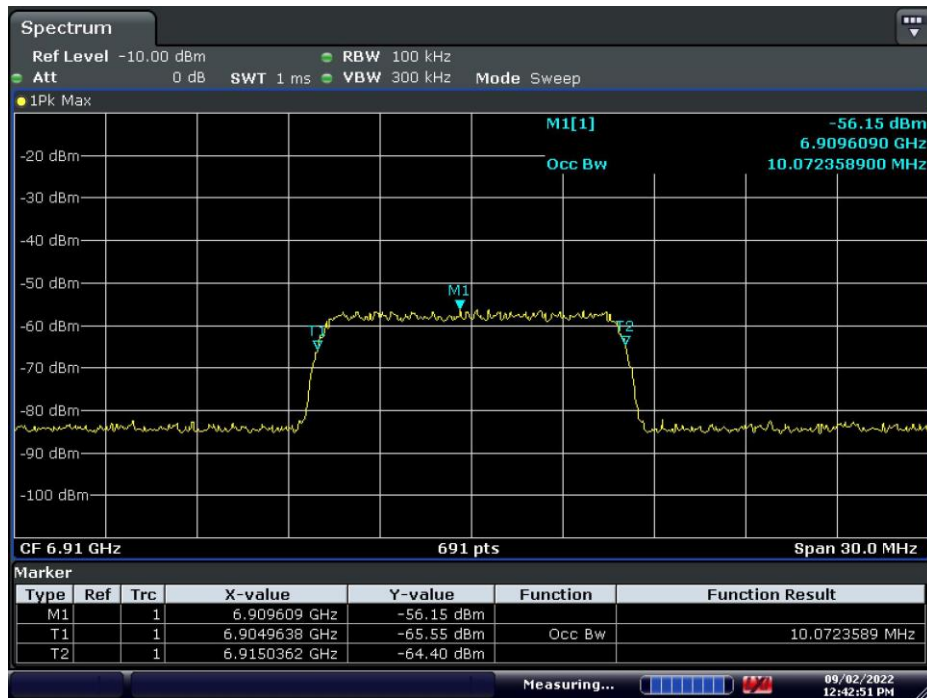

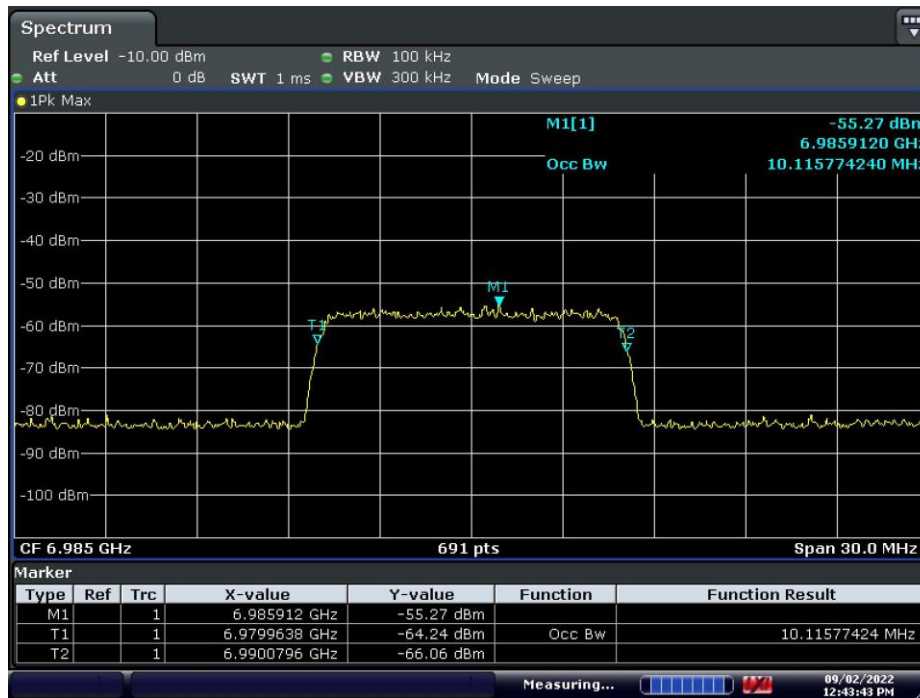
Plot 7-565. AWGN Signal – UNII 8 – 20MHz



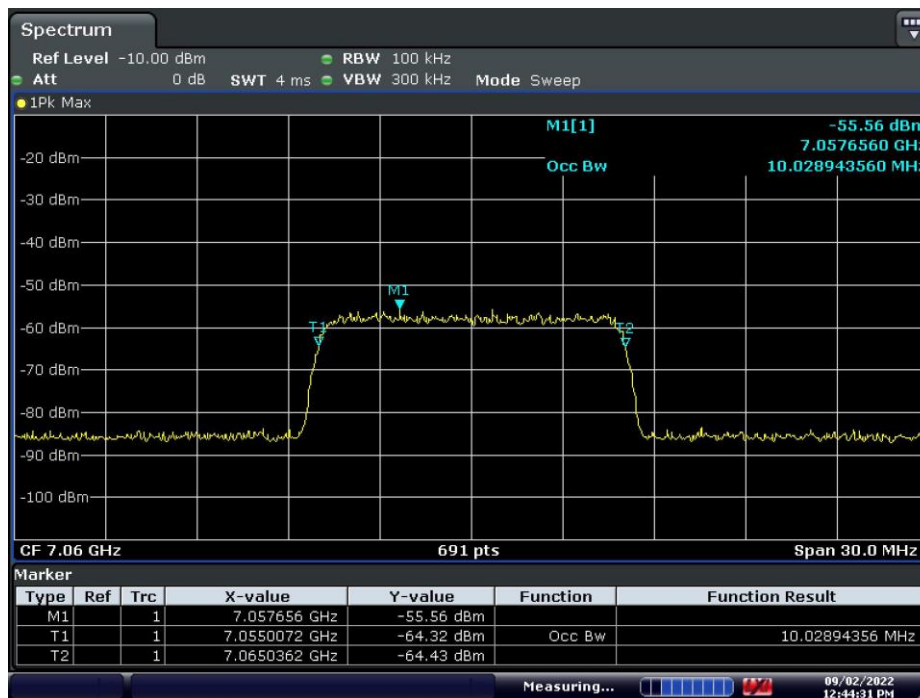
Plot 7-566. AWGN Signal – UNII 8 – 160MHz - Low

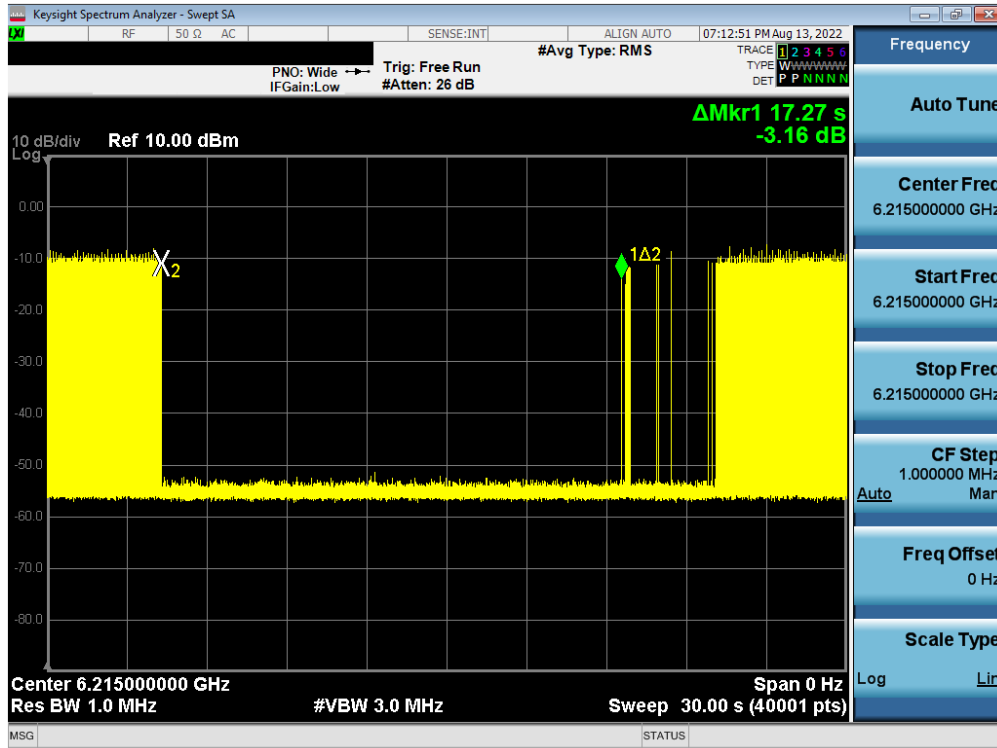
Plot 7-567. AWGN Signal – UNII 8 – 160MHz – Mid



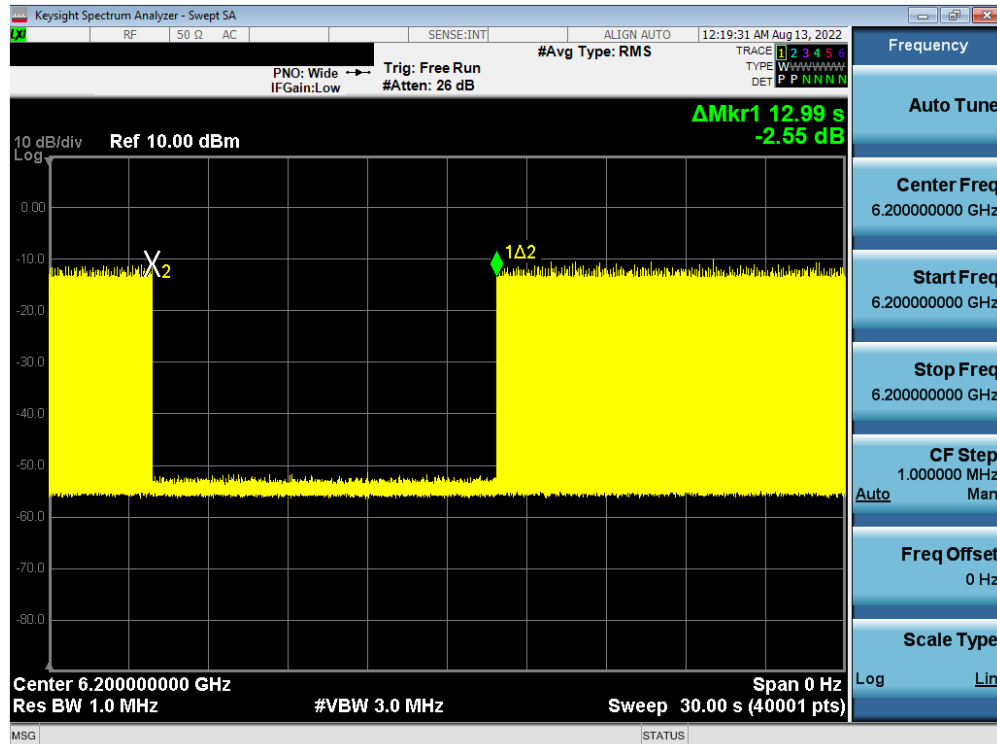
Plot 7-568. AWGN Signal – UNII 8 – 160MHz - High

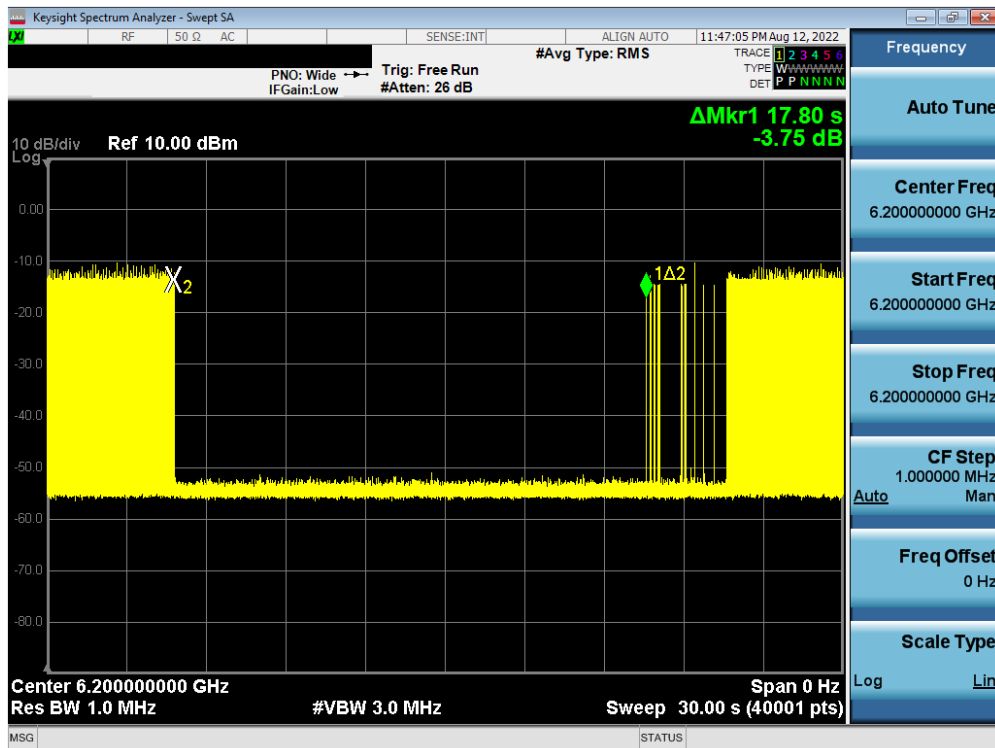
Plot 7-569. Contention Based Protocol Timing Plot – UNII 5 – 20MHz Channel 53



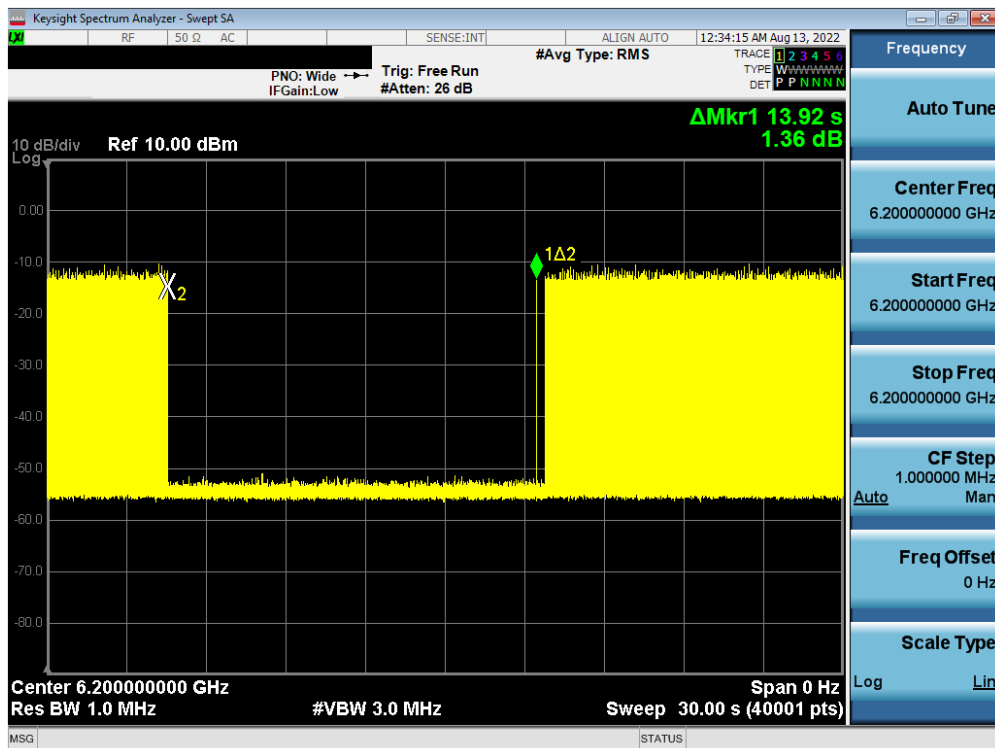
Plot 7-570. Contention Based Protocol Timing Plot – UNII 5 – 160MHz Channel 47 – Low

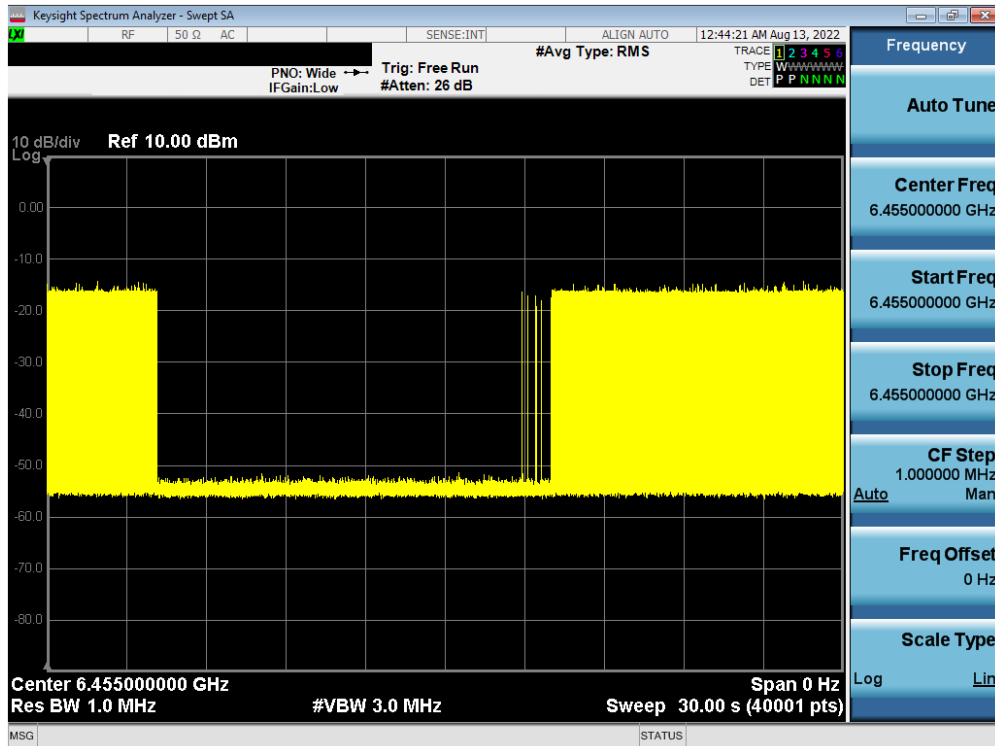
Plot 7-571. Contention Based Protocol Timing Plot – UNII 5 – 160MHz Channel 47 – Mid



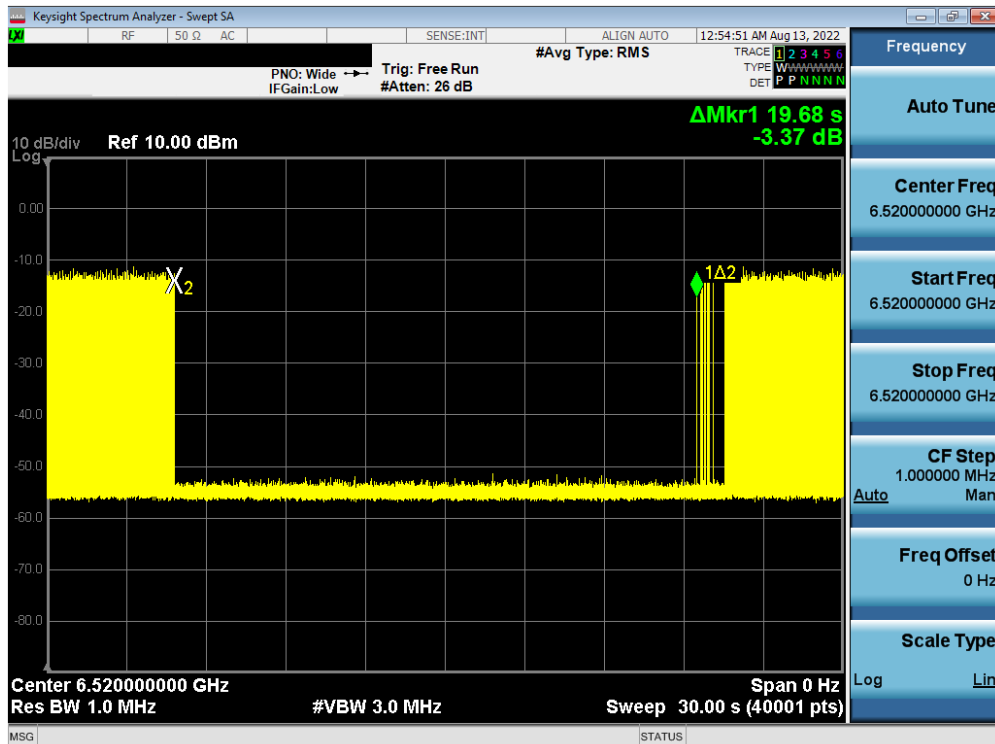
Plot 7-572. Contention Based Protocol Timing Plot – UNII 5 – 160MHz Channel 47 – High

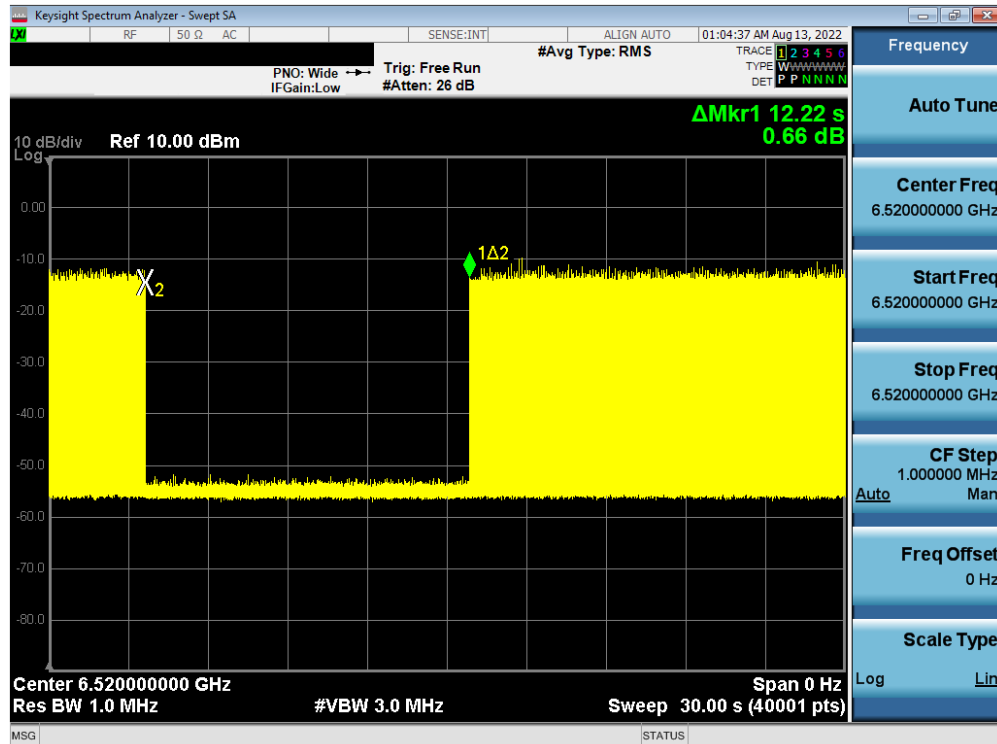
Plot 7-573. Contention Based Protocol Timing Plot – UNII 6 – 20MHz Channel 101



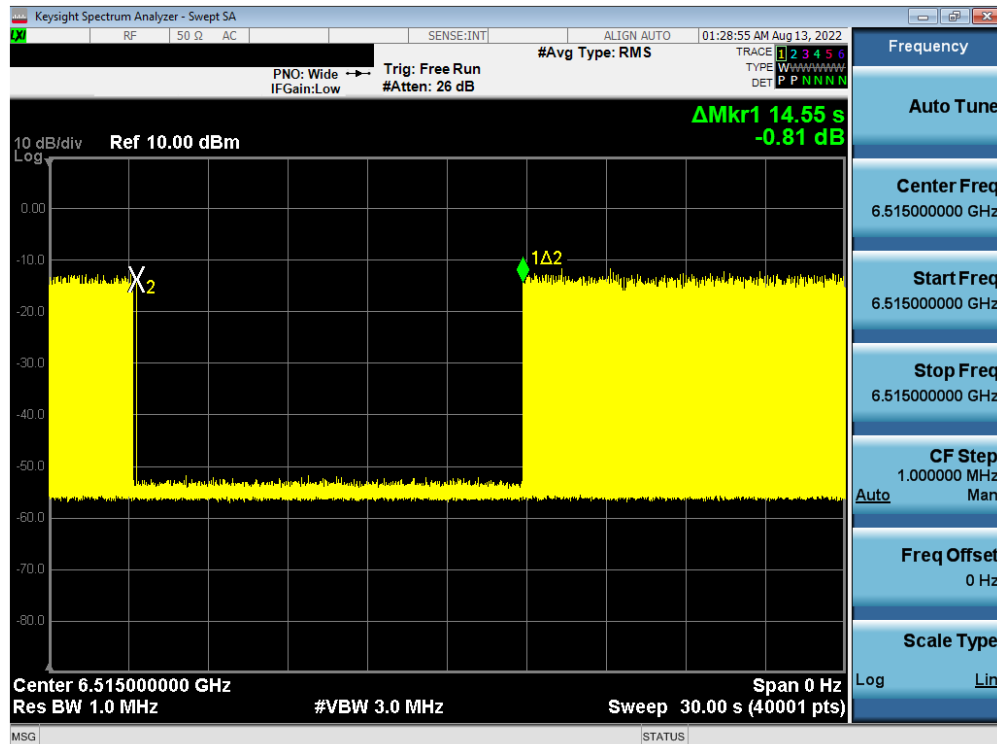
Plot 7-574. Contention Based Protocol Timing Plot – UNII 6 – 160MHz Channel 111 – Low

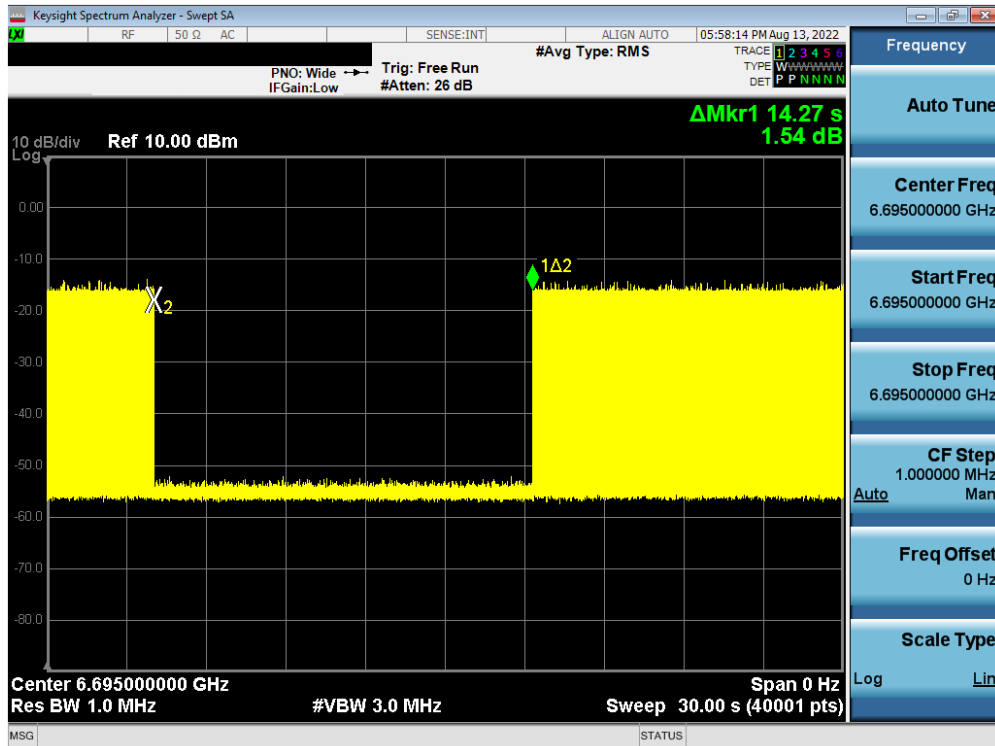


Plot 7-575. Contention Based Protocol Timing Plot – UNII 6 – 160MHz Channel 111 – Mid

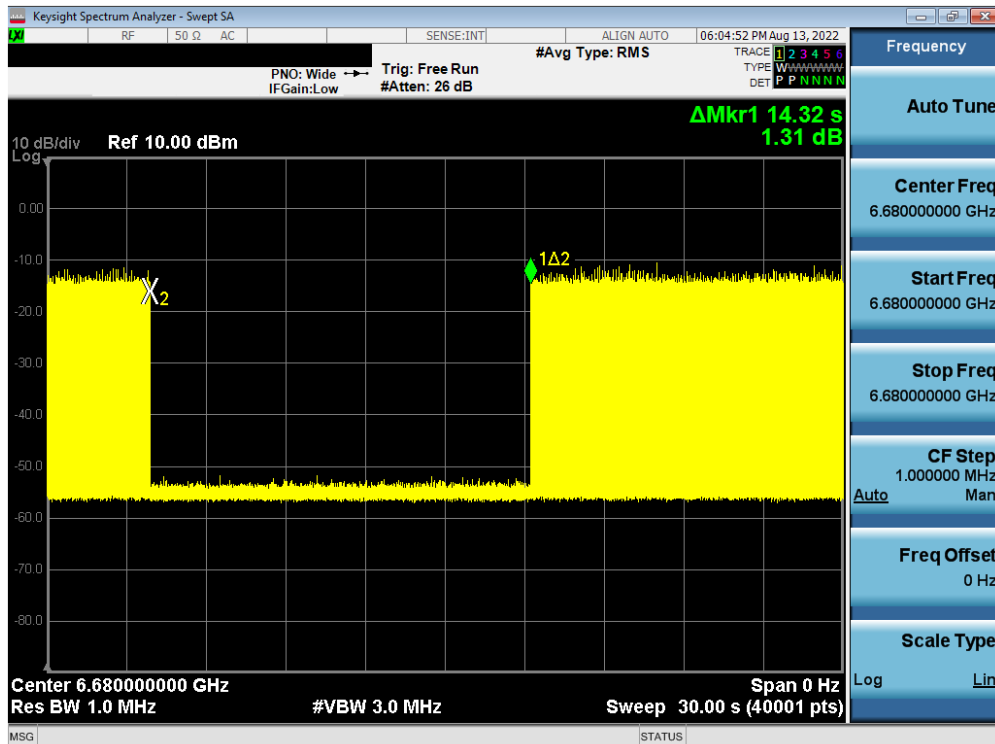


Plot 7-576. Contention Based Protocol Timing Plot – UNII 6 – 160MHz Channel 111 – High

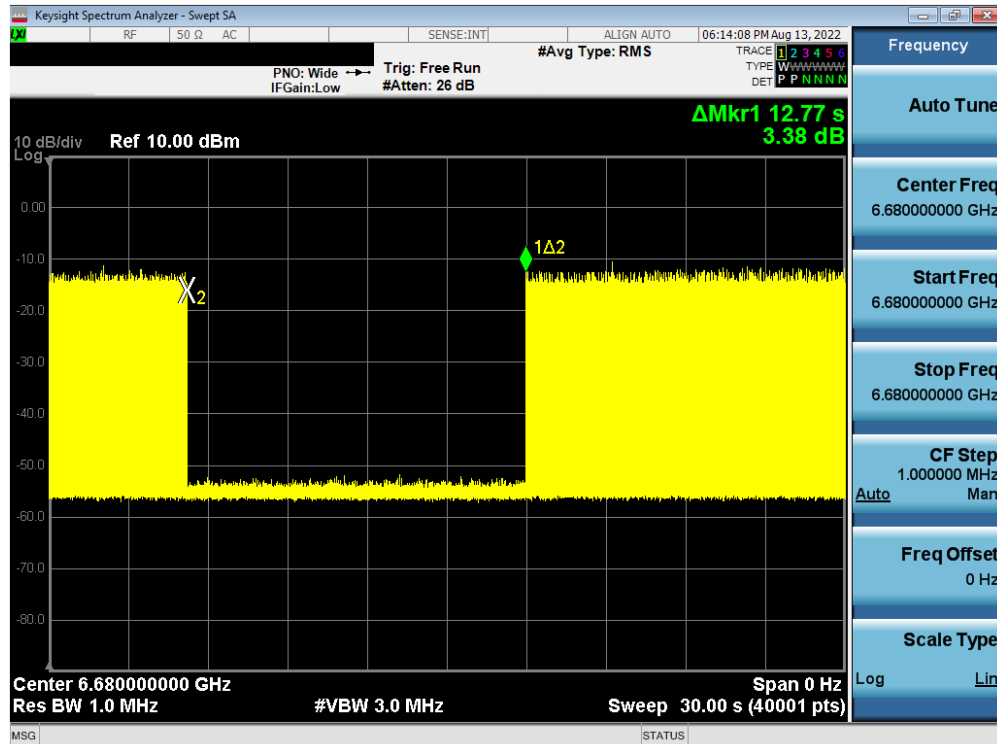


Plot 7-577. Contention Based Protocol Timing Plot – UNII 7 – 20MHz Channel 149

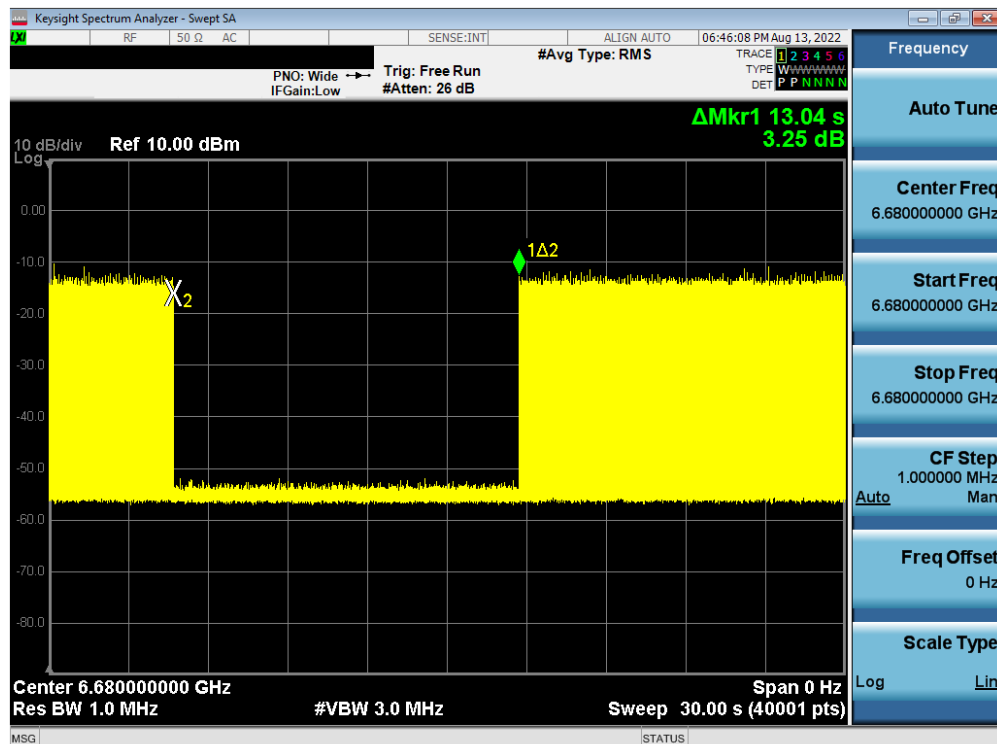


Plot 7-578. Contention Based Protocol Timing Plot – UNII 7 – 160MHz Channel 143 – Low

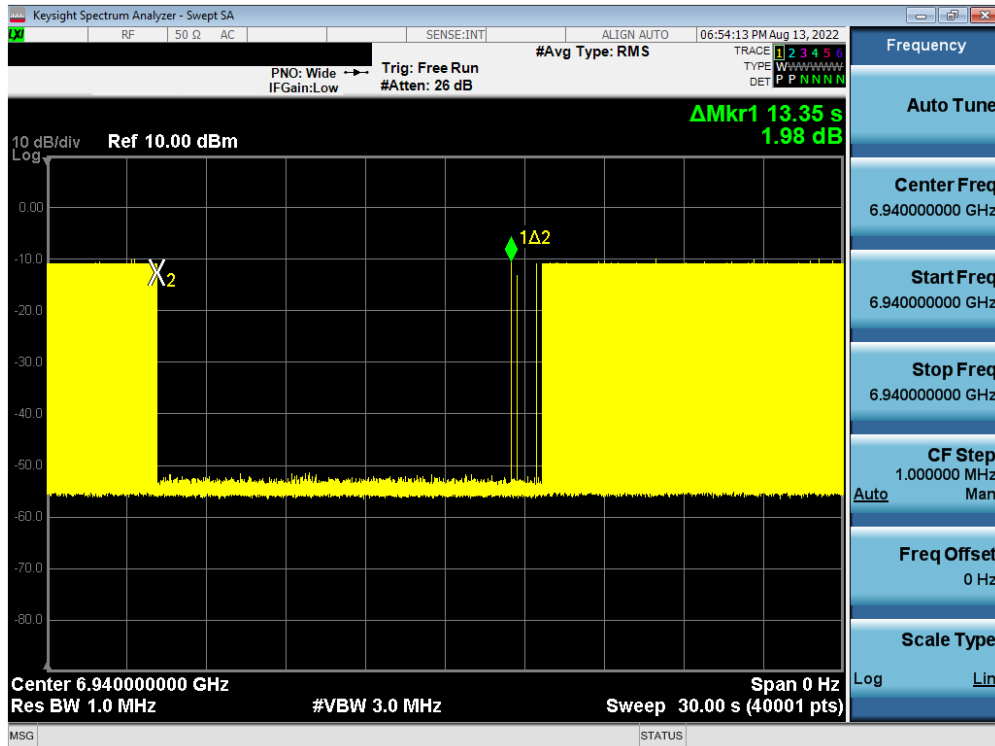


Plot 7-579. Contention Based Protocol Timing Plot – UNII 7 – 160MHz Channel 143 – Mid

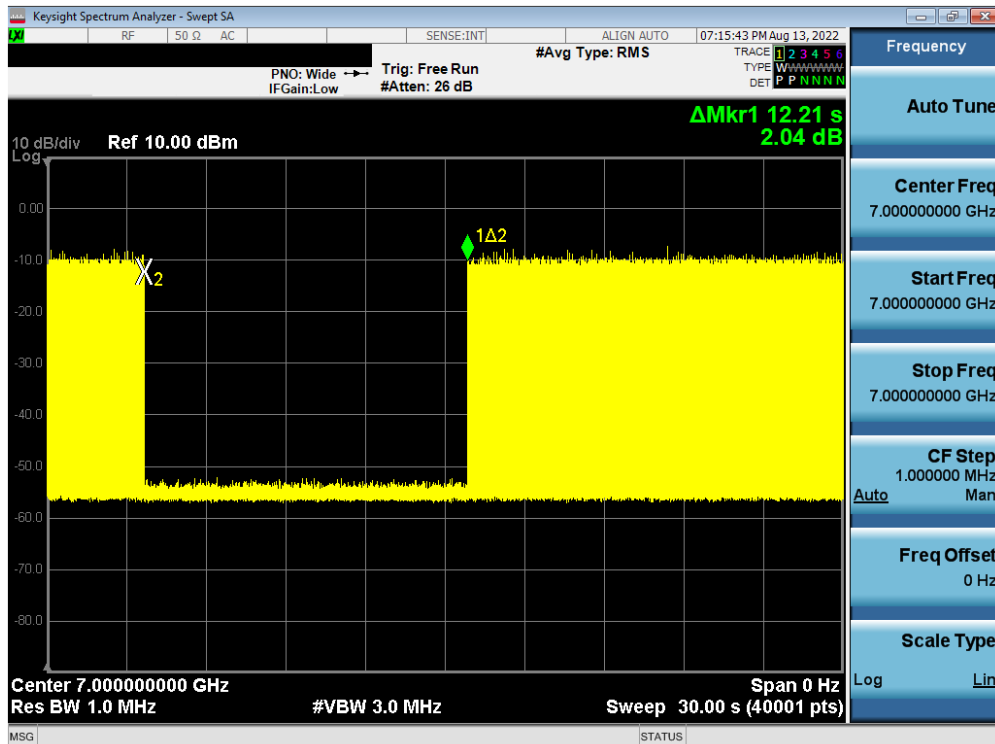


Plot 7-580. Contention Based Protocol Timing Plot – UNII 7 – 160MHz Channel 143 – High

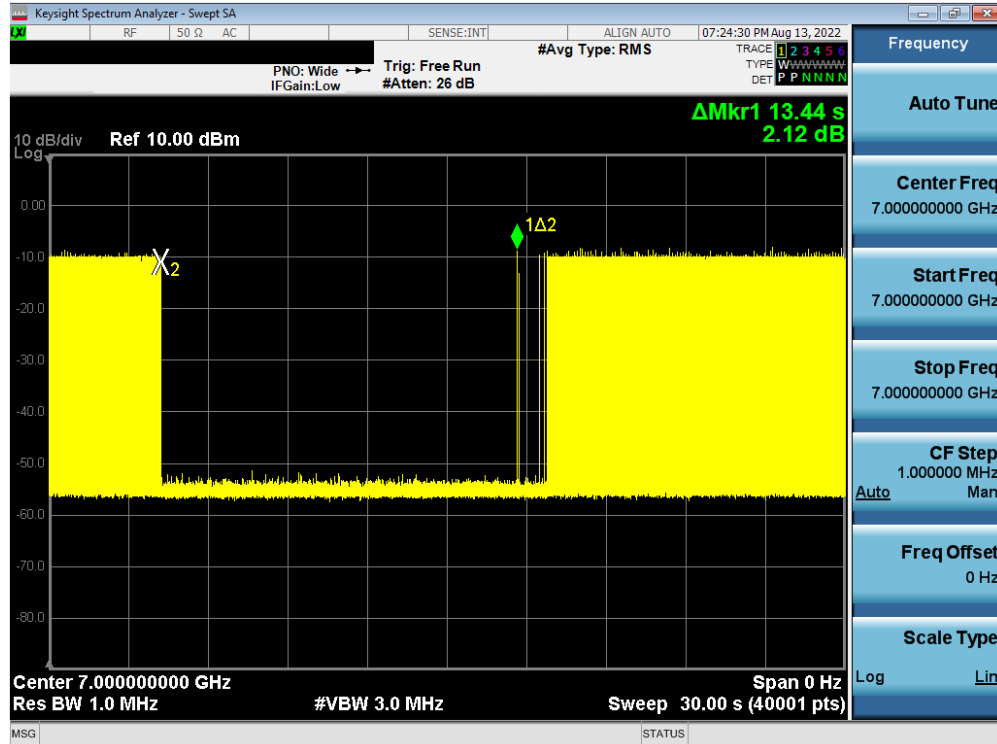


Plot 7-581. Contention Based Protocol Timing Plot – UNII 8 – 20MHz Channel 197

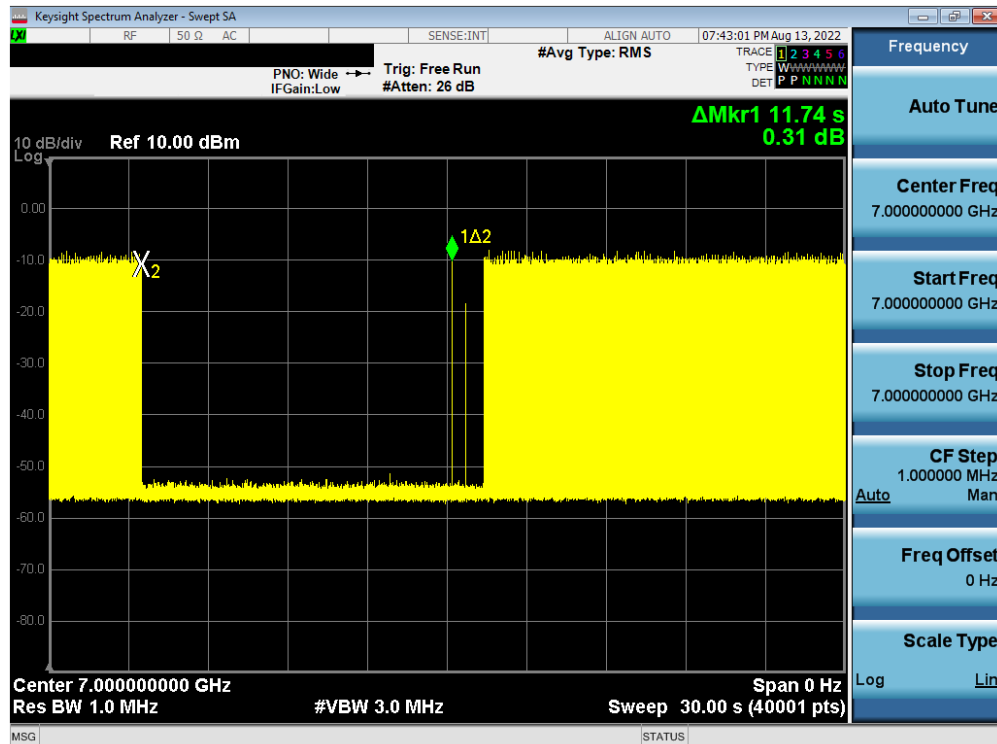


Plot 7-582. Contention Based Protocol Timing Plot – UNII 8 – 160MHz Channel 207 – Low

7.7 Radiated Spurious Emissions – Above 1GHz

Test Overview and Limit

All out of band radiated spurious emissions are measured with a spectrum analyzer connected to a receive antenna while the EUT is operating at its maximum duty cycle, at its maximum power control level, as defined in ANSI C63.10-2013 and KDB 789033 D02 v02r01, and at the appropriate frequencies. All channels, modes (e.g. 802.11a, 802.11n, 802.11ax(SU) (20MHz BW), 802.11n, 802.11ax(SU) (40MHz BW), and 802.11ac, 802.11ax(SU) (80MHz), and modulations/data rates were investigated among all UNII bands. Only the radiated emissions of the configuration that produced the worst case emissions are reported in this section.

For transmitters operating in the 5.925-7.125 GHz band: All emissions outside of the 5.925-7.125 GHz band shall not exceed an EIRP of -27 dBm/MHz. Emissions found in a restricted band are subject to the limits of 15.209 as shown in the table below.

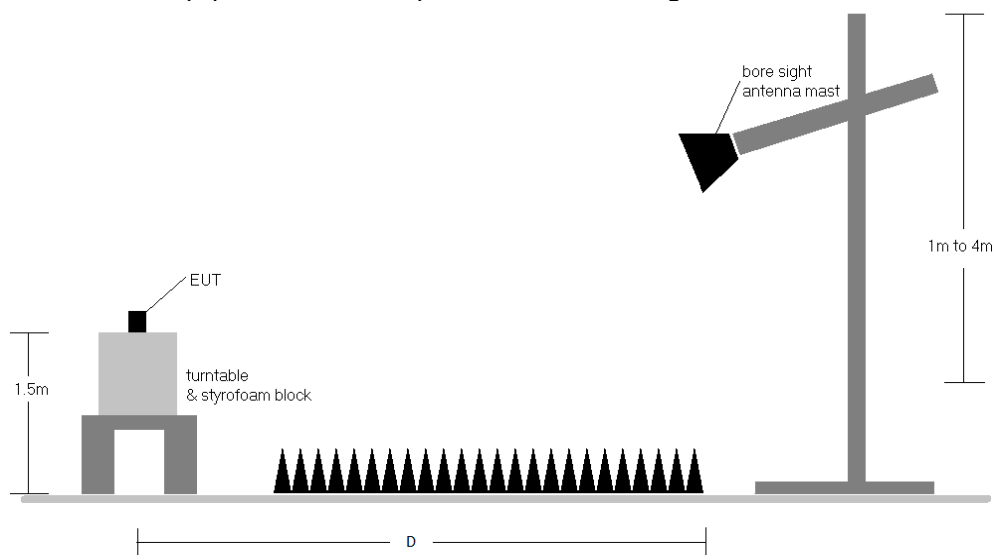


Figure 7-6. Test Instrument & Measurement Setup

2. All spurious emissions lying in restricted bands specified in §15.205 and Section 8.10 of RSS-Gen are below the limit shown in Table 7-56. All spurious emissions that do not lie in a restricted band are subject to a peak limit of -27dBm/MHz. At a distance of 3 meters, the field strength limit in dB μ V/m can be determined by adding a "conversion" factor of 95.2dB to the EIRP limit of -27dBm/MHz to obtain the limit for out of band spurious emissions of 68.2dB μ V/m.
3. The antenna is manipulated through typical positions, polarity and length during the tests. The EUT is manipulated through three orthogonal planes.
4. This unit was tested with its standard battery.
5. The spectrum is measured from 9kHz to the 10th harmonic of the fundamental frequency of the transmitter using CISPR quasi peak detector below 1GHz. Above 1 GHz, average and peak measurements were taken using linearly polarized horn antennas.

10. The "-" shown in the following RSE tables are used to denote a noise floor measurement.

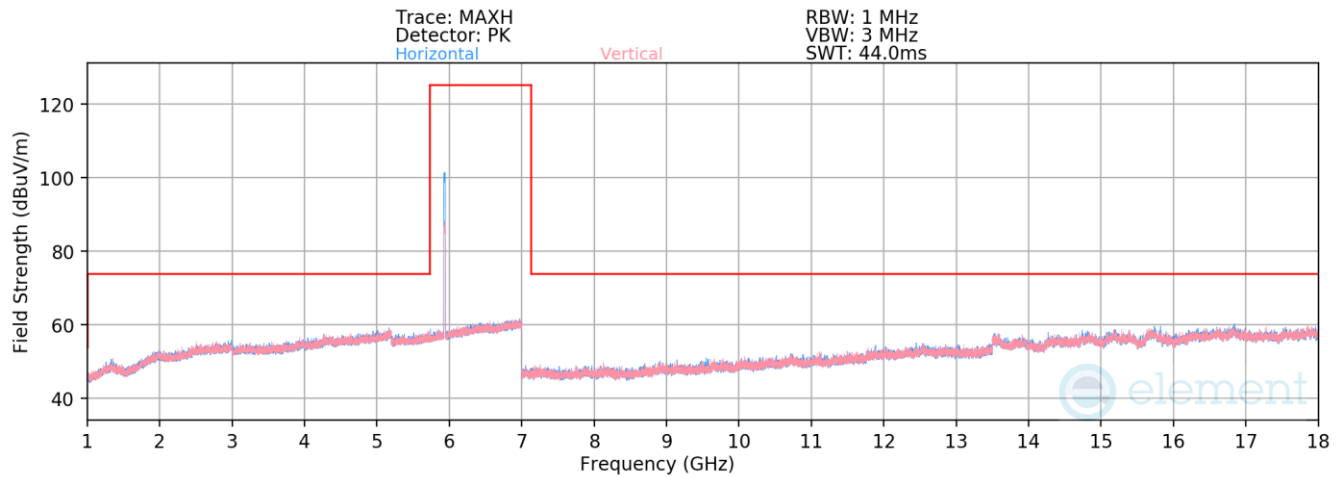

Plot 7-585. Radiated Spurious Emissions above 1GHz Antenna WF5t (802.11ax – Ch. 1, MCS2)

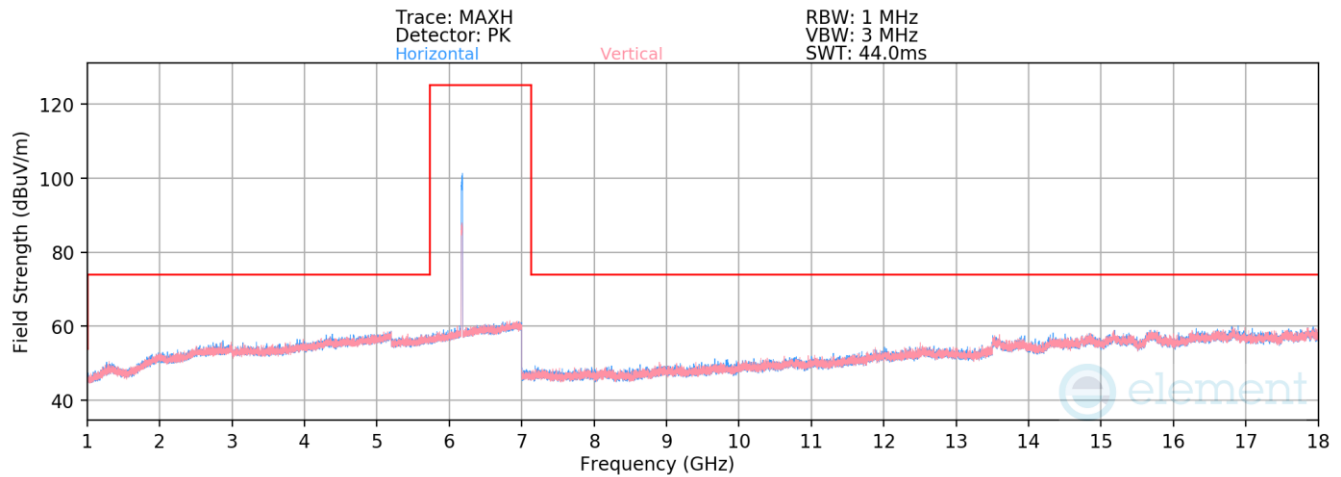

Plot 7-586. Radiated Spurious Emissions above 1GHz Antenna WF5t (802.11ax – Ch. 45, MCS2)

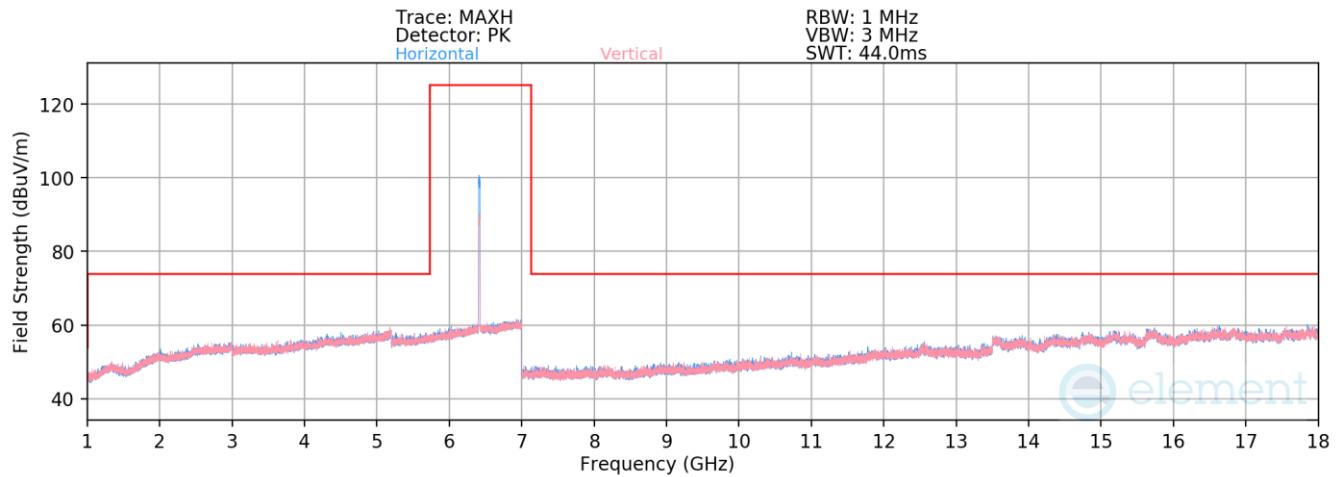

Plot 7-587. Radiated Spurious Emissions above 1GHz Antenna WF5t (802.11ax – Ch. 93, MCS2)

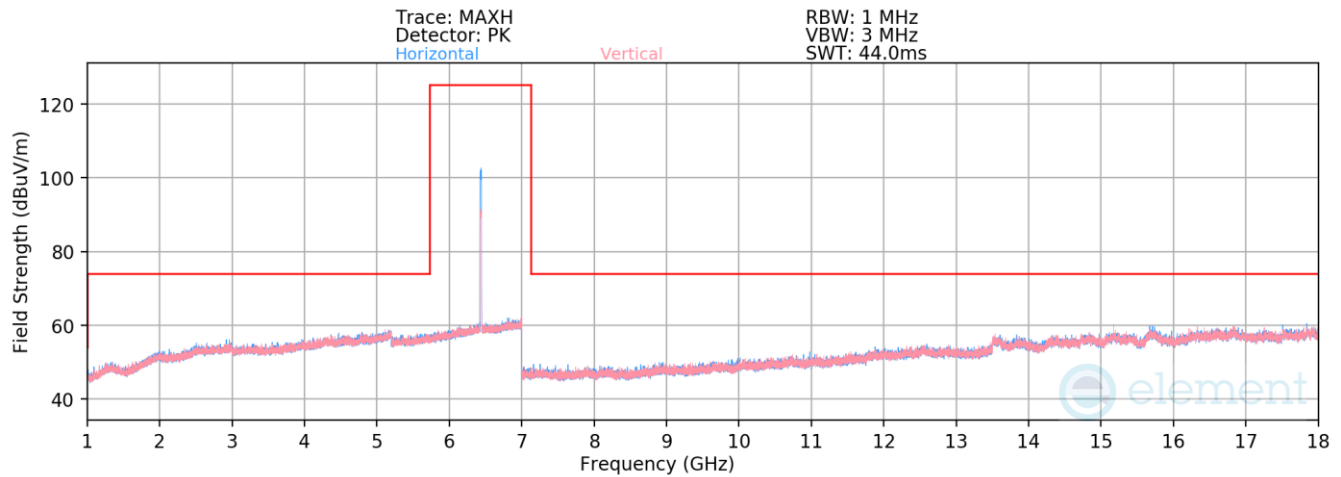

Plot 7-588. Radiated Spurious Emissions above 1GHz Antenna WF5t (802.11ax – Ch. 97, MCS2)

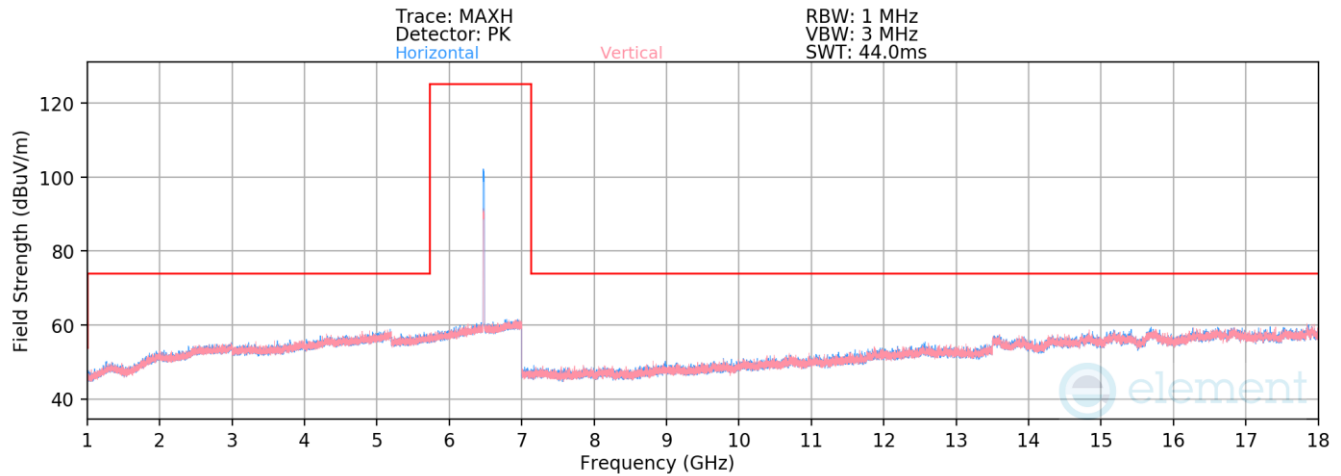

Plot 7-589. Radiated Spurious Emissions above 1GHz Antenna WF5t (802.11ax – Ch. 105, MCS2)

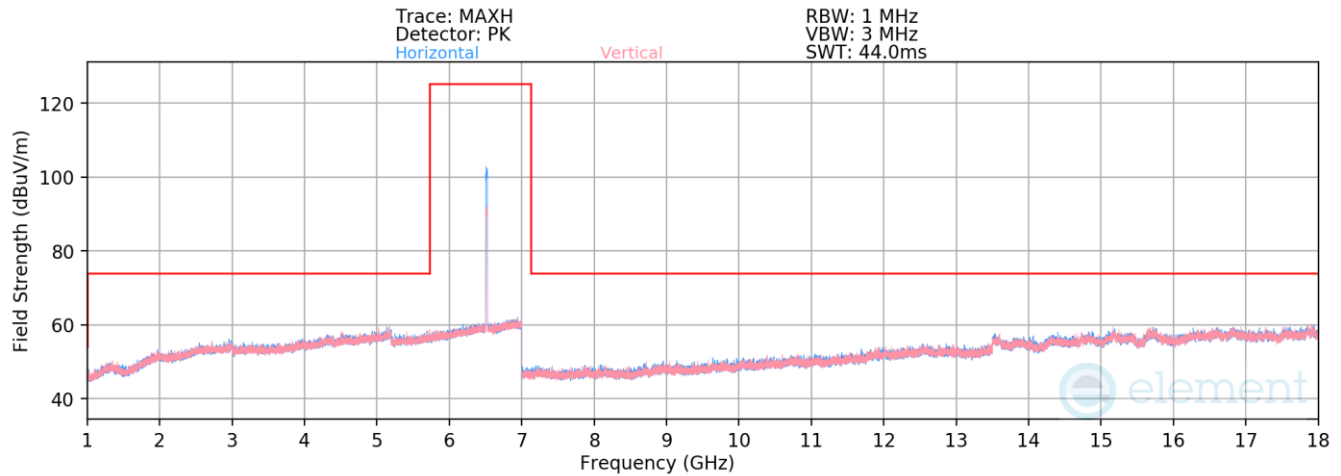

Plot 7-590. Radiated Spurious Emissions above 1GHz Antenna WF5t (802.11ax – Ch. 113, MCS2)

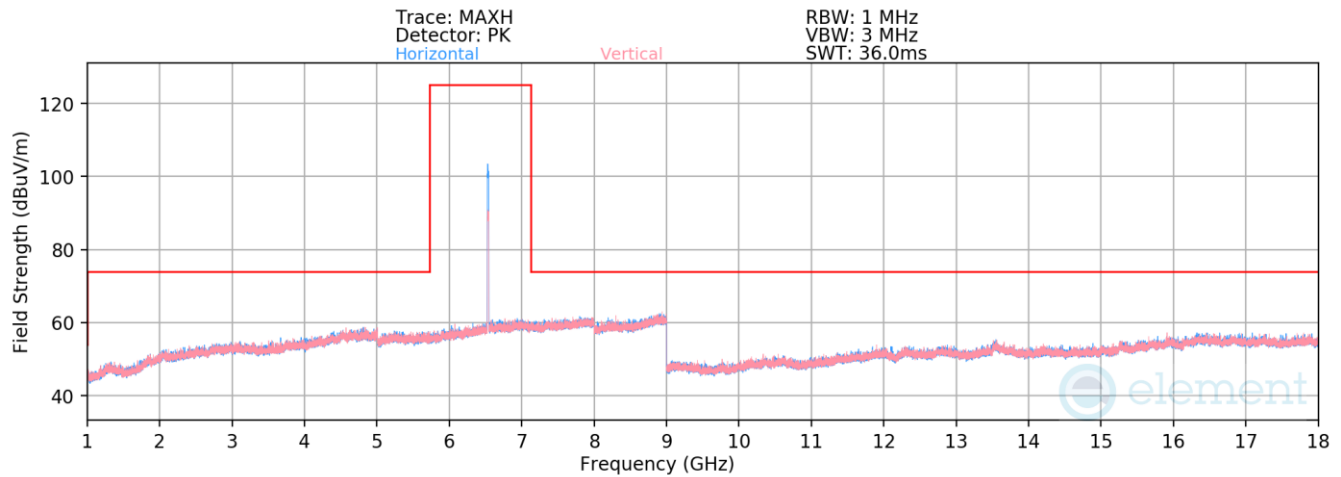

Plot 7-591. Radiated Spurious Emissions above 1GHz Antenna WF5t (802.11ax – Ch. 117, MCS2)

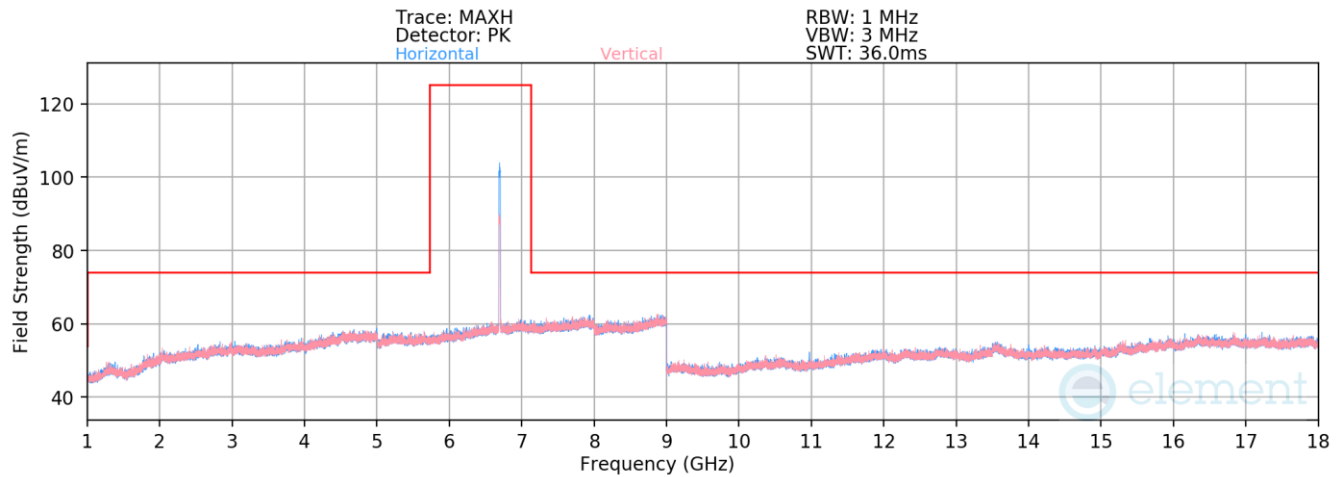

Plot 7-592. Radiated Spurious Emissions above 1GHz Antenna WF5t (802.11ax – Ch. 149, MCS2)

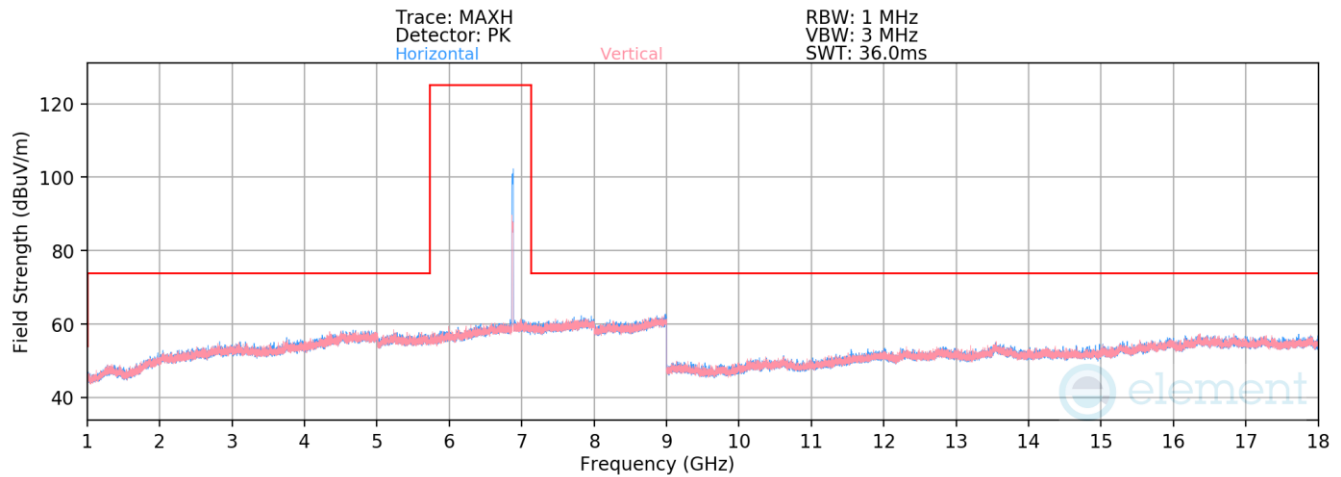

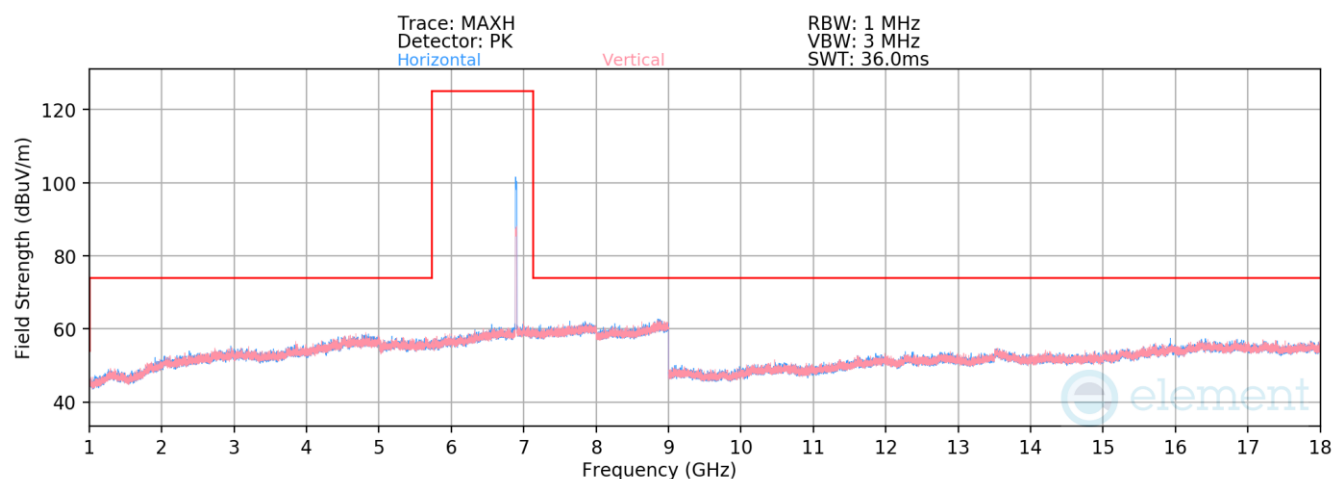

Plot 7-594. Radiated Spurious Emissions above 1GHz Antenna WF5t (802.11ax – Ch. 189, MCS2)

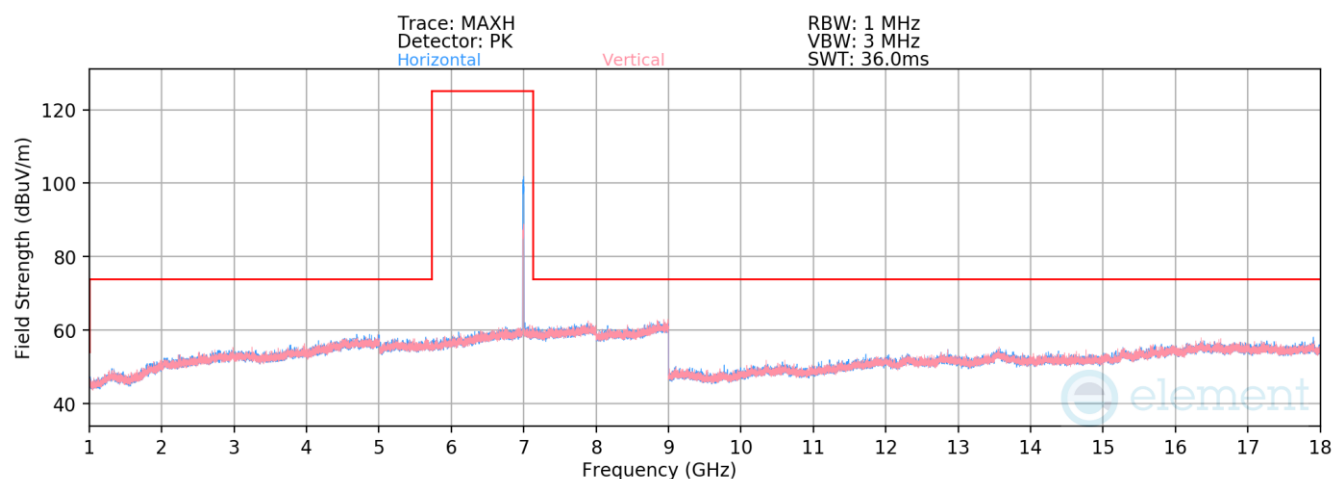

Plot 7-595. Radiated Spurious Emissions above 1GHz Antenna WF5t (802.11ax – Ch. 209, MCS2)

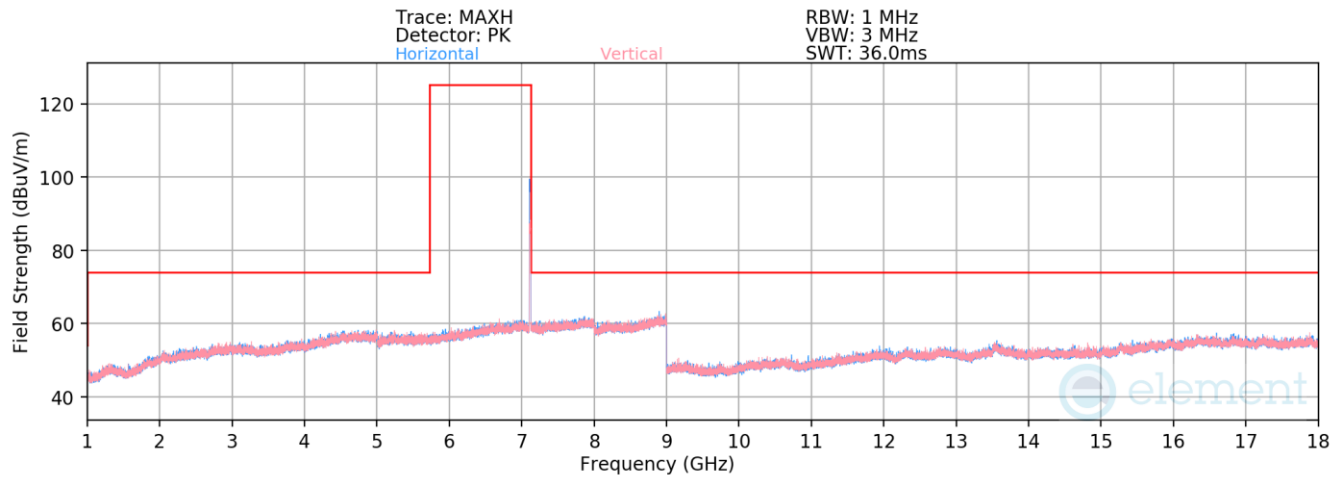

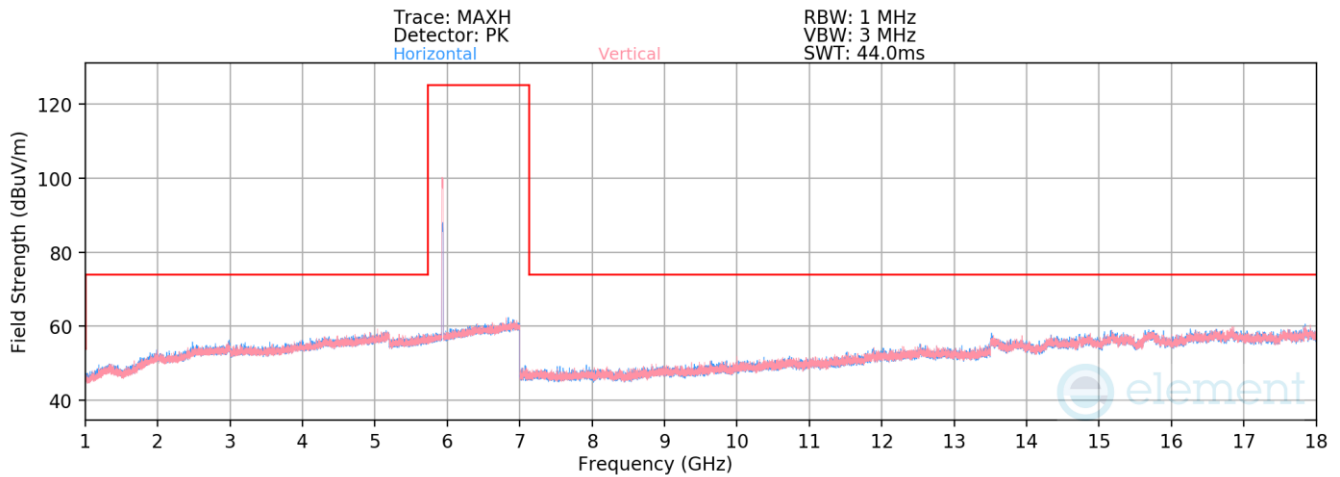

Plot 7-597. Radiated Spurious Emissions above 1GHz Antenna WF5b (802.11ax – Ch. 1, MCS2)

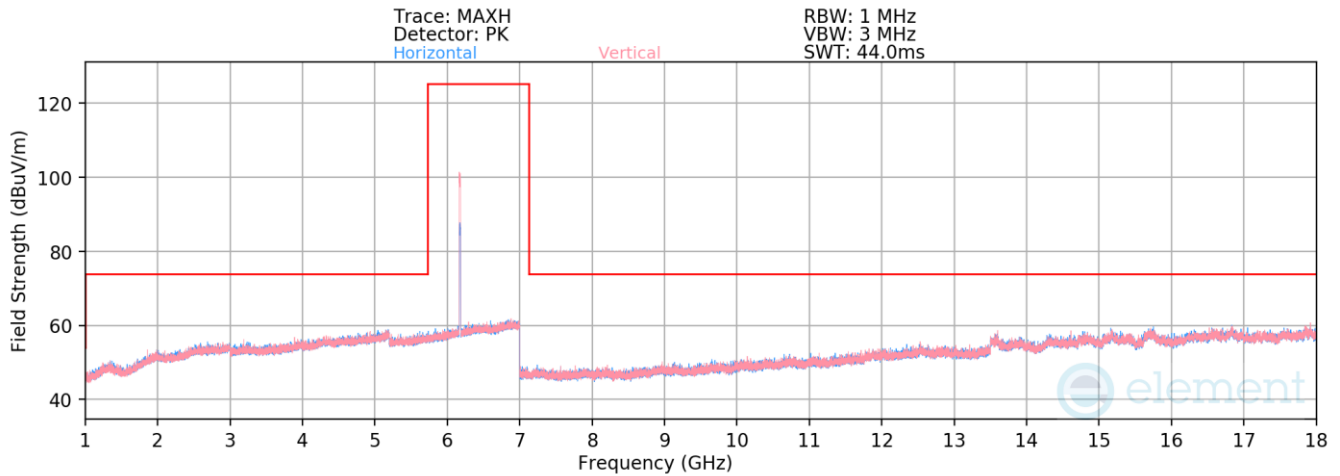

Plot 7-598. Radiated Spurious Emissions above 1GHz Antenna WF5b (802.11ax – Ch. 47, MCS2)

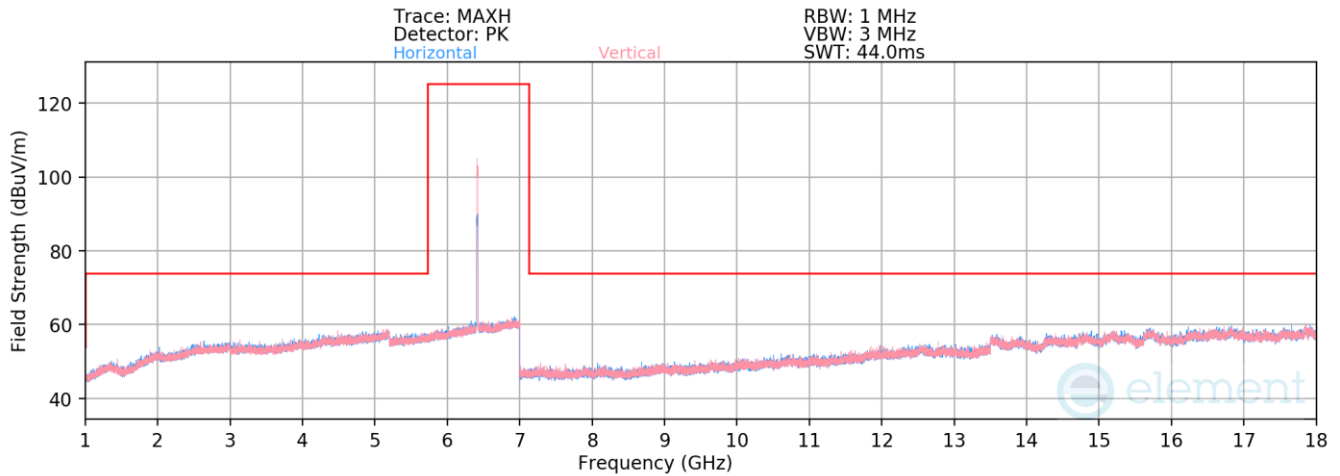

Plot 7-599. Radiated Spurious Emissions above 1GHz Antenna WF5b (802.11ax – Ch. 93, MCS2)

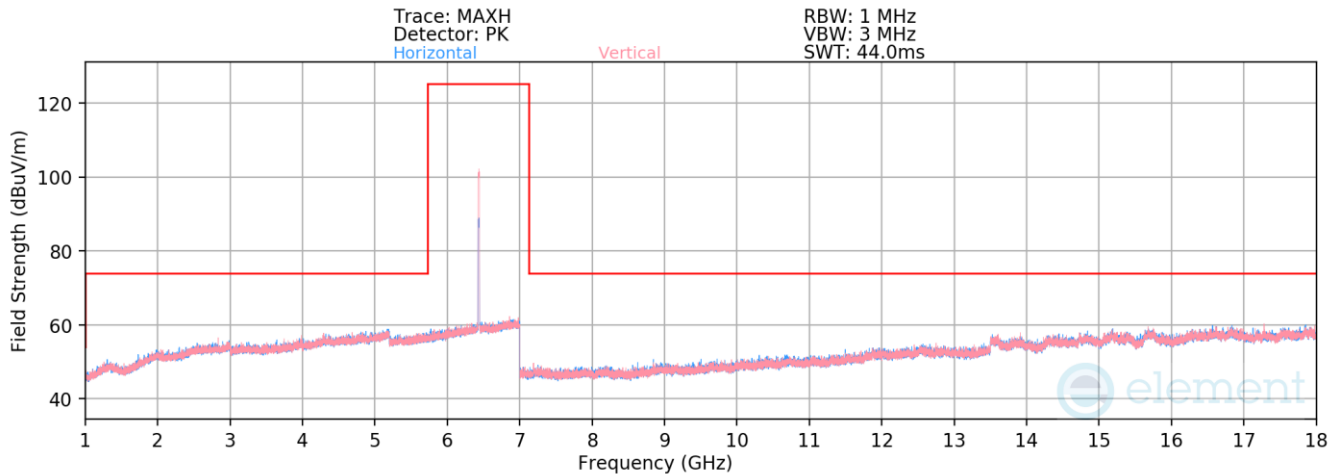

Plot 7-600. Radiated Spurious Emissions above 1GHz Antenna WF5b (802.11ax – Ch. 97, MCS2)

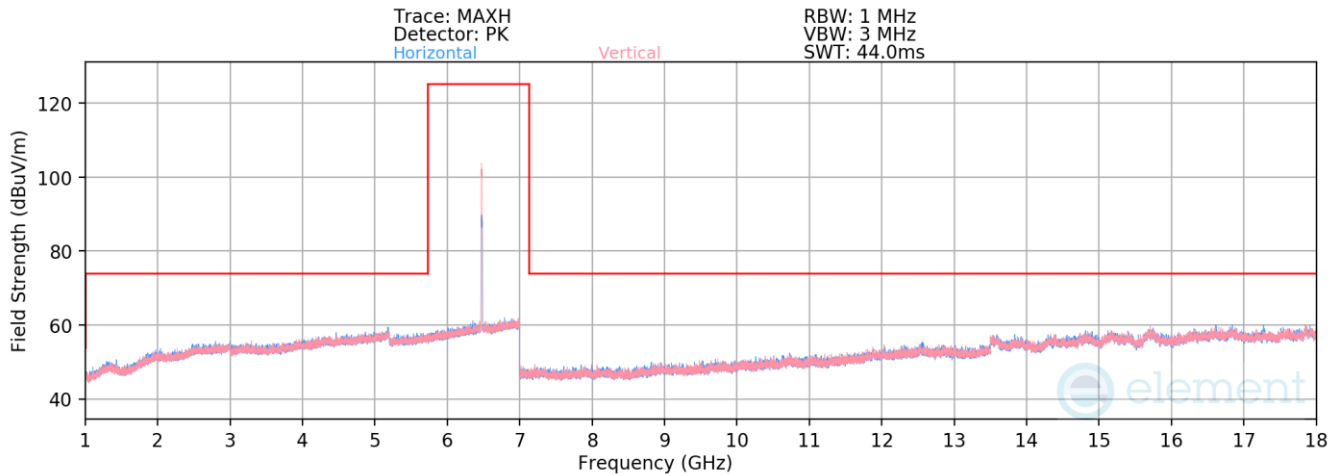

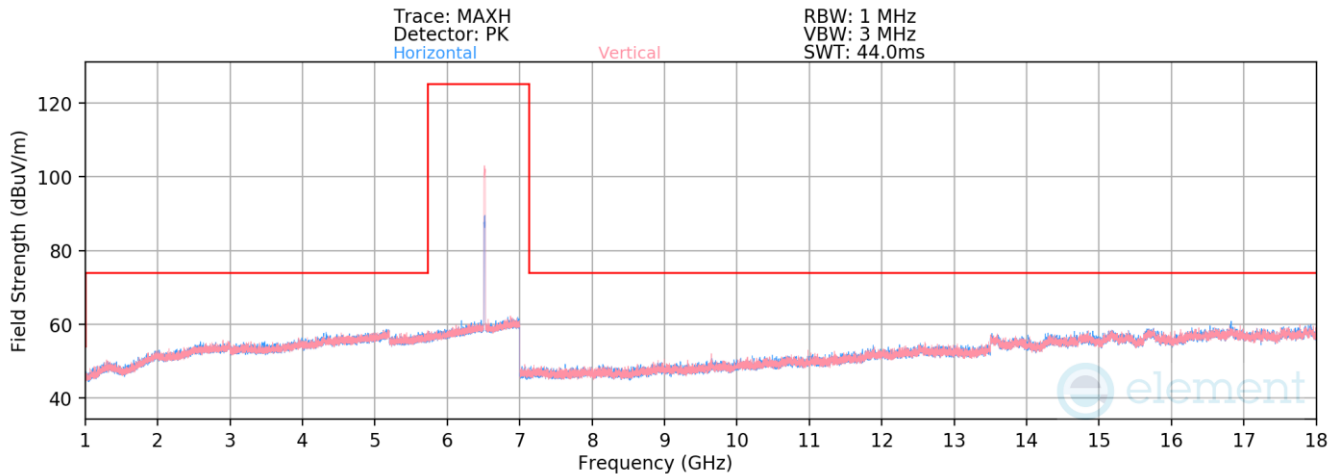

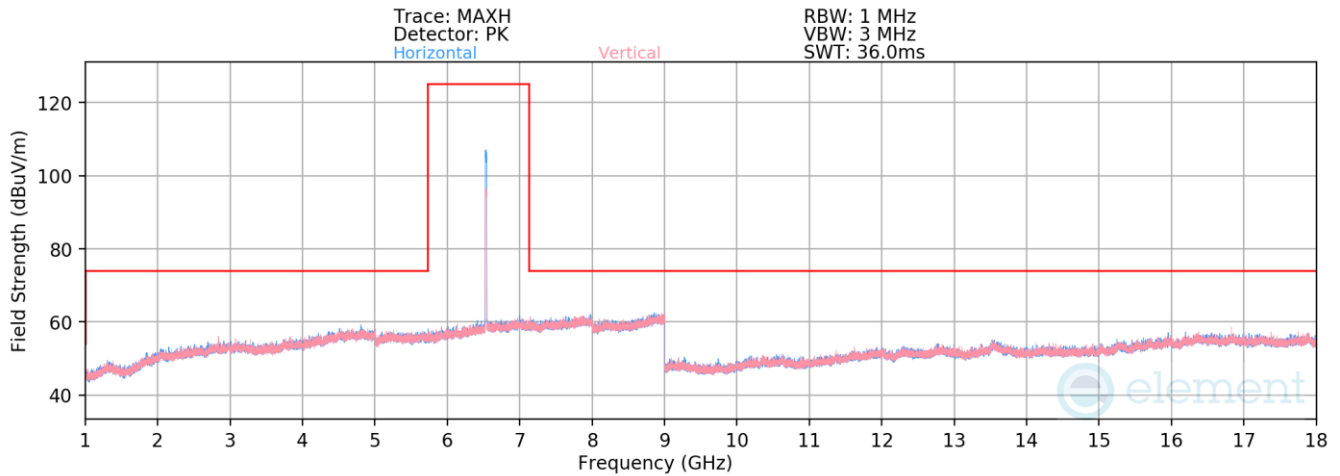

Plot 7-603. Radiated Spurious Emissions above 1GHz Antenna WF5b (802.11ax – Ch. 117, MCS2)

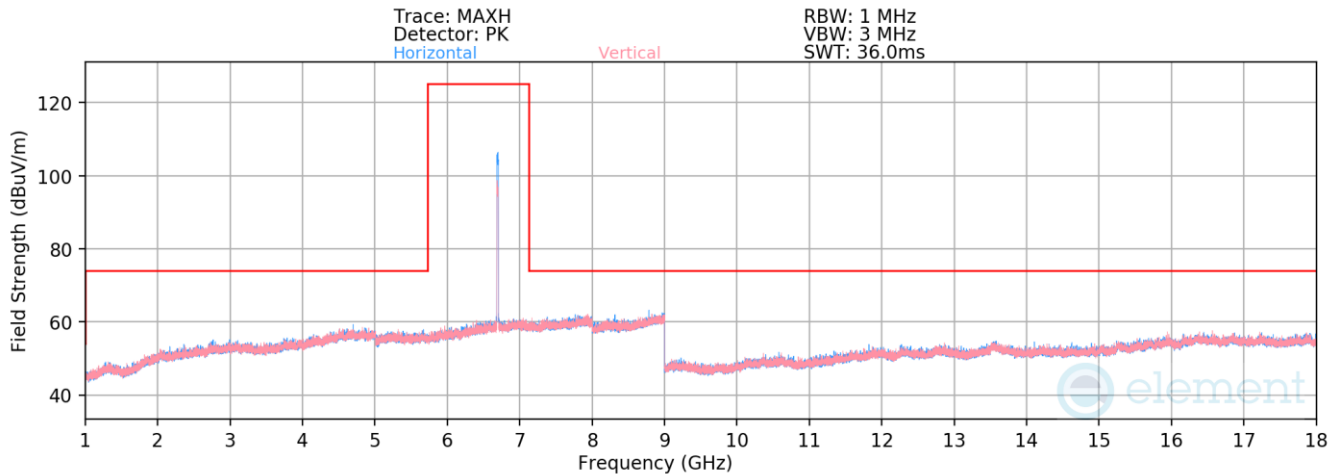

Plot 7-604. Radiated Spurious Emissions above 1GHz Antenna WF5b (802.11ax – Ch. 149, MCS2)

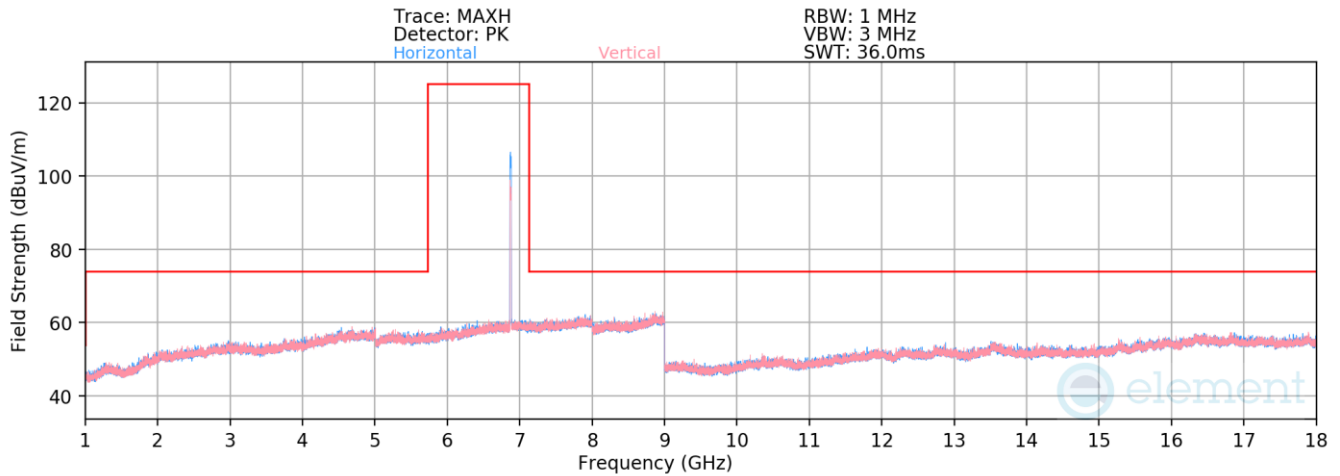

Plot 7-605. Radiated Spurious Emissions above 1GHz Antenna WF5b (802.11ax – Ch. 185, MCS2)

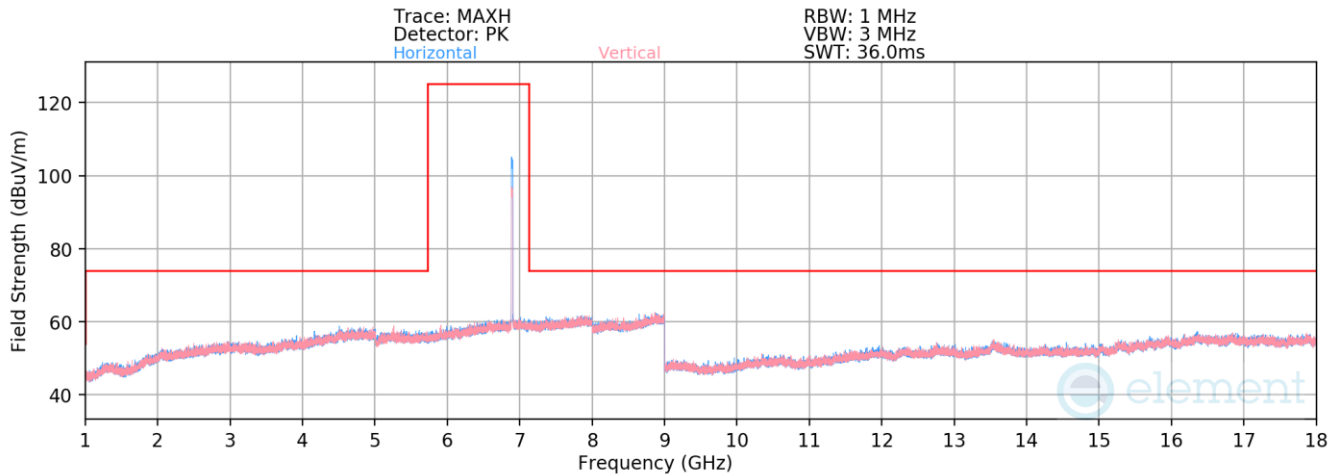

Plot 7-606. Radiated Spurious Emissions above 1GHz Antenna WF5b (802.11ax – Ch. 189, MCS2)

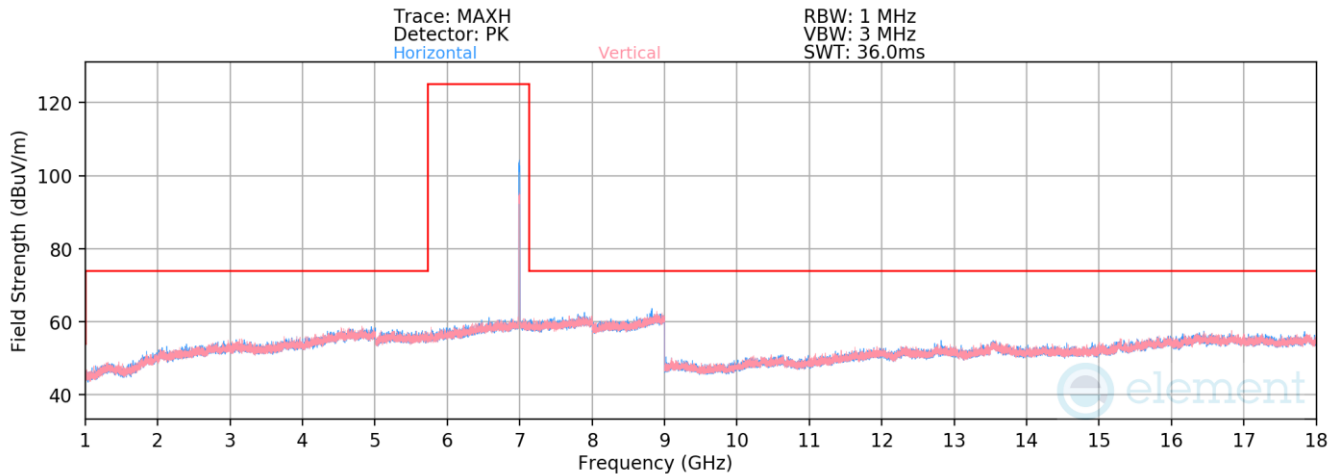
