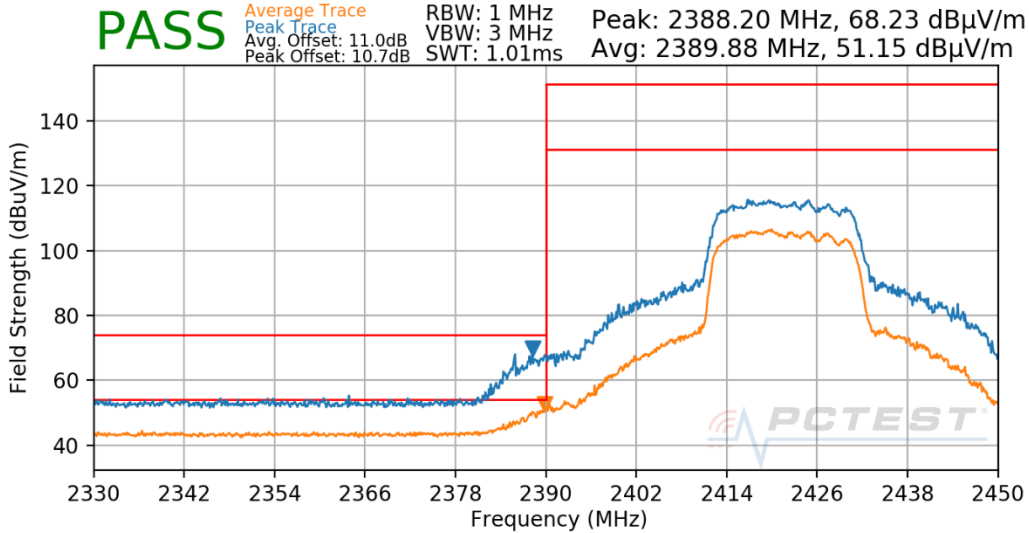
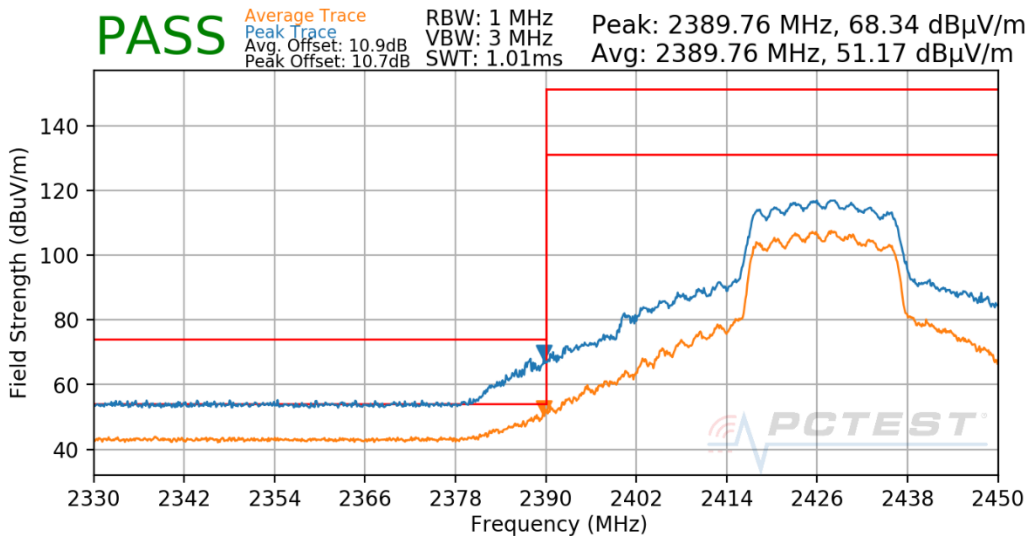

Plot 7-703. Radiated Restricted Lower Band Edge Measurement Antenna CDD

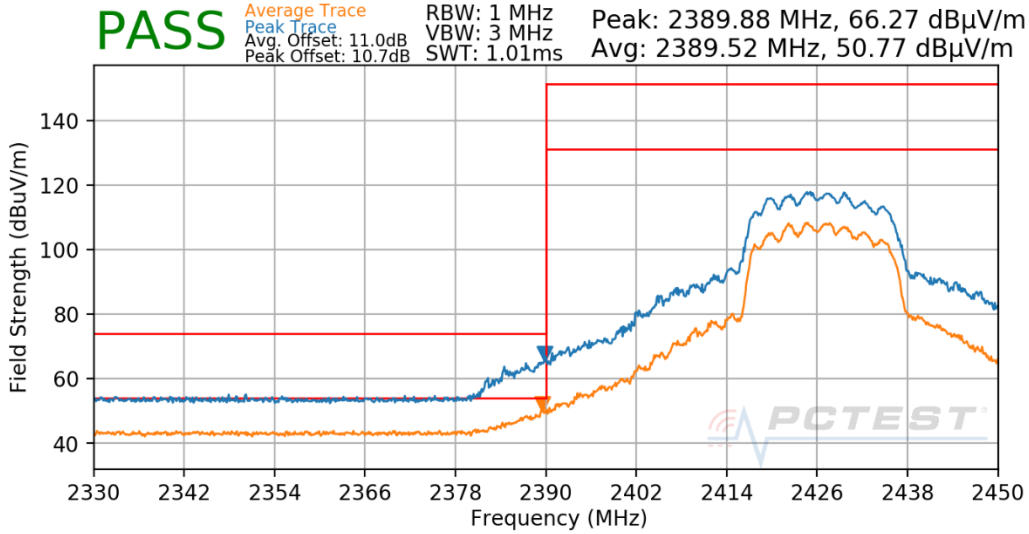

Plot 7-704. Radiated Restricted Lower Band Edge Measurement Antenna CDD

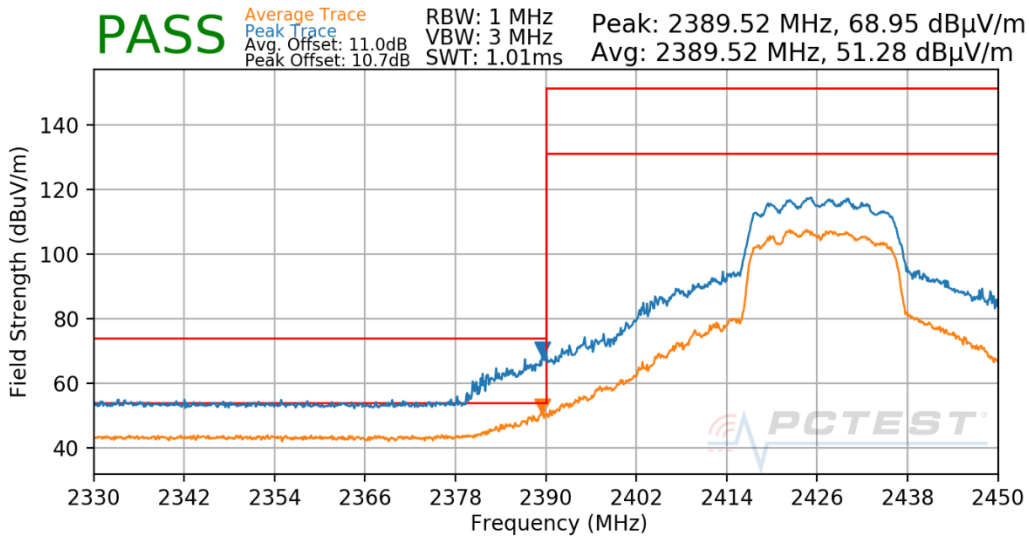

Plot 7-705. Radiated Restricted Lower Band Edge Measurement Antenna CDD

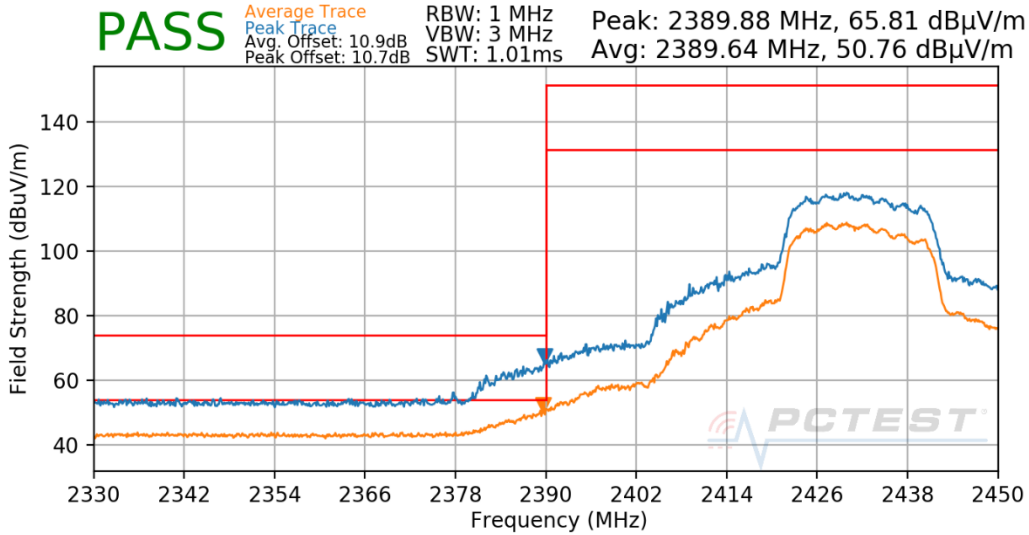

Plot 7-706. Radiated Restricted Lower Band Edge Measurement Antenna CDD

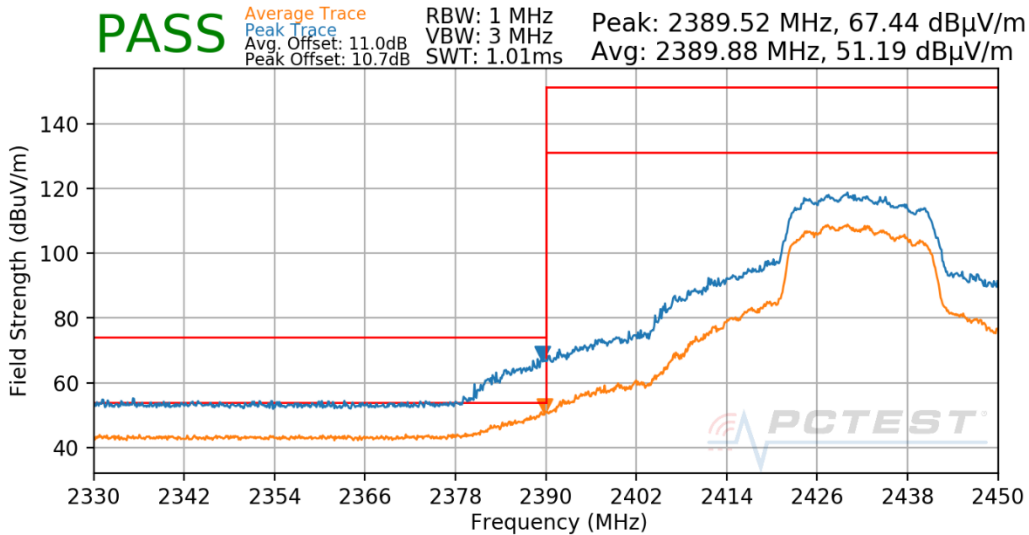

Plot 7-707. Radiated Restricted Lower Band Edge Measurement Antenna CDD

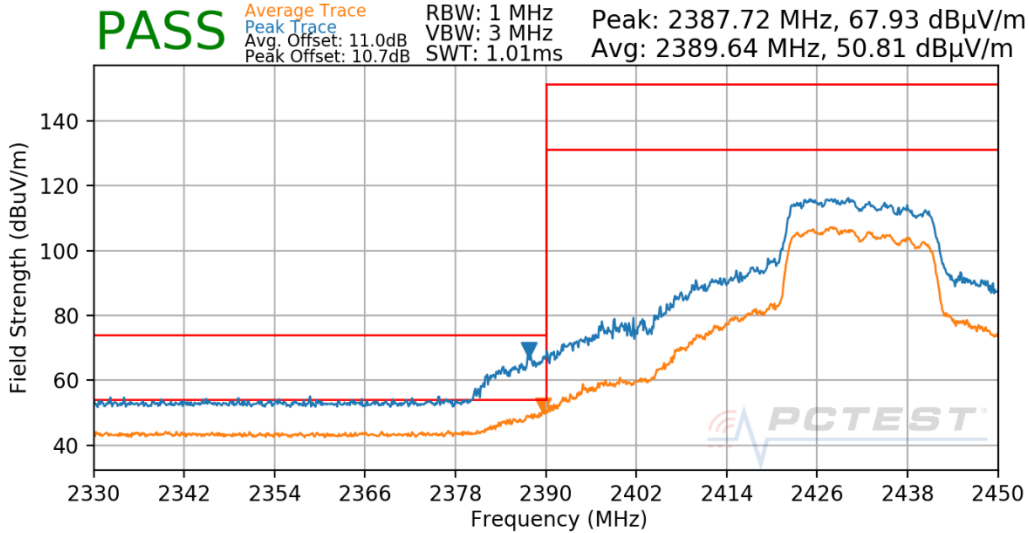

Plot 7-708. Radiated Restricted Lower Band Edge Measurement Antenna CDD

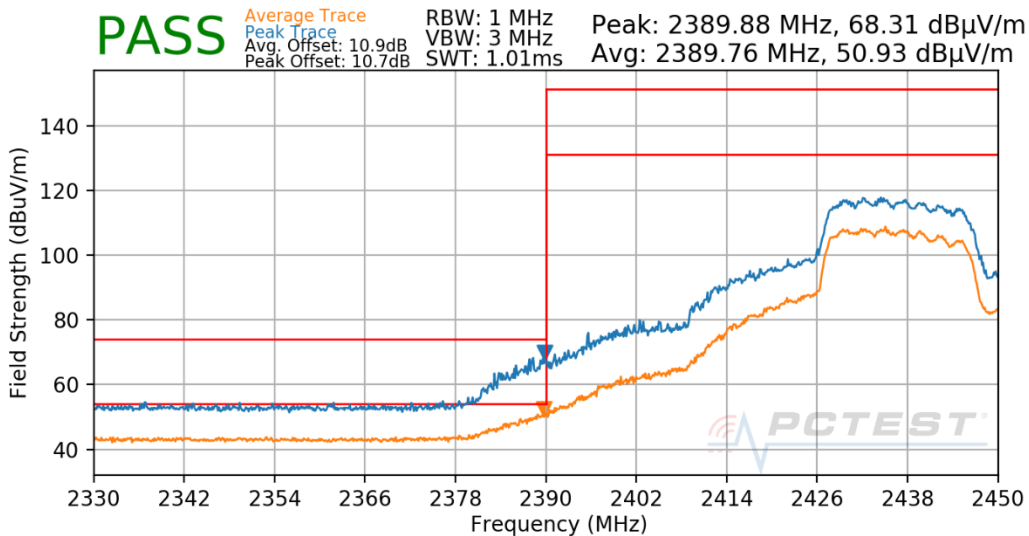

Plot 7-709. Radiated Restricted Lower Band Edge Measurement Antenna CDD

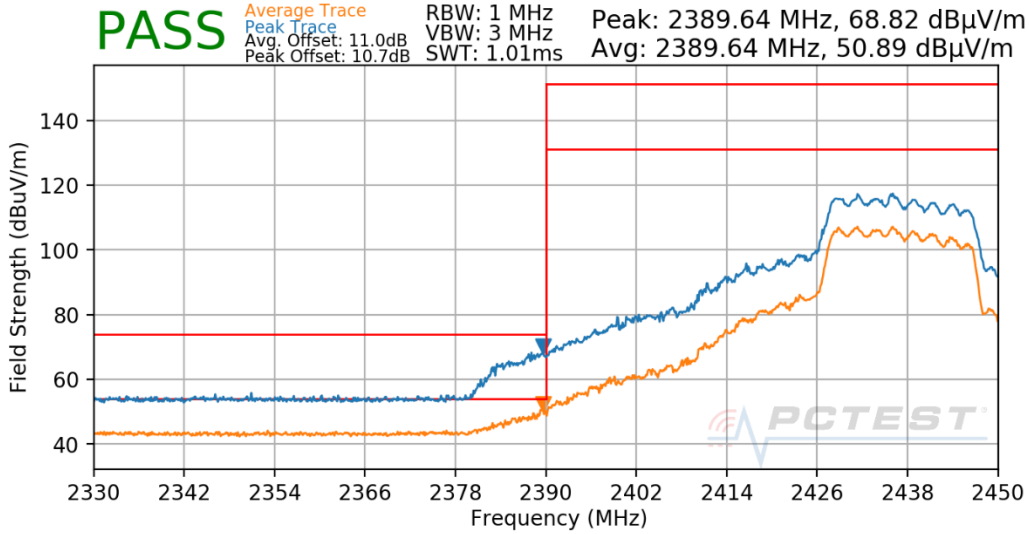

Plot 7-710. Radiated Restricted Lower Band Edge Measurement Antenna CDD

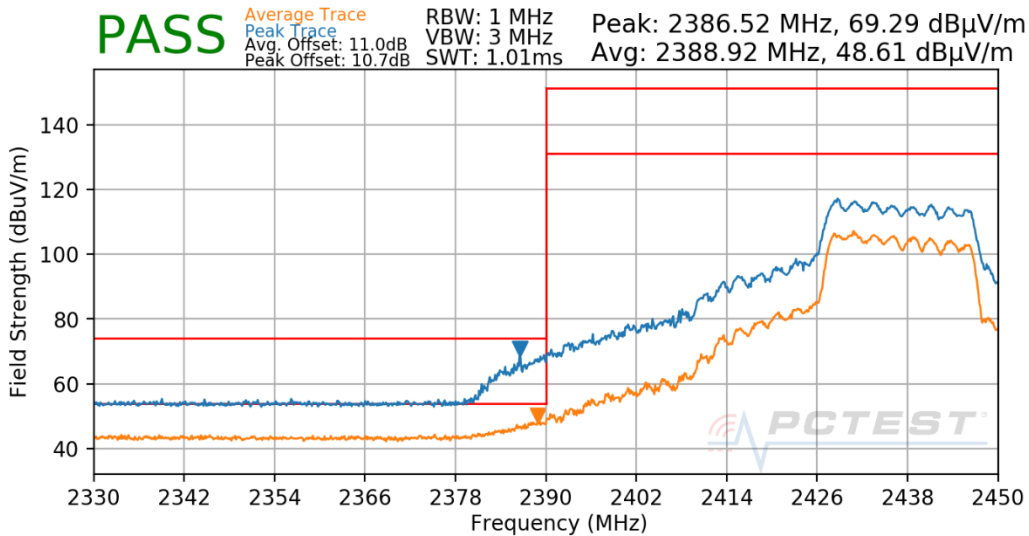

Plot 7-711. Radiated Restricted Lower Band Edge Measurement Antenna CDD

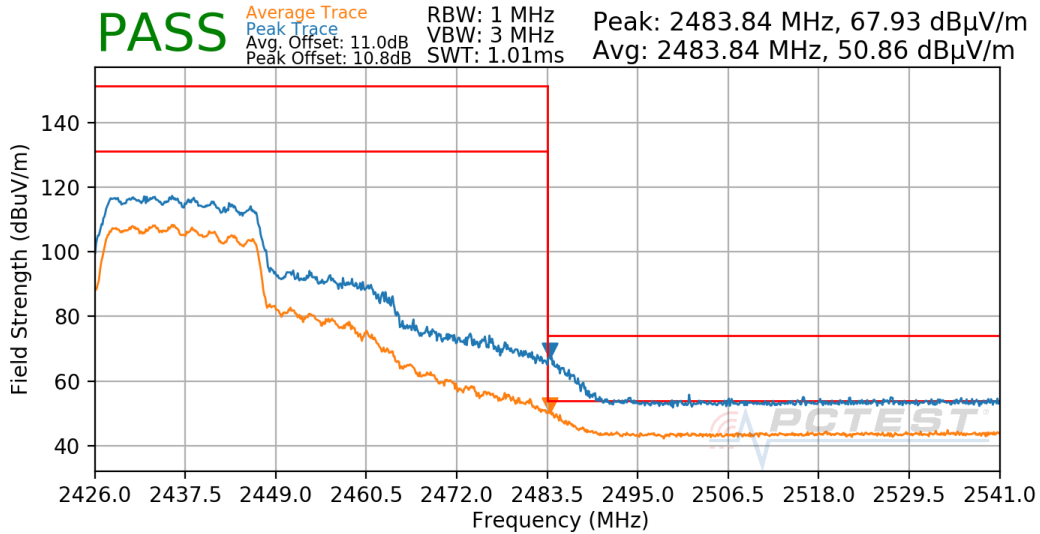

Plot 7-712. Radiated Restricted Lower Band Edge Measurement Antenna CDD

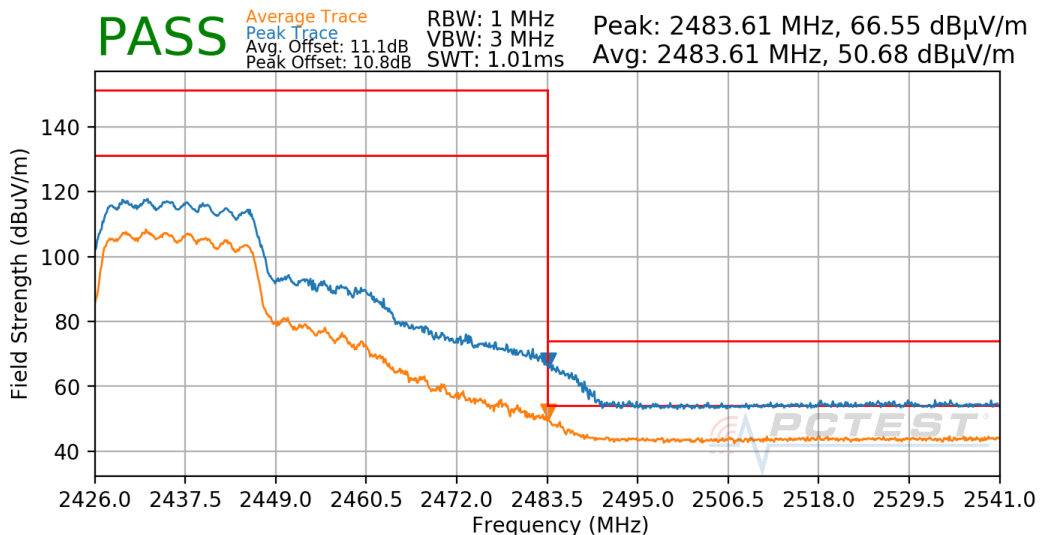

Plot 7-713. Radiated Restricted Upper Band Edge Measurement Antenna CDD

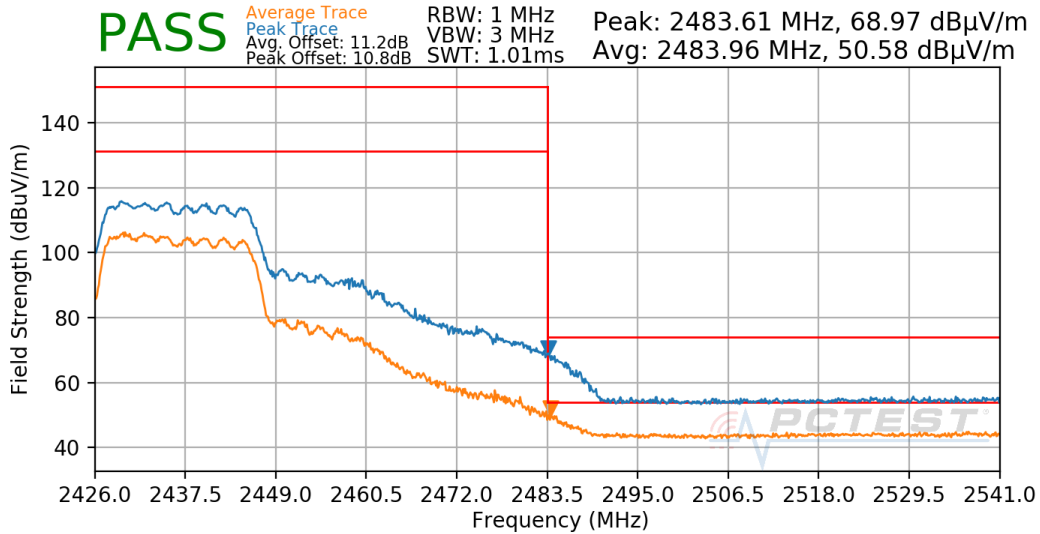

Plot 7-714. Radiated Restricted Upper Band Edge Measurement Antenna CDD

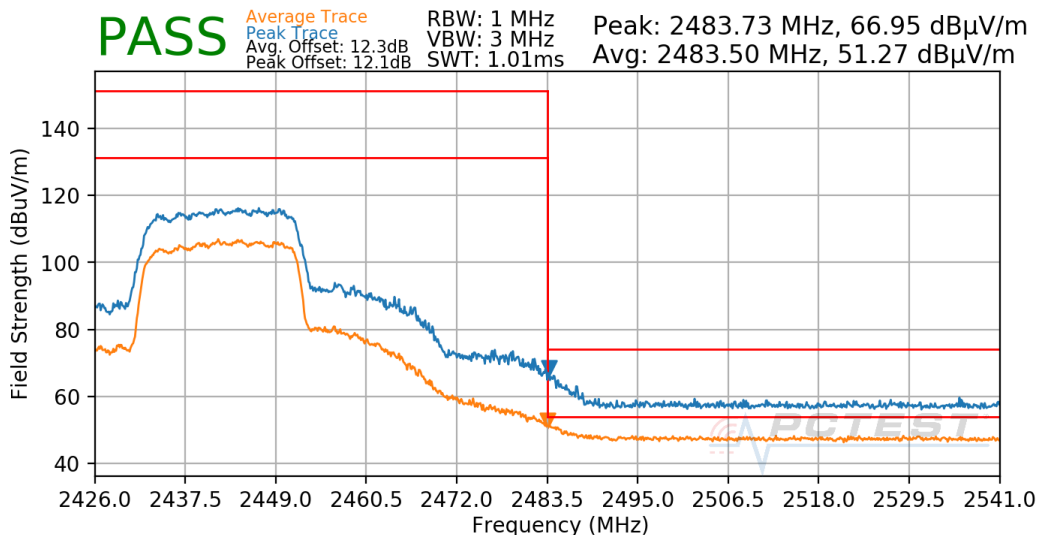

Plot 7-715. Radiated Restricted Upper Band Edge Measurement Antenna CDD

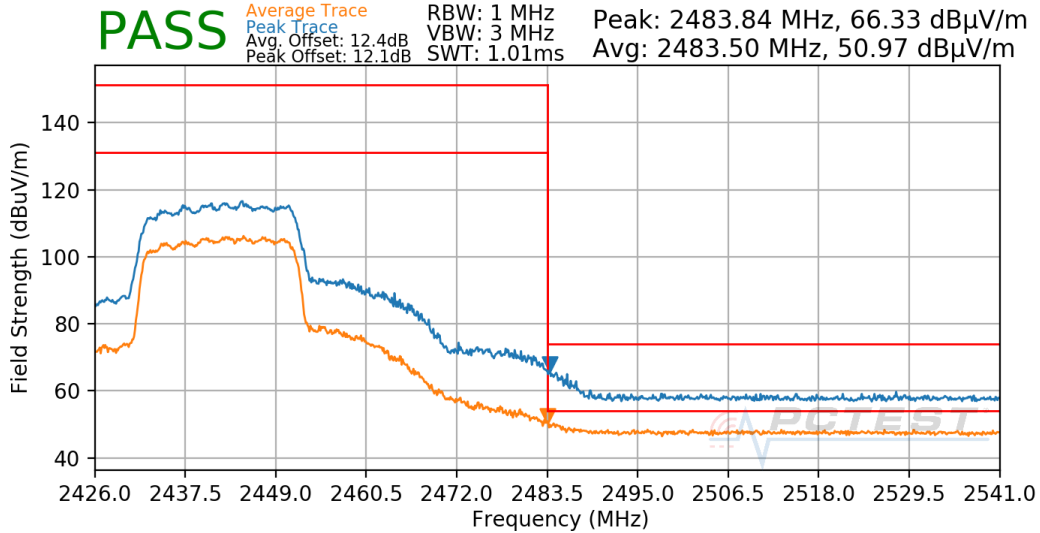

Plot 7-716. Radiated Restricted Upper Band Edge Measurement Antenna CDD

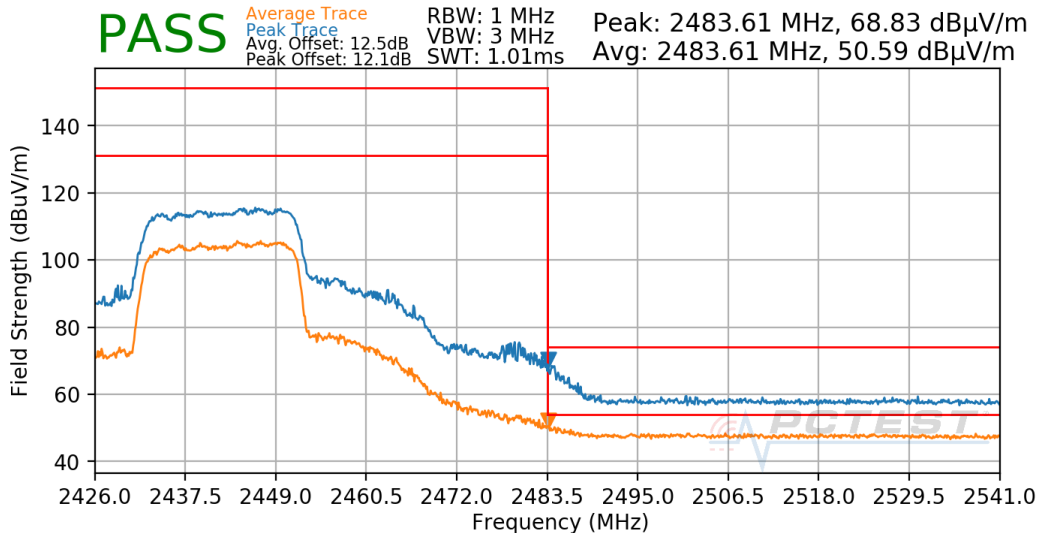

Plot 7-717. Radiated Restricted Upper Band Edge Measurement Antenna CDD

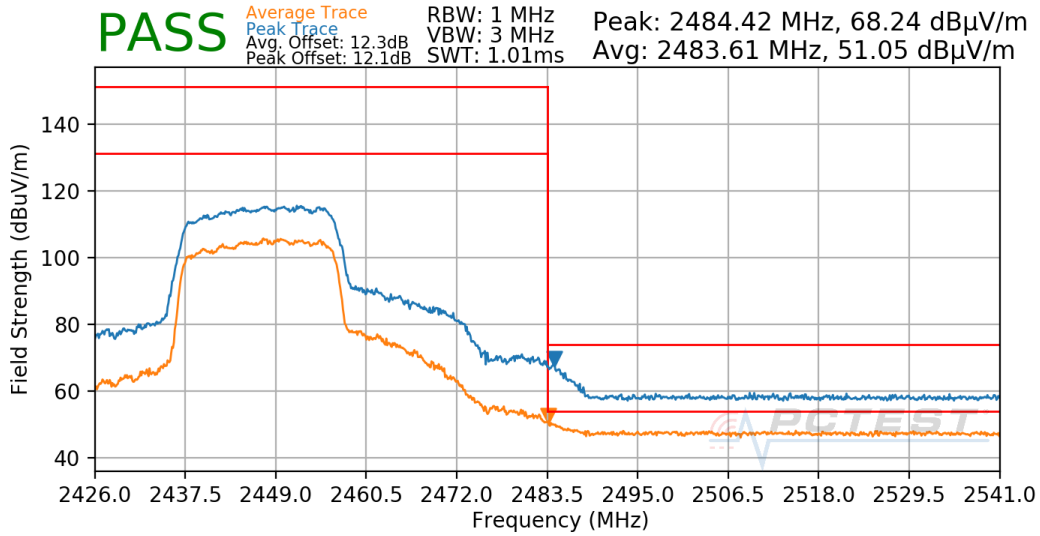

Plot 7-718. Radiated Restricted Upper Band Edge Measurement Antenna CDD

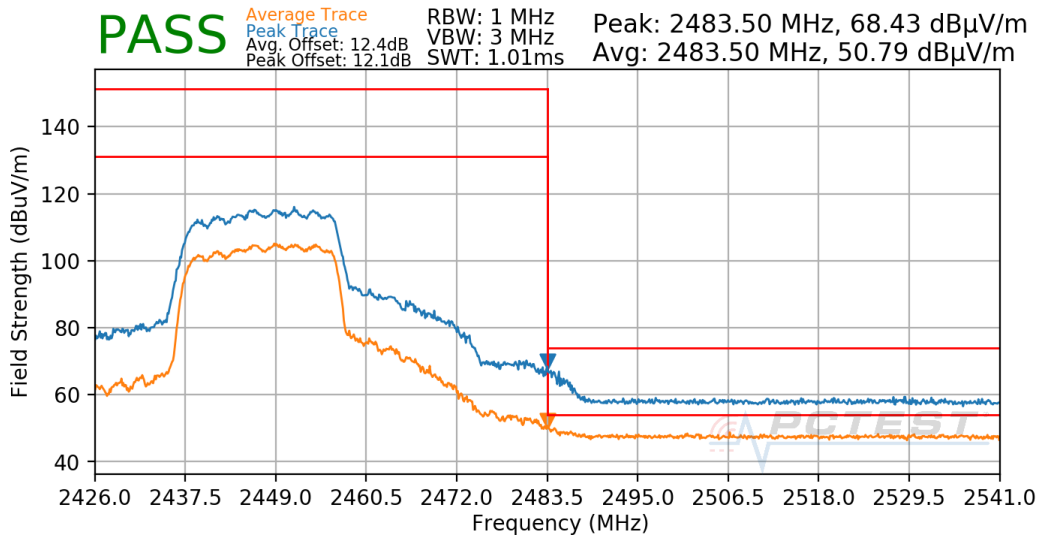

Plot 7-719. Radiated Restricted Upper Band Edge Measurement Antenna CDD

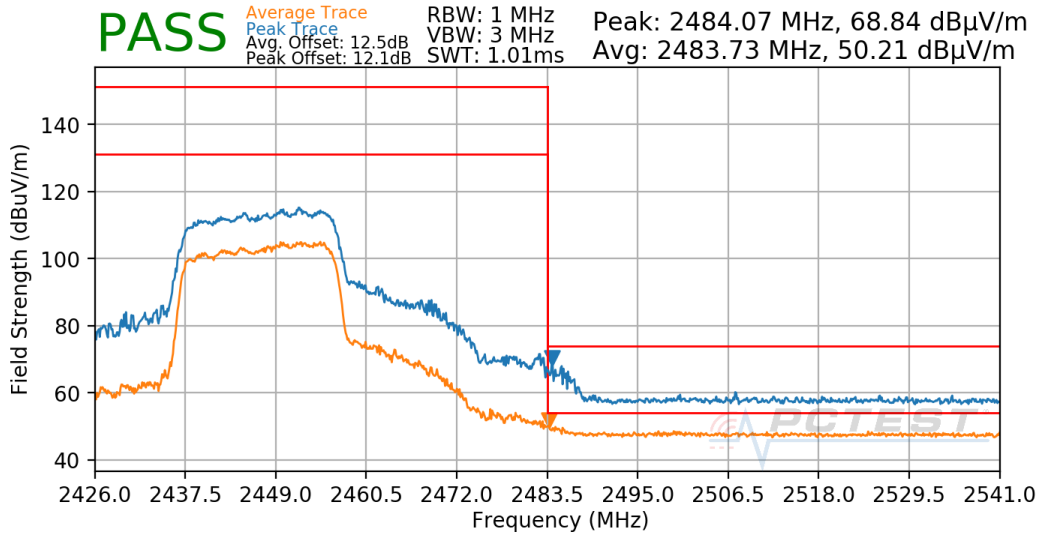

Plot 7-720. Radiated Restricted Upper Band Edge Measurement Antenna CDD

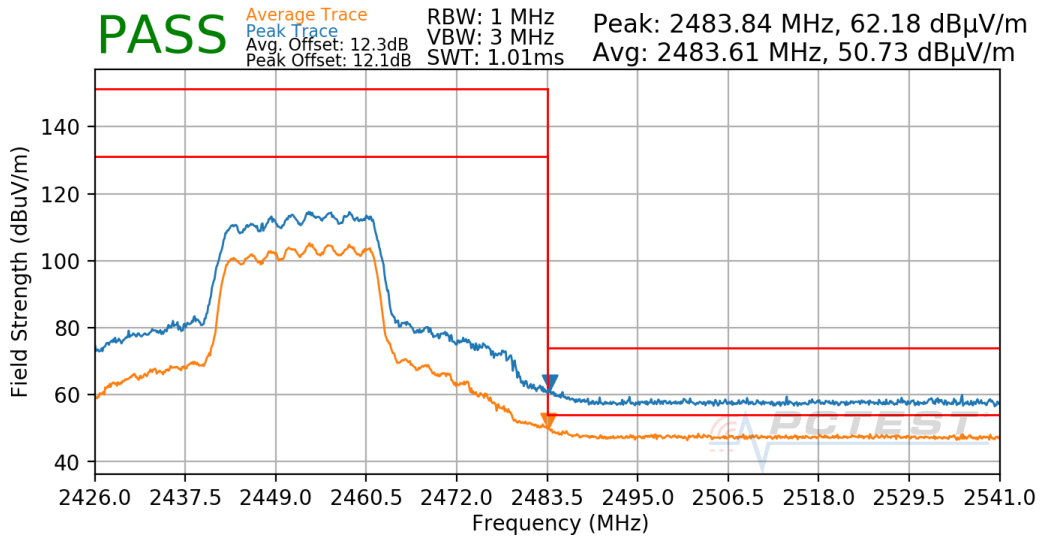

Plot 7-721. Radiated Restricted Upper Band Edge Measurement Antenna CDD

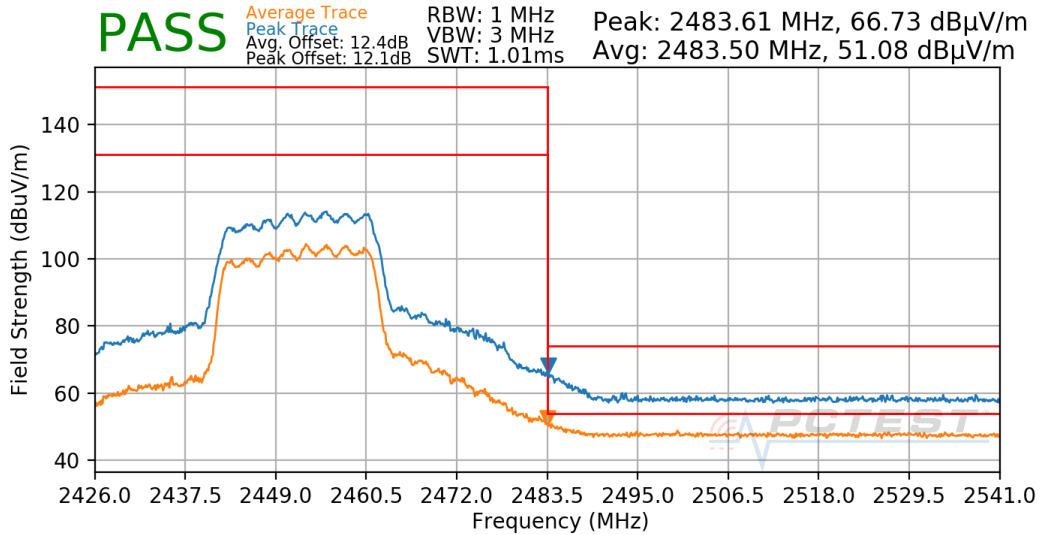

Plot 7-722. Radiated Restricted Upper Band Edge Measurement Antenna CDD

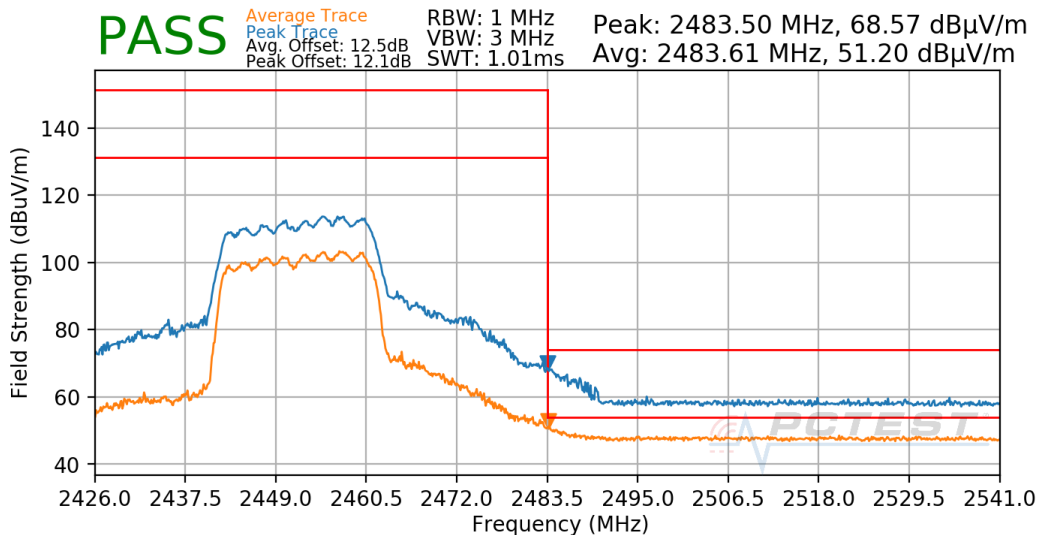

Plot 7-723. Radiated Restricted Upper Band Edge Measurement Antenna CDD

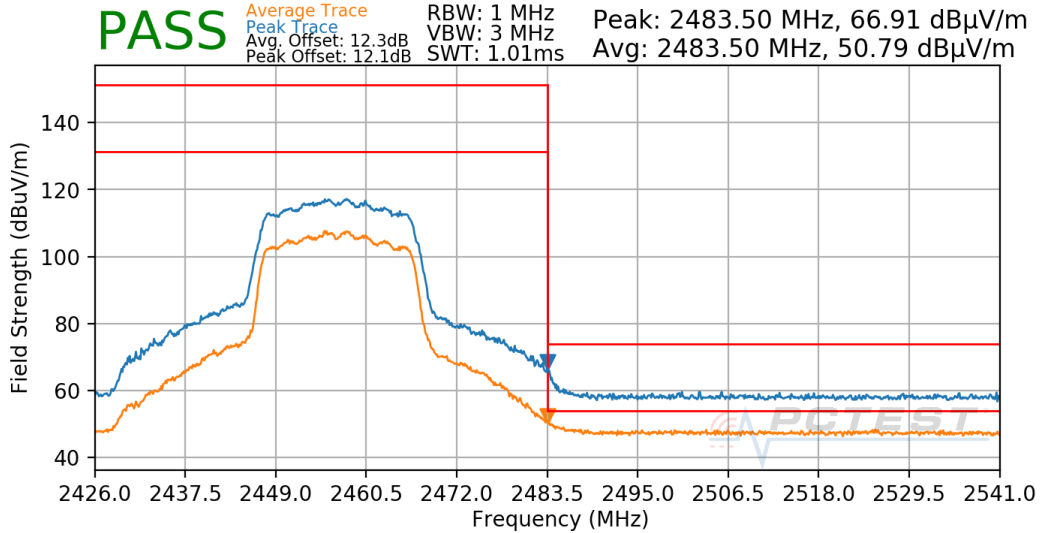

Plot 7-724. Radiated Restricted Upper Band Edge Measurement Antenna CDD

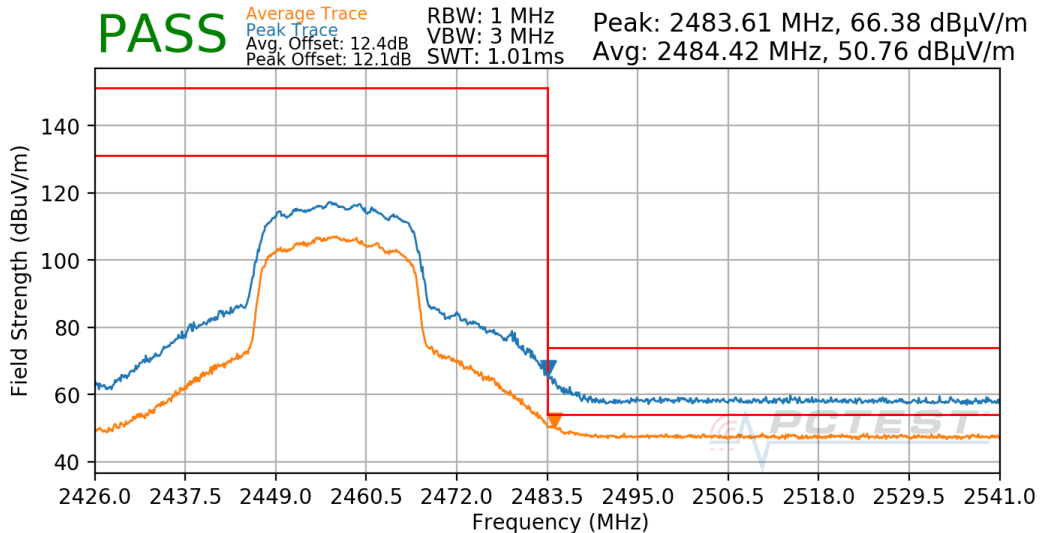

Plot 7-725. Radiated Restricted Upper Band Edge Measurement Antenna CDD

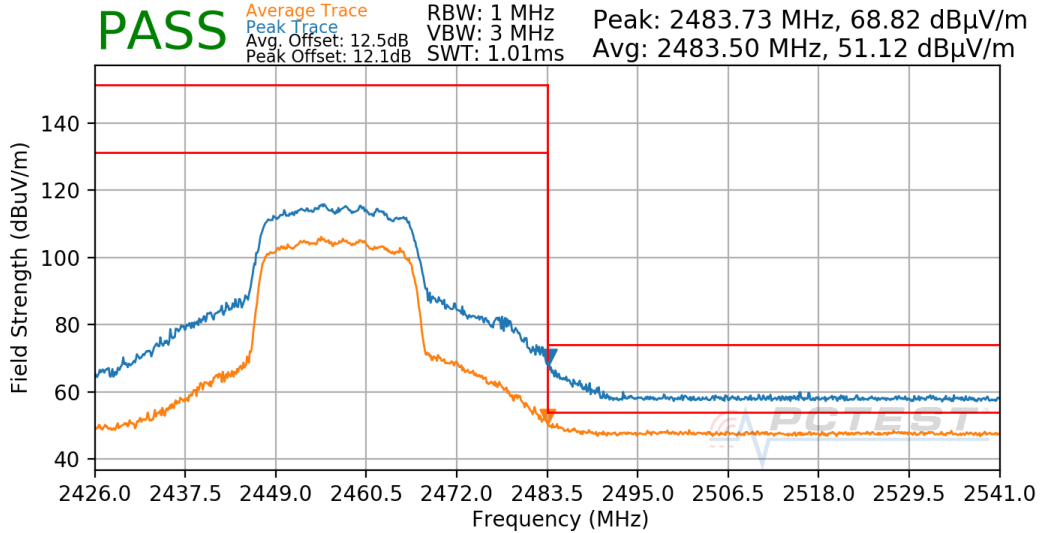

Plot 7-726. Radiated Restricted Upper Band Edge Measurement Antenna CDD

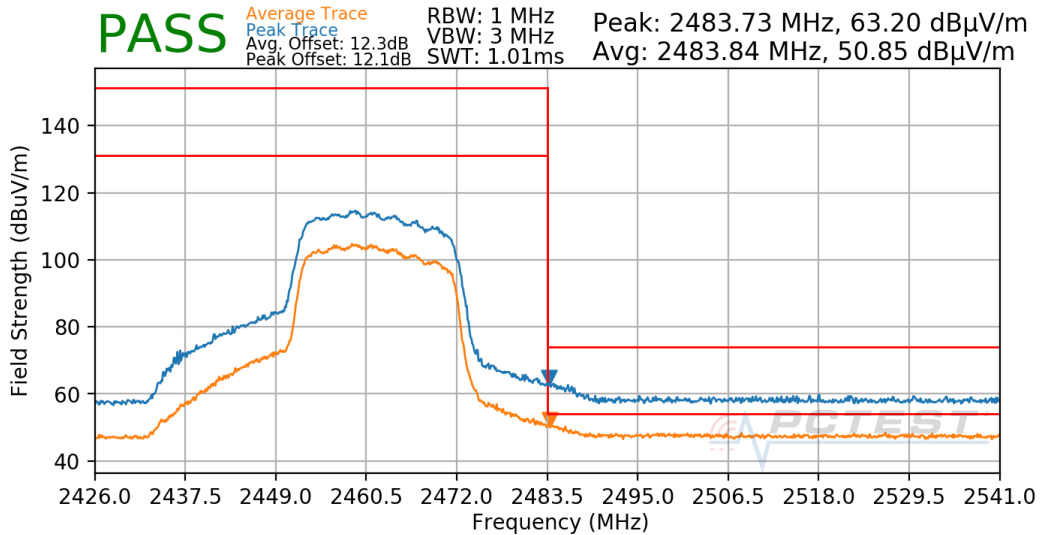

Plot 7-727. Radiated Restricted Upper Band Edge Measurement Antenna CDD

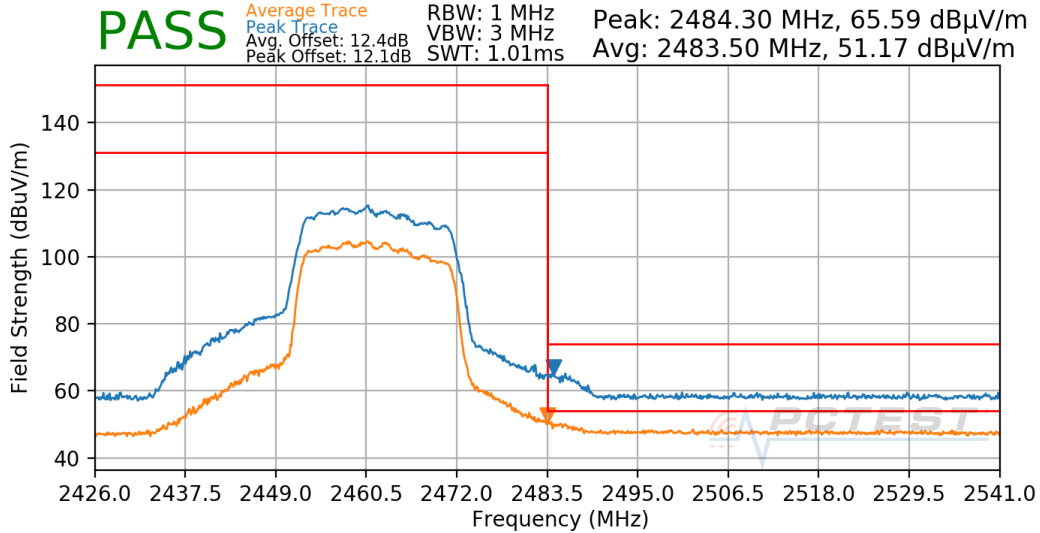

Plot 7-728. Radiated Restricted Upper Band Edge Measurement Antenna CDD

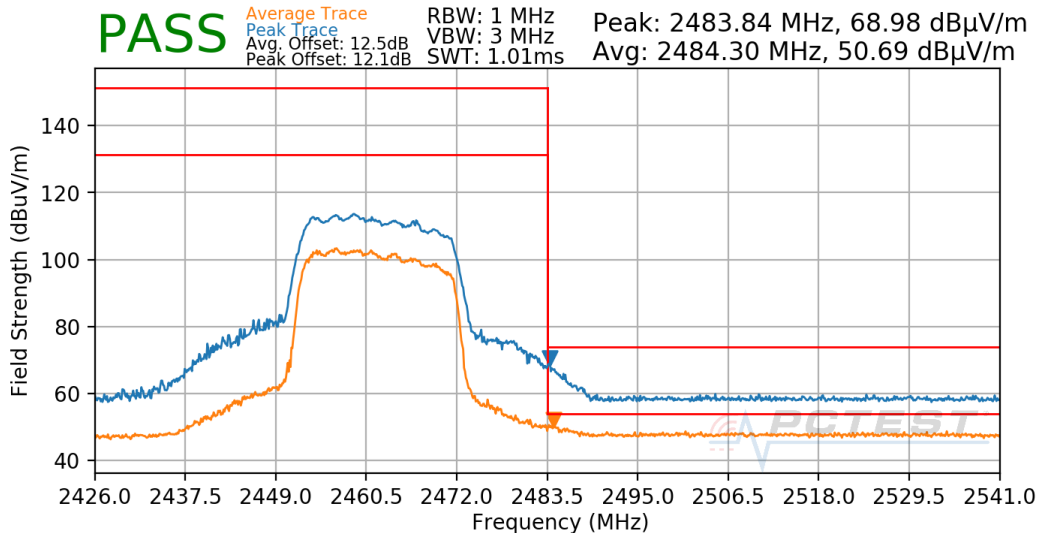

Plot 7-729. Radiated Restricted Upper Band Edge Measurement Antenna CDD

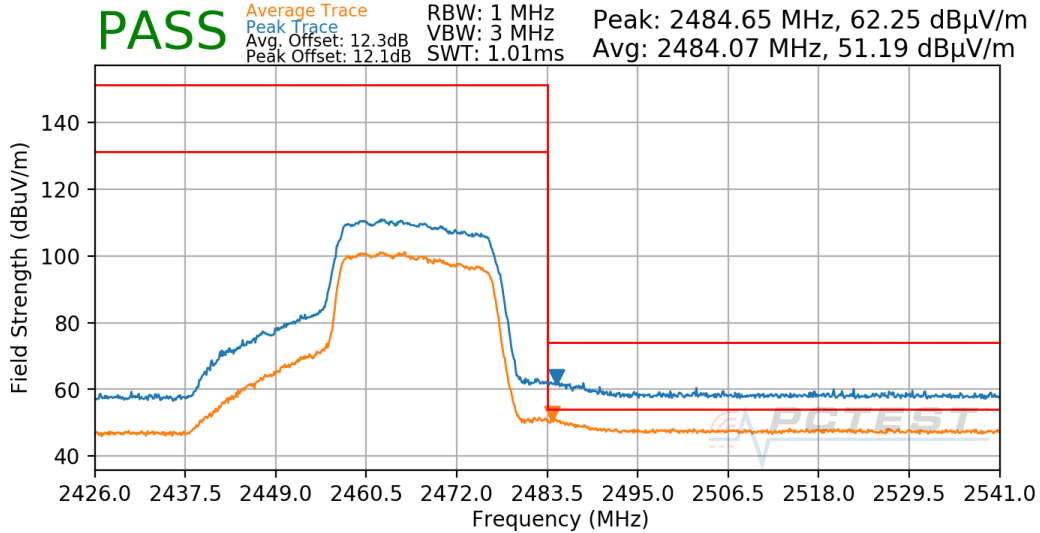

Plot 7-730. Radiated Restricted Upper Band Edge Measurement Antenna CDD

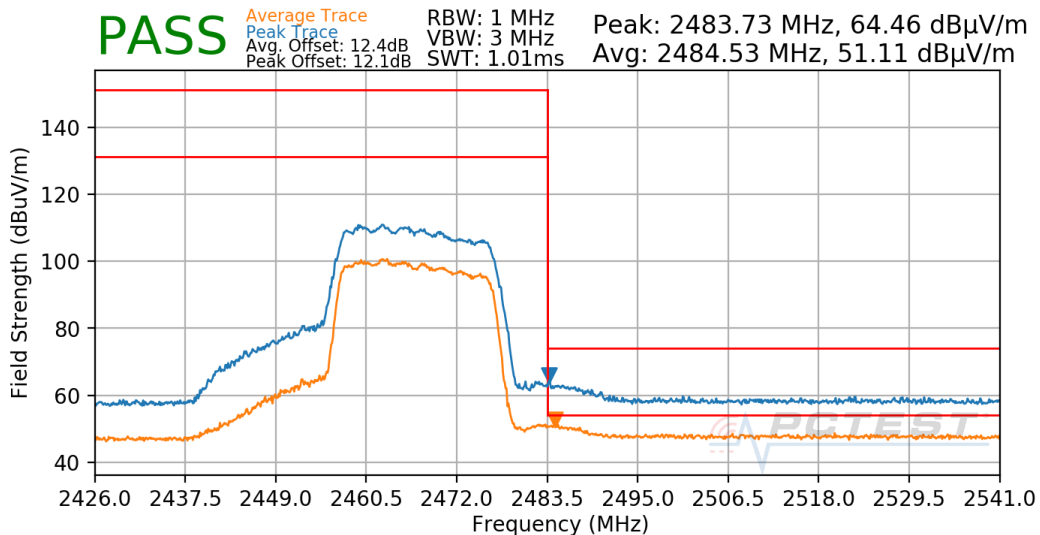

Plot 7-731. Radiated Restricted Upper Band Edge Measurement Antenna CDD

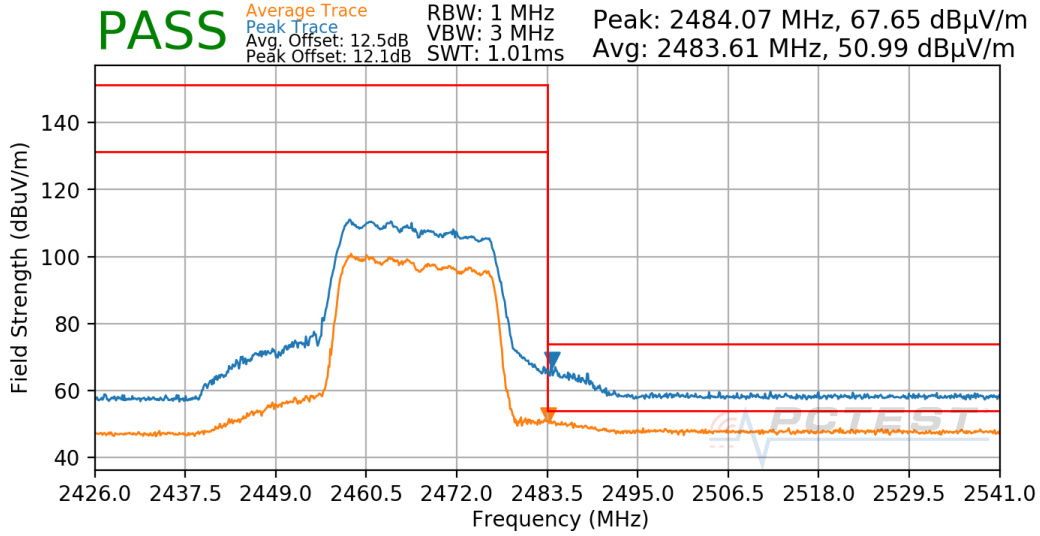

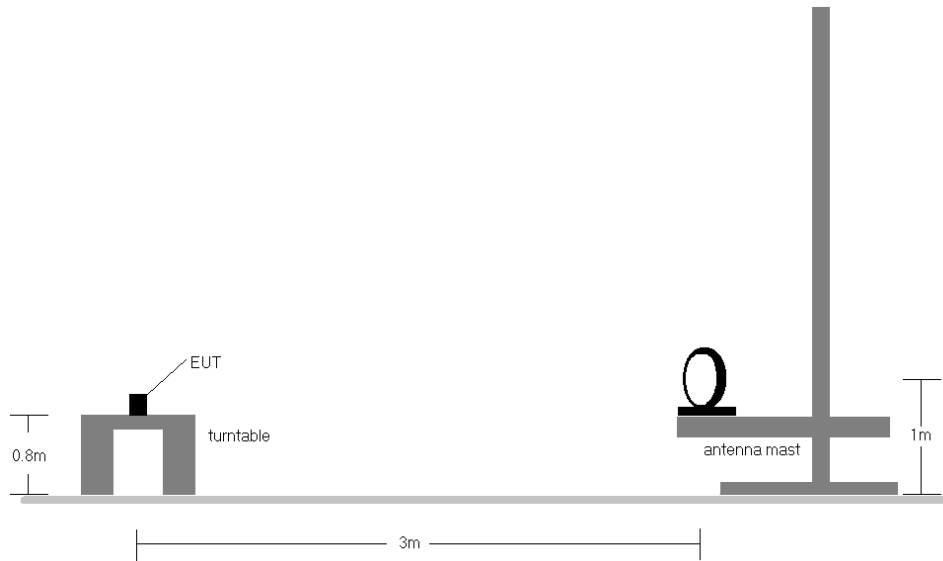


Figure 7-7. Radiated Test Setup < 30Mhz

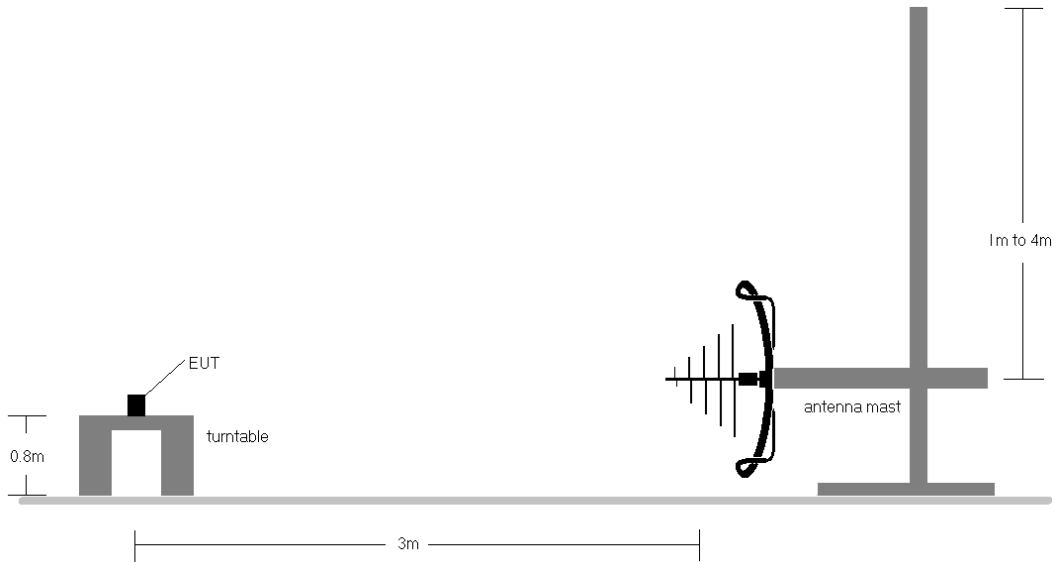


Figure 7-8. Radiated Test Setup < 1GHz

Test Notes

1. All emissions lying in restricted bands specified in §15.205 and RSS-Gen(8.10) are below the limit shown in Table 7-66.

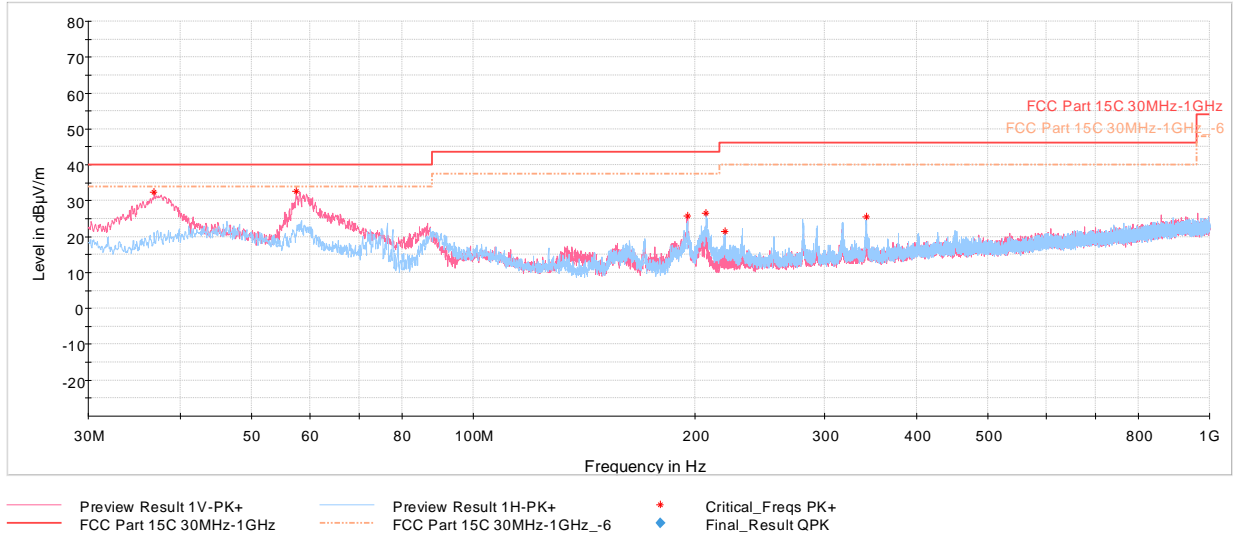

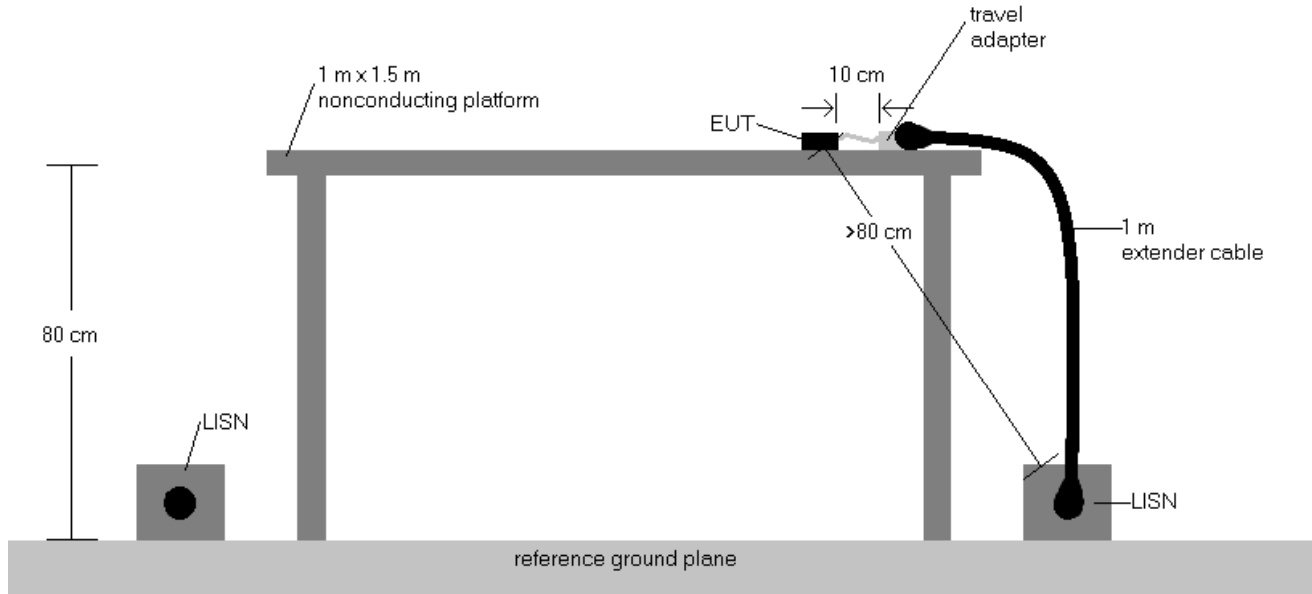
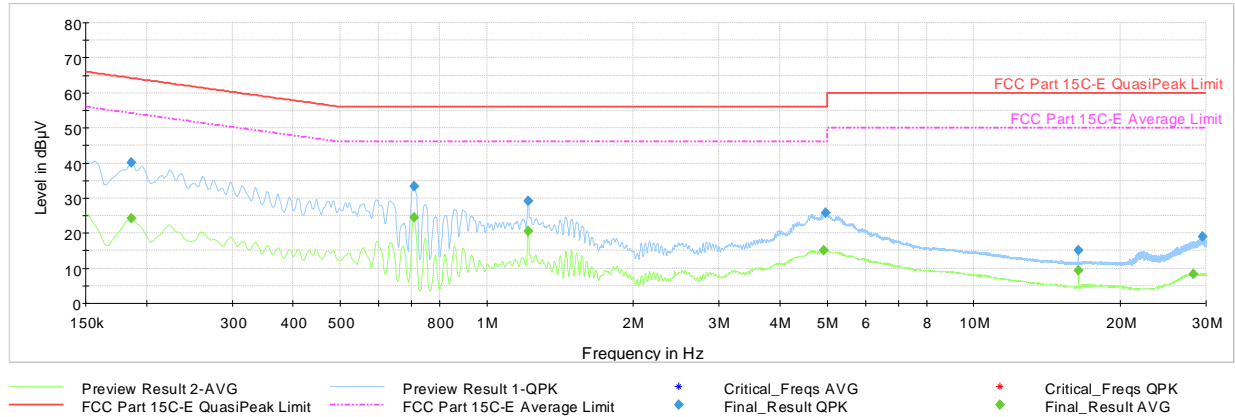


Figure 7-9. Test Instrument & Measurement Setup

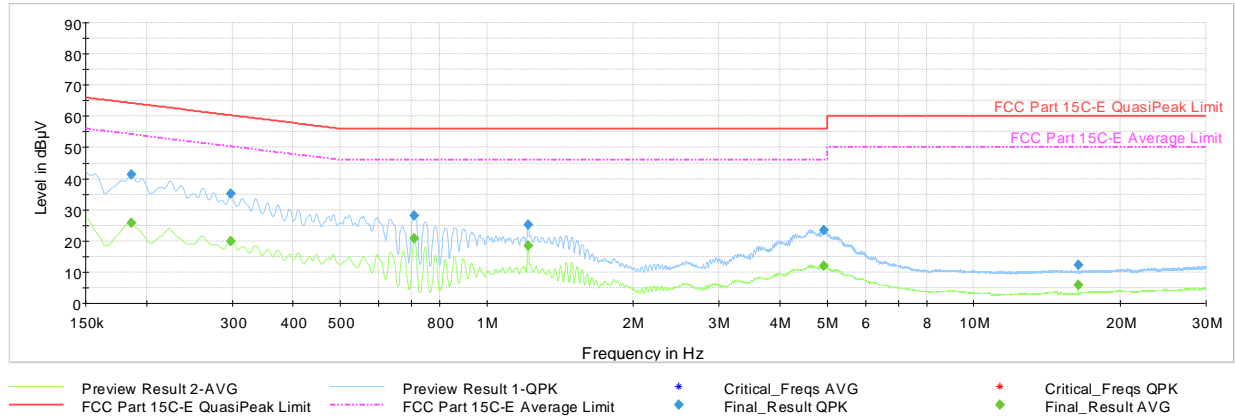


Plot 7-736. AC Line Conducted Plot with CDD 11n Ch.6 (L1, with AC/DC Adapter)

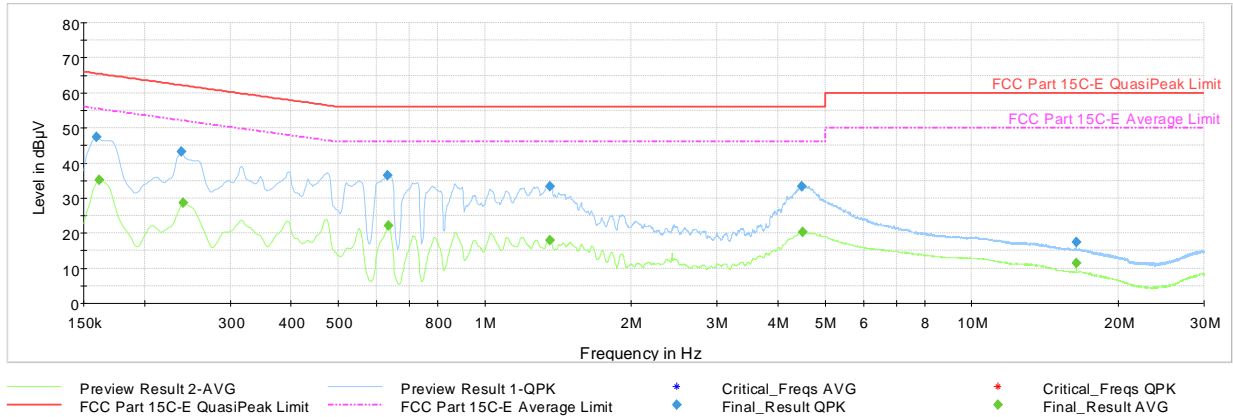


Plot 7-737. AC Line Conducted Plot with CDD 11n Ch.6 (N, with AC/DC Adapter)

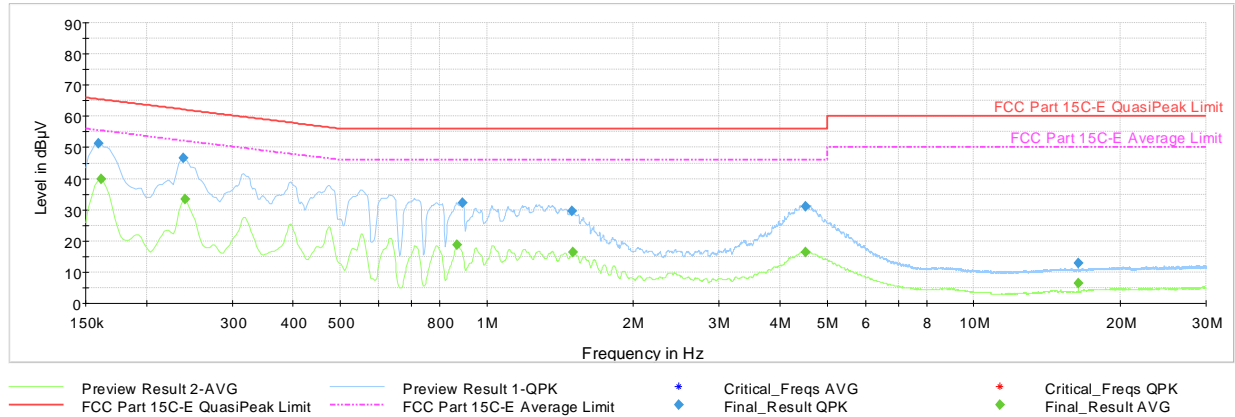


Plot 7-738. AC Line Conducted Plot with CDD 11ax - SU Ch.6 (L1, with AC/DC Adapter)
