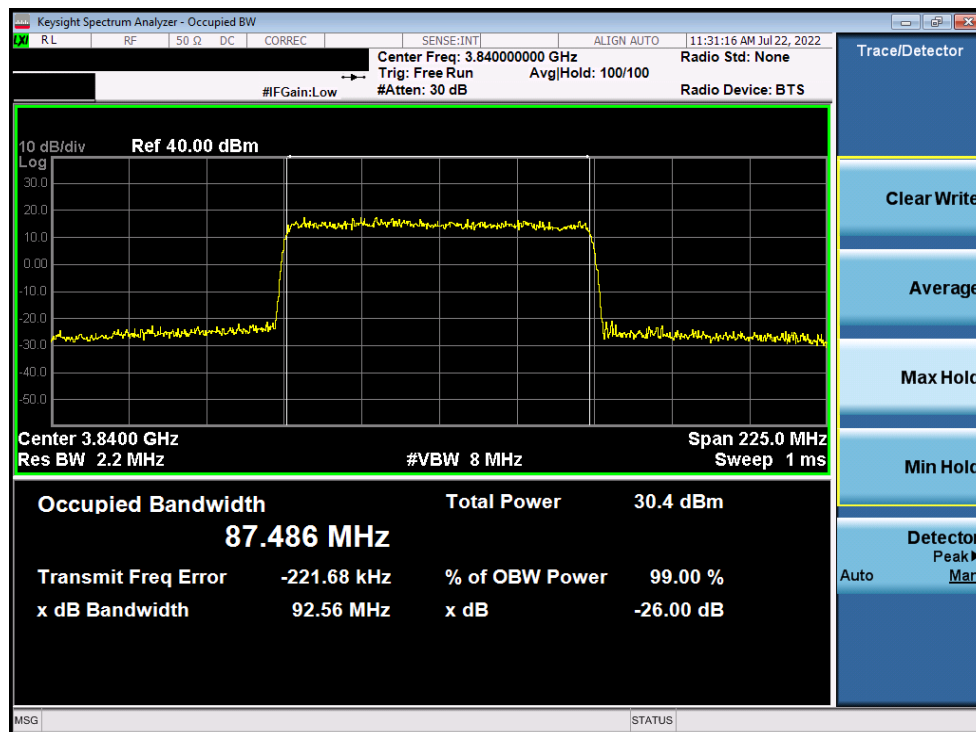

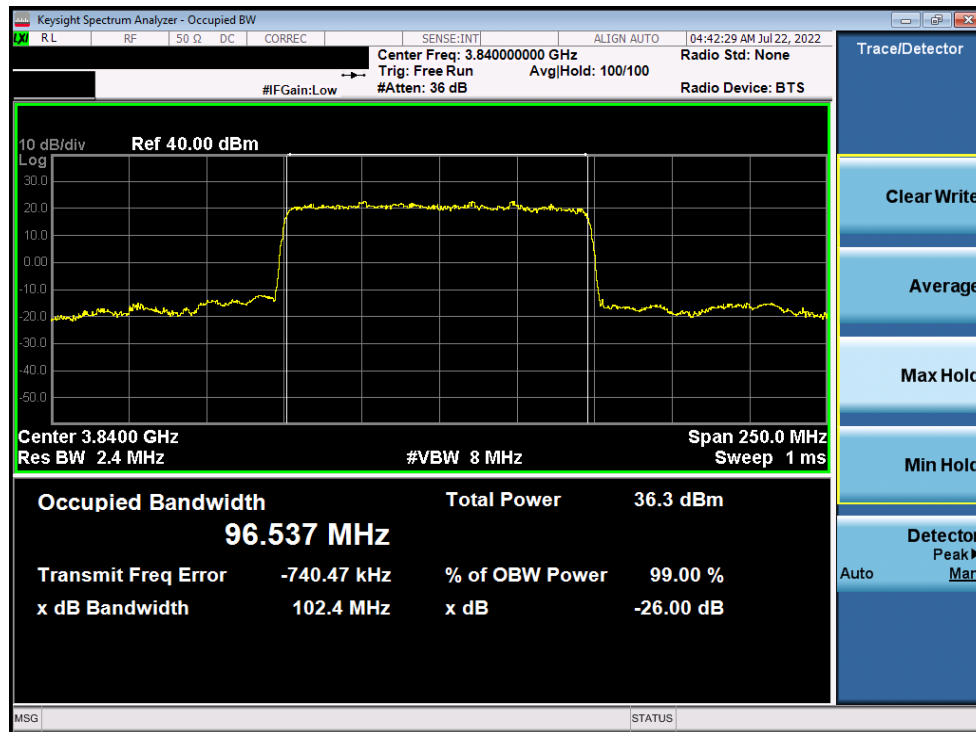


Plot 7-84. Occupied Bandwidth Plot (NR Band n77 C-Band - 90MHz CP-OFDM 64-QAM - Full RB)

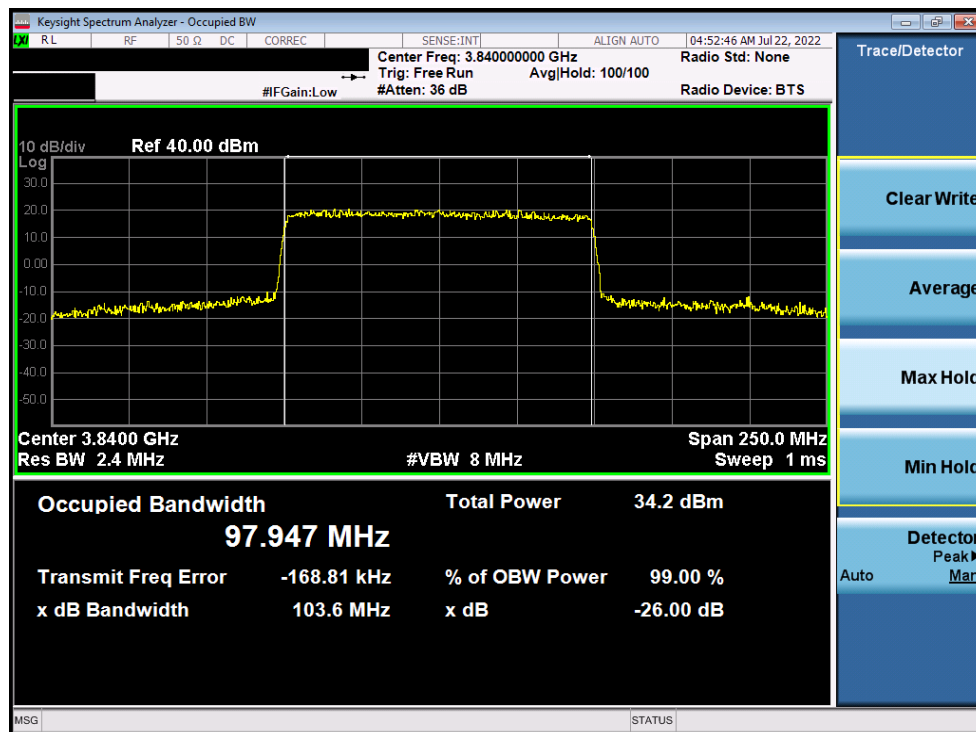


Plot 7-85. Occupied Bandwidth Plot (NR Band n77 C-Band - 90MHz CP-OFDM 256-QAM - Full RB)

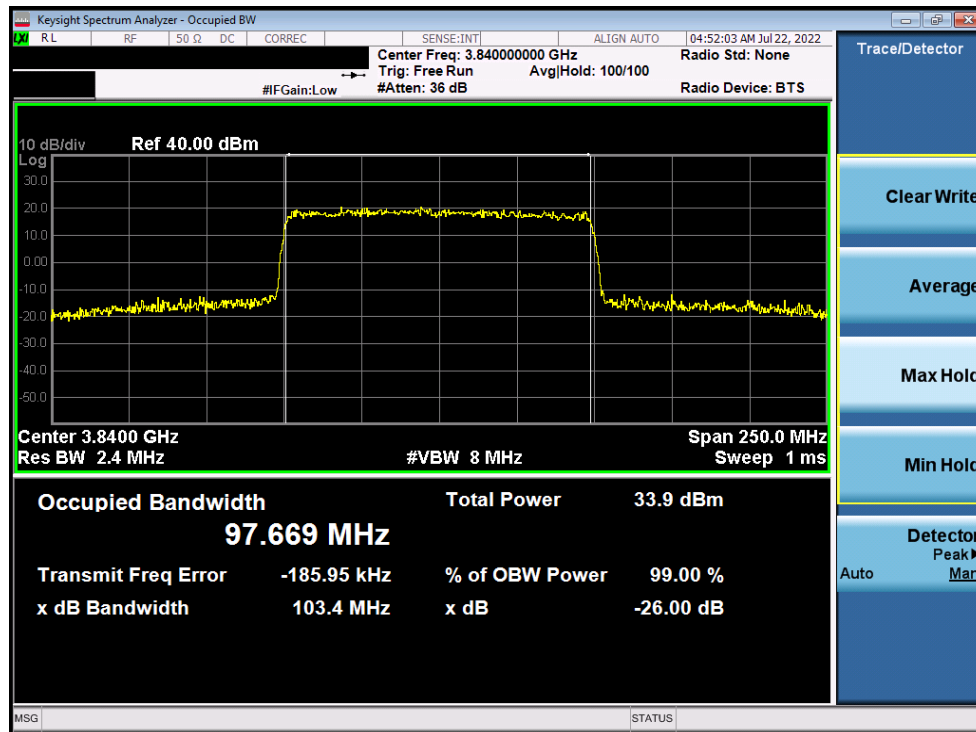


Plot 7-87. Occupied Bandwidth Plot (NR Band n77 C-Band - 100MHz CP-OFDM QPSK - Full RB)

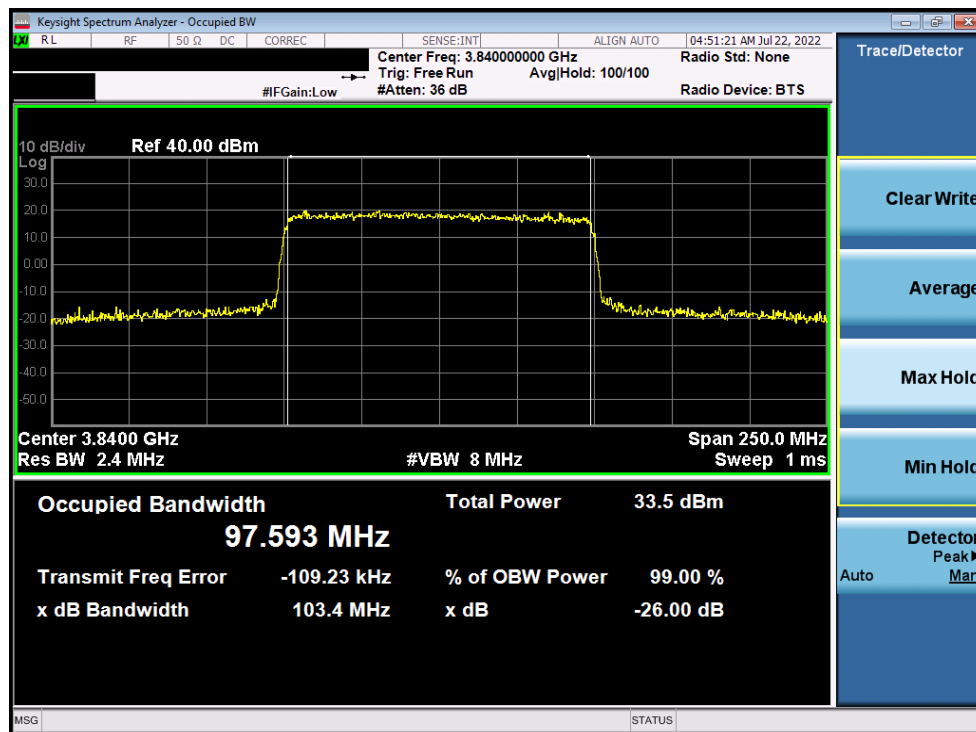

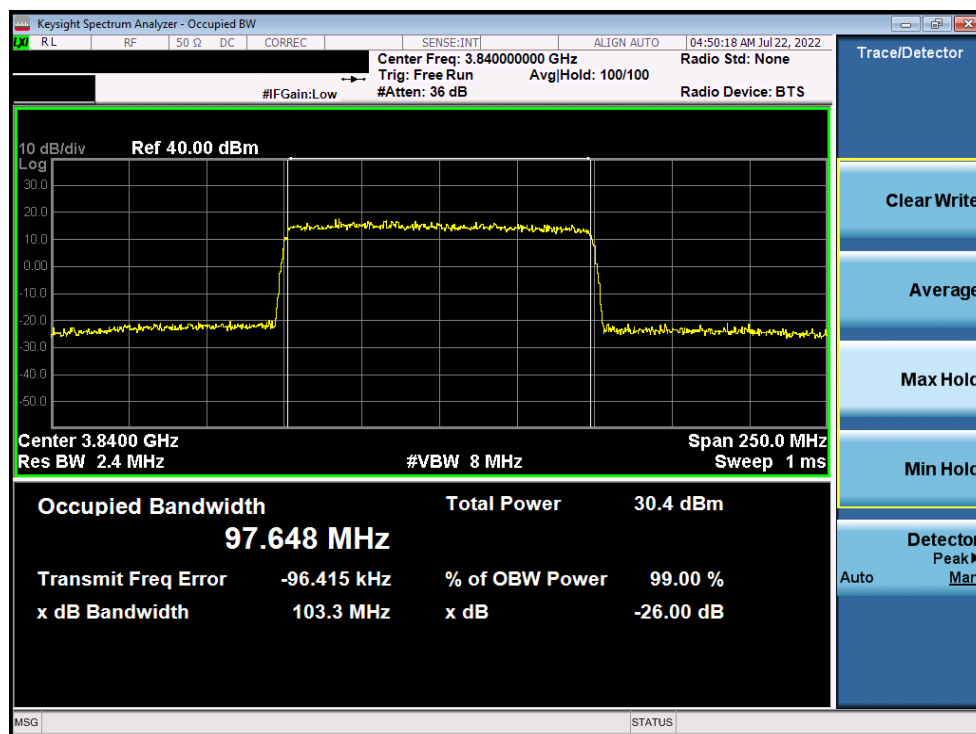


Plot 7-88. Occupied Bandwidth Plot (NR Band n77 C-Band - 100MHz CP-OFDM 16-QAM - Full RB)

7.3 Spurious and Harmonic Emissions at Antenna Terminal

§2.1051, §27.53(l), §27.53(n)

Test Overview

The level of the carrier and the various conducted spurious and harmonic frequencies is measured by means of a calibrated spectrum analyzer. The spectrum is scanned from the lowest frequency generated in the equipment up to a frequency including its 10th harmonic. All out of band emissions are measured with a spectrum analyzer connected to the antenna terminal of the EUT while the EUT is operating at maximum power, and at the appropriate frequencies. All data rates were investigated to determine the worst case configuration. All modes of operation were investigated and the worst case configuration results are reported in this section.

The minimum permissible attenuation level of any spurious emission is $43 + 10 \log_{10}(P_{\text{Watts}})$, where P is the transmitter power in Watts.

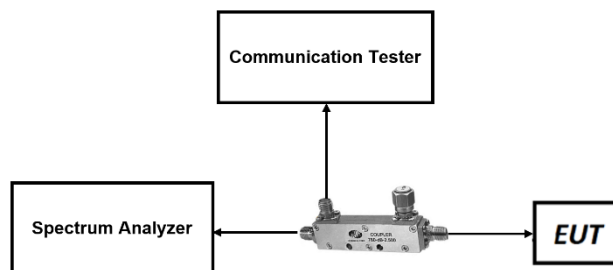




Figure 7-2. Test Instrument & Measurement Setup

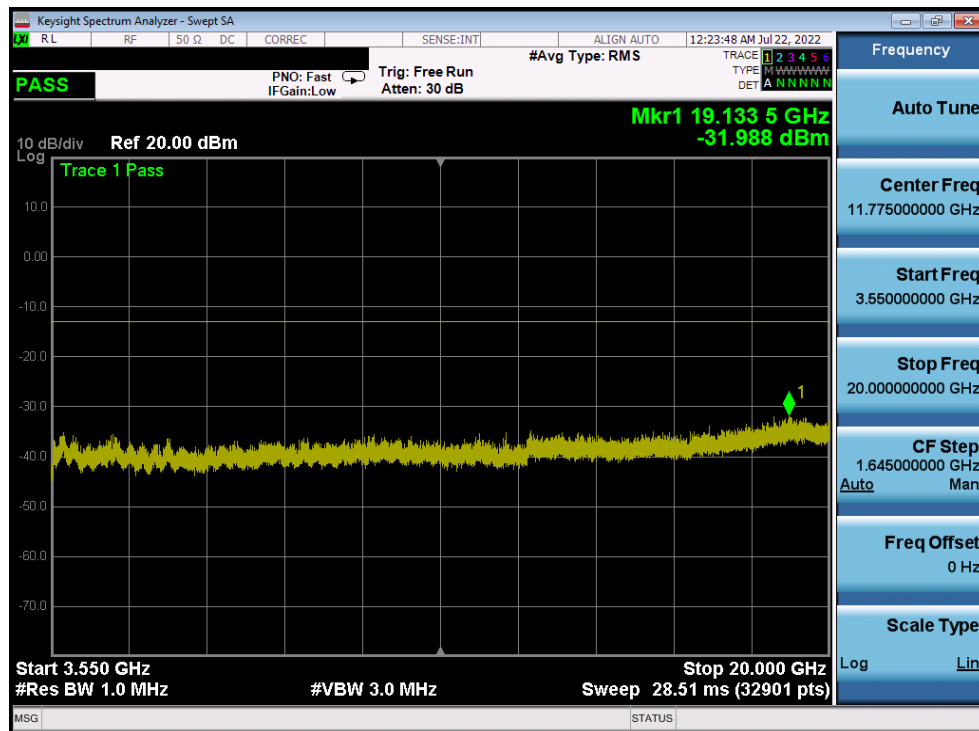

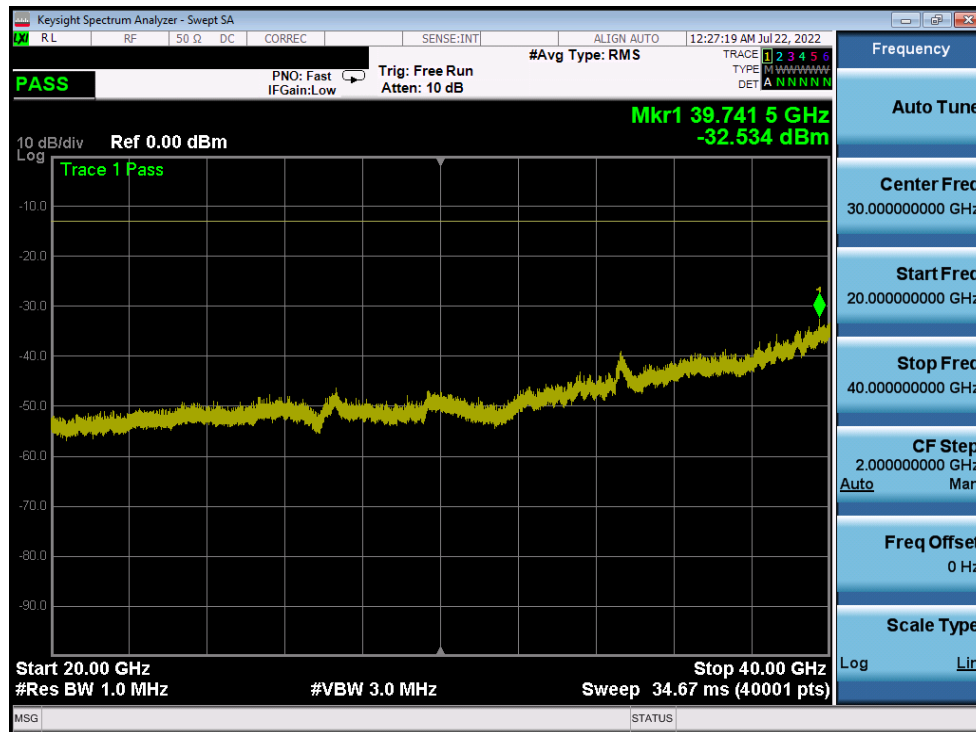

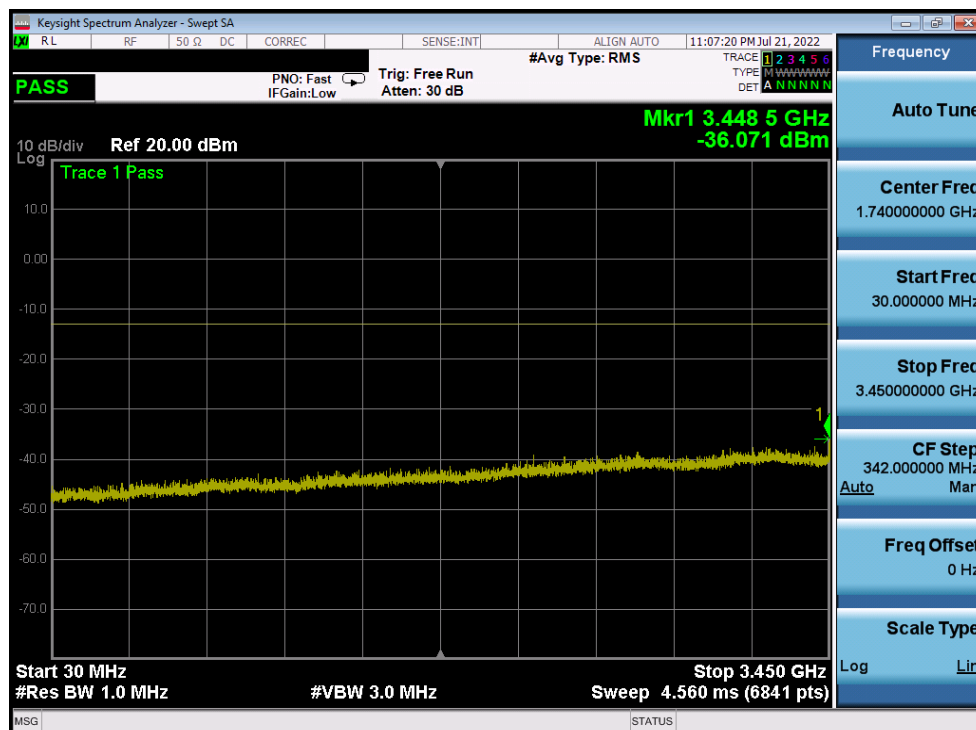

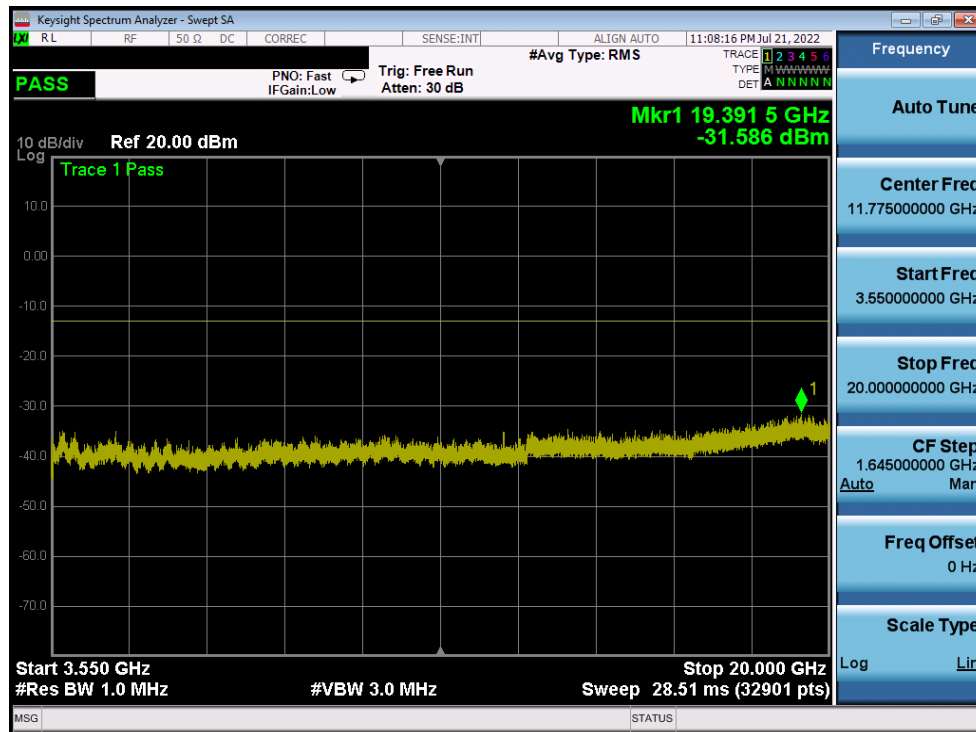

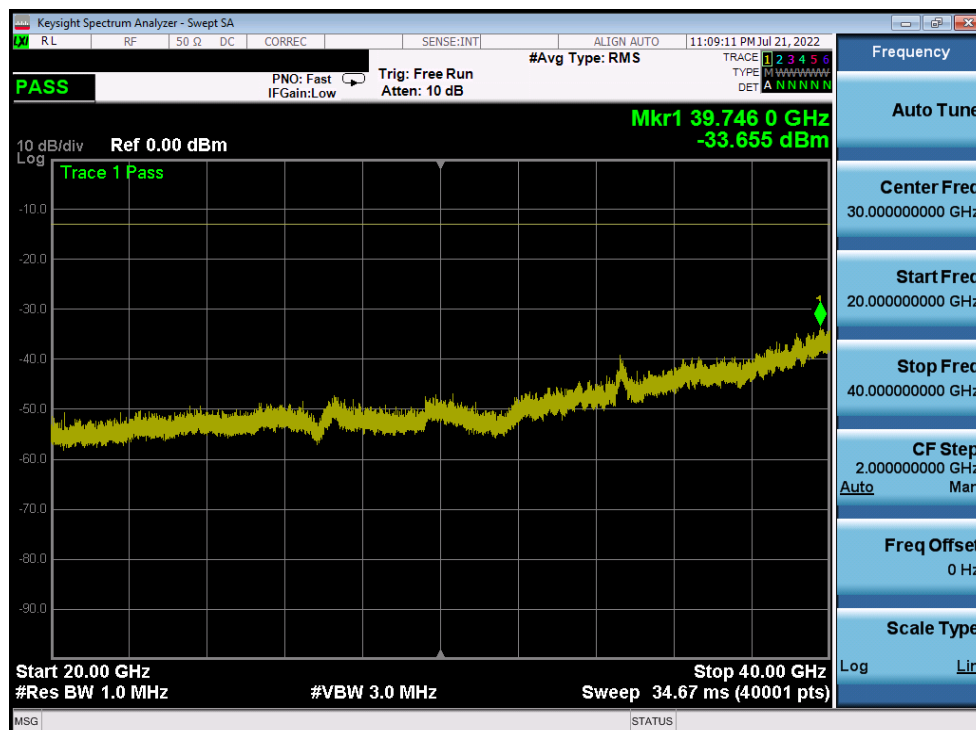

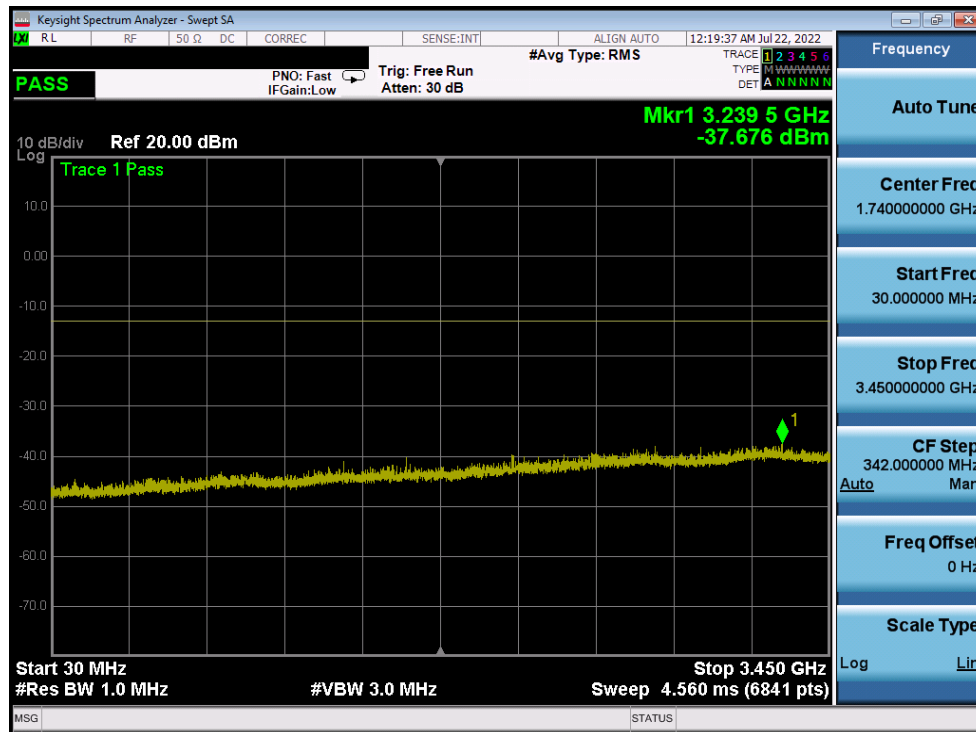

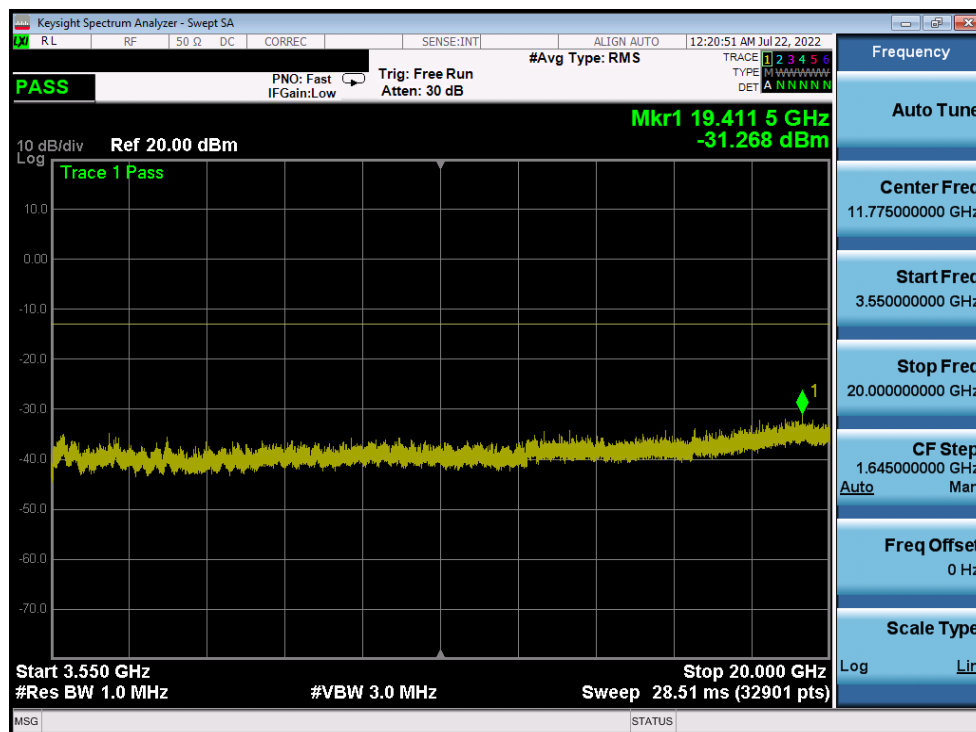

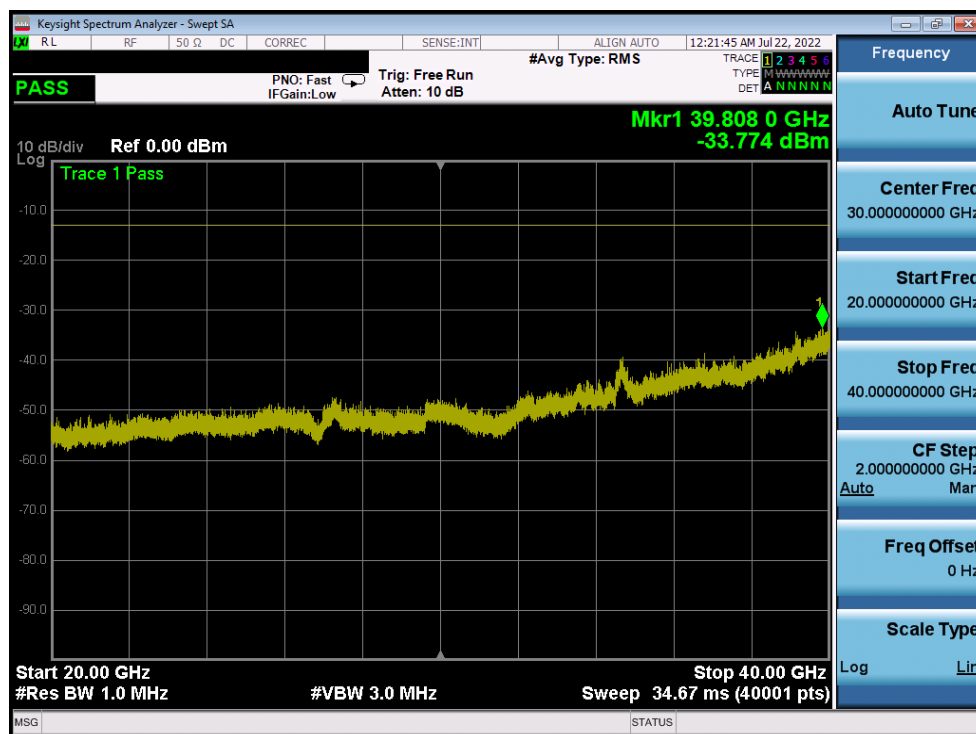

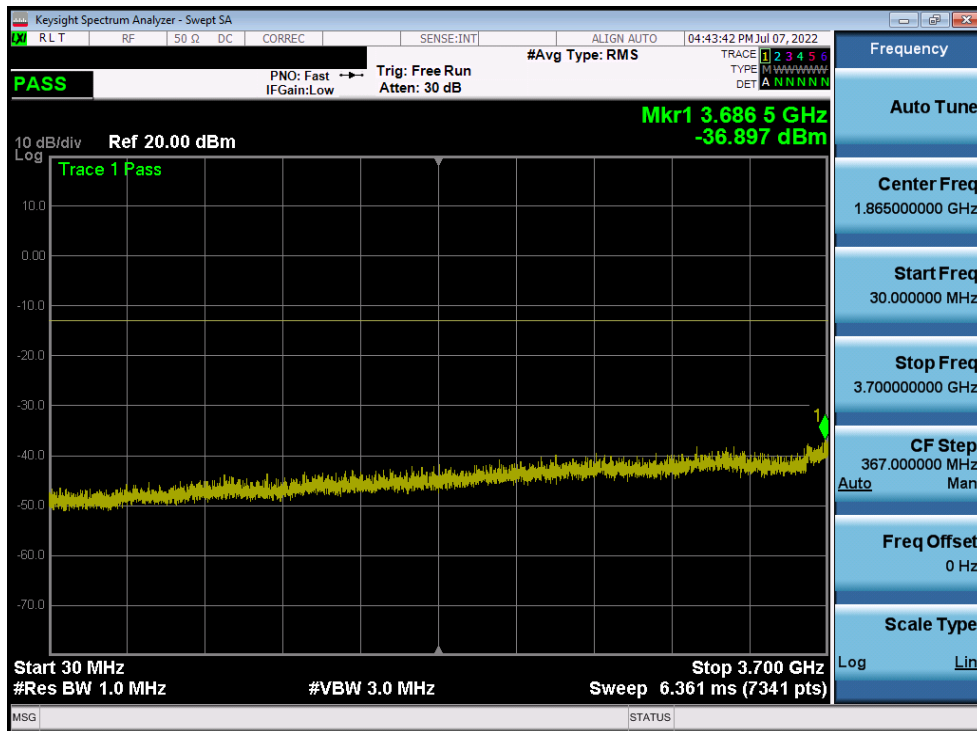

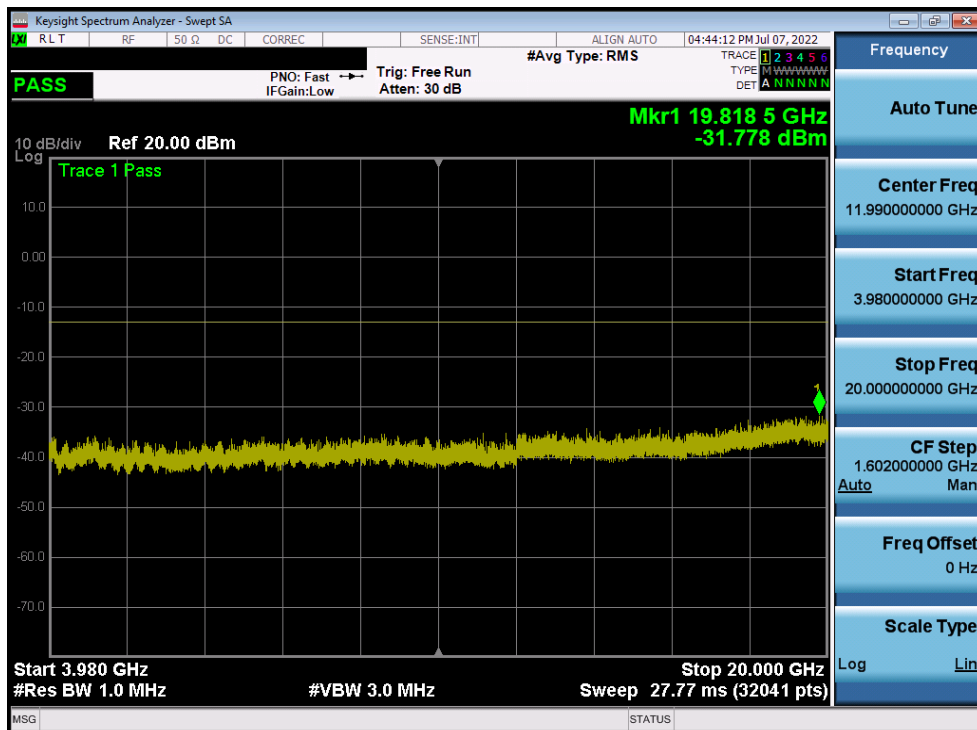

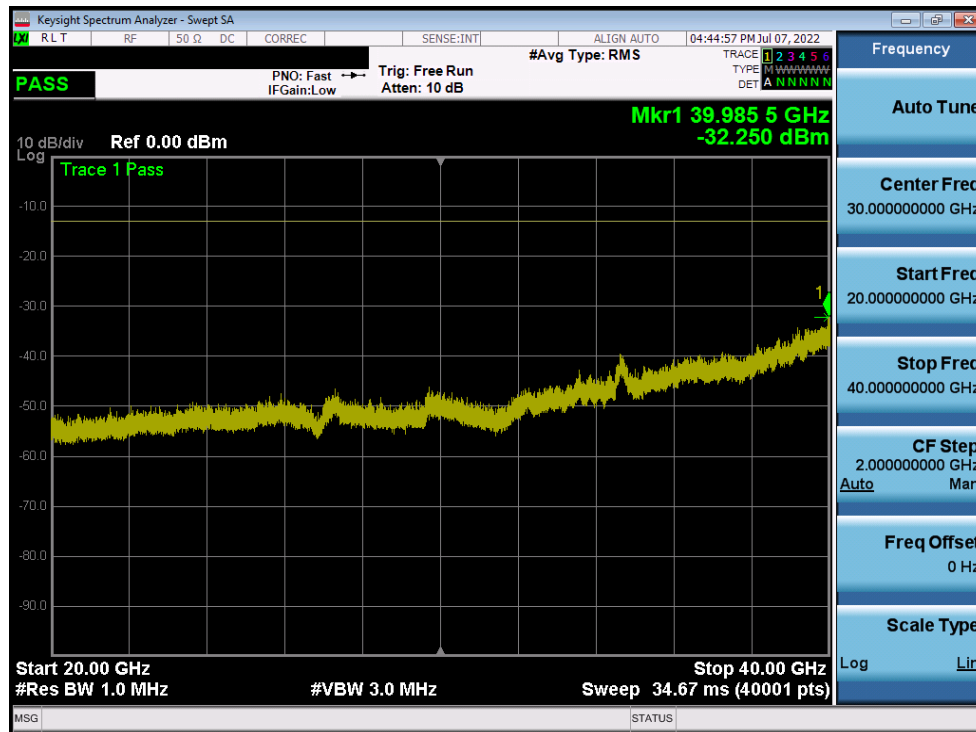

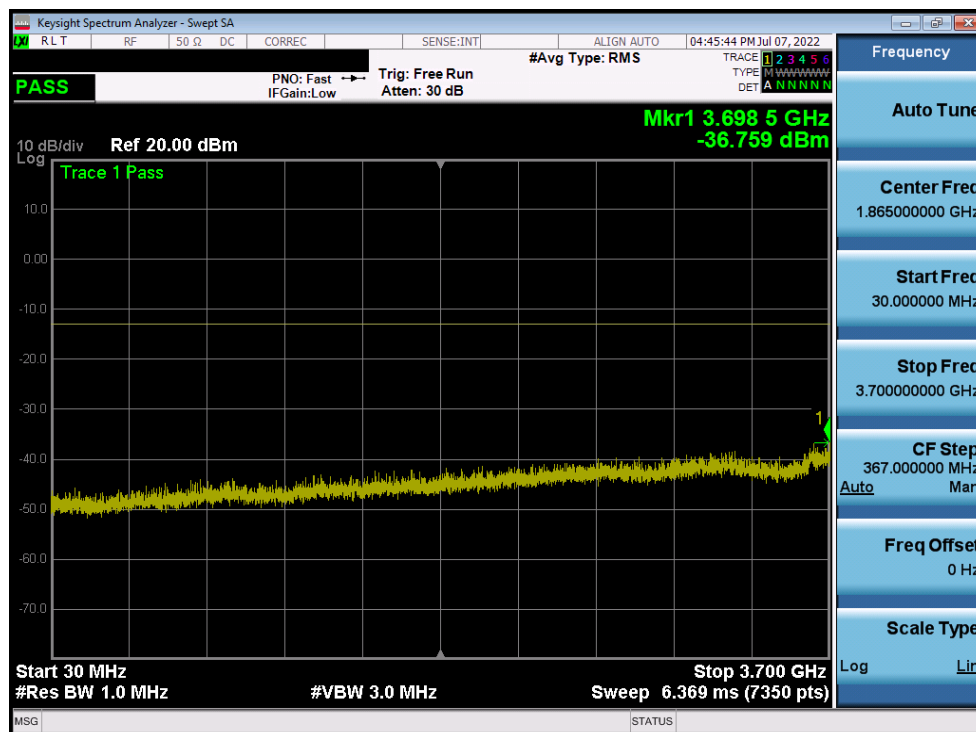

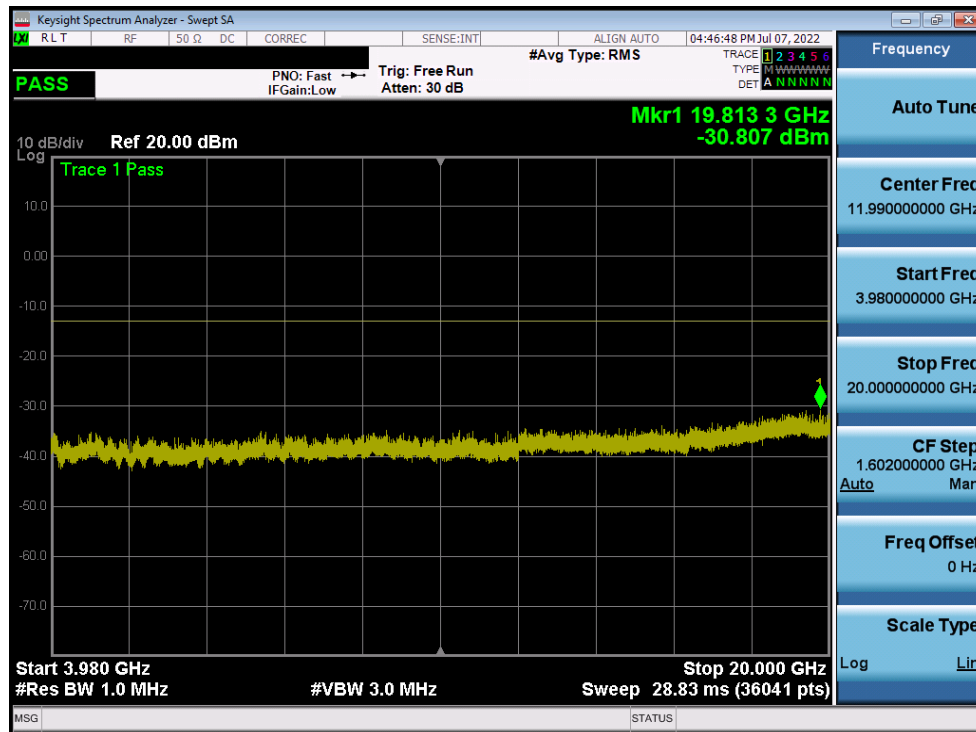

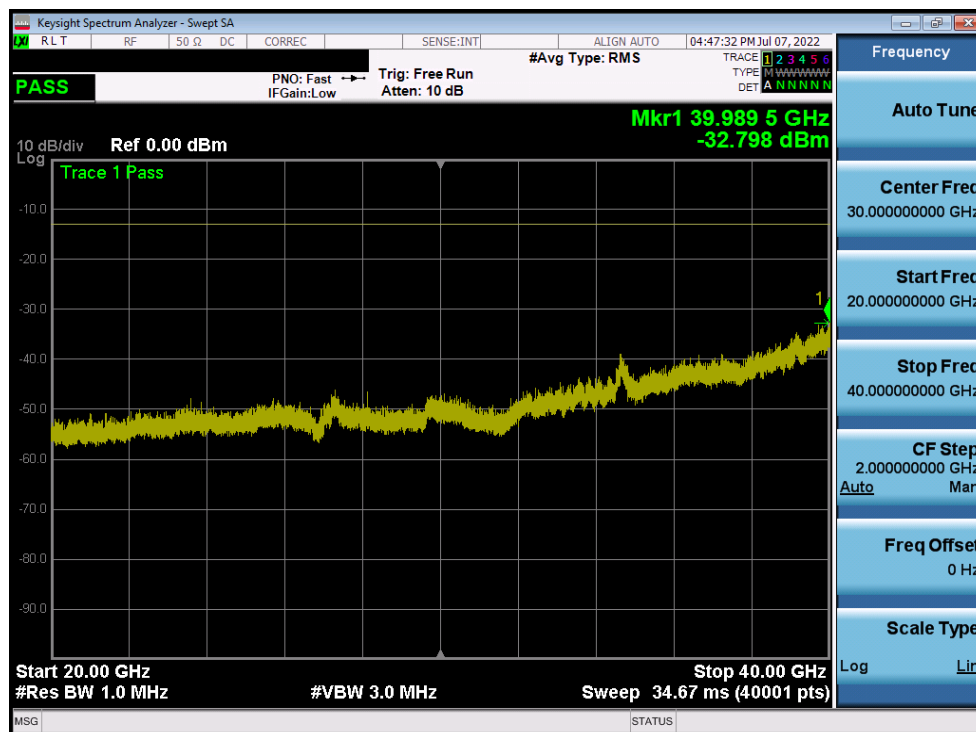

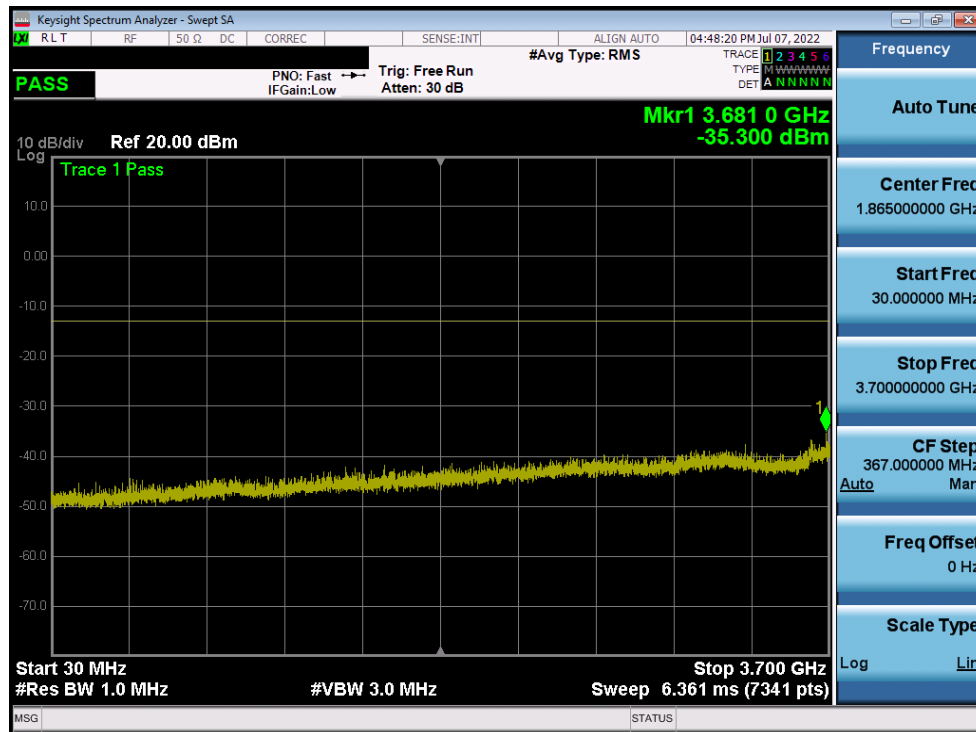

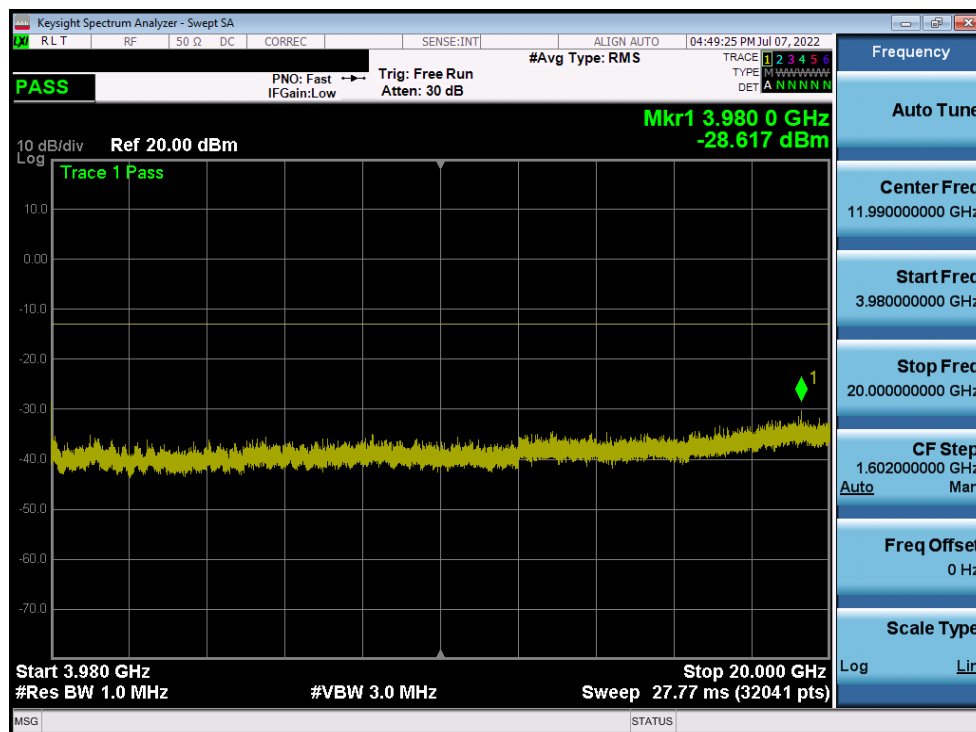

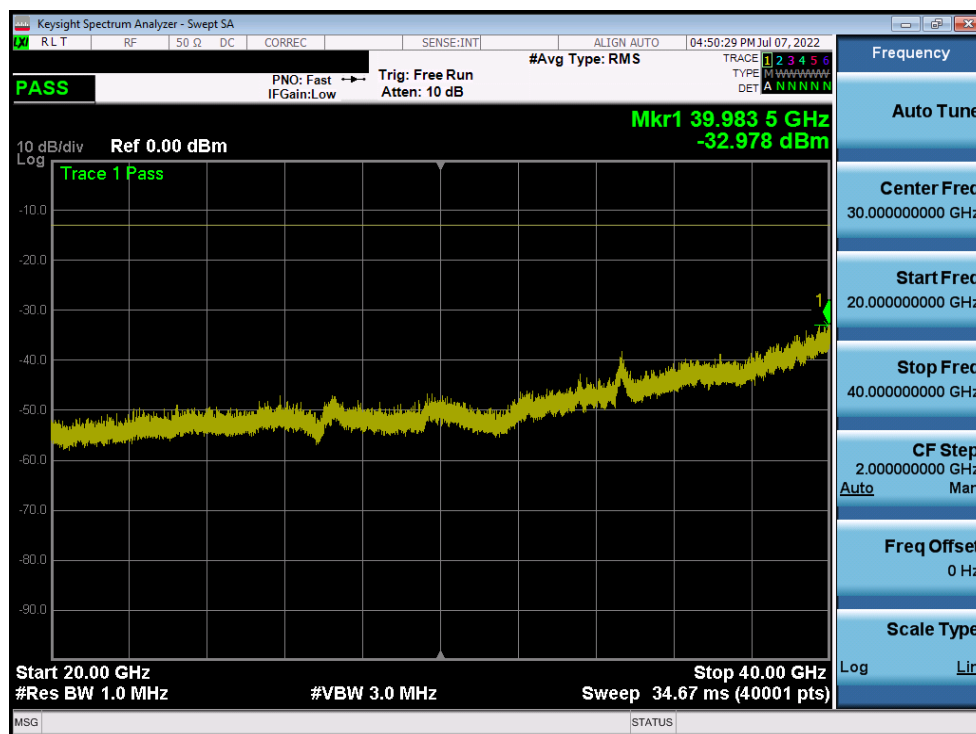

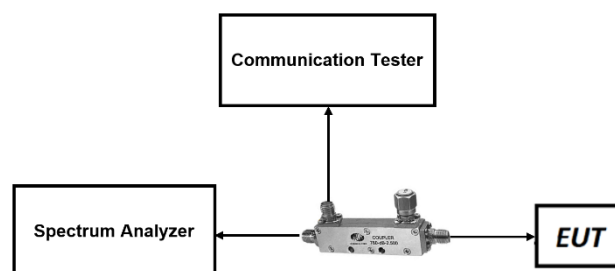




Figure 7-3. Test Instrument & Measurement Setup

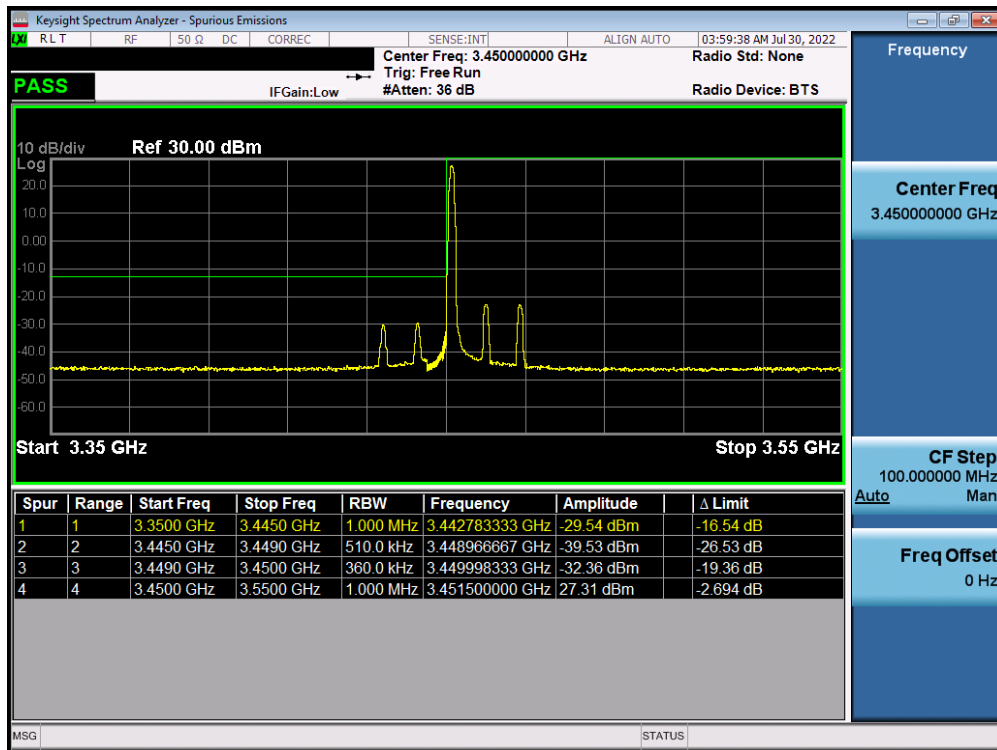

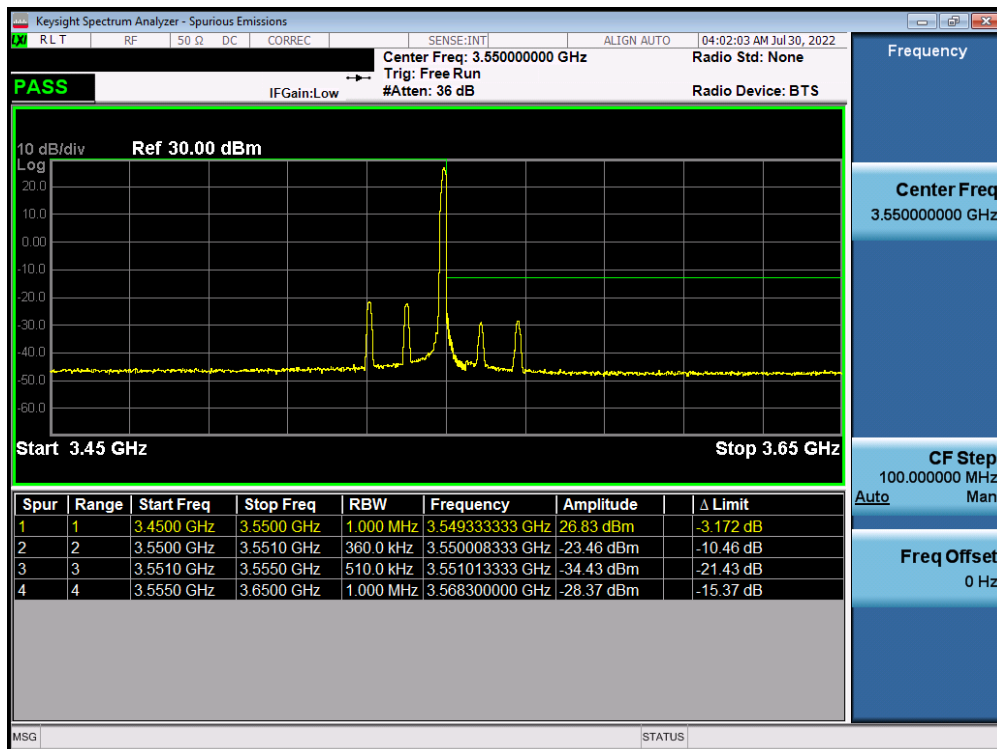

Plot 7-109. Lower ACP Plot (NR Band n77 - 20MHz DFT-s-OFDM $\pi/2$ BPSK – 1RB)

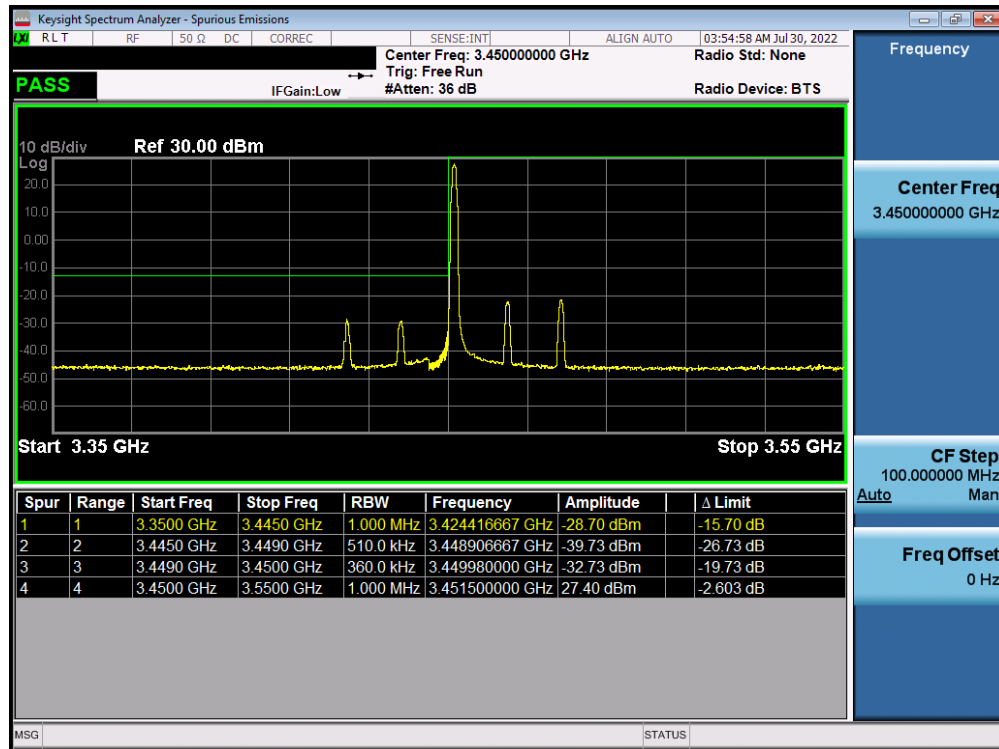


Plot 7-110. Upper ACP Plot (NR Band n77 - 20MHz DFT-s-OFDM $\pi/2$ BPSK – 1RB)

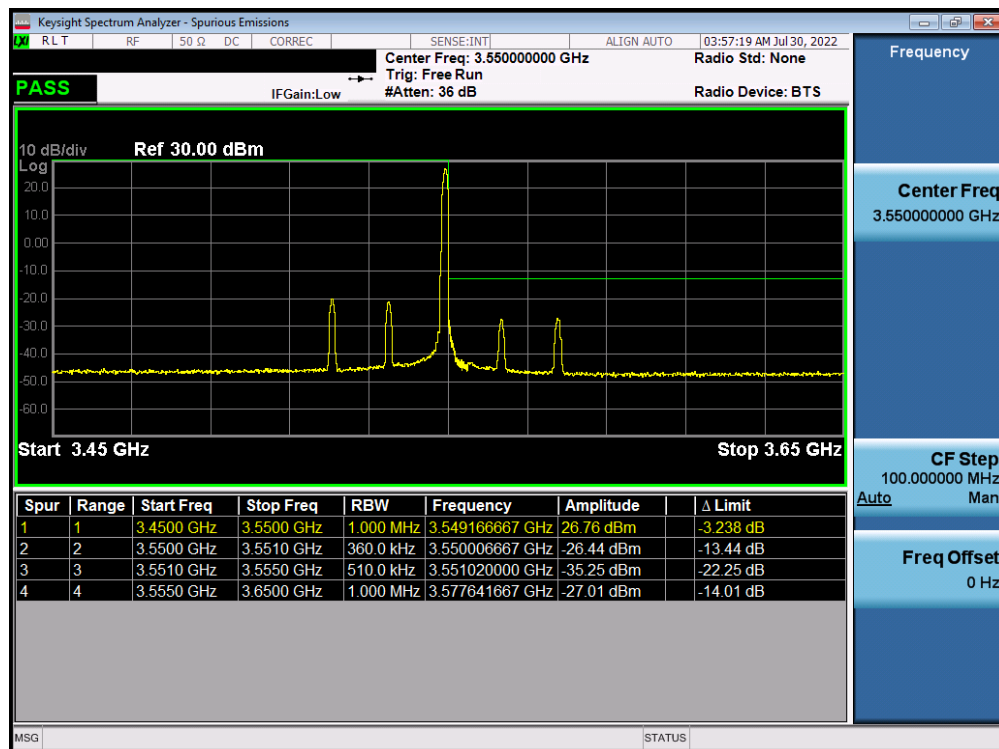

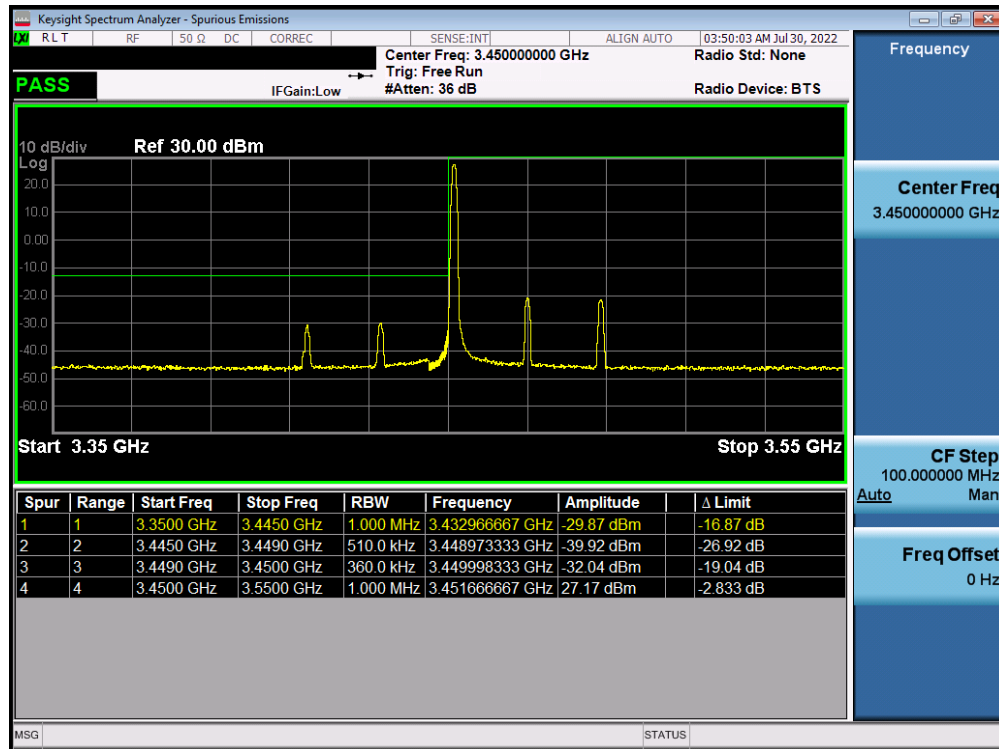
Plot 7-111. Lower ACP Plot (NR Band n77 - 30MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)



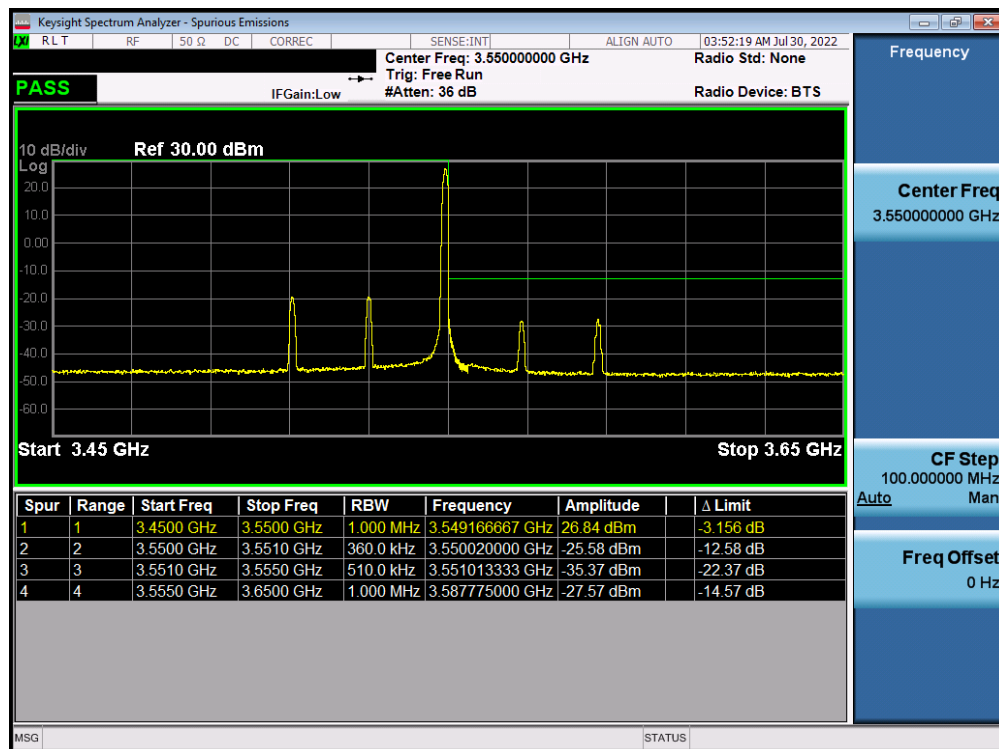
Plot 7-112. Upper ACP Plot (NR Band n77 - 30MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)

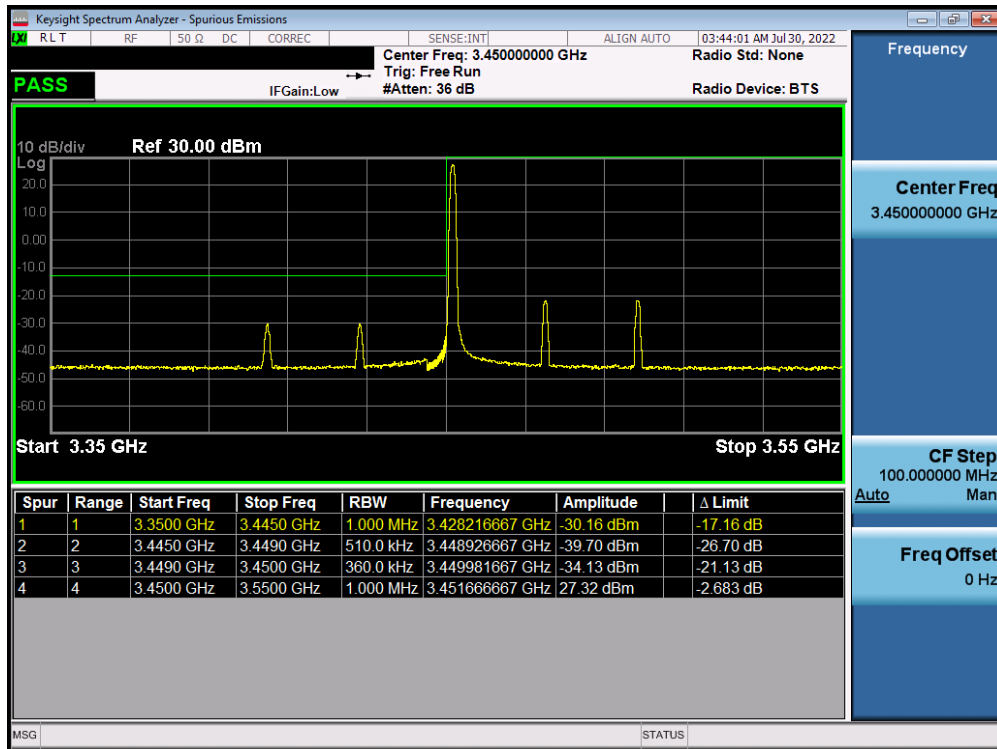
Plot 7-113. Lower ACP Plot (NR Band n77 - 40MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)



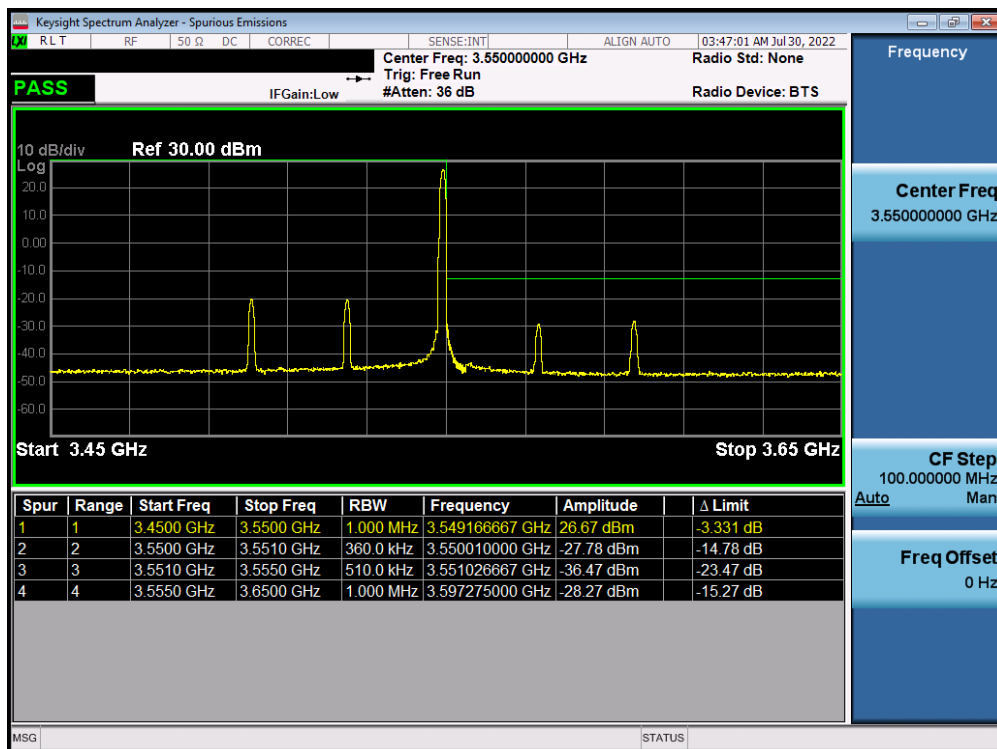
Plot 7-114. Upper ACP Plot (NR Band n77 - 40MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)

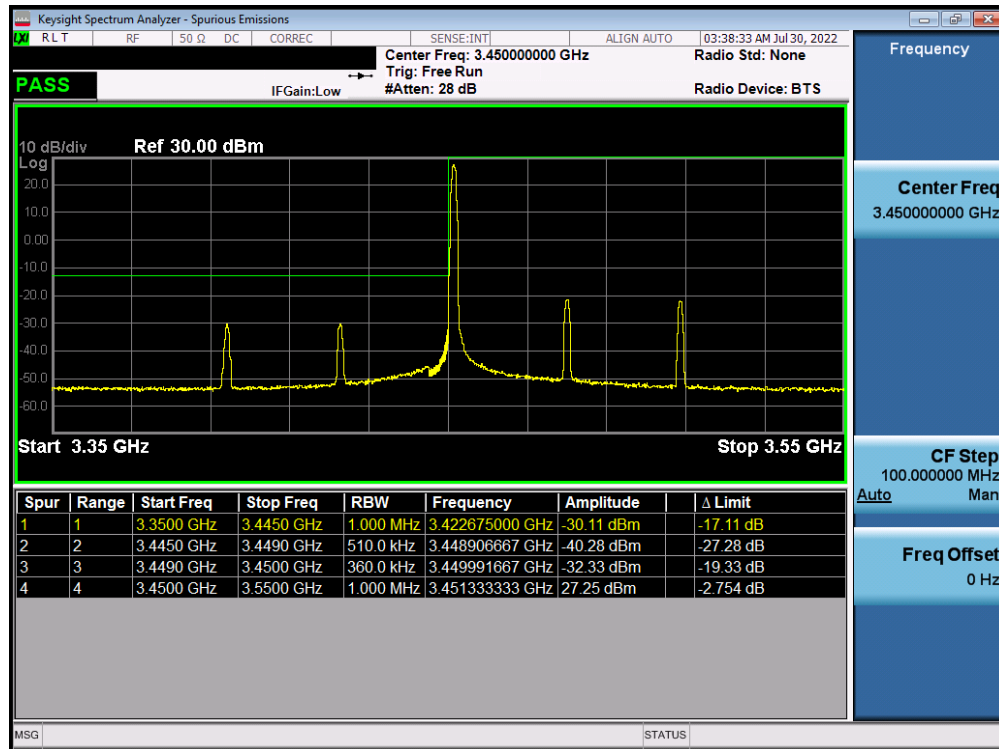
Plot 7-115. Lower ACP Plot (NR Band n77 - 50MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)



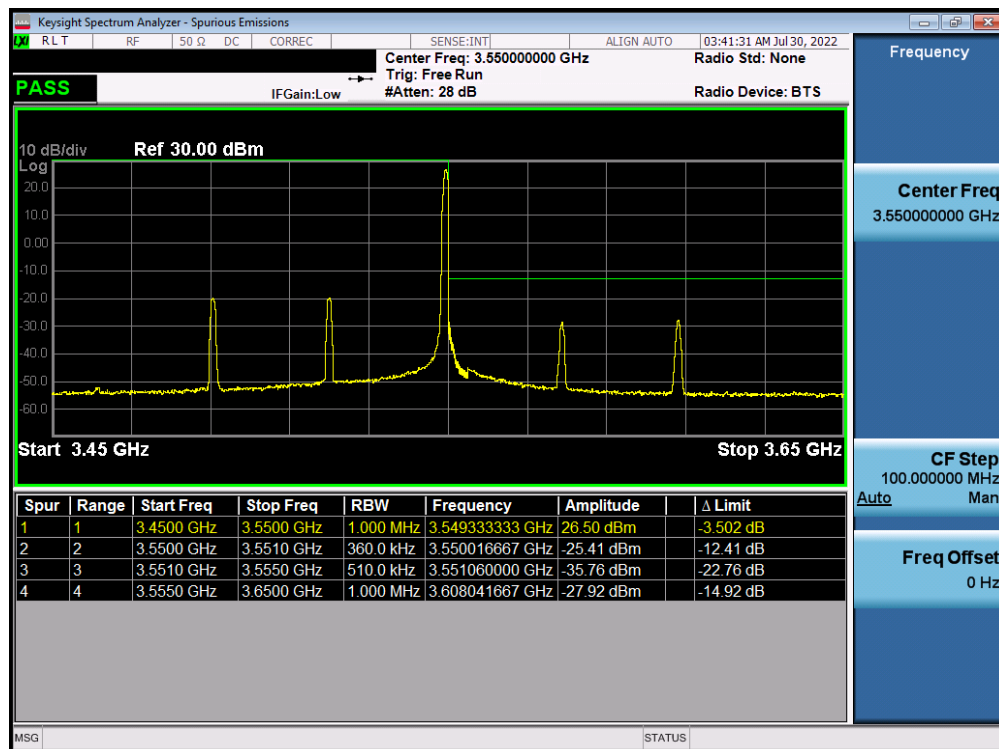
Plot 7-116. Upper ACP Plot (NR Band n77 - 50MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)

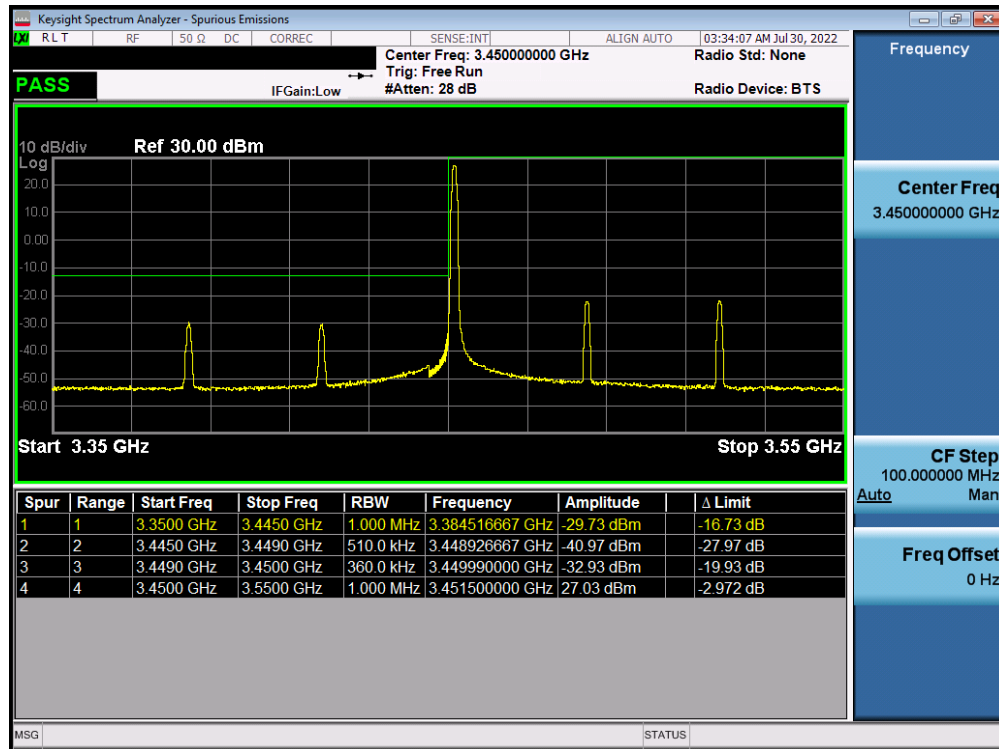


Plot 7-117. Lower ACP Plot (NR Band n77 - 60MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)

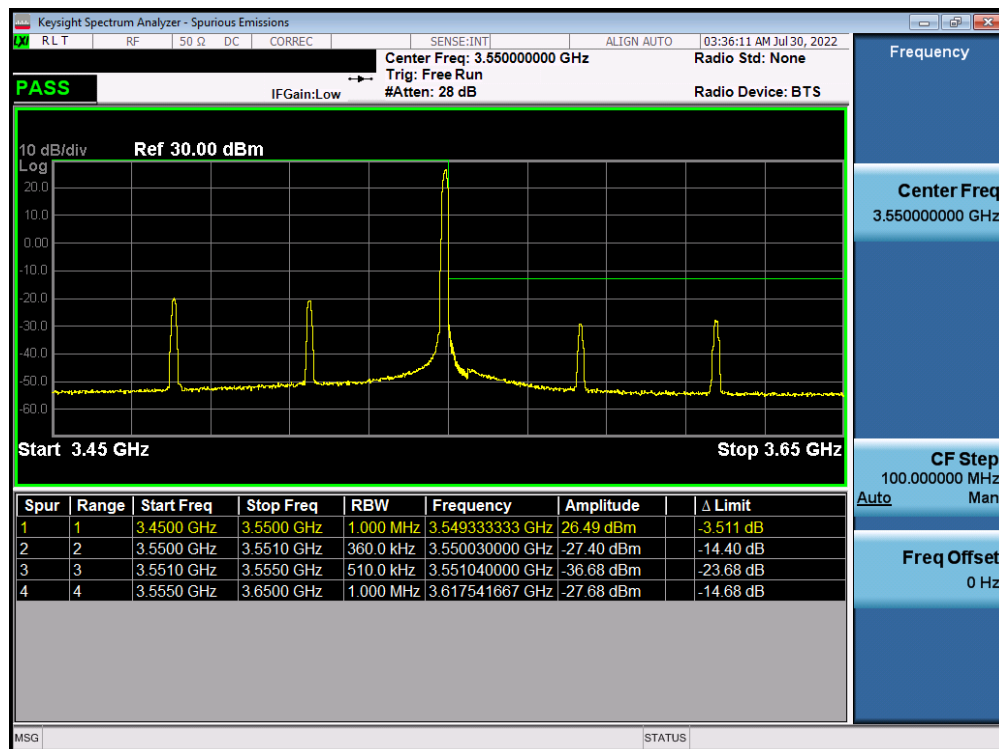


Plot 7-118. Upper ACP Plot (NR Band n77 - 60MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)

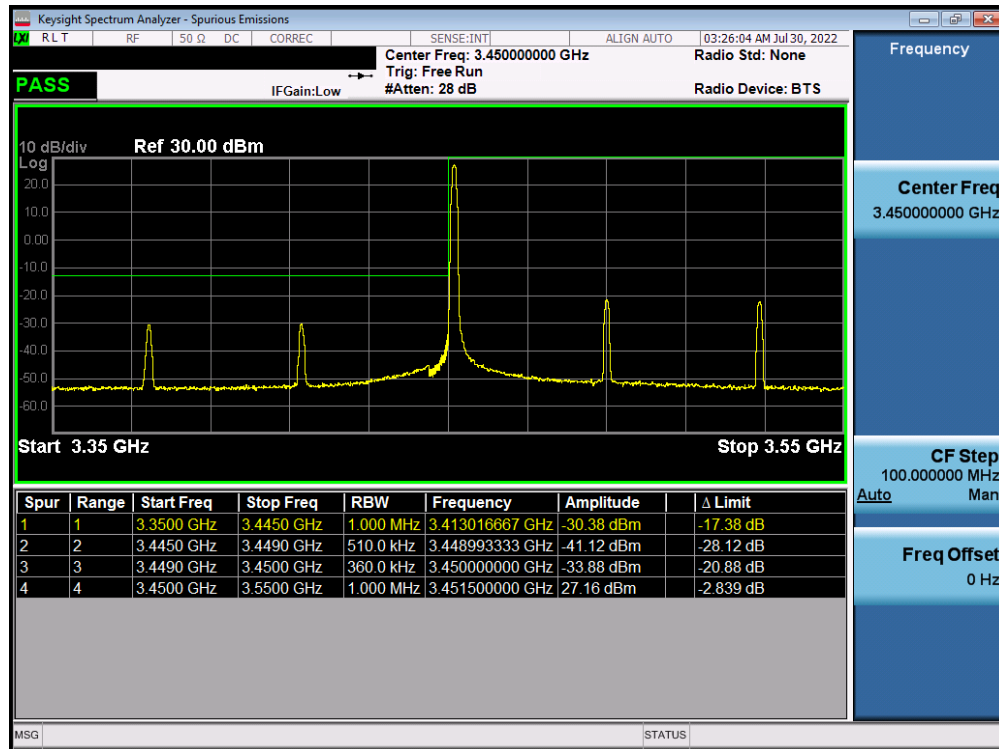


Plot 7-119. Lower ACP Plot (NR Band n77 - 70MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)

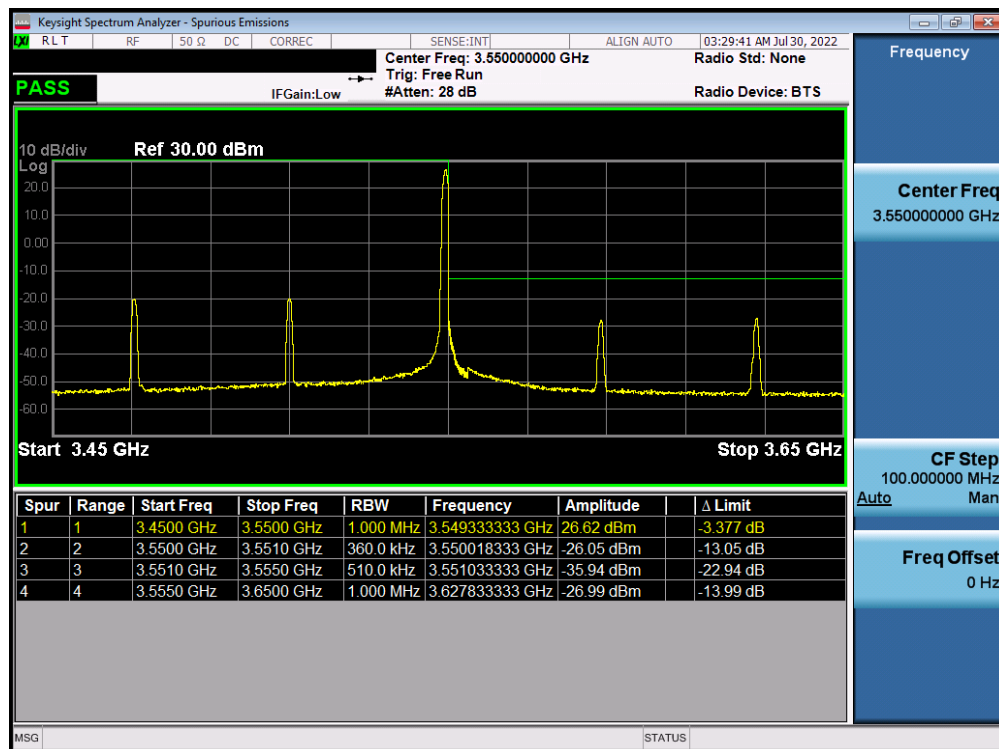


Plot 7-120. Upper ACP Plot (NR Band n77 - 70MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)

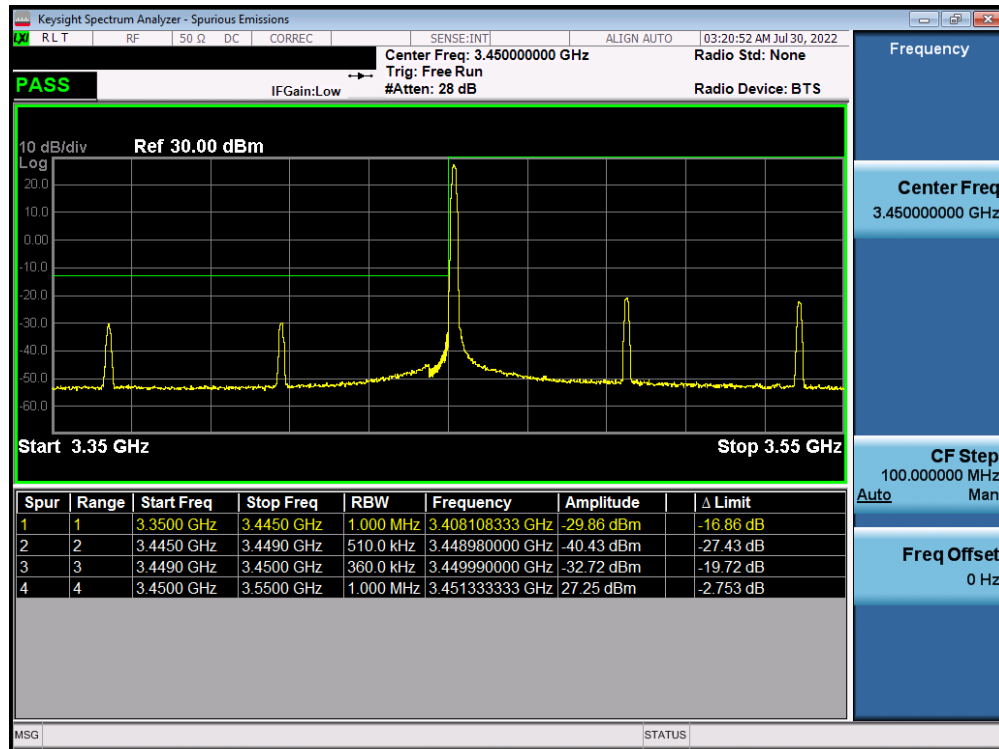


Plot 7-121. Lower ACP Plot (NR Band n77 - 80MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)

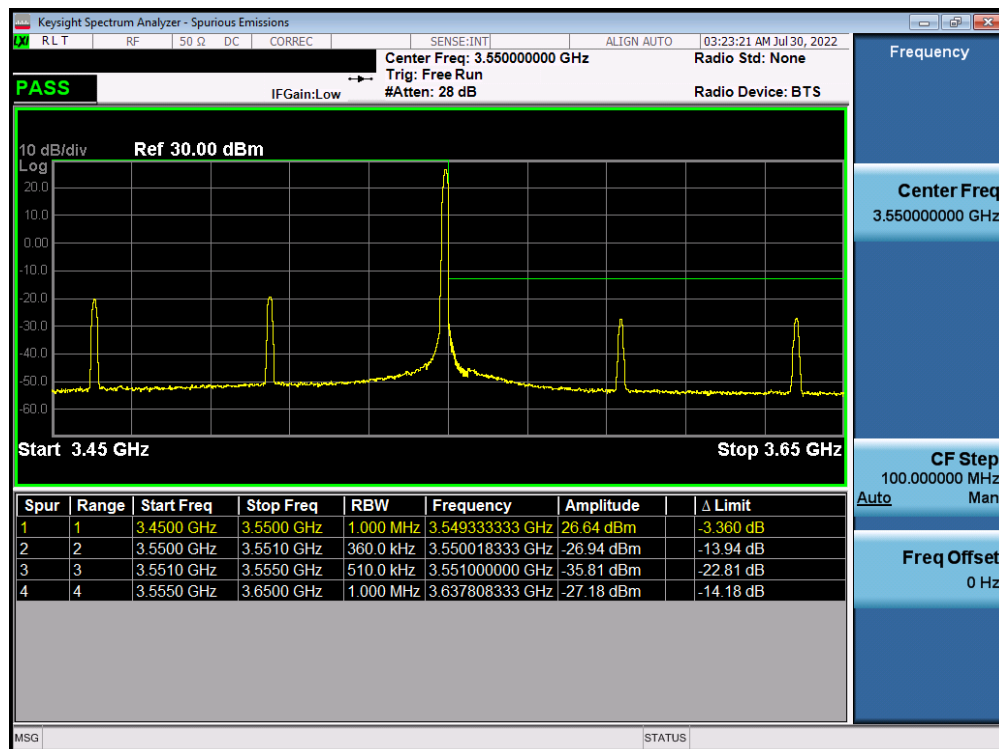


Plot 7-122. Upper ACP Plot (NR Band n77 - 80MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)

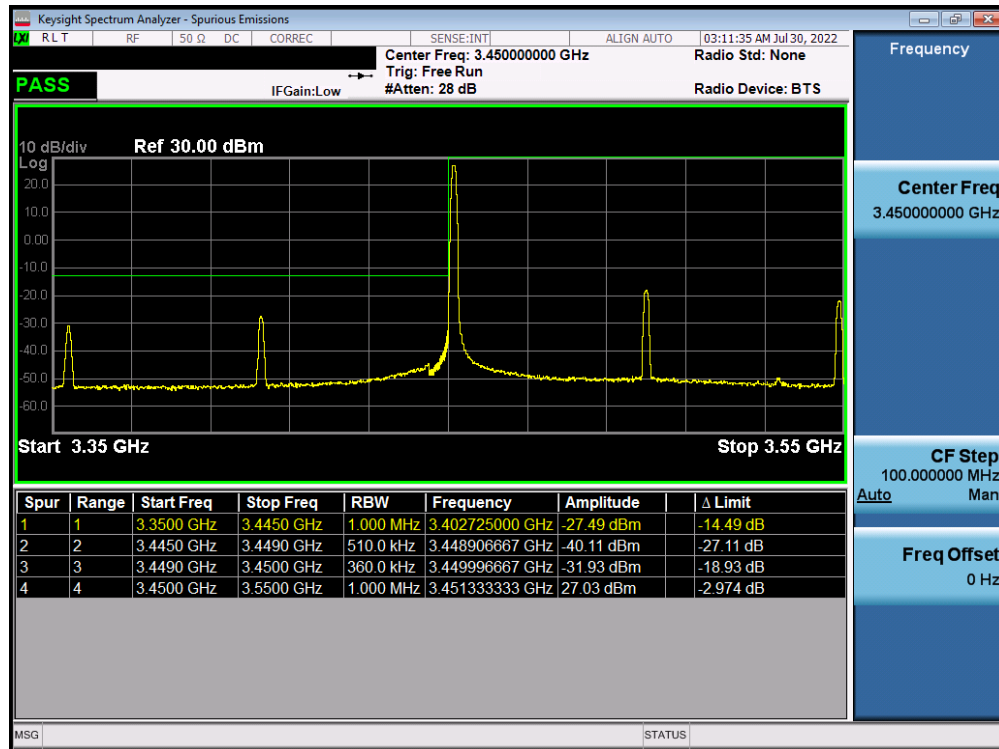


Plot 7-123. Lower ACP Plot (NR Band n77 - 90MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)

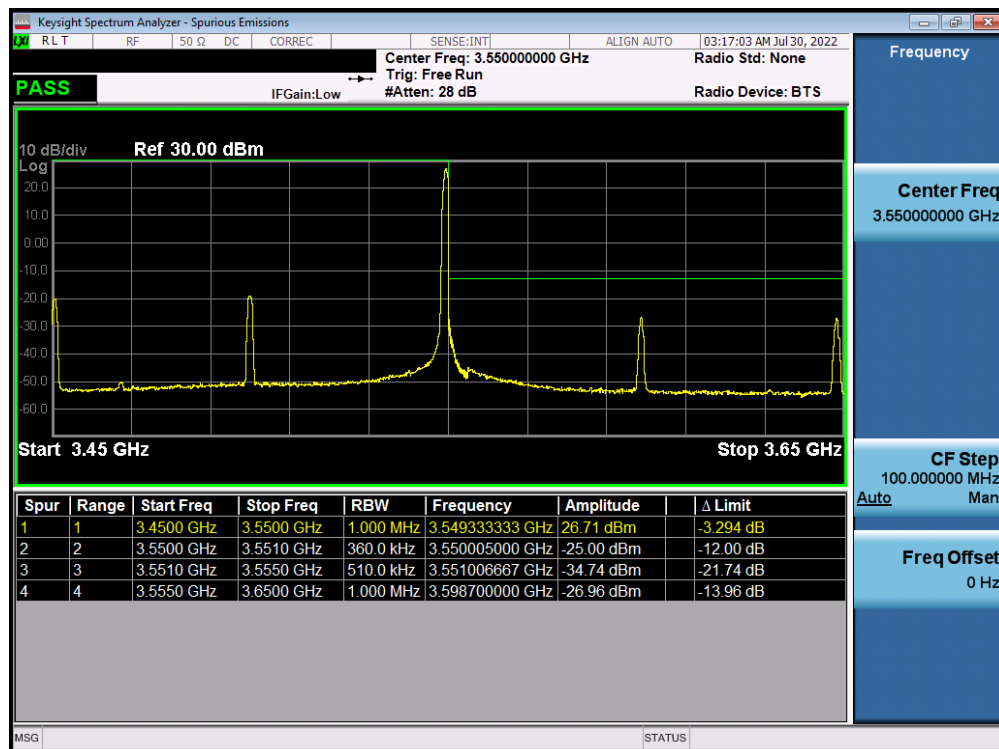


Plot 7-124. Upper ACP Plot (NR Band n77 - 90MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)

Plot 7-125. Lower ACP Plot (NR Band n77 - 100MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)

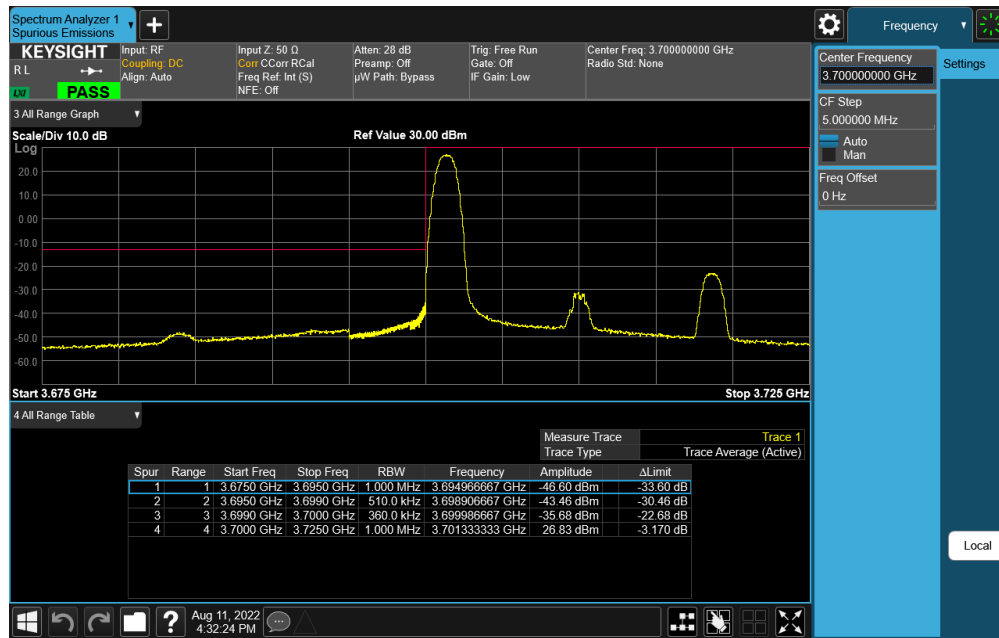


Plot 7-126. Upper ACP Plot (NR Band n77 - 100MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)

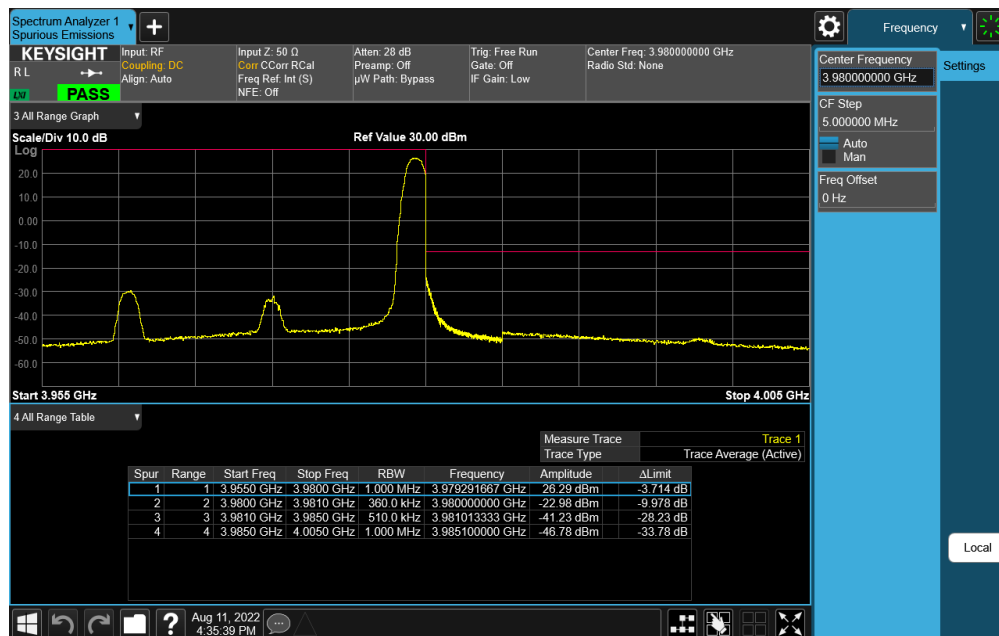

Plot 7-127. Lower ACP Plot (NR Band n77 - 20MHz DFT-s-OFDM $\pi/2$ BPSK – 1RB)

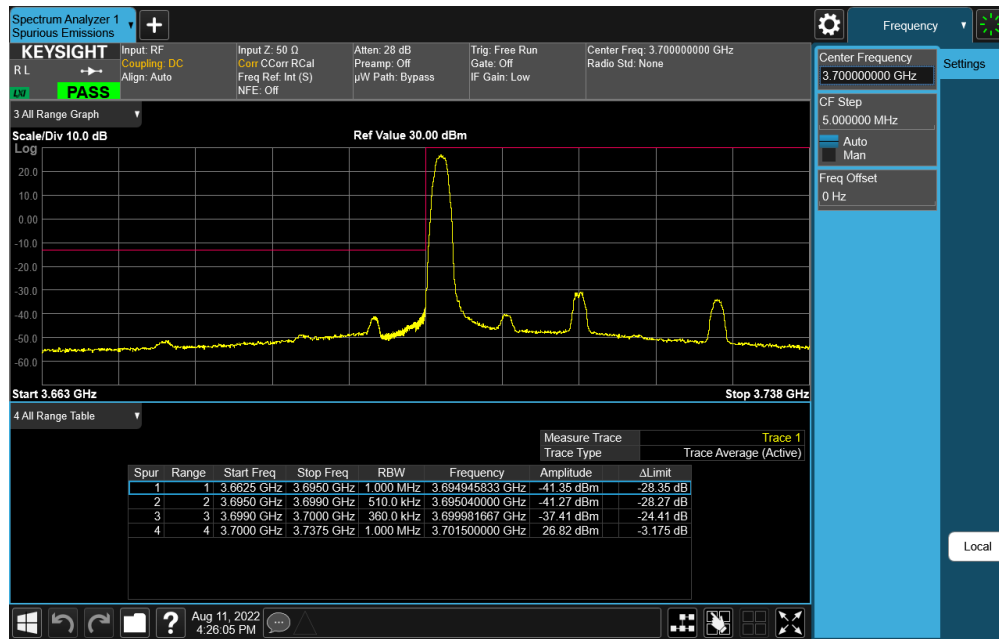


Plot 7-128. Upper ACP Plot (NR Band n77 - 20MHz DFT-s-OFDM $\pi/2$ BPSK – 1RB)

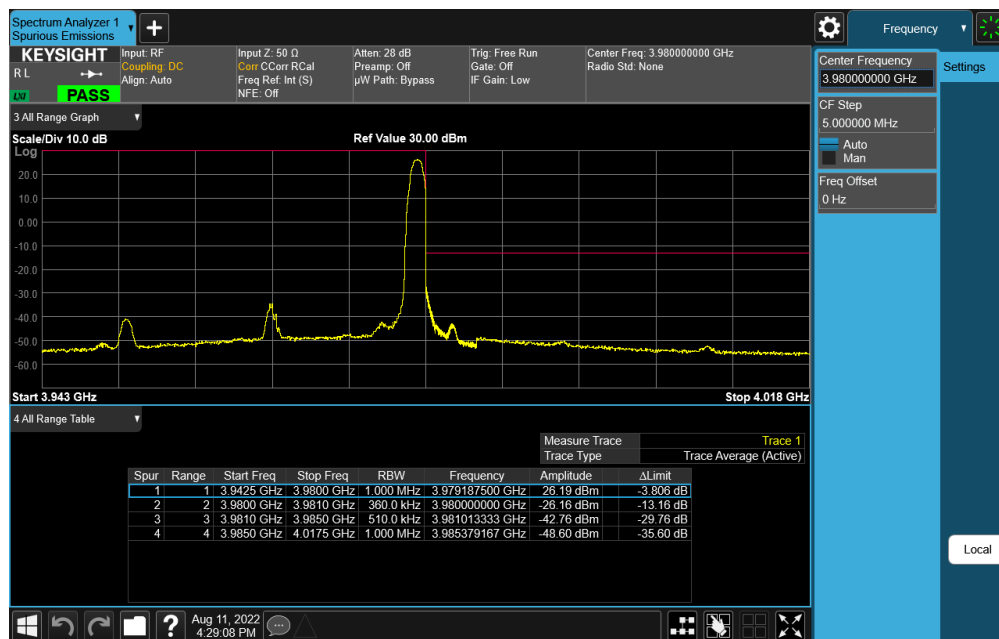

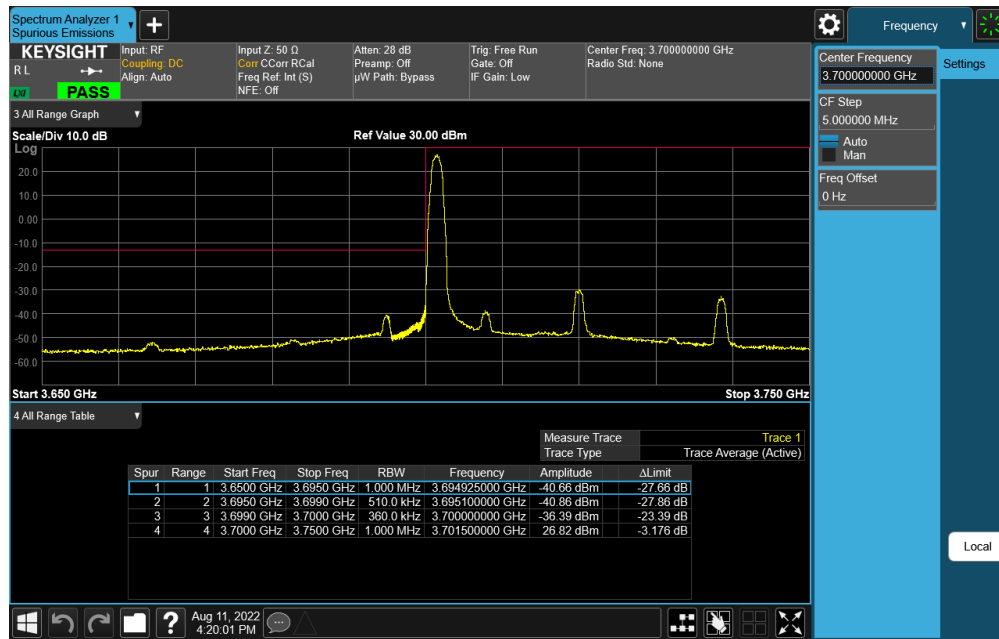


Plot 7-129. Lower ACP Plot (NR Band n77 - 30MHz DFT-s-OFDM QPSK – 1RB)

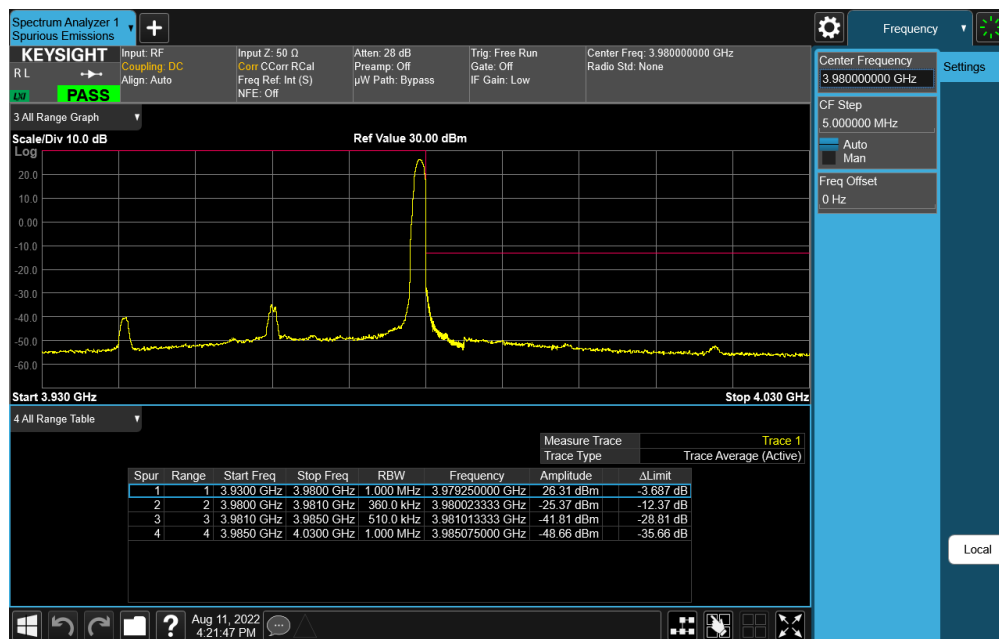


Plot 7-130. Upper ACP Plot (NR Band n77 - 30MHz DFT-s-OFDM $\pi/2$ BPSK – 1RB)

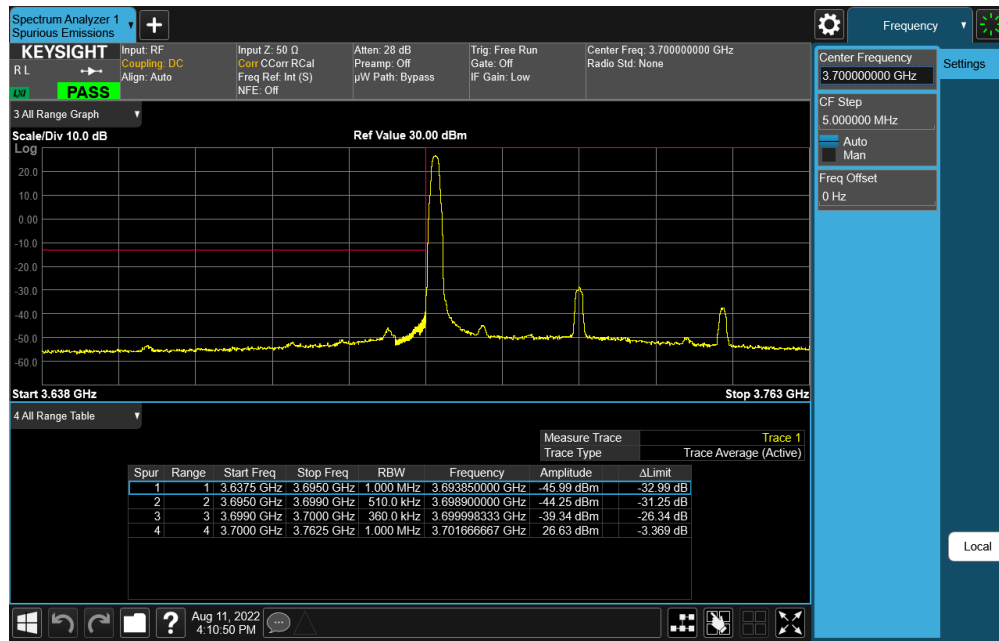


Plot 7-131. Lower ACP Plot (NR Band n77 - 40MHz DFT-s-OFDM QPSK – 1RB)

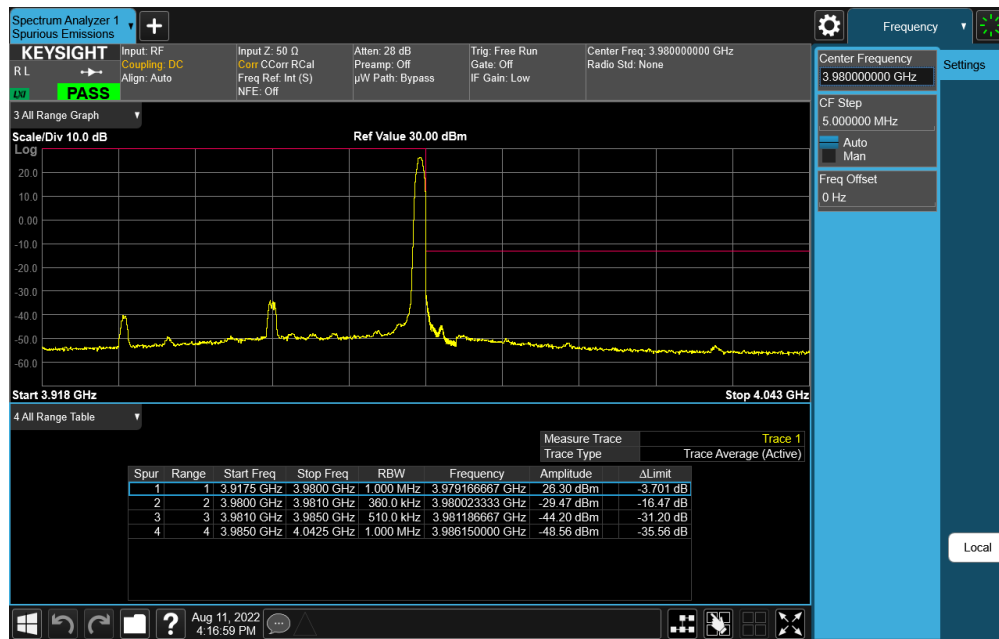


Plot 7-132. Upper ACP Plot (NR Band n77 - 40MHz DFT-s-OFDM $\pi/2$ BPSK – 1RB)

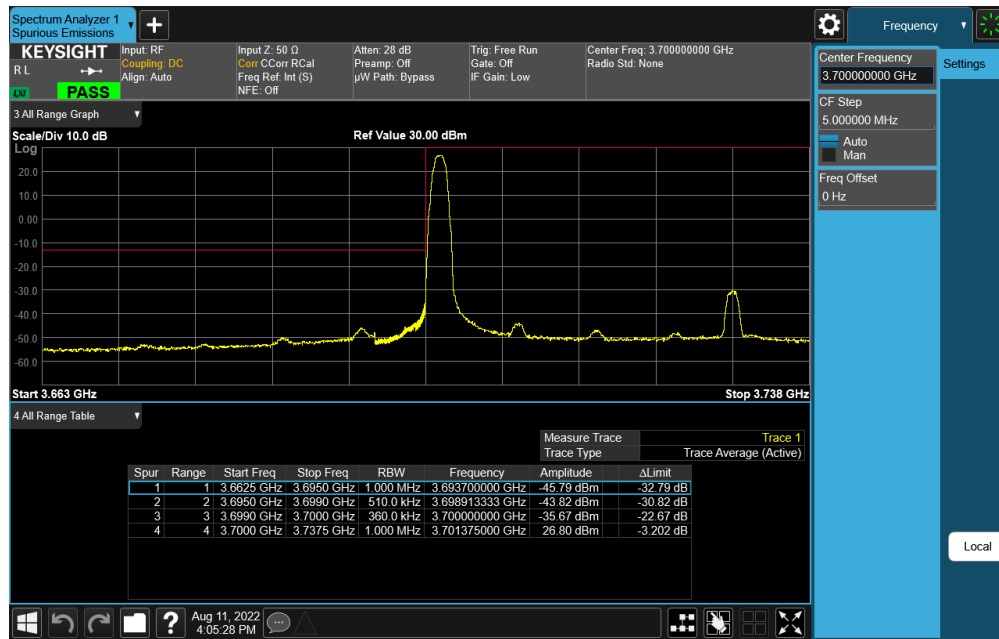


Plot 7-133. Lower ACP Plot (NR Band n77 - 50MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)

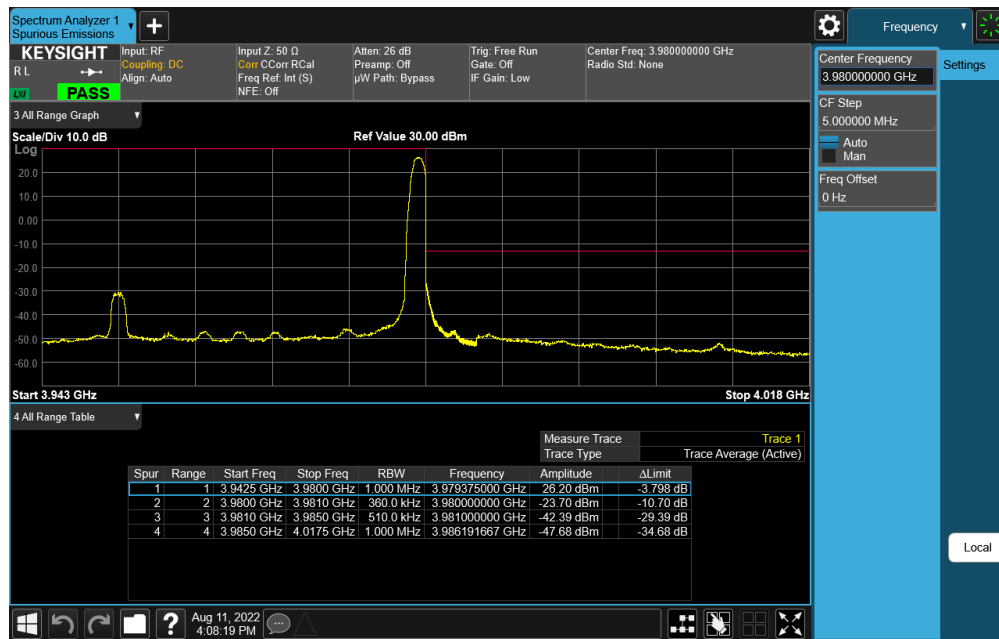


Plot 7-134. Upper ACP Plot (NR Band n77 - 50MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)

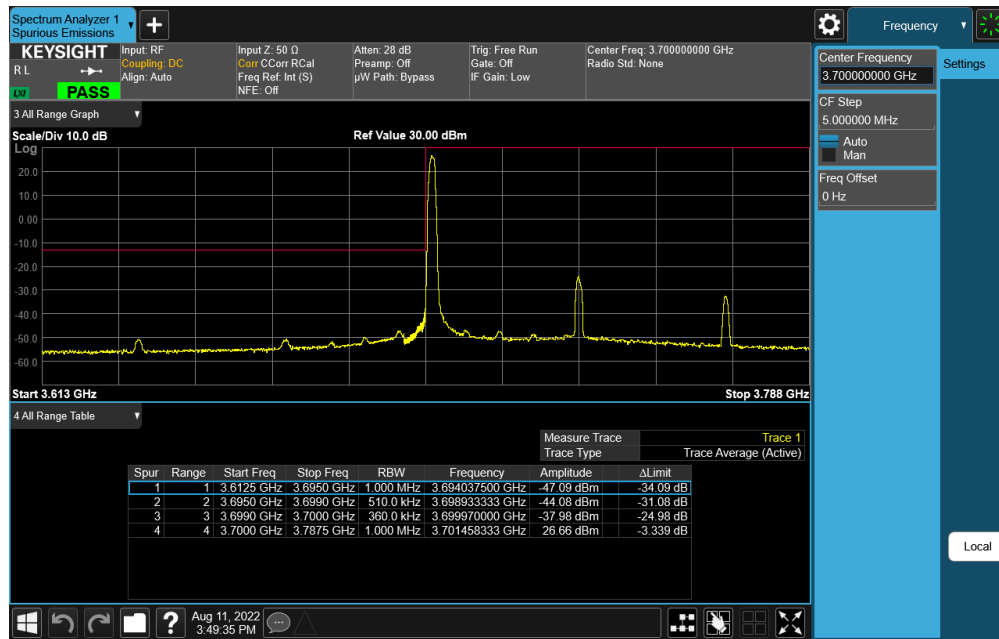


Plot 7-135. Lower ACP Plot (NR Band n77 - 60MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)

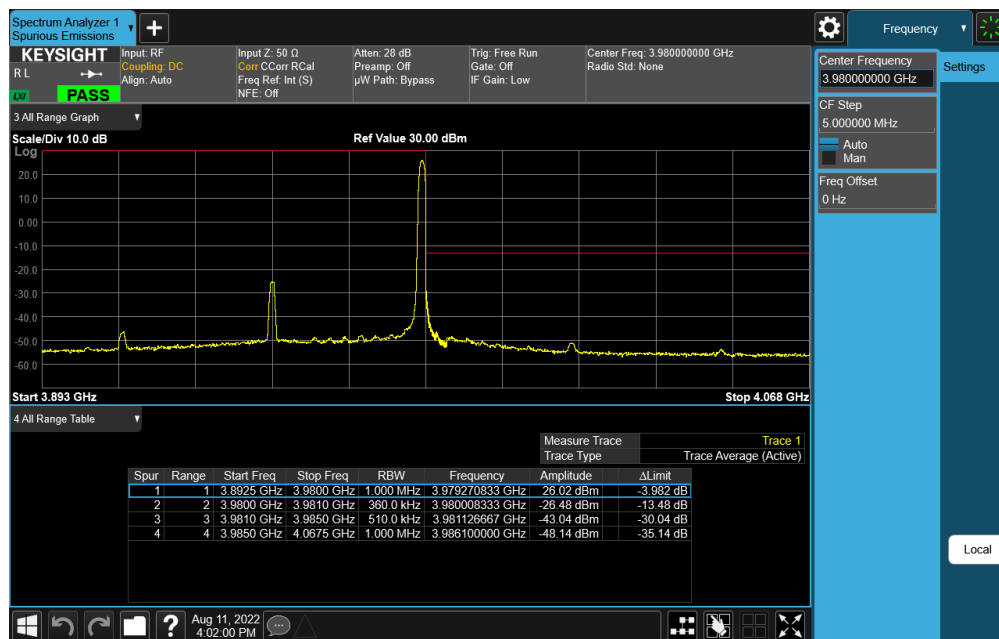


Plot 7-136. Upper ACP Plot (NR Band n77 - 60MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)

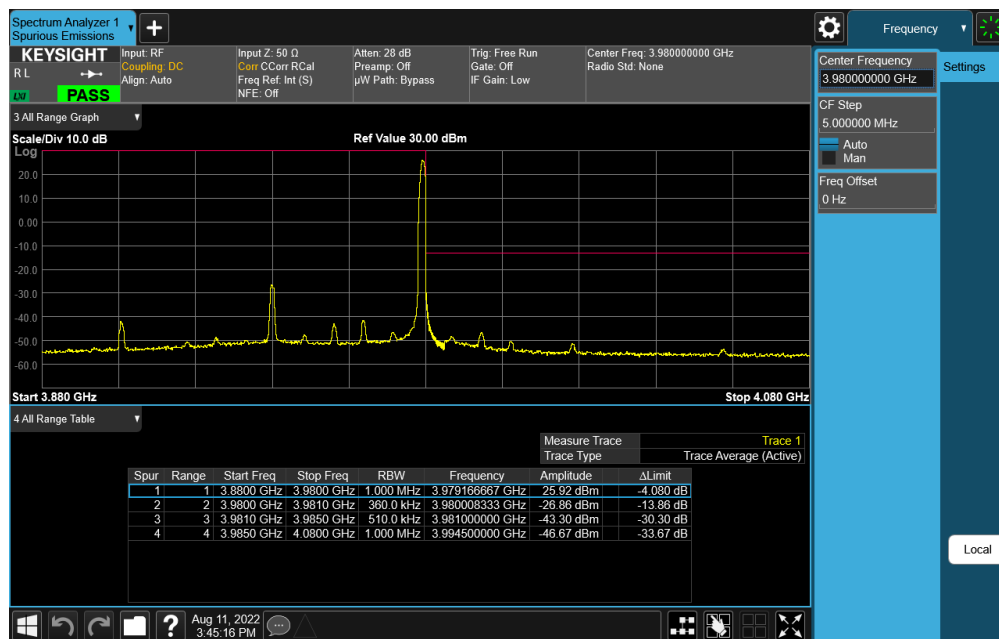
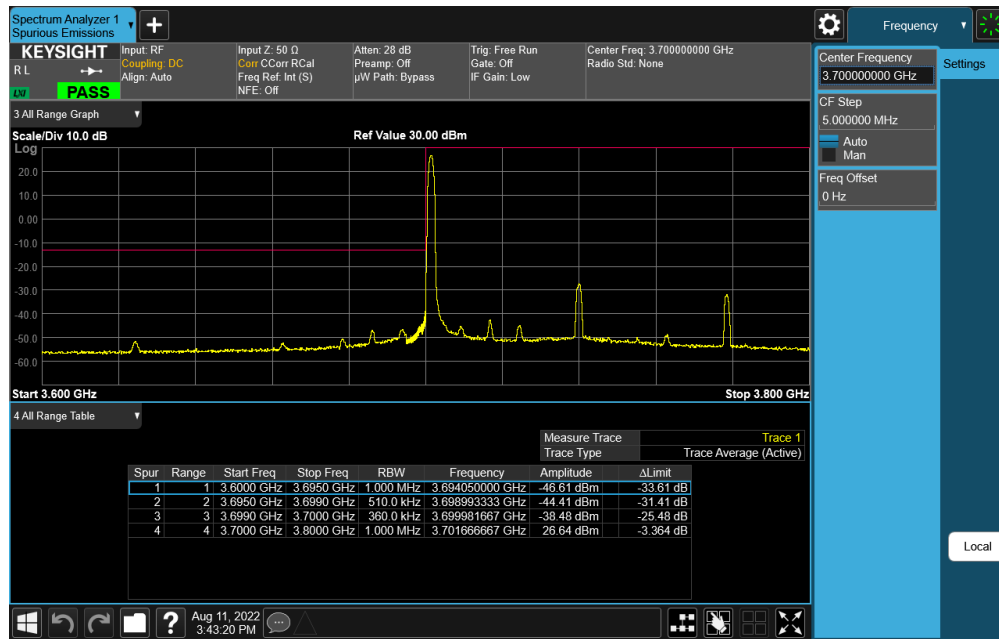


Plot 7-137. Lower ACP Plot (NR Band n77 - 70MHz DFT-s-OFDM QPSK – 1RB)

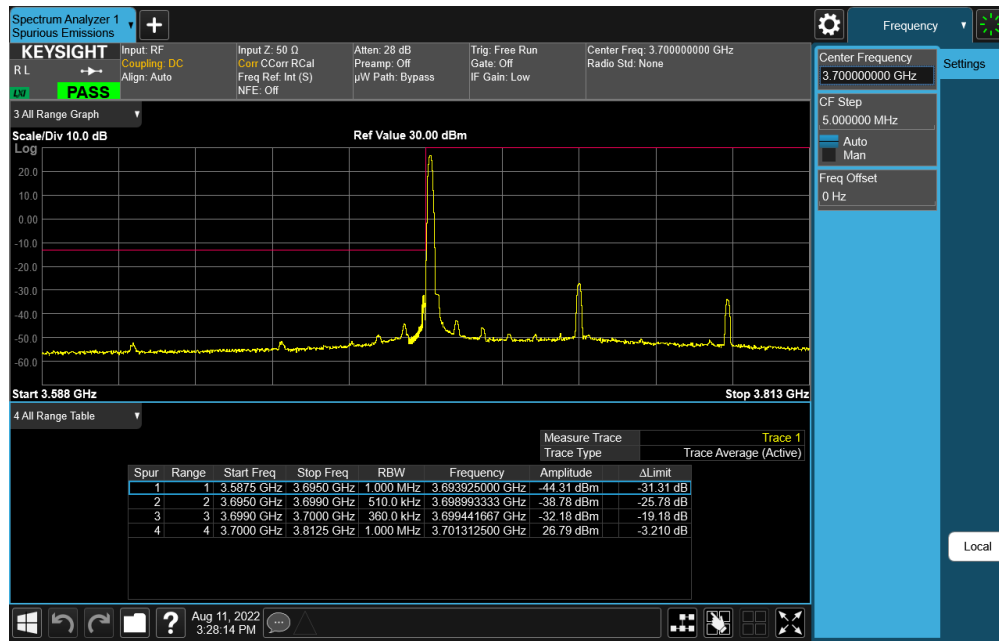


Plot 7-138. Upper ACP Plot (NR Band n77 - 70MHz DFT-s-OFDM $\pi/2$ BPSK – 1RB)

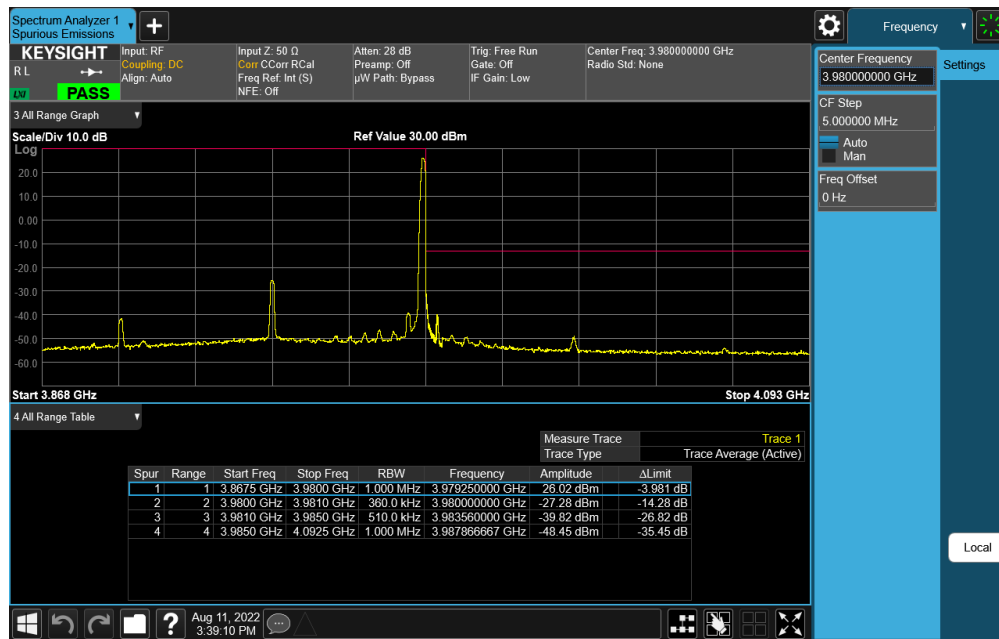

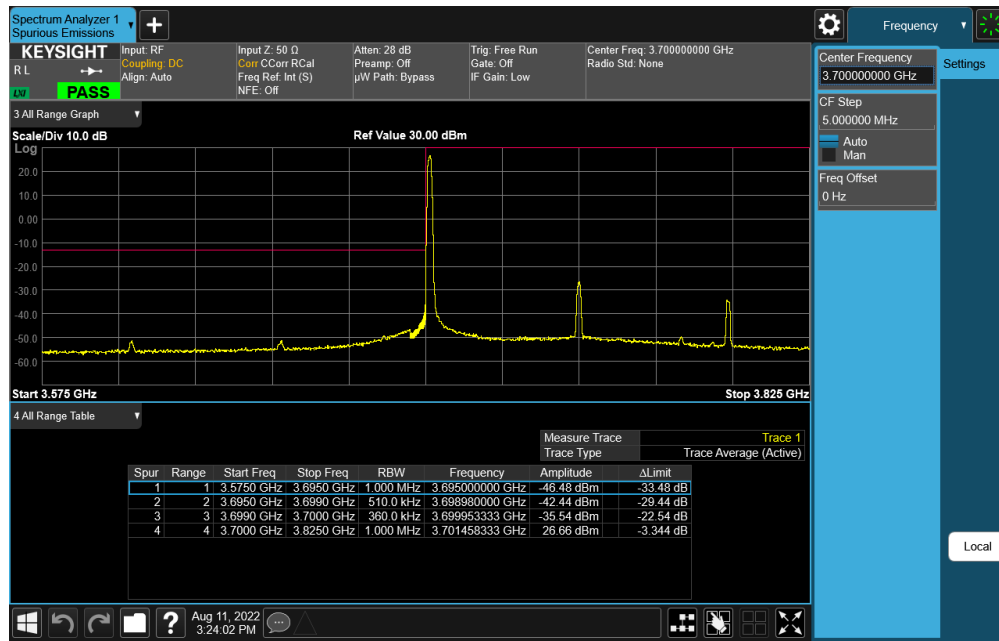


Plot 7-141. Lower ACP Plot (NR Band n77 - 90MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)

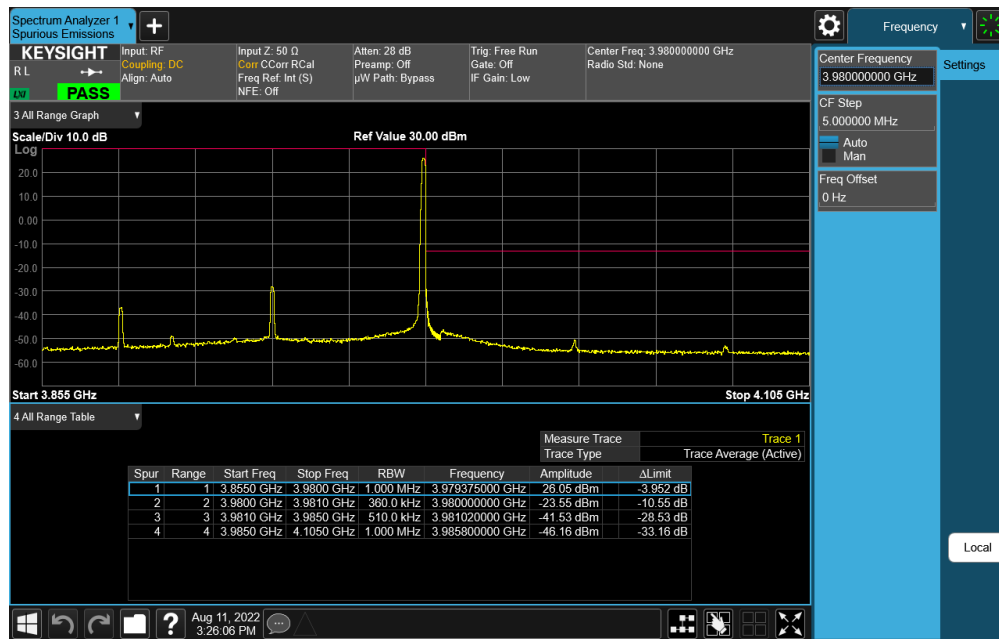


Plot 7-142. Upper ACP Plot (NR Band n77 - 90MHz DFT-s-OFDM $\pi/2$ BPSK - 1RB)

7.5 Peak-Average Ratio

§27.50(k)(4), §27.50(j)(4):

Test Overview

A peak to average ratio measurement is performed at the conducted port of the EUT. The spectrum analyzers Complementary Cumulative Distribution Function (CCDF) measurement profile is used to determine the largest deviation between the average and the peak power of the EUT in a given bandwidth. The CCDF curve shows how much time the peak waveform spends at or above a given average power level. The percent of time the signal spends at or above the level defines the probability for that particular power level. All ports were tested and only the worst case data were reported.

Test Procedure Used

KDB 971168 D01 v03r01 – Section 5.7.1

Test Settings

1. The signal analyzer's CCDF measurement profile is enabled
2. Frequency = carrier center frequency
3. Measurement BW \geq OBW or specified reference bandwidth
4. The signal analyzer was set to collect one million samples to generate the CCDF curve
5. The measurement interval was set depending on the type of signal analyzed. For continuous signals (>98% duty cycle), the measurement interval was set to 1ms. For burst transmissions, the spectrum analyzer is set to use an internal "RF Burst" trigger that is synced with an incoming pulse and the measurement interval is set to less than the duration of the "on time" of one burst to ensure that energy is only captured during a time in which the transmitter is operating at maximum power

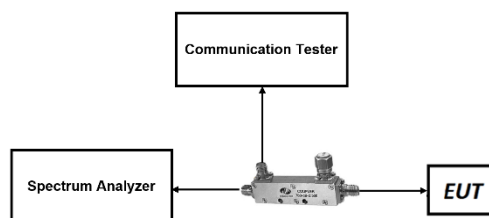



Figure 7-4. Test Instrument & Measurement Setup

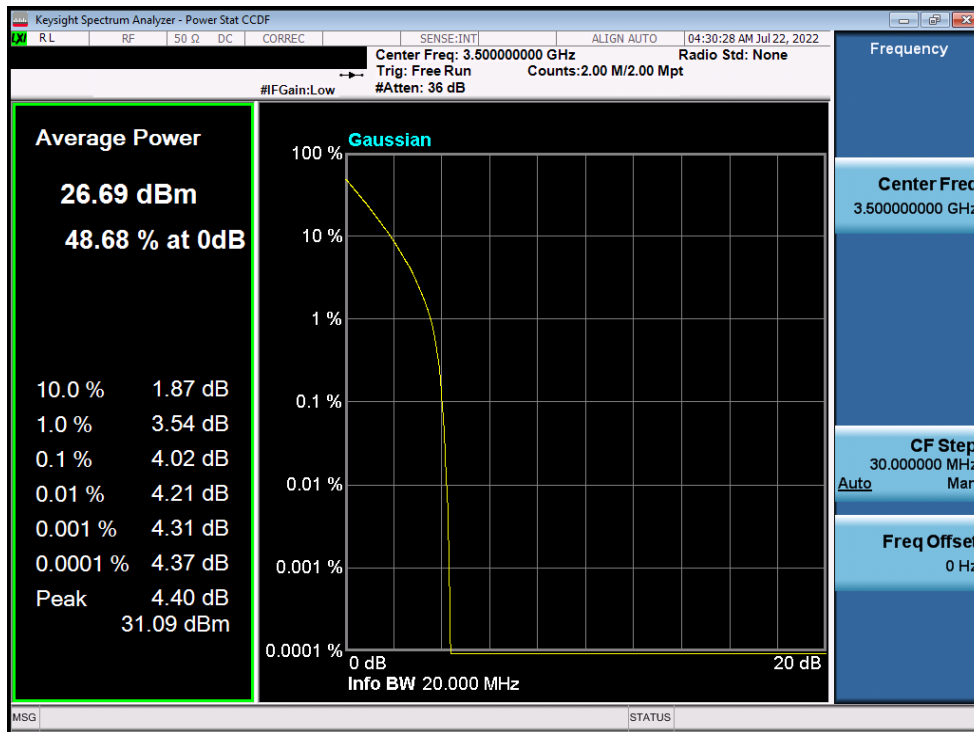

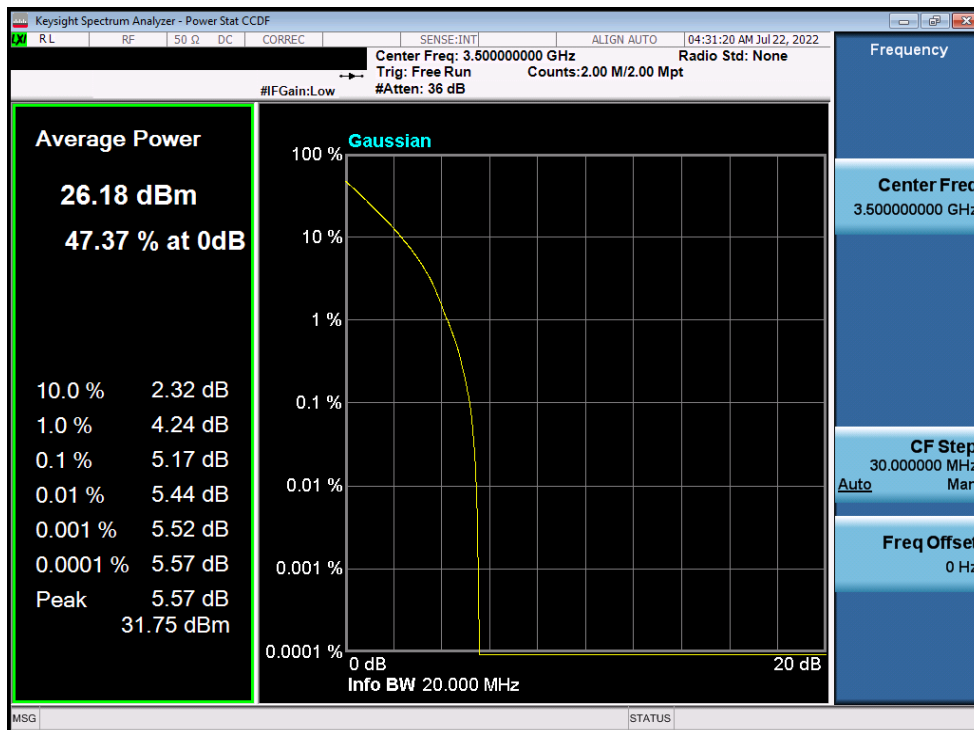

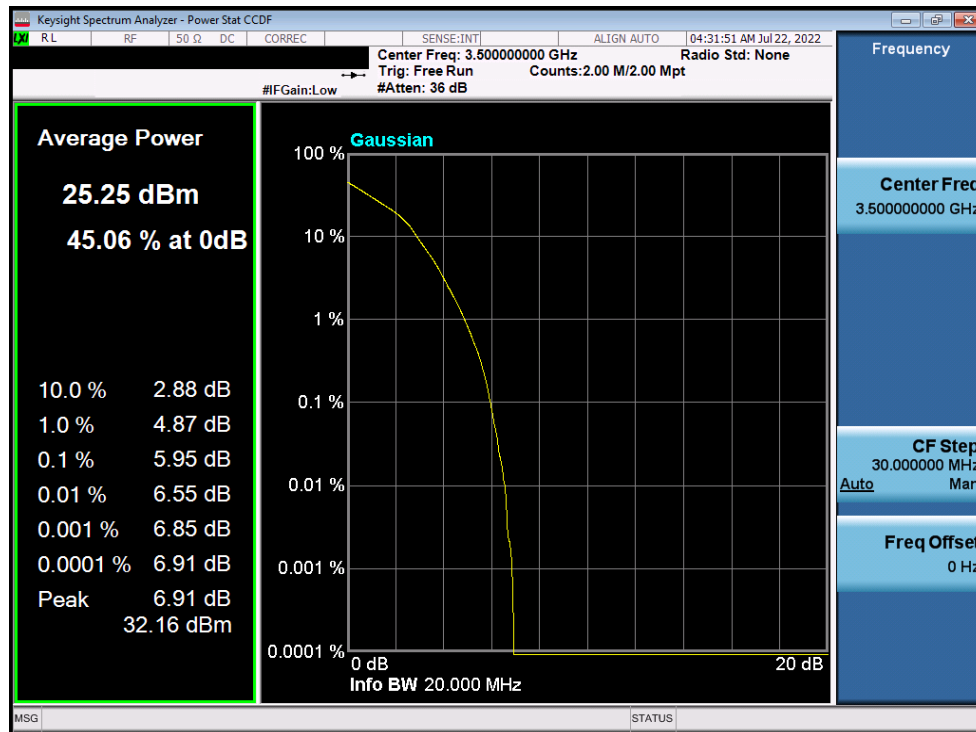
Plot 7-145. PAR Plot (NR Band n77 - 20MHz DFT-s-OFDM $\pi/2$ BPSK - Full RB)



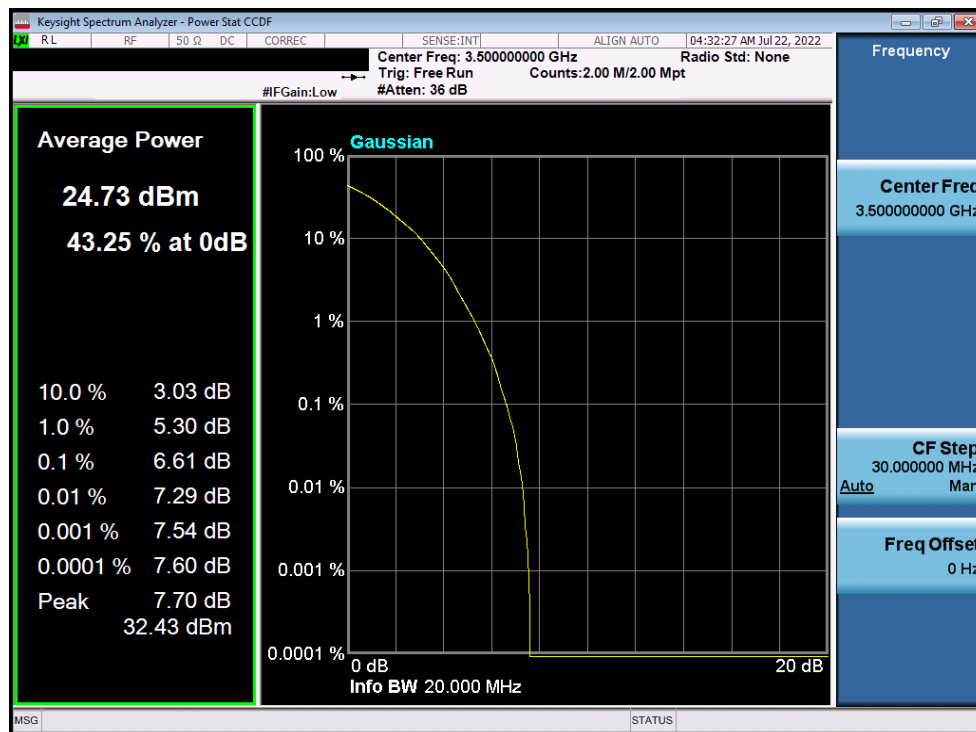
Plot 7-146. PAR Plot (NR Band n77 - 20MHz DFT-s-OFDM QPSK - Full RB)

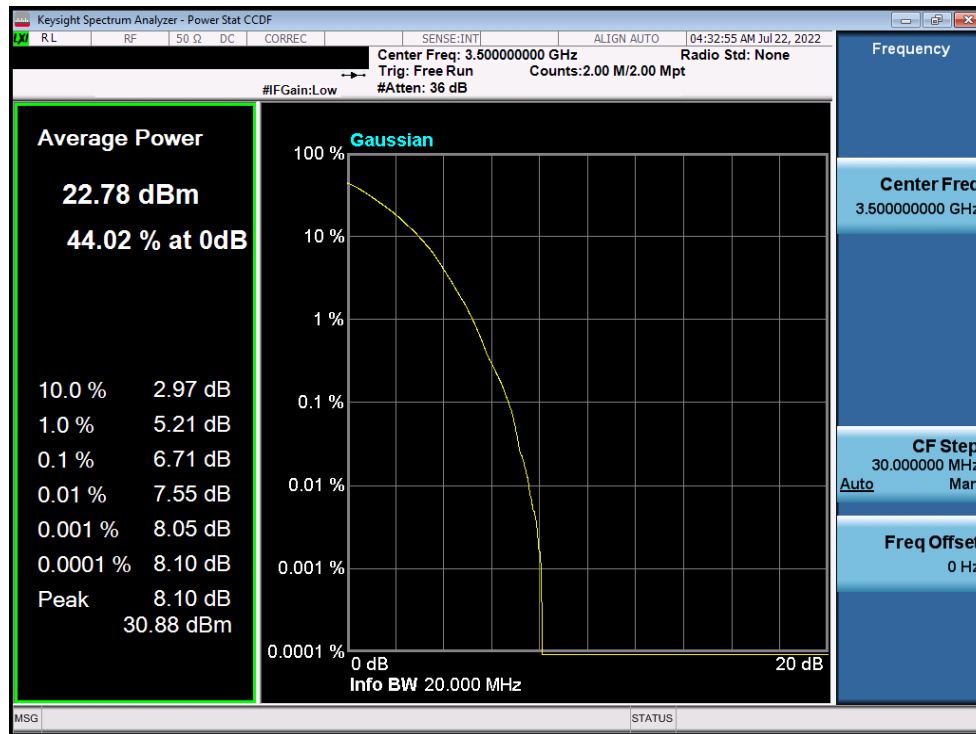


Plot 7-147. PAR Plot (NR Band n77 - 20MHz DFT-s-OFDM 16-QAM - Full RB)

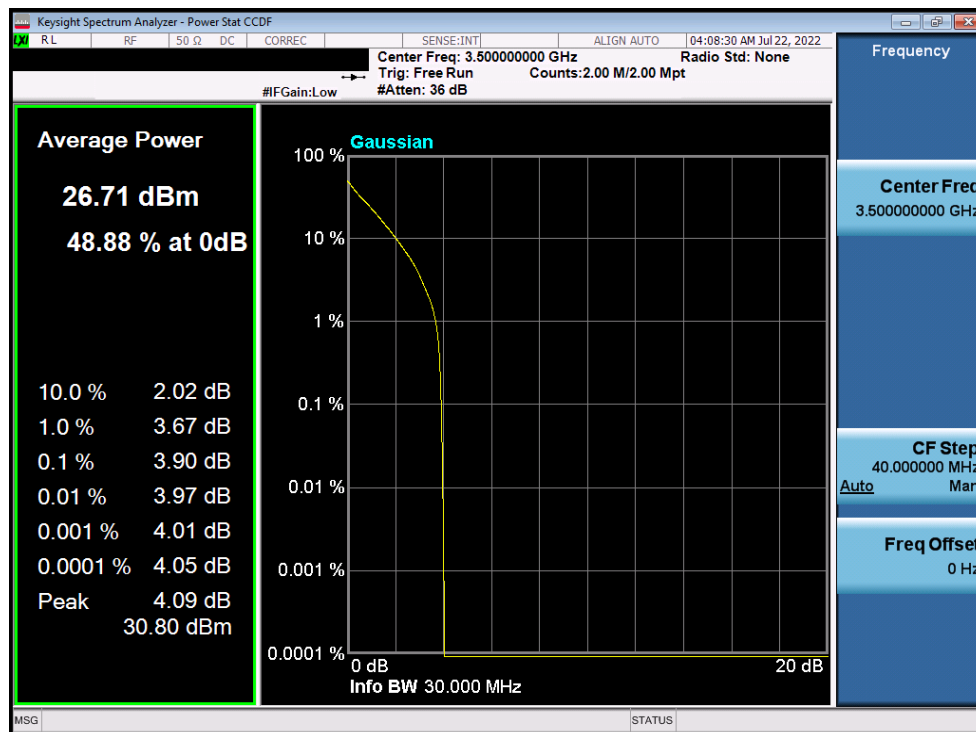


Plot 7-148. PAR Plot (NR Band n77 - 20MHz DFT-s-OFDM 64-QAM - Full RB)

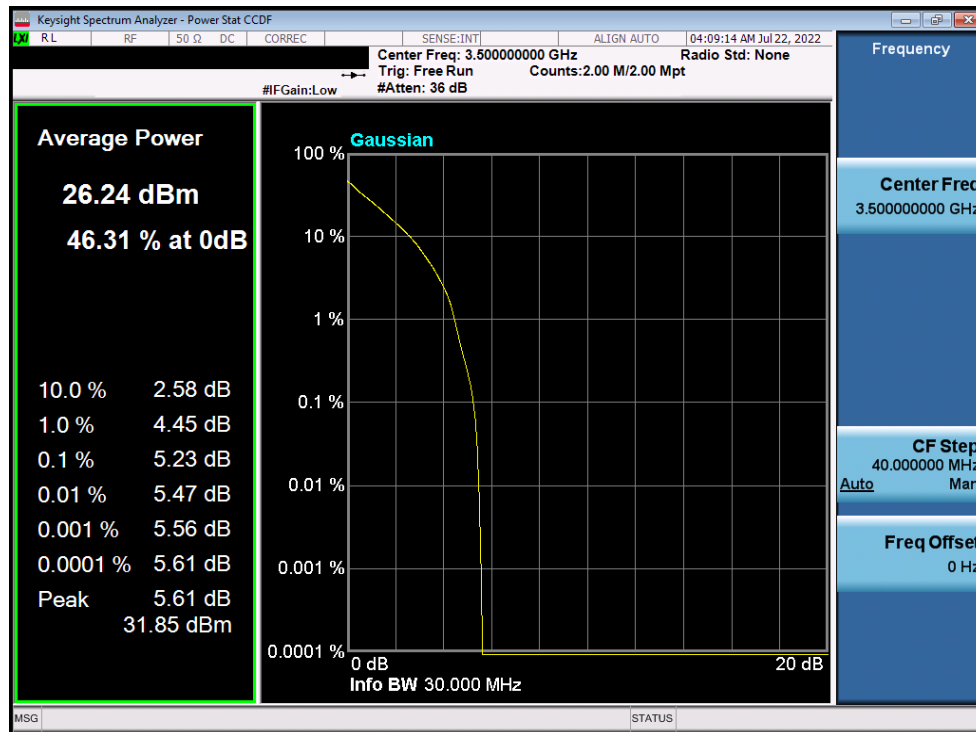
Plot 7-149. PAR Plot (NR Band n77 - 20MHz DFT-s-OFDM 256-QAM - Full RB)



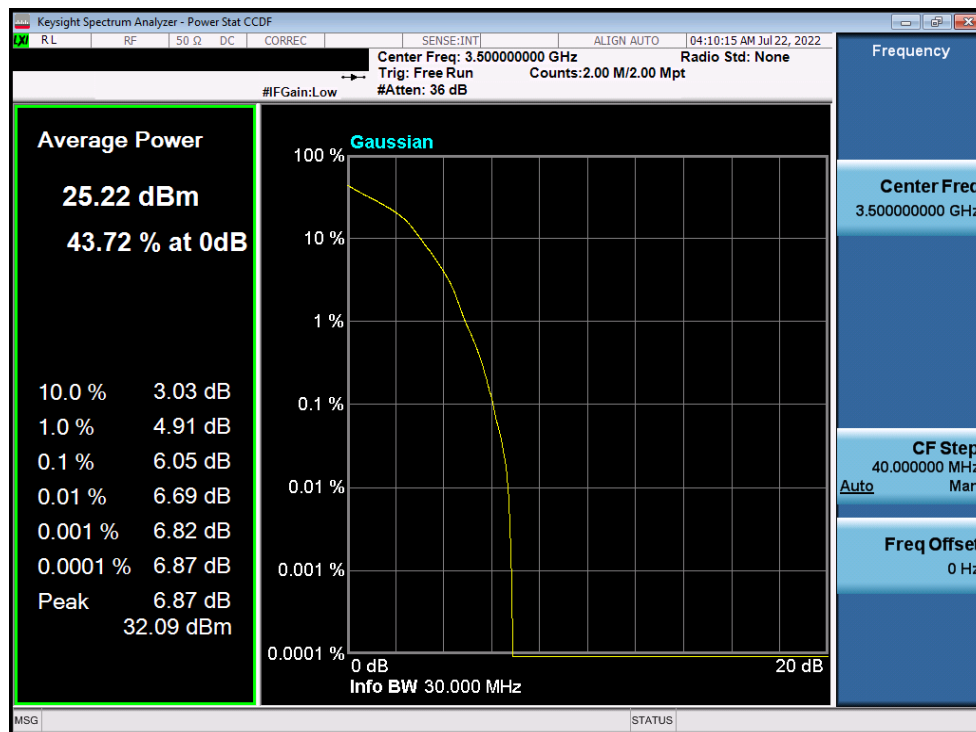
Plot 7-150. PAR Plot (NR Band n77 - 30MHz DFT-s-OFDM $\pi/2$ BPSK - Full RB)

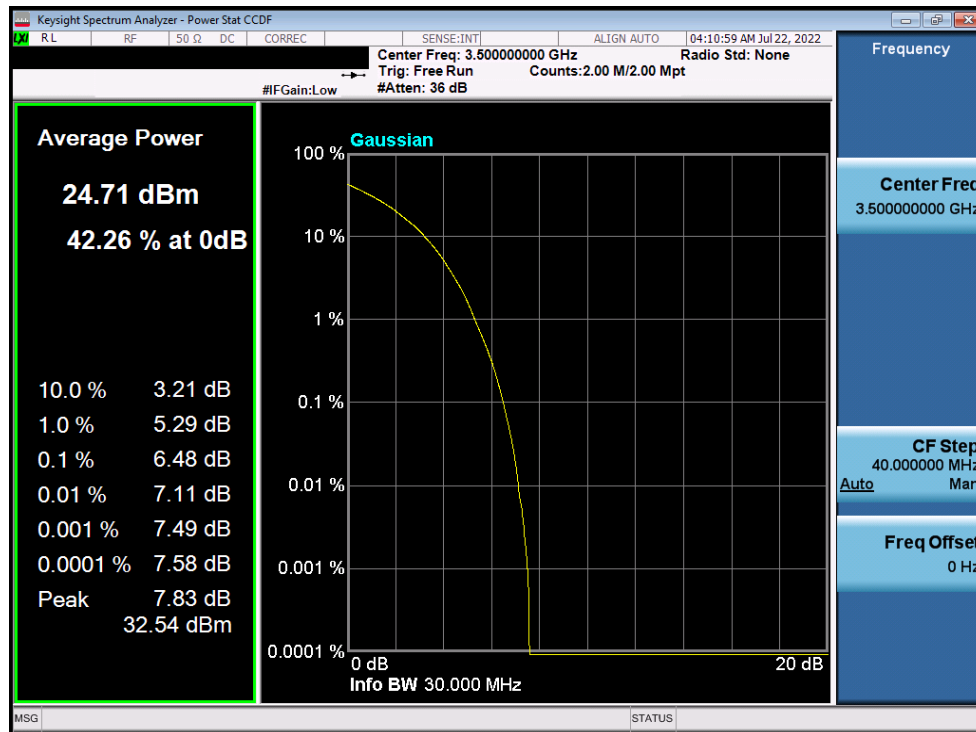


Plot 7-151. PAR Plot (NR Band n77 - 30MHz DFT-s-OFDM QPSK - Full RB)

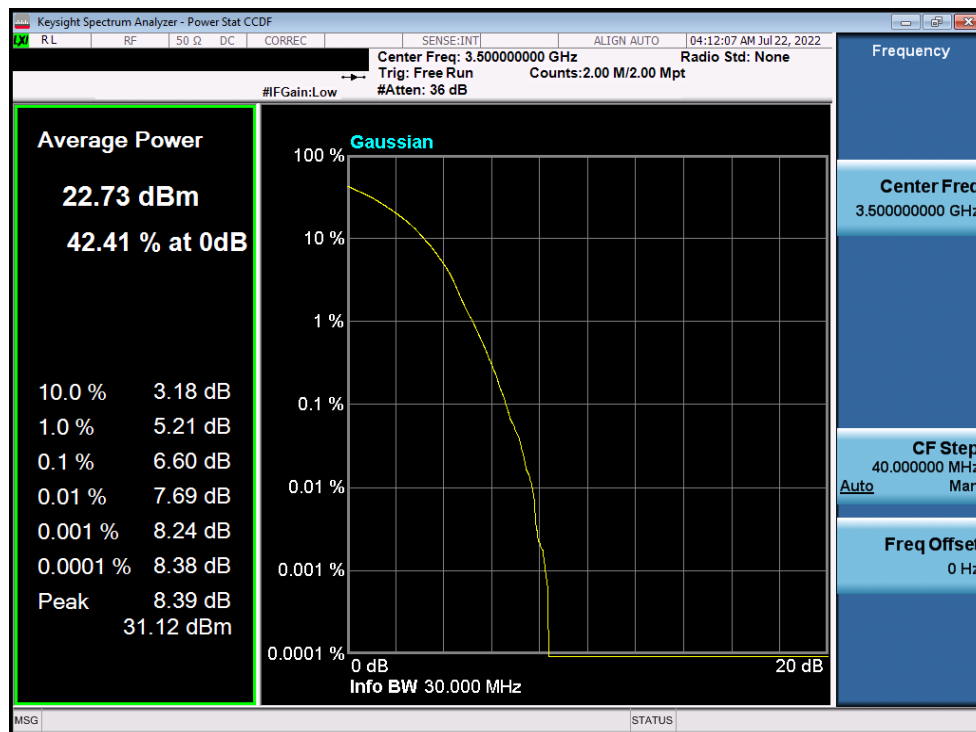


Plot 7-152. PAR Plot (NR Band n77 - 30MHz DFT-s-OFDM 16-QAM - Full RB)

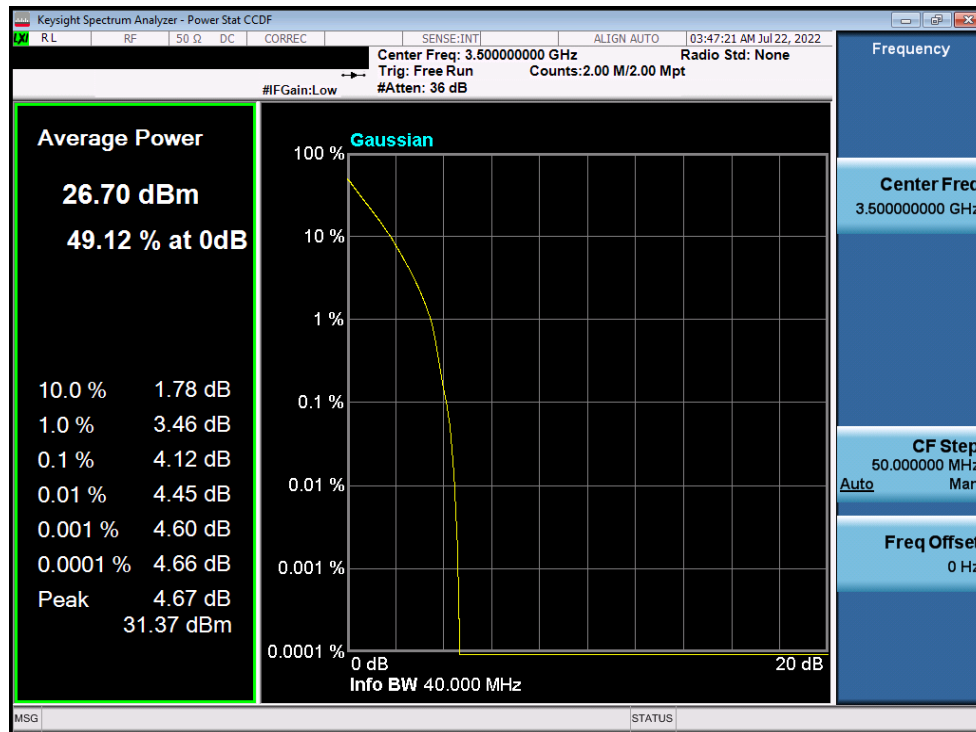


Plot 7-153. PAR Plot (NR Band n77 - 30MHz DFT-s-OFDM 64-QAM - Full RB)

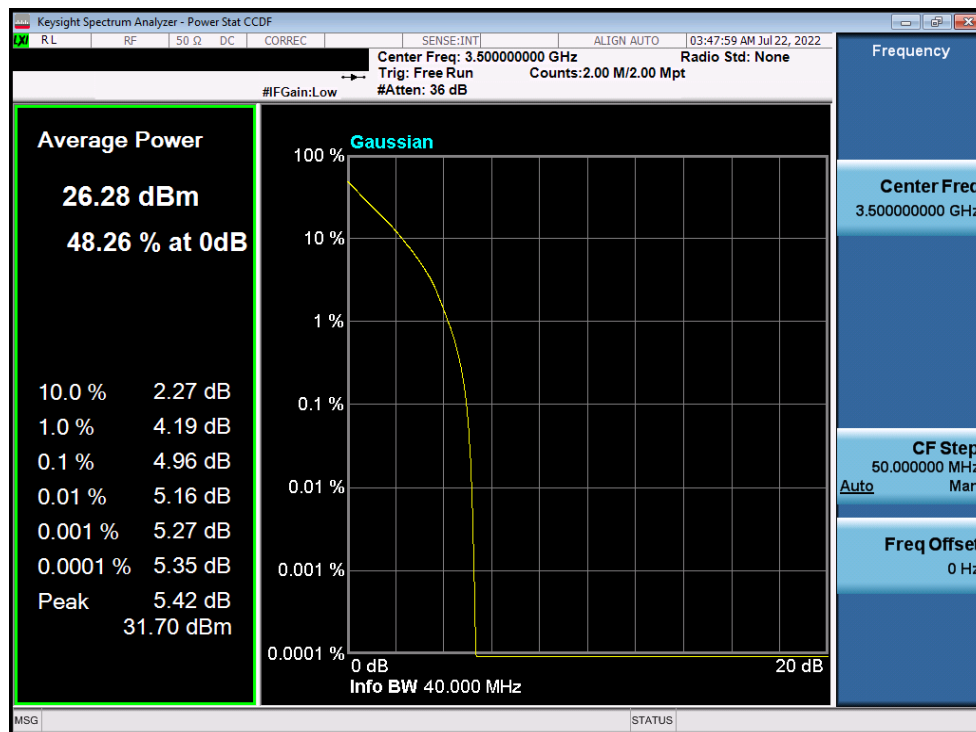


Plot 7-154. PAR Plot (NR Band n77 - 30MHz DFT-s-OFDM 256-QAM - Full RB)

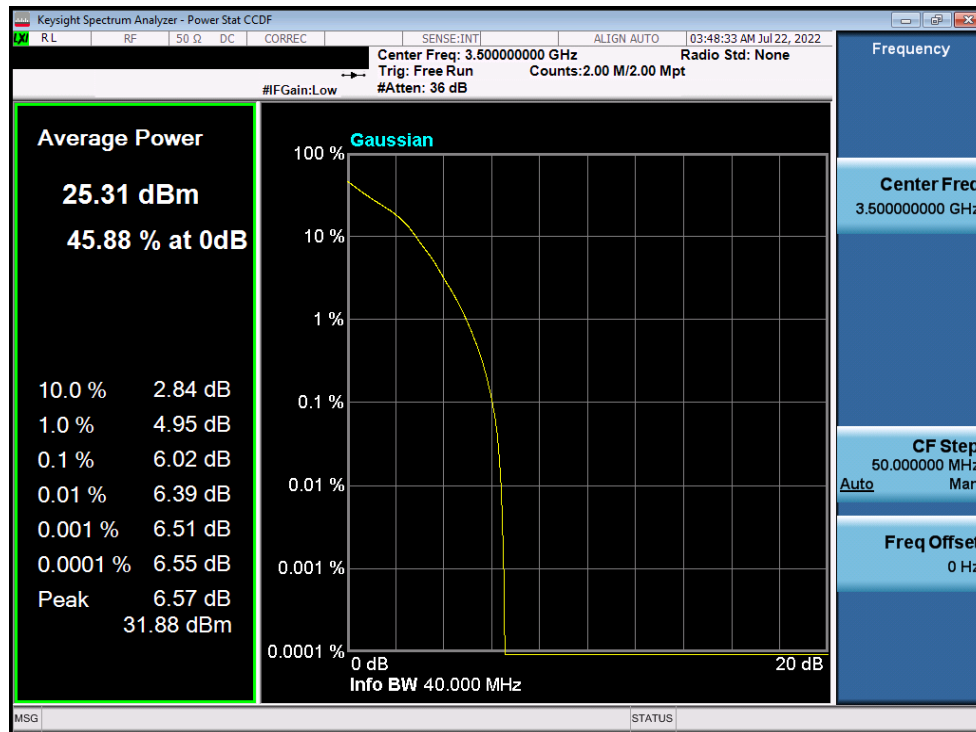


Plot 7-155. PAR Plot (NR Band n77 - 40MHz DFT-s-OFDM $\pi/2$ BPSK - Full RB)

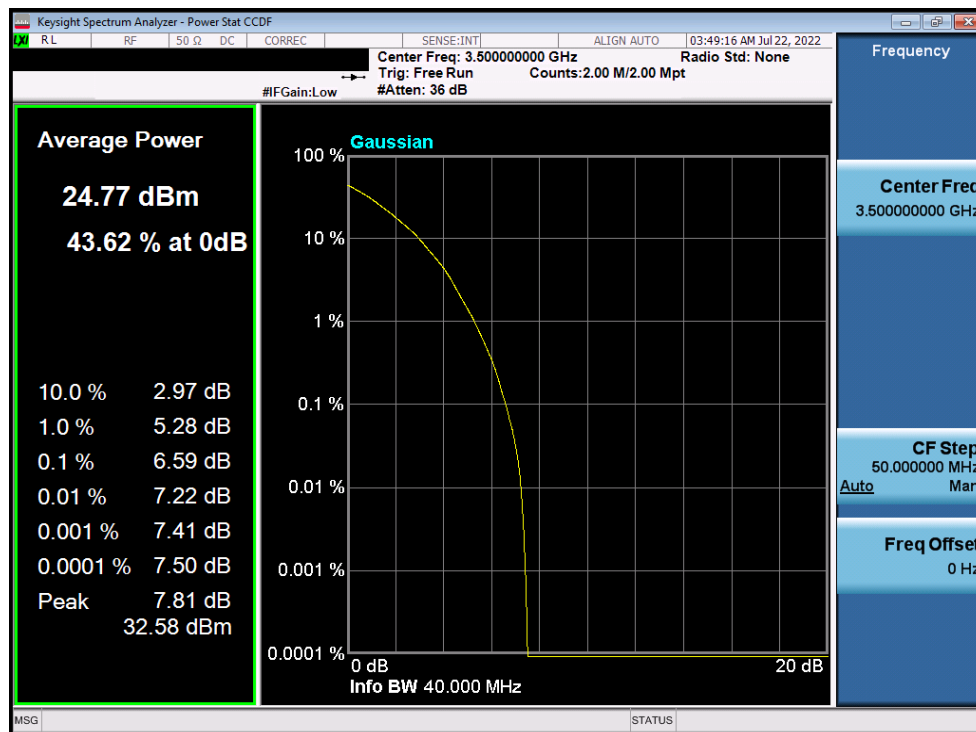


Plot 7-156. PAR Plot (NR Band n77 - 40MHz DFT-s-OFDM QPSK - Full RB)

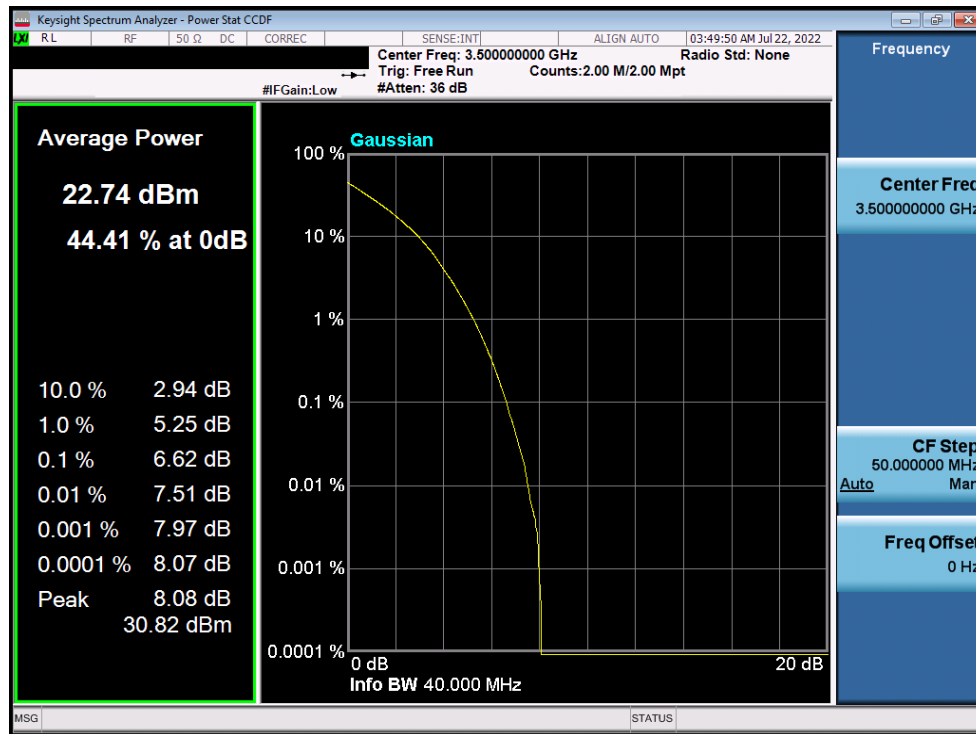


Plot 7-157. PAR Plot (NR Band n77 - 40MHz DFT-s-OFDM 16-QAM - Full RB)

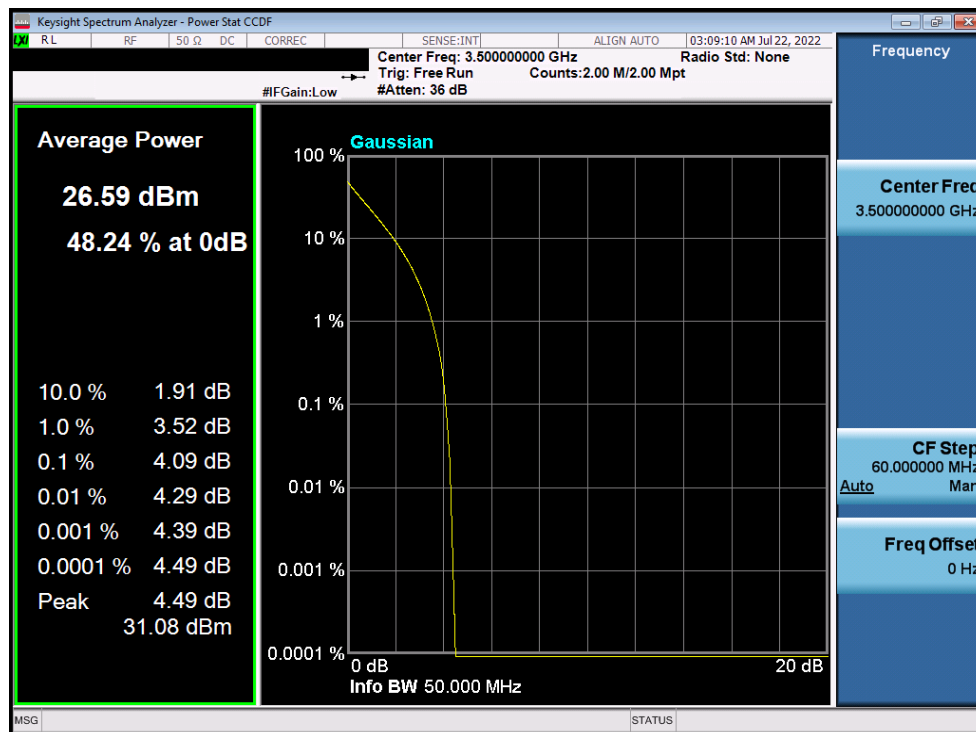


Plot 7-158. PAR Plot (NR Band n77 - 40MHz DFT-s-OFDM 64-QAM - Full RB)

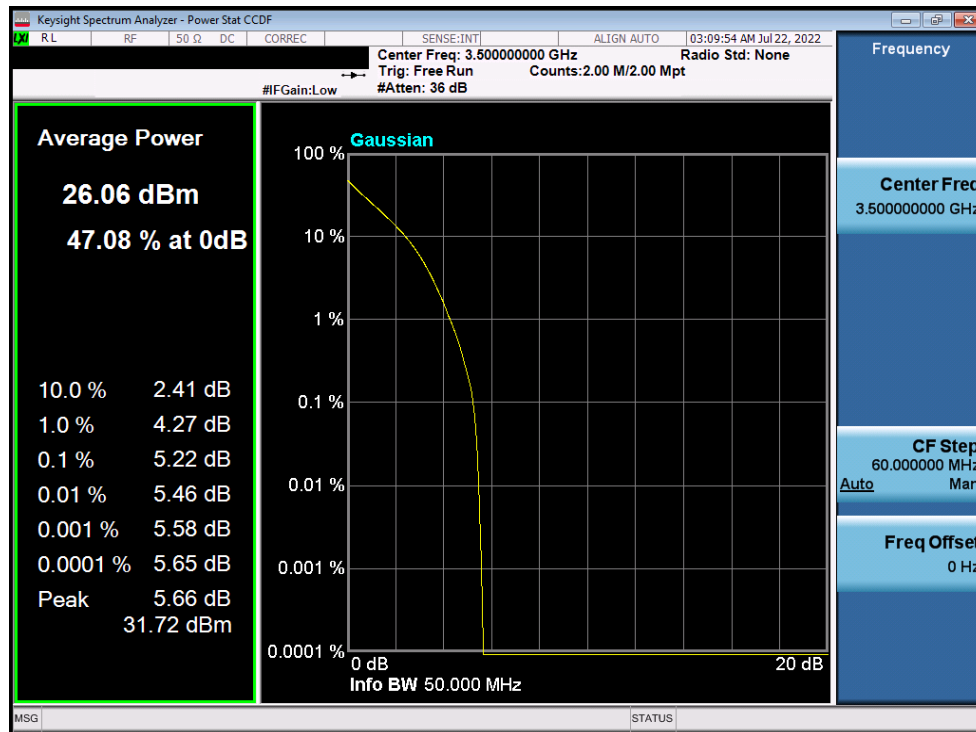
Plot 7-159. PAR Plot (NR Band n77 - 40MHz DFT-s-OFDM 256-QAM - Full RB)



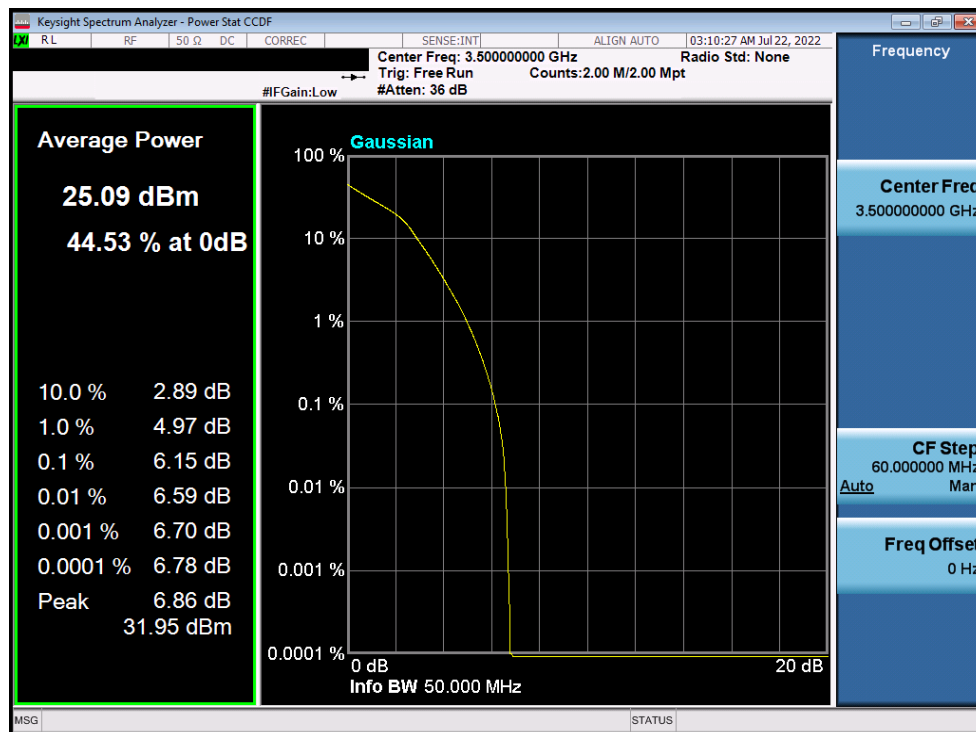
Plot 7-160. PAR Plot (NR Band n77 - 50MHz DFT-s-OFDM $\pi/2$ BPSK - Full RB)

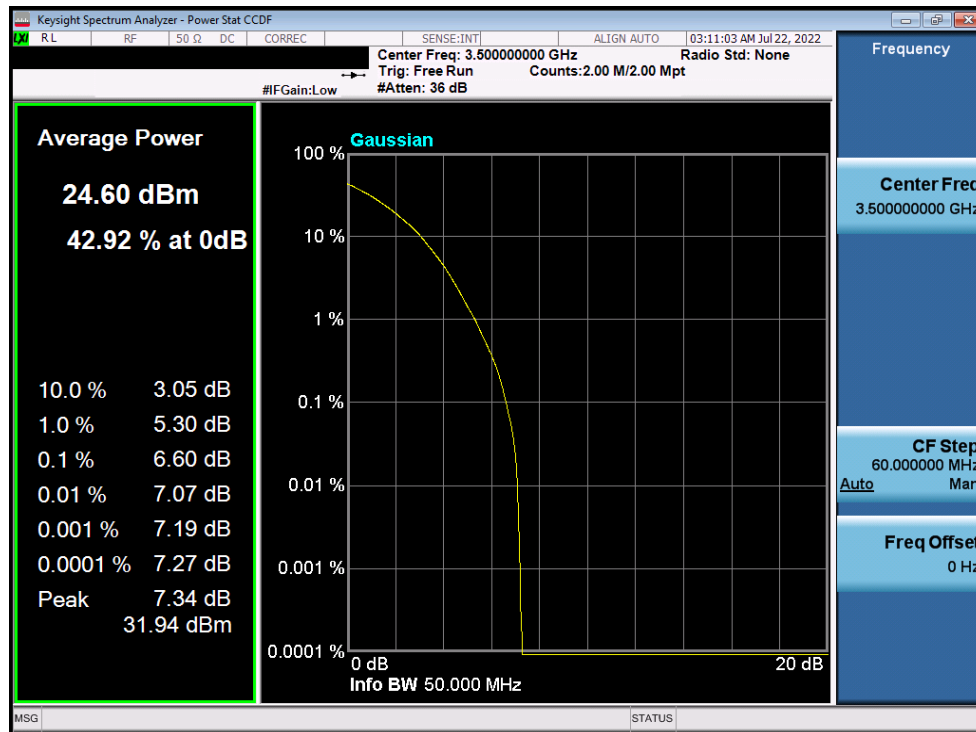
Plot 7-161. PAR Plot (NR Band n77 - 50MHz DFT-s-OFDM QPSK - Full RB)



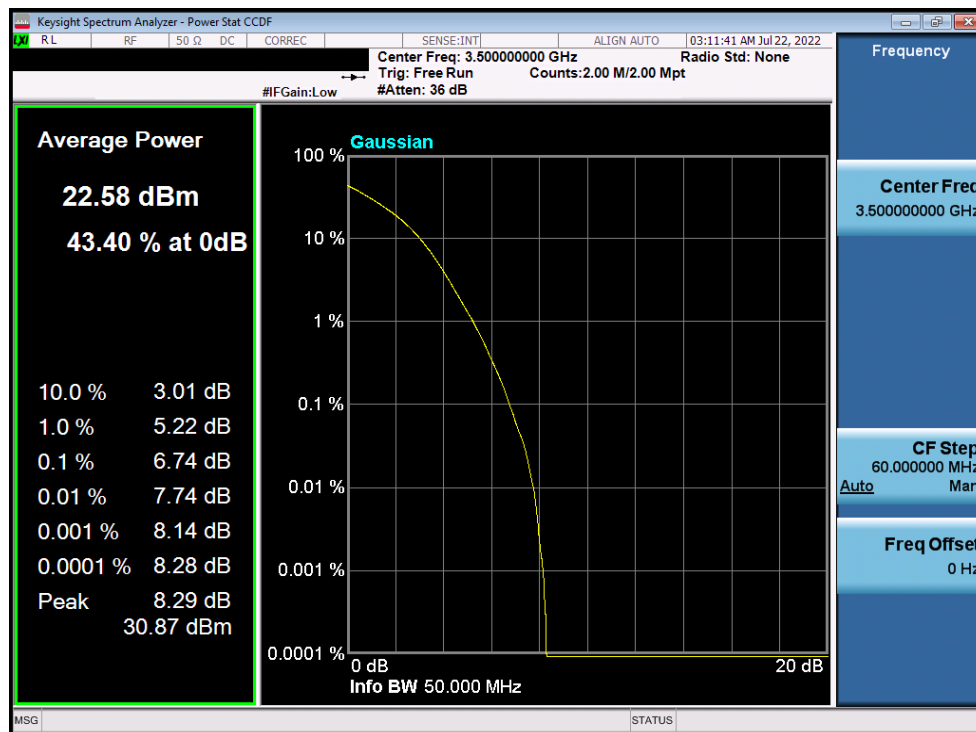
Plot 7-162. PAR Plot (NR Band n77 - 50MHz DFT-s-OFDM 16-QAM - Full RB)
