- 2. The BEJGS500_OTH_01042010_0347451.pdf document indicates a 7mm distance between the Bluetooth and Licensed antennas but the SAR report indicates that this distance is 1.0 cm. Please reconcile.
 - → Please find the revised SAR test report.
- 3. The schematic diagrams indicate WCDMA Band 2 and Band 5 EUT capability. Please confirm that this capability is not implemented in the EUT and if it is, please provide the appropriate test data.
 - → This EUT doesn't support WCDMA bands.
- 4. The internal EUT photos provided in the BEJGS500_INP_01042010_0358463.pdf document do not have all the RF shielding removed form the daughter pc board. Please remove these shields and provide photos per CFR 47 Part 2.1033(c).
 - → Please find the revised internal photos.

Note: The test configuration for the 15B certification testing should place the laptop power supply at 10 cm from the laptop (per CFR 47 Part 15.107).

FYI: In the future, please supply all EUT test positions in the test photos for the Bluetooth testing.
