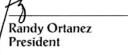

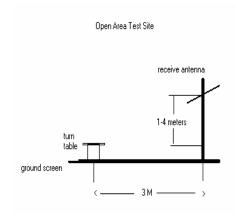

INTRODUCTION

Measurement Procedure 1.1

The radiated spurious measurements were made outdoors at a 3-meter test range (see Figure 1-1). The equipment under test is placed on a wooden turntable 3-meters from the receive antenna. The receive antenna height and turntable rotations were adjusted for the highest reading on the receive spectrum analyzer. A half-wave dipole was substituted in place of the EUT. This dipole antenna was driven by a signal generator and the level of the signal generator was adjusted to obtain the same receive spectrum analyzer reading. This level is recorded. 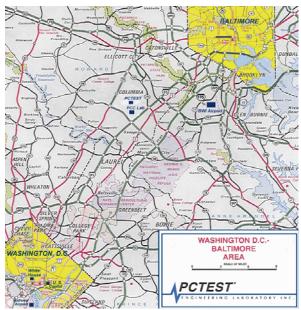


Figure 1-2. Map of the Greater Baltimore and Metropolitan Washington, D.C. area.

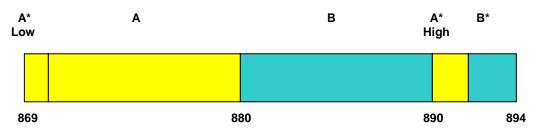


3.0 DESCRIPTION OF TESTS

3.1 Occupied Bandwidth Emission Limits §2.1049, 22.917(a), 24.238(a)

- a. On any frequency outside a licensee's frequency block, the power of any emission shall be attenuated below the transmitter power (P) by at least 43 + 10 log(P) dB.
- b. Compliance with these provisions is based on the use of measurement instrumentation employing a resolution bandwidth of 1 MHz or greater. However, in the 1 MHz bands immediately outside and adjacent to the frequency block a resolution bandwidth of at least one percent of the emission bandwidth of the fundamental emission of the transmitter may be employed. The emission bandwidth is defined as the width of the signal between two points, one below the carrier center frequency and one above the carrier center frequency, outside of which all emission are attenuated at least 26 dB below the transmitter power.
- c. When measuring the emission limits, the nominal carrier frequency shall be adjusted as close to the licensee's frequency block edges, both upper and lower, as the design permits.
- d. The measurement of emission power can be expressed in peak or average values, provided they are expressed in the same parameters as the transmitter power.

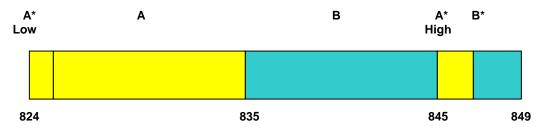

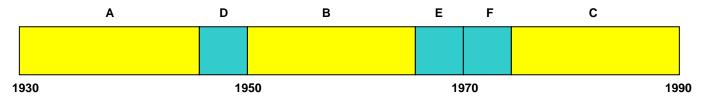

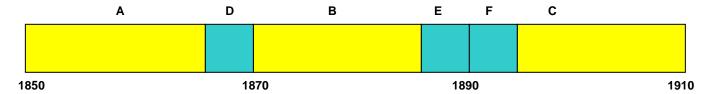


BLOCK 1: 1930 - 1945 MHz (A) BLOCK 4: 1965 - 1970 MHz (E)
