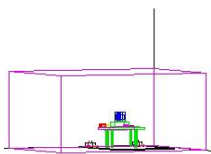

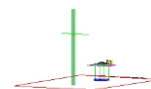

1.0 INTRODUCTION

1.1 Scope

Measurement and determination of electromagnetic emissions (EMC) of radio frequency devices including intentional and/or unintentional radiators for compliance with the technical rules and regulations of the Federal Communications Commission and the Innovation, Science and Economic Development Canada.

1.2 PCTEST Test Location

These measurement tests were conducted at the PCTEST facility located at 7185 Oakland Mills Road, Columbia, MD 21046. The measurement facility is compliant with the test site requirements specified in ANSI C63.4-2014.

1.3 Test Facility / Accreditations

Measurements were performed at PCTEST located in Columbia, MD 21046, U.S.A.

2.3 Test Configuration

The EUT was tested per the guidance of KDB 558074 D01 v05r02. ANSI C63.10-2013 was used to reference the appropriate EUT setup for radiated spurious emissions testing and AC line conducted testing. See Sections 3.2 for AC line conducted emissions test setups, 3.3 for radiated emissions test setups, and 7.2, 7.3, 7.4, 7.5, and 7.6 for antenna port conducted emissions test setups.

This device supports open and closed configurations. Multiple angles are tested and the worst case radiated emissions data is shown in the report.

3.0 DESCRIPTION OF TESTS

3.1 Evaluation Procedure

The measurement procedures described in the American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices (ANSI C63.10-2013) and the guidance provided in KDB 558074 D01 v05r02 were used in the measurement of the EUT.

3.2 AC Line Conducted Emissions

The line-conducted facility is located inside a 10'x16'x9' shielded enclosure. The shielded enclosure is manufactured by ETS Lindgren RF Enclosures. The shielding effectiveness of the shielded room is in accordance with MIL-Std-285 or NSA 65-5. A 1m x 1.5m wooden table 80cm high is placed 40cm away from the vertical wall and 80cm away from the sidewall of the shielded room. Two 10kHz-30MHz, 50 Ω /50 μ H Line-Impedance Stabilization Networks (LISNs) are bonded to the shielded room floor. Power to the LISNs is filtered by external high-current high-insertion loss power line filters. The external power line filter is an ETS Lindgren Model LPRX-4X30 (100dB Attenuation, 14kHz-18GHz) and the two EMI/RFI filters are ETS Lindgren Model LRW-2030-S1 (100dB Minimum Insertion Loss, 14kHz – 10GHz). These filters attenuate ambient signal noise from entering the measurement lines. These filters are also bonded to the shielded enclosure.

The EUT is powered from one LISN and the support equipment is powered from the second LISN. If the EUT is a DC-powered device, power will be derived from the source power supply it normally will be powered from and this supply line(s) will be connected to the second LISN. All interconnecting cables more than 1 meter were shortened to a 1 meter length by non-inductive bundling (serpentine fashion) and draped over the back edge of the test table. All cables were at least 40cm above the horizontal reference groundplane. Power cables for support equipment were routed down to the second LISN while ensuring that that cables were not draped over the second LISN.

Sufficient time for the EUT, support equipment, and test equipment was allowed in order for them to warm up to their normal operating condition. The RF output of the LISN was connected to the spectrum analyzer and exploratory measurements were made to determine the frequencies producing the maximum emission from the EUT. The spectrum was scanned from 150kHz to 30MHz with a spectrum analyzer. The detector function was set to peak mode for exploratory measurements while the bandwidth of the analyzer was set to 10kHz. The EUT, support equipment, and interconnecting cables were arranged and manipulated to maximize each emission. Once the worst case emissions have been identified, the one EUT cable configuration/arrangement and mode of operation that produced these emissions is used for final measurements on the same test site. The analyzer is set to CISPR quasi-peak and average detectors with a 9kHz resolution bandwidth for final measurements.

Line conducted emissions test results are shown in Section 7.8. The EMI Receiver mode of the Agilent MXE was used to perform AC line conducted emissions testing.

3.3 Radiated Emissions

The radiated test facilities consisted of an indoor 3 meter semi-anechoic chamber used for final measurements and exploratory measurements, when necessary. The measurement area is contained within the semi-anechoic chamber which is shielded from any ambient interference. The test site inside the chamber is a 6m x 5.2m elliptical, obstruction-free area in accordance with Figure 5.7 of Clause 5 in ANSI C63.4-2014. Absorbers are arranged on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections for measurements above 1GHz. An 80cm tall test table made of Styrodur is placed on top of the turn table. For measurements above 1GHz, an additional Styrodur pedestal is placed on top of the test table to bring the total table height to 1.5m.

For all measurements, the spectrum was scanned through all EUT azimuths and from 1 to 4 meter receive antenna height using a broadband antenna from 30MHz up to the upper frequency shown in 15.33 depending on the highest frequency generated or used in the device or on which the device operates or tunes. For frequencies above 1GHz, linearly polarized double ridge horn antennas were used. For frequencies below 30MHz, a calibrated loop antenna was used. When exploratory measurements were necessary, they were performed at 1 meter test distance inside the semi-anechoic chamber using broadband antennas, broadband amplifiers, and spectrum analyzers to determine the frequencies and modes producing the maximum emissions. Sufficient time for the EUT, support equipment, and test equipment was allowed in order for them to warm up to their normal operating condition. The test set-up was placed on top of the 1 x 1.5 meter table. The EUT, support equipment, and interconnecting cables were arranged and manipulated to maximize each emission. Appropriate precaution was taken to ensure that all emissions from the EUT were maximized and investigated. The system configuration, mode of operation, turntable azimuth, and receive antenna height was noted for each frequency found.

Final measurements were made in the semi-anechoic chamber using calibrated, linearly polarized broadband and horn antennas. The test setup was configured to the setup that produced the worst case emissions. The spectrum analyzer was set to investigate all frequencies required for testing to compare the highest radiated disturbances with respect to the specified limits. The turntable containing the EUT was rotated through 360 degrees and the height of the receive antenna was varied 1 to 4 meters and stopped at the azimuth and height producing the maximum emission. Each emission was maximized by changing the orientation of the EUT through three orthogonal planes and changing the polarity of the receive antenna, whichever produced the worst-case emissions.

All radiated measurements are performed in a chamber that meets the site requirements per ANSI C63.4-2014. Additionally, radiated emissions below 30MHz are also validated on an Open Area Test Site to assert correlation with the chamber measurements per the requirements of KDB 474788 D01.

3.4 Environmental Conditions

The temperature is controlled within range of 15°C to 35°C. The relative humidity is controlled within range of 10% to 75%. The atmospheric pressure is monitored within the range 86-106kPa (860-1060mbar).

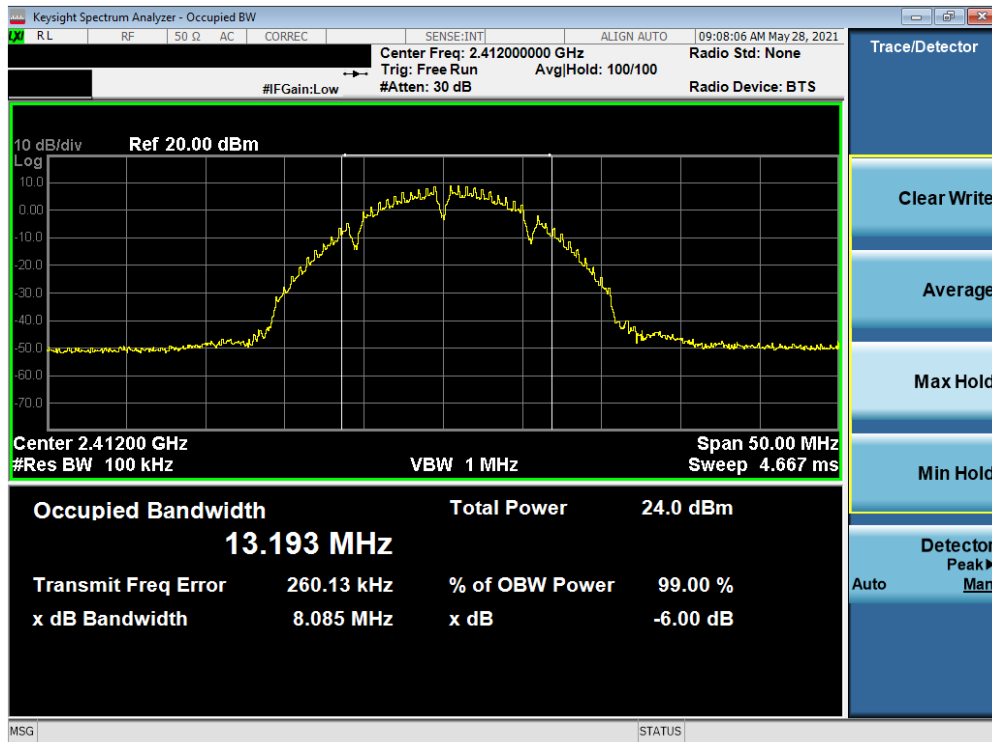

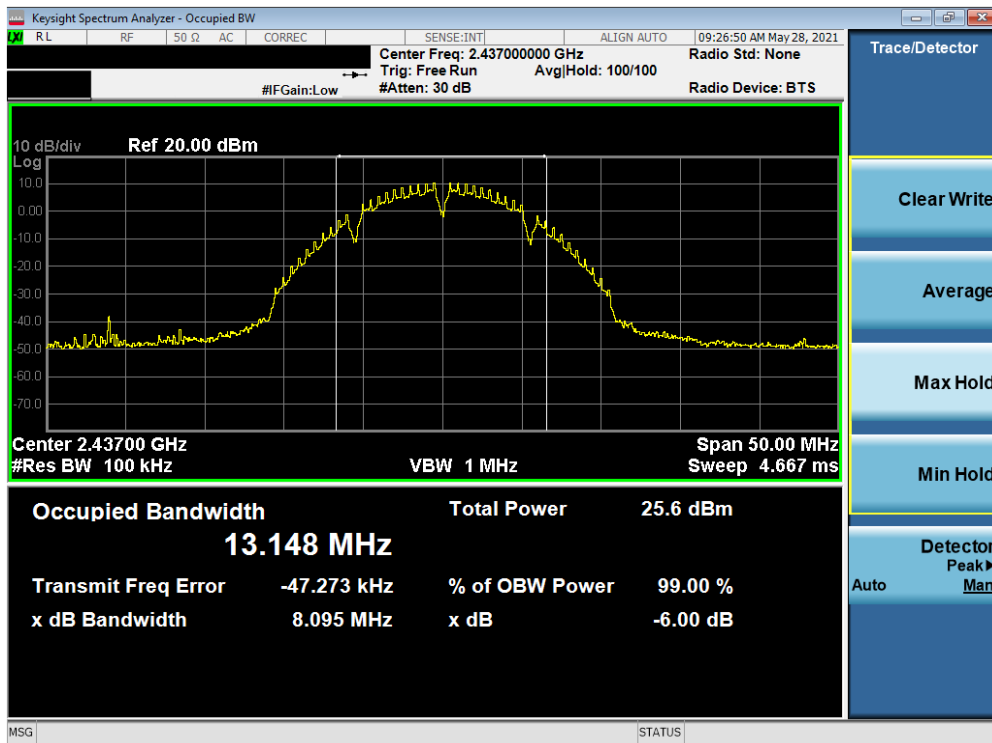

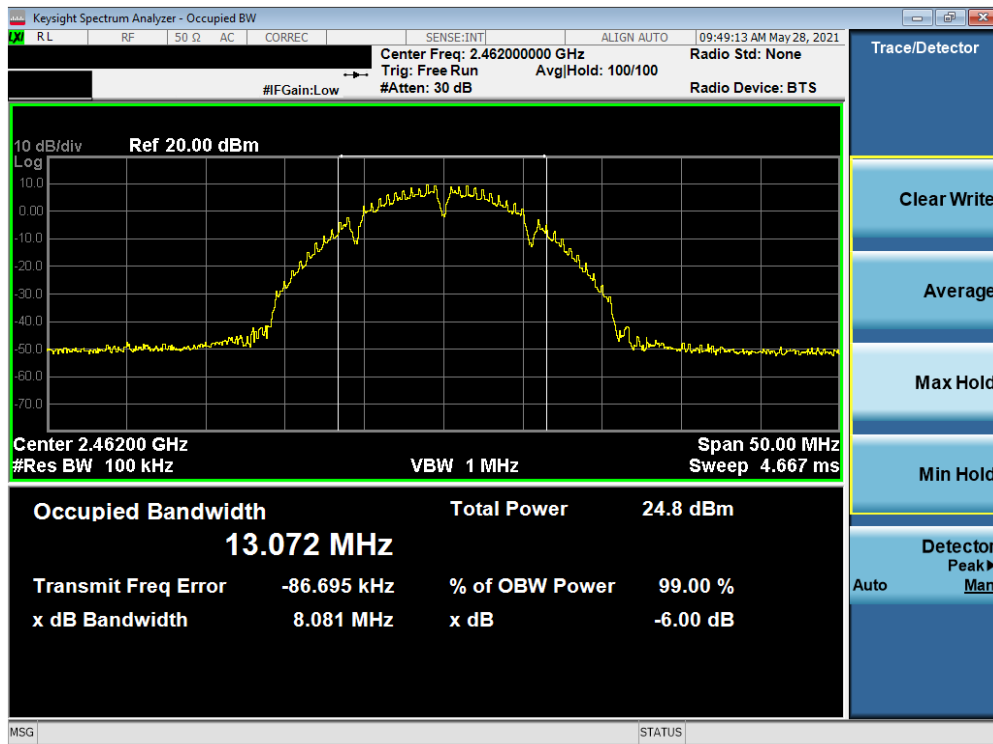


Plot 7-1. 6dB Bandwidth Plot SISO SOUTH (802.11b – Ch. 1)

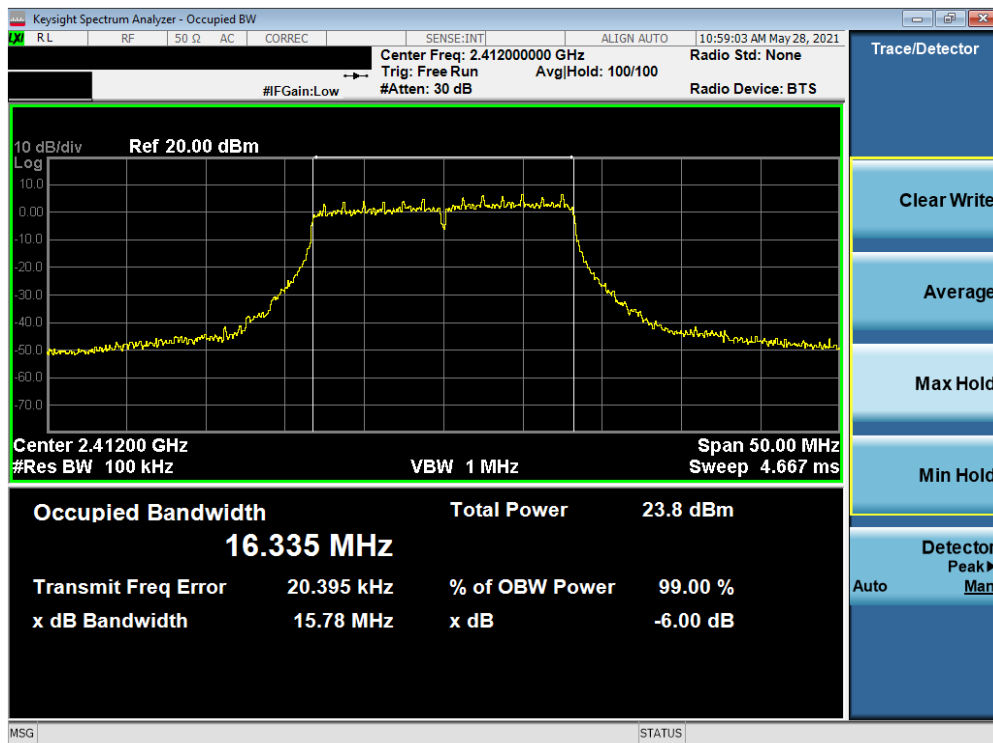


Plot 7-2. 6dB Bandwidth Plot SISO SOUTH (802.11b – Ch. 6)

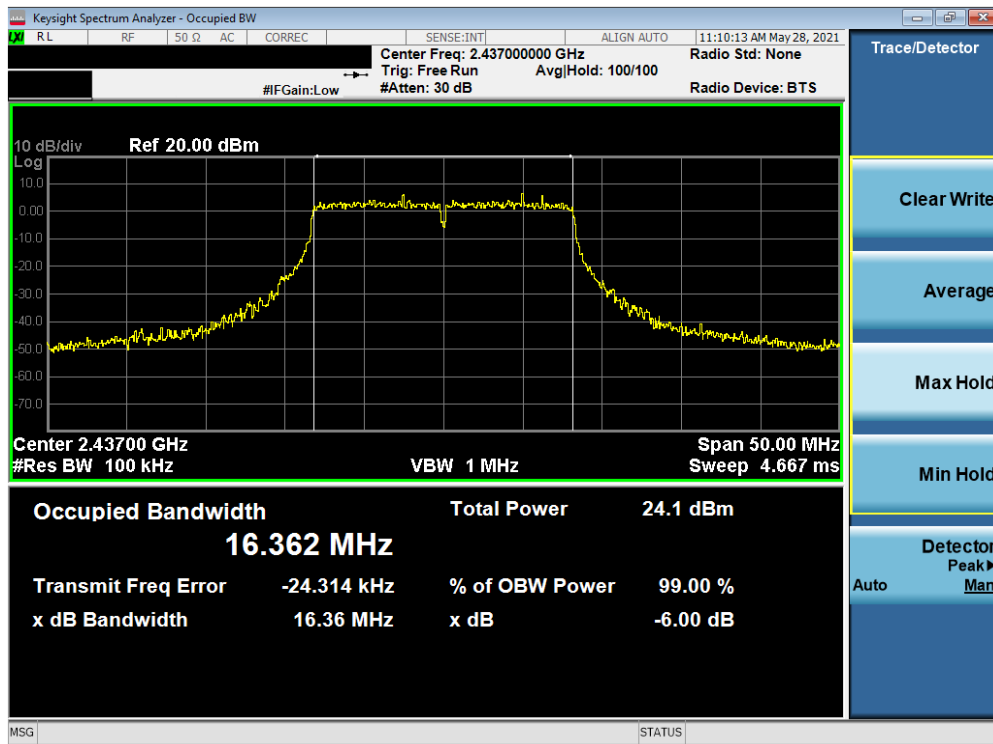


Plot 7-3. 6dB Bandwidth Plot SISO SOUTH (802.11b – Ch. 11)

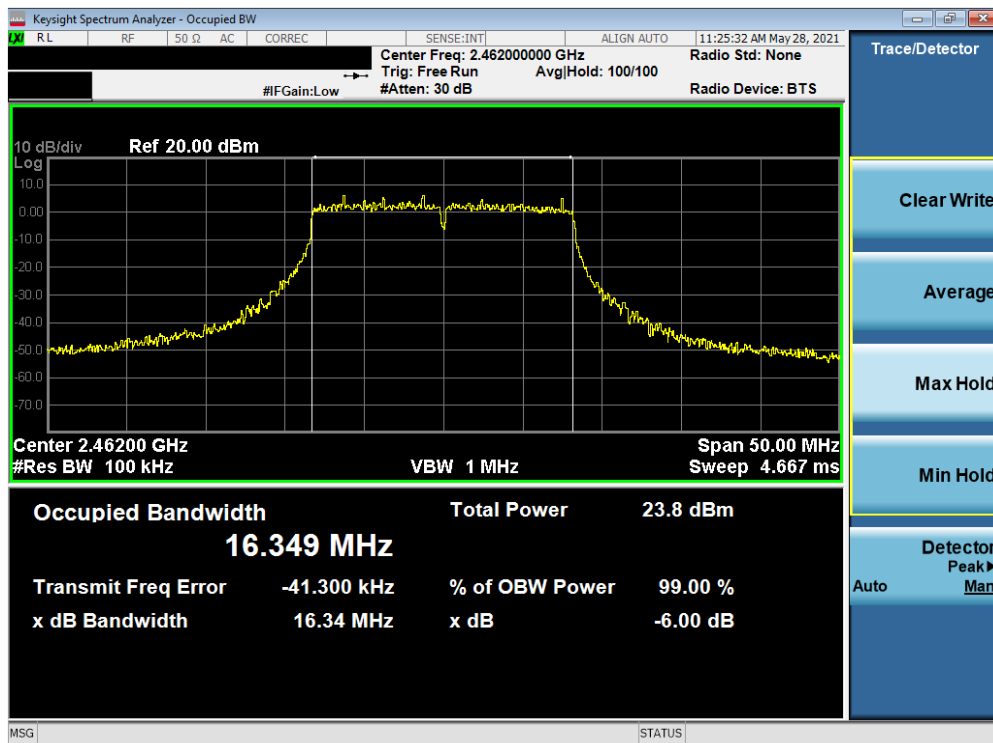


Plot 7-4. 6dB Bandwidth Plot SISO SOUTH (802.11g – Ch. 1)

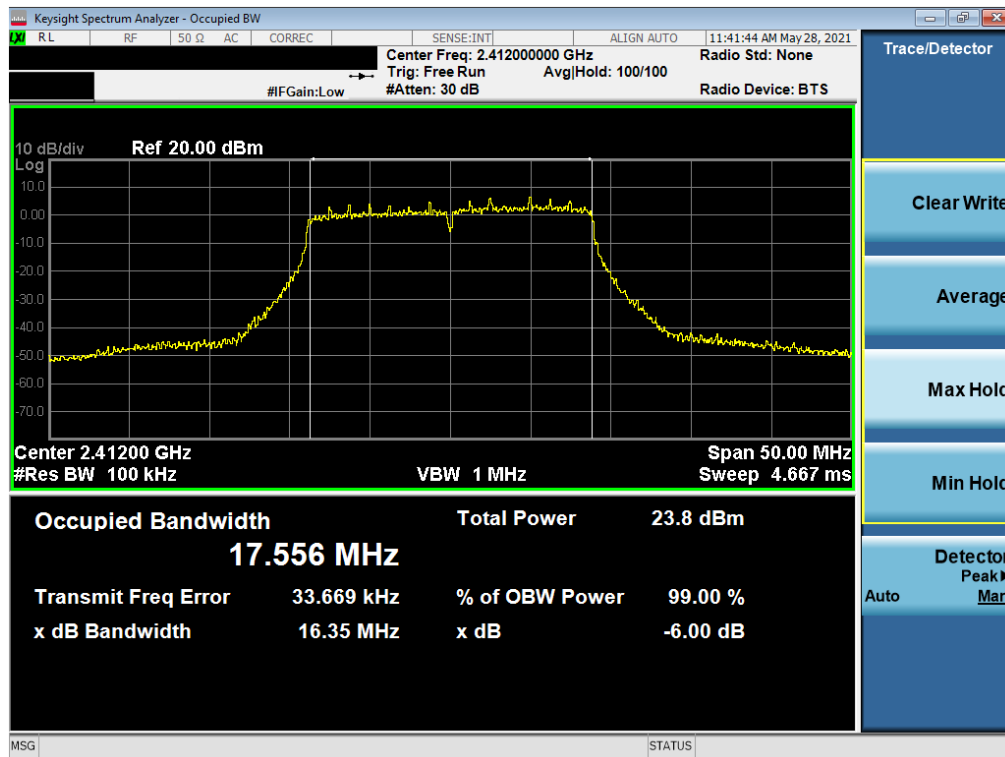


Plot 7-5. 6dB Bandwidth Plot SISO SOUTH (802.11g – Ch. 6)

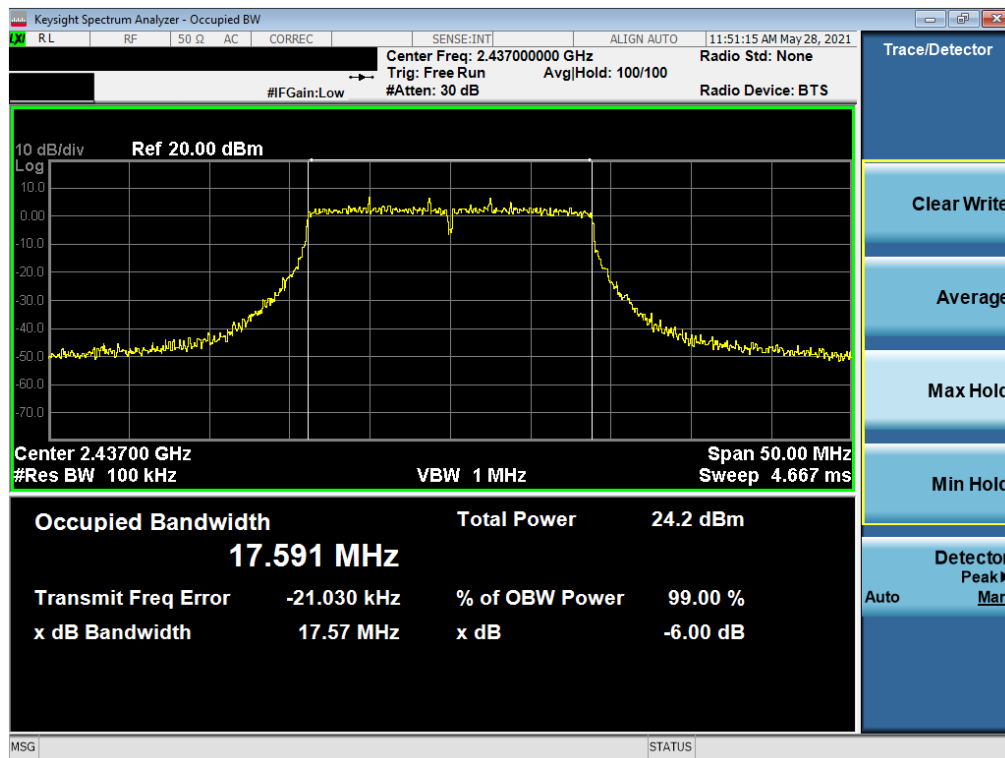


Plot 7-6. 6dB Bandwidth Plot SISO SOUTH (802.11g – Ch. 11)

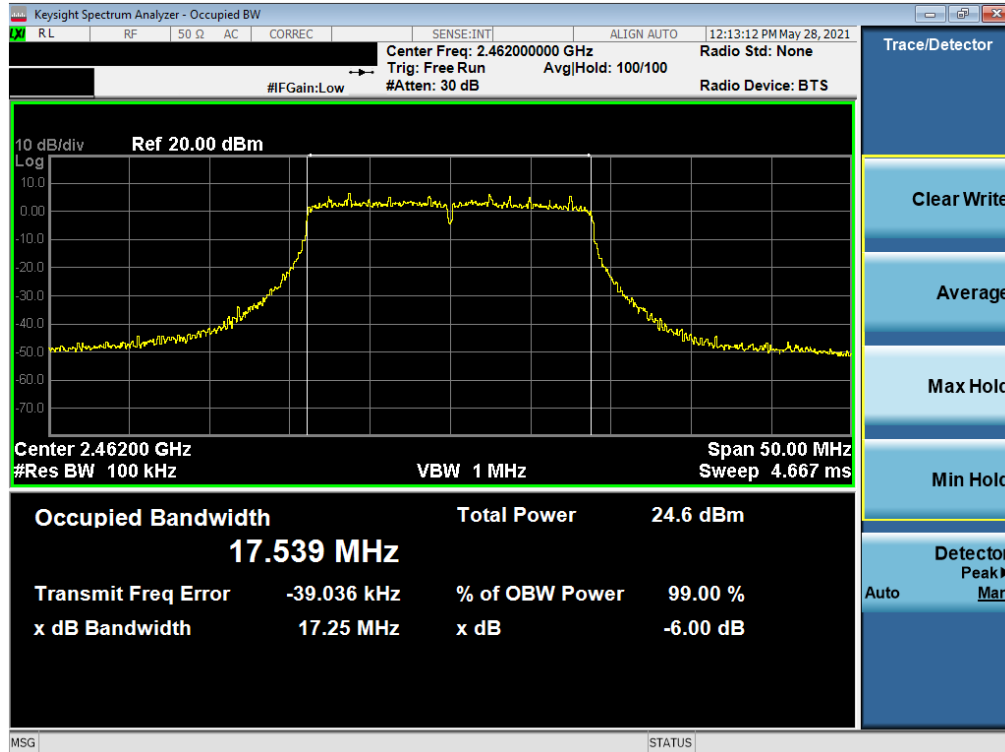


Plot 7-7. 6dB Bandwidth Plot SISO SOUTH (802.11n 20MHz BW (2.4GHz) – Ch. 1)

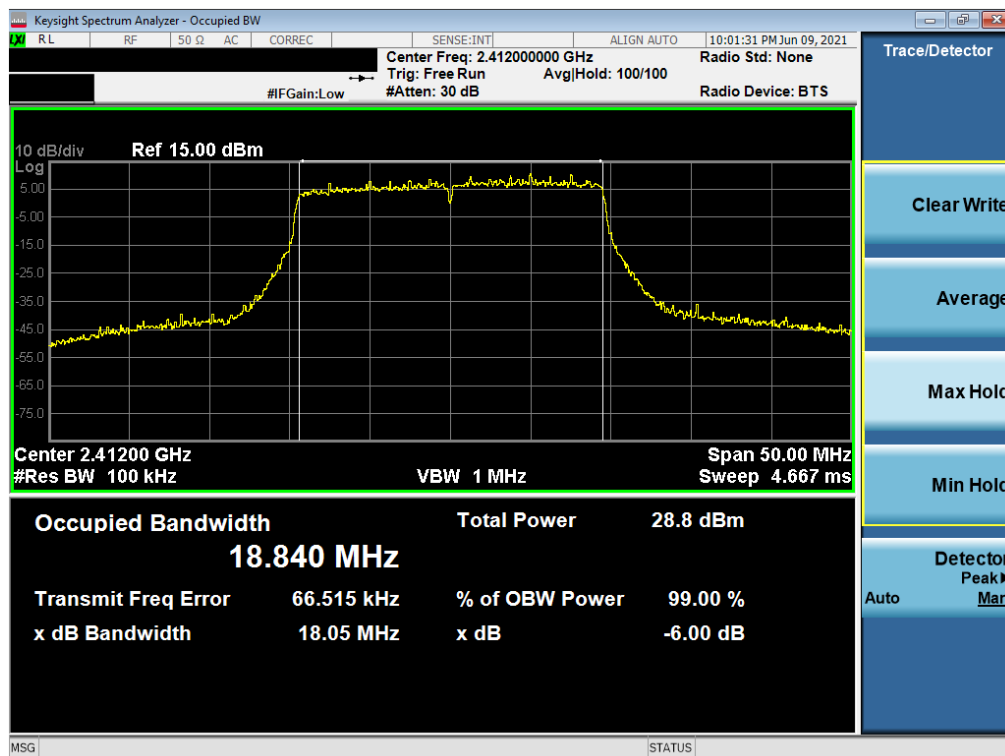


Plot 7-8. 6dB Bandwidth Plot SISO SOUTH (802.11n 20MHz BW (2.4GHz) – Ch. 6)

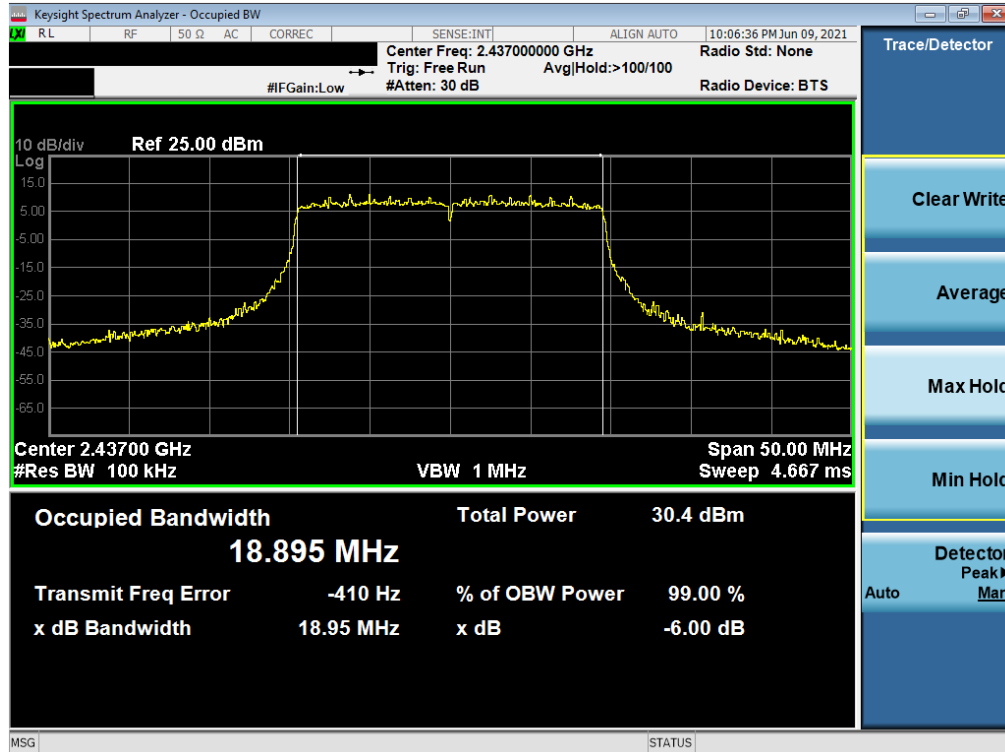


Plot 7-9. 6dB Bandwidth Plot SISO SOUTH (802.11n 20MHz BW (2.4GHz) – Ch. 11)

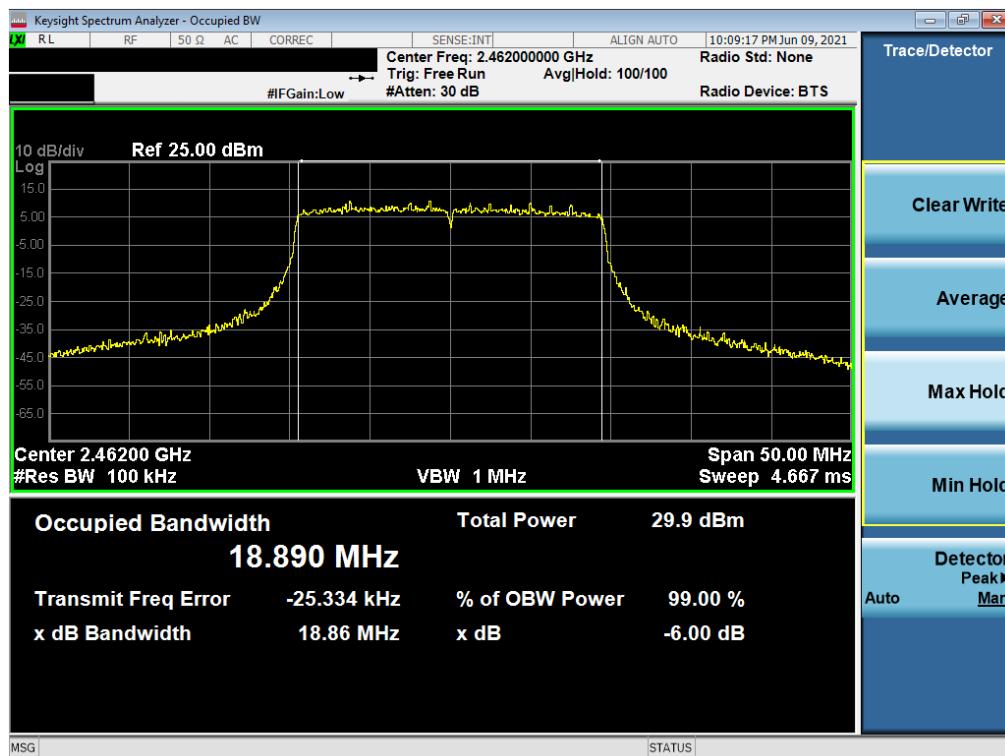


Plot 7-10. 6dB Bandwidth Plot SISO SOUTH (802.11ax 20MHz BW (2.4GHz) – Ch. 11)

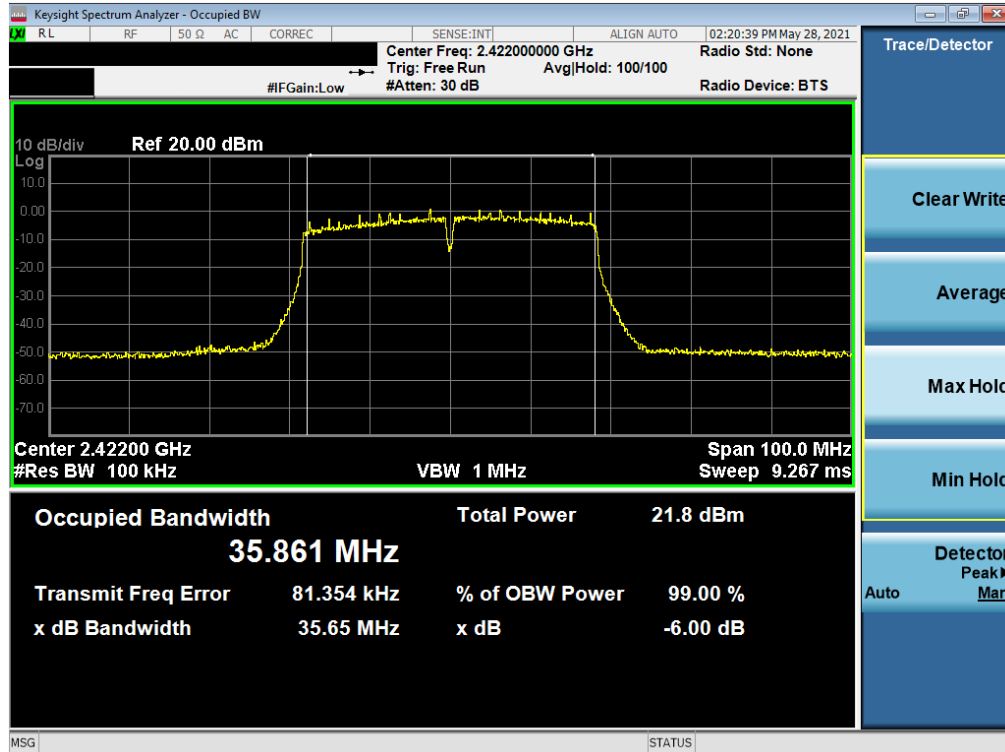


Plot 7-11. 6dB Bandwidth Plot SISO SOUTH (802.11ax 20MHz BW (2.4GHz) – Ch. 6)

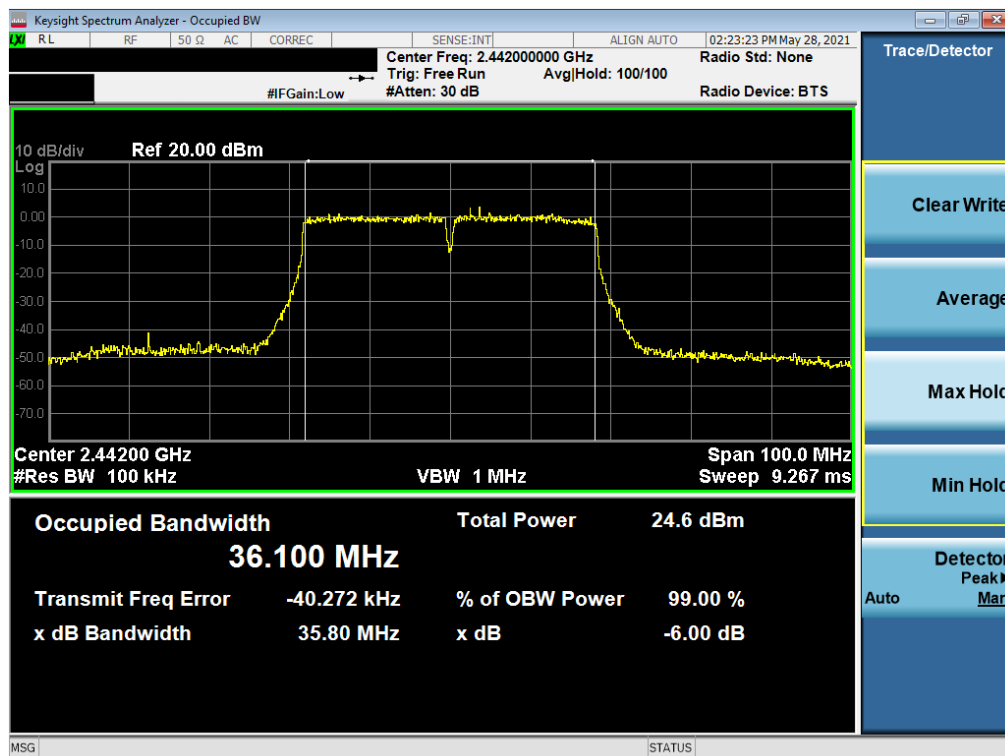


Plot 7-12. 6dB Bandwidth Plot SISO SOUTH (802.11ax 20MHz BW (2.4GHz) – Ch. 11)

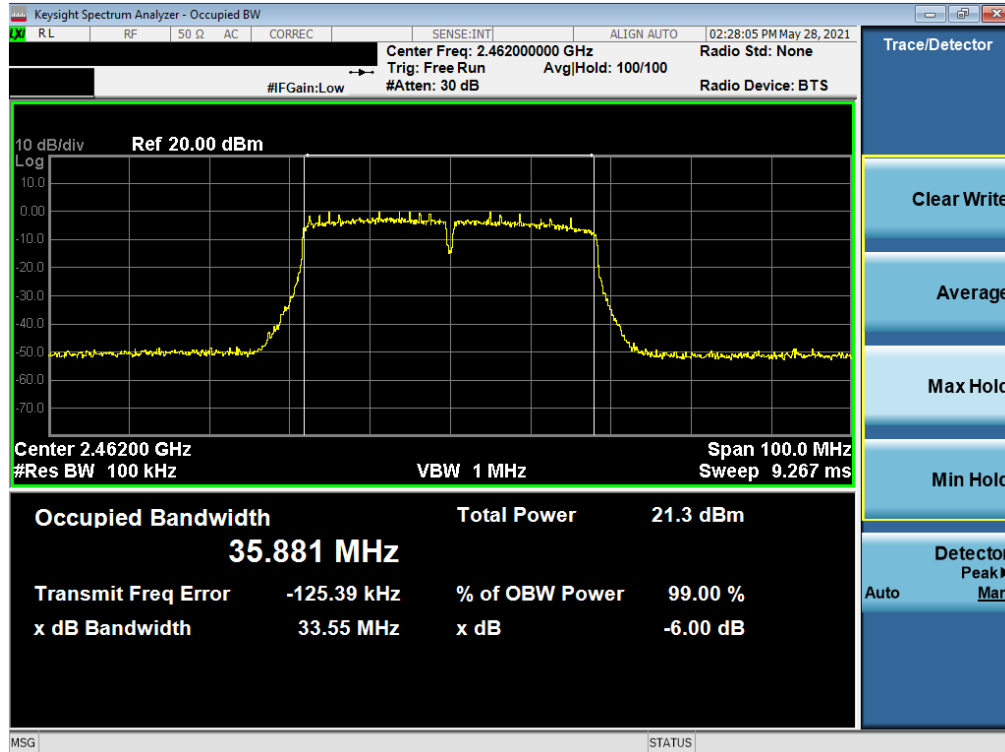


Plot 7-13. 6dB Bandwidth Plot SISO SOUTH (802.11n 40MHz BW (2.4GHz) – Ch. 3)

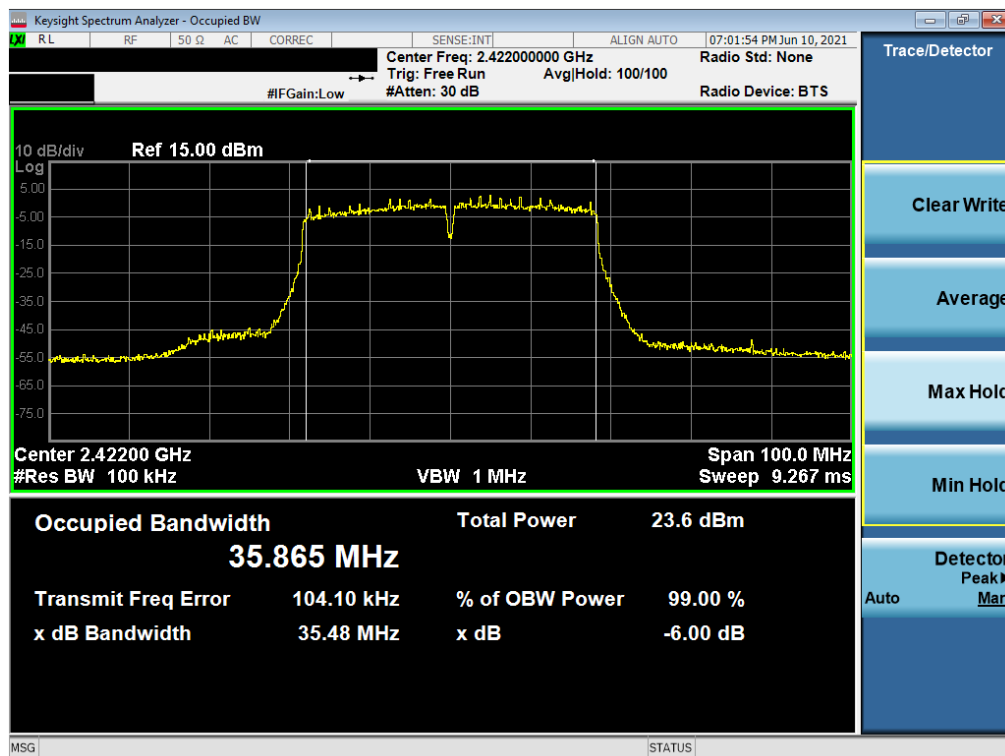


Plot 7-14. 6dB Bandwidth Plot SISO SOUTH (802.11n 40MHz BW (2.4GHz) – Ch. 7)

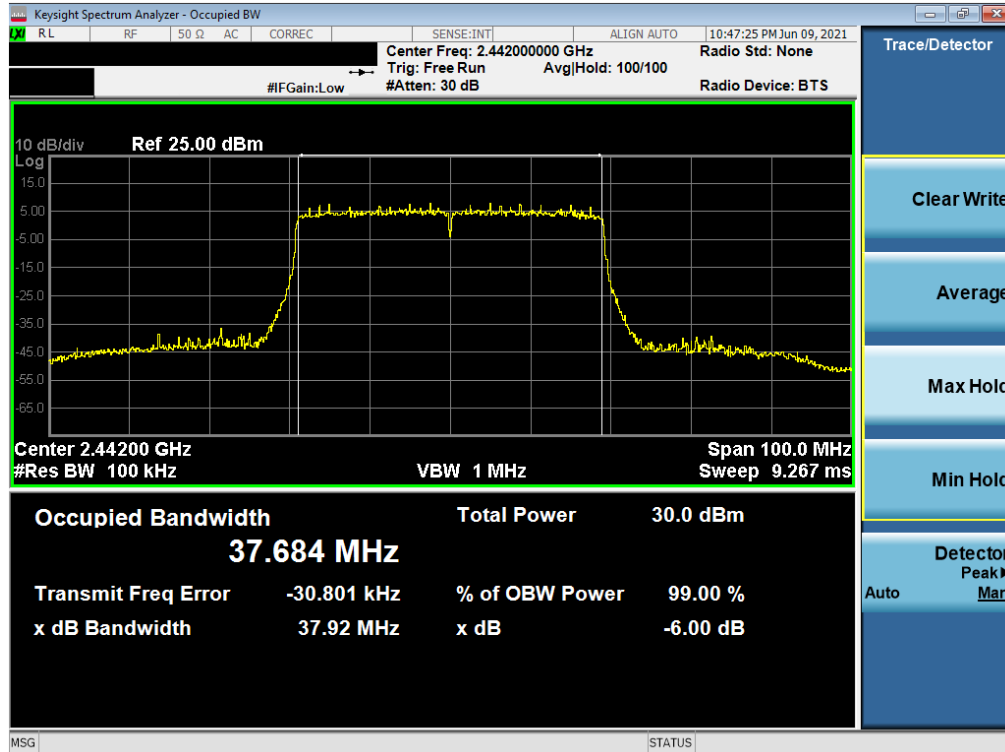


Plot 7-15. 6dB Bandwidth Plot SISO SOUTH (802.11n 40MHz BW (2.4GHz) – Ch. 11)

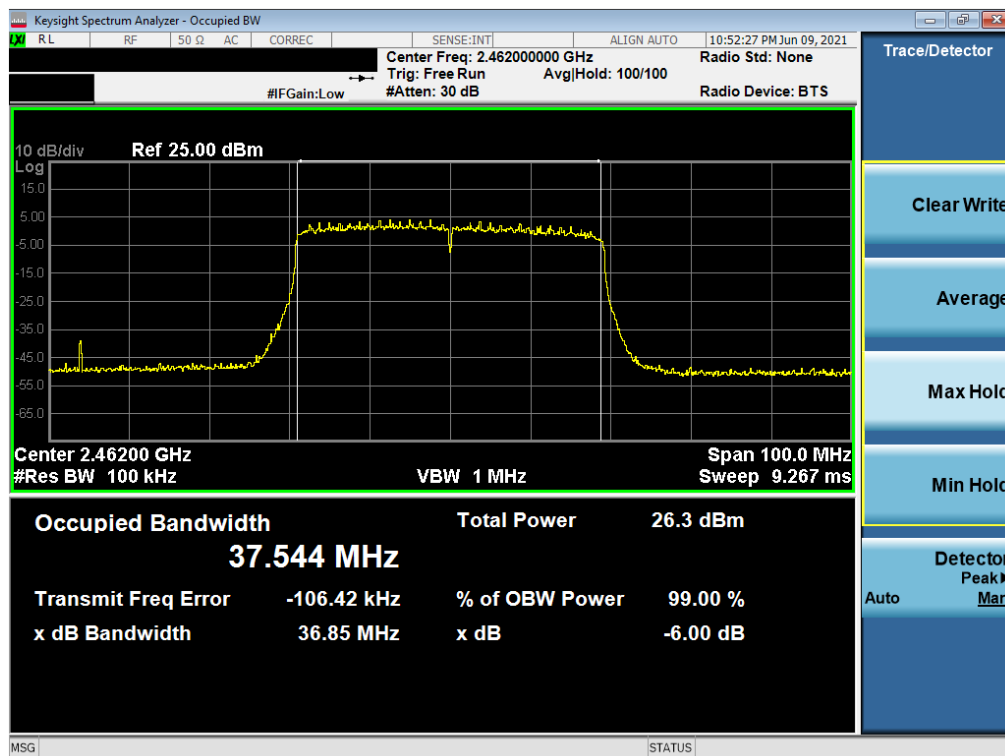


Plot 7-16. 6dB Bandwidth Plot SISO SOUTH (802.11ax 40MHz BW (2.4GHz) – Ch. 3)

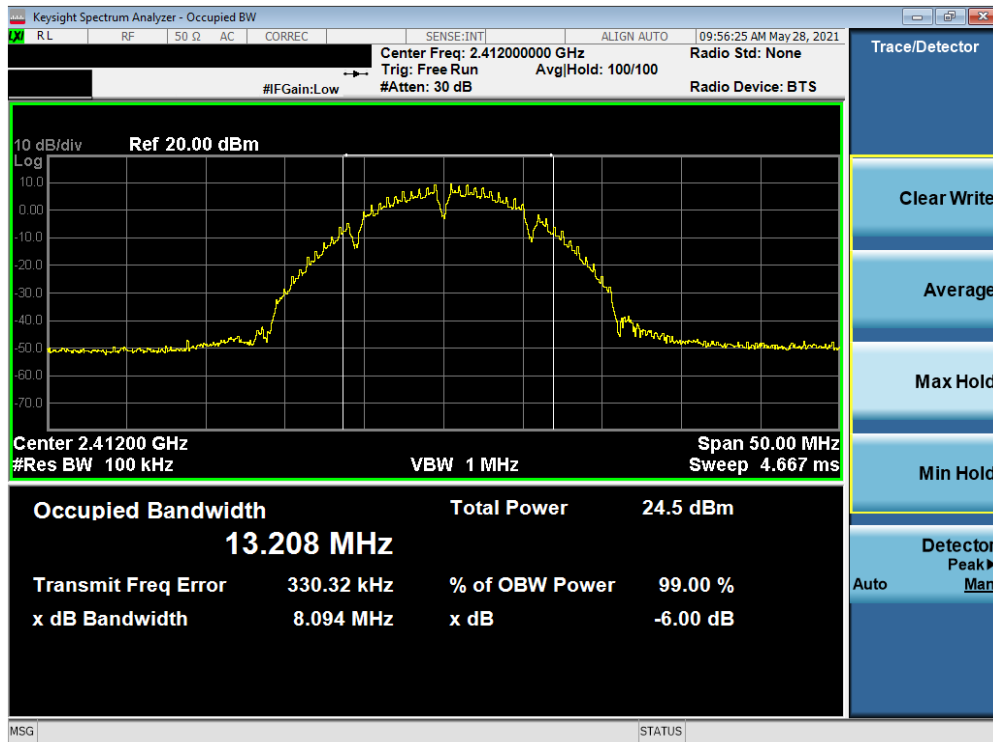

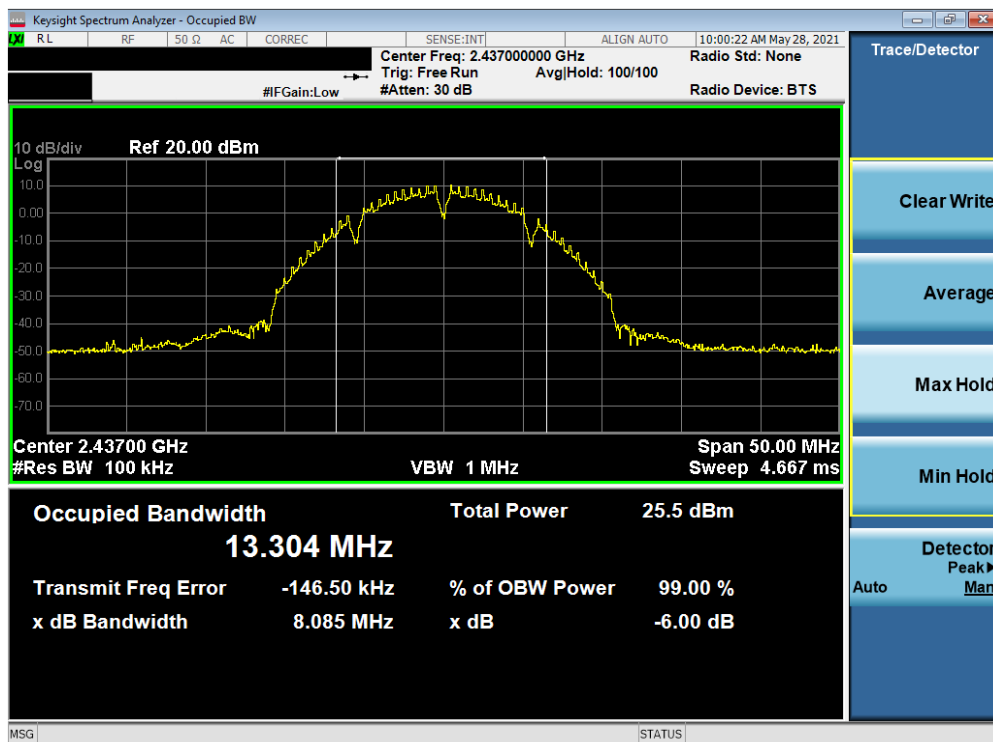

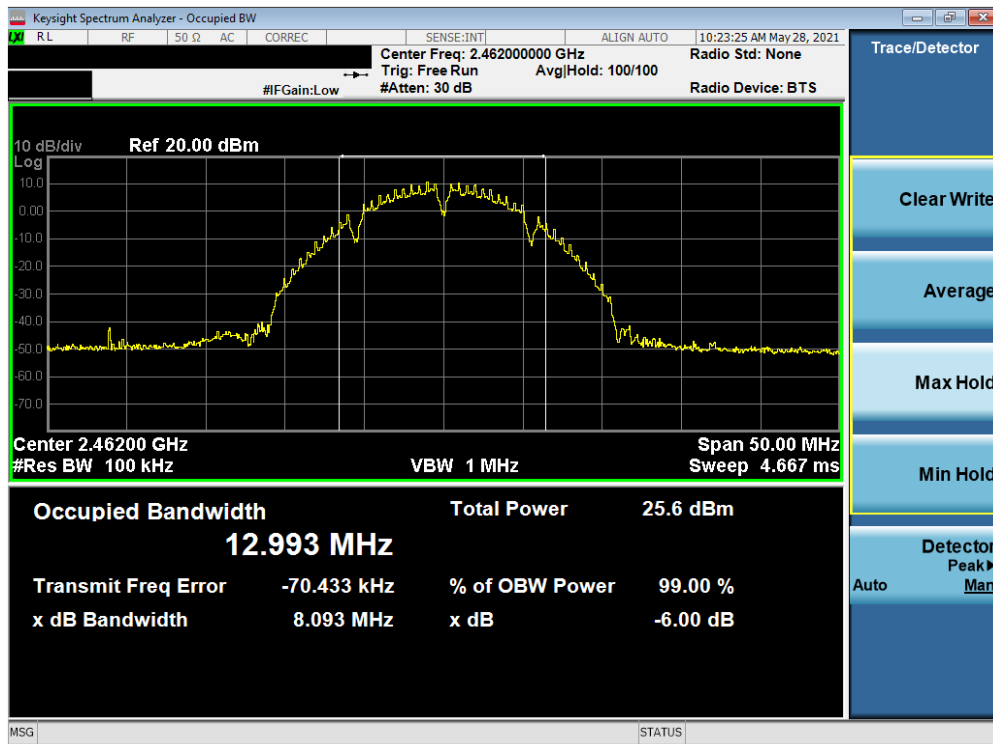


Plot 7-19. 6dB Bandwidth Plot SISO NORTH (802.11b – Ch. 1)

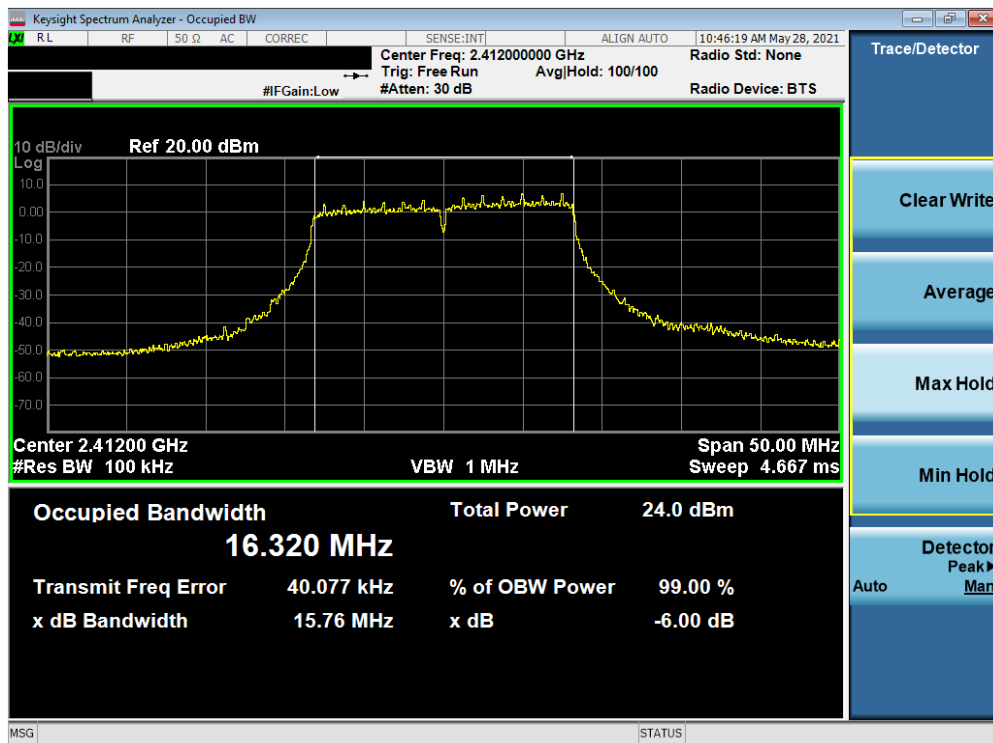


Plot 7-20. 6dB Bandwidth Plot SISO NORTH (802.11b – Ch. 6)

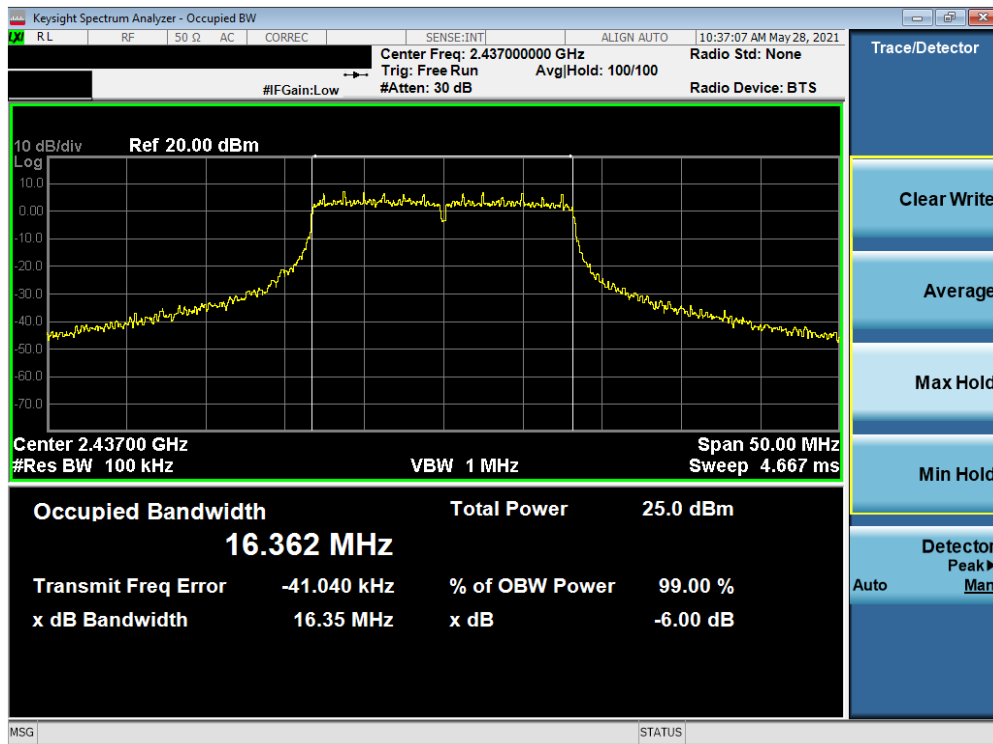


Plot 7-21. 6dB Bandwidth Plot SISO NORTH (802.11b – Ch. 11)

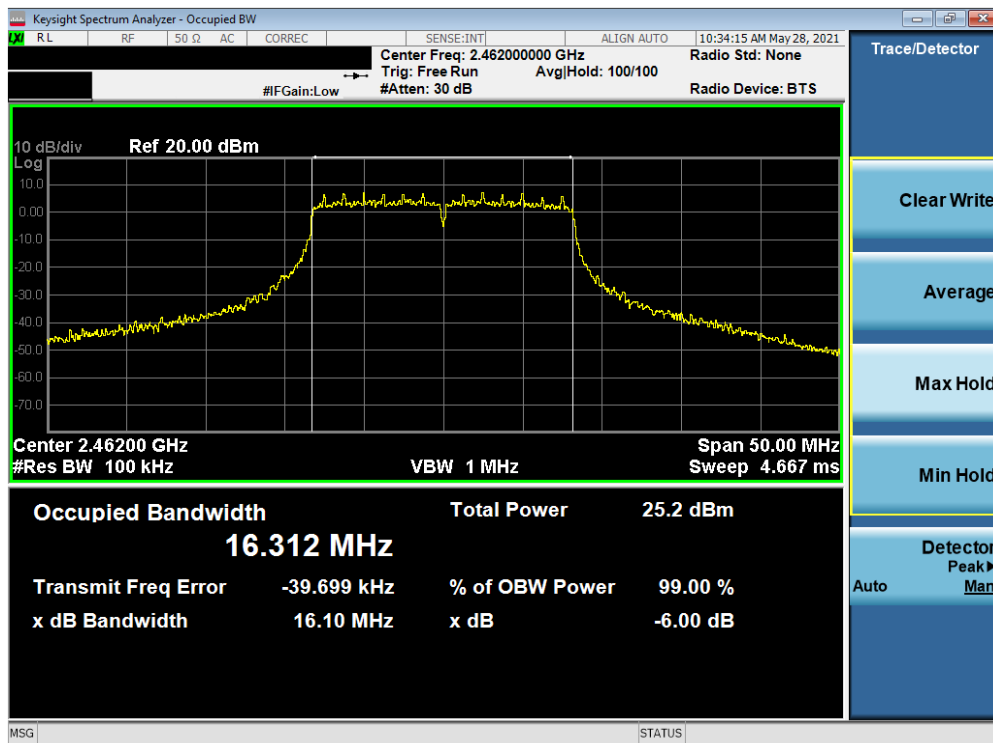


Plot 7-22. 6dB Bandwidth Plot SISO NORTH (802.11g – Ch. 1)

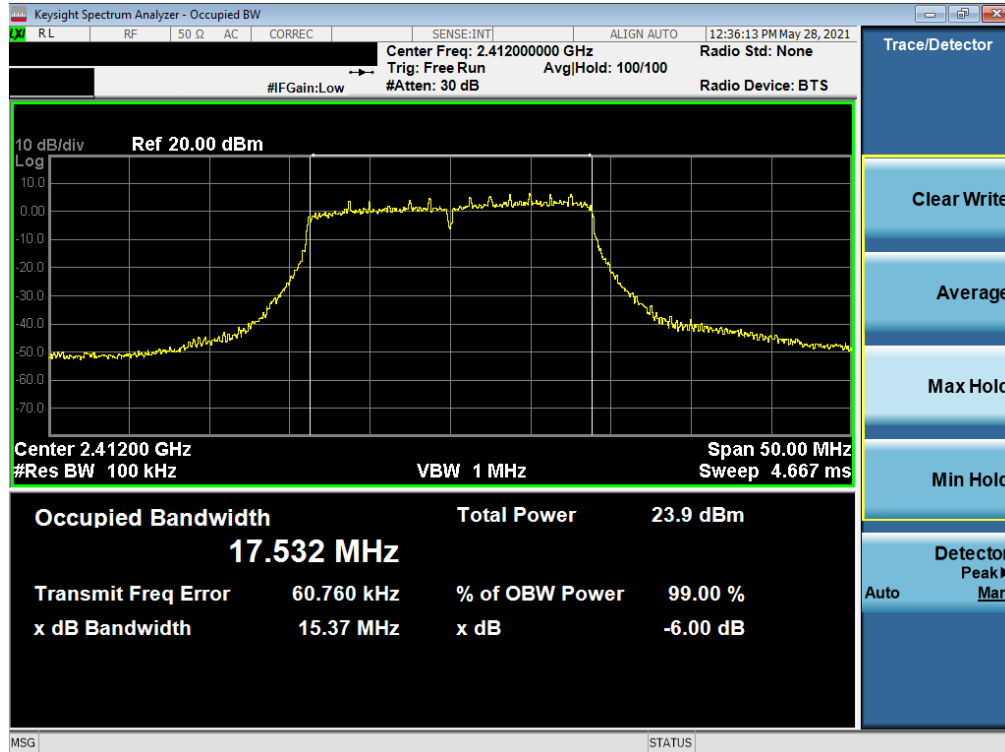


Plot 7-23. 6dB Bandwidth Plot SISO NORTH (802.11g – Ch. 6)

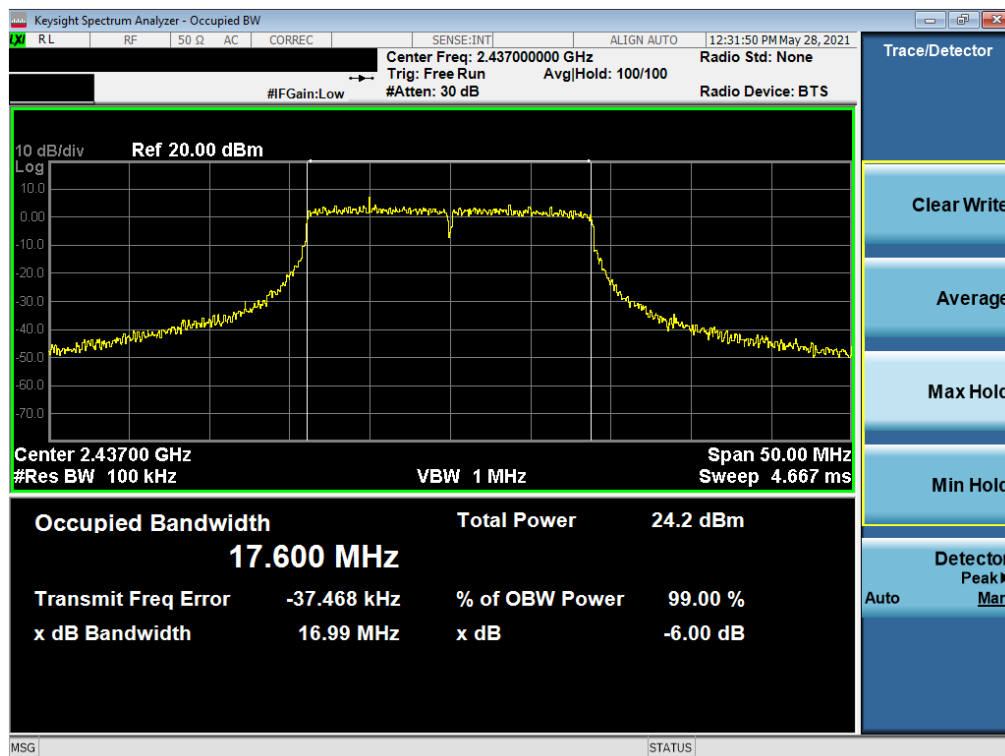


Plot 7-24. 6dB Bandwidth Plot SISO NORTH (802.11g – Ch. 11)

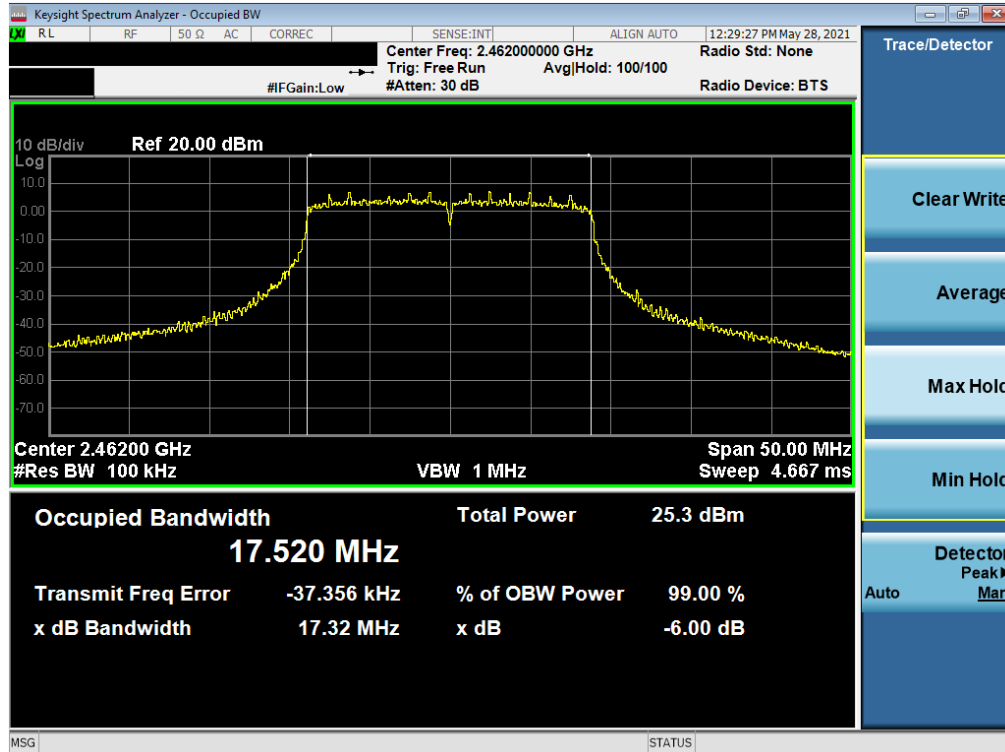


Plot 7-25. 6dB Bandwidth Plot SISO NORTH (802.11n 20MHz BW (2.4GHz) – Ch. 1)

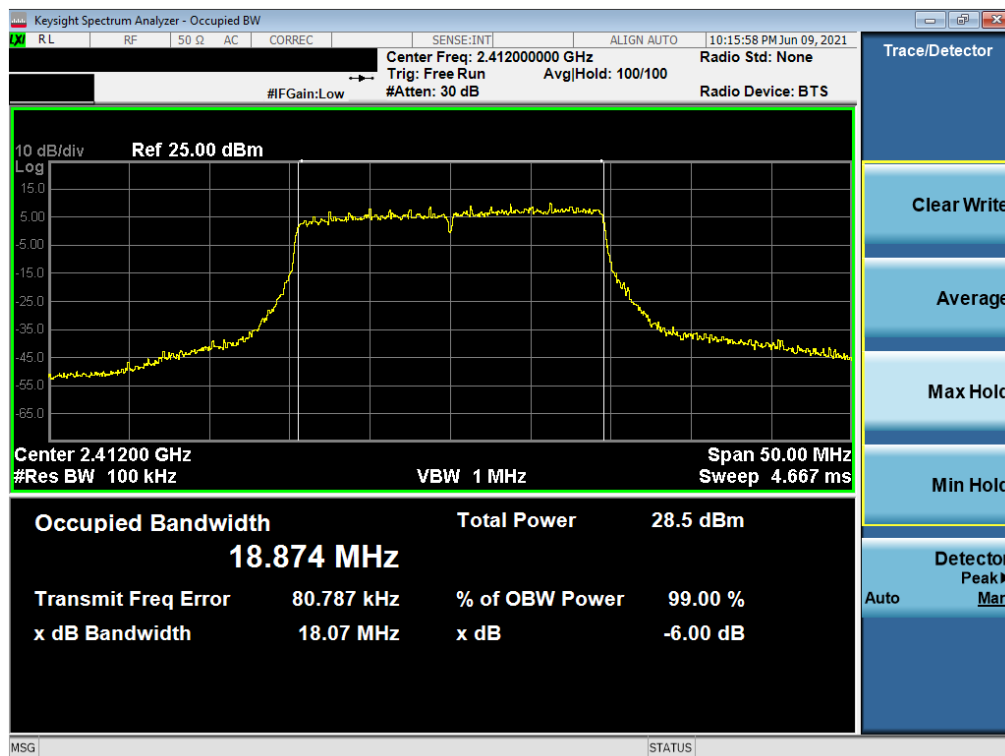


Plot 7-26. 6dB Bandwidth Plot SISO NORTH (802.11n 20MHz BW (2.4GHz) – Ch. 6)

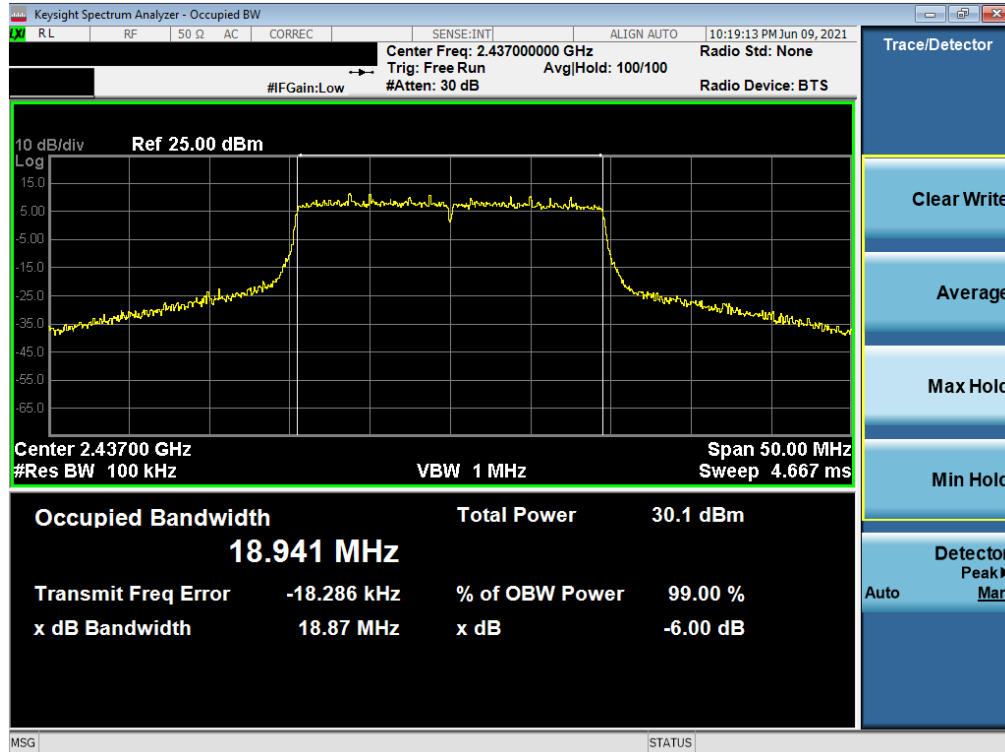


Plot 7-27. 6dB Bandwidth Plot SISO NORTH (802.11n 20MHz BW (2.4GHz) – Ch. 11)

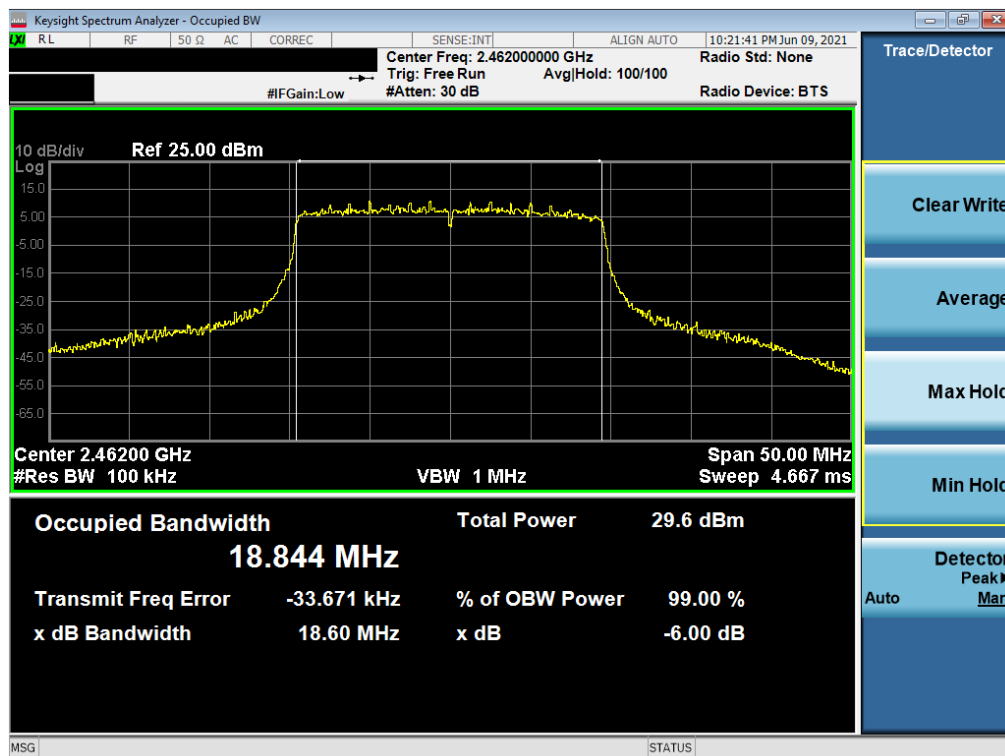


Plot 7-28. 6dB Bandwidth Plot SISO NORTH (802.11ax 20MHz BW (2.4GHz) – Ch. 1)

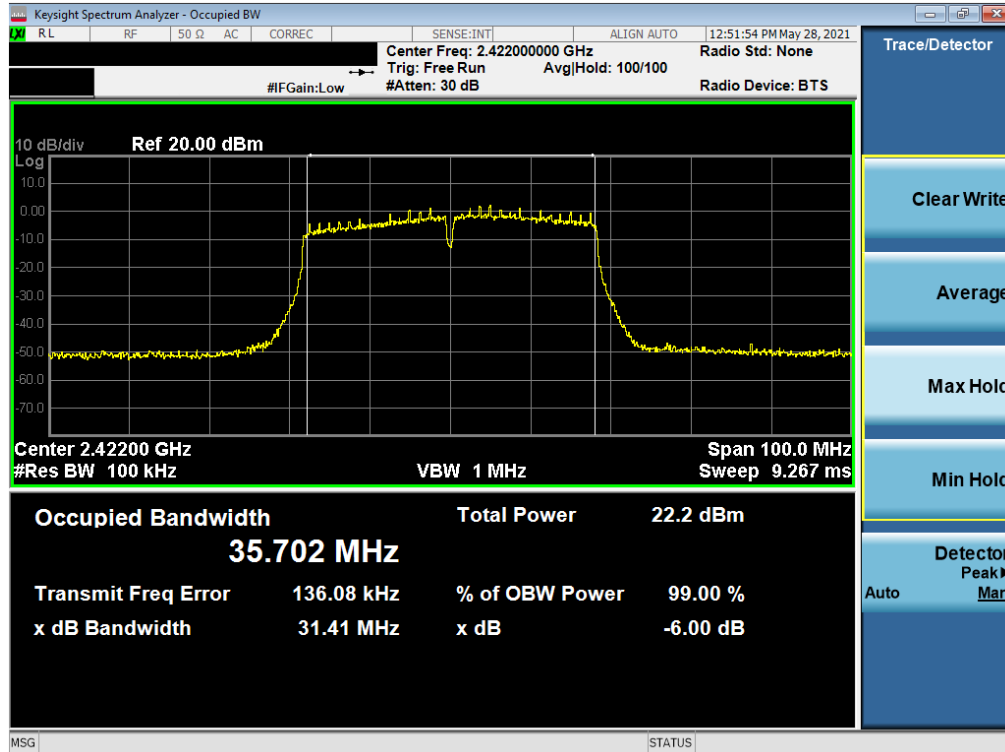


Plot 7-29. 6dB Bandwidth Plot SISO NORTH (802.11ax 20MHz BW (2.4GHz) – Ch. 6)

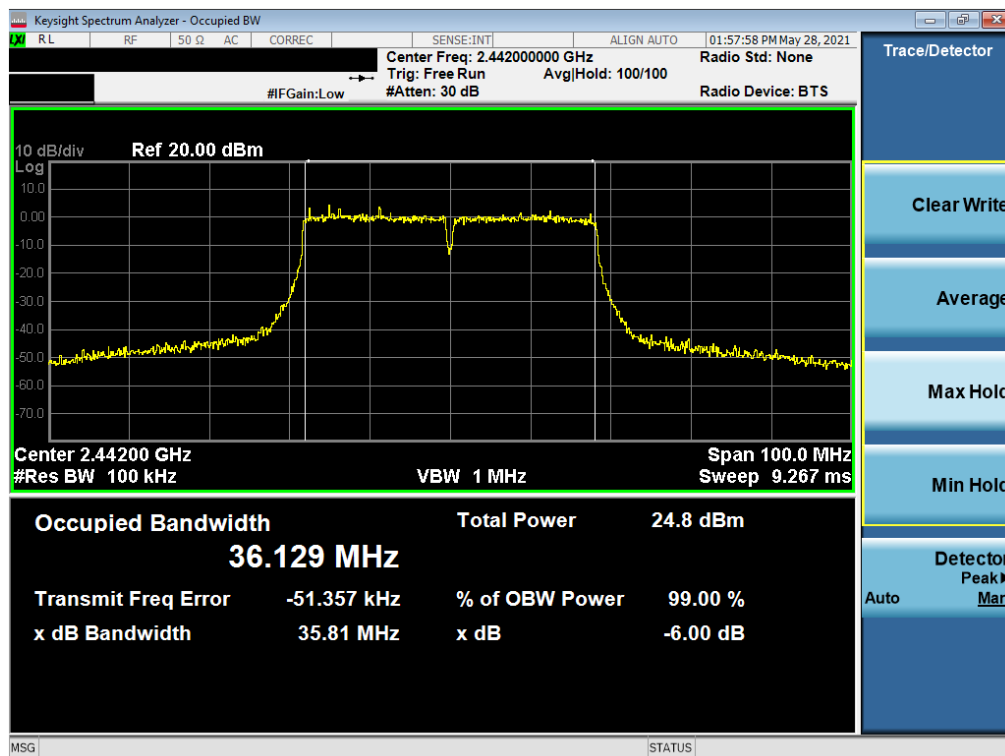


Plot 7-30. 6dB Bandwidth Plot SISO NORTH (802.11ax 20MHz BW (2.4GHz) – Ch. 11)

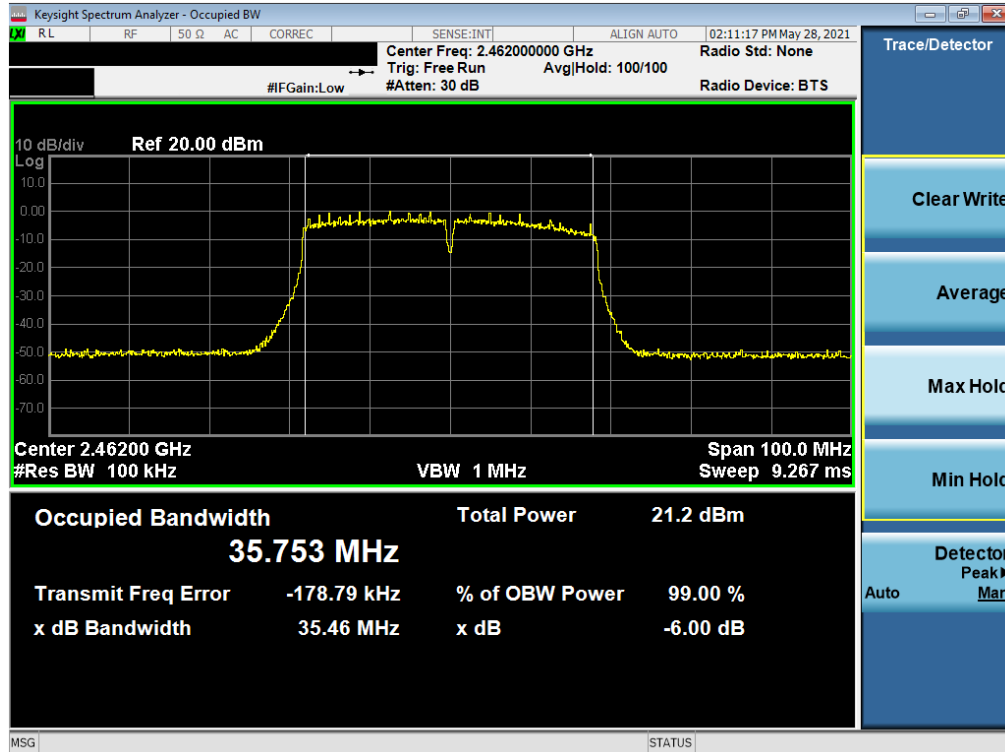


Plot 7-31. 6dB Bandwidth Plot SISO NORTH (802.11n 40MHz BW (2.4GHz) – Ch. 3)

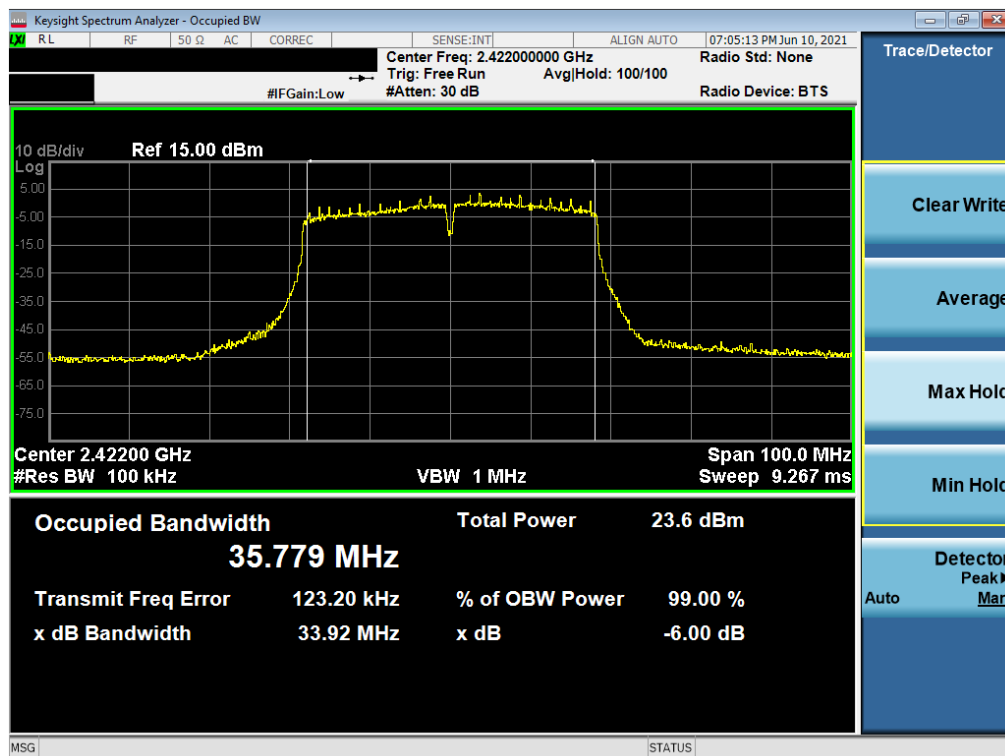


Plot 7-32. 6dB Bandwidth Plot SISO NORTH (802.11n 40MHz BW (2.4GHz) – Ch. 7)

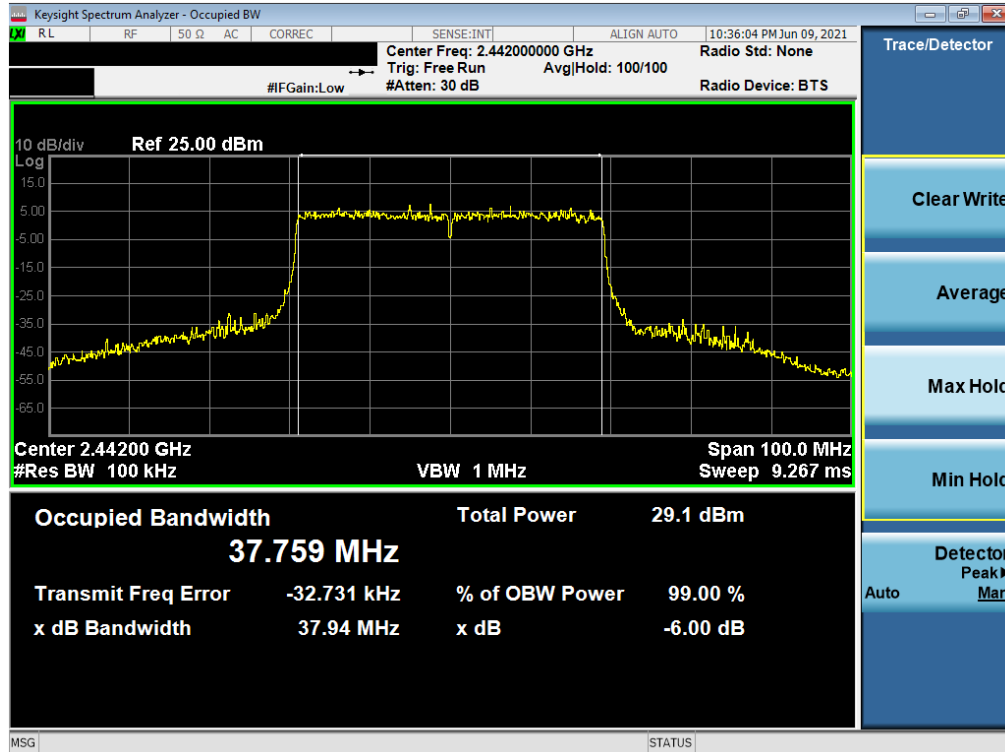


Plot 7-33. 6dB Bandwidth Plot SISO NORTH (802.11n 40MHz BW (2.4GHz) – Ch. 11)

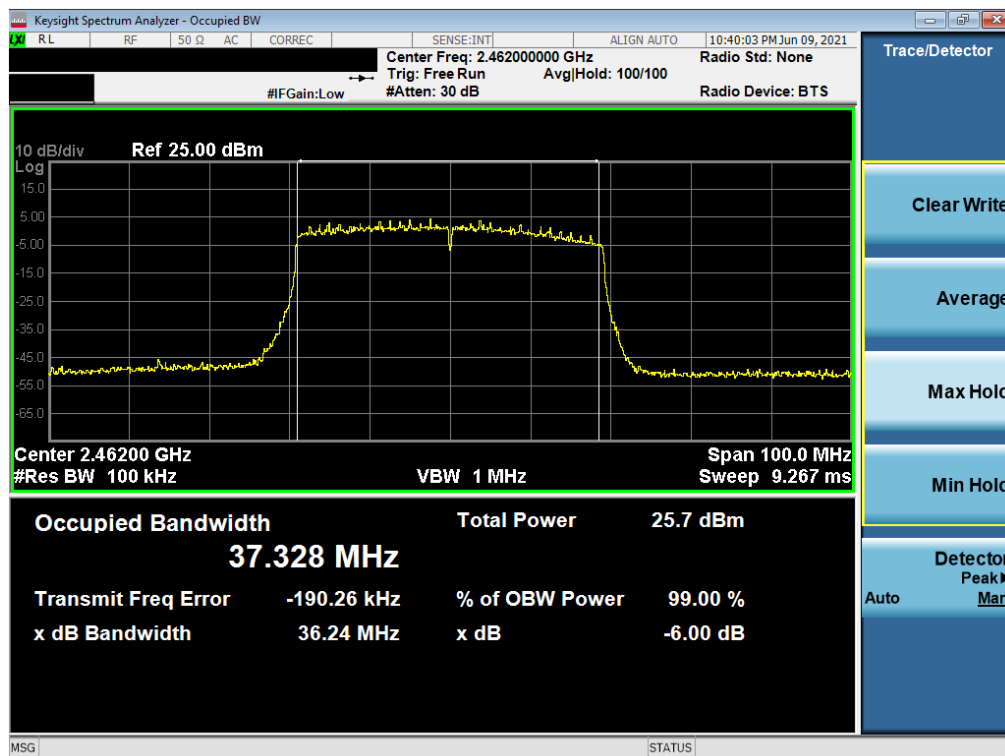


Plot 7-34. 6dB Bandwidth Plot SISO NORTH (802.11ax 40MHz BW (2.4GHz) – Ch. 3)

Test Settings

Method PKPM1 (Peak Power Measurement)

Peak power measurements were performed only when the EUT was transmitting at its maximum power control level using a broadband power meter with a pulse sensor. The pulse sensor employs a VBW = 50MHz so this method was only used for signals whose DTS bandwidth was less than or equal to 50MHz.

Method AVGPM-G (Average Power Measurement)

Average power measurements were performed only when the EUT was transmitting at its maximum power control level using a broadband power meter with a pulse sensor. The power meter implemented triggering and gating capabilities which were set up such that power measurements were recorded only during the ON time of the transmitter. The trace was averaged over 100 traces to obtain the final measured average power.

7.4 Power Spectral Density

Test Overview and Limit

The peak power density is measured with a spectrum analyzer connected to the antenna terminal of the EUT while the EUT is operating at its maximum duty cycle, at maximum power, and at the appropriate frequencies. All data rates were investigated and the worst case configuration results are reported in this section.

The maximum permissible power spectral density is 8 dBm in any 3 kHz band.

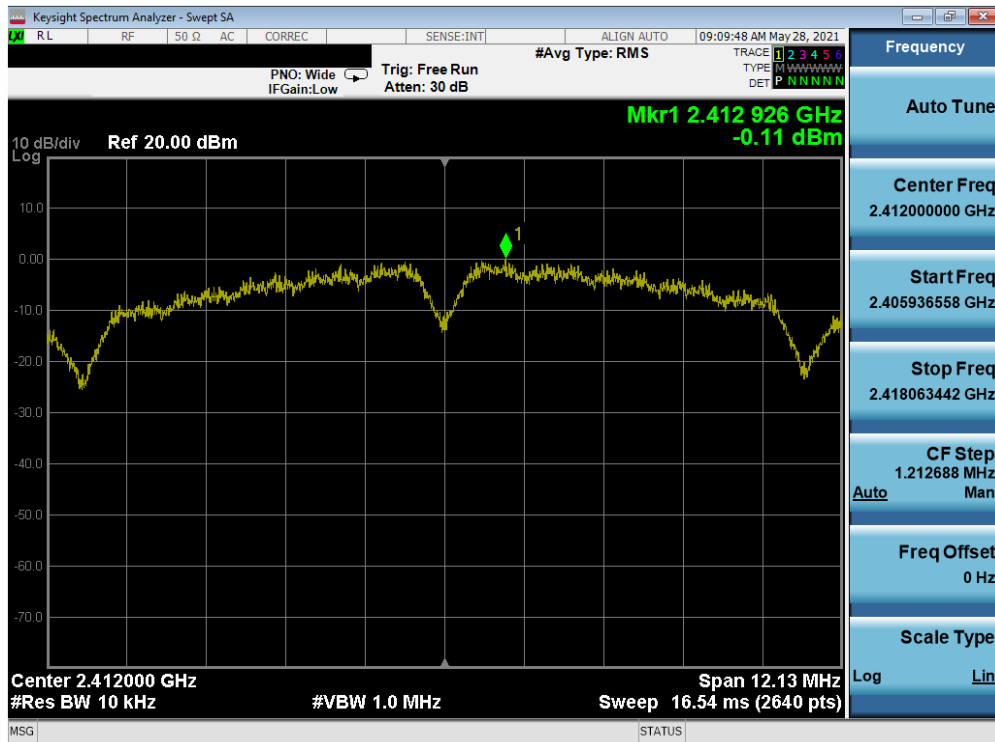

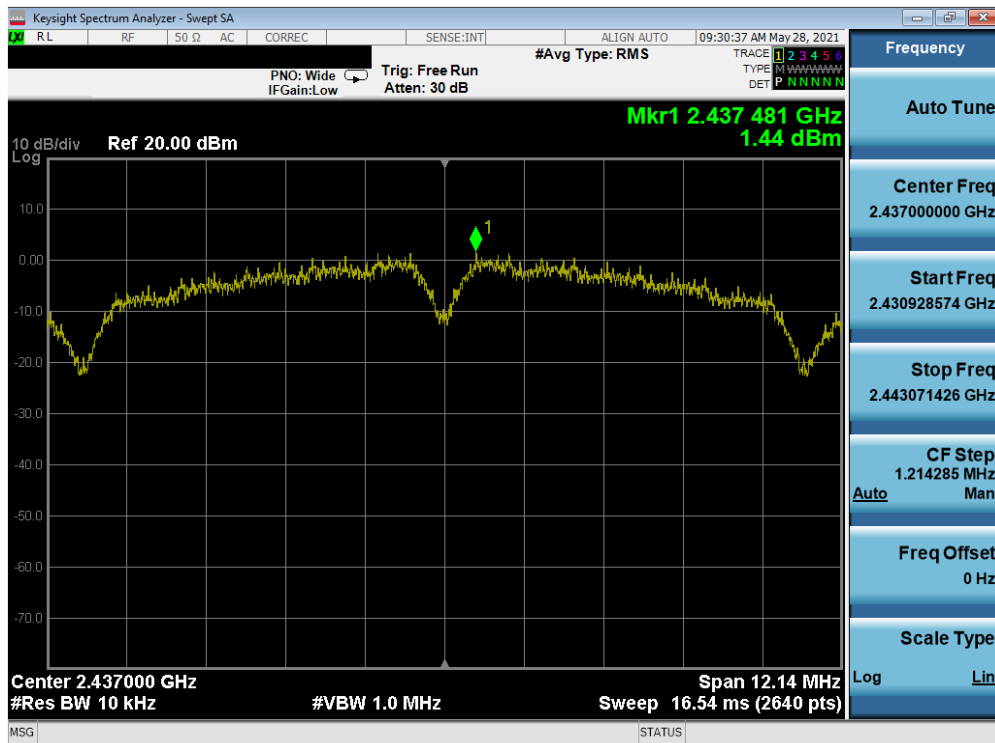

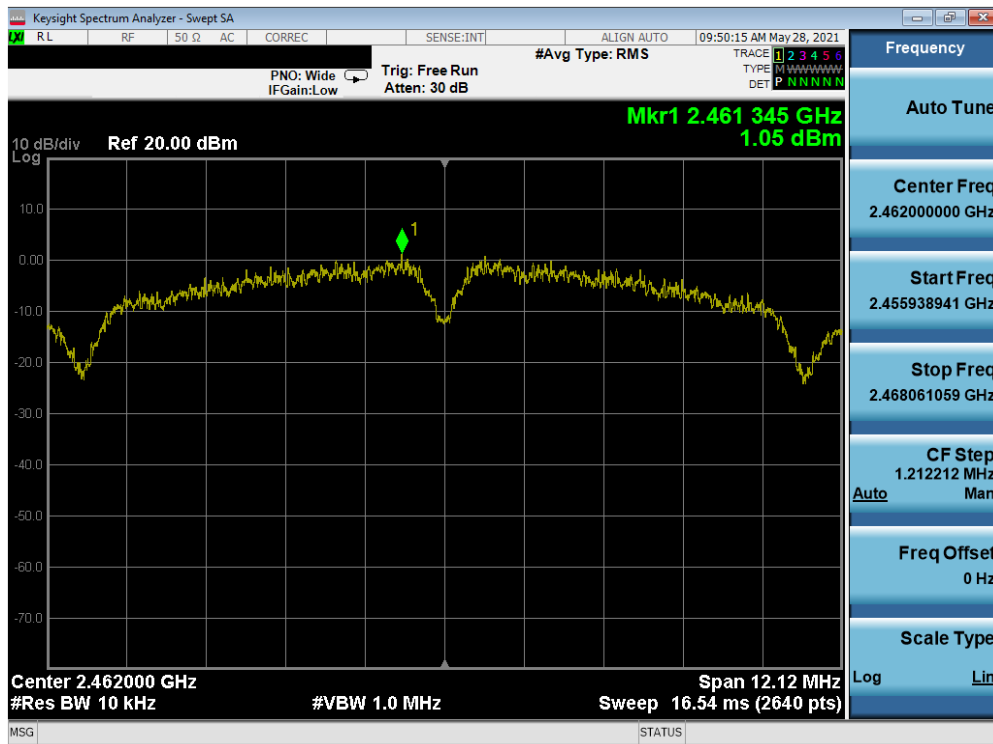


Plot 7-37. Power Spectral Density Plot SISO SOUTH (802.11b – Ch. 1)

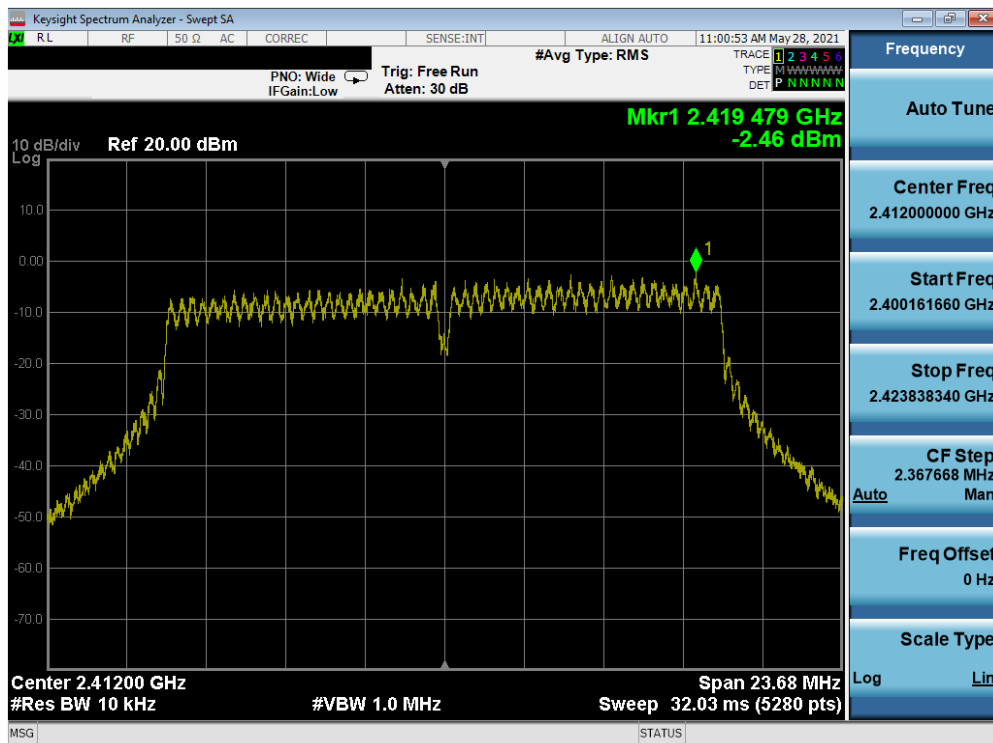


Plot 7-38. Power Spectral Density Plot SISO SOUTH (802.11b – Ch. 6)

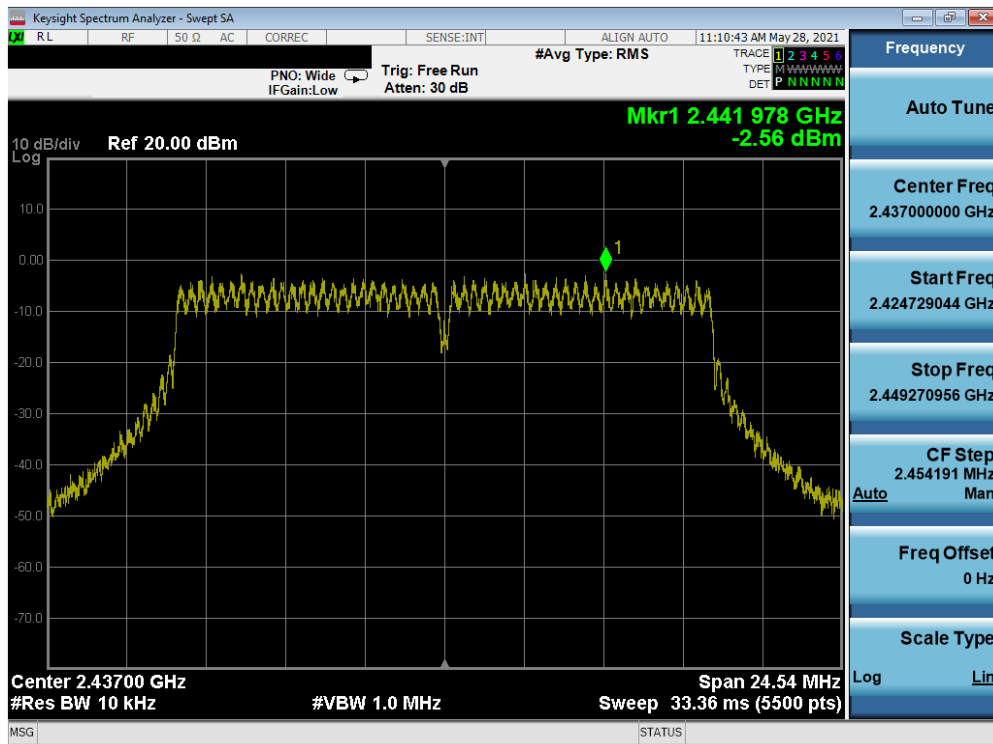


Plot 7-39. Power Spectral Density Plot SISO SOUTH (802.11b – Ch. 11)

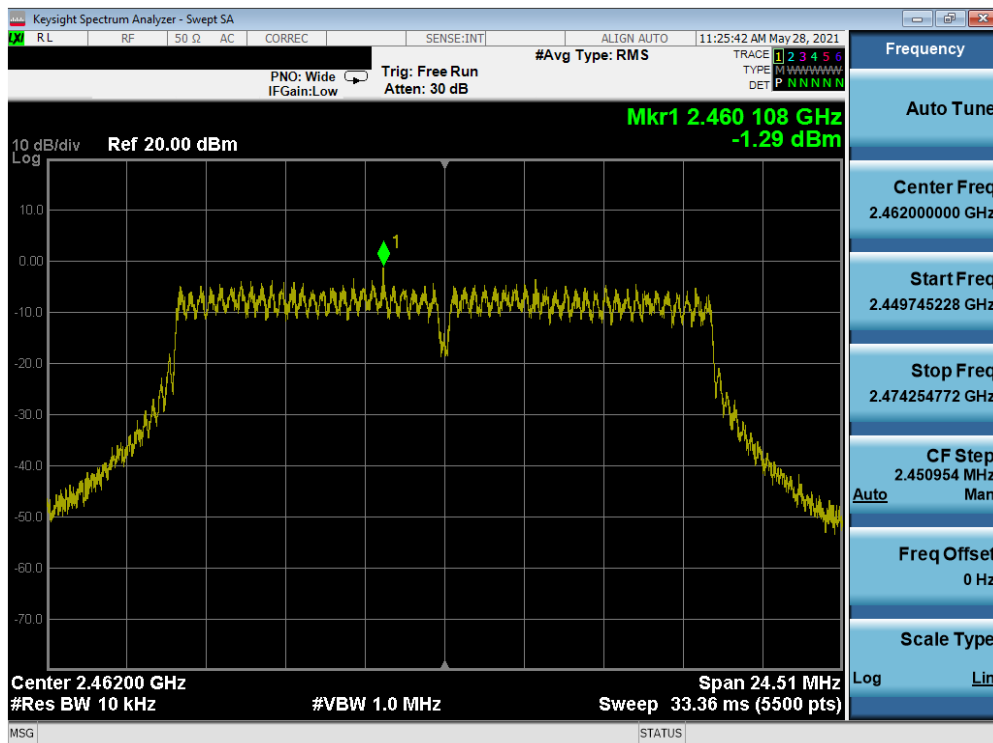


Plot 7-40. Power Spectral Density Plot SISO SOUTH (802.11g – Ch. 1)

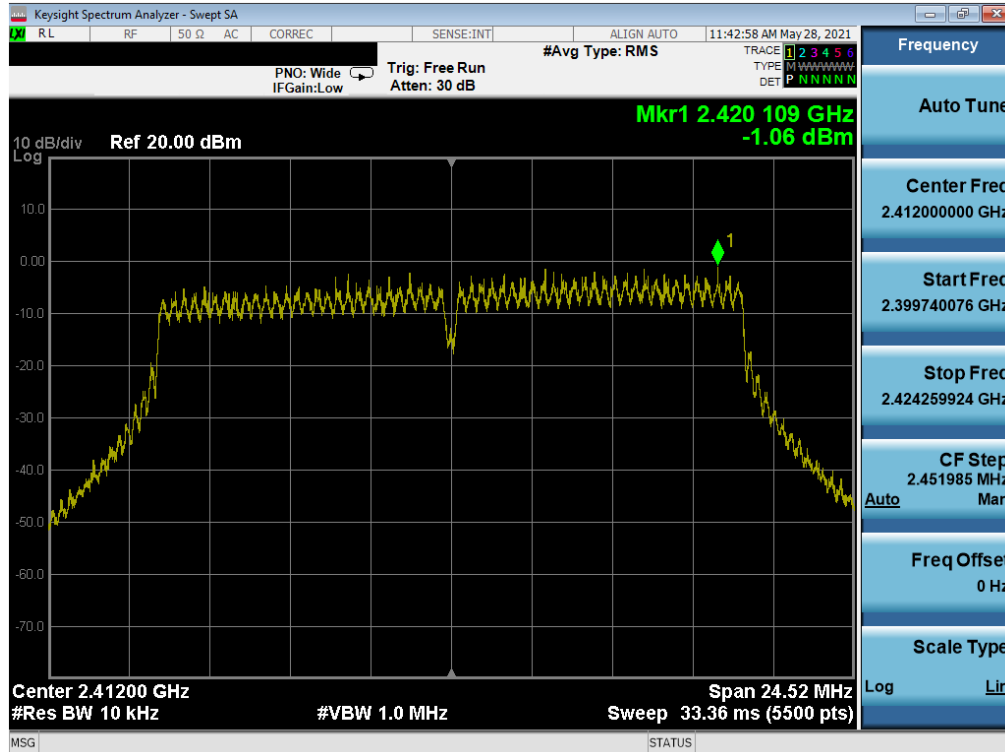


Plot 7-41. Power Spectral Density Plot SISO SOUTH (802.11g – Ch. 6)

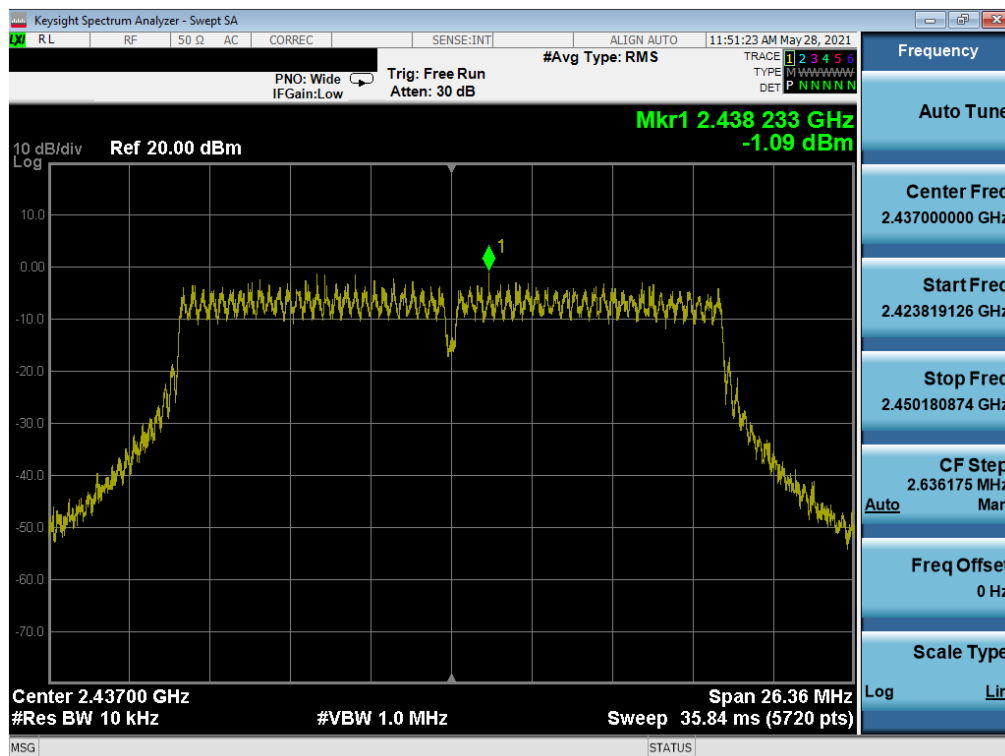


Plot 7-42. Power Spectral Density Plot SISO SOUTH (802.11g – Ch. 11)

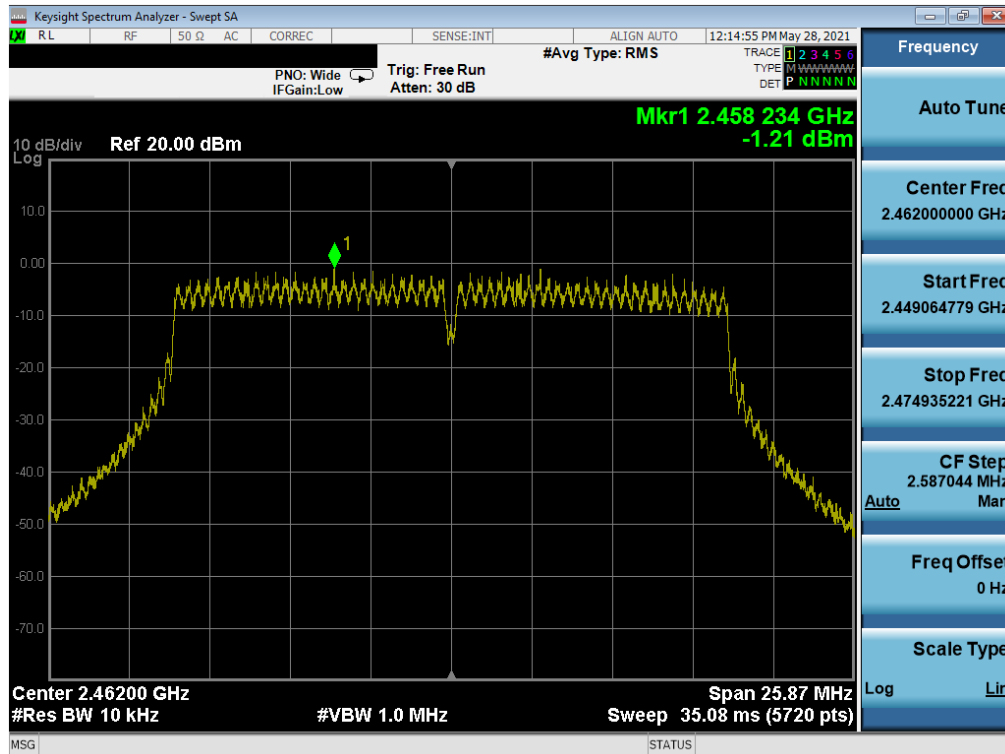


Plot 7-43. Power Spectral Density Plot SISO SOUTH (802.11n 20MHz BW (2.4GHz) – Ch. 1)

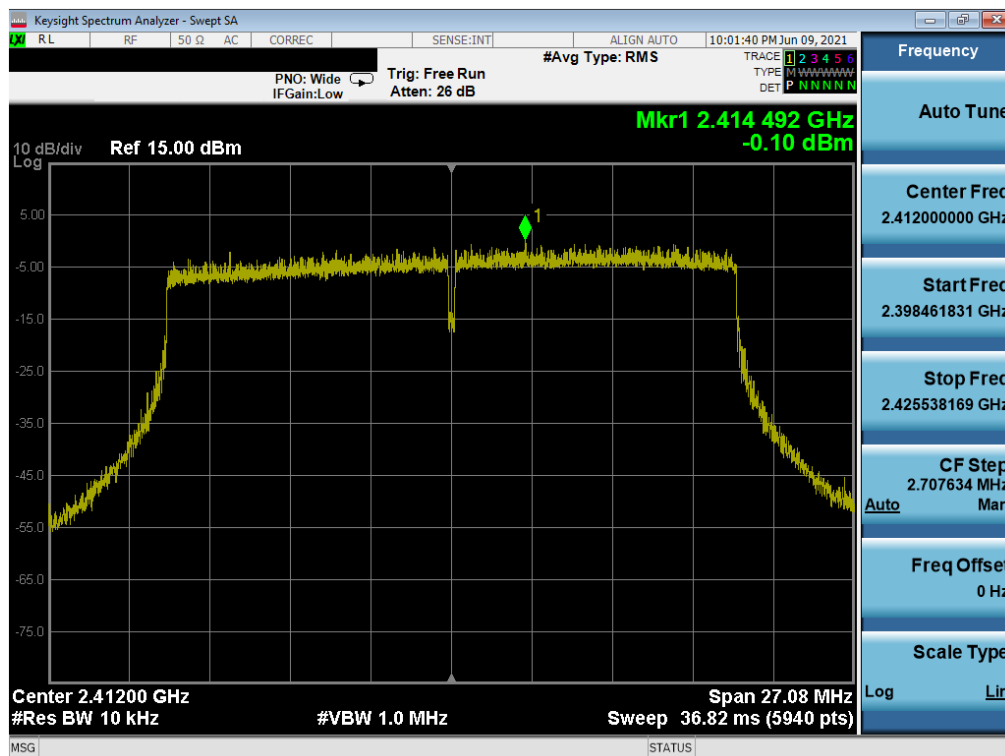


Plot 7-44. Power Spectral Density Plot SISO SOUTH (802.11n 20MHz BW (2.4GHz) – Ch. 6)

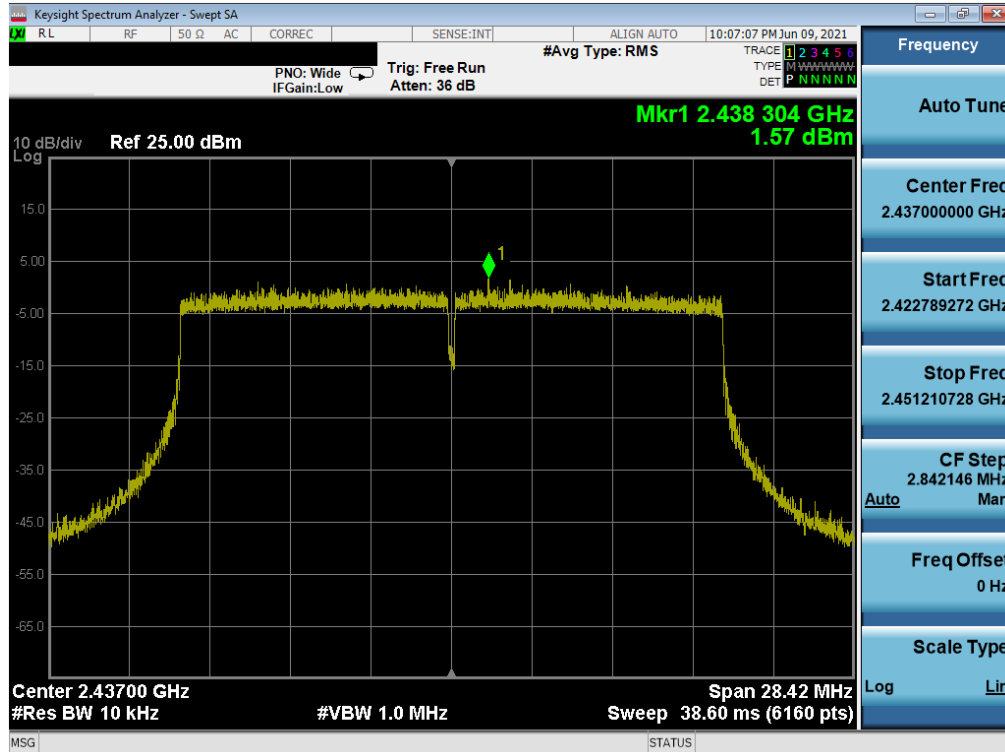


Plot 7-45. Power Spectral Density Plot SISO SOUTH (802.11n 20MHz BW (2.4GHz) – Ch. 11)

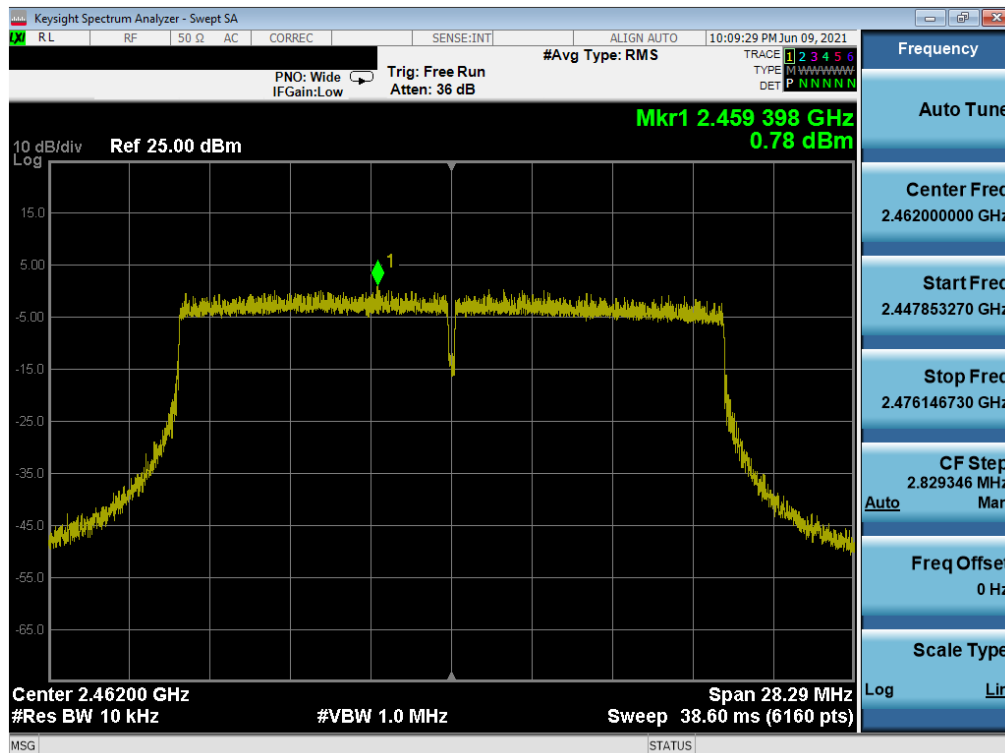


Plot 7-46. Power Spectral Density Plot SISO SOUTH (802.11ax 20MHz BW (2.4GHz) – Ch. 1)

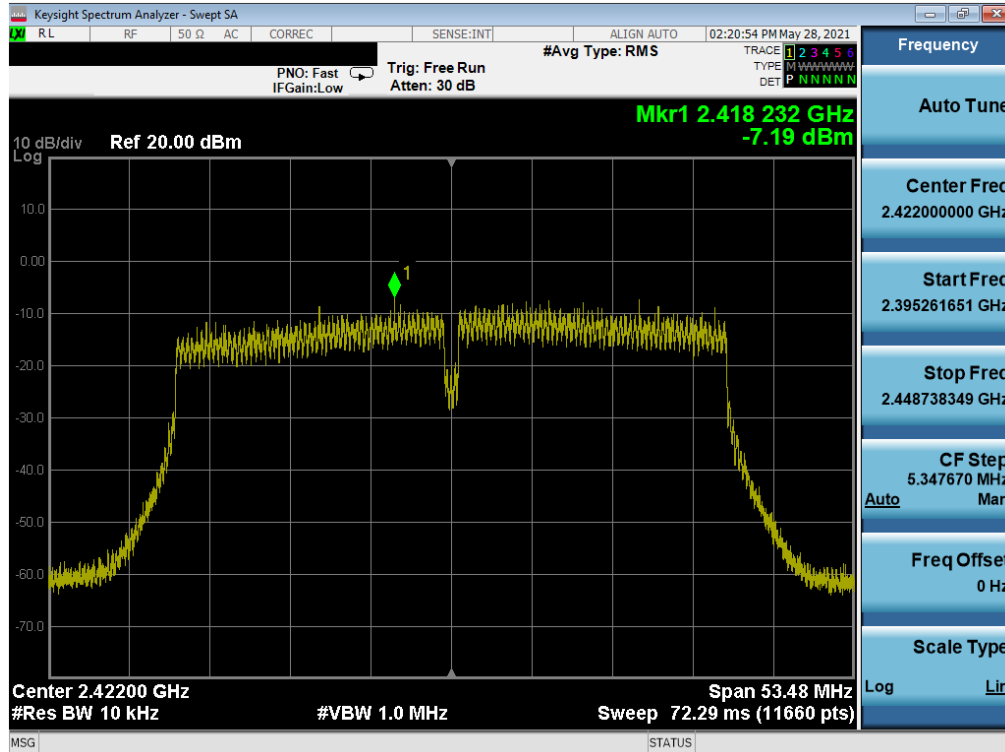


Plot 7-47. Power Spectral Density Plot SISO SOUTH (802.11ax 20MHz BW (2.4GHz) – Ch. 6)

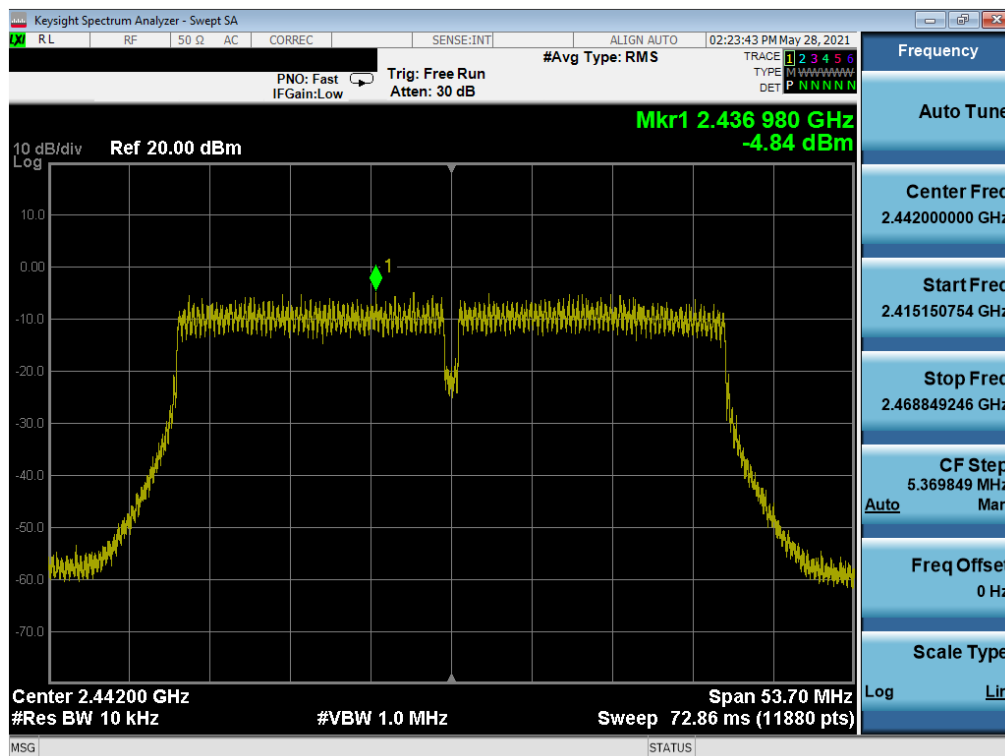


Plot 7-48. Power Spectral Density Plot SISO SOUTH (802.11ax 20MHz BW (2.4GHz) – Ch. 11)

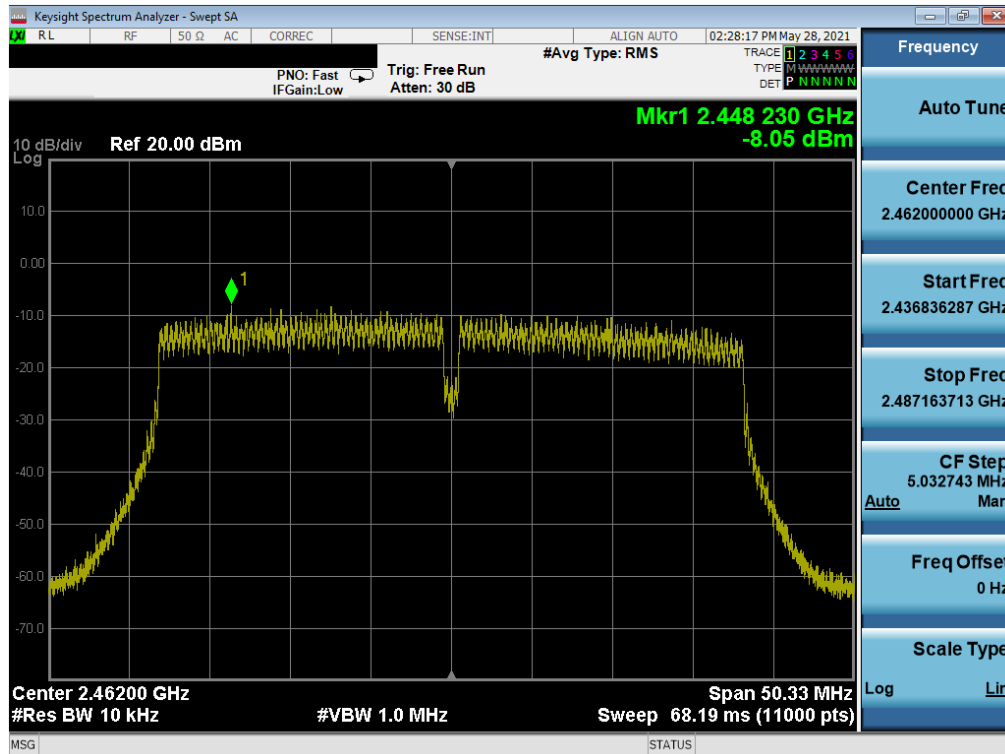


Plot 7-49. Power Spectral Density Plot SISO SOUTH (802.11n 40MHz BW (2.4GHz) – Ch. 3)

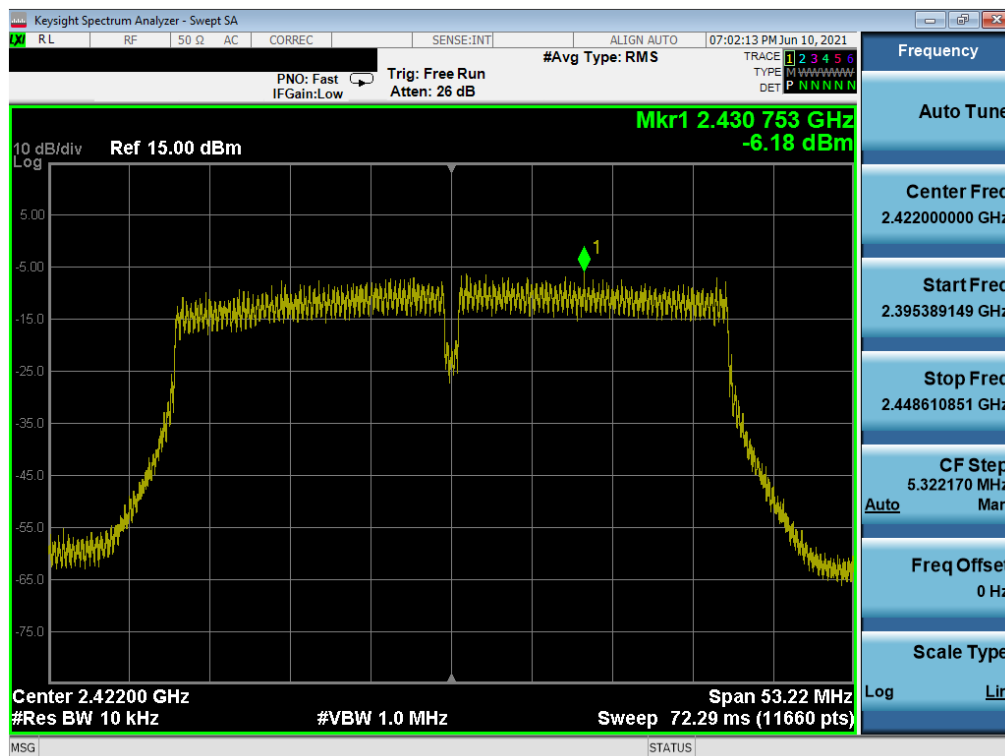


Plot 7-50. Power Spectral Density Plot SISO SOUTH (802.11n 40MHz BW (2.4GHz) – Ch. 7)

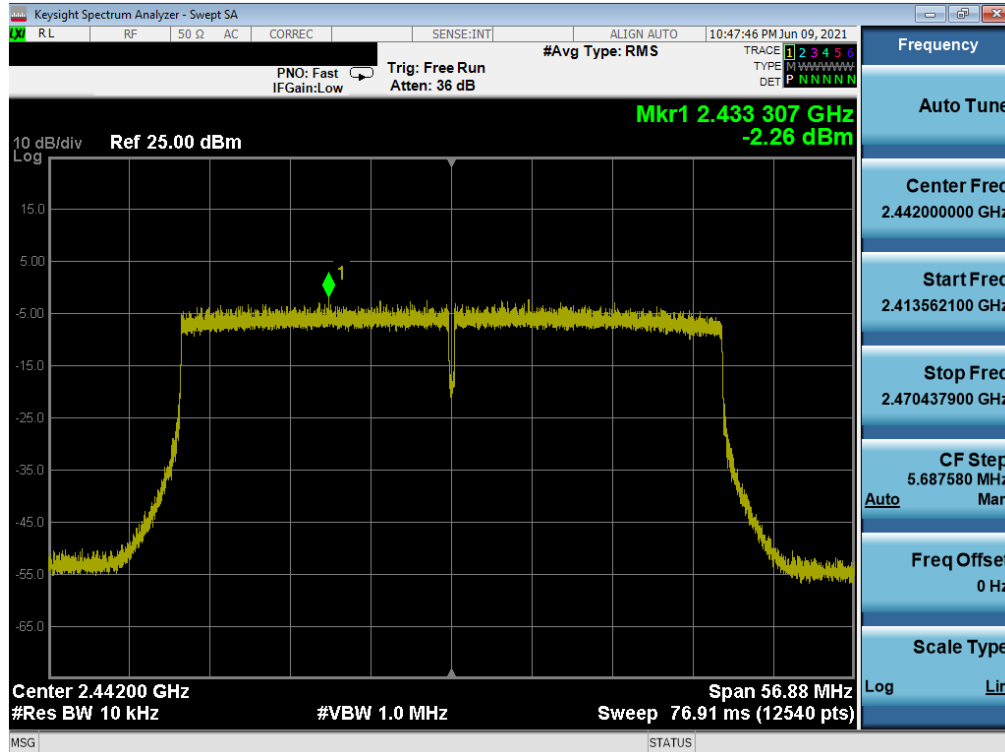


Plot 7-51. Power Spectral Density Plot SISO SOUTH (802.11n 40MHz BW (2.4GHz) – Ch. 11)

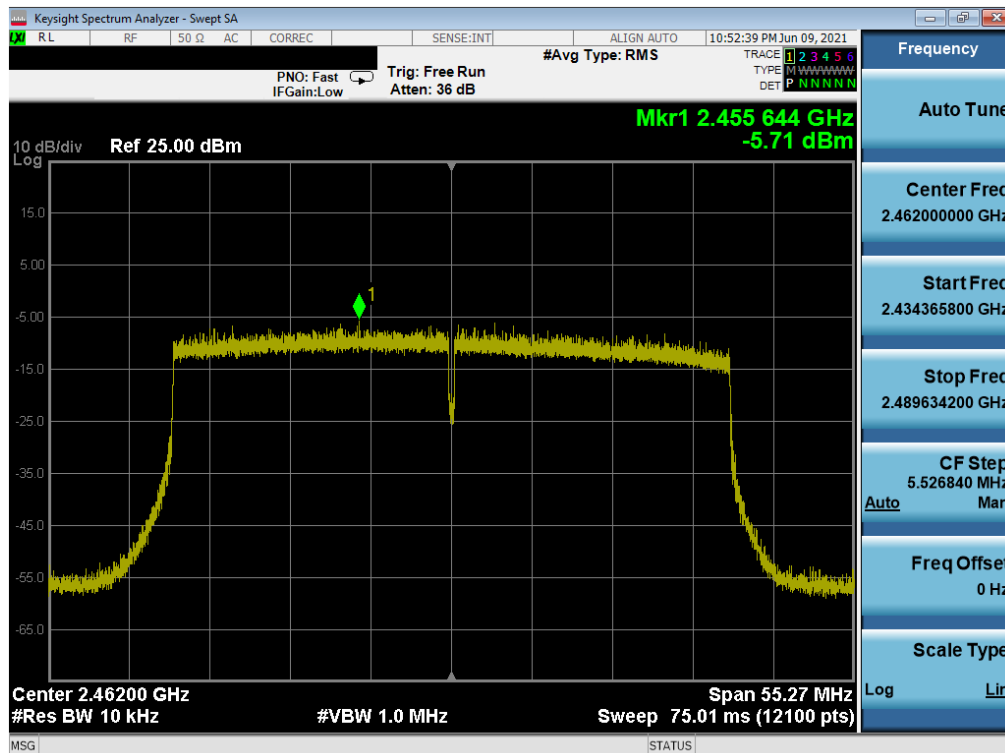


Plot 7-52. Power Spectral Density Plot SISO SOUTH (802.11ax 40MHz BW (2.4GHz) – Ch. 3)

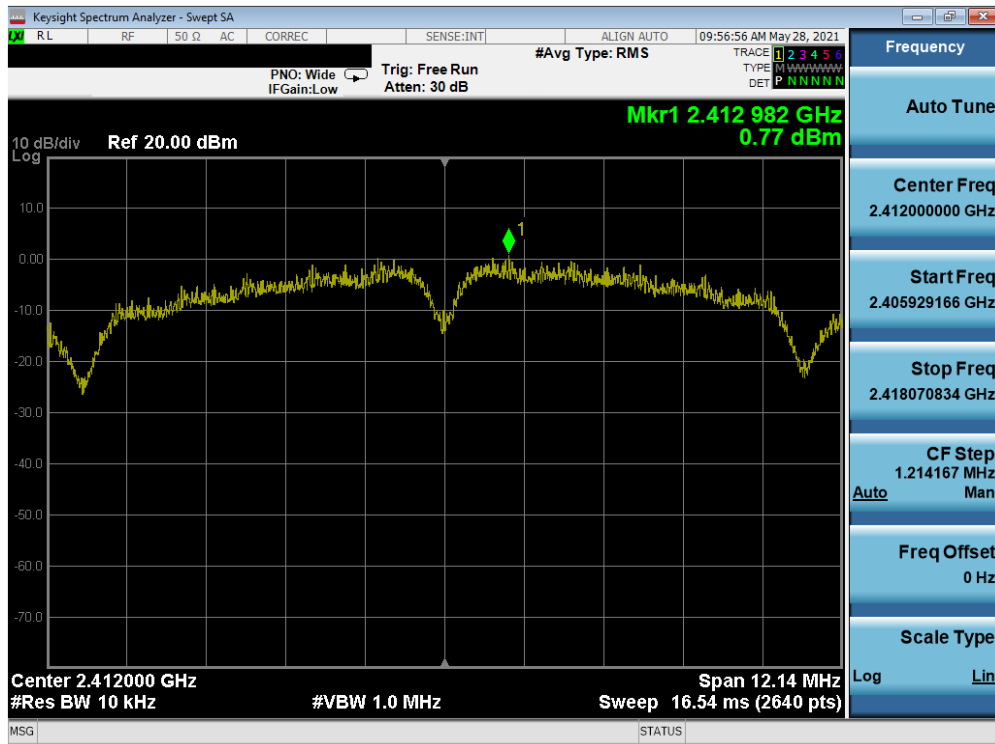

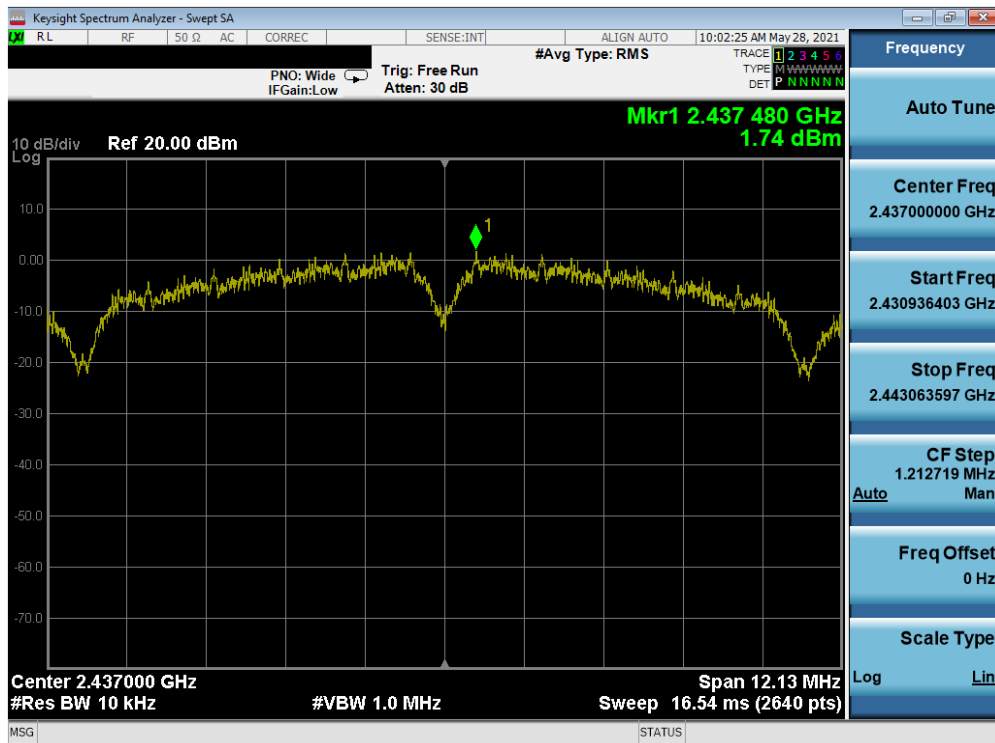

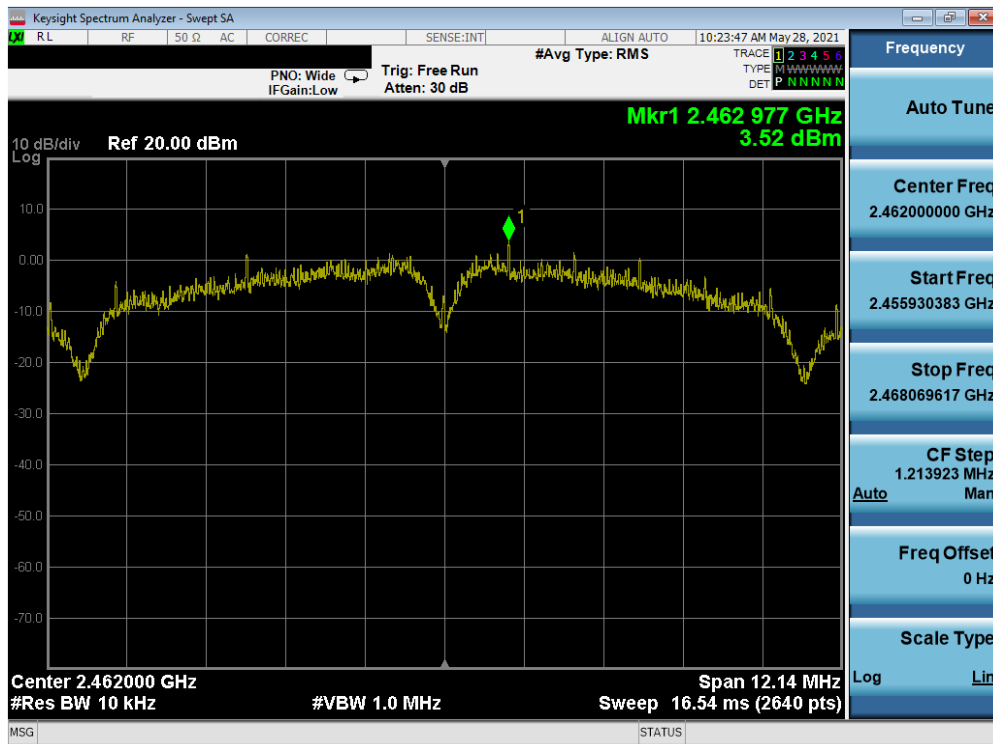


Plot 7-55. Power Spectral Density Plot SISO NORTH (802.11b – Ch. 1)

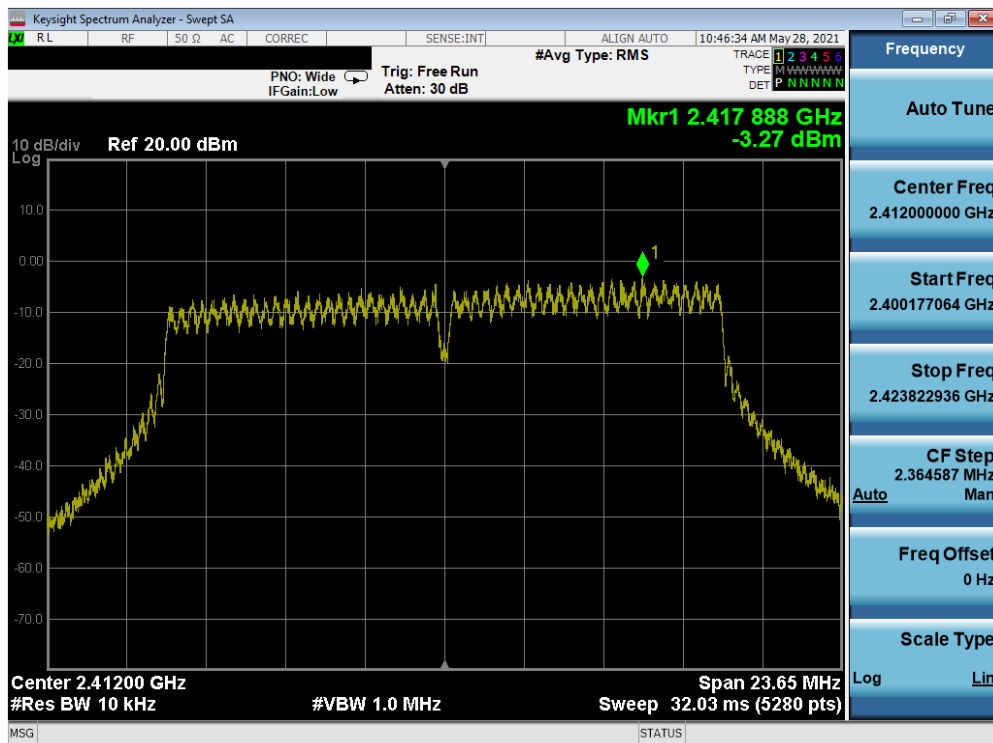


Plot 7-56. Power Spectral Density Plot SISO NORTH (802.11b – Ch. 6)

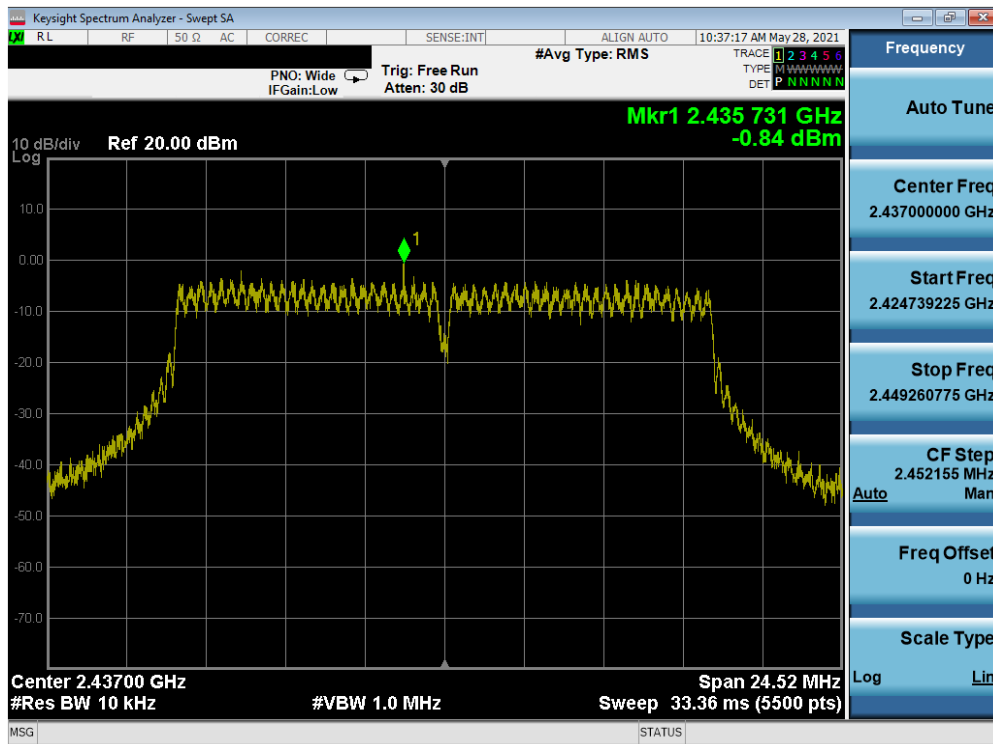


Plot 7-57. Power Spectral Density Plot SISO NORTH (802.11b – Ch. 11)

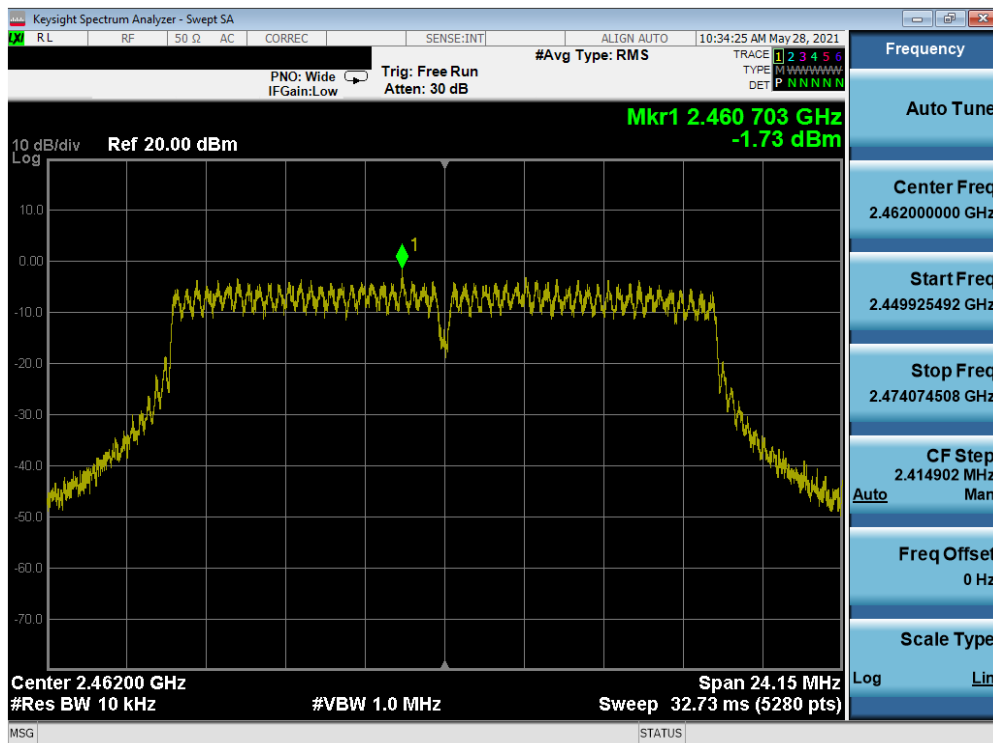


Plot 7-58. Power Spectral Density Plot SISO NORTH (802.11g – Ch. 1)

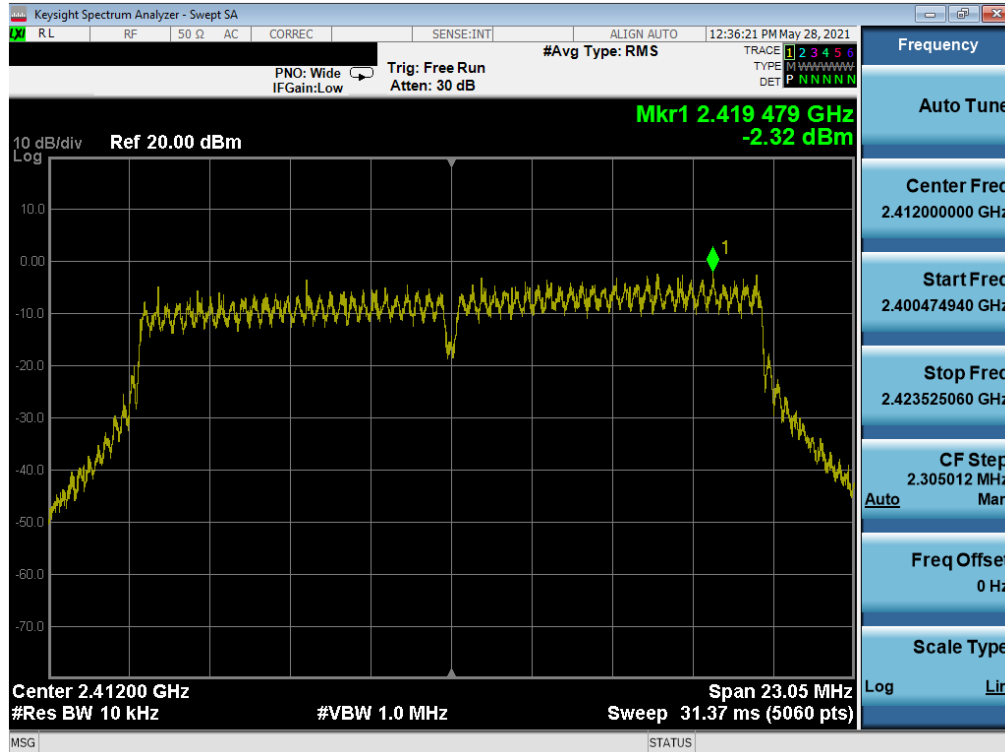


Plot 7-59. Power Spectral Density Plot SISO NORTH (802.11g – Ch. 6)

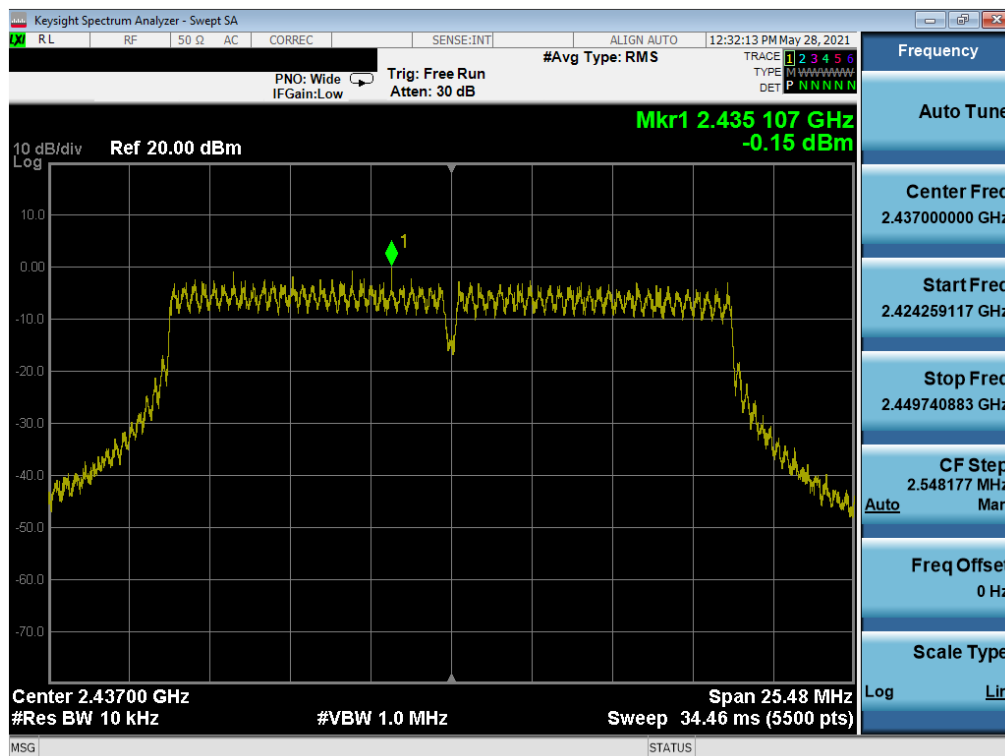


Plot 7-60. Power Spectral Density Plot SISO NORTH (802.11g – Ch. 11)

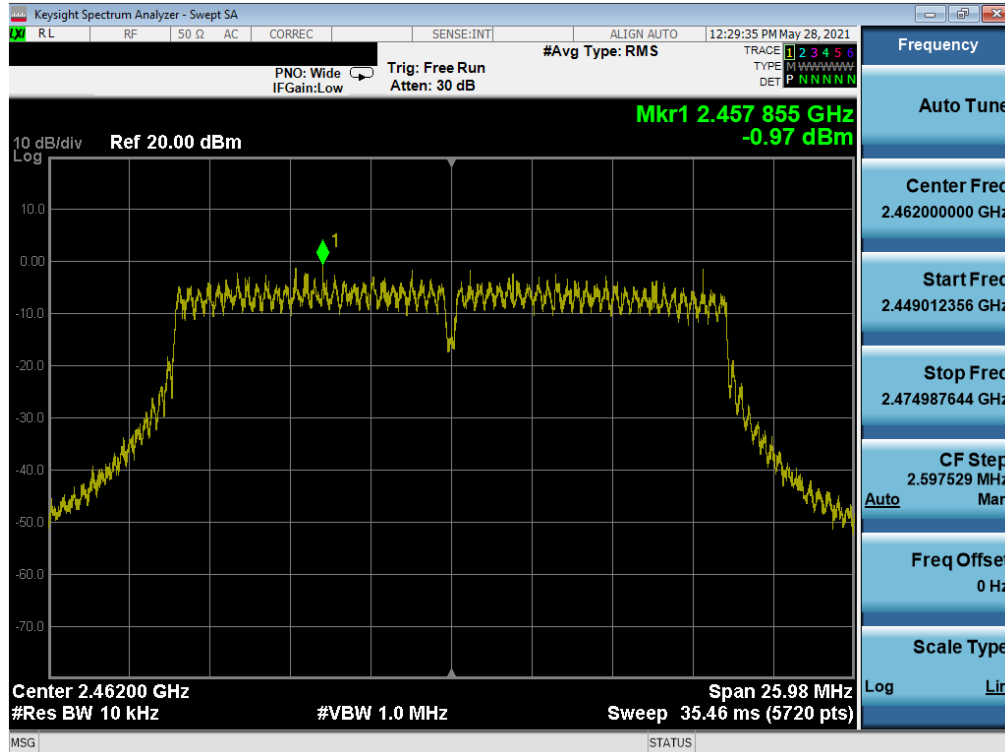


Plot 7-61. Power Spectral Density Plot SISO NORTH (802.11n 20MHz BW (2.4GHz) – Ch. 1)

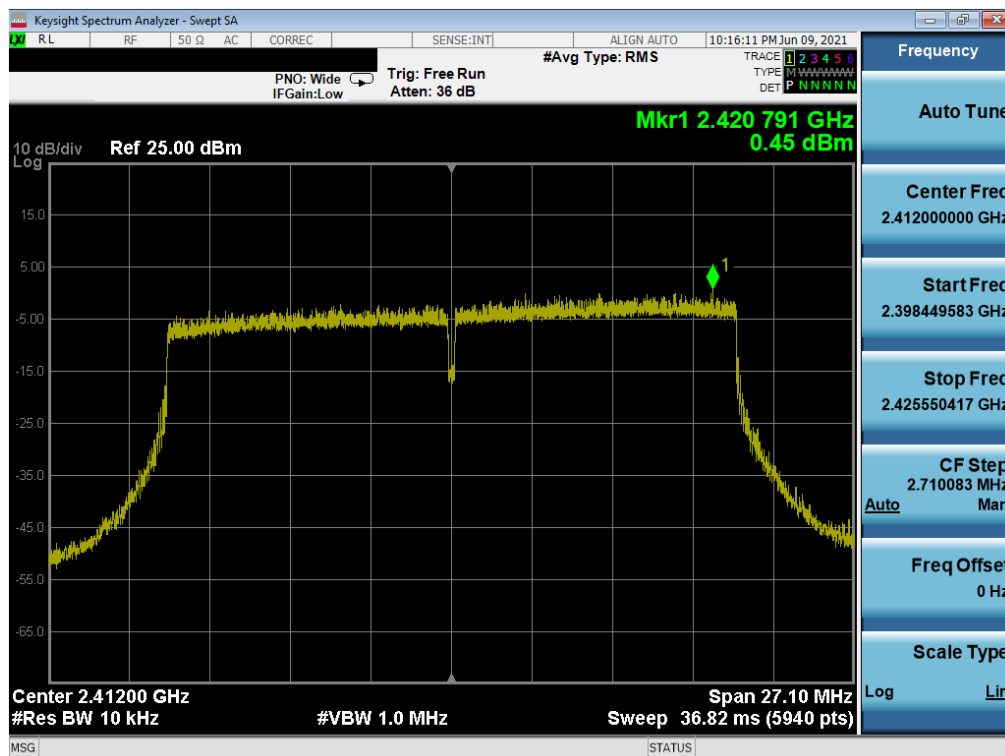


Plot 7-62. Power Spectral Density Plot SISO NORTH (802.11n 20MHz BW (2.4GHz) – Ch. 6)

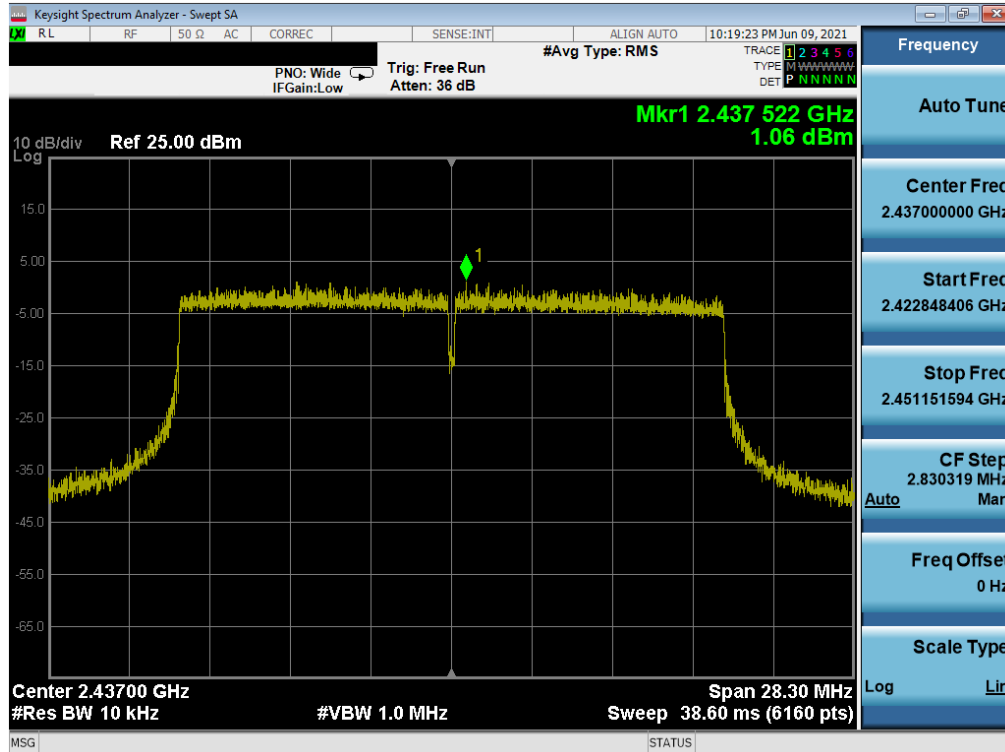


Plot 7-63. Power Spectral Density Plot SISO NORTH (802.11n 20MHz BW (2.4GHz) – Ch. 11)

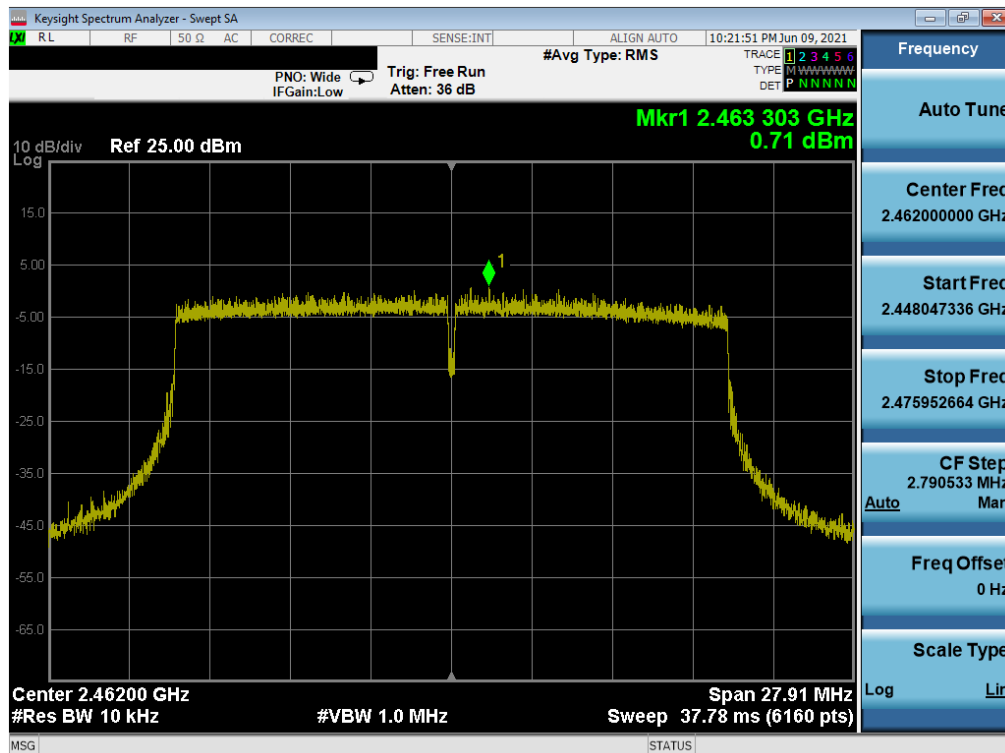


Plot 7-64. Power Spectral Density Plot SISO NORTH (802.11ax 20MHz BW (2.4GHz) – Ch. 1)

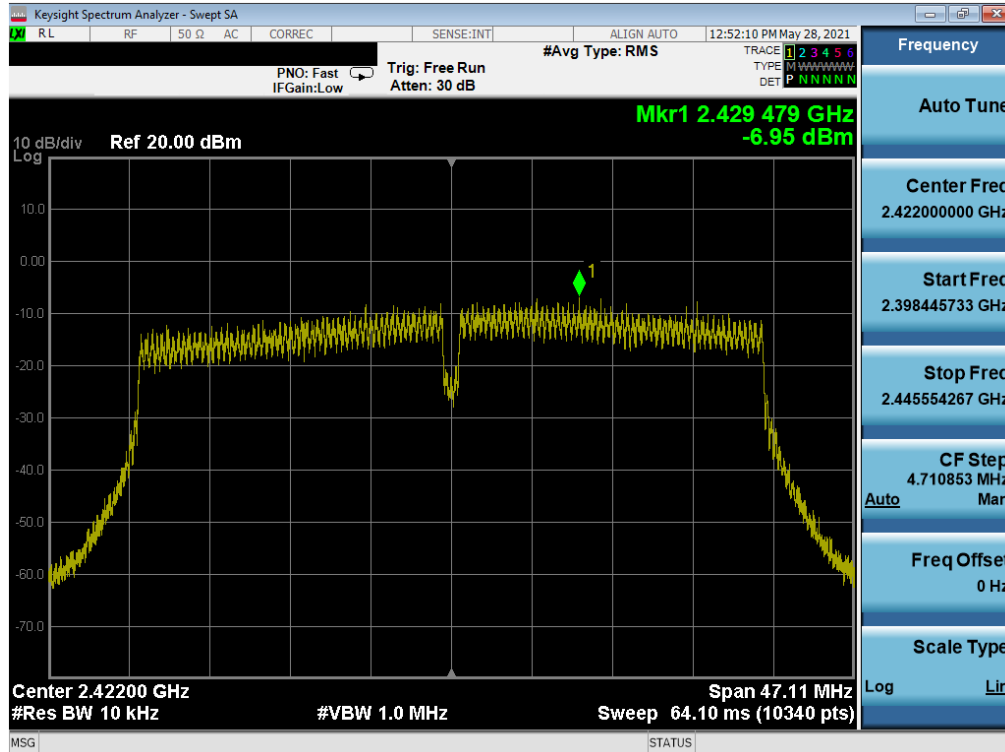


Plot 7-65. Power Spectral Density Plot SISO NORTH (802.11ax 20MHz BW (2.4GHz) – Ch. 6)

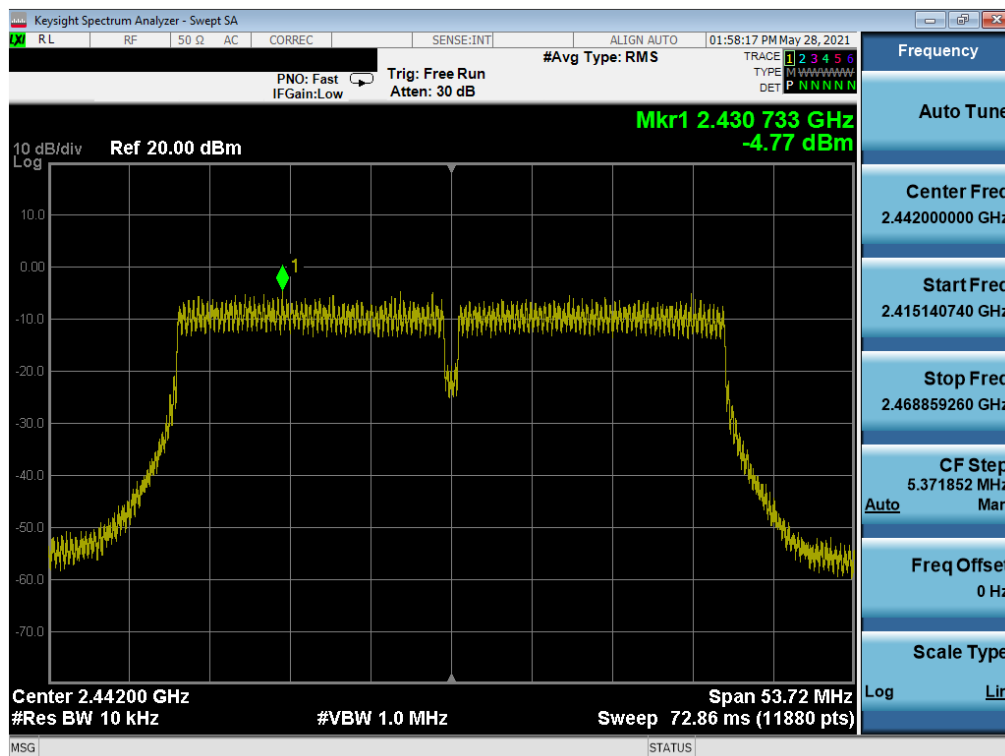


Plot 7-66. Power Spectral Density Plot SISO NORTH (802.11ax 20MHz BW (2.4GHz) – Ch. 11)

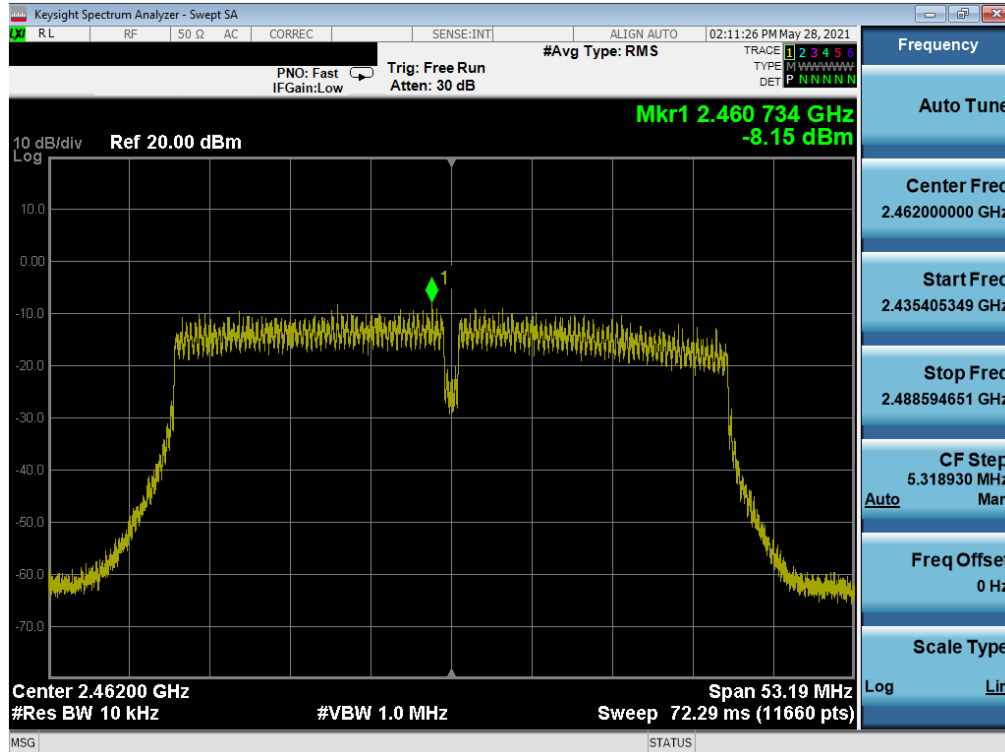


Plot 7-67. Power Spectral Density Plot SISO NORTH (802.11n 40MHz BW (2.4GHz) – Ch. 3)

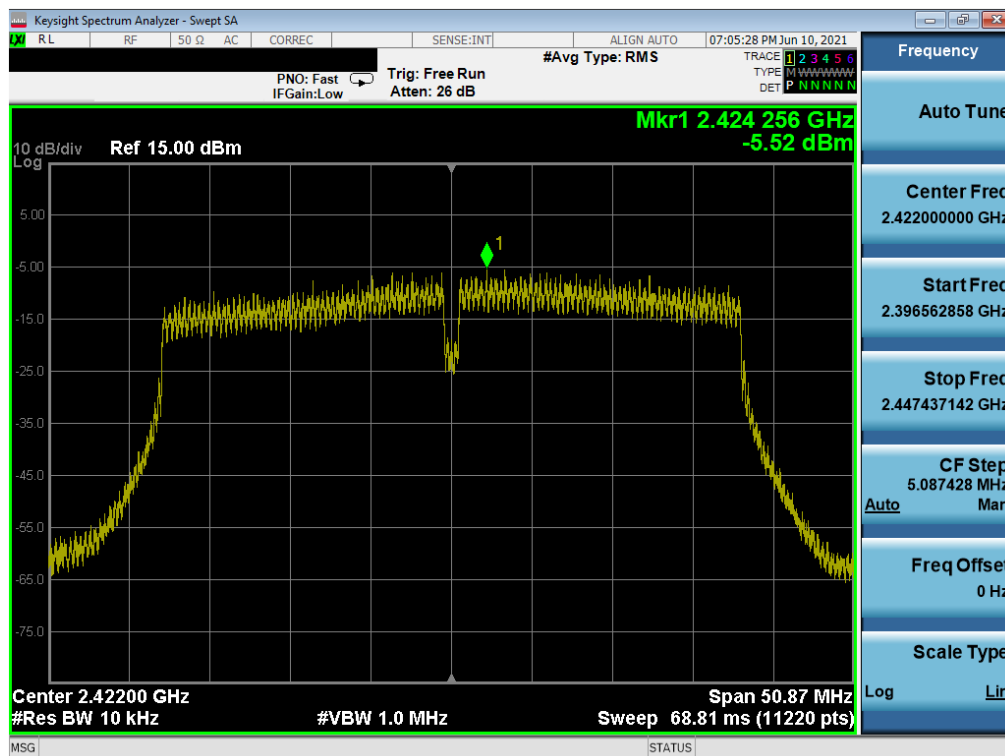


Plot 7-68. Power Spectral Density Plot SISO NORTH (802.11n 40MHz BW (2.4GHz) – Ch. 7)

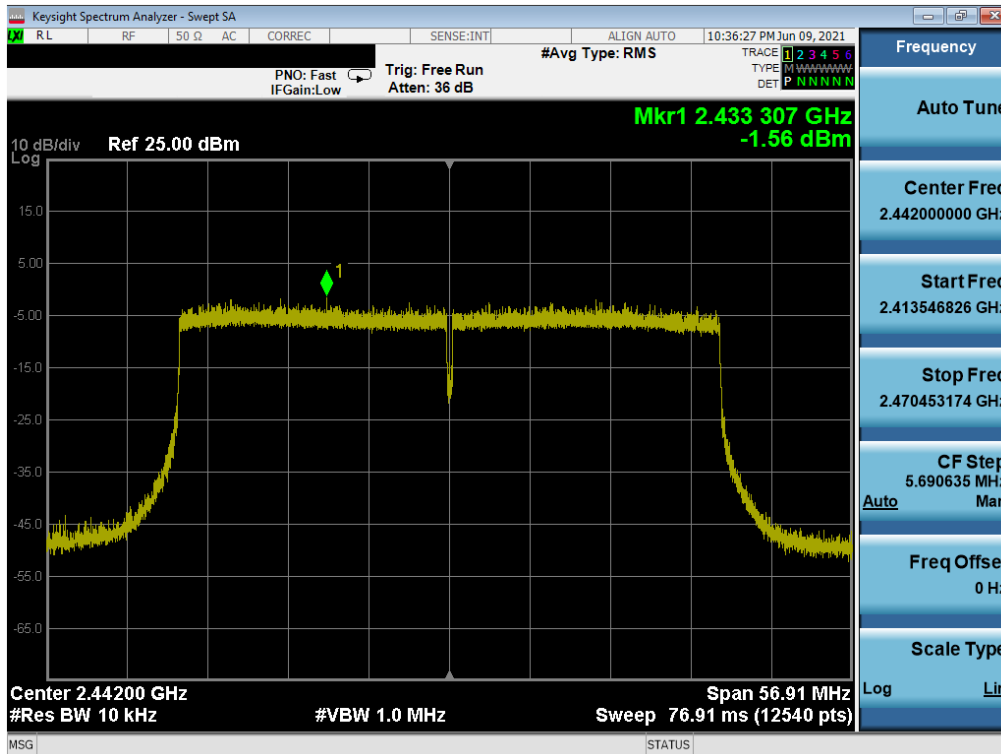


Plot 7-69. Power Spectral Density Plot SISO NORTH (802.11n 40MHz BW (2.4GHz) – Ch. 11)

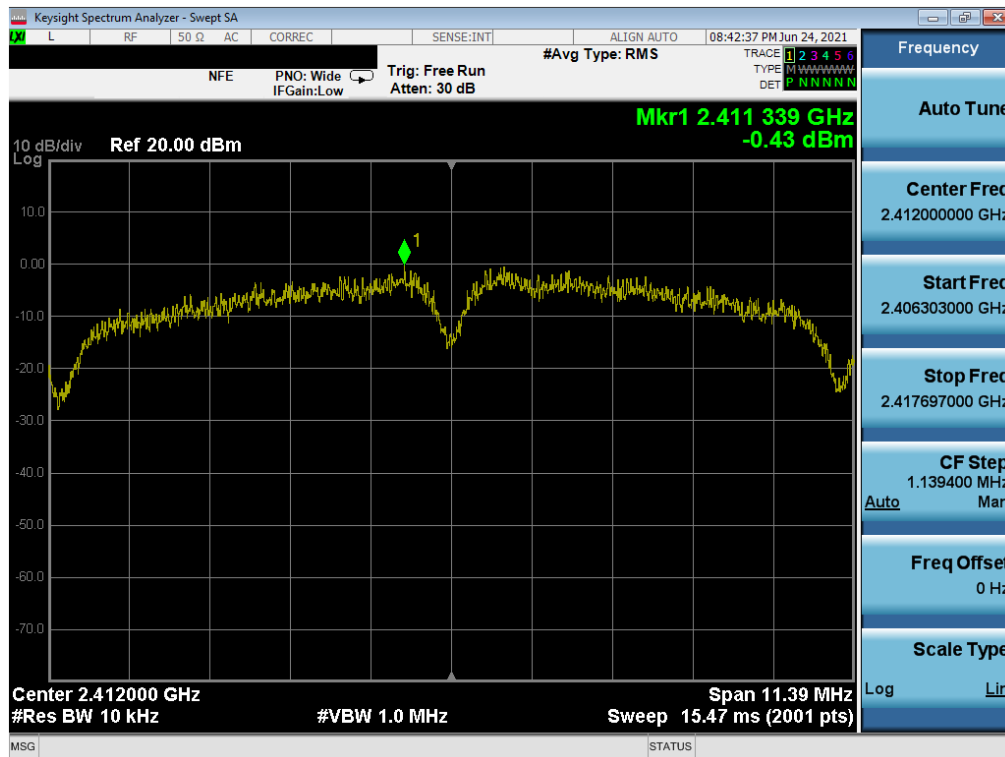

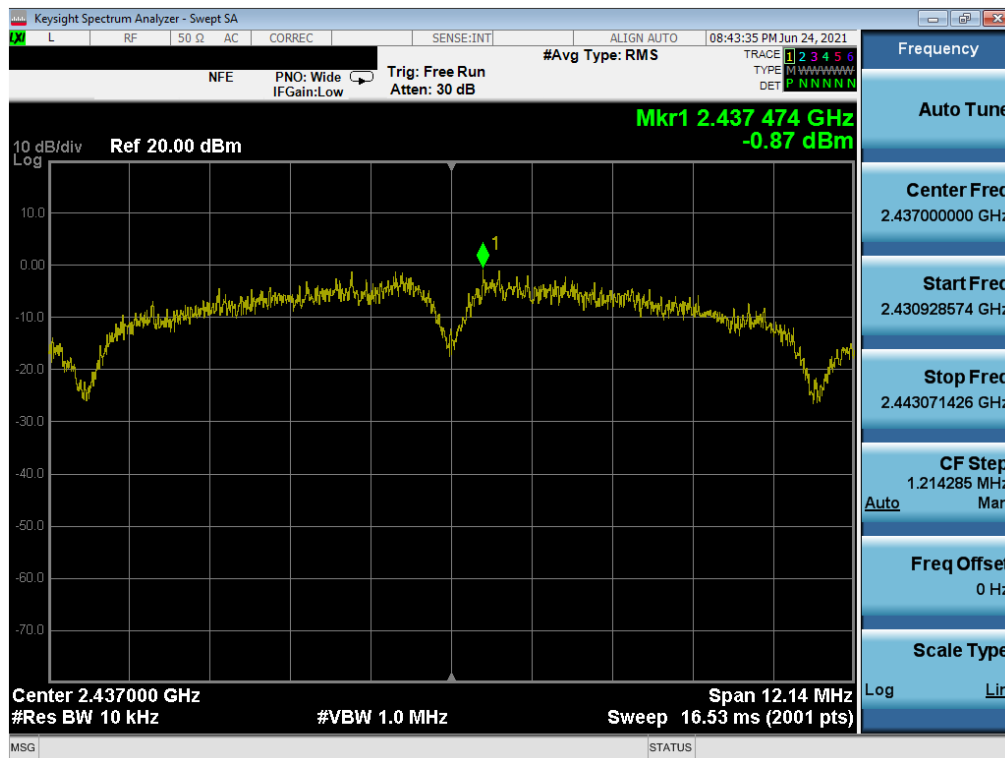

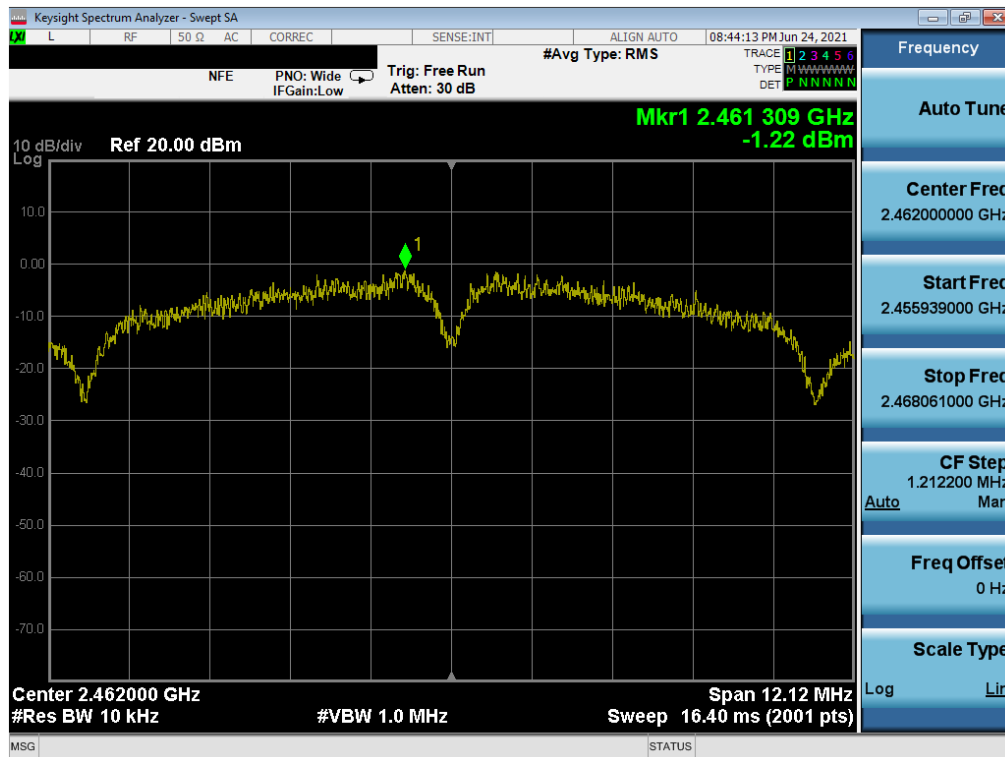


Plot 7-73. Power Spectral Density Plot MIMO SOUTH (802.11b – Ch. 1)

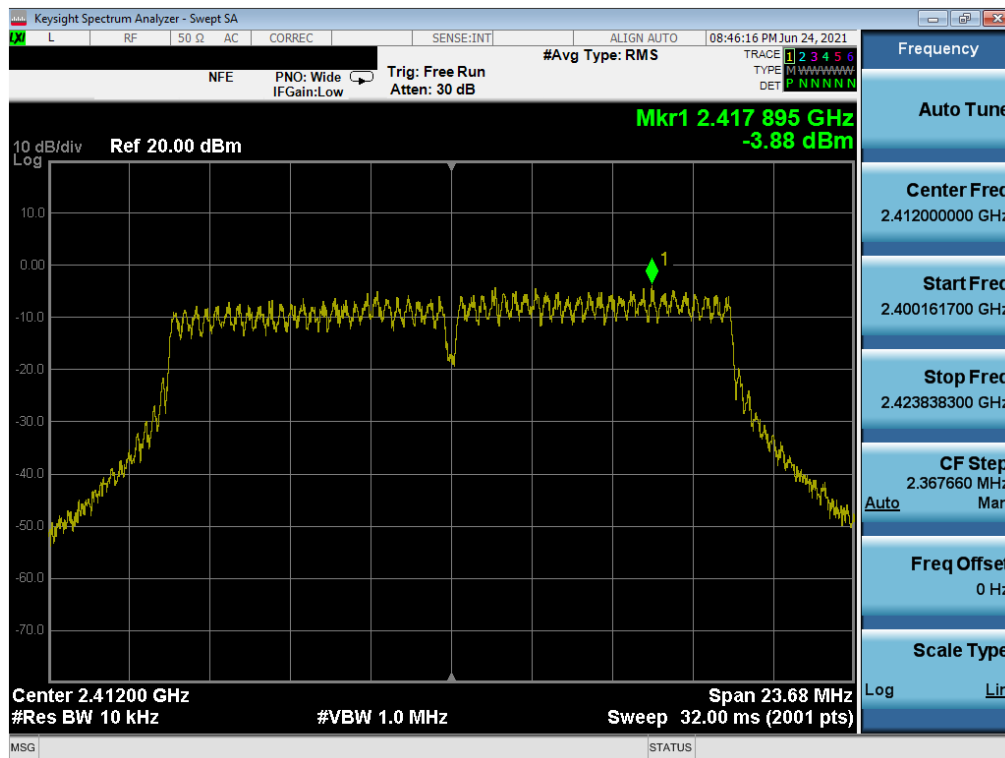


Plot 7-74. Power Spectral Density Plot MIMO SOUTH (802.11b – Ch. 6)

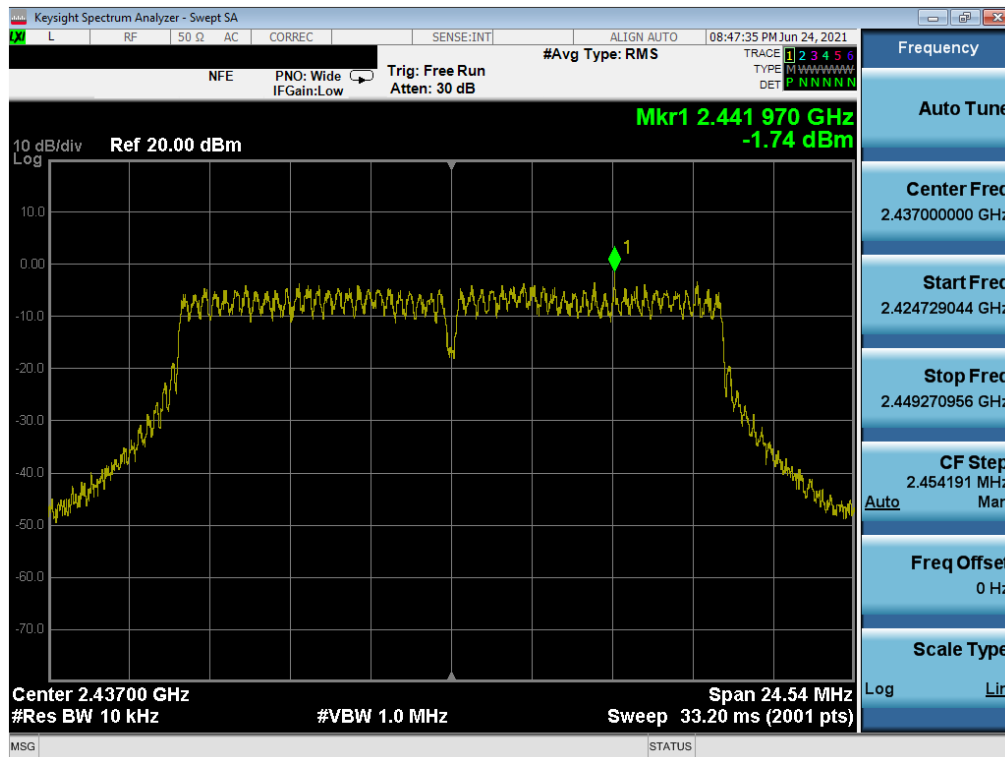


Plot 7-75. Power Spectral Density Plot MIMO SOUTH (802.11b – Ch. 11)

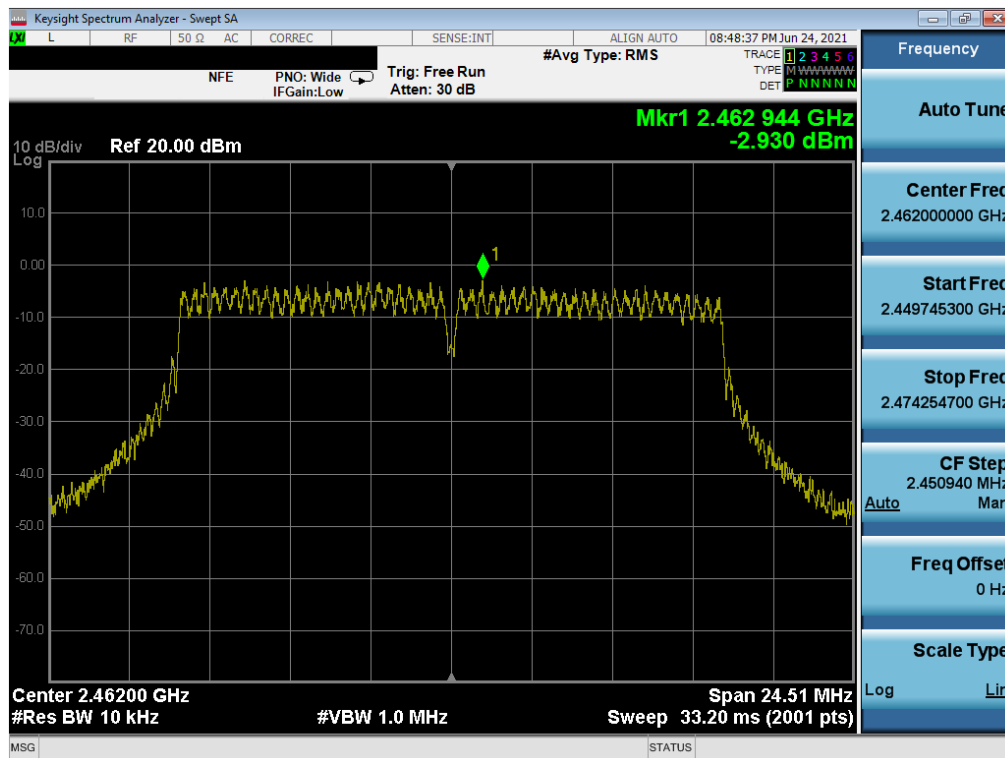


Plot 7-76. Power Spectral Density Plot MIMO SOUTH (802.11g – Ch. 1)

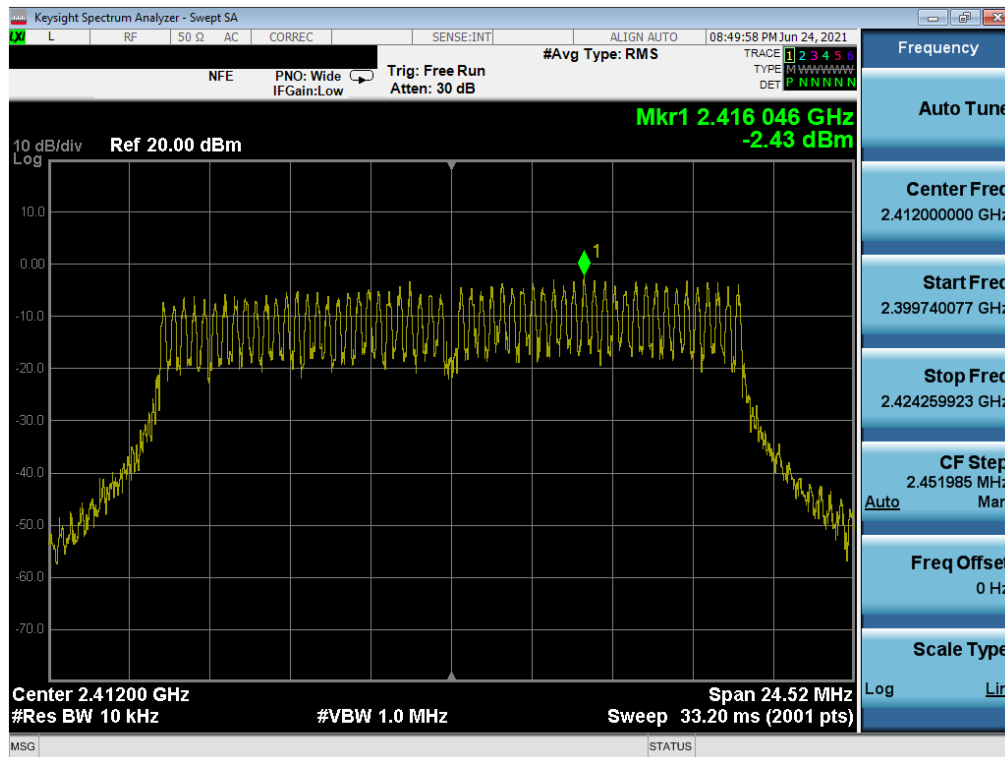


Plot 7-77. Power Spectral Density Plot MIMO SOUTH (802.11g – Ch. 6)

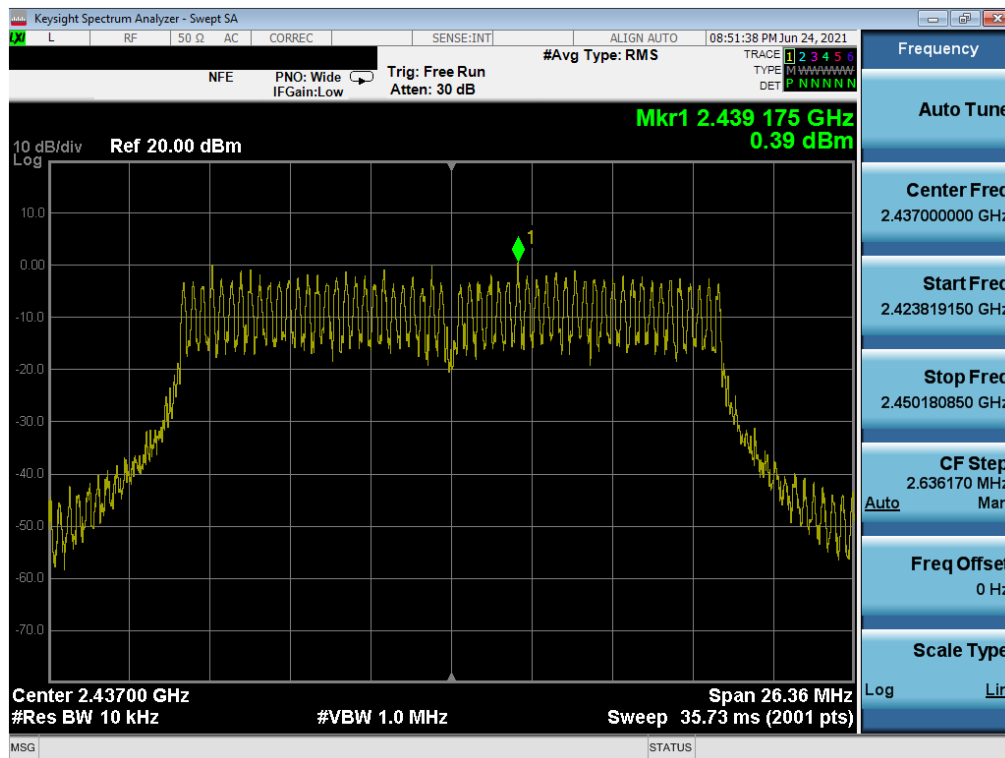


Plot 7-78. Power Spectral Density Plot MIMO SOUTH (802.11g– Ch. 11)

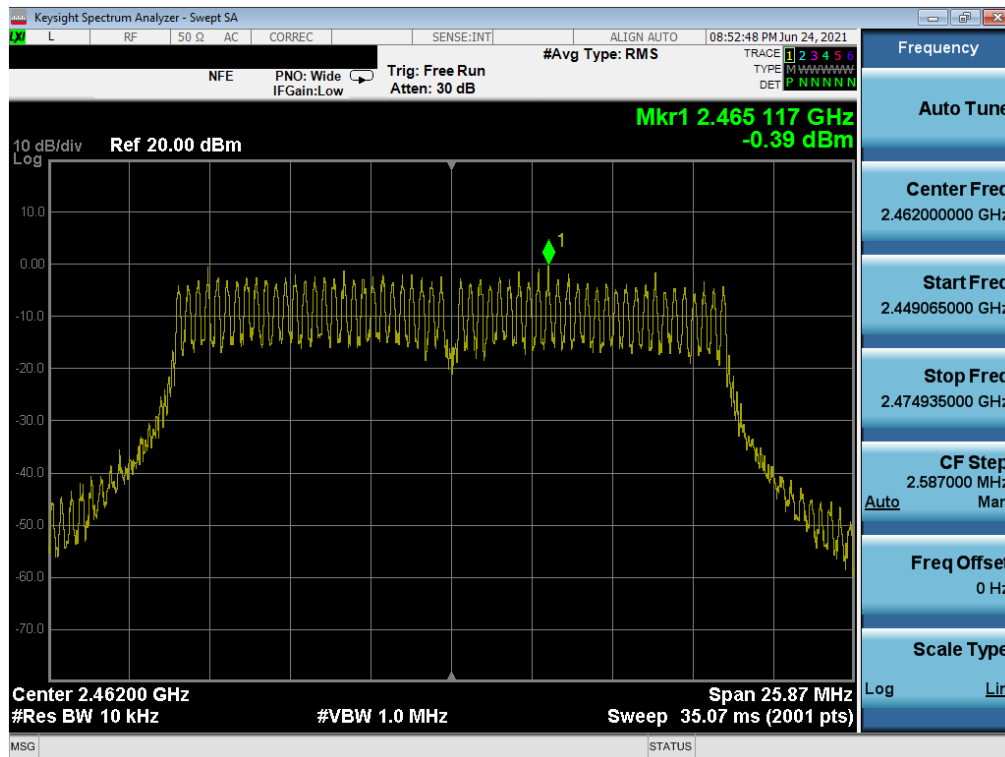


Plot 7-79. Power Spectral Density Plot MIMO SOUTH (802.11n 20MHz BW (2.4GHz) – Ch. 1)

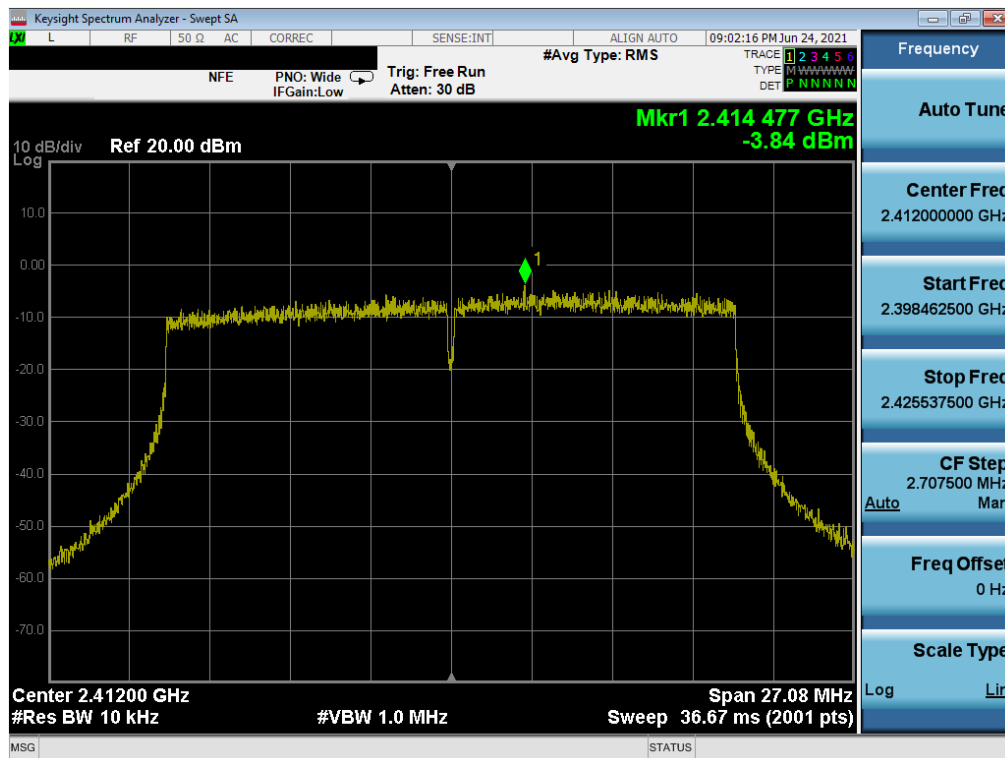


Plot 7-80. Power Spectral Density Plot MIMO SOUTH (802.11n 20MHz BW (2.4GHz) – Ch. 6)

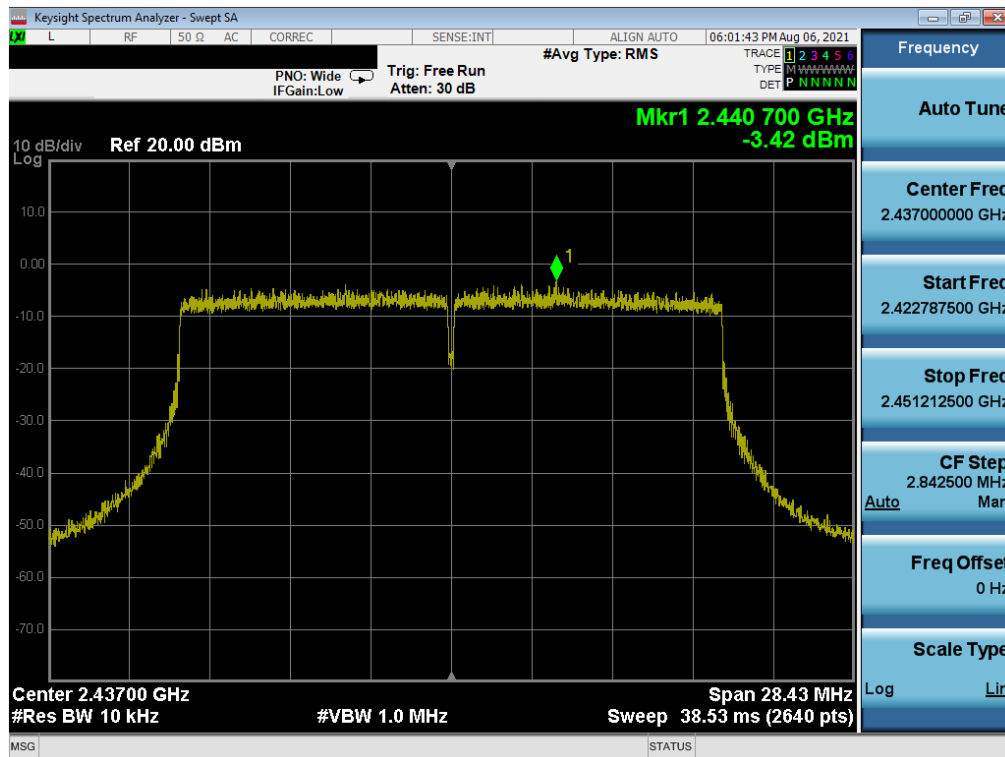


Plot 7-81. Power Spectral Density Plot MIMO SOUTH (802.11n 20MHz BW (2.4GHz) – Ch. 11)

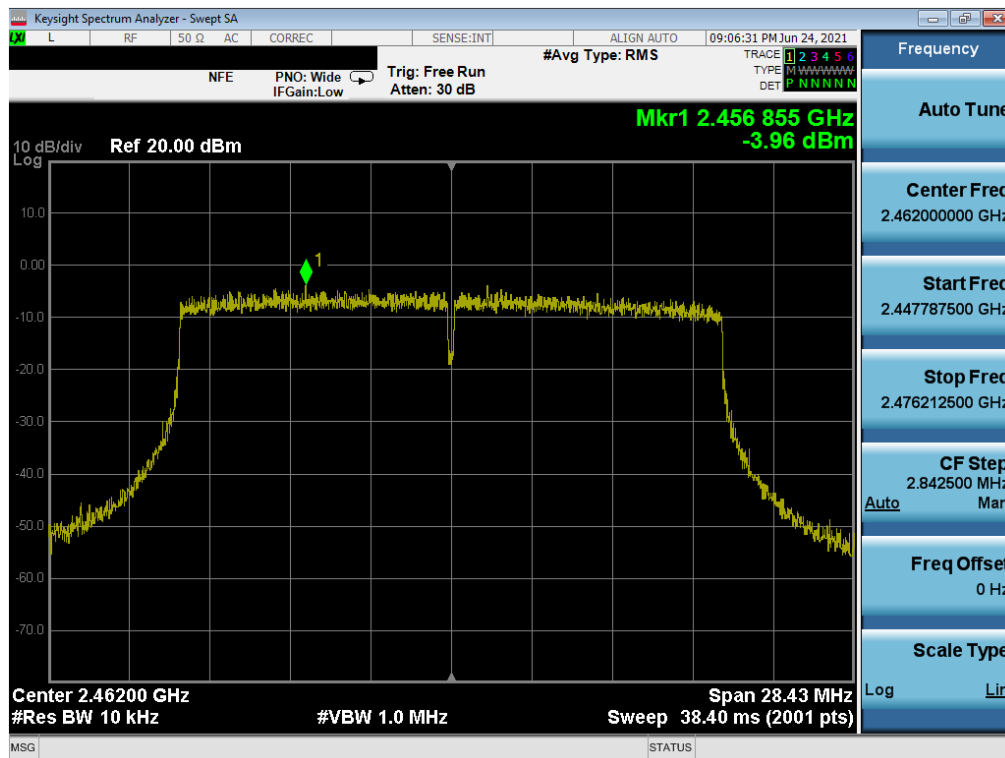


Plot 7-82. Power Spectral Density Plot MIMO SOUTH (802.11ax 20MHz BW (2.4GHz) – Ch. 1)

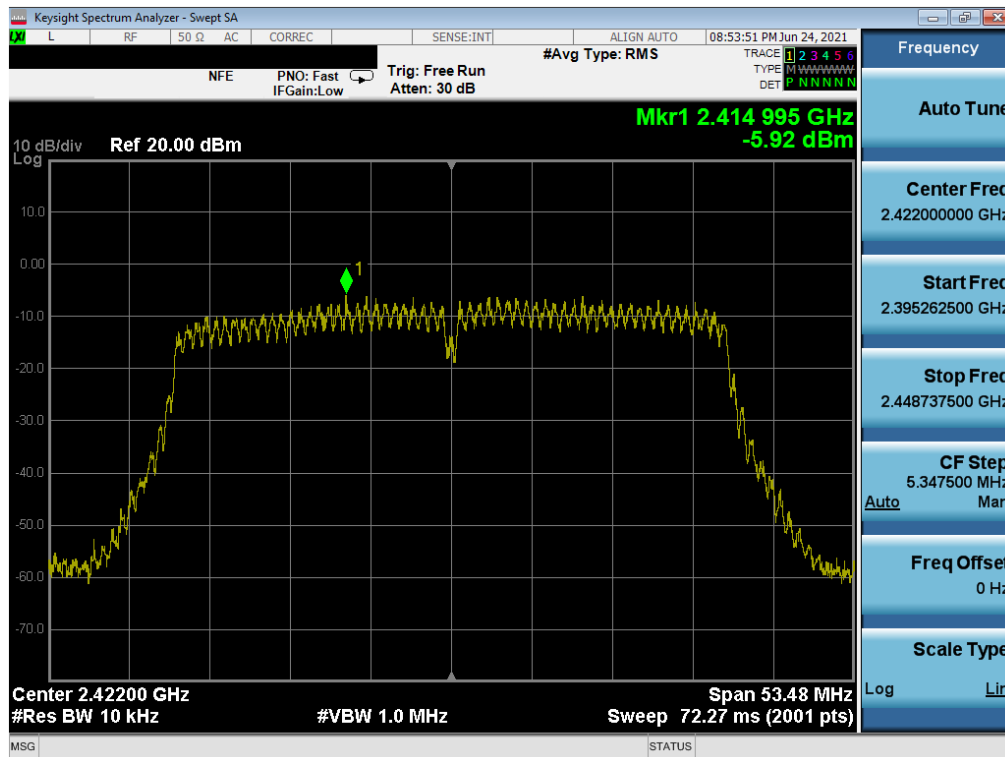


Plot 7-83. Power Spectral Density Plot MIMO SOUTH (802.11ax 20MHz BW (2.4GHz) – Ch. 6)

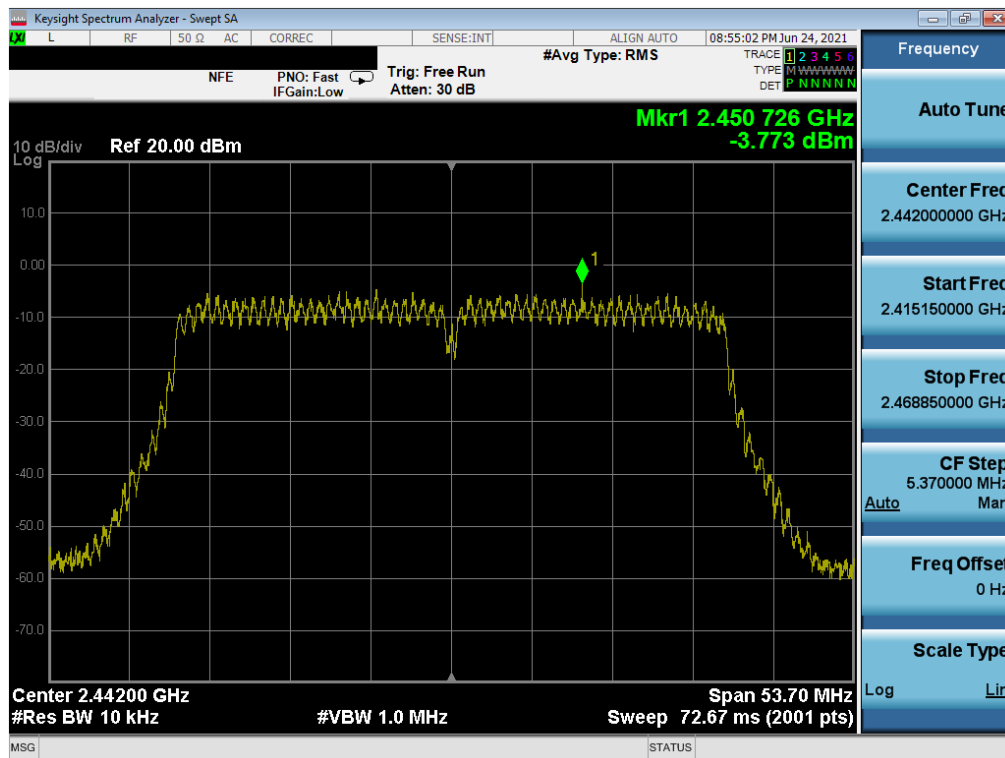


Plot 7-84. Power Spectral Density Plot MIMO SOUTH (802.11ax 20MHz BW (2.4GHz) – Ch. 11)

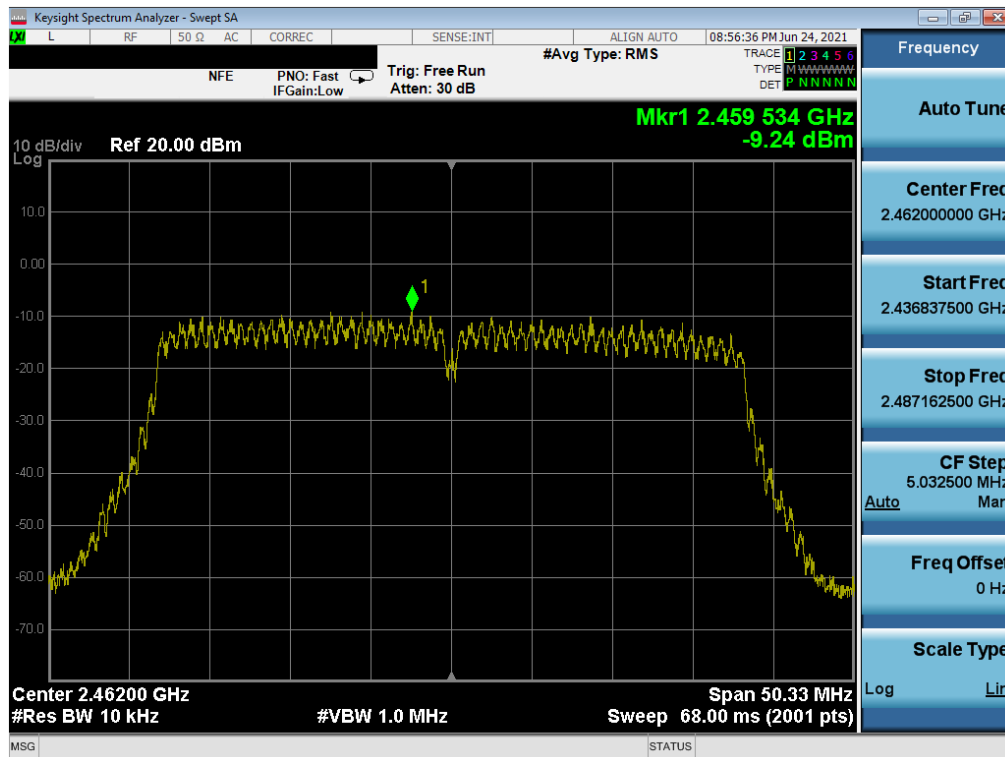


Plot 7-85. Power Spectral Density Plot MIMO SOUTH (802.11n 40MHz BW (2.4GHz) – Ch. 3)

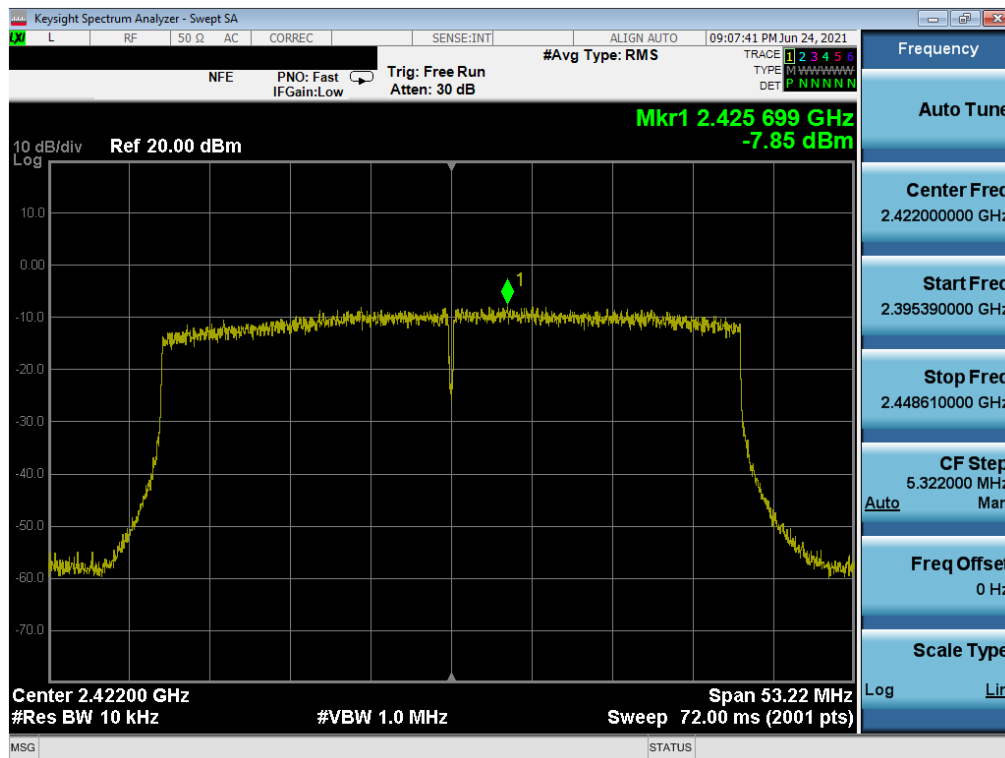


Plot 7-86. Power Spectral Density Plot MIMO SOUTH (802.11n 40MHz BW (2.4GHz) – Ch. 7)

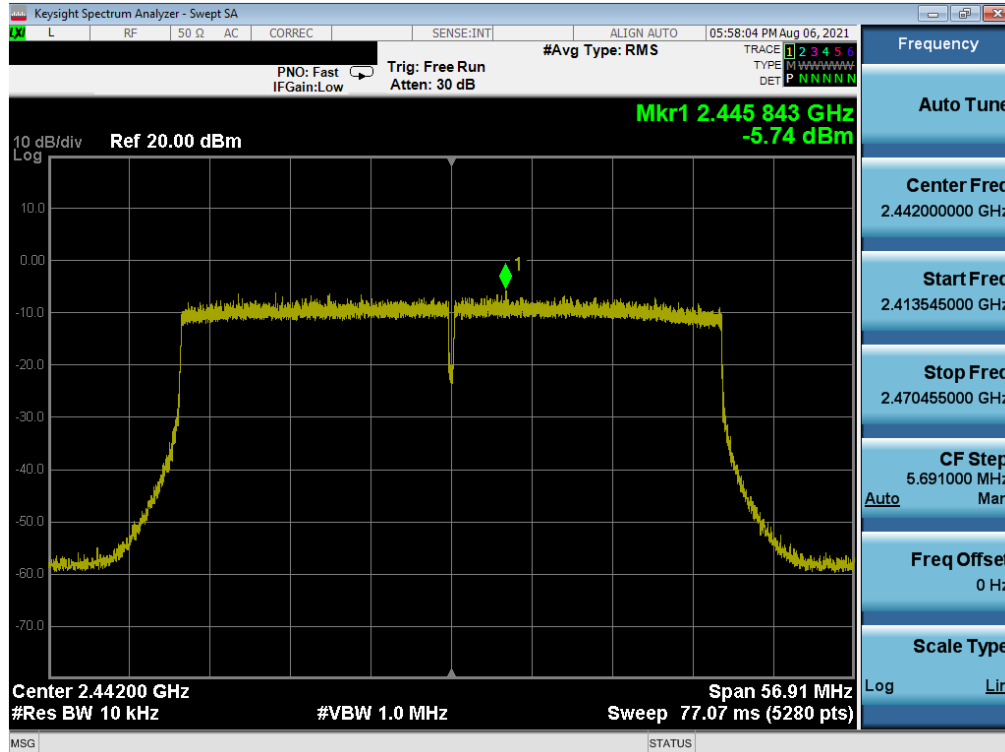


Plot 7-87. Power Spectral Density Plot MIMO SOUTH (802.11n 40MHz BW (2.4GHz) – Ch. 11)

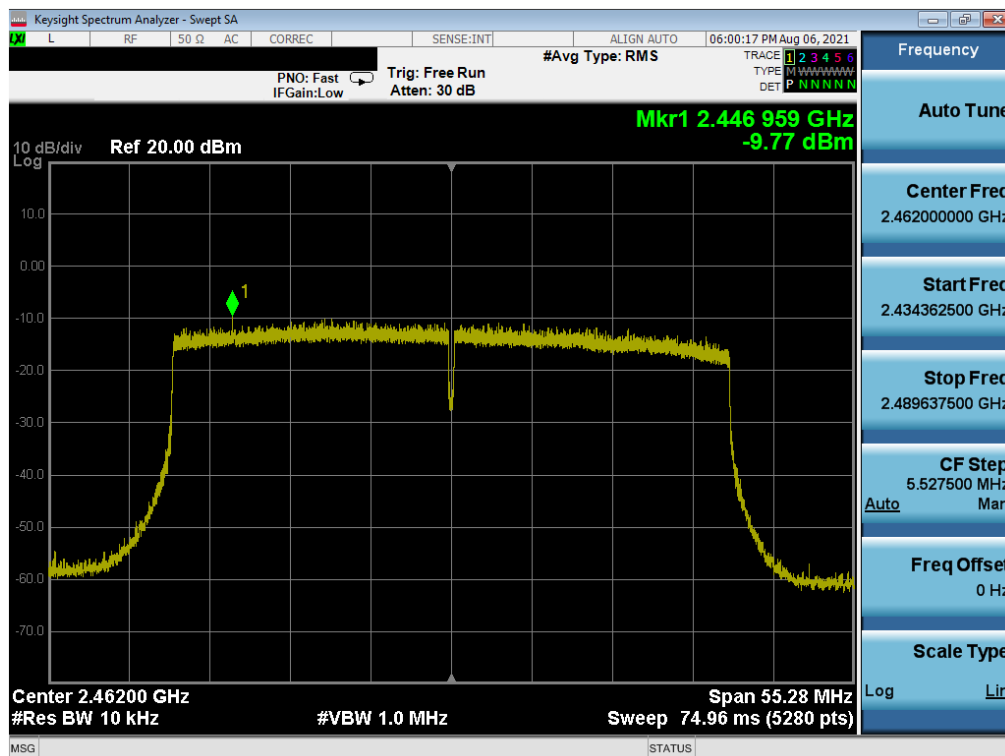


Plot 7-88. Power Spectral Density Plot MIMO SOUTH (802.11ax 40MHz BW (2.4GHz) – Ch. 3)

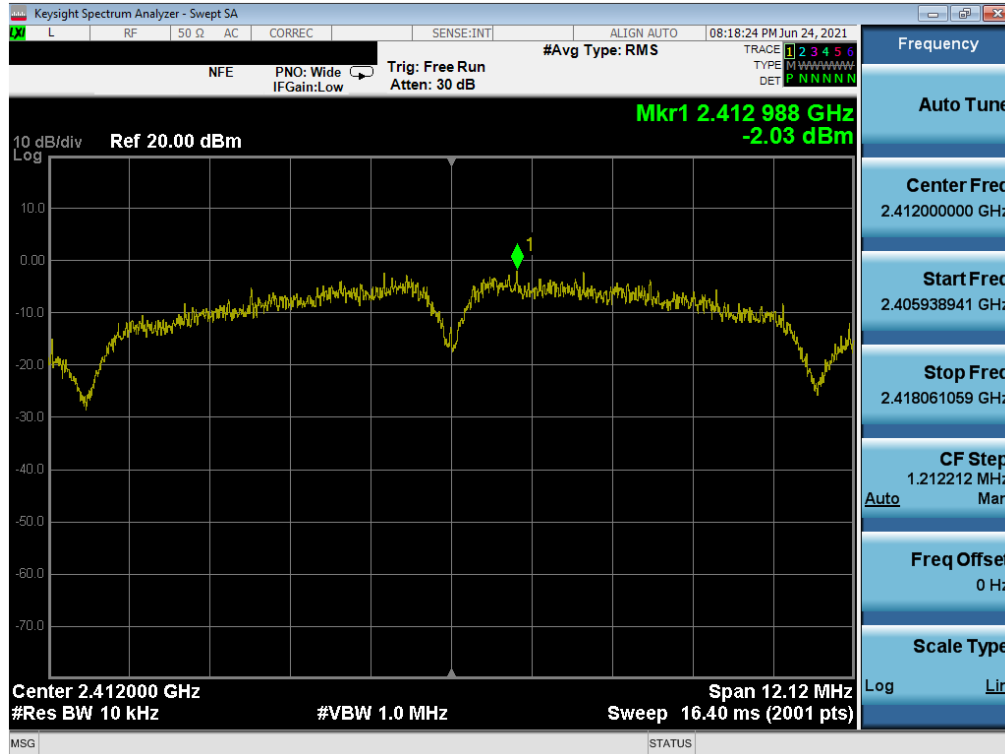


Plot 7-89. Power Spectral Density Plot MIMO SOUTH (802.11ax 40MHz BW (2.4GHz) – Ch. 7)

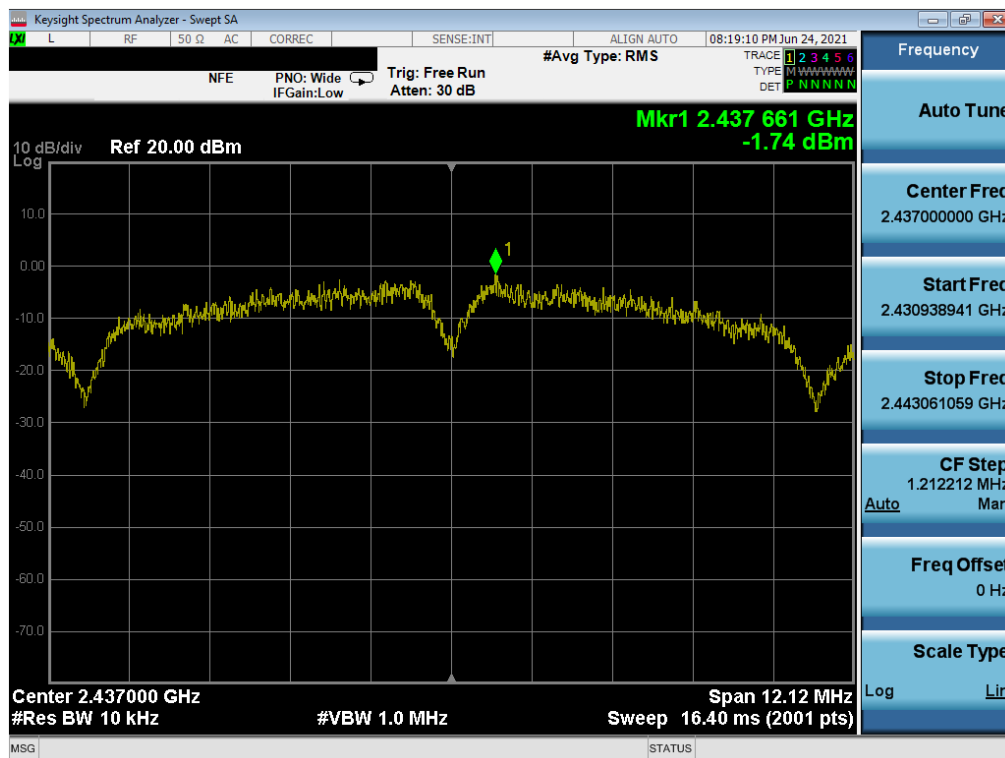


Plot 7-90. Power Spectral Density Plot MIMO SOUTH (802.11ax 40MHz BW (2.4GHz) – Ch. 11)

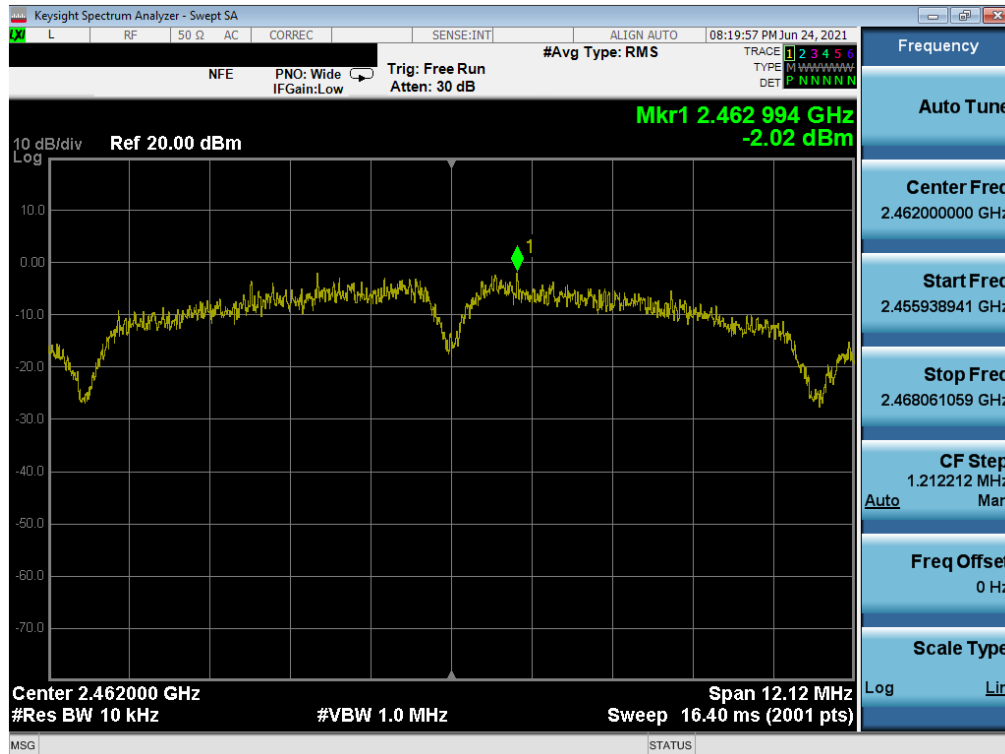


Plot 7-91. Power Spectral Density Plot MIMO NORTH (802.11b – Ch. 1)

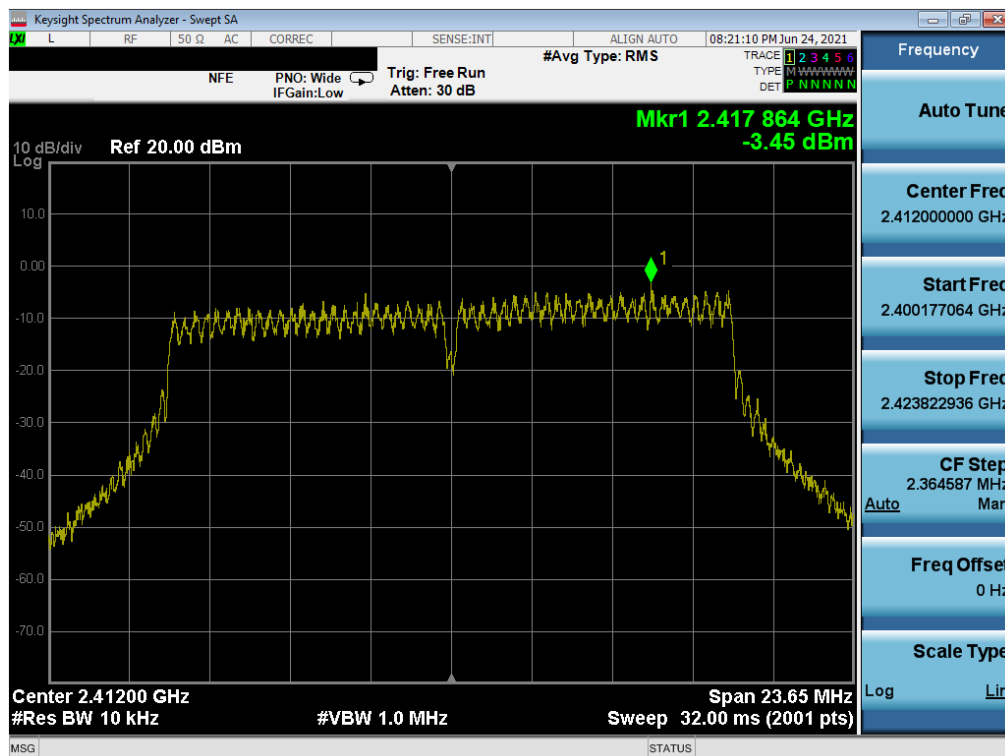


Plot 7-92. Power Spectral Density Plot MIMO NORTH (802.11b – Ch. 6)

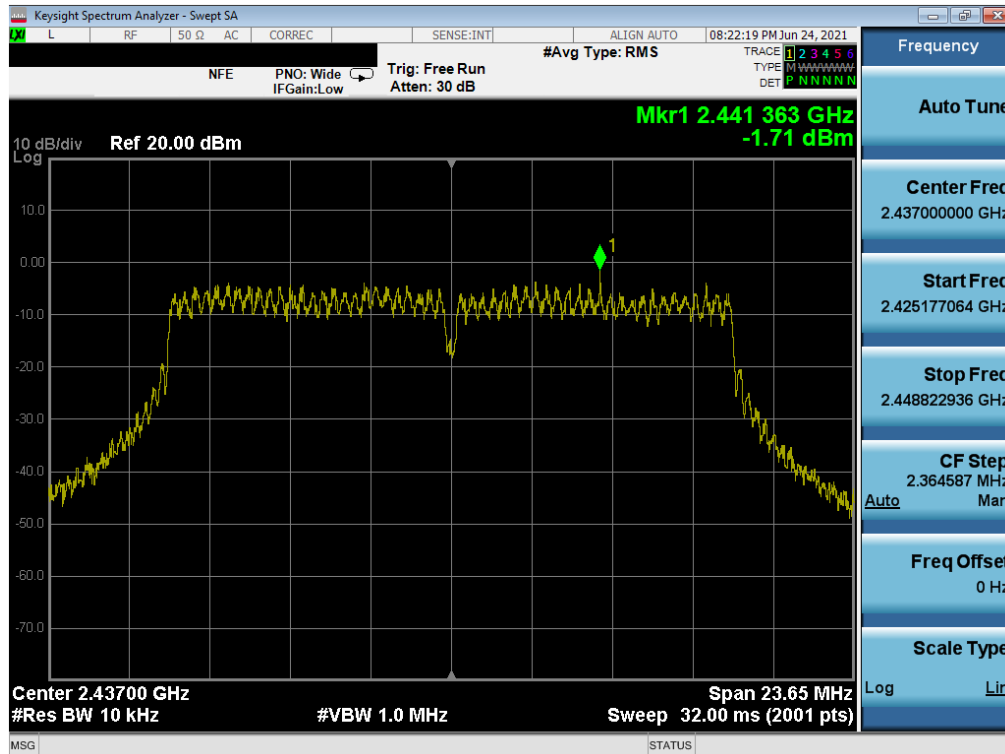


Plot 7-93. Power Spectral Density Plot MIMO NORTH (802.11b – Ch. 11)

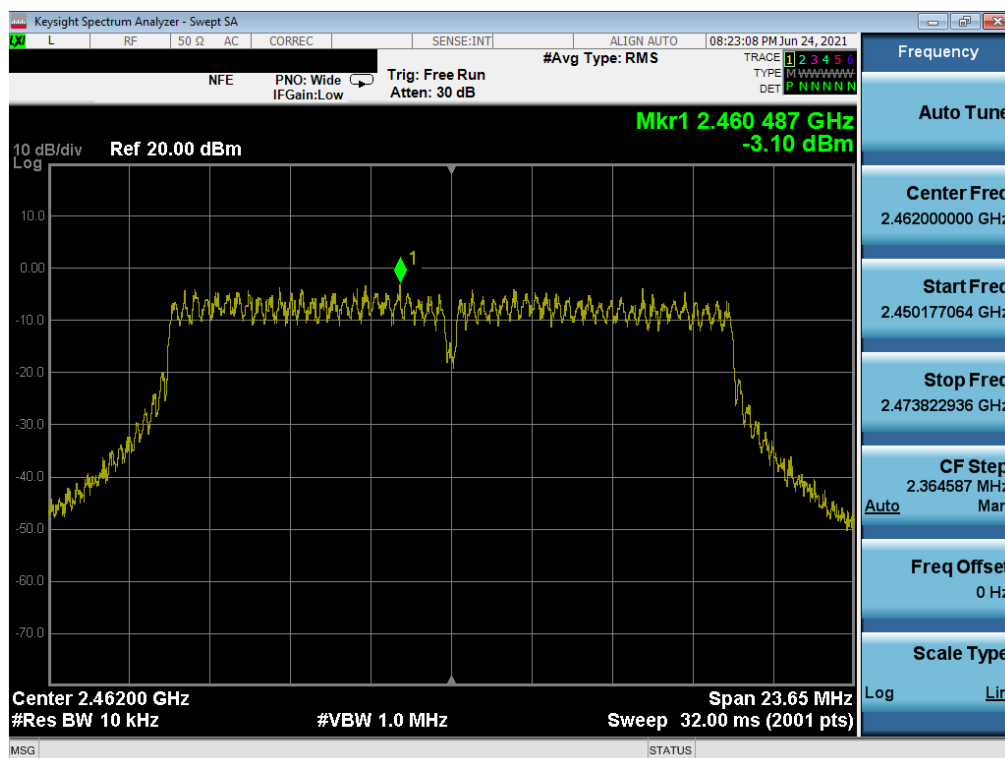


Plot 7-94. Power Spectral Density Plot MIMO NORTH (802.11g – Ch. 1)

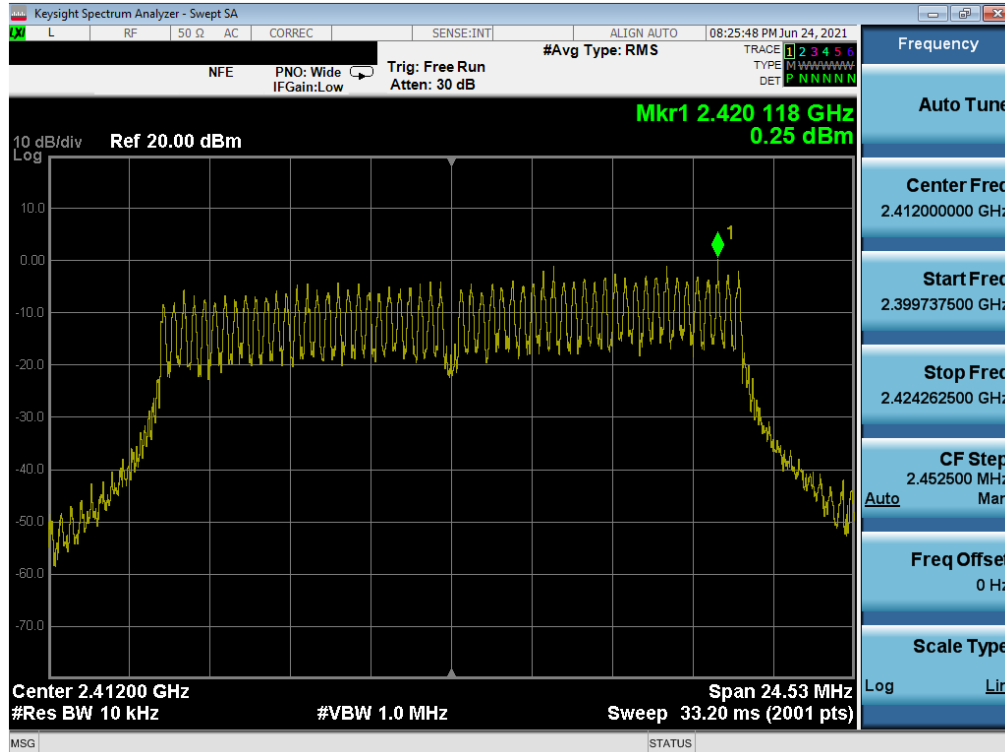


Plot 7-95. Power Spectral Density Plot MIMO NORTH (802.11g – Ch. 6)

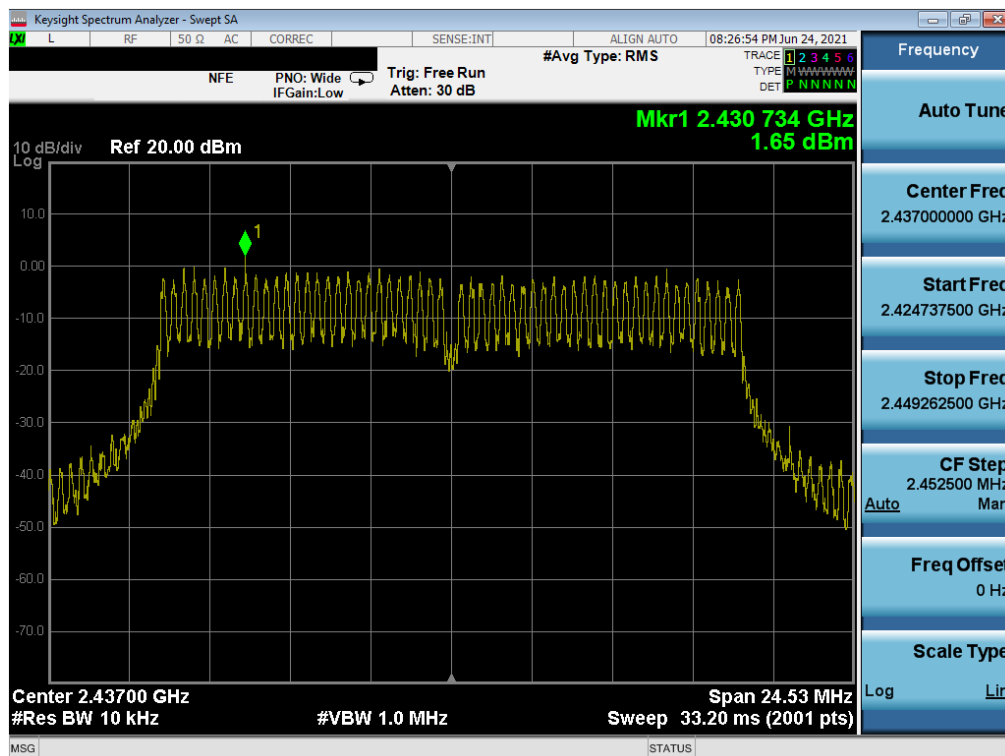


Plot 7-96. Power Spectral Density Plot MIMO NORTH (802.11g– Ch. 11)

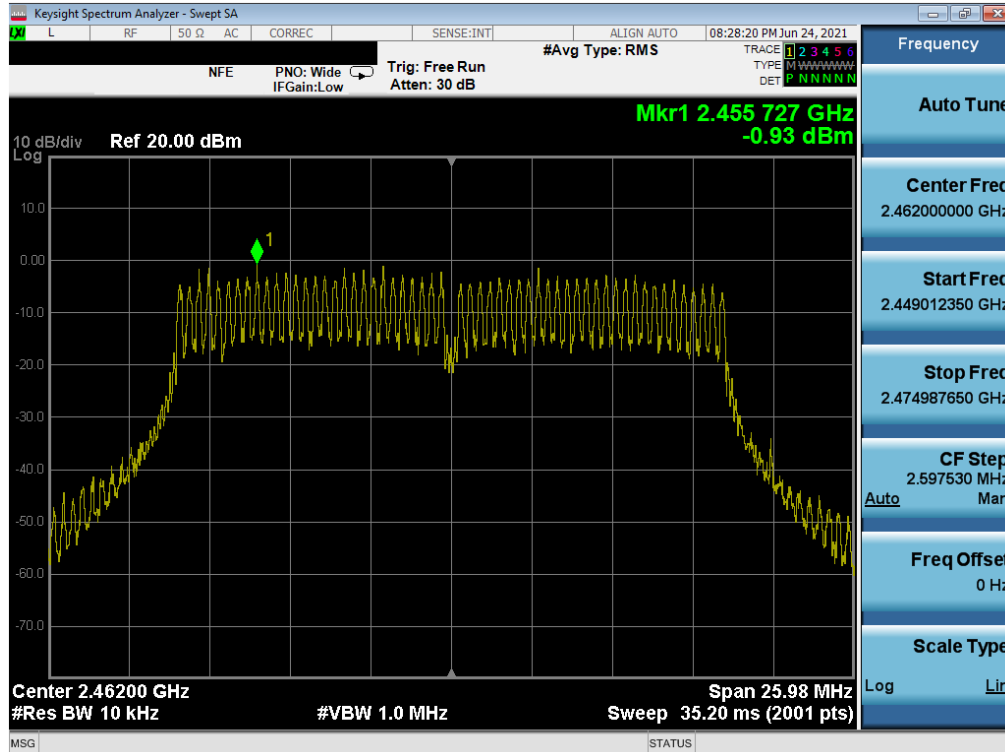


Plot 7-97. Power Spectral Density Plot MIMO NORTH (802.11n 20MHz BW (2.4GHz) – Ch. 1)

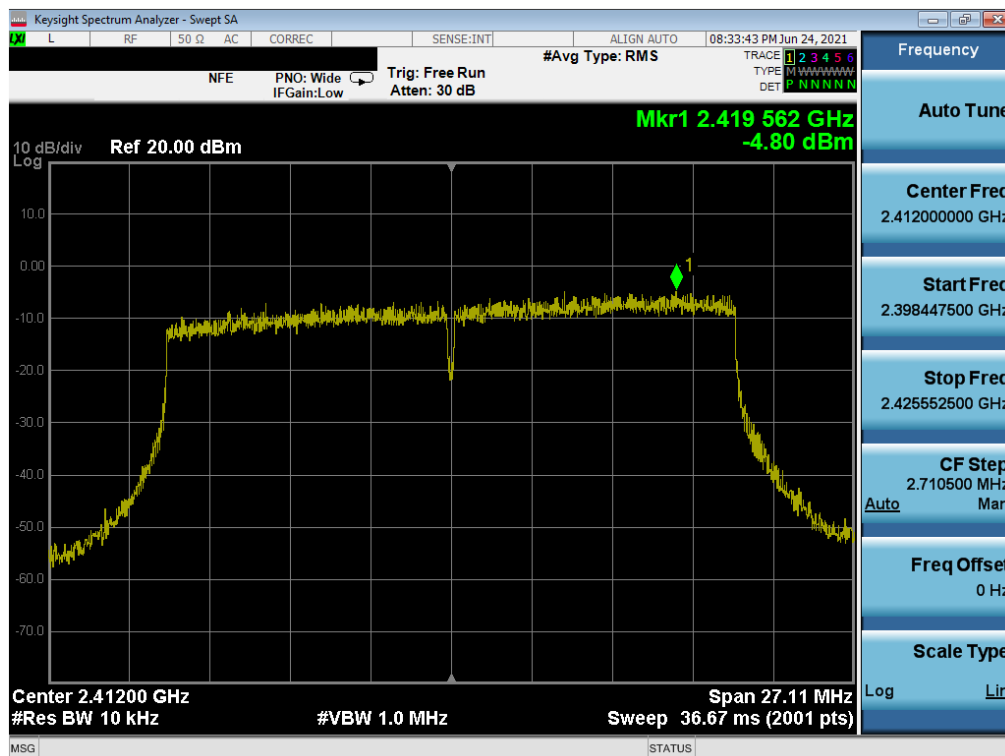


Plot 7-98. Power Spectral Density Plot MIMO NORTH (802.11n 20MHz BW (2.4GHz) – Ch. 6)

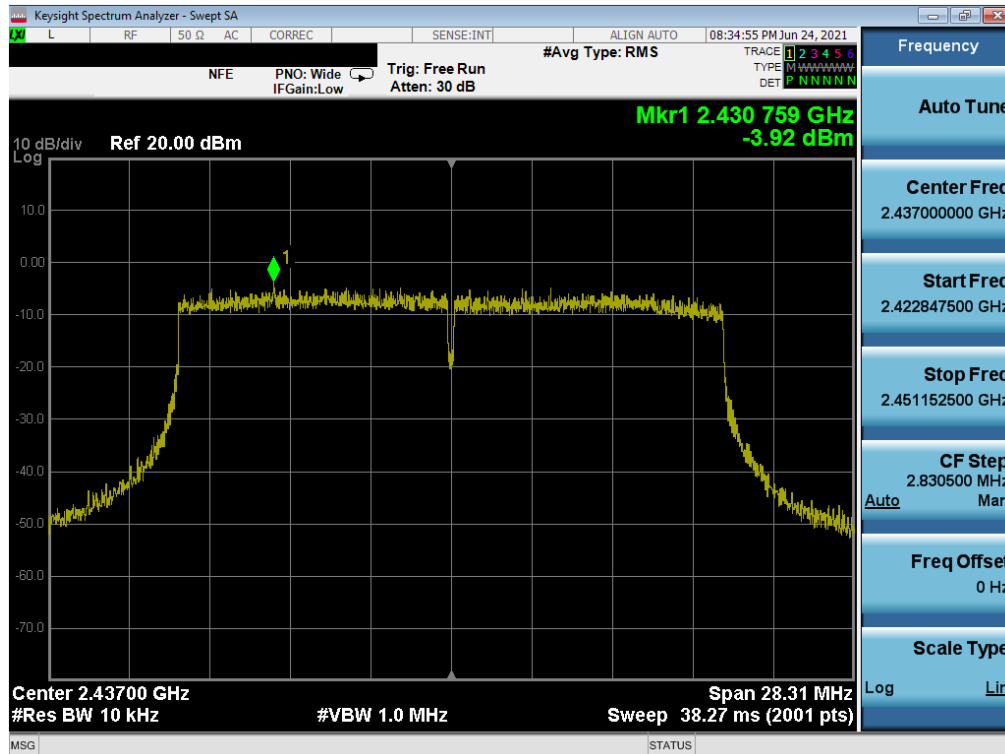


Plot 7-99. Power Spectral Density Plot MIMO NORTH (802.11n 20MHz BW (2.4GHz) – Ch. 11)

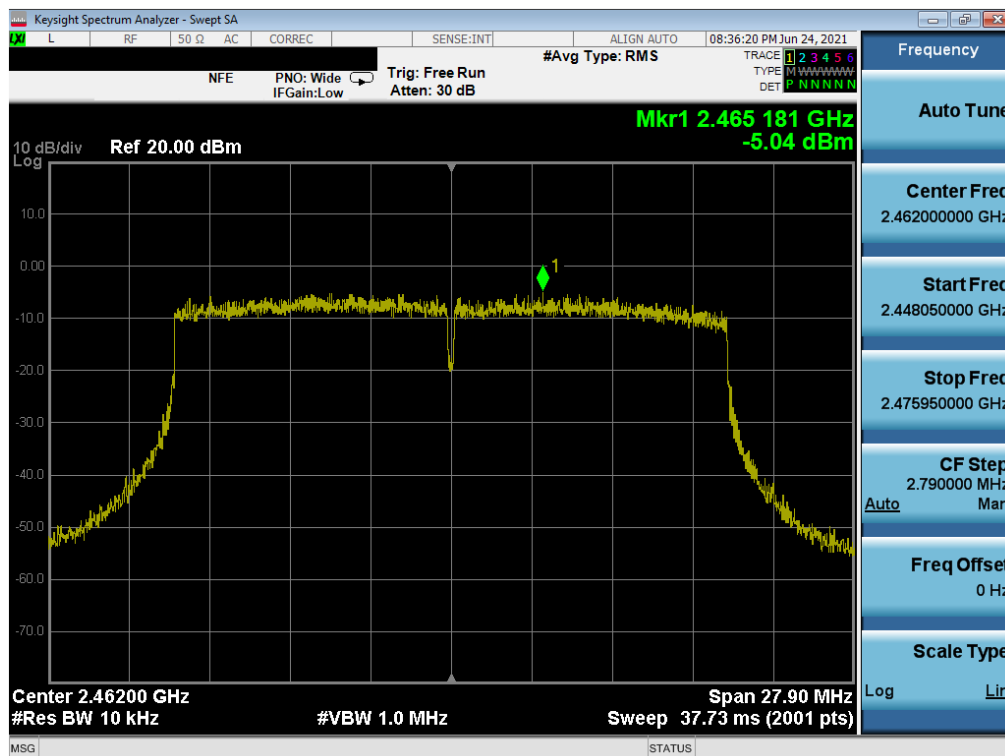


Plot 7-100. Power Spectral Density Plot MIMO NORTH (802.11ax 20MHz BW (2.4GHz) – Ch. 1)

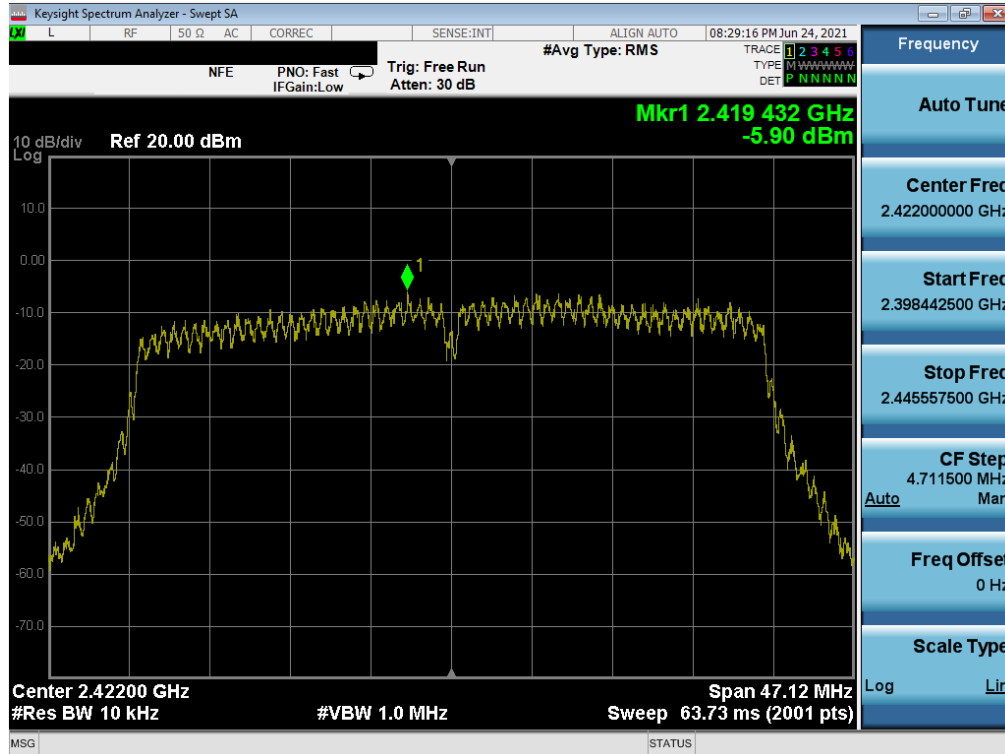


Plot 7-101. Power Spectral Density Plot MIMO NORTH (802.11ax 20MHz BW (2.4GHz) – Ch. 6)

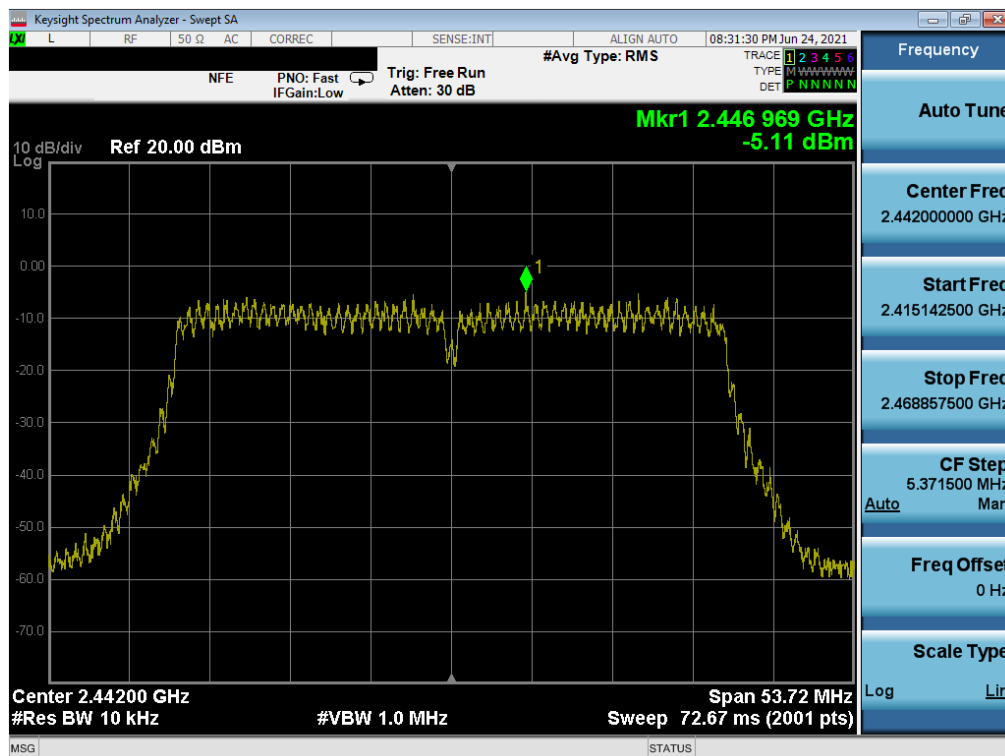


Plot 7-102. Power Spectral Density Plot MIMO NORTH (802.11ax 20MHz BW (2.4GHz) – Ch. 11)

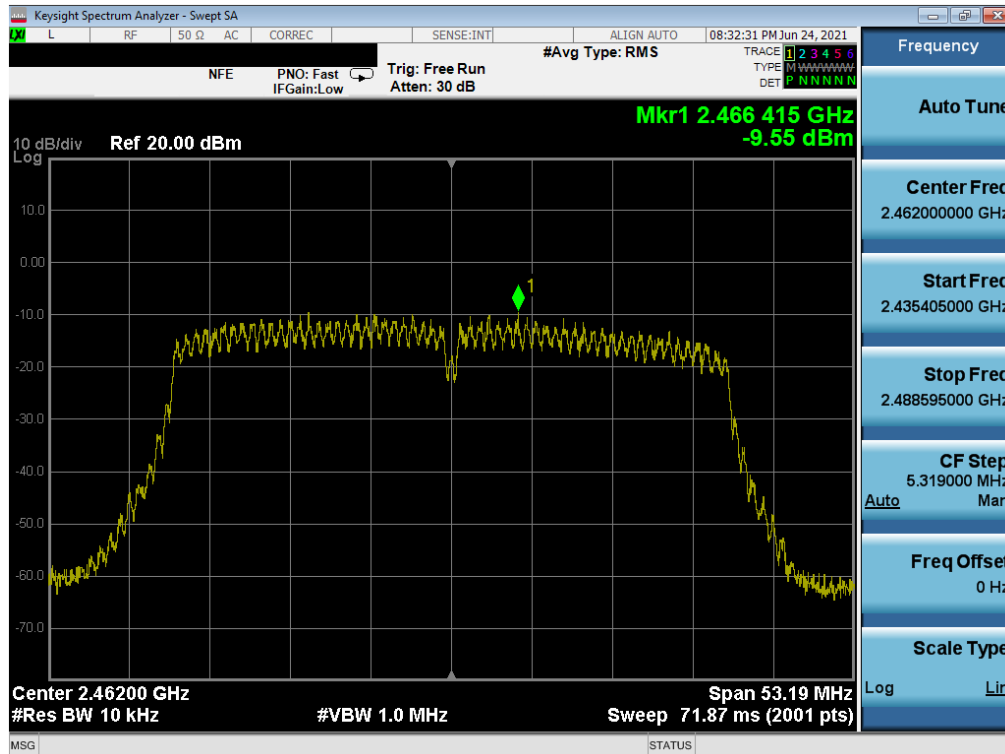


Plot 7-103. Power Spectral Density Plot MIMO NORTH (802.11n 40MHz BW (2.4GHz) – Ch. 3)

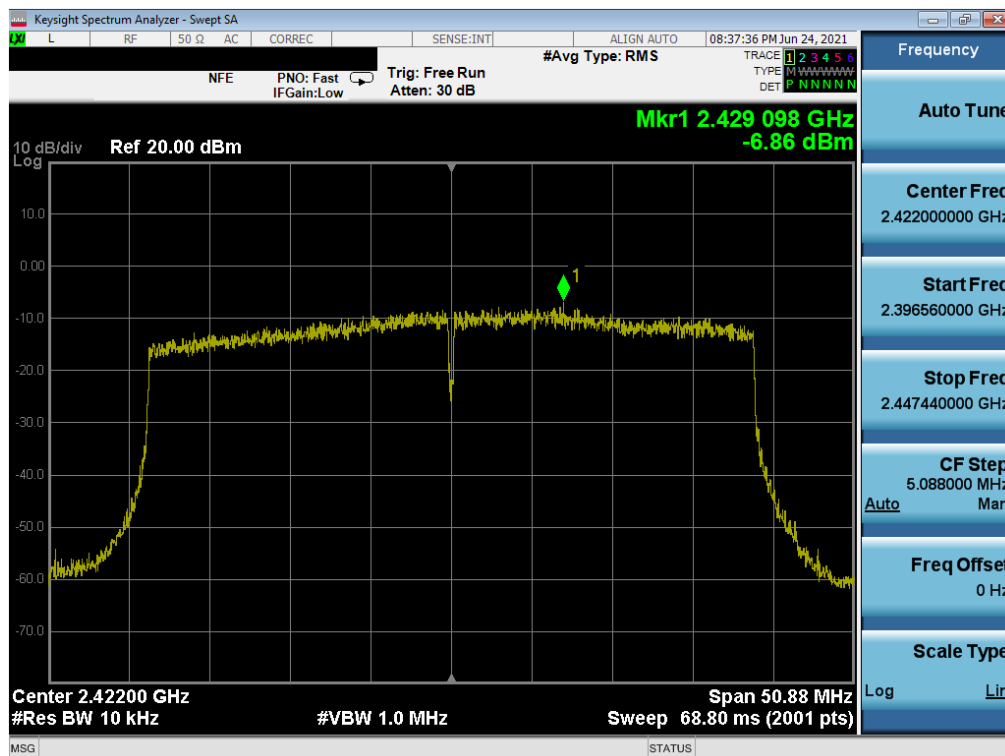


Plot 7-104. Power Spectral Density Plot MIMO NORTH (802.11n 40MHz BW (2.4GHz) – Ch. 7)

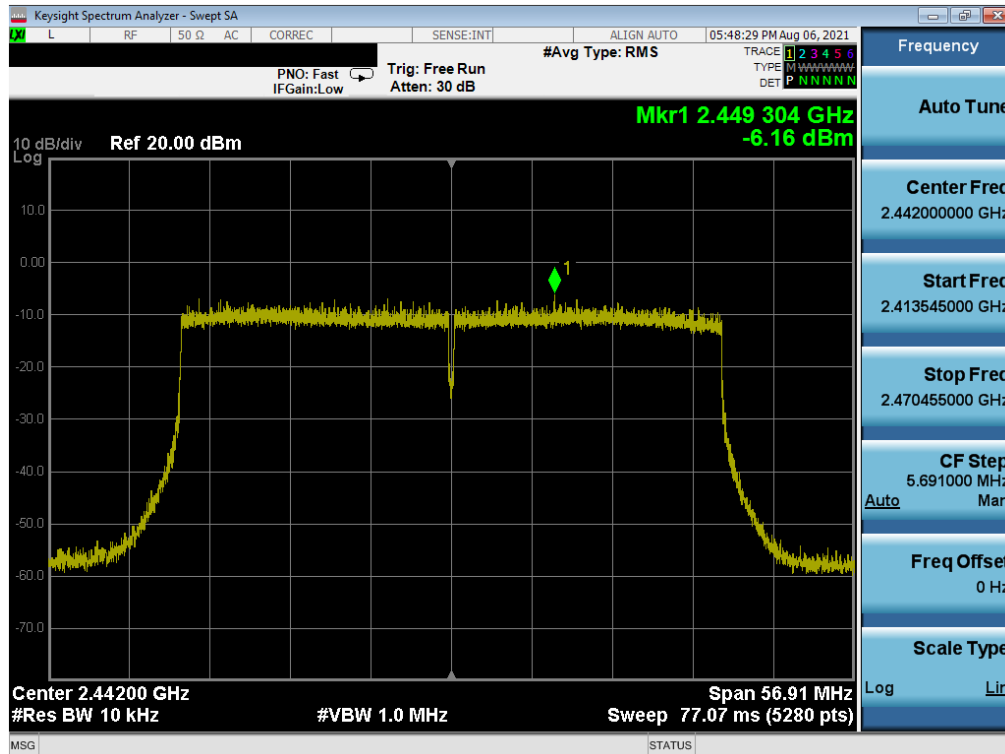


Plot 7-105. Power Spectral Density Plot MIMO NORTH (802.11n 40MHz BW (2.4GHz) – Ch. 11)

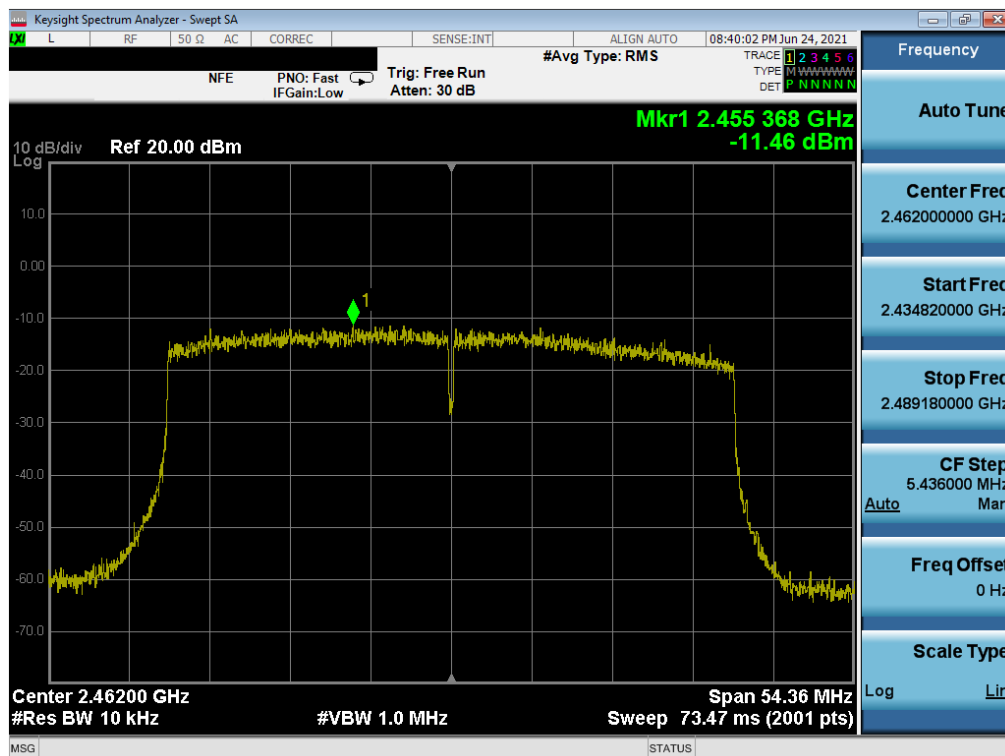


Plot 7-106. Power Spectral Density Plot MIMO NORTH (802.11ax 40MHz BW (2.4GHz) – Ch. 3)

7.5 Conducted Emissions at the Band Edge

§15.247(d); RSS-247 [5.5]

Test Overview and Limit

All out of band emissions are measured with a spectrum analyzer connected to the antenna terminal of the EUT while the EUT is operating at its maximum duty cycle, at maximum power, and at the appropriate frequencies. All data rates were investigated to determine the worst case configuration. For the following out of band conducted spurious emissions plots at the band edge, the EUT was set at a data rate of 1Mbps for “b” mode, 6 Mbps for “g” mode, 6.5/7.2Mbps for “n” mode, and 8.6Mbps for “ax” mode as these settings produced the worst-case emissions.

The limit for out-of-band spurious emissions at the band edge is 30dB below the fundamental emission level, as determined from the in-band power measurement of the DTS channel performed in a 100kHz bandwidth per the PSD procedure (Section 7.4).

Test Settings

1. Start and stop frequency were set such that the band edge would be placed in the center of the plot
2. Span was set large enough so as to capture all out of band emissions near the band edge
3. RBW = 100kHz
4. VBW = 1MHz
5. Detector = Peak
6. Number of sweep points $\geq 2 \times \text{Span/RBW}$
7. Trace mode = max hold
8. Sweep time = auto couple
9. The trace was allowed to stabilize

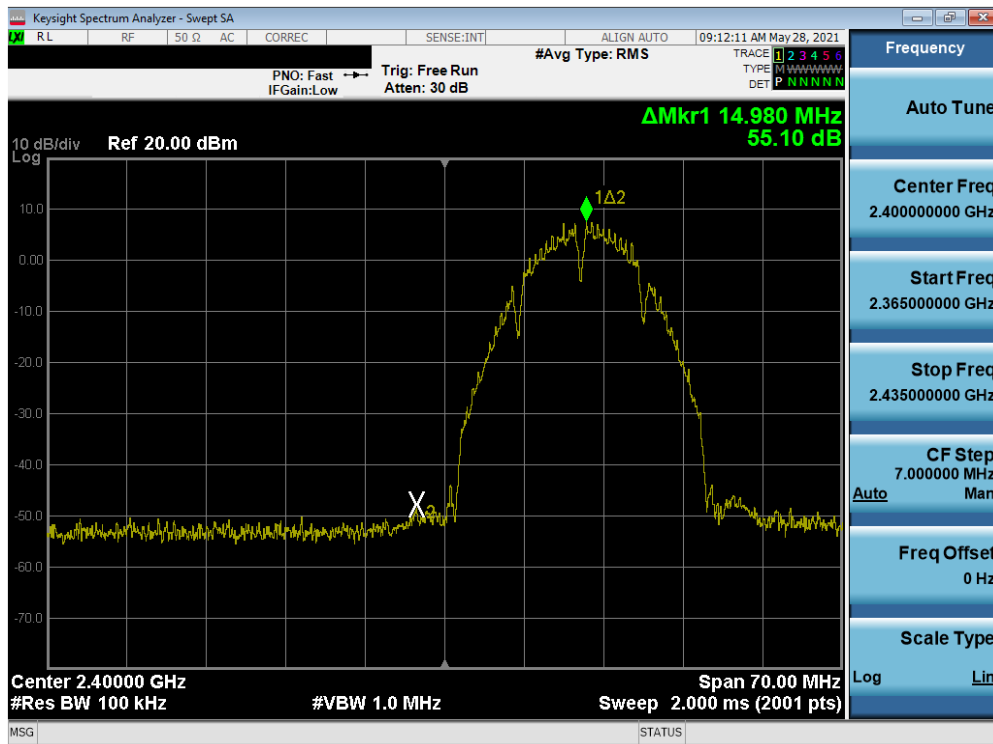

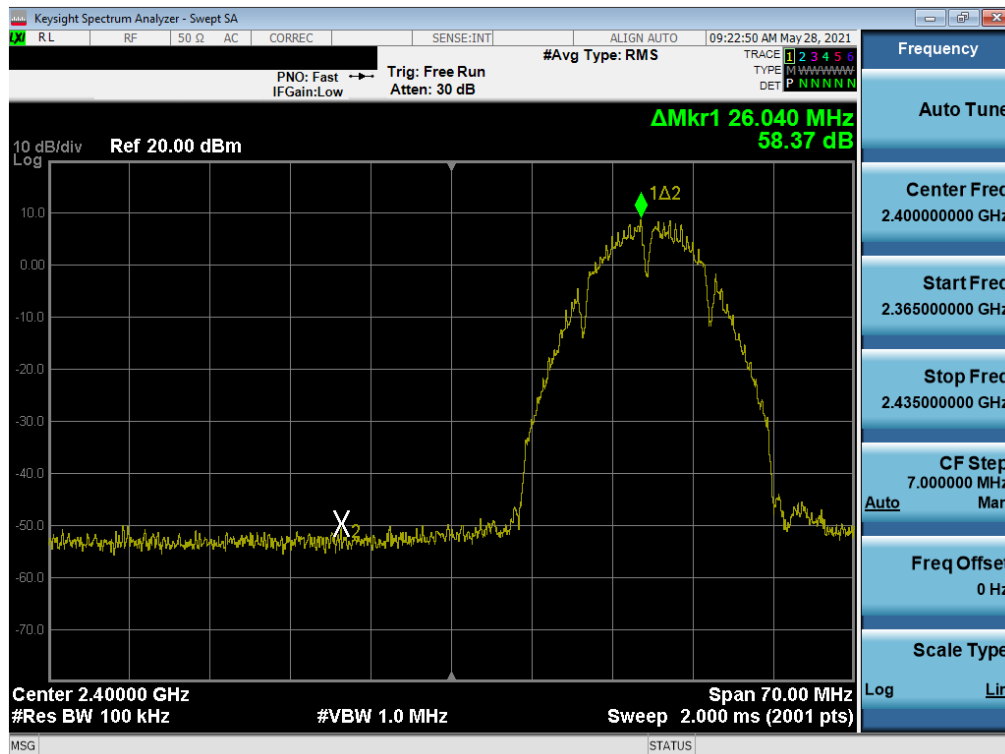
