







According to description of ANSI C63.4-2003 sec.12.1.5, the antenna conducted power measurements were carried out.

Antenna-conducted power measurements shall be performed with the EUT antenna terminals connected directly to either a spectrum analyzer or another measuring instrument, if the antenna impedance matches the impedance of the measuring instrument. Otherwise, use a balun or impedance-matching network to connect the measuring instrument to antenna terminals of the EUT. 

Frequency in MHz




