### 3. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4 and FCC CFR 47 2.1046, 2.1047, 2.1049, 2.1051, 2.1053, 2.1055, 2.1057, 15.207, 15.209 and 15.249.

#### 3.1EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

#### 3.2EUT EXERCISE

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.107 and 15.109 under the FCC Rules Part 15 Subpart B and Section 15.207, 15.209,15.249 under the FCC Rules Part 15 Subpart C.

#### 3.3GENERAL TEST PROCEDURES

#### **Conducted Emissions**

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-peak and average detector modes.

#### **Radiated Emissions**

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 13.1.4.1 of ANSI C63.4.

(b) Except as provided in paragraphs (d) and (e), the field strength of emissions appearing within these frequency bands shall not exceed the limits shown in Section 15.209. At frequencies equal to or less than 1000 MHz, compliance with the limits in Section 15.209 shall be demonstrated using measurement instrumentation employing a CISPR quasi-peak detector. Above 1000 MHz, compliance with the emission limits in Section 15.209 shall be demonstrated based on the average value of the measured emissions. The provisions in Section 15.35 apply to these measurements.

#### 3.5DESCRIPTION OF TEST MODES

The EUT (model: M953U III) had been tested under operating condition.

After verification, all tests were carried out with the worst case test modes as shown below except radiated spurious emission below 1GHz and powerline conducted emission below 30MHz, which worst case was in normal link mode.

Channel Low(2410MHz), Channel Mid(2437MHz) and Channel High(2473MHz) were chosen for the final testing.







### Detector mode: Peak Polarity: Vertical




### Detector mode: Average Polarity: Vertical





### Detector mode: Average Polarity: Horizontal





### Detector mode: Peak Polarity: Vertical












