We are herewith submitting an original filing for Thomson Consumer Electronics, Inc. for their Model 26921XXX-M [where "XXX" is any letter or number which represents trade name, packaging and colour], for Part 15 certification.

The subject model is a 900MHz low power analog cordless telephone.

All required tests in compliance with Part 15 of the FCC Rules have been completed with the following modifications:

Base Unit:

1. F1, 10  $\Omega$  1/2W resistor was changed to Polyswitch (TR600-150) or 350mA slow blow fuse.
2. R33, 47 $\Omega$  1/2W resistor was deleted and replaced by a jumper.
3. J21 was deleted.
4. R103, 33K $\Omega$  resistor was changed to 20K $\Omega$ .
5. R104, 22K $\Omega$  resistor was changed to 36K $\Omega$ .
6. R103 was connected to 5V instead of 9V.

At the same time, Thomson Consumer Electronics Canada Inc. would like to add the their Models 26920XXX-M, 2-6921M and 2-6920M as a family approval with Model 26921XXX-M as detailed below. These models will bear the same FCC ID: G9H2-6920M.

**26920XXX-M** is identical to 26921XXX-M except for model designation and headset [26921XXX-M has a headset whereas 26920XXX-M does not have a headset].

**2-6921M** is identical to 26921XXX-M except for model designation.

**2-6920M** is identical to 26920XXX-M except for model designation
