We are herewith submitting a modification filing for Thomson Consumer Electronics, Inc. for their Model 2-9750(XXXX) for Part 15 Class II Permissive Change. The new version of 2-9750(XXXX) is now 267000XXX-A (where "XXX" is any letter or number which represents trade name, packaging and colour), which has the same FCC ID G9H2-9750.

The alternate construction consists of changes in the circuitry.

Applicable tests have been completed on revised Model 26700XXX-A with the following modifications:

Base Unit:

1. C36, 68pF capacitor was changed to 150pF.
2. R57, 2.2K Ω resistor was changed to 3.3K Ω .
3. F1, 10 Ω 1/2W resistor was changed to Polyswitch (TR600-150) or 350mA slow blow fuse.
4. R33, 47 Ω 1/2W resistor was deleted and replaced by a jumper.
