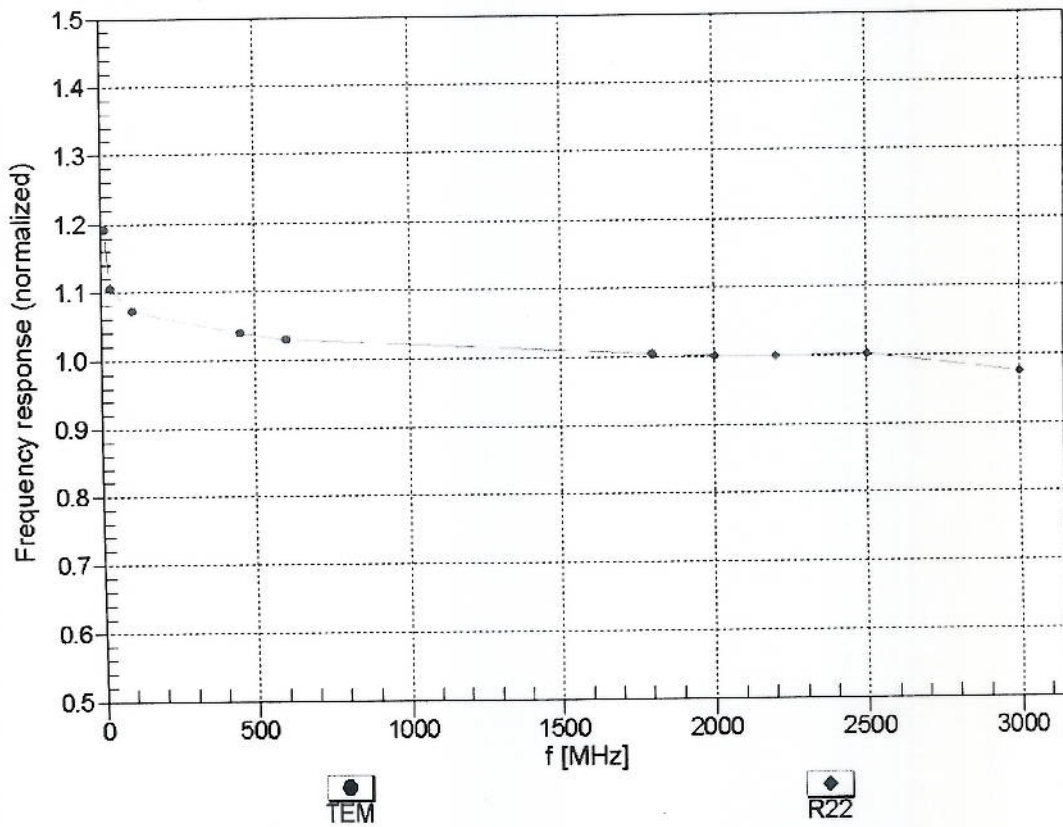

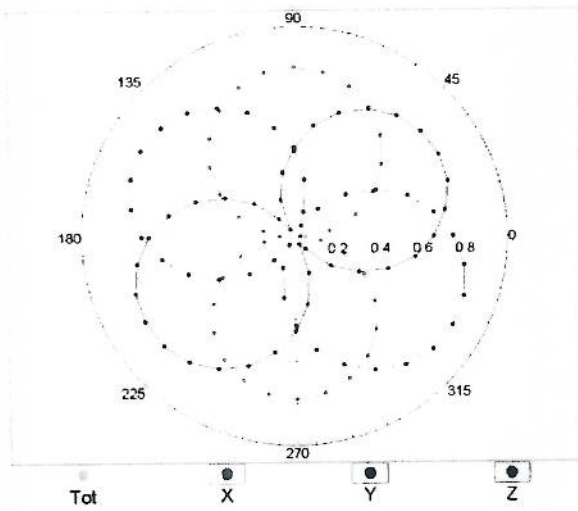
## Frequency Response of E-Field (TEM-Cell: ifi110 EXX, Waveguide: R22)



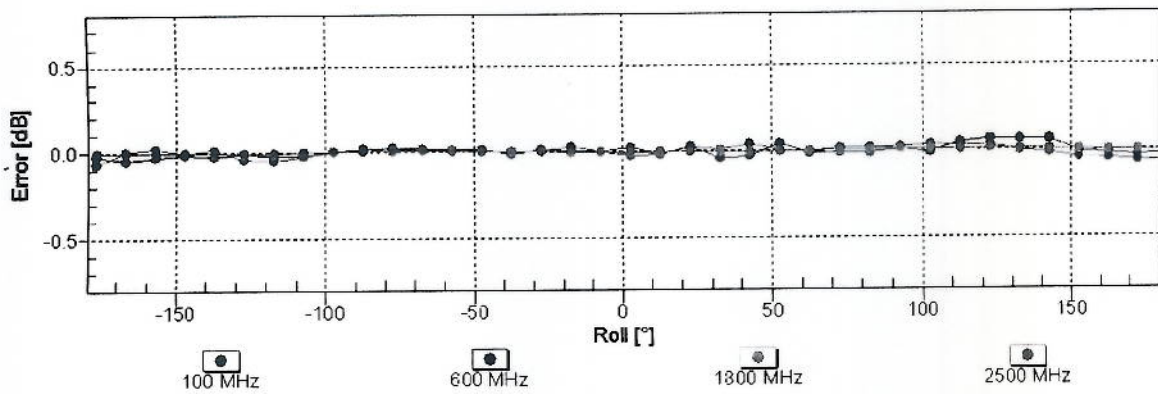
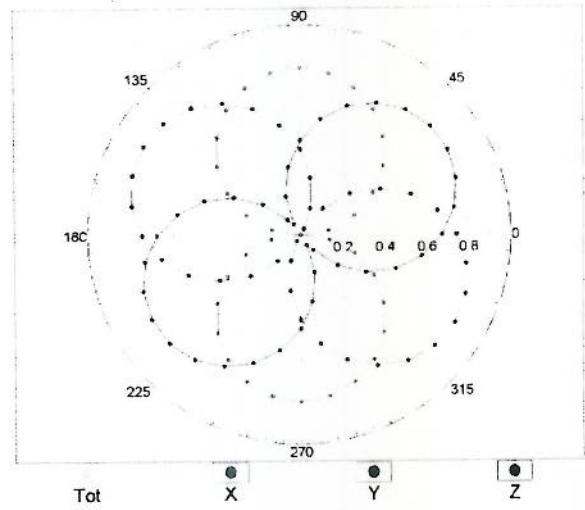

f=600 MHz,TEM

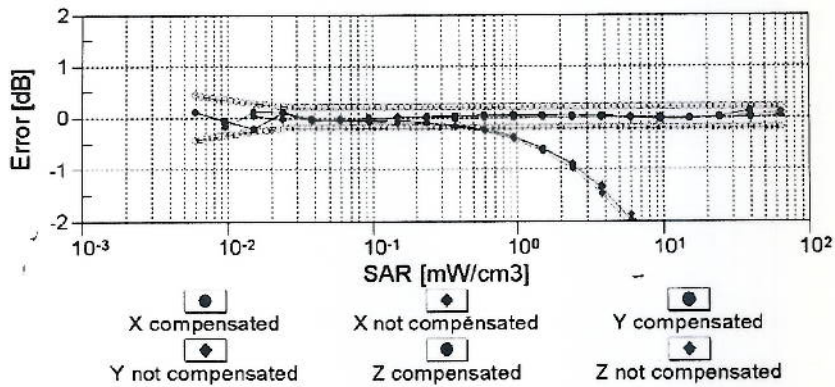
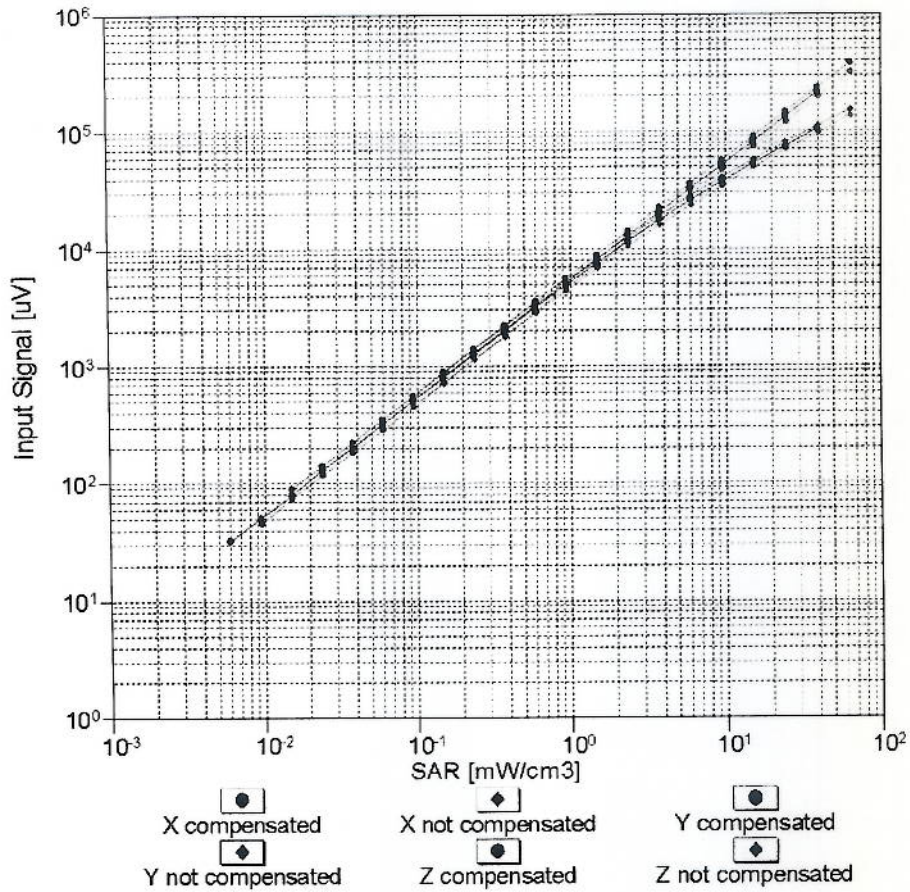


f=1800 MHz,R22



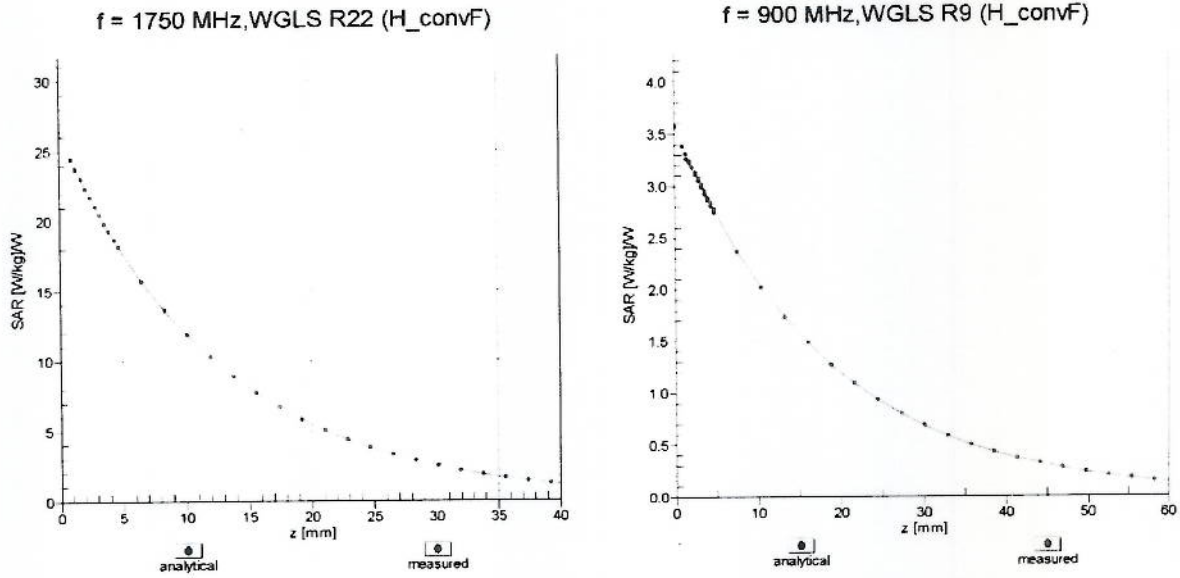
Uncertainty of Axial Isotropy Assessment:  $\pm 0.5\%$  ( $k=2$ )
