


Fig.2.1 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)




Fig.2.2 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)




Fig.4 Lap-held mode
