Measurement Result

The predicted power density level at 20 cm is 0.00229 mW/cm². This is below the uncontrolled exposure limit of 1 mW/cm² at 2480MHz.

Note: In comparison with BR, and EDR, BR results highest emission of power, and further produces higher value of Maximum Permissible Exposure at 20cm. Hence, only the derivation of MPR on the basis of BR mode is present in this given test report.
