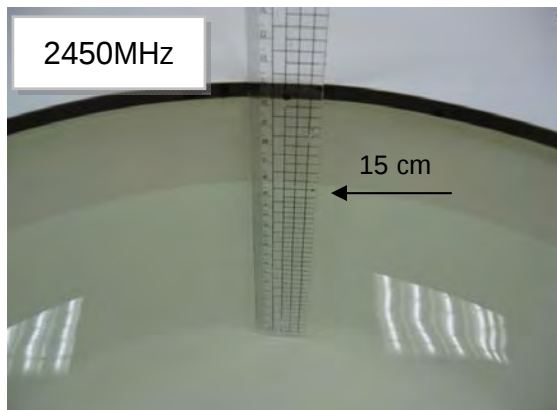

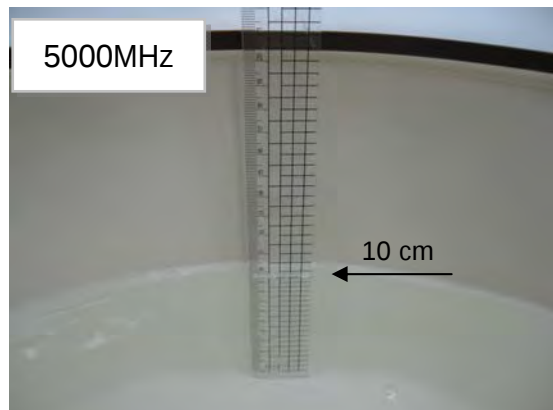

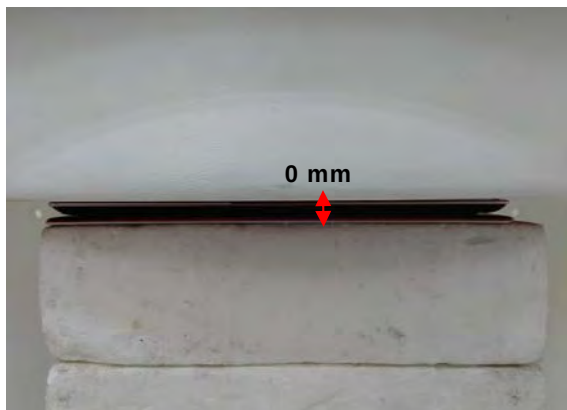


Fig.3 EUT Back side_Tablet mode to flat phantom

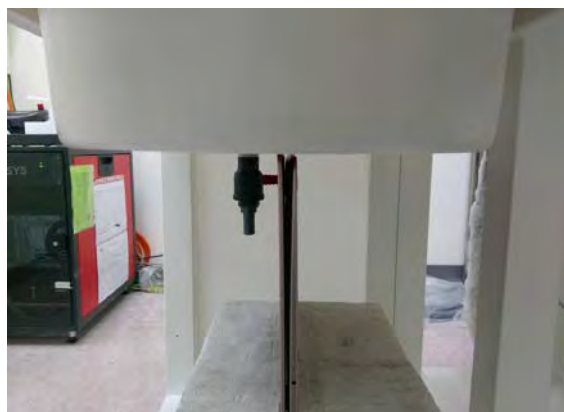


Fig.4 EUT Top side_Tablet mode to flat phantom

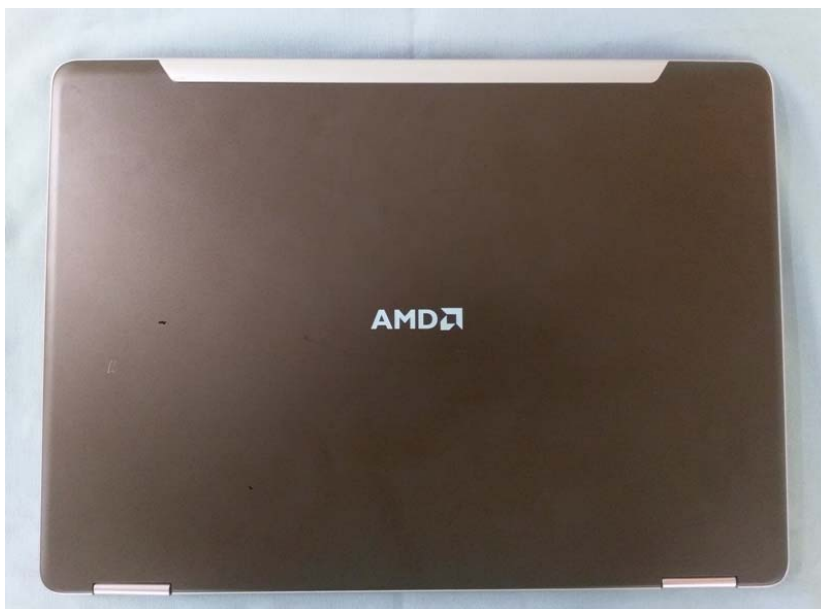


Fig.5 Front view of EUT

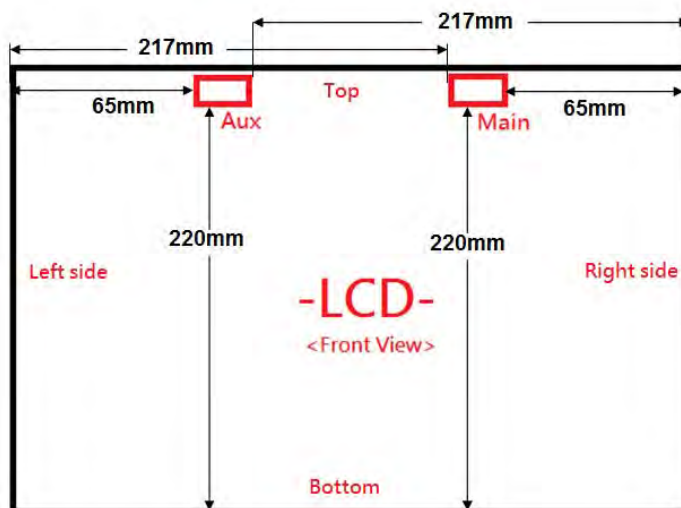


Fig.7 Antenna location of tablet mode (front view)

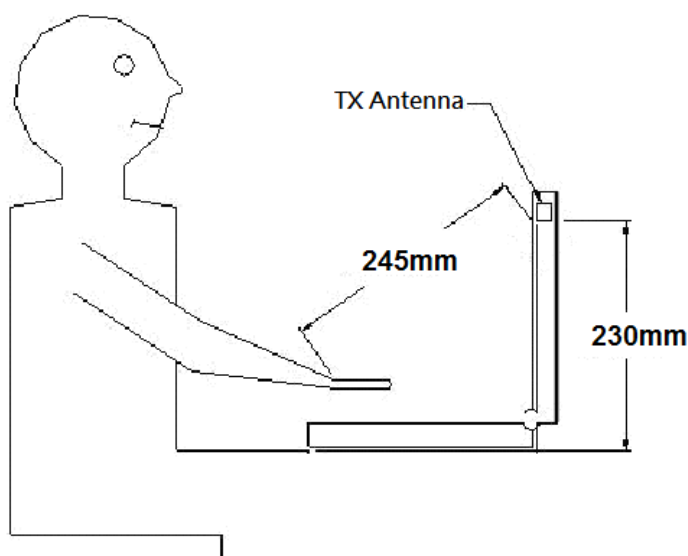


Fig.9 Antenna location of laptop mode
