






Fig.3 EUT Back side (Stand Mode) to flat phantom




Fig.4 EUT Top side (Stand Mode) to flat phantom





Fig.5 EUT Bottom side (Stand Mode) to flat phantom




Fig.6 EUT Right side (Stand Mode) to flat phantom





Fig.7 EUT Left side (Stand Mode) to flat phantom




Fig.8 EUT Bottom side (Display Mode_Main) to flat phantom




Fig.12 Antenna location of EUT (Stand mode)




Fig.13 Antenna location of EUT (Display mode)




Fig.14 Antenna location of EUT (Notebook mode)
