Question #1: Appendix H provides Probe assessment due to conversion factor per KDB 450824. By reviewing the Appendix H, probe assessment only covers 900 MHz body conversion factor for cellular band. Since the final SAR is evaluated with probe calibrated at 1950 MHz which is also outside +/- 50 MHz of 1852.4-1907.6 MHz PCS frequency range. Please provide additional probe assessment for 1950 MHz.

FYI: For the future filing, please make sure to enter all radio parameter from the original grant to permissive change application.
