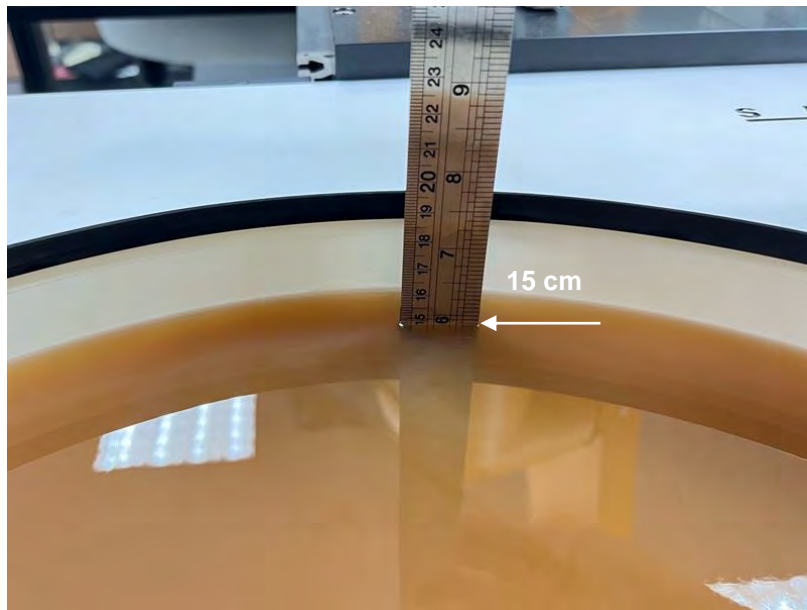


Fig.1 Photograph of the SAR measurement system

**Photograph of the tissue simulant fluid liquid depth (Body)**



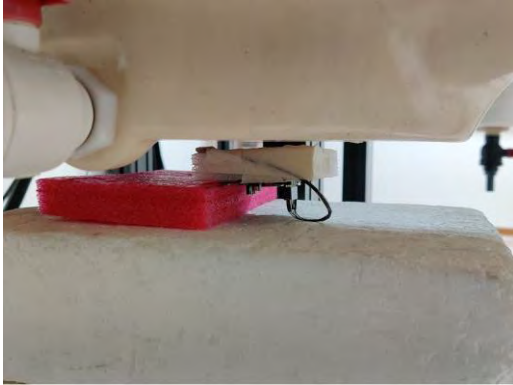

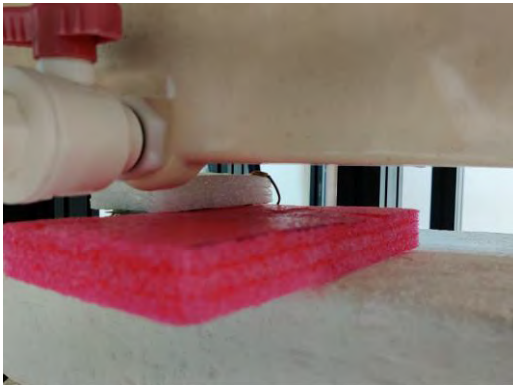

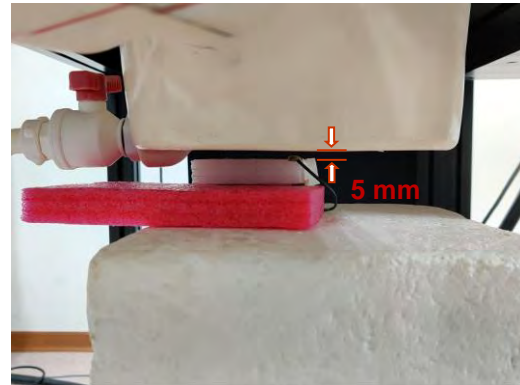
**Photograph 1. Body, Front Surface, 5mm**

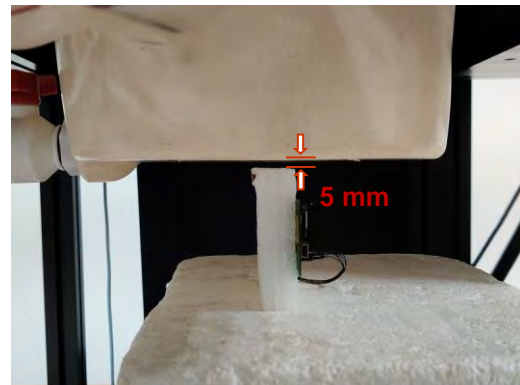
**Photograph 3. Body, Back Surface, 5mm**

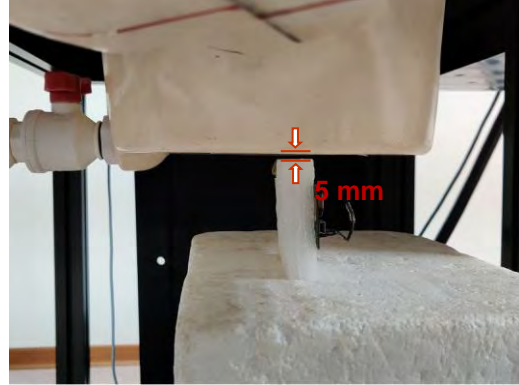

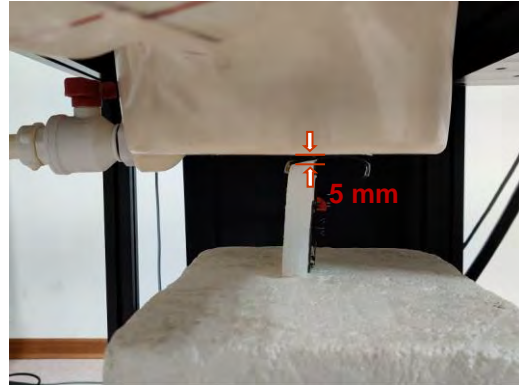
**Photograph 7. Body, Bottom Edge, 5mm**

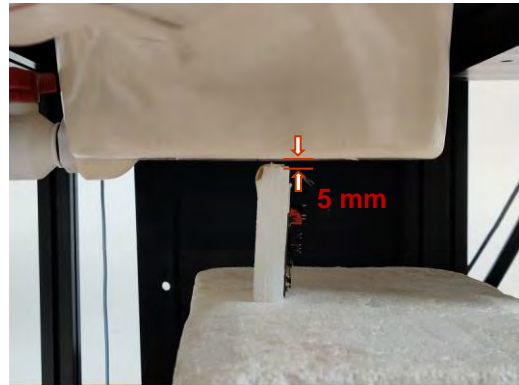
**Photograph 9. Body, Right Edge, 5mm**

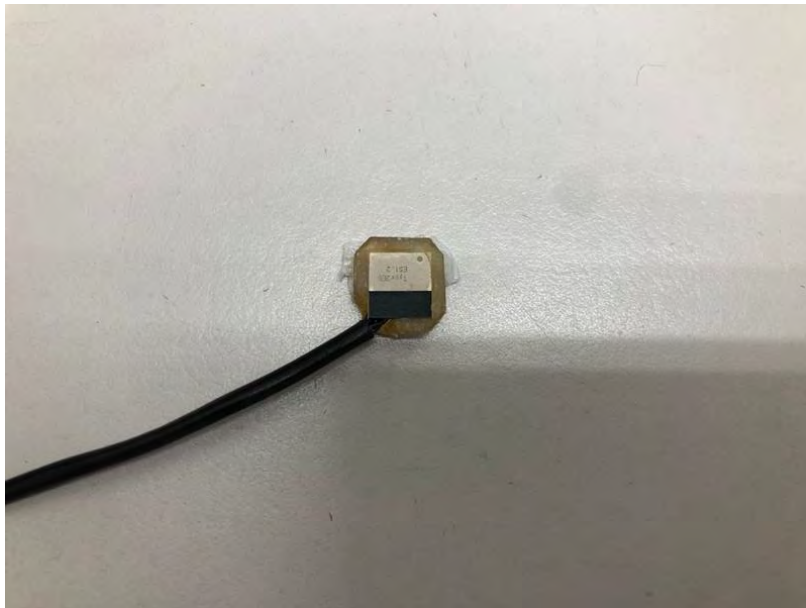

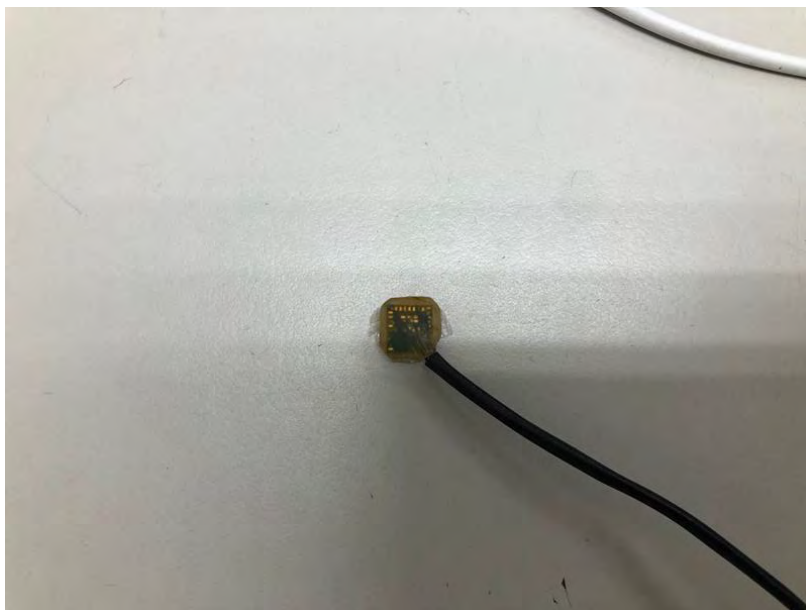

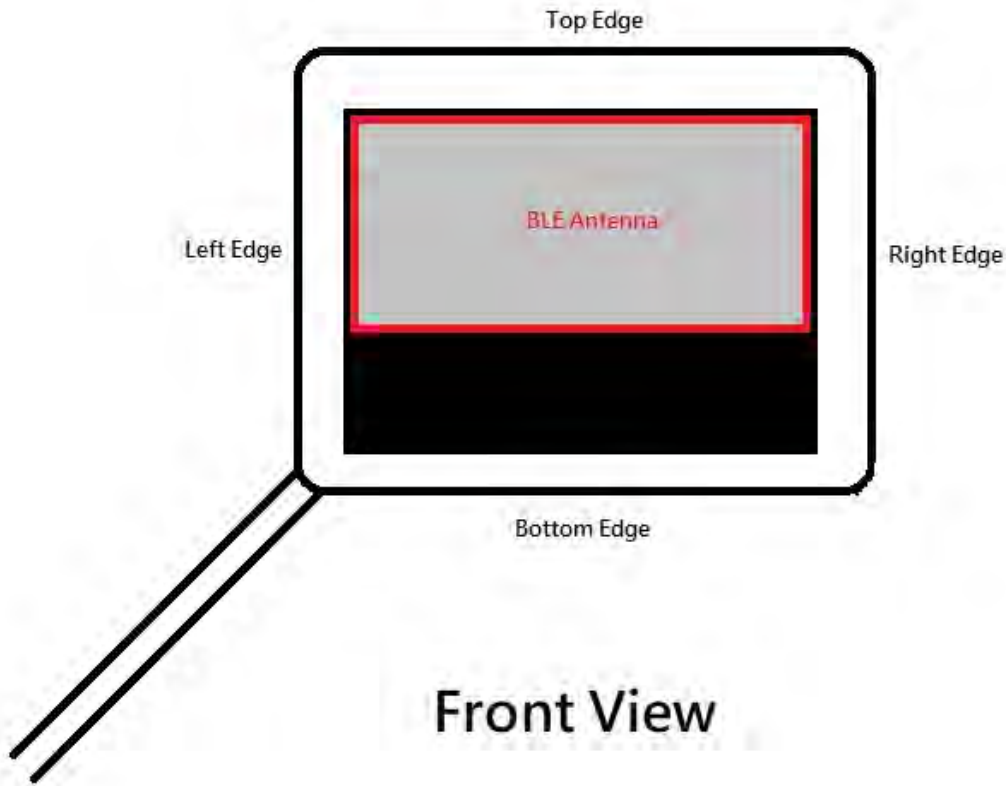


Photograph 14. Back view of EUT
