Buttons and Controls

Getting Started

Congratulations on the purchase of your new Avid MiniTracker 4 Wand™ microchip scanner!


Need to get started quickly? Just follow these instructions:

1. Remove your new scanner from the packaging.
2. Hold down the read button to activate the reader and scan for a microchip.
3. When a microchip ID is read, it will be displayed on the screen and retained in the history of scanned microchips.

Powering off:

By default, the MiniTracker 4 Wand automatically powers off when no buttons are pressed for 1 minute.

To manually power off the reader:

1. Hold down both the  (center) and read buttons.
2. After 3 seconds, the reader will power off.

Bluetooth connectivity

1. Press the * button to change settings.
2. Scroll down to “Bluetooth”, press the circle button and switch Bluetooth® to “on”.
3. On your device search for new Bluetooth® devices and pair as usual.
4. Every time you scan a microchip, the number will be sent to the device as if it were being typed on the keyboard.

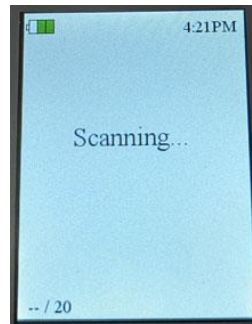

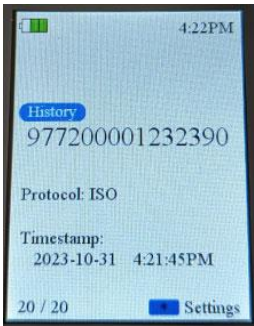

Changing the Batteries

To replace the batteries:

1. Unscrew the two screws on the back of the case, near the top and bottom of the label.
2. Remove the old batteries.
3. Insert the new batteries.
4. Replace the back and tighten the screws to fix it in place.
