


Figure RE06.2: EUT test setup, front view




Figure RE06.3: EUT test setup, reverse view




Figure RE13.2: EUT test setup, front view




Figure RE13.3: EUT test setup, reverse view




Figure CE03.3: Test setup, left side view

Figure RE16.2: EUT test setup, front view




Figure RE16.3: EUT test setup, reverse view




Figure RE17.2: EUT test setup, front view




Figure RE17.3: EUT test setup, reverse view




Figure RE02.3: EUT test setup, primary view (Y orientation).




Figure RE03.3: EUT test setup, primary view (Y orientation)




Figure RE04.5: EUT test setup, primary view





Figure RE05.2: EUT test setup, front view




Figure RE11.4: EUT test setup, front view




Figure CE01.3: Test setup, left side view




Figure RE01.3: EUT test setup, primary view (Y orientation)





Figure RE05.2: EUT test setup, front view




Figure RE11.4: EUT test setup, front view




Figure CE01.3: Test setup, left side view
