



Test results in this report relate only to the items tested.

Equipment Function and Configuration

The EUT incorporates a low power transmitter with operation capability in the 2402-2480 MHz frequency band (CFR 47 15.249 and RSS-210). The design provides operation using multiple communication protocols with single active channel at any time. The design utilizes internal fixed antenna system and offers no provision for antenna replacement or modification. Two samples were provided for testing, one production design and the other modified for testing purposes replacing integral antenna with RF connection port. Both samples were provided with test software enabling testing personnel ability to enable transmitter function on defined channels. The antenna modification offered testing facility ability to connect test equipment to the temporary antenna port for antenna port conducted emission testing. The EUT was arranged as typical user equipment configurations for testing purposes. The transmitter offers no other interface connections than those in the configuration diagram as shown below. The unit operates from internal battery power only and requires recharge with use of associated charging cable and AC Adapter. No other interface options are provided than those shown in the configuration diagram below. As requested by the manufacturer and required by regulations, the equipment was tested for emissions compliance using the available configurations with the worst-case data presented. Test results in this report relate only to the products described in this report.


In accordance with the Federal Communications Code of Federal Regulations, dated October 1, 2012, Part 2, Subpart J, Paragraphs 2.907, 2.911, 2.913, 2.925, 2.926, 2.1031 through 2.1057, and applicable parts of paragraph 15, Part 15C Paragraph 15.249, and RSS-210 the following information is submitted. Test procedures used are the established Methods of Measurement of Radio-Noise Emissions as described in ANSI C63.4-2009 and ANSI C63.10-2009. Testing for the AC line-conducted emissions were performed as defined in sections 7 and 13.1.3, testing of the radiated emissions was performed as defined in sections 8 and 13.1.4 of ANSI C63.4-2009. Testing of the radiated emissions was performed as required including procedures in section 13 of ANSI C63.4-2009.

Equipment Testing Procedures

AC Line Conducted Emission Test Procedure

Testing for the AC line-conducted emissions was performed as defined in sections 7.2.4 and 13.3 of ANSI C63.4-2009. The test setup, including the EUT, was arranged in the test configurations as presented during testing. The test configuration was placed on a 1 x 1.5-meter wooden bench, 0.8 meters high located in a screen room. The power lines of the system were isolated from the power source using a standard LISN with a 50- μ Hy choke. EMI was coupled to the spectrum analyzer through a 0.1 μ F capacitor internal to the LISN. The LISN was positioned on the floor beneath the wooden bench supporting the EUT. The power lines and cables were draped over the back edge of the table. Refer to photographs in exhibits for EUT placement used during testing.

Diagram 1 Test arrangement for Conducted emissions




1. Interconnecting cables that hang closer than 40 cm to the ground plane were folded back and forth in the center forming a bundle 30 cm to 40 cm long.
2. Input/output (I/O) cables that are not connected to a peripheral shall be bundled in the center. The end of the cable may be terminated, if required, using the correct terminating impedance. The overall length shall not exceed 1 m.
3. EUT connected to one LISN. Unused LISN measuring port connectors are terminated into 50 Ω loads. LISN is placed on top of and bonded to reference ground plane.
 - 3.1 All other equipment powered from additional LISN(s).
 - 3.2 Multiple outlet strips can be used for multiple power cords of non-EUT equipment.
 - 3.3 LISN is positioned at least 80 cm from nearest part of EUT chassis.
4. Cables of hand-operated devices, such as keyboards, mice, and so on, shall be placed as for normal use.
5. Non-EUT components of EUT system being tested.
6. Rear of EUT, including peripherals, shall all be aligned and flush with rear of tabletop.
7. Rear of tabletop shall be 40 cm removed from a vertical conducting plane that is bonded to the ground plane (see 5.2.2 for options).

Radiated Emission Test Procedure

The EUT was placed on a rotating 1 x 1.5-meter wooden platform, 0.8 meters above the ground plane at a distance of 3 meters from the FSM antenna. Radiated emissions testing was performed as required in CFR47 15, RSS-210 and specified in sections 8 and 13.1.4 of ANSI C63.4-2009. EMI energy was maximized by equipment placement, raising and lowering the FSM antenna, changing the antenna polarization, and by rotating the turntable. Each emission was maximized before data was taken using a spectrum analyzer. The frequency spectrum from 9 kHz to 25,000 MHz was searched for during preliminary investigation. Refer to diagrams 2 and 3 showing typical test arrangement and photographs in the test setup exhibits for specific EUT placement during testing.


Diagram 2 Test arrangement for radiated emissions of tabletop equipment



1. Interconnecting cables that hang closer than 40 cm to the ground plane shall be folded back and forth in the center, forming a bundle 30 cm to 40 cm long.

2. I/O cables that are not connected to a peripheral shall be bundled in the center. The end of the cable may be terminated if required using the correct terminating impedance. The total length shall not exceed 1 m.
3. If LISNs are kept in the test setup for radiated emissions, it is preferred that they be installed under the ground plane with the receptacle flush with the ground plane.
4. Cables of hand-operated devices, such as keyboards, mice, and so on, shall be placed as for normal use.
5. Non-EUT components of EUT system being tested.
6. Rear of EUT, including peripherals, shall all be aligned and flush with rear of tabletop (possibly center of table for transmitter equipment).
7. No vertical conducting plane used.
8. Power cords drape to the floor and are routed over to receptacle.

Intentional Radiators

As per CFR47, Subpart C, paragraph 15.249 and RSS-210 the following information is submitted.

Antenna Requirements

The EUT incorporates integral antenna system and offers no provision for connection to alternate system. The antenna connection point complies with the unique antenna connection requirements. The unique antenna connection requirements are fulfilled. There are no deviations or exceptions to the specification.

Restricted Bands of Operation

Spurious emissions falling in the restricted frequency bands of operation were measured at the OATS. The EUT utilizes frequency, determining circuitry, which generates harmonics falling in the restricted bands. Emissions were investigated at the OATS, using appropriate antennas or pyramidal horns, amplification stages, and a spectrum analyzer. Peak and average amplitudes of frequencies above 1000 MHz were compared to the required limits with worst-case data presented below. Test procedures of ANSI C63.4-2009 paragraphs 13.1 and 8.3.1.2 were used during testing. No other significant emission was observed which fell into the restricted bands of operation. Computed emission values take into account the received radiated field strength, receive antenna correction factor, amplifier gain stage, and test system cable losses.

Other emissions present had amplitudes at least 20 dB below the limit. Peak and Quasi-Peak amplitude emissions are recorded for frequency range below 1000 MHz. Peak and Average amplitude emissions are recorded for frequency range above 1000 MHz.

Summary of Results for Radiated Emissions in Restricted Bands

The EUT demonstrated compliance with the radiated emissions requirements of CFR 47 Part 15C and RSS-210 Intentional Radiators. The EUT demonstrated a worst-case minimum margin of -2.0 dB below the radiated emissions requirements in restricted frequency bands. Peak, Quasi-peak, and average amplitudes were checked for compliance with the regulations. Worst-case emissions are reported with other emissions found in the restricted frequency bands at least 20 dB below the requirements.

General Radiated Emissions Procedure

The EUT was arranged in a typical equipment configuration and operated through all available modes with worst-case data recorded. Preliminary testing was performed in a screen room with the EUT positioned 1 meter from the FSM. Radiated emissions measurements were performed to identify the frequencies, which produced the highest emissions. Each radiated emission was then maximized at the OATS location before final radiated emissions measurements were performed. Final data was taken with the EUT located at the OATS at a distance of 3 meters between the EUT and the receiving antenna. The frequency spectrum from 9 kHz to 25,000 MHz was searched for general radiated emissions. Measured emission levels were maximized by EUT placement on the table, rotating the turntable through 360 degrees, varying the antenna height between 1 and 4 meters above the ground plane and changing antenna position between horizontal and vertical polarization. Antennas used were Loop from 9 kHz to 30 MHz, Broadband Biconical from 30 to 200 MHz, Biconilog from 30 to 1000 MHz, Log Periodic from 200 MHz to 1 GHz and or double Ridge or pyramidal horns and mixers from 1 GHz to 40 GHz, notch filters and appropriate amplifiers and external mixers were utilized.

Other emissions present had amplitudes at least 20 dB below the limit. Peak and Quasi-Peak amplitude emissions are recorded for frequency range below 1000 MHz. Peak and Average amplitude emissions are recorded for frequency range above 1000 MHz.

Summary of Results for General Radiated Emissions

The EUT demonstrated compliance with the radiated emissions requirements of CFR47 Part 15C paragraph 15.209 and RSS-210 Intentional Radiators. The EUT demonstrated a minimum margin of -18.9 dB below the requirements. Other emissions were present with amplitudes at least 20 dB below the Limits.



Operation in the Band 2400 – 2483.5 MHz

The transmitter output power; harmonic and general emissions were measured on an open area test site @ 3 meters. Test procedures of ANSI C63.4-2009 paragraphs 13.1 and 8.3.1.2 were used during testing. The EUT was placed on a wooden turntable 0.8 meters above the ground plane and at a distance of 3 meters from the FSM antenna. The peak and quasi-peak amplitude of frequencies below 1000 MHz were measured using a spectrum analyzer. The peak and average amplitude of frequencies above 1000 MHz were measured using a spectrum analyzer. The amplitude of each emission was then recorded from the analyzer display. Emissions radiated outside of the specified bands, except for harmonics, shall be attenuated by at least 50 dB below the level of the fundamental or to the general radiated emission limits, whichever is the lesser attenuation. Plots were taken of transmitter performance for reference in this and other documentation. Refer to figures one through eight showing plots taken of the EUT performance displaying compliance with the specifications. The amplitude of each radiated emission was measured on the OATS at a distance of 3 meters from the FSM antenna (testing was performed on sample 1 representative of production with integral antenna). The amplitude of each radiated emission was maximized by varying the FSM antenna height, polarization, and by rotating the turntable. A Loop antenna was used for measuring emissions from 0.009 to 30 MHz, Biconilog Antenna for 30 to 1000 MHz, Double-Ridge, and/or Pyramidal Horn Antennas from 1 GHz to 25 GHz. Emissions were measured in dB μ V/m @ 3 meters.




Figure 1 Plot of Transmitter Emissions (Output in Operational Band Protocol 1)




Figure 2 Plot of Transmitter Emissions (Occupied Bandwidth Protocol 1)




Figure 3 Plot of Transmitter Emissions (Low Band Edge Protocol 1)




Figure 4 Plot of Low Band Edge (High Band Edge Protocol 1)




Figure 5 Plot of Transmitter Emissions (Output in Operational Band Protocol 2)




Figure 6 Plot of Transmitter Emissions (Occupied Bandwidth Protocol 2)




Figure 7 Plot of Transmitter Emissions (Low Band Edge Protocol 2)




Figure 8 Plot of Low Band Edge (High Band Edge Protocol 2)

Summary of Results for Transmitter Radiated Emissions of Intentional Radiator

The EUT demonstrated compliance with the radiated emissions requirements of FCC CFR 47 Part 15.249, RSS-210 and other applicable standards for Intentional Radiators. The EUT worst-case configuration demonstrated minimum margin of -19.5 dB below the average emission limit. The EUT worst-case configuration demonstrated minimum radiated harmonic emission margin of -2.0 dB below the limits. No other radiated emissions were found in the restricted bands less than 20 dB below limits than those recorded in this report. Other emissions were present with amplitudes at least 20 dB below the limits.

Statement of Modifications and Deviations

No modifications to the EUT were required for the unit to demonstrate compliance with the CFR47 Part 15C and RSS-210 emissions standards. There were no deviations to the specifications.


