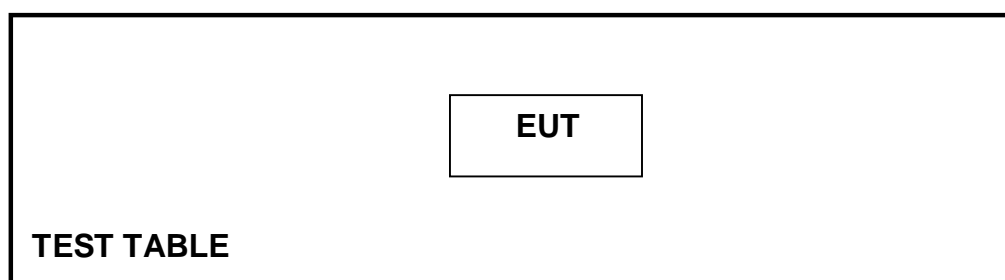

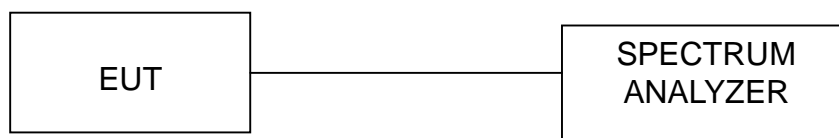

1. Check the calibration of the measuring instrument (SA) using either an internal calibrator or a known signal from an external generator.
2. Turn on the EUT and connect its antenna terminal to measurement via a low loss cable. Then set it to any one measured frequency within its operating range and make sure the instrument is operated in its linear range.
3. Set the SA on MaxHold Mode, and then keep the EUT in hopping mode. Record all the signals from each channel until each one has been recorded.
4. Set the SA on View mode and then plot the result on SA screen.
5. Repeat above procedures until all frequencies measured were complete.

For FHSS, the average time of occupancy on any frequency shall not be greater than 0.4 seconds within a 31.6 second period. For hybrid systems, the average time of occupancy on any frequency should not exceed 0.4 seconds within a time period in seconds equal to the number of hopping frequencies employed multiplied by 0.4.

3. Adjust the center frequency of SA on any frequency be measured and set SA to zero span mode. And then, set RBW and VBW of spectrum analyzer to proper value.
4. Measure the time duration of one transmission on the measured frequency. And then plot the result with time difference of this time duration.
5. Repeat above procedures until all frequencies measured were complete.

### 4.7.3 TEST PROCEDURES

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 10 meter semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

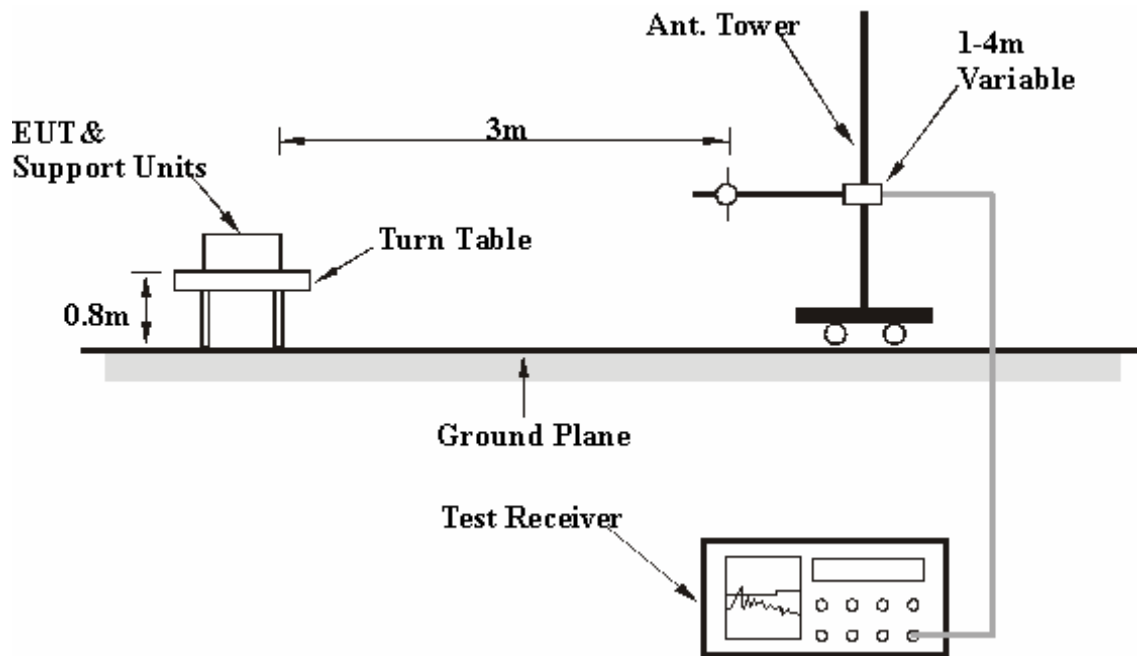

### 4.8.3 TEST PROCEDURE

The transmitter output was connected to the spectrum analyzer via a low lose cable. Set both RBW and VBW of spectrum analyzer to 100 kHz with suitable frequency span including 100 MHz bandwidth from band edge. The band edges was measured and recorded.

#### 4.8.5 EUT OPERATING CONDITION

The software provided by client enabled the EUT to transmit and receive data at lowest, middle and highest channel frequencies individually.

#### 4.8.6 TEST RESULTS

The spectrum plots are attached on the following 2 pages. D2 line indicates the highest level, D1 line indicates the 20dB offset below D2. It shows compliance with the requirement in part 15.247(C).

Note - The delta method is only used up to 2 MHz away from the restricted bandage, The radiated emissions which located in other restricted frequency band, the result, please refer to 4.2.

#### **NOTE (Peak):**

The band edge emission plot on the following page show 59.22dB delta between carrier maximum power and local maximum emission in restrict band (2.3900GHz). The emission of carrier strength list in the test result of channel 0 at the item 4.2 is 98.30dBuV/m, so the maximum field strength in restrict band is  $98.30-59.22=39.08$ dBuV/m which is under 74 dBuV/m limit.

The band edge emission plot on the following page shows 56.54dB delta between carrier maximum power and local maximum emission in restrict band (2.4835GHz). The emission of carrier strength list in the test result of channel 78 at the item 4.2 is 99.96dBuV/m, so the maximum field strength in restrict band is  $99.96-56.54=43.42$ dBuV/m which is under 74 dBuV/m limit.
