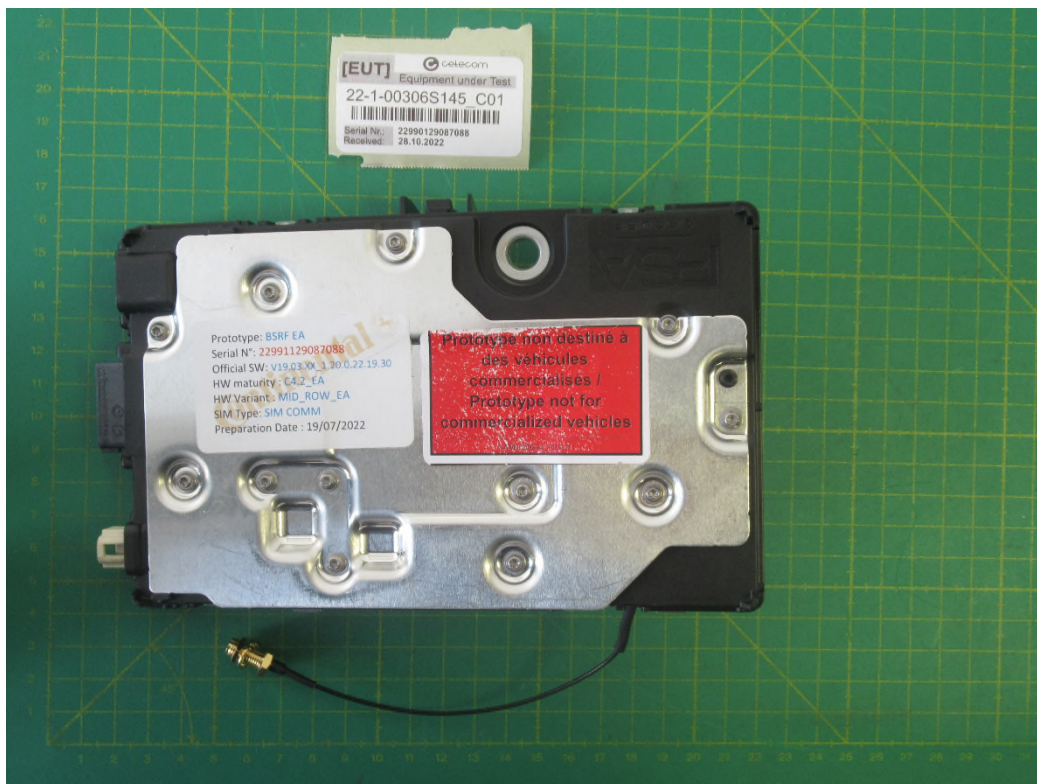


Fig. Ext.: 3 : Ext. - Front Telematic Control Unit EUT 2

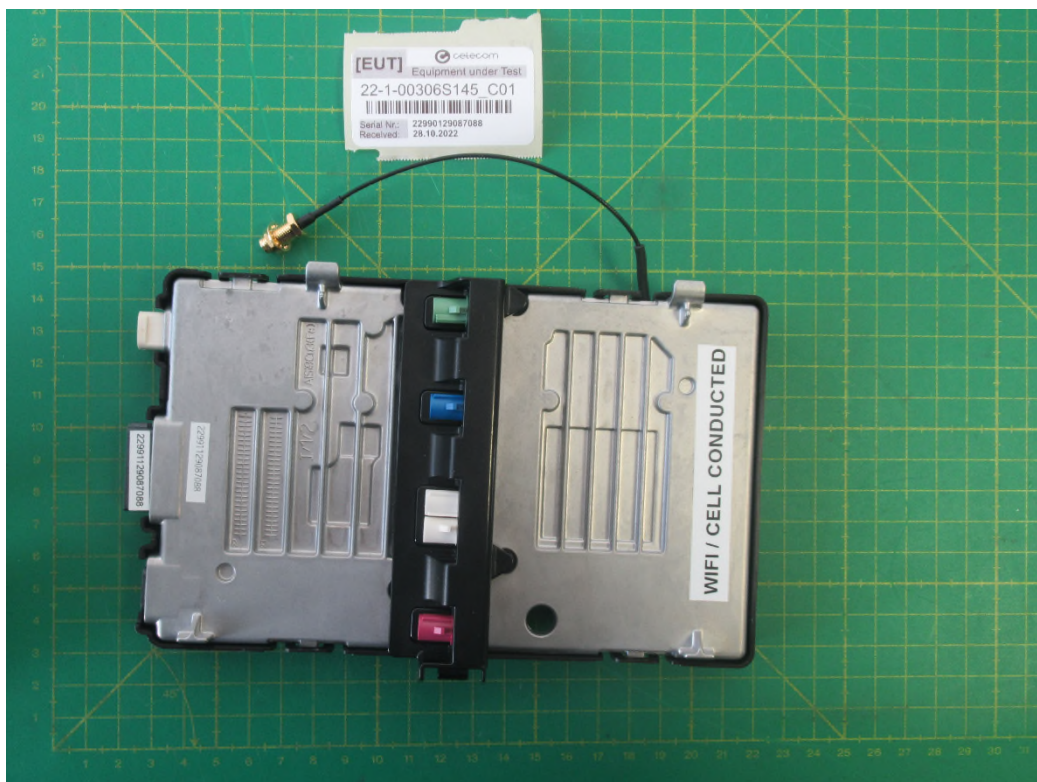


Fig. Ext.: 4 : Ext. - Rear Telematic Control Unit EUT 2

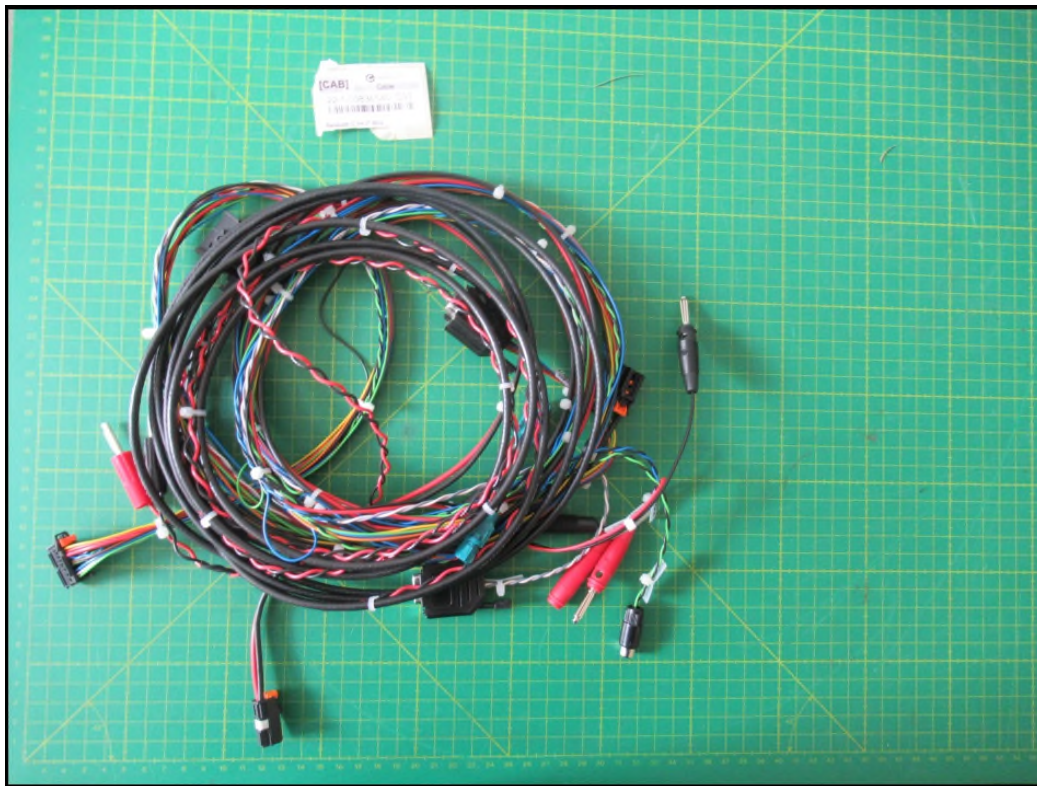
