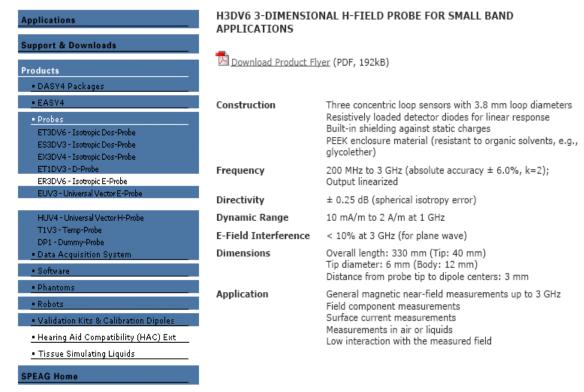

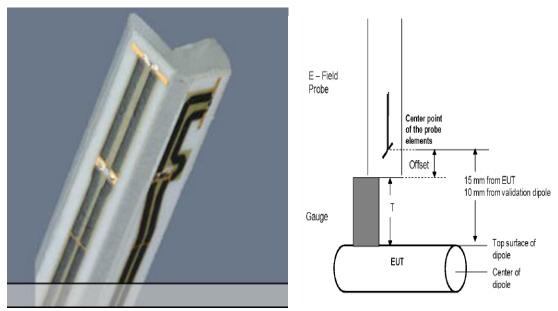

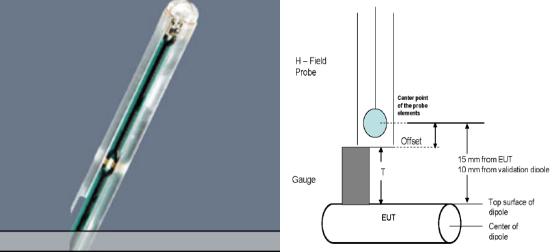

The following information is from the system manufacturer user manual describing the process chain:

In the current implementation, DASY4 waits longer than 100 ms after having reached the grid point before starting a measurement, i.e., the response time uncertainty is negligible.

If the device under test does not emit a CW signal, the integration time applied to measure the electric field at a specific point may introduce additional uncertainties due to the discretization. The tolerances for the different systems had the worst-case of 2.6%.

Receiving Pattern (ϕ), $\vartheta = 90^{\circ}$



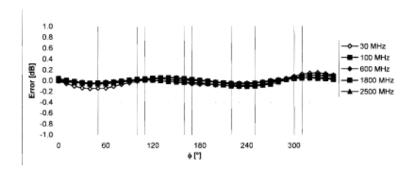

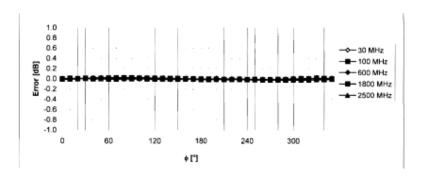

Deviation from Isotropy in Air Error (ϕ, ϑ) , f = 900 MHz



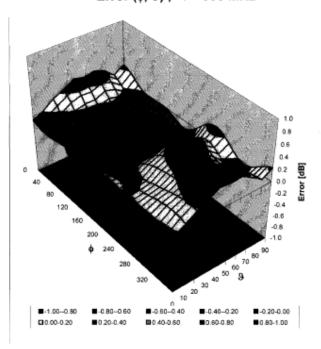

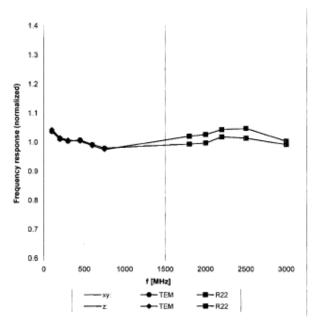

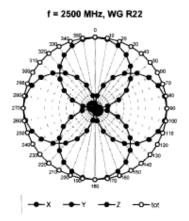

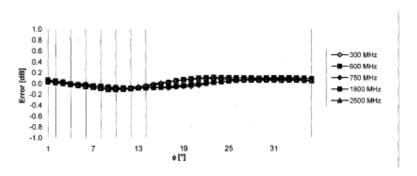

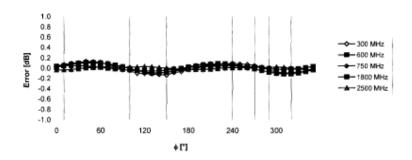
