3. The modular transmitter must have its own power supply regulation.	All power lines derived from the host device are regulated before energizing other circuits internal to the WB1500SH. Please see Block diagram.pdf and Schematic.pdf
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c).	The WB1500SH meets the FCC antenna requirements. Please see external photo.pdf
5. The modular transmitter must be tested in a stand-alone configuration, i.e., the module must not be inside another device during testing.	The WB1500SH was tested in a stand-alone configuration via a PCMCIA extender. Please see conducted set-up photo.pdf and spurious set-up photo.pdf

The modular transmitter must be labeled with its own FCC ID number, and, if the FCC ID is not visible when the module is installed inside another device, then the outside of the device into which the module is installed must also display a label referring to the enclosed module. The modular transmitter must comply with any specific rule or operating requirements applicable to the transmitter and the manufacturer must provide adequate instructions along with the module to explain any such requirements. A copy of these instructions must be included in the application for equipment authorization.	The WB1500SH is compliant with all applicable FCC rules.
