



- Reorient or relocate the receiving antenna.

1. THE BASE STATION AND THE TWO HEADSET WALKIE TALKIES ARE ON THE SAME FREQUENCY. WHEN ALL UNITS ARE ON, IT IS POSSIBLE FOR THREE UNITS TO COMMUNICATE WITH EACH OTHER ONLY ONE PERSON CAN TALK AT THE SAME TIME.
2. OPEN EACH HEADSET COMPARTMENT AND SNAP IN ONE "9-VOLT" BATTERY PER HEADSET BATTERY COMPARTMENT.
3. TURN THE ON/OFF AND VOLUME CONTROL TO DESIRED SOUND LEVEL.
4. TO USE BASE STATION, PRESS THE PUSH-TO-TALK BUTTON ON THE HAND HELD MICROPHONE. TO TRANSMIT, SPEAK IN A NORMAL VOICE, LEVEL INTO THE MICROPHONE GRILL. YOUR MESSAGE WILL BE TRANSMITTED TO BOTH HEADSETS.
5. RELEASE THE PUSH-TO-TALK BUTTON TO RECEIVE.
6. TO SEND SECRET-CODE: PUSH THE PUSH-TO-TALK BUTTON AND PRESS AND RELEASE THE SECRET-CODE KEY FOR THE DESIRED SIGNALS.
7. YOU CAN PRACTICE SECRET-CODE WITHOUT TRANSMITTING BY PRESSING THE SECRET-CODE KEY BUT NOT PRESSING THE PUSH-TO-TALK SWITCH.
8. TO USE HEADSET, SPEAK IN A NORMAL VOICE INTO THE MICROPHONE. THE MICROPHONE OF THE HEADSET IS VOICE-ACTIVATED, SO AS SOON AS YOU BEGIN TALKING YOUR MESSAGE WILL BE TRANSMITTED TO THE OTHER HEADSET OR BASE STATION. THE MICROPHONE WILL BE ACTIVATED IF WIND BLOWS DIRECTLY INTO IT. ADJUST YOUR POSITION TO AVOID THE WIND AND OTHER OUTSIDE NOISES THAT INTERFERE WITH THE MICROPHONE.
9. IN THE EVENT OF INTERFERENCE CAUSED BY OTHER RADIO SIGNALS IN THE VICINITY, MOVE TO A DIFFERENT LOCATION.
10. THE UNITS MAY HAVE FEEDBACK WHEN USED TOO CLOSE TOGETHER. MOVE FURTHER APART WHEN THIS OCCURS.

USING OPTIONAL AC ADAPTOR (NOT INCLUDED)

YOU CAN ALSO POWER THE BASE STATION FROM AC POWER USING A POSITIVE CENTER, 9V DC, 300mA ADAPTOR.

CONNECTING IT TO ANY OTHER ADAPTOR MAY DAMAGE THE UNIT. ADAPTORS ARE AVAILABLE IN MOST RADIO STORES.
