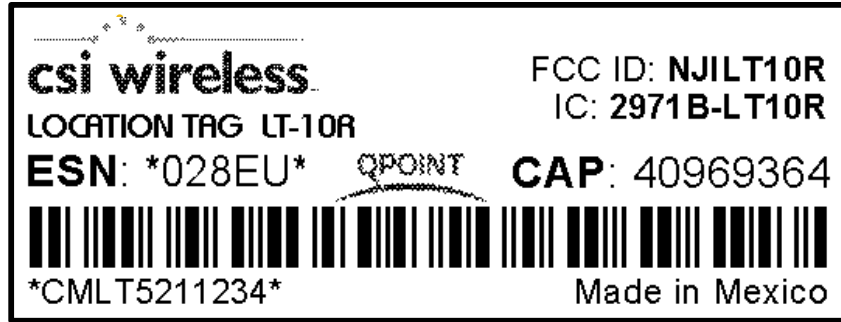

- CAP CODE: typeface shall be Arial 5.3 point lettering.
- ESN Number shall be in Arial 5.3 point lettering.
- Country of origin shall be in Arial 4.2 point lettering.
- Serial Number shall be in Arial 4.2 point lettering.
