#### 3.1. End User Device additional requirements

(a) End User Devices may operate only if they can positively receive and decode an authorization signal transmitted by a CBSD, including the frequencies and power limits for their operation.

(1) An End User Device must discontinue operations, change frequencies, or change its operational power level within 10 seconds of receiving instructions from its associated CBSD.

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuation factor between EUT conducted port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly EUT RF output level.

1. Setup with frequency 3560MHz and power level 22dBm/MHz
2. Enable AP service from EPC management
3. Check EUD Tx Frequency and power
4. Disable AP service from EPC management
  - a. Check EUD stops transmission within 10seconds.
5. Setup with 3690MHz & power level 3dBm/MHz
6. Enable AP service from EPC management
7. Check EUD Tx Frequency and power
8. Disable AP service from EPC management
  - a. Check EUD stops transmission within 10seconds.


