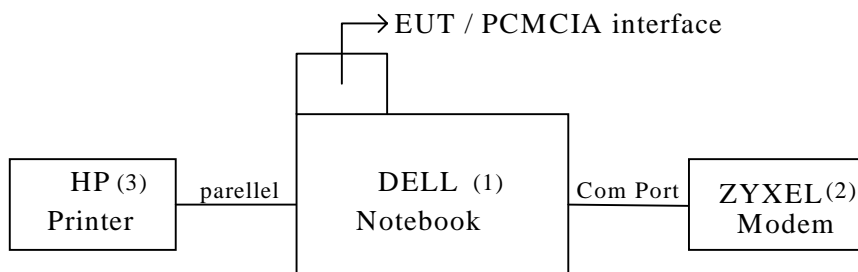

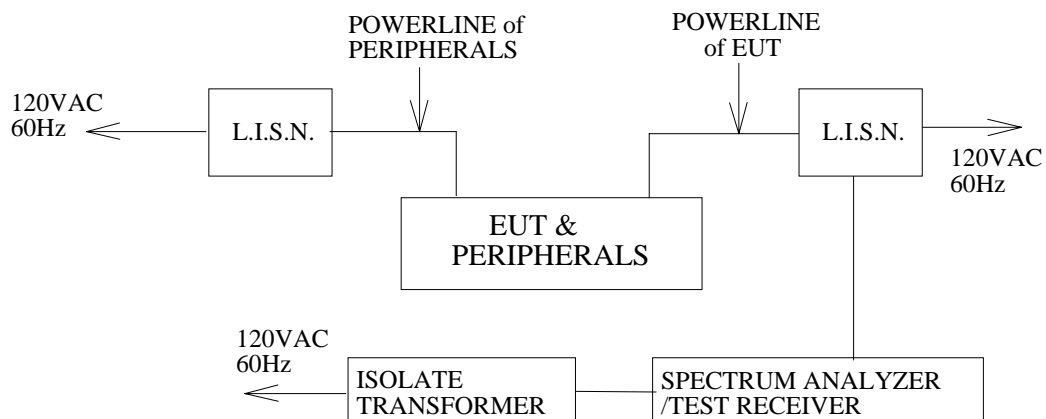

2.4 TEST PROCEDURE

The test procedure is performed in a 12ft \times 12ft \times 8ft(L \times W \times H) shielded room. the EUT along with its peripherals were placed on a 1.0m(W) \times 1.5m(L) and 0.8m in height wooden table and the EUT was adjusted to maintain a 0.4 meter space from a vertical reference plane. The EUT was connected to power mains through a line impedance stabilization network (LISN) which provides 50 ohm coupling impedance for measuring instrument and the chasis ground was bounded to the horizontal ground plane of shielded room. All peripherals were connected to the second LISN and the chasis ground also bounded to the horizontal ground plane of shielded room. The excess power cable between the EUT and the LISN was bundled. The power cables of peripherals were unbundled. All connecting cables of EUT and peripherals were moved to find the maximum emission.

2.5 UNCERTAINTY OF CONDUCTED EMISSION

The uncertainty of conducted emission is \pm 1.36dB.



2.6 LINE CONDUCTED RF VOLTAGE MEASUREMENT

The frequency spectrum from 0.45 MHz to 30 MHz was investigated. All emissions not reported below are more than 20 dB below the prescribed limits.

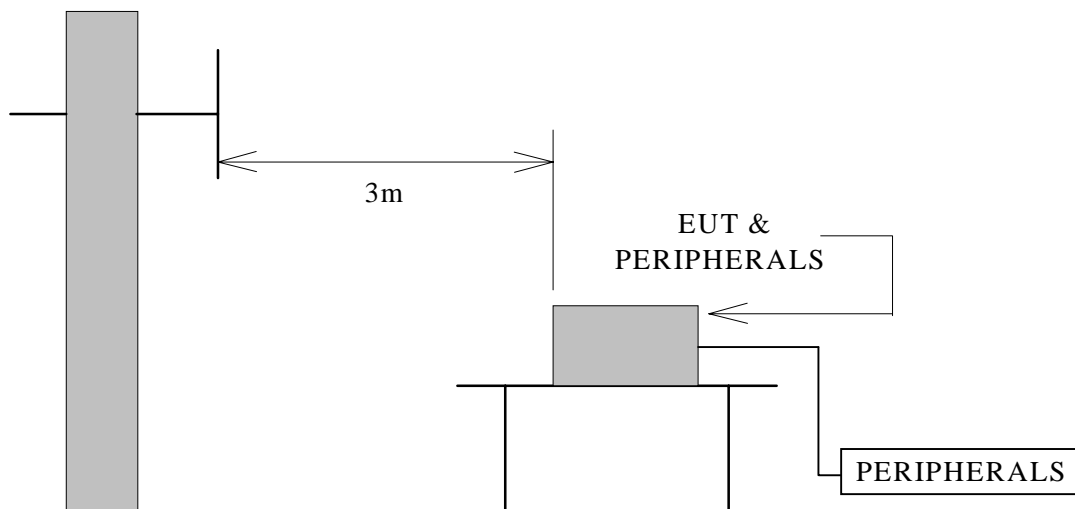

3.3 RADIATION LIMIT

For unintentional device, according to § 15.109(a), except for Class A digital devices, the field strength of radiated emissions from unintentional radiators at a distance of 3 meters shall not exceed the following values :

For intentional device, according to § 15.209(a), the general requirement of field strength of radiated emissions from intentional radiators at a distance of 3 meters shall not exceed the above table.



3.4 TEST PROCEDURES

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 10 meter open area test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

NOTE :

1. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 120 KHz for Peak detection (PK) and Quasi-peak detection (QP) at frequency below 1GHz.
2. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 1 MHz for Peak detection and frequency above 1GHz.
3. The resolution bandwidth of test receiver/spectrum analyzer is 1 MHz and the video bandwidth is 10 Hz for Average detection (AV) at frequency above 1GHz.

3.5 UNCERTAINTY OF RADIATED EMISSION

The uncertainty of radiated emission is $\pm 2.72\text{dB}$.

10.4 TEST PROCEDURE

Section 15.247(c): Spurious emissions. The following tests are required:

1. RF antenna conducted test: Set RBW= 100kHz, Video bandwidth (VBW) > RBW, scan up through 10th harmonic. All harmonics/spurs must be at least 20 dB down from the highest emission level within the authorized band as measured with a 100kHz RBW.
2. Radiated emission test: Applies to harmonics/spurs that fall in the restricted bands listed in Section 15.205. The maximum permitted average field strength is listed in Section 15.209. 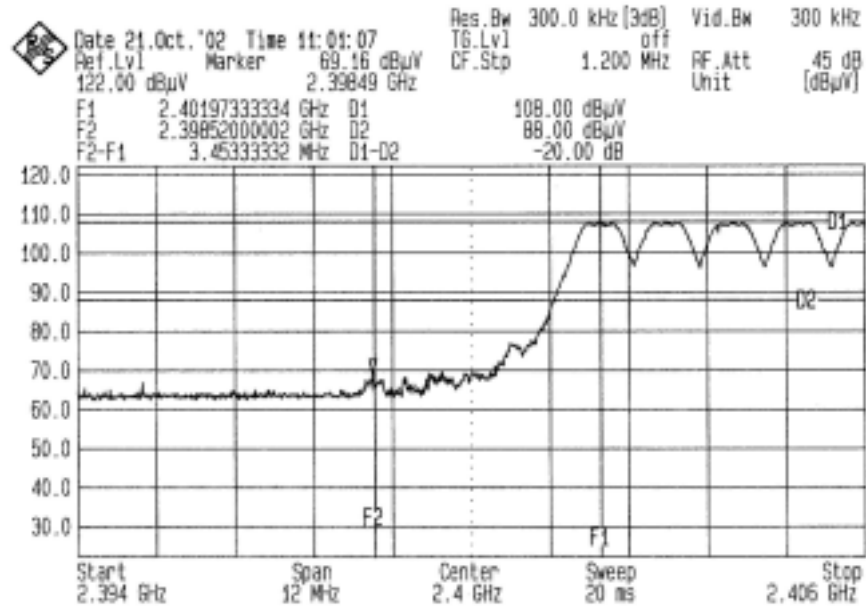

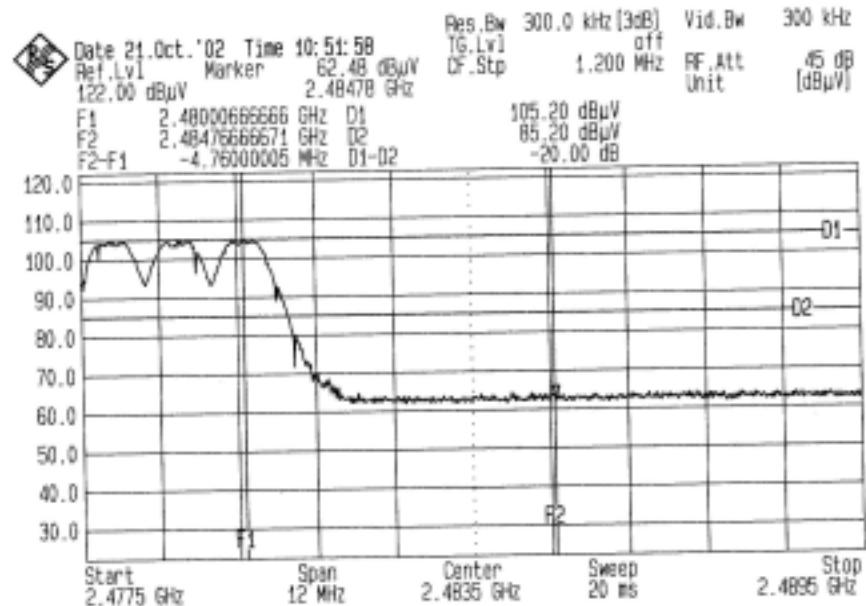

12.1 FRIIS FORMULA

Friis transmission formula : $P_d = (P_{out} * G) / (4 * \pi * r^2)$

Where

P_d = power density in mW/cm²

P_{out} = output power to antenna in mW

G = gain of antenna in linear scale

π = 3.1416

R = distance between observation point and center of the radiator in cm

P_d is the limit of MPE, 1 mW/cm². If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

The distance r (4th column) calculated from the Friis transmission formula is far shorter than 20cm separation requirement. So, RF exposure limit warning or SAR test are not required.
